### RULES.

Each child on joining receives a box and card and gives its first gift of five cents. This is not put into the box, but sent with the name of the child to the secretary, who decides how this money is to be used. The card certifies that the child is a member of the Babies' Branch and has given its first five cents for missions.

Each week, on the first day of the week, the baby drops into the box the offering put into its little hand, and the mother offers, for her child, the prayer that God will bless the missionaries all over the world, and all the little helpers. When some special mercy to the little one fills the heart of the mother and the father with gratitude, they may be glad to put into baby's box their thank offering. As soon as the child is old enough he may be taught to lisp the prayer himself.

On Holy Innocents' Day the money in the box, with the card, should be sent back to the secretary, who credits the amount on the card, and after it has been divided, entry is made how the money has been used, and the card is sent back into the home, carrying missionary information to mothers, who, perhaps, have little time to give to such matters.

### REASONS FOR THE BABIES' BRANCH.

- 1st.—Every baby by baptism becomes a member of the Missionary Society—the Church.
- 2d. — The first day of the week is the time to lay apart for the Lord, as the Apostles did, forming the habit in the child's life.
- 3d. — This must not be a parish society; it is to teach something broader: that the child belongs to the Church at large, and so
- 4th.—The gifts are to be divided equally between the Foreign, Domestic and Diocesan work.

A fifth idea has produced already beautiful fruit. If the little ones are transplanted to Paradise, their work does not cease, but each Sunday a penny is put into the box by the mother, or other children, in memory of the little one, and a prayer offered for the

## PRESIDENT'S ADDRESS

---

For the first time since becoming your President, I welcome you to an Annual Meeting without the cloud of war over us.

The Women of our Church have responded to the call of our Nation, and I fear in laboring for relief work have sometimes forgotten that to accomplish the best results we must first be good Churchwomen and bring to our work our Christian ideals and our Church training. But now with the hope of a permanent peace may our women resume Church activities and put as much energy and consecrated action into their efforts as they did in the relief work. We need more of the spirit which led you to do relief work, to the exclusion of everything else, to realize our new opportunities and to ensure the proper service from us all.

This is the one thought I want to emphasize today. The other officers will give their reports and offer suggestions, but my present appeal to you is that you will give of your time and strength and courage to the Women's Work of the Church, and will recognize the need of hearty cooperation that the great Missionary work may go forward steadily and rapidly.

The creditable response to the Advent Call to Prayer leads me to believe that our women are alive to the need of spiritual power, which is quite as necessary now as during the past few years. In our Auxiliary undertakings may we see better days and show our gratitude for present blessings in more consecrated work.

Last year I visited Cocoanut Grove, Miami, Buena Vista, Palm Beach, West Palm Beach, Eau Gallie, Daytona, St. Cloud, Kissimmee, Winter Park, and also presided at the Neighborhood Meeting at Orlando. At this meeting ten places were represented and an attendance of forty outside of Orlando. I recommend more frequent meetings of this kind. They are certainly helpful.

Let us all pray for the success of our work during the coming year.



## MINUTES OF THE TWENTY-SIXTH ANNUAL MEETING

---

The Twenty-Sixth Annual Meeting of the Southern Florida Branch of the Woman's Auxiliary opened at Holy Cross Church, Sanford, January, 9th at 9:00 a. m., with a Corporate Communion which was celebrated by Bishop Mann assisted by Rev. W. R. Hayes. A large number of women received Communion.

After a greeting and a few words of gratitude and encouragement from Bishop Mann the business meeting was called to order by the President.

The meeting opened with the Creed and Prayers of the Woman's Auxiliary.

Minutes of the last annual meeting were omitted as they had been printed in the annual report.

The roll call by the secretary showed an attendance of 10 officers and 31 delegates representing 10 Auxiliaries and 13 Guilds.

An inspiring address by the President was then listened to with close and interested attention.

The Vice President gave a report on the number of copies of Palm Branch and Spirit of Missions which was compiled by her from the reports sent by the Parochial Vice Presidents. This was followed by a spirited discussion and was accepted as read.

The Secretary's report was accepted as read.

The Treasurer's report which was most encouraging was read by Mrs. Moore and was as follows: Total receipts for the year \$2,124.61; disbursements, \$1,122.50; balance on hand \$1,002.11. The Systematic Offering was \$588.01, showing a gain of \$12.43 over the previous year.

It was then put to vote whether all the report should be read or only special items as called for. It was decided in favor of special items and Convocation Gifts, Special Gifts, and Systematic Offerings were called for and read. On motion of Miss Carey-Elwes seconded by Mrs. Vivian the report was accepted as read.

Convocation Gifts were then received from twelve Auxiliaries and eleven Guilds and were found to total \$580.75. Auxiliaries giving \$363.75 and Guilds \$162.00 and \$55.00 in Special Gifts.

The committee on disbursement of funds was then appointed by the president and was as follows:

### Disbursement Committee

Chairman, Mrs. C. H. Morse, Winter Park; Mrs. L. A. Wye, West Palm Beach; Mrs. E. B. Putnam, Daytona; Mrs. S. O. Chase, Sanford; Mrs. E. F. Sperry, Orlando.

Suggestions from the floor were then called for by the president as to the disbursement of funds and were made as follows: Bishop's Fund, Endowment of Diocese, St. Luke's Hospital, Orlando; Colored Work at Tampa, Cocanut Grove, and Raleigh, Apportionment and Board of Missions.



Mrs. Mann then announced that the apportionment had been met for this year.

The United Offering Treasurer gave a most helpful and interesting talk and reported the sum of \$922.00 on hand with the earnest hope that it would reach \$1200 before the Triennial. The offering at the Corporate Communion was reported as \$24.95.

The Educational Secretary's report was then read and accepted. She stated that the Advent Call to Prayer had been observed in fourteen places as follows: Sanford, West Palm Beach, Orlando, St. Cloud, Lakeland, Tampa, Cocoa, Miami, Daytona, DeLand, Titusville, Winter Park, Oakland-Ocoee, and Key West.

Mrs. Mann made a plea for more Mission Study Classes during Lent.

The report of the President of the Little Helpers was read by Mrs. Mann as Mrs. Huguenin was unable to be present.

The report of the Church Periodical Club was also read by the President as Mrs. Thompson was absent. Both of these reports were then accepted as read.

There was no report from the President of the Junior Auxiliary but the report of the Secretary and Treasurer, Mrs. Hudson was read and accepted.

The President then announced that election of officers was in order and asked what was the pleasure of the meeting. Mrs. Bliss made a motion seconded by Mrs. Shaw that a nominating committee be appointed by the Chair and election be held through that committee. This was carried. Mrs. Mann then appointed the following committee:

Chairman, Mrs. L. H. Lothridge, Tampa; Mrs. Robert MacKay, Daytona; Mrs. Seth Woodruff, Orlando; Mrs. L. D. Frost, St. Cloud; Mrs. L. H. Robbins, Daytona.

Mrs. Mann then asked for a report of the Advent Call to Prayer from West Palm Beach, Winter Park and Daytona. Mrs. Wye reported a most uplifting and helpful result at West Palm Beach which was carried out exactly as planned by the Board of Missions as was also the case at Sanford.

The noon hour having arrived Prayers were said by Rev. F. A. Shore and the meeting adjourned for luncheon.

The meeting reconvened at 1:15 p. m., called to order by the President.

Mrs. Woodruff made a motion that a rising vote of thanks be given the ladies of Sanford for their hospitality this was seconded by Mrs. Bliss.

Mrs. Mann then asked for a report from the committee on disbursement and Mrs. Morse reported the following disbursements which was accepted by the meeting.

## REPORT OF THE SECRETARY

---

Another year has passed and we stand at the beginning of a new one for the Woman's Auxiliary in Southern Florida.

The war with its consequent work for Red Cross and other Relief organizations, together with the terrible epidemic which has swept over the land has interfered seriously with the work of the Church Societies in many Parishes.

From four places the report comes that no meetings have been held during the past year but with the close of the conflict and the return to normal conditions we are hoping for great achievement during 1919.

There have been held during the year three officers meetings for discussion of work and plans for the Annual Meeting, two in Orlando and one in Tampa. The Secretary has attended with the President regular meetings of the Auxiliary at Winter Park and of the Guilds at Daytona, Kissimmee, and St. Cloud. In May a most inspiring and helpful neighborhood meeting was held at Orlando addressed by our United Offering Treasurer, Mrs. Shaw. Representatives from the Societies of Lakeland, Ocala, Sanford, Winter Park, Leesburg, Daytona, Kissimmee, Oakland, Ocoee and St. Cloud were present.

The correspondence during the past year has been very light; 22 letters having been received, and 310 pieces of mail sent out, including 15 letters, 240 Annual Reports and 55 Report Blanks. Of the Blanks only 32 have been returned up to date. Of these 14 represent Auxiliaries and 18 Guilds, showing a total membership of 734. In these Societies there are 88 copies of Spirit of Missions taken and 143 copies of the Palm Branch.

There have been 11 Advent Boxes reported as sent, valued at \$529.36 and 6 others valued at \$182.80 and \$9.50 in cash.

Three Scholarships have been given to the Cathedral School for the year 1918. One from the Woman's Auxiliary of Southern Florida, one from a member of the Orlando Auxiliary and one from a member of the Winter Park Auxiliary.

Your Secretary has met with a committee and prepared a program, endeavoring to follow, as usual, the suggestions from the General Educational Department. This program has been sent, as heretofore, to the President of every Auxiliary and each Guild where there is no Auxiliary, asking that this program be used when possible and when not, that it may serve as a suggestion for the educational work.

Also every parish and mission were written to and urged to observe the Advent Call to prayer. Fourteen places have reported having observed this Call.

Instead of a Mission Study Class during Lent, the Rev. R. P. Cobb has kindly consented to give a course of instruction in the Cathedral, Orlando.

It is hoped that other places may have a Study Class during Lent, taking for their course of study, "Studies in Religion for War Times."

I have made only one visit, at which time I talked to the ladies present about the program for the season's study and the Advent Call to Prayer.

In our home giving would suggest that we work for the Cocoanut Grove School as we will be helping children in doing that and I would like to see one of the boxes at Christmas or Easter sent there.

I am glad to mention one way in which we have improved. The Secretaries are responding so much better and the different Branches are all working for the same object. It is in this way that we shall get the best results.

Our new Secretary-Treasurer has started in with fine enthusiasm and already through her interest and energy there are rumors of three new branches and we hope that they will soon be organized and at work. ## CONSTITUTION OF THE SOUTHERN FLORIDA BRANCH OF WOMAN'S AUXILIARY

---

### Article I. NAME.

The name of this Association shall be "The Southern Florida Branch of the Woman's Auxiliary to the Board of Missions."

The objects of this Association are

### Article II. OBJECTS.

### Article III. MEMBERSHIP.

All baptized women in the District of Southern Florida are eligible for mebership in this Association.

First.—By means of Prayer and Offerings to spread Christ's Kingdom in the world.

Second.—To diffuse Missionary Intelligence.

Third.—By united and Systematic effort to increase Missionary Activity among the women of the District, and to encourage the formation of Local Auxiliaries where none exist.

### Article IV. OFFICERS.

There shall be a President, Vice-President, Secretary, Treasurer, United Offering Treasurer and such other officers as may at any time be required.

### Article V.

There shall be a Junior Department of this Association for the younger women and children of the District, working under its own Constitution and electing its own officers.

### Article VI. LOCAL AUXILIARIES.

Local Auxiliaries may be organized in all Parishes and Missions of this District by the consent of the Rector or Missionary, and of the District President.

### Article VII. ANNUAL MEETING.

There shall be an annual meeting of Delegates from the Local Auxiliaries at the time of the Annual District Convention.

### Article VIII. ELECTION OF OFFICERS.

The election of officers at the annual meeting shall be by ballot.

### Article IX. AMENDMENT.

This Constitution may be amended at any annual meeting by a two-third vote of the Delegates present, and upon the approval of the Bishop.

---

## BY-LAWS

### 1. QUORUM.

Three of the District Officers shall form a quorum for transacting business at committee meetings.

Delegates from five Local Auxiliaries shall form a quorum in annual meetings.

### 2. EXPENSES.

The current expenses of this Association shall be paid from the General Expense Fund.

### 3. MEETINGS.

All meetings shall be opened with prayer.



#### 4. DUTIES OF OFFICERS.

The duty of the President shall be to preside at all meetings, to arrange for the organization of Local Auxiliaries, and to have general charge and care of the work, throughout the District.

The duty of the Vice-President shall be to preside in the absence of the President, and to have special care and charge of the subscription list of the SPIRIT OF MISSIONS and THE PALM BRANCH.

The duty of the Secretary shall be to

1. Issue notices of meetings;
2. Keep the minutes of the Association;
3. Prepare and edit the annual report and perform such other functions as may be assigned her by this Association.

The duty of the Treasurer shall be to receive and under the direction of the President to disburse all moneys, and to render an account of the same at each annual meeting.

The duty of the United Offering Treasurer shall be to distribute Blue and Birthday Boxes to local United Offering Officers, receive annually all moneys from the same, prepare an annual report and present the total amount at each Triennial meeting at the time of General Convocation.
