




THE OBJECT OF THE WOMAN'S AUXILIARY TO THE NATIONAL  
COUNCIL IN THE DIOCESE OF SOUTH FLORIDA

"The object of this organization shall be to carry forward the three great aims of the Church: Extension of the Kingdom, Religious Education and Christian Social Service, through Prayer, Study, Work, and Gifts, in the Home, Parish, Community, Diocese, Nation and World."

(Article II, Constitution).

DIOCESAN OBJECTIVES FOR 1938

1. Bishop Wing:
  1. Every Church woman in South Florida a member of the Woman's Auxiliary.
  2. Broadening of our educational programme to increase our knowledge of the Church.
2. President of the Woman's Auxiliary—Miss Alpha B. Nash:  
Every member of the Woman's Auxiliary contributing to the Dioceasan Camp Fund.
3. Secretary of Religious Education—Mrs. Thomas G. Price:  
Every Branch awake to the vital importance of religious education and doing active work along this line.
4. United Thank Offering Custodian—Miss Elizabeth Rand:  
Realization of the Privilege and the Responsibility shared through our Blue Box offering.
5. Supply Secretary—Mrs. O. R. Grosse:  
Every Church woman in the Diocese to have the privilege of sharing in the work of Mission Boxes.
6. Christian Social Service Secretary—Mrs. C. C. Simpson:  
To make your Social Service "Christian"—from the heart—for Jesus' sake.

OBLIGATION AND PRIVILEGE OF EVERY PARISH BRANCH

1. Work in Five Fields of Service, with Expense Fund paid, and Annual Diocesan Gift presented.
2. At least one Quiet Day and one Corporate Communion.
3. Report of year's work in hands of Diocesan officers by January first.
4. Representation at Annual and District meetings.
5. Better understanding of the budget of the General Church, the Diocese and the Parish.

## OUTSTANDING ACCOMPLISHMENTS REPORTED BY THE DIRECTORS

District I—Plans made and programme arranged by Auxiliary of one Branch for Inter-denominational World Day of Prayer: best report of Christian Social Service work done by group of less than fifteen.

District II—Inter-denominational Bible Class and Vacation Bible School organized by the Episcopal women.

District III—Organization of prayer groups: free-will offering to make up their budget by women of the Auxiliary of one Branch: organization of one new Branch.

District IV—Work carried on in five Fields by small groups—one with only eight members: increase in number attending Summer Conferences—nine from this District.

District V—Winning of the second prize in the Provincial Scholarship contest: one Branch maintaining four Bible classes: a community center developed in a rural area.

**PROCEEDINGS OF THE ANNUAL MEETING**

The Annual Meeting of the Woman's Auxiliary of the Diocese of South Florida was held in West Palm Beach, Florida, May 3 to 5, 1938.

At 3:00 P. M. on May 3, the following Conferences for Department Leaders took place:

- Conference for Presidents led by Miss Alpha B. Nash;
- Conference for Supply Secretaries led by Mrs. T. K. Wade, National Supply Secretary;
- Conference for Religious Education Chairmen led by Mrs. Thomas G. Price;
- Conference for Christian Social Service Chairmen led by Mrs. C. C. Simpson;
- Conference for United Thank Offering Custodians led by Miss Elizabeth Rand.

The joint opening service of the Sixteenth Annual Convention of the Diocese of South Florida was held in Holy Trinity Church at 8:00 P. M. on May 3rd, at which time the Rt. Rev. John D. Wing, D.D., LLD., Bishop of the Diocese, gave his report for the year.

A corporate celebration of the Holy Communion was held at 7:30 A. M. on the following morning at Holy Trinity Church, with Bishop Wing as Celebrant.

**OPENING BUSINESS SESSION**

May 4th, 9:30 A. M.

**THEME**

*"Fellowship in Faith and Work"*

The Annual Meeting of the Woman's Auxiliary of the Diocese of South Florida was declared in session by the President, Miss Alpha B. Nash, on the morning of May 4th, the same being held in the auditorium of the Woman's Club. Singing of Hymn, "Love Divine All Love Excelling", followed. Miss Elizabeth Rand gave a short instruction on the value of prayer, after which she led the assembly in prayers. Mrs. George S. Whitting, President of Holy Trinity Auxiliary, extended a cordial welcome to the delegates and visitors. Mrs. C. B. Lillie, Director of District Two, responded for the Convention.

The President then introduced the guest speaker, Mrs. T. K. Wade, National Supply Secretary, the Diocesan Officers and Department Heads.

Roll call followed showing 24 Parishes and 26 Missions represented by 93 delegates, 107 visitors and 11 Diocesan Officers—making a total of 211.

The annual Convention Gift was then presented by Parish and Mission representatives.

The President called for the report of the Credentials Committee; which was given, although incomplete, due to the fact that delegates had arrived since the meeting convened.

The annual reports of the President, the Secretary and the Treasurer were then read by those respective officers. The report of the auditor from January 1, 1937, to May 31, 1937, was read by the Treasurer. Motion was made by Mrs. Drane, duly seconded, that this report be accepted. Motion carried. The report of the auditor from June 1, 1937, to December 31, 1937, was read by the Treasurer. Motion was made by Mrs. Camp, duly seconded, that this report be accepted. Motion carried.

The President announced the following Committees:

Mrs. John E. Culmer, President of the Colored Convocation of the Woman's Auxiliary of the Diocese, reported on the work being done by her organization.

Mrs. T. K. Wade, National Supply Secretary, gave an informal talk on the History and Purpose of the Supply Department.

The President called for the annual reports of the Department Heads. Mrs. O. R. Grosse, Supply Secretary, reported first.

There not being sufficient time before noon to finish these reports, the Rev. Mr. Louttit was given time for a brief talk in behalf of the Permanent Camp Fund.

At noon Bishop Wing led the assembly in prayer. Bishop Wing then addressed the assembly, urging that two things be stressed:

1. Work to have every Church woman an active member of the Woman's Auxiliary.

2. Need for broadening our religious education to increase our knowledge of the Church.

The Bishop announced that South Florida won Second and Fourth places in the Provincial Woman's Auxiliary contest for the best paper on "What Is the Church?"; Mrs. G. S. Rogers, of Holy Trinity, West Palm Beach, winning Second and Miss A. M. Tulane, of St. Peter's, St. Petersburg, winning Fourth place.

Annual reports were then continued. Mrs. C. C. Simpson, Christian Social Service Secretary, was followed by Mrs. Thomas G. Price, Secretary of Religious Education; who, in turn, was followed by Miss Elizabeth Rand, United Thank Offering Custodian. Mrs. W. F. Moses exhibited three posters made by the Y. P. S. L. of Lakeland to stimulate interest in the Permanent

Camp. Mrs. Moses also read the report on the Cathedral School prepared by Mrs. Edith R. Massey, Principal.

The meeting thereupon recessed for lunch.

#### Afternoon Session

The Special Memorial Committee, headed by Mrs. E. W. Shaw, conducted the memorial service for the late Mrs. Arnetta M. Vance, former Publicity Chairman. The service was opened with the Hymn, "The King of Love My Shepherd Is"; followed by the Scripture reading, Revelation 7:15-17, after which was read the tribute to Mrs. Vance, viz:

#### In Memoriam

"As we have gathered today for our Diocesan Annual Meeting, we are missing the presence of one who, for the past ten years has been with us as a beloved fellow worker and faithful officer of our organization, Arnetta M. Vance.

Called Home on March the 9th, she passed beyond our immediate vision into the 'fullness of joy'; and, in our sense of loss and our sorrow, we can rejoice that a life dominated by the spirit and power of God has completed its earthly career and entered into the life of perfect service; for, to a Christian, death does not mean the end of a career,—it is simply passing into its enrichment and completion.

'We are so selfish about death. We count our grief  
Far more than we consider their relief,  
And we forget that it means only life—  
Life—with all joy and glory rife,  
The victory won and ended all the strife  
And Heaven no longer far away and strange.'

Today we love to recall our happy memories of Mrs. Vance. We think of her as she sat at the piano, leading our hymns of devotion and praise at many of our services.

We remember her patient and efficient work as Educational Secretary, when she laid the permanent foundation for the religious and missionary study, that is becoming more and more a vital part of our Auxiliary program.

When in 1934, she accepted the office of Publicity Chairman, she brought to that office a spirit which raised it above the commonplace; she made it a spiritual and inspirational service, reminding us that we are bidden to 'Tell it out among the heathen that the Lord is King,' and all her efforts were toward the advancing of that Kingdom.

Mrs. Vance's character might be summed up in two words, faithfulness and joyousness. To every task, however small, she gave her complete attention and always with a spirit of cheer and courage that was an inspiration.

We, who knew her, thank God for all she accomplished here, and is to accomplish in Heaven."

The service was concluded with prayers.

The President called the meeting to order at 2:15 P. M. and announced that, if there would be no objections, the reading of the minutes of the morning session would be dispensed with until the following morning.

Motion was made by Miss Tulane that a copy of the Memorial to Mrs. Vance be included in the minutes of the Annual Meeting and that a copy thereof be sent to the family of Mrs. Vance and to the Palm Branch for publication: which motion was duly seconded and adopted.

Reports were heard from the Rev. Hamilton West on college student work at the University of Florida; from Deaconess Bedell on her work in the Everglades (the same being no longer limited to the Seminoles but extending to the fisher-folk and negroes); and by Miss Julia Gehan on the student work at Florida State College for Women. Miss Gehan stated that of the thirty-eight Summer volunteer student workers, financed by our Gift of Life, four have continued in Church work.

Reports from the following Committees were read: Publicity and also Prayer Partners by Mrs. W. G. Seekins; Gift of Life and the Forward Movement by Mrs. Thomas G. Price; and the Field Department by Mrs. C. B. Lillie.

It was announced that the Convention Gifts presented at the morning session amounted to \$1,370.85.

It was also announced that the offering at the Corporate Communion was \$59.90; which goes toward our Diocesan United Thank Offering Fund.

The Directors of the five Districts then gave in turn what they considered the outstanding achievement in their respective Districts; a summary of which is to be found elsewhere in the Annual.

The meeting recessed at 4:00 P. M.

#### Business Session—May 5th

The meeting reconvened on Thursday morning, May 5th, at 9:30, with singing of Hymn 477; followed by the Auxiliary prayer. Minutes of the preceding sessions were read and approved. On motion of Mrs. Price, duly seconded, the reading of that portion of the minutes pertaining to the Memorial to Mrs. Vance was omitted as it was to be published in the Palm Branch. Motion carried.

As the first recommendation from the Executive Board, Mrs. Joseph Halton presented the following Amendment to the Constitution, and moved its adoption:

**"BE IT RESOLVED,** That Article VI of the Constitution be amended by adding thereto an additional Section, to be numbered Section III and to read as follows:

All members of the Executive Board shall be entitled to all privileges of the Annual Meeting, including the right to vote.

and that all subsequent Sections of said Article be re-numbered accordingly."

Motion seconded and unanimously carried.

The second recommendation from the Executive Board (the increase of the Expense Fund) was presented by Mrs. Norman H. Bunting, Treasurer, who moved the adoption of the following Resolution:

"WHEREAS the expenses of this organization have increased in the same proportion as all living costs; and

WHEREAS the Expense Fund has been insufficient to cover the expenses for the past several years; and

WHEREAS it has been necessary to set aside a portion of the Convention Gift into a fund called the Contingent Fund to meet the deficit in the Expense Fund; and

WHEREAS it seems meet and right that this organization should be on a better business basis:

THE THEREFORE, BE IT RESOLVED, That a new and more equitable assessment be made on the following basis, estimated on the 1937 income:

Missions whose income is from \$100 to \$300 to pay \$3.00.

Missions whose income is from \$300 to \$500 to pay \$5.00.

Missions whose income is from \$500 up to pay \$8.00.

Parishes whose income is from \$200 to \$300 to pay—No increase.

Parishes whose income is from \$300 to \$500 to be increased \$6.00.

Parishes whose income is from \$500 to \$700 to be increased \$8.00.

Parishes whose income is from \$700 to \$1000 to be increased \$10.00.

BE IT FURTHER RESOLVED, That this assessment be effective on and after January, 1939."

It was explained by the Treasurer, Mrs. Bunting, that this would increase the income of the Expense Fund about \$150.00.

A copy of the list of Parishes and Missions, giving the old and new assessment of each, was distributed to all present; after which the Treasurer read the list calling attention to the changes in these assessments, if any. There being no objection (three Parishes volunteering to take a larger assessment than the new assessment provided), the question was put and the resolution as presented was unanimously adopted.

The final report of the Credentials Committee was given by the Chairman, Mrs. John H. Birdsall, showing 24 Parishes and 26 Missions represented, 11 Diocesan Officers, 93 Delegates and 107 Visitors—total number present 211.

The following Resolutions were presented by the Chairman of the Resolutions Committee, Mrs. H. H. Booth, who moved the adoption of each Resolution in turn:

#### Peace

"United Prayer for Peace.

WHEREAS, Christian men and women face an increasingly stern and stirring challenge in the strife-torn world of today,

AND WHEREAS, it is more and more evident that the highway to justice, freedom and peace cannot be built by human might, but only as the power of the Spirit of Jesus Christ unites the hearts and soul of men and women, and guides their thoughts and acts,

THEREFORE, BE IT RESOLVED: That the members of the Woman's Auxiliary endeavor each day to pray more fervently than ever before for peace throughout the world.

BE IT FURTHER RESOLVED: That a definite form of prayer be used in order to deepen the realization of full power of united intercession by the membership of this great body of consecrated women.

AND BE IT FURTHER RESOLVED: That we, the members of the Woman's Auxiliary, call upon our clergy and laymen to join us, and that we, with them, urge all Christian folk within our influence to share in this, a real unity of Christians in intercession." Resolution adopted.

#### Young People

"Chairman of Young Peoples' Work.

WHEREAS, The members of the Woman's Auxiliary are convinced that there is real need for some form of activity to promote the education of young women and girls in the mission of the Church, in cooperation with the existing work of Church Schools, the Girl's Friendly Society, Young People's Service League and the Woman's Auxiliary, and whereas no new organization is suggested;

THEREFORE, BE IT RESOLVED: That this meeting approve the appointment of a Chairman of Young Peoples' Work in this Diocese, and in Parishes where feasible, to further such activity, such person to act as co-operating Chairman in the interest of the Mission of the Church with existing youth organizations." Resolution adopted.

#### Tithing and Proportionate Giving

"WHEREAS, the missionary budget of the Episcopal Church does not tap the resources of the Church, and

WHEREAS, The practice of tithing on the part of the individual members would assure an extended program and inspire other Christians,

THEREFORE, BE IT RESOLVED: That every member of the Auxiliary be asked to give prayerful consideration to personal tithing or larger proportionate giving." Resolution adopted.

#### Appreciation

"BE IT RESOLVED: That we tender our appreciative thanks to our guest speaker, Mrs. T. K. Wode, National Supply Secretary, for her informative and inspiring message." Resolution adopted.

"BE IT RESOLVED: That we, being greatly blessed in the spiritual leadership of our beloved Diocesan, do hereby express to him our continued appreciation for his guidance and our desire that, through prayer and service, we may ever uphold and strengthen his labors in this Diocese." Resolution adopted.

"BE IT RESOLVED: That we extend our heartiest congratulations to our mother Diocese on this, her one hundredth birthday, and that the Secretary be instructed to send this message of good-will to the Bishop of Florida." Resolution adopted.

Mrs. A. L. Robinson, of the Resolutions Committee, presented the following courtesy Resolution:

"BE IT RESOLVED: That we, the members of the Woman's Auxiliary of the Diocese of South Florida assembled at our Annual Meeting in West Palm Beach, as guests of Holy Trinity Church, express our sincere appreciation to the Rev. H. Irving Louttit, Mrs. G. Ray Sparks and Mr. Lynn S. Nichols; also to the members of the Woman's Auxiliary for their gracious hospitality and many courtesies, which have made this a most inspiring and enjoyable Convention." Resolution adopted.

Mrs. H. J. Drane, Chairman of the Memorial Committee, read the names of those Auxiliary members who have passed into Eternal Life during the year 1937; during the reading of which the body of the Meeting stood in respect.

Mrs. Price spoke on the value of Adult Conferences and urged as many as possible of the women to attend.

The Rev. W. F. Moses, Chairman of the Department of Religious Education of the Diocese, requested that the Woman's Auxiliary sponsor the Church Schools Service Program and that the President appoint a Chairman for this Program. Motion was made by Mrs. W. G. Seekins, seconded by Mrs. Price, that, in compliance with the request of the Director of Religious Education, the Woman's Auxiliary sponsor the Church Schools Service Program; which motion was unanimously adopted.

The President announced, with permission of the Meeting, that she would appoint a committee to approve the minutes of the last session.

The meeting adjourned at 11:45 A. M. and benediction was pronounced by the Rev. Mr. Moses.

## REPORT OF PRESIDENT

At this, the close of my year's work as your President, it gives me great pleasure to make a report of my activities. As you will see, the months have been full. If they have been profitable, it is because I have had the full co-operation of every Department; because you as individuals have striven to carry out our objective, "To make the Auxiliary a spiritual force in the Parish and Mission."

And here I wish to especially thank my Officers for their fine reports which came so promptly on January first; Miss Rand for making the especial effort to have the second ingathering of the United Thank Offering before the Triennial; Mrs. Price for the excellent Programme and the original design on the frontispiece; Mrs. Grosse for the special effort put forth in behalf of the missionaries in China who because of the war there were deprived of homes and clothing; Mrs. Simpson for so capably filling two offices; all of my Directors for their cooperation in planning the Fall and Spring meetings; and the members of the Auxiliary who so beautifully entertained me on my visits throughout the Diocese.

My first official visit was on May 12th, upon the invitation of the Director, Mrs. Humphreys, to the Spring meeting of District One held in Inverness. This gave me the opportunity to present the plans for the Adult Diocesan Conference and to urge attendance.

It was my great honor to be asked to be a member of the staff of the first Adult Conference held in this Diocese; and from June 7th to 12th I spent in Haines City, not only teaching the Woman's Auxiliary Course every day, but attending two classes as well; and I am happy to say that I have two credits for this work. With the approval of the Bishop, five scholarships were offered by the Woman's Auxiliary to this Conference,—one in each District but only three Districts were able to avail themselves of this offer. Our Contingent Fund made possible these scholarships.

A large part of July was spent in collecting and preparing material for the Annual which was subsequently edited by our Past President, Mrs. Turner.

July 25th I left South Florida for Sewanee, Tennessee, and from July 28th to August 10th I was a member of the Adult Conference there. South Florida was represented at the Sewanee Conference by four full time students and by twice that number of part-time students. I must confess that three of these four were from Sarasota; and here is a challenge to other Parishes—to do as well or better this coming year. Among the instructors at Sewanee was the Rev. Kenneth Morris, here on leave from Kyoto, Japan, whose course on "Japan" gave us the opportunity to see the problems confronting the Japanese Christians. It may be interesting to you to know that the Woman's Auxiliary of the Diocese of Alabama pays One Thousand Dollars a year toward the salary of the Rev. Mr. Morris. Another member of the Conference, whose personality added much to the fellowship of the entire group, was the Rev. Nelson E. P. Liu, from Ichang, China. Mr. Liu had a year's leave of absence from his Parish to work on his Doctor's degree and had spent it in the United States.

Provincial Auxiliary Day, August 6th, was a pleasant experience. Mrs. Fred Ramsey of Knoxville was in charge; and Mrs. MacMillan, President of the Woman's Auxiliary of the Province, was one of the speakers.

Saturday, August 7th, was my first Provincial Board meeting and, due to the absence of the Secretary, I served in that capacity. From this Board meeting came the recommendation that we give preference to the subject "Rural America", as our study for this year.

In August a letter from Miss Lindley came telling of the proposed visit to our Diocese of a "Missionary Team" and asking that meetings for the Woman's Auxiliary be planned in conjunction with the mass meetings which were to be held. After conferring with the Bishop, these meetings were finally planned and the schedule arranged to coincide with the night meetings.

October 6th to 19th—Cincinnati. I will always be deeply grateful for the privilege of attending this great meeting and certain high lights will remain in my memory forever:—the Opening Meeting; the Presentation of the United Thank Offering; the picture of our Presiding Bishop with the thirty-two Missionary Bishops standing back of him; the Announcement of the Offering; the Joint Session with a member of the Woman's Auxiliary speaking before that great body; Bishop Azariah; and our new Presiding Bishop, so humbly accepting the responsibilities put upon him. I am happy to say that fifteen women from this Diocese attended the Triennial. Besides attending all business sessions as a delegate and every evening one of the mass meetings, I was a member of the Supply Committee, and of Discussion Group, section 8; attended the Presidents' Council; the Provincial meeting on the 8th; the Diocesan luncheon on the 11th; the Provincial dinner on the 14th; and the Provincial Board meeting on the 15th. At this Board meeting, Mrs. MacMillan's resignation as President was accepted and Mrs. Fred Ramsey of Knoxville was elected President of the Province.

Immediately following the Triennial your President prepared and sent a letter to every Parish President giving the high lights of the Convention and the Triennial, as well as giving a list of the names of our Delegates and Alternates who attended the Triennial and urging them to use these members as speakers at their meetings, and thus catch the inspiration of the Triennial. This recommendation was followed by many; and, if the other Delegates were called upon as often as was your President, every Parish must have had a report of the Triennial. It was my pleasure to speak before the following Branches:

November 2nd, Sarasota.

November 5th, St. Elizabeth's Guild, Sarasota.

November 15th, Bradenton.

November 17th, Churchmen's Club, Sarasota.

November 24th, St. Petersburg, meeting of District Three.

On November 26th I attended the Fall meeting of District Four in Sarasota and had the pleasure of hearing the visiting Missionary Team speak.

On December 6th I was the guest of the Lakeland Auxiliary and spoke on "The History of the Auxiliary."

On January 17th I made my second visit to the Bradenton Auxiliary.

February 11th, the Executive Board met in Sarasota for its annual meeting. Bishop Wing met with us and was the Celebrant at the corporate communion held at the Church of the Redeemer at 11:00 A. M. It was my pleasure to preside at the business session which opened at 2:00 P. M. and continued until 5:00 P. M., when we adjourned for dinner. A short session after dinner completed the day. Eight of the eleven members of the Board were present. It was a great help to have Bishop Wing with us at this meeting; and I feel that, because of his presence, the recommendations of the Board, which will come to you later, will be accepted by this body.

March 7th found me in Tampa at St. Andrew's. It was a great honor to be asked to speak in this Parish on the United Thank Offering, and I accepted the responsibility with deep humility.

From March 14th to the 18th I spent travelling with Mrs. Price, our Religious Education Secretary, from one District meeting to another;—Bradenton on the 14th, Winter Haven the 15th, Sanford the 16th, Eustis the 17th and Ft. Pierce on the 18th. These meetings were all enthusiastic and well attended, and the reports heard proved the increased interest in the work.

And thus ends the past. As we look toward the future, there are three words that were heard over and over again during our Triennial meeting: "Fellowship", "Forward" and "Faith"; the first two depending upon the third. When you hear the reports of the Officers and Department Heads,

you may judge for yourselves how far this Faith has increased our usefulness. As we plan for the future, let us think in concrete terms how we may go forward. Let us not pass resolutions and then go home and forget them.

I beg to make the following recommendations. The first is with reference to our own organization. I heartily commend the Central Organization plan for all Parishes, large and small, for, if the personnel is changed regularly and all ages work together for the good of the whole, enthusiasm and optimism are contributed by the younger women and experience and wisdom by the older ones. All of the work of the women in any Parish should be organized under the guidance of the Woman's Auxiliary; and the work of all groups (not belonging to National Cooperating Organizations) should be reported through the Woman's Auxiliary. Otherwise the sum total of the work of Church-women is unknown.

The future of our Church depends upon our young people and the training we give them. It is a well known fact that the training they receive in the Summer Camps plays no small part in their development; and this presents my second recommendation. Let us prove our interest in our young people and their future by helping in a substantial way to make the Permanent Camp possible. Let me repeat here what I have said at every District meeting—the least the women of the Auxiliary can do is to provide one of the buildings needed at this Camp; and to this end I am asking every woman of the Auxiliary to contribute toward this fund. Let us give more scholarships to the Y. P. S. L. Camps; and let more of our women offer to serve as Counsellors.

Third—if we are to keep step with the young people, we must have more trained leaders, the lack of which is one of our greatest weaknesses. To correct this, let us send more women to the Adult Conferences.

We must remember that our responsibility is to EVERY woman in the Parish; that our field is the womanhood of the Church. Our duty is to see the talents of the individual and bring her into the kind of service she can give and into the Fellowship that we may share this Faith.

One of the great hopes of all Christendom is Church Unity, but that will not come unless we work for it, pray for it and cultivate a spirit of tolerance toward other denominations. We can begin by sharing in the World Day of Prayer, by sharing in the Good Friday Offering and by forming or joining discussion groups with the World Conferences as the subject.

We, women of the Auxiliary, are one in Faith. Our Unity is of heart and spirit. We believe this Faith must make itself manifest to the world. Let us ask ourselves in what way has my Faith expressed itself in Fellowship? Extraordinary conditions in the world today demand courage and enthusiasm to Go Forward, Faith to sustain us and Love to share with all for

## UNITED THANK OFFERING

Diocese of South Florida—Triennium 1934-1937

The report of the United Thank Offering for the Triennium 1934-1937 is one of encouragement and gain in the Diocese of South Florida. The Offering which was placed on the Golden Alms Basin at Cincinnati in October was larger by \$2,120.16 than the Offering sent to Atlantic City in 1934.

A study of the tabulated report shows that in a number of places there has been a steady forward movement and the number of women aroused to new interest is proved by the increase in the yearly gifts. Offerings were received from sixty-six parishes and missions, including ten Colored Congregations of the Diocese.

With regard to the offerings of the Colored Women of South Florida, a change was made during the last part of the three-year period, when, at the request of a number of the women gathered in the Diocesan Conference for Colored Workers, a separate colored custodian was appointed to receive and handle the collections from the Blue Boxes held by members of the Colored Congregations of the Diocese. With the authorization of our Bishop, the U. T. O. Custodian of South Florida paid over to the newly-appointed Colored Custodian, Mrs. Wilhelmina Davis, Tampa, the sum of \$112.20, which was the amount collected from the Blue Boxes of the Colored Congregations to June, 1937. From that time the U. T. O. work of the Colored people became a separate matter handled and reported directly to the National Council by the Colored Custodian as it is done in several other Southern Dioceses of the Province of Sewanee.

In the fifty-six places noted in the columns attached, there has been a rather general increase, with the distribution of a large number of Blue Boxes. There have been many letters telling of growing interest and of realization of the personal joy which the use of the individual boxes arouses. In one small mission, after six months use of the boxes in place of a yearly sum sent from the Auxiliary Treasury, the Offering was increased to four times the customary amount and members had come to realize the joy of PERSONAL giving. In several cases sums noted as "Individual Gifts" have been ended for the future, by the death of the donors of many years.

Offerings made at the spring and autumn meetings of the five Auxiliary Districts of the Diocese have been sent to the U. T. O. Treasury and for the three years during which the Corporate Service of the Woman's Auxiliary has been combined with the Early Communion Service of the Annual Diocesan Convention, the collection at that service has been given to the U. T. O. During the first year of the Triennium a small dividend from a closed bank in Tampa was received. As the itemized report shows, more than \$200.00 in interest was gained in the 3 year period, which proves the wisdom of frequent collections of the contents of the Boxes.

During the gathering of the 1934-1937 U. T. O. the Diocese was served by three custodians; Mrs. Amy Shaw, who had served for thirty years, resigned at the Annual Meeting of 1935; Mrs. T. B. McClelland carried on the work for the full year following, and the present custodian took over the position in April, 1936. It has been a joy and inspiration to these women to be in contact with so many workers in the diocese and to witness the splendid results of their faith and service.

Shall it not be the resolve of those who know the privilege and blessing of having a part in the great United Thank Offering which binds the women of the Church together in a thrilling comradeship of service for the Master; shall it not be their resolve for the new Triennium, to make this Offering more widely known and understood, until, in each home in the Diocese of South Florida, there will be a little Blue Box in which is being gathered gifts for the work and progress of God's Kingdom?

REPORT OF THE SECRETARY OF RELIGIOUS EDUCATION  
The Woman's Auxiliary to the National Council, Diocese of South Florida  
Annual Meeting, May, 1938

During the year 1937-1938 the work of the Department of Religious Education has shown satisfactory progress; indeed, in one respect, such outstanding advancement has been made that we might well call this a banner year. For the past seven or eight years, our Diocese has each summer had a few Auxiliary women in attendance at the Sewanee and Kanuga Conferences. In 1936, five members were present at the Sewanee Conference; one, at the Kanuga; six of our branches were thus represented. In 1937, we had THIRTY-EIGHT WOMEN present at summer conferences; five, at Sewanee; four, at Kanuga; twenty-nine, at the first South Florida Conference. It has repeatedly been said that no one thing will do more to stimulate interest for a branch of the Auxiliary than sending one or more members to a summer conference; this statement is true and will bear continued repetition. At a summer conference the Auxiliary woman finds an actual demonstration of "Fellowship in Faith and Work."

Our interest in Religious Education seems to be growing steadily; this is manifested in many ways. The great majority of our branches are doing educational work; they report not only study work, but numerous related activities. Of particular interest, forty branches list members teaching in the Church's School—a total of one hundred eighty seven teachers for the forty branches. You will recall that one of our Educational Objectives is, "To encourage a more active interest in the Church's School." The Auxiliaries should see that each of these one hundred eighty seven teachers has a copy of the booklet, "Re-Thinking Religious Education." This booklet contains a wealth of valuable suggestions; not only our Church School Teachers, but every Auxiliary woman, will find it helpful: it will clarify her thinking and guide her in her efforts to find "Fellowship in Faith and Work."

However, despite the fine work being done by the majority of our branches, the fact remains that 8 did no educational work in the past year. We can never rest content until each of our branches is awake to the importance of Religious Education. The Forward Movement suggests seven key words as a basis for a disciple's Rule-of-Life: "LEARN" is the third of the seven words. Whether we are members of a large group in a big parish, or whether we are members of a small group in a little mission, we are each "a member in Christ"; we each labor under that Great Commission, "Go ye therefore, and teach . . ."; under the command, "Ye shall be witnesses unto me". How can we hope to teach, how can we expect to bear witness unto Him, unless we are ever alert to keep ourselves informed? On May sixth we go forward into a new year of Auxiliary work; let us realize that through study classes held in His name, we have an opportunity to deepen our faith, a wonderful opportunity to develop Christian fellowship.

From a devotional standpoint, the majority of our branches have made a good record for the year; yet, here too, we must face the fact that some failed to celebrate even one Corporate Communion and one Quiet Day—our stated objective. We do appreciate the position of the small mission with no resident clergyman. However, if you explain to the rector who supplies for your mission, he will be glad to help you meet this objective. We are so human, so prone to give up in the face of obstacles; and yet, we usually find a way—or make a way—to do the thing we are determined to do, the thing we really long to do. From its beginning the Woman's Auxiliary has placed first emphasis upon spiritual development. We will each admit that the life of the organization is strengthened by a short, vital service of worship at each meeting, by prayer groups, by days of intercession, by quiet days, by corporate communions. In the last analysis, the intention to find God, to yield ourselves to His will, is the primary and essential fact of religion. The Bible states that God is "a rewarder of them that diligently seek Him." This is so of the organization, as well as of the individual.

And so, in 1938-1939, let us resolve anew to seek Him diligently; let us come together expecting, above all else, to find God, to experience His real presence, to worship Him. In this way we will come to know, we will help other to find, "Fellowship in Faith."

REPORT OF DIOCESAN SECRETARY OF CHRISTIAN  
SOCIAL SERVICE

Madam President and Fellow Workers:

As Secretary of this Department, I am happy to report that there has been some advancement shown in the work during the past year. When you analyze the reports which were sent in for the year, and see the thousands of hospital and home calls, letters and cards, flowers, clothing, reading matter, baskets and trays of food and fruit, gallons of milk, car rides and cash given, together with the other miscellaneous kindnesses, you will have some small conception of the wonderful work being done.

In spite of these marvelous reports, the prevailing idea of the women of this Diocese seems to follow the instruction in the Gospel of St. Matthew, 6:3, "But when thou doest alms, let not thy left hand know what thy right hand doeth," and this in a measure has greatly retarded the reporting of the Christian Social Service work.

If we would only remember that our Saviour also said, "Let your light so shine before men, that they may see your good works and glorify your Father which is in Heaven." He also said, "Neither do men light a candle and put it under a bushel, but on a candlestick, and it giveth light unto all that are in the house."

The women of the Auxiliary are one in faith, "Therefore, while we have time let us do good unto all men, and especially unto them that are of the household of Faith," which is one of the offertory sentences.

Our Unity is of heart and spirit, which we must make manifest to the world, and how can we make it manifest unless we are willing to tell about it.

These reports must have some meaning, else we would not be asked to give them. So let us try to comply with the request from the National Council and make these reports with a willing spirit, for how else has our Faith helped us to extend fellowship to the World, unless it is through the work of Christian Social Service. It is then your reports will speak for themselves.

I would like to take this opportunity to thank you most sincerely for the splendid help that you have given me as Secretary of Christian Social Service, but I would also urge you to get away from the feeling of hesitancy in making known to the world the little acts of helpfulness in bringing about our Lord's injunction, "Peace on earth and good will towards men."

After all, Christian Social Service is merely the showing of our Christianity one toward the other, without hope of reward. It is these little contacts that we make which will build a more Christ-like world. That is what Auxiliary women are striving for—to follow in the footsteps of our Master, hearing the far-reaching call from St. Matthew: "And the King shall answer and say unto them, 'Verily I say unto you, inasmuch as ye have done it unto one of the least of these, my brethren, ye have done it unto me'."

## REPORT OF SUPPLY SECRETARY

The women of the Auxiliary of this Diocese have during the past year contributed surgical dressings to hospitals and dispensaries and cash for warm clothing for missionaries in China; boxes of supplies and clothing to three Home Mission schools (Bethany Mission in Rugby, Tennessee; Lower Pocosan Mission in McMullen, Virginia; St. Thomas' Mission at Point Hope, Alaska); and three personal boxes for missionaries and their families, (one in Brevard, North Carolina; one in Statesville, North Carolina; and a third to Minneapolis, Minnesota).

The most outstanding work was the quick response to a call from Mrs. Wade, National Supply Secretary, for \$200.00 for St. Thomas' Mission, Point Hope, Alaska. Each Branch I asked to contribute did so. Two could not send the full amount but \$191.50 was sent. Mrs. Wade wrote me that it was a splendid piece of work; so naturally I cannot help but feel that we are taking Supply Work more seriously.

How we can extend "Fellowship in Faith and Work?" In the Diocese of South Florida, we have twenty-four Parishes, forty-eight organized Missions, twelve unorganized Missions, thirteen dormant Missions and one Parochial Mission—a total of ninety-eight. Seven of this number are Colored Missions, which leaves us ninety-one Parishes and Missions. From this number, fifty-five contributed to the Supply Department. You can readily see that we have much work to do, as each Mission should have the privilege of sharing in this most necessary work, to further God's Plan on Earth.

Those not contributing to the Supply Work are Missions, where they have no organized Woman's Auxiliary. I have written to the Priests who serve several of these Missions, asking for a name of some member of the Mission Church; but, so far, I have not been successful in making contact with any of them, except two which are near my home. Both of these are now contributing to the work. So I feel that the personal contact is the only way to get them started. I would suggest that each Supply Secretary living near any of these dormant Missions find some one interested and send their name to the Diocesan Supply Secretary.

This work is worthy of any effort we can make to give each Church member a chance to share with us the great privilege God has given us. Did you ever stop to think how handicapped the missionaries in the field would be without the aid of Supply Workers? So let every member of the Woman's Auxiliary in South Florida make an effort to find some Church woman who is not contributing and interest her in the work. Many of our rural women would be only too glad to share this joy with us.

It has been impossible for me to visit the different Branches but I commend to you the prayer for the Supply Work, as more things are accomplished by prayer than any one ever knows, and only through prayer and God's guiding hand can we go forward in Fellowship in Faith and Work.

For your splendid work and cooperation, I thank you.

GLADE CROSS MISSION  
Everglades, Fla.

First I want to thank the members of the Woman's Auxiliary of the Diocese of South Florida for their loving interest and help in the work among the Seminole Indians. Without you the work could not have been started, and without you it could not have been so successful.

The work has grown beyond our expectations and when the Indian Council gives its consent practically the whole tribe will come into the Church. Four are ready now and the other three are very friendly.

The work along the Tamiami Trail goes to Miami and in these villages there are few opportunities for gathering the Indians but much individual work is done and with the use of Bible pictures and an interpreter the Gospel story is told.

Out in the Everglades one sees the real life of the Seminoles and always going with Indians I am assured a welcome. The driver knows the way and acts as my interpreter. Staying one or two nights with them is a great help in knowing them better. The Mission extends 62 miles and many villages are visited.

The industrial work is an important part of the Mission. Last year 67 different Indians brought to the Mission over one thousand dollars worth of things they made. This enables me to help those in need and makes contacts for spiritual work; it also develops their native arts and crafts. Those who have helped me to get a market for these things help much.

Once a month the Mission visits the county jail in Everglades and sees each of the prisoners individually.

Through the Church Periodical Club books and magazines have been distributed among the fishing people among the Ten Thousand Islands; through these contacts several have been baptized.

In Everglades there are 16 white Communicants and Church literature is distributed and services arranged when a cleryman can be secured.

The first and third Sundays of each month Bible classes for children and adults are conducted, a meeting of the women on Saturday afternoon, and Evening Prayer on Sunday night on the Island of Marco. This is an important work. There are 11 members of the Church and several will be confirmed in the fall.

An adult Church class of 8 members—communicants of the Church—is held in Immokalee the fourth Sunday of each month. The work is heavy but with your partnership—your prayers and gifts—the work goes on.



**CONSTITUTION AND BY-LAWS**

of the  
 Woman's Auxiliary to the National Council in the  
 Diocese of South Florida

Revised as of May 5, 1938

**CONSTITUTION****ARTICLE I—Name**

The name of this organization shall be the Woman's Auxiliary to the National Council in the Diocese of South Florida.

**ARTICLE II—Object**

The object of this organization shall be to carry forward the three great aims of the Church: Extension of the Kingdom, Religious Education, and Christian Social Service, through Prayer, Study, Work and Gifts, in the Home, Parish, Community, Diocese, Nation and World.

**ARTICLE III—Membership**

All women of the Diocese, by virtue of their Baptism, are eligible for membership in the Woman's Auxiliary.

**ARTICLE IV—Organization**

The Woman's Auxiliary in the Diocese of South Florida shall be organized into Five Districts, same to be called District One, Two, Three, Four and Five, respectively.

**ARTICLE V—Officers**

Section 1. The officers of this organization shall be: President, Vice-Presidents, these being the Directors of the Districts; a Recording and Corresponding Secretary combined, a Treasurer, an Educational Secretary, a United Thank Offering Custodian, a Christian Social Service Secretary, and a Supply Secretary.

Section 2. The Directors of the Districts shall automatically become Vice-Presidents of the Diocesan Branch; the First Vice-President being always the President of the District in which the next Annual Meeting is to be held.

Section 3. These Officers shall constitute the Executive Board.

**ARTICLE VI—Meetings**

Section 1. The Annual Meeting shall be held at the same time and place as the Annual Convention of the Diocese.

Section 2. Each and every Parish branch shall be entitled to representation in the Annual Meeting by three duly elected delegates, and each Mission branch by one duly elected delegate. Only delegates from branches which have paid their Expense Fund shall be entitled to vote.

Section 3. All members of the Executive Board shall be entitled to all privileges of the Annual Meeting, including the right to vote.

Section 4. The Executive Board shall meet once a year, and the President shall be empowered to call a meeting at any time that she may consider necessary. The Board shall have authority to fix its quorum and to adopt other By-Laws for its government.

Section 5. District meetings shall be held twice a year, preferably in the Spring and Fall.

**ARTICLE VII—Quorum**

A quorum shall consist of delegates representing one-fifth of the total number of Parochial and Mission branches.

**ARTICLE VIII—Amendments**

This Constitution may be amended at any Annual Meeting by a majority of the delegates present and voting; due notice of the proposed change having been given to the Executive Board two months prior to the Annual Meeting; and upon the approval of the Bishop of the Diocese.

**BY-LAWS****1. Elections**

Section 1. Election of Officers: The President shall appoint a committee of three at the Annual Convention to receive nominations. Nominations may be in writing or from the floor. All names shall be presented to the Convention. Voting shall be by ballot. If there is no majority on the first ballot, all names shall be dropped but the three having the largest number of votes. Of these three, the one receiving the largest number of votes on the second ballot shall be declared elected.

Section 2. All Officers shall be elected annually and for a term of one year. No Officer, having served for three years, shall be eligible for re-election until after the lapse of one Convention year. All Officers shall serve until their successors shall be duly elected and qualified.

Section 3. District Directors shall be elected annually by their own constituencies at the Spring meeting preceding the annual Diocesan meeting.

Section 4. The names of five delegates and their alternates to the Triennial Convention shall be presented by the nominating committee and elected at the Annual Meeting preceding the Triennial Convention. The Diocesan President shall be one of the five delegates.

Section 5. The names of five delegates and their alternates to the Provincial Auxiliary meeting shall be presented by the nominating committee and elected at the Annual Meeting preceding the Provincial meeting. The Diocesan President shall be one of the five delegates. It is provided, however, that the delegates to the Triennial Convention shall be considered duly qualified delegates to any Provincial meeting which shall be called at the time and place of the Triennial Convention.

Section 6. All vacancies in offices, occurring during the intervals between Annual Meetings, shall be filled by the Executive Board.

**2. Duties of Officers**

Section 1. The President shall preside at all meetings, appoint all committees, and have general supervision of the work throughout the Diocese. She shall be ex-officio a member of all committees.

Section 2. The Vice-President shall assist the President and, in her absence, shall perform all the duties of that office.

Section 3. The Secretary shall keep a correct record of the proceedings of all meetings of the organization and of the Executive Board; issue all notices of all meetings; conduct the correspondence; submit a written report to the Annual Meeting; and prepare and edit with the President the Annual Report (or Year Book).

Section 4. The Treasurer shall receive all monies except the United Thank Offering, and pay such bills as are endorsed by the President. She shall forward all monies given for special causes, and shall make a quarterly report of receipts and disbursements to the President. At the Annual Meeting, she shall make a report covering receipts and disbursements for the year. At the end of the fiscal year, her accounts shall be audited by a public accountant.

Section 5. The District Directors shall have general supervision of the work in their Districts. In the absence of the President, they shall, in the order of their rank, perform all the duties of that office, it being understood that the Director of the District in which the next Annual Meeting is to be held shall rank as First Vice-President. They shall stimulate the activities of all Parish and Mission branches; form new branches; preside at all District meetings; and make reports to the Annual Meeting. They shall notify the Diocesan Secretary of any changes that occur in the branches in their District.

Section 6. The Secretary of Religious Education, the Secretary of Christian Social Service and the Supply Secretary shall carry out as nearly as possible the program suggested by the National Council.

Section 7. The United Thank Offering Custodian shall receive the United Thank Offering in the Spring and Fall and remit to the Treasurer of the National Council.

Section 8. All Officers shall present written reports at the Annual Meeting.

**3. Assessments**

Each local branch shall be assessed a certain amount for current expenses

**4. Amendments**

These By-Laws may be altered or amended by a majority of the delegates at any Annual Meeting.

**5. Rules of Order**

Roberts' Rules of Order (revised) shall govern all meetings.






