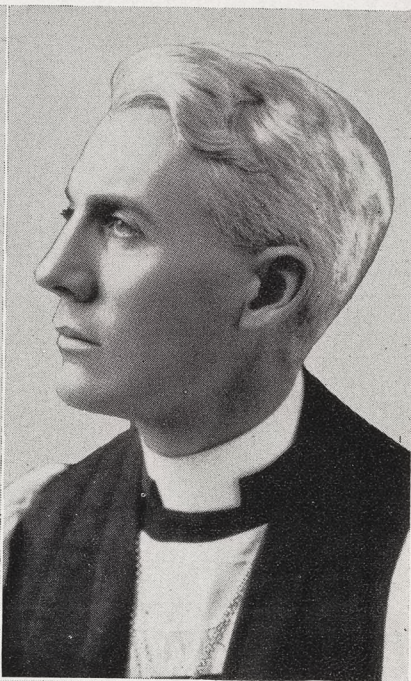

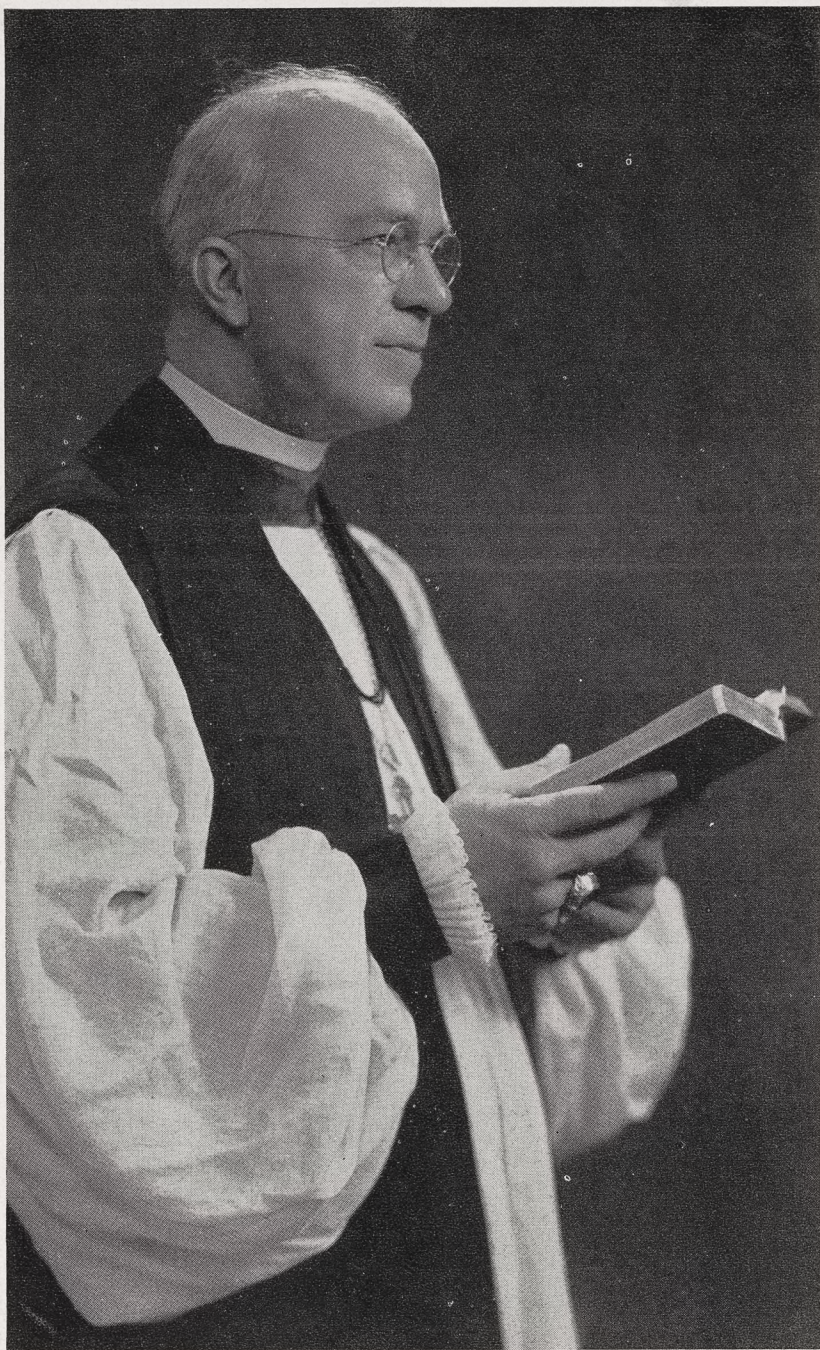

## PROCEEDINGS OF THE ANNUAL MEETING

The Annual Meeting of the Woman's Auxiliary of the Diocese of South Florida was held in Sanford, Florida, April 25-27, 1939.

At 3:00 P. M. on April 25th, the following Conferences for Department Leaders were held in Holy Cross Parish House:

Conference for Presidents led by Miss Alpha B. Nash;

Conference for Educational Secretaries led by Mrs. Thomas G. Price;

Conference for United Thank Offering Custodians led by Miss Elizabeth Rand;

Conference for Supply Secretaries led by Mrs. O. R. Grosse.

The opening service of the Convention was at 8:00 P. M. in Holy Cross Church; with the Rt. Rev. Frank E. Wilson, D.D., S.T.D., Bishop of Eau Claire, as the Preacher.

Corporate celebration of the Holy Communion was held at 7:30 A. M. on Wednesday morning, April 26th, in Holy Cross Church, with Bishop Wing as Celebrant.

## OPENING BUSINESS SESSION

Wednesday, April 26th.

## THEME

Reality in Fellowship.

The joint opening session of the Seventeenth Annual Convention of the Diocese and the Annual Meeting of the Woman's Auxiliary of the Diocese of South Florida was called to order by the Rt. Rev. John D. Wing, D.D., LL.D., at 10:00 A. M., Wednesday, April 26th, 1939, in the Mayfair Hotel, Sanford, Florida. Opening prayers were said by Bishop Wing; after which the President of the Woman's Auxiliary, Miss Alpha B. Nash, read her annual report. Immediately thereafter Bishop Wing gave his annual report to the Convention.

(Full text of Bishop Wing's report was printed in the May, 1939, issue of the Palm Branch and will, therefore, not be repeated herein.)

Whereupon the meeting was adjourned and the Convention retired for deliberation elsewhere in the Hotel.

The business session of the Woman's Auxiliary was called to order by the President. Opening prayer was led by Mrs. Thomas G. Price, of Ft. Myers; after which Mrs. Price presented the theme of the meeting, "Reality in Fellowship".

The President extended cordial greetings to all delegates and visitors. The President of the Hostess Branch, Mrs. A. M. Phillips, welcomed the assembly and the response was made by the First Vice-President of the Auxiliary, Mrs. George E. Krug.

The Past President of the Woman's Auxiliary, Mrs. Deane Turner, was recognized by the Chair and presented to the meeting. Mrs. Turner brought a brief greeting to the women of the Diocese.



The President introduced the five new members of the Executive Board: Mrs. Wilbur F. Divine, Treasurer; Mrs. George E. Krug, Director of District Two; Miss Elsie Coates, Director of District One; Mrs. Gladstone Rogers, Director of District Three; and Mrs. D. H. Saunders, Director of District Five.

The Secretary called the roll of the Branches to which 23 Parishes and 24 Missions responded; with a total of 90 Delegates and 102 Visitors; 11 Diocesan Officers; and 3 Diocesan Chairmen.

The presentation of the Convention Gift was then made.

The first report of the Credentials Committee was called for by the President; which showed 22 Parishes and 22 Missions; 84 Delegates; 31 Visitors; registered at the opening hour of the meeting.

The First Vice-President took the chair and Miss Nash explained the assignment, by the National Council, of St. Elizabeth's School in South Dakota as a project of the Woman's Auxiliary of this Diocese in the present National Crisis. A portion of Bishop Roberts' letter of appreciation and explanation of the school was read by the President; who thereupon resumed the Chair.

Mrs. W. O. Kinnebrew, Secretary of the Woman's Auxiliary of the Diocese, read her annual report.

Mrs. Divine then read the annual report of the Treasurer; followed by the auditors' reports covering the periods of January 1st to May 31st, 1938, and June 1st to December 31st, 1938; which, upon motion, were duly accepted.

Mrs. John E. Culmer, President of the Colored Convocation of the Woman's Auxiliary of the Diocese, gave a short report of the work of her organization and appealed for assistance in leadership by local Branches in places where there are Colored Organizations.



Mr. Morton O. Nace announced plans for the Summer Camps and left literature; which he asked to be carried back to the Branches.

Mrs. Price gave the report on the Gift of Life and with pride called attention to the fact that Miss Charlotte Kamper, a former Gift of Life recipient, had been selected as one of five students from the Southern States to go to the National Youth Congress meeting in Amsterdam in July.

Noon-day Prayers were said by Bishop Wing; after which he presented the Negro work in the Diocese as a challenge to the women, speaking in part as follows:

"I do not believe there is a like opportunity in this whole country as the missionary work to be done for the negroes right here in our own Diocese,—negroes who were reared in our Church—brought in here from the Bahamas and the British West Indies—not less than 6,000 of them in South and East Florida. These are not like the American negroes whose training and back-ground are foreign to the Episcopal Church. The Church of England has made a substantial success in its work with the negroes. Florida is the only place where it can be shown what can be done with the negroes. Other places other Churches are already there in possession. Ye that are strong should bear the infirmities of the weak.

We spend nearly \$5,000 a year on the negro work. This nearly \$5,000 expended for this work comes from New York. If the deficit, known as the National Crisis, is not made up, it means that \$900 must be cut in the salaries of the workers here. We used to be a Missionary District. We gradually took over the White work but have done nothing for the negroes. I wonder if we must not, in our self-respect, do it. It is our job. It is our obligation to support the negro work ourselves. As the negroes grow stronger, they will gradually assume their own support.

At Daytona Beach is a negro college. Negroes from Miami, Key West, West Palm Beach and all up and down this coast come there to go to school, but there is no Church there for them. They have their own Churches at Miami, Key West and West Palm Beach but they are denied one at Daytona. They cannot take the Communion there; which is a great deprivation. They have commenced having services in a home.

I want to buy a lot in Daytona. Anything of value costs something. I can get a lot suitable for a negro Church for \$1200. I am not asking for a general campaign but won't you see what you can do, and DO IT QUICKLY? I have an option to take up on this lot on May 12th. I think it would be a fine thing if the women of this Auxiliary would take it as a part of their work the coming years to spread the Gospel among the colored people just right here at our door. In France they speak of noblesse oblige. There are certain things which are expected of all of us because we are what we are—representatives of the finest white citizenry in the State of Florida. God has every right to expect great things of you."

Thereupon the Bishop retired from the hall and immediately pledges were made toward the purchase fund for the above referred to lot by the following Branches: Lake Worth, \$5.00; St. Cloud, \$5.00; Sarasota, \$10.00; Sanford, \$10.00; Vero Beach, \$5.00; Miami, Holy Cross, \$10.00; Ft. Pierce, \$10.00; Leesburg, \$5.00; Hollywood, \$3.00; Lakeland, \$10.00; Daytona Beach, Trinity, \$10.00; Winter Park, \$25.00; Avon Park, \$5.00; Cocoa, \$5.00; Daytona Beach, St. Mary's, \$20.00; Zephyrhills, \$3.00; Auburndale, \$5.00; Bradenton, \$10.00;



Ft. Lauderdale, \$5.00; Deaconess Bedell for three Missions, \$10.00; Kissimmee, \$5.00; Eustis, \$5.00; St. Petersburg, St. Bartholomew's, \$5.00; Winter Haven, \$10.00; DeLand, \$5.00; Orlando, \$10.00; Tampa, St. John's, \$5.00; Fruitland Park, \$5.00; St. Petersburg, St. Peter's, \$10.00; Delray Beach, \$5.00; Lake Wales, \$5.00; and the following personal donations were made: Mrs. Joseph Halton, Sarasota, \$10.00; Mrs. Charles H. Reach, Sarasota, \$5.00; making a total of \$256.00 pledged toward the purchase price of the lot in Daytona Beach.

Miss Elizabeth Rand, United Thank Offering Custodian, gave a challenge for this, the Jubilee Year of the United Thank Offering. She then introduced Mrs. Venora P. Mingo, a United Thank Offering worker at St. Peter's School, Key West, who gave a full account of the work done there and presented the needs of the School.

Meeting recessed for lunch.

#### Afternoon Session—April 26, 1939.

The afternoon session of the meeting of the Woman's Auxiliary reconvened at 2:15. The President announced that, with their permission, the reading of the minutes of the morning session would be deferred until Thursday morning.

Mrs. O. R. Grosse, Supply Secretary, gave her report which showed an increase of three Missions doing Supply work.

The Rt. Rev. Frank E. Wilson, D.D., S.T.D., Bishop of Eau Claire, gave an address covering the History of the Formation of the Diocese of Eau Claire.

The Rev. John B. Walthour, Diocesan Chairman of the Department of Christian Social Relations, presented a program for that Department. He was followed by the Rev. Frank M. Brunton, Chairman of Parochial Social Service, who gave suggestions for furthering that phase of the work.

A note from Bishop Wing, thanking the meeting for the pledges for the Daytona Beach lot, was then received and read to the assembly by the President.

The amount of the Convention Gift was reported by the Treasurer as \$1,418.00.

The Rev. Hamilton West, Student Chaplain at the University of Florida, gave a report on his work, as well as a report of the progress of the new chapel at the University, and announced that the ground for the chapel would be broken on April 28th.

The President announced that she had just been asked by the Rev. W. L. Hargrave, Chairman of the Department of Missions and Church Extension of the Diocese, to name five women of the Auxiliary who would, in turn, be recommended by him for election by the Executive Board of the Diocese to serve as members of that Department.

Meeting recessed at 4:00 P. M.

#### Business Session, April 27, 1939.

The business session of the Woman's Auxiliary reconvened on Thursday, April 27th, 1939, at 9:30 A. M., with the President in the chair.

Hymn 489 was sung; followed by the Woman's Auxiliary Prayer repeated in unison.

Minutes of the preceeding day's session were read by the Secretary and approved by the meeting.



## WOMAN'S AUXILIARY

Mrs. W. F. Divine, Diocesan Treasurer, asked to make a correction stating that the amount of the Convention Gift was \$1,362.00 instead of the amount previously announced.

Mrs. Bowen, of Lake Worth, announced that the amount pledged by the Auxiliary of Lake Worth for the Colored work in the Diocese was intended as a yearly pledge.

The President thanked the President of the Hostess Branch, Mrs. Phillips, personally for the corsage sent her for the banquet, and expressed her appreciation to the Hostess Branch for the flowers sent to all members of the Executive Board and the many courtesies extended to every one.

Miss Nash read a response, written by the Poor Parson, to the poem she had read at the banquet on the previous evening; which created considerable amusement.

Mrs. Thomas G. Price, Secretary of Religious Education, read her annual report; after which she presented the speaker for that Department, Dr. Alexander Guerri, Vice Chancellor of the University of the South, who spoke on "College Chapel".

The following resolution was brought to the meeting from the Convention.

"Approving of the joint session of the Woman's Auxiliary and this Convention held yesterday and seeing therein possibilities for the improvement of future programs of the Convention:

BE IT RESOLVED by this Convention that a committee of three members be appointed to confer with a similar number of the Woman's Auxiliary of the Diocese, charged with the responsibility of studying the program and the possible changes to be made advantageously therein; which committee may, in consultation with the Bishop and the President of the Woman's Auxiliary, suggest changes in arrangements and methods for 1940.

G. I. Hiller, Chairman of Standing Committee.

A motion was made by Mrs. Price that we heartily endorse the above resolution; which motion unanimously carried.

Miss Julia Gehan, Student Worker at F. S. C. W., gave a report of her work and thanked the Auxiliary for so generously providing a discretionary fund which enabled her to do many things for the students which would not otherwise be possible.

Deaconess Harriet M. Bedell gave a report of her work which includes work among the Seminole Indians, the inhabitants of Marco Island and the residents of Everglades, Florida.

A request came from the Convention that the President of the Auxiliary send to the Bishop the names of the members of the Auxiliary who were to be on the Convention Program Committee for next year, as provided for in the foregoing Resolution. Miss Nash appointed the following as members of that Committee: Mrs. Thomas G. Price, Mrs. W. O. Kinnebrew and Mrs. D. H. Saunders; and immediately sent their names to the Bishop. It was announced that the Bishop had appointed the following as members of that Committee: the Rev. G. I. Hiller, Dr. E. L. Pennington and Mr. Lynn T. Nichols.

The Rev. Mr. Bram spoke on the Adult Conference which will be held in Avon Park, July 2-8.



The following reports were read by the Chairmen:

Forward Movement by Mrs. Thomas G. Price;  
Co-Operating with Young People's Work by Miss Aileen Mitchell;  
Church School Service Program by Mrs. S. J. Matatics;  
Prayer Partner and Publicity by Mrs. W. G. Seekins.

Mrs. Seekins read a program for the Publicity Department and asked for its endorsement; which was unanimously given.

The President announced that the Bishop had requested the meeting to nominate some one to fill the vacancy on the Cathedral School Board caused by the resignation of Mrs. W. F. Moses. Mrs. T. E. Emery, of Winter Park, was nominated for that office.

It was announced by the President that the names of the Departments of Christian Social Service and Religious Education had been changed by the National Council to "Christian Social Relations" and "Christian Education"; and that automatically those Departments of the Woman's Auxiliary take the new names.

The final report of the Credentials committee was called for; and Mrs. Amelia Noble, Chairman, reported:

Mrs. George H. Just gave the report of the Resolutions Committee for Mrs. Gordon B. Knowles, Chairman. Mrs. Just moved the adoption of each Resolution, in turn; which Resolutions were as follows:

#### Resolution No. 1. Peace.

WHEREAS, Christian men and women continue to face a world torn by strife and war.

AND WHEREAS, peace cannot be built by human might, but only by the spirit of God can hearts and minds be united,

BE IT RESOLVED: That we as Christian women, continue to pray for peace and unity.

Resolution adopted.

#### Resolution No. 2. Colored Work.

WHEREAS, we realize the need for our spiritual help and co-operation in the Negro work,

BE IT RESOLVED: That the members of the Woman's Auxiliary endeavor, in every way possible, to help with the Negro work in the Diocese.

AND BE IT FURTHER RESOLVED: That each Auxiliary group in the Diocese assist the Colored Branch in its community.

Resolution adopted.

#### Resolution No. 3. National Deficit.

WHEREAS, there is a deficit in the Apportionment for missionary work of the Church, causing a national crisis,

BE IT RESOLVED: That we, the members of the Woman's Auxiliary of the Diocese of South Florida, realizing the immediate needs in this crisis, pledge \$1,000.00 to St. Elizabeth School in the Diocese of South Dakota.

Resolution adopted.



**BE IT RESOLVED:** That we express our appreciation and gratitude to our guest speakers, the Rt. Rev. Frank E. Wilson, S.T.D., Bishop of Eau Claire, and Dr. Alexander Guerri, Vice Chancellor of the University of the South, for the great spiritual help and new thought expressed in their messages to us.

Resolution adopted.

**BE IT RESOLVED:** That we, realizing the spiritual leadership of our beloved Bishop, do hereby express to him our appreciation for his guidance and our wish to uphold and strengthen his work in the Diocese.

Resolution adopted.

**BE IT RESOLVED:** That we, the members of the Woman's Auxiliary, express our appreciation of the help and inspiration given us by our President, Miss Alpha B. Nash, and all other Diocesan Officers.

**AND BE IT FURTHER RESOLVED:** That a vote of thanks be given the retiring Officers for their faithful service.

Resolution adopted.

**BE IT RESOLVED:** That we, the members of the Woman's Auxiliary of the Diocese of South Florida, assembled for the 17th Annual Meeting, as guests of Holy Cross Church, Sanford, wish to thank the Rev. Martin J. Bram and his Committeees, for their gracious hospitality and many courtesies shown us during this Convention.

**AND BE IT FURTHER RESOLVED:** That we thank those who assisted in arranging the various exhibits.

Resolution adopted.

The Committee was thanked for their work by Miss Nash and dismissed.

Noon-day Prayers were said by the Rev. W. A. Lillicrop, Rector of the Church of the Redeemer, Sarasota.

The President reminded the women of the Auxiliary of the great opportunity they would have in hearing the leading Church people of the Province at the Provincial Meeting in Tampa, and urged that every woman who possibly could attend do so and consider herself an official hostess for this Meeting.

The Chair announced that, with the permission of this assembly, she would appoint some one to meet with her and approve the minutes of this morning's session.

There being no further business the meeting adjourned and the Rev. Mr. Pollard pronounced the benediction.

## REPORT OF PRESIDENT

Woman's Auxiliary, Diocese of South Florida

April 26, 1939

If every woman here had read her Palm Branch, it would not be necessary for the President to make a report as your representative in the Diocese, and elsewhere, because our Publicity Chairman has so ably filled her position that the events have all been published as they occurred.

Your President was very happy to be one of the eleven women from South Florida who attended the Sewanee Conference held at the University of the South. Only those who have been to Sewanee can know the real value of the ten days spent in study, worship and fellowship in that beautiful spot on top of the mountain. You will hear from others of the fine exhibit of the Department of Education; and it is with pride that I say that our Diocese received its share of the awards.

In October, the Provincial meeting of the Woman's Auxiliary was held in Winston-Salem, North Carolina; and this Diocese was represented at the Board meeting by your President, and at the Provincial meeting by our full strength of five delegates and (to their credit) by three visitors. It was my privilege to serve on the Nominating Committee and as Chairman of the Findings Committee. The invitation of St. Andrew's Church, Tampa, extended by your President to the Woman's Auxiliary of the Province, to meet in Tampa in the Fall of 1939, was accepted.

Ten District meetings of the Woman's Auxiliary have been held in this Diocese during the past year; and it was my pleasure to attend seven of these meetings. We were indeed fortunate to have as our guest speakers at all five Spring meetings the Rt. Rev. William Blair Roberts, D.D., Bishop of South Dakota, and Mrs. Fred Ramsey, of Knoxville, Tennessee, the Provincial President of the Woman's Auxiliary. Bishop Roberts brought to us a vision of the Church at work in a Missionary District in the Far West and the great need of support for this work. Mrs. Ramsey's message presented the practical application of the Woman's Auxiliary to the needs of the Church.

In order that we may take courage and go forward, it is necessary for us to consider our accomplishments and our failures of the past year. Definite recommendations and Objectives, other than the Department Objectives, were then given for this year. Let us take a look at the results.

The first recommendation was in regard to our own organization in Parishes where there were more than one group. I am delighted to say that four of our growing Parishes (Sarasota, Sanford, St. John's (Tampa) and Ft. Myers) have re-organized, or are in the process of re-organization under the Unified Plan. Next year will show a very definite growth in these Parishes with a strong central organization.

The President's second recommendation (the Second Diocesan Objective) has been so wholeheartedly carried out that it is impossible for me to express my gratitude to the Branches who made possible the 100% fulfillment. To date, \$1,052.00 has been given to the Permanent Diocesan Camp Fund. To every woman who helped, to every one who contributed, I am deeply grateful; and, when you see the Camp buildings, you will all be glad you have had a part.

Now, it is necessary for us to look at our failures,—our weakness. Bishop Wing gave us our First Diocesan Objective,—to make every Churchwoman a member of the Woman's Auxiliary. As I compare the membership of the Auxiliary this year (1938) with 1937, I find that 20 Branches have lost a total of 215 members;—of these 55 were by death. 21 Branches gained 255 members; and 15 are unchanged in membership;—making a total gain in the entire Diocese of 40 members. Have we met the challenge? Why have we failed?



Another comparison is necessary if we are to frankly face our failures, as well as our advances. In the annual reports from the Branches, there has been a steady growth in the amount contributed by the Branches to the Parish work. But what about the amount we give outside of our Parish; outside of our Diocese? The only thing we give as an organization outside of the Province is the amount given through the Supply Department and our United Thank Offering. Both of these Departments show a slight increase this year. Let us not put the Parish luxury ahead of necessity in the Mission Field. True this is a young Diocese and many Parishes and Missions are just getting on their feet following the Florida Boom; but the Presiding Bishop said in an address to a Diocesan Branch of the Woman's Auxiliary,

"There is nothing the Church needs more than something that will save us from the danger of promoting our own welfare. It may be of our Parish, of our Diocese or of our Nation."

We have been told that there are 16,000 members of the Protestant Episcopal Church in South Florida,—more than in any other Diocese in this Province. Is there any reason why the Woman's Auxiliary of one Diocese in this Province can give \$1,000 for the support of a missionary in the Foreign Field, and we do not? Is there any reason why the Woman's Auxiliary of another Diocese in this Province can give \$3,400 to the Church's program outside of their own Diocese, and we cannot? Is there any reason why the Woman's Auxiliary of a Diocese, whose membership is less than ours, can support a missionary in the Domestic Field, and we give nothing for that purpose? Have we failed to keep before the women of this Diocese the needs of the Church?

I do not believe the women of the Auxiliary of South Florida are any less loyal, any less generous, any less interested than the members in other Dioceses; but we must ask ourselves where are we, as Church-women, at fault? Is it because we, as individuals, are not making the effort to interest other women? With a membership of about 2,000, where are those 4,000 other Church-women? Let us be honest with ourselves when we ask the question: why is my Branch not increasing in members in the proportion my Parish membership increases?

The whole Church has been called by Bishop Tucker to "finish the job" in this great missionary crisis. The Woman's Auxiliary has been called upon to serve in any capacity possible; and there is probably, as Miss Lindley said, no other group so able to do the part asked.

The Woman's Auxiliary of this Diocese has been asked to assume \$1,000 as our share in the Crisis; and we have been assigned by the National Council St. Elizabeth's School in South Dakota as our project. I am sure this amount will be given. Already \$827.00 has been pledged. But what about the future? If, as we are told, this deficit is not just for this year, if the Church is even to continue her work as it is now,—this amount will be needed every year. How are we to have our share in the Church's work?

The answer is found in Bishop Wing's challenge. That challenge was not made for one year. It stands until we meet it. Our task lies in giving these disinterested Church-women the opportunity to serve; and, when we have made every Church-woman a member of the Auxiliary, we will not need to worry about how we can help. We can answer Our Lord's command, "Go ye into all the world" with our gifts to support those who are serving in our stead.

## DEPARTMENT OF THE UNITED THANK OFFERING

The message for us today from the Department of the United Thank Offering is one of Privilege, of Responsibility and of Vision.

Do you know that this is the Jubilee Year of the United Thank Offering? On the third of October, 1939 it will be fifty years since the members of the Woman's Auxiliary, meeting in New York City at the time of the General Convention of 1889, gathered for a service at the Church of The Holy Communion and placed on the altar the first United Thank Offering. So small it was, so pitifully inadequate, though by a fine and generous gift it was increased, so that from that offering a tiny chapel was built in Anvik, Alaska, and a young woman-missionary was sent to work among the women of Japan.

We know the story of the growth of the Offering when once it was understood, and presented as a UNITED Offering, not only for those who came to the meetings of General Convention, but for ALL women who found themselves united by the bonds of Prayer and Gifts and Joyful Service. From two thousand to twenty thousand, the Offering grew by the next Convention, three years later, and then onward and upward; and that one small building in Alaska was but the forerunner of chapel, school, hospital and mission-buildings scattered throughout the Church's field, in our own country, in far-off lands and in the islands of the sea. And through the half century, a noble army of women-workers has followed and is following now, that one brave young soul who went out as the first United Offering missionary. We may well keep this Jubilee Year with thanksgiving for the privilege of such service.

We must realize, however, that with the Privilege has come Responsibility and this responsibility has grown and is growing still, with each passing year. We, the women of the Church, we women of South Florida,—you and I—are responsible for the carrying on, for the united support, and for the further development of much and vitally important work, now a very definite part of the Church's Program.

IF the United Thank Offering failed—But of such a tragic possibility we must not think! More and more fully must we realize the part which we have assumed in the work of the Church; and with earnest prayer and active service we must strive to make our gifts meet the increasing needs. And we CAN meet the challenge which confronts us, IF we have VISION—wider, clearer vision. We must be able to visualize humanity's appalling need for Christianity, to hold a vision of God's Church as a great saving force, to grasp a clearer conviction of the truth that knowledge of God's love and grace is the only means possible for the redemption of the world. We must realize that WE can help to make Salvation known.

SO MANY MORE women are needed, who will give of prayers and gifts and service for God's work. If the women of the Church in the United States would give on an average of a penny a day, we could place on the Golden Alms Basin at the next Triennial Thanksgiving Service more than three million dollars. In less than three trienniums we could give the Church's work more than has been given through the United Thank Offering during the past fifty years.

Who thinks to know what the coming fifty years may hold for this sin-sick world? In these fast-moving times we do not dare to wonder and to wait. To each of us the call is clear—Be up and doing NOW.

Here in South Florida we ARE advancing in our work. For the United Thank Offering, we note a steady gain in interest and in contributions. But, OH, how much more fine and splendid a gain we should be able to show, here, in our Diocese, if the women of South Florida would more fully realize their Privilege and would rise to meet their responsibility with blessed Faith and Sacrifice and Vision.

So might we, indeed, keep a worthy Year of Jubilee.

## REPORT OF THE SECRETARY OF RELIGIOUS EDUCATION

During the past year, the work of the Department of Religious Education has made definite and satisfactory progress.

A fine spirit of co-operation, a ready response to the work on the part of the members reflects a growing interest in Christian Education that is most gratifying. Younger women are taking a greater interest in educational work, many acting as leaders of study groups.

I am delighted to report that we have been mindful of the objective set for us by Bishop Wing at the Annual Meeting in 1938,—“To broaden our educational program to increase our knowledge of the Church.” This was revealed by the books listed in answer to the question on the Annual Report Blanks, “What books or literature did you use in study classes?”

I rejoice to note one marked increase, we have two hundred twenty-seven Auxiliary members teaching in the Church's Schools, forty more than in the previous year.

In 1939-1940, let us seek “Reality in Fellowship” by accepting the following as our special aims:

1. To deepen our sense of the privilege and responsibility of Christian Educational Work.

In this connection, we should ask ourselves some searching questions. Who is our leader? Does He still call, “Follow me”? What is the purpose of Christian Education? Do we realize the vital importance of Corporate Communion, Quiet Days, Prayer Circles as means of strengthening our work by yielding it to God's will? Any individual or group can quickly think up a list of such questions. Face them, make them the subject of an educational program, discuss them together, think them through to their logical conclusion. Such a re-orientation to the work would make a firm foundation for the year's program.

Do we believe that Christianity is the answer to the world's needs? If so, study classes should take on new significance. The first step toward teaching others is to become informed one's self. We should have a broader knowledge of the Church—its teachings and history—and of its Missionary program; and we should be acquainted with the aims and findings of the great World Conferences.

2. To further leadership training.

Our greatest need continues to be trained and consecrated leadership. We now have a Permanent Camp, and this summer an Adult Conference will be held, July third to eighth. Each branch of the Woman's Auxiliary should have as many members as possible present at this Conference. We can also do our part towards training leaders for the future by giving scholarships to our Young People's Camps and by continuing to support College Student Work.

In closing, I quote from the Oxford Conference Report: “In Christ and in the union of man with God and of man with man, which He creates, life . . . . has a meaning. In His Name we set our hands, as the servants of God and in Him of one another, to the task of proclaiming God's message of redemption”.

## REPORT OF SUPPLY SECRETARY

In I Corinthians, Chapter 13, Verses 1, 2 and 13, you will find the following words:

- "1. Though I speak with the tongues of men and of angels, and have not charity, I am become as sounding brass, or as a tinkling cymbal.
2. And though I have the gift of prophecy, and understand all mysteries, and all knowledge; and though I have all faith, so that I could remove mountains, and have not charity, I am nothing."
- "13. And now abideth faith, hope, charity, these three; but the greatest of these is charity."

Charity is a word that is often thought of as just almsgiving, but in reality it has many other meanings—Christian love, leniency, readiness



to forgive, generous consideration. Those of us, who had the privilege of hearing Bishop Roberts, of the Diocese of South Dakota, at our District Meetings, will add life itself to the list. Since hearing Bishop Roberts, we more fully understand what the Supply Work means to the missionaries in the field. It is appalling to know that our Indian catechists are receiving \$10.00 per month, and the Supply Department sends them one suit of clothes a year costing \$30.00. Truly they are God's own Children doing his work of spreading the Gospel among their own people. It is hard for us to realize how little we are doing to help these workers. We give what we are asked to give, but why not give more than that? A little self-denial on our part would add very materially to the deficit we are now facing in our missionary budget.

How easy it would be for most of us to have a little box tucked away in a corner, and sometimes when we wanted to go to the movies we just took that 35 or 40 cents and dropped it in the box. I do not, of course, mean every time we wanted to go to the movies, but an occasional donation would not after all mean so much to us, and it would mean a very great deal to our workers in the field. I would call this box a "Sacrificial Life Box." (I am not talking about the United Thank Offering, I am talking about missionary work in general.)

No Christian was ever so busy as St. Paul, but he found time to encourage others. How much harm is done when people forget to watch for opportunities to do the Lord's work!

When we say the Lord's Prayer, gratitude should be accompanied by generosity.

For the person who says he does not believe in missions, there is an article in the Spirit of Missions, written by The Rt. Rev. John Boyd Bentley, D.D. Bishop Bentley says, in the first place, the missionary work of the Church has been a glorious success since that day in 1607 when Good Master Robert Hunt, chaplain of that little band of bold Englishmen, established the first permanent English settlement in America and planted the Anglican Church in the New World.

On the other hand, and it is our second point, we can say to our friend who is doubtful and critical of Christian Missions, that while we rejoice because the missionary enterprise of the Church in America has been a glorious success, we would continue to believe in missions even had the effort been a miserable failure, because the responsibility for the success or failure of Christian Missions does not rest upon us, but upon God.

My three years as your Diocesan Supply Secretary have been a source of joy. The many pleasant contacts I have made have been an education in missionary work, and I have received more than I have given. My only regret is that I did not have the time to visit each Auxiliary personally, but I have answered letters as promptly as possible.

My objective for 1938 was to give every Church woman in the Diocese the privilege of sharing in the Supply Work. I have not accomplished this fully, but have added three Missions to the list: Holy Spirit, Apopka; Christ Church, Longwood; St. Francis Mission, Lake Placid.

To our Past President, Mrs. Turner, for most generous help and counsel in my first year, 1936, I am deeply grateful.

To Miss Nash, for her ready help and deep interest in the Supply Work, as well as her wise council, I Thank You. My two years of work with you will always be a pleasant memory.

To all members and co-workers in Christ, I thank you for your loyal support and ever ready willingness to take extra work when asked to do so.

For my successor, I can ask nothing more than that you give her the same loyal support you have given me the past three years.

Let us go forward in the Five Fields of Service with an open mind and an ever willing hand to carry on God's work of sending missionaries to preach the Gospel to every nation.

## REPORT OF DEACONESS HARRIET M. BEDELL

Missionary in Charge of  
Glade Cross Mission, Everglades, Florida.

The Indian work has gone on steadily, but amid many discouraging hindrances. This is the only Tribe in the United States that has not sworn allegiance to the Flag. They are governed by their own Council which meets officially at the annual Corn Dance, when important matters of the Tribe are decided, marriages performed, ceremony giving boys full privileges of the Tribe, etc.

They wear attractive costumes and live in a primitive way on platforms, cooking on a common open fire. Outside influences and suggestions affect them very little except as they choose to adopt them. All this makes them much in demand for exhibition. This is a great hindrance to their spiritual and moral uplift. Yes, some of the Indians drink, but not more than their white brothers.

The game laws are becoming more and more rigid and, because the white men secured game out of season through the Indians, it now affects them too. Our industrial work has been a great help, not only in developing their native arts and crafts, and helping them to be self-supporting, but in making contacts for knowing them better and winning their confidence. Three members of the Council and several "Households" are ready to be baptized. The others are friendly and I am made very welcome as I visit for one or two days at a time in their villages.

We are ready now for the next step in the work. Three years ago the Indians built for me a dwelling in Immokalee in their village near the white town or Trading Post. They said, so I could be with them when they assembled there for a few days! This is now being remodeled, a well dug, etc.: so I can take one or two couples, or girls, to live with me for a few days at a time at first; then for a longer period. Later, as we have the money, we can take more girls.

As I go in their villages, I am their guest and cannot tell them to work differently except as they see my dishes and bedding and, of their own accord, adopt what they like. In the new plan, the young people are my guests and, while we will live in their way, I can help them to live better; and, when they start homes of their own, they will be on a higher plane. Then, too, there will be opportunity for individual work, leading up to their being baptized. This work requires Godly wisdom and ghostly strength: so I ask your prayers that I may lead these people to Christ and His Church.

#### REPORT FROM THE COLORED BRANCH

April 25, 1939.

It is always a privilege and pleasure to meet with you, and bring you greetings from the Colored Branch.

We find it difficult to designate the most outstanding accomplishments of the past year. However, at our last yearly meeting we were encouraged to go forward despite the fact of the few women we have prepared or willing to sacrifice their time for the work. We are doing community work generally, such as, supplying clothing for unfortunate children, sending baskets of groceries to needy families, visiting and sending flowers to hospitals and shut-ins, distributing the "Forward Movement" and "Spirit of Missions" wherever possible.

We sent Christmas boxes to St. Paul's School, Lawrenceville, Virginia, from seven Missions which amounted to \$48.77. Our yearly dues was paid to the National Council. The women are becoming to understand the United Thank Offering better. We collect our boxes yearly with Corporate Communion for all the women of the Church.

One of our handicaps is the lack of trained workers in our diocese. And, occasional visits from our National secretaries would help our work a great deal.

I suggest that, in communities where there are colored Auxiliaries, the white ladies make frequent visits with them for educational instructions in the work of the Auxiliary.

## Gift-of-Life

### Co-operating Chairman

At the last annual Convention the Woman's Auxiliary of the Diocese of South Florida was convinced that there was a real need for some form of activity to promote the education of young women and girls in the mission of the Church in co-operation with the existing work of Church Schools, the Girl's Friendly Society, Y. P. S. L. and the Woman's Auxiliary. It was therefore resolved that a Liaison Officer be appointed to be known as a co-operating chairman.

Upon my appointment as co-operating chairman, I secured one hundred names of girls in this Diocese who had been active in the Student Center at Tallahassee during their college years. I wrote letters asking them to co-operate with me in extending the work of the Woman's Auxiliary to the younger women of the Church. To this plea I received only a few answers and the majority of these were from girls who had moved out of the Diocese and wanted to let me know why they would be unable to help.

Recently, I wrote to the various Parish Presidents and I am very happy to report that answers were prompt and encouraging. The reports show that there are already five younger Business Girl Chapters and two younger matron groups. No doubt there are several other groups from which I have not heard.

It is my sincere belief that this plan of bringing the younger women into the Auxiliary is a splendid one. I am asking each one of you present at this meeting to consider it your responsibility to lead those younger women into the Auxiliary, thereby strengthening this great organization and also meeting the needs of girls who would not otherwise be connected with any Church group.

We cannot expect great results this year for we are really only laying a foundation for a plan that will surely succeed; but, I am convinced that if each one of you would interest only one girl in organizing a chapter to suit her needs, by the time of Convention next year we would be able to report that every Parish in the Diocese of South Florida had at least one Chapter suitable for the younger Women of the Church today who will be the leaders of tomorrow.

**Church School Service Program for 1938**

I am happy to report that there has been considerable increase in the four Offerings included in this Program, both in the numbers of parishes participating, and also in the offerings themselves. Much of this is the result of the many letters that have been sent out during the past year by the four Chairmen and myself.

The Lenten Mite Box Offering with Mrs. L. E. Lackey as Chairman was \$3,983.51 with 62 Church Schools participating. An increase of \$306.51.

The Birthday Thank Offering, with Mrs. Grace B. Mitchell as Chairman, amounted to \$395.74, with 23 Church Schools participating. Last year, the offering of 17 Church Schools was \$172.43. An increase of \$223.31.

The Christmas Box Offering, with Miss Annis Tulane as Chairman, was the contribution of gifts from 32 Church Schools. 174 gifts for Indian children in Lower Bruel Mission, South Dakota, and 419 gifts for Indian children in Crow Creek Mission, South Dakota. \$10 was sent to the District of Anking, China, for gifts.

The Little Helpers, with Mrs. Warren T. Zeuch as Chairman, added 7 new departments this year to the 10 which were already established. Of the 17, Offerings amounted to \$129.96 have been received from 7 departments.

During the past year literature and information about the offerings was sent to very nearly every Church School or to the person in charge. 157 cards and 375 letters were sent out by the four Chairmen and myself.

The results of the past year's Offerings are both gratifying and encouraging to all of us, and with the increasing interest of the members of the Woman's Auxiliary, we hope that next year will show greater increase in both the Offerings and the numbers of Church Schools participating in them.

**CONSTITUTION AND BY-LAWS**  
of the  
**Woman's Auxiliary to the National Council in the**  
**Diocese of South Florida**

**Revised as of May 5, 1938**

**CONSTITUTION**

**ARTICLE I—Name**

The name of this organization shall be the Woman's Auxiliary to the National Council in the Diocese of South Florida.

**ARTICLE II—Object**

The object of this organization shall be to carry forward the three great aims of the Church: Extension of the Kingdom, Christian Education, and Christian Social Relations, through Prayer, Study, Work and Gifts, in the Home, Parish, Community, Diocese, Nation and World.

**ARTICLE III—Membership**

All women of the Diocese, by virtue of their Baptism, are eligible for membership in the Woman's Auxiliary.

**ARTICLE IV—Organization**

The Woman's Auxiliary in the Diocese of South Florida shall be organized into Five Districts, same to be called District One, Two, Three, Four and Five, respectively.

**ARTICLE V—Officers**

Section 1. The officers of this organization shall be: President, Vice-Presidents, these being the Directors of the Districts; a Recording and Corresponding Secretary combined, a Treasurer, an Educational Secretary, a United Thank Offering Custodian, a Christian Social Relations Secretary, and a Supply Secretary.

Section 2. The Directors of the Districts shall automatically become Vice-Presidents of the Diocesan Branch; the First Vice-President being always the President of the District in which the next Annual Meeting is to be held.

Section 3. These Officers shall constitute the Executive Board.

**ARTICLE VI—Meetings**

Section 1. The Annual Meeting shall be held at the same time and place as the Annual Convention of the Diocese.

Section 2. Each and every Parish branch shall be entitled to representation in the Annual Meeting by three duly elected delegates, and each Mission branch by one duly elected delegate. Only delegates from branches which has paid their Expense Fund shall be entitled to vote.

Section 3. All members of the Executive Board shall be entitled to all privileges of the Annual Meeting, including the right to vote.

Section 4. The Executive Board shall meet once a year, and the President shall be empowered to call a meeting at any time that she may consider necessary. The Board shall have authority to fix its quorum and to adopt other By-Laws for its government.

Section 5. District meetings shall be held twice a year, preferably in the Spring and Fall.

**ARTICLE VII—Quorum**

A quorum shall consist of delegates representing one-fifth of the total number of Parochial and Mission branches.

**ARTICLE VIII—Amendments**

This Constitution may be amended at any Annual Meeting by a majority of the delegates present and voting; due notice of the proposed change having been given to the Executive Board two months prior to the Annual Meeting; and upon the approval of the Bishop of the Diocese.



**BY-LAWS****1. Elections**

Section 1. Election of Officers: The President shall appoint a committee of three at the Annual Convention to receive nominations. Nominations may be in writing or from the floor. All names shall be presented to the Convention. Voting shall be by ballot. If there is no majority on the first ballot, all names shall be dropped but the three having the largest number of votes. Of these three, the one receiving the largest number of votes on the second ballot shall be declared elected.

Section 2. All Officers shall be elected annually and for a term of one year. No Officer, having served for three years, shall be eligible for reelection until after the lapse of one Convention year. All Officers shall serve until their successors shall be duly elected and qualified.

Section 3. District Directors shall be elected annually by their own constituencies at the Spring meeting preceding the annual Diocesan meeting.

Section 4. The names of five delegates and their alternates to the Triennial Convention shall be presented by the nominating committee and elected at the Annual Meeting preceding the Triennial Convention. The Diocesan President shall be one of the five delegates.

Section 5. The names of five delegates and their alternates to the Provincial Auxiliary meeting shall be presented by the nominating committee and elected at the Annual Meeting preceding the Provincial meeting. The Diocesan President shall be one of the five delegates. It is provided, however, that the delegates to the Triennial Convention shall be considered duly qualified delegates to any Provincial meeting which shall be called at the time and place of the Triennial Convention.

Section 6. All vacancies in offices, occurring during the intervals between Annual Meetings, shall be filled by the Executive Board.

**2. Duties of Officers**

Section 1. The President shall preside at all meetings, appoint all committees, and have general supervision of the work throughout the Diocese. She shall be ex-officio a member of all committees.

Section 2. The Vice-President shall assist the President and, in her absence, shall perform all the duties of that office.

Section 3. The Secretary shall keep a correct record of the proceedings of all meetings of the organization and of the Executive Board; issue all notices of all meetings; conduct the correspondence; submit a written report to the Annual Meeting; and prepare and edit with the President the Annual Report (or Year Book).

Section 4. The Treasurer shall receive all monies except the United Thank Offering, and pay such bills as are endorsed by the President. She shall forward all monies given for special causes, and shall make a quarterly report of receipts and disbursements to the President. At the Annual Meeting, she shall make a report covering receipts and disbursements for the year. At the end of the fiscal year, her accounts shall be audited by a public accountant.

Section 5. The District Directors shall have general supervision of the work in their Districts. In the absence of the President, they shall, in the order of their rank, perform all the duties of that office, it being understood that the Director of the District in which the next Annual Meeting is to be held shall rank as First Vice-President. They shall stimulate the activities of all Parish and Mission branches; form new branches; preside at all District meetings; and make reports to the Annual Meeting. They shall notify the Diocesan Secretary of any changes that occur in the branches in their District.

Section 6. The Secretary of Christian Education, the Secretary of Christian Social Relations and the Supply Secretary shall carry out as nearly as possible the program suggested by the National Council.

Section 7. The United Thank Offering Custodian shall receive the United Thank Offering in the Spring and Fall and remit to the Treasurer of the National Council.



**Section 8.** All Officers shall present written reports at the Annual Meeting.

**3. Assessments**

Each local branch shall be assessed a certain amount for current expenses.

**4. Amendments**

These By-Laws may be altered or amended by a majority of the delegates at any Annual Meeting.

**5. Rules of Order**

Roberts' Rules of Order (revised) shall govern all meetings.
