CONSTITUTION AND BY-LAWS

CONSTITUTION

ARTICLE I.

Name.—The name of this Association shall be “The Southern Ohio Branch of the Woman’s Auxiliary to the Board of Missions.”

ARTICLE II.

Object.—The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Woman’s Auxiliary, viz.: Daily Prayer for Missions, the Study of Missions, and Systematic Giving for Missions.

ARTICLE III.

Membership.—The Church itself is the Missionary Society. Every baptized person is a member of that Society. All women, and all parish societies of women, in this diocese, willing to carry out the purpose of this Association, shall be considered members of it.

ARTICLE IV.

Officers.—The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Box Secretary, a Secretary of the Junior and Baby Branches, a Treasurer, and a Treasurer of the United Offering.

These officers shall also constitute the Executive Board of the Association.

ARTICLE V.

Duties.—Sec. 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Sec. 2. The Bishop, when present, shall preside at meetings of the Association and of the Executive Board.

Sec. 3. The President shall be elected at the Annual Meeting next before the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop’s approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop’s absence, preside at

them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting.

In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop, and a committee of two selected by the Executive Board.

Sec. 4. Each Vice-President shall be elected immediately after the Annual Meeting, by the members of her own deanery, to serve three years, but shall not be eligible for two consecutive terms. Such an election shall be held, and a temporary vacancy in this office may be supplied, by a deanery meeting on the call of the President. A Vice-President, with the approval of the President, may, in her own deanery, appoint any other deanery officers and prescribe their duties. She shall, in the absence of the Bishop and President, preside at all meetings in her own deanery. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own deanery.

Sec. 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Sec. 6 of this Article. She shall also make an annual report of the work done from data furnished by the other officers.

Sec. 6. The Box Secretary shall receive and distribute all information relating to missionary boxes, and shall report annually to the Secretary the work done.

Sec. 7. The Secretary of the Junior and Baby Branches shall, under the direction of the Executive Board, promote each of these interests by local information, visitation and organization, and shall also report in full to the Annual Meeting.

Sec. 8. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Sec. 9. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount in hand, and forward the triennial offering.

ARTICLE VI.

Meetings.—Sec 1. There shall be an Annual Meeting of this Association. Every parish branch may send three delegates including any executive officer; and every mission branch one delegate. Except in the election of a President, executive

officers, when not delegates, may vote on all questions before the house.

Sec. 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Sec. 3. Deanery meetings may be held on the call of the deanery officers.

ARTICLE VII.

Mode of Election.— Sec. 1. In the election of a President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Sec. 2. Unless there be an election by a clear majority on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

ARTICLE VIII.

Amendment.—Sec. 1. This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

Sec. 2. In questions of constitutional amendment each Junior Branch is entitled to one vote.

BY-LAWS

1. The Annual Meeting shall be held, if practicable, on the day before and at the same place as the Annual Convention of the Diocese.
2. The Order of Business at any Annual Meeting shall be:
 1. A service of Holy Communion.
 2. Roll call.
 3. The annual report of the Secretary.
 4. Report of the Secretary of the Junior and Baby work.
 5. The annual report of Treasurer.
 6. Report of the Treasurer of the United Offering.
 7. Report of the Correspondent of the Church Periodical Club.
 8. The President's address.
 9. Pledges for new year.
 10. New business.
 11. The election of President.
 12. Minutes.
3. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.
4. A Central Expense Fund of \$300 should be provided for printing, postage, stationery, and traveling expenses of officers and speakers. Towards this fund the Cincinnati Deanery is asked to contribute \$150, the Columbus Deanery \$90, and the Dayton Deanery \$60, according to an apportionment to be made by the several Vice-Presidents; this to be the first payment made to the Diocesan Treasurer.
5. Local receipts for the United Offering shall be remitted to its Treasurer in April and October, except triennially in September.
6. The accounts of the Treasurer and of the Treasurer of the United Offering shall be audited and certified in the printed annual report of the Association.
7. The annual report of the Diocesan correspondent of the Church Periodical Club may be printed in the annual report of this Association.
8. An Intelligence Committee of three persons, one for each department of missions—diocesan, domestic and foreign—may be appointed by the Executive Board when necessary.
9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

REPORT OF SECRETARY

A review of the work of the past year, comprising details of service and financial accounting, is presented in this, the Thirty- Second Annual Report of the Southern Ohio Branch of the Woman's Auxiliary to the Board of Missions.

There have been six general meetings during the year, the Annual meeting, two each in the Cincinnati and Dayton Convocations, and one in the Columbus Convocation.

The Executive Board has held three meetings.

The Thirty-first Annual Meeting was held in St. Paul's Cathedral, Cincinnati, on May 14, 1907. At 10:00 o'clock there was a celebration of the Holy Communion by the Rev. John Hewitt, of St. Paul's, Columbus, assisted by the Rev. C. K. Benedict, Glendale, and Canons McGrath and Reade of the Cathedral. At the close of the service a brief address was made by Dr. Hewitt.

The business meeting which followed was held in the Assembly Hall of the Cathedral House. An address of welcome was made by the Dean, the Very Rev. Paul Matthews.

At roll call there were present 88 delegates, representing 39 parishes; 17 Juniors, representing 13 branches, and over 100 visitors. The reports of the officers were received, followed by the annual address of the retiring President, Mrs. Mortimer Matthews. Though not formally expressed, it was the general sentiment that the able service of Mrs. Matthews as Diocesan President, had left a deep and lasting impress upon the work of the Auxiliary. The election of the Diocesan President followed in due order, the result of the ballot, the election of Mrs. Lewis W. Irwin to that office, being a matter of great satisfaction.

At the afternoon session the Auxiliary had the pleasure and privilege of being addressed by Miss Julia C. Emery, General Secretary of the Woman's Auxiliary, upon the subjects, General Missions, the work of the Woman's Auxiliary as helpers to the Board of Missions, and the United Offering. Miss Emery's words brought to each and all enlightenment and encouragement.

The Rev. Mr. Evans, of Middletown, then told of the benefit which had accrued to that parish by the gift of \$500.00 from the Building Fund.

The attendance at this meeting was very large.

The Bishop was present at the Missionary meeting in the evening, when Dr. C. F. S. Lincoln, of Shanghai, made the ad-

dress in which he told of the great good done by the Medical Missionary in the foreign field.

The Cincinnati Convocation held its first meeting June 14, 1907, in the parishes of Holy Trinity, Hartwell, and Ascension Mission, Wyoming. The rector, the Rev. F. H. Richey, assisted by the Rev. R. F. Graham, celebrated the Holy Communion. Mrs. Irwin presided at the business session which followed. Miss Elizabeth Kellogg was duly elected Vice-President of the Cincinnati Convocation. It was decided at this meeting that the Cincinnati Convocation increase its responsibility \$150.00, and by so doing assume \$1,650.00 toward the \$3,000.00 appropriation of the Board.

The afternoon session was addressed by Miss Van Horn, who told of her work at Bat Cave, Bald Mountain, N. C., and by the Rev. Mr. McMillen, whose description of the work and opportunity of the Church in the Kentucky Mountains, was replete with interest.

At the second all-day meeting held in Grace Church, Avondale, the Holy Communion was celebrated by the rector, Rev. Wallace M. Gordon, after which the Convocation adjourned to the parish house and Mrs. Irwin called the business session to order. The Auxiliary went into the election of a Vice-President, as Miss Kellogg was unable to serve in that capacity. Mrs. H. L. Laws was then duly elected Vice-President of the Cincinnati Convocation.

The afternoon session was addressed by Bishop Vincent, on the Spiritual Side of Missionary Work. The Rev. Thomas Jenkins, aided by stereopticon views, told interestingly of the past, present and future of Alaska, and of the important work done there by the Church.

In December, Bishop Kinsolving, of Brazil, preached one of his eloquent sermons at Christ Church, the History of the Church in Virginia being the subject.

Miss Wood, of Boone School, Wuchang, China, spoke on December 27th to the Auxiliary, forcibly and favorably presenting the opportunities and responsibility of the Church in establishing a public library in Wuchang.

Mrs. Emma Drant visited a number of the branches and told of her work among the Chinese in San Francisco.

The Auxiliary of the Church of the Advent, on the afternoon of April 3, 1908, gave an invitation to all the branches in Cincinnati and vicinity to hear Bishop Tuttle, presiding Bishop of the Church. His eloquent tribute to the work of women in the Church from the Apostolic days down to the present time, impressed every hearer with the grave responsibility which the women of today should bear.

There was no general mission study class during Lent, as it was thought this would conflict with Mission study work undertaken by individual branches.

Early in September, 1907, application was made to the Church Mission House to secure speakers for Lenten Missionary services throughout the diocese. As no arrangement could be made without a somewhat large outlay of money, and the financial condition not justifying such an expense, the plan was abandoned.

It is a matter for congratulation that Rev and Mrs. Thomas Jenkins spent the winter in the Diocese and were ready to respond to every appeal for help.

The general meeting held in the Columbus Convocation was addressed by the Diocesan President, Mrs. Irwin, on the subject of the General Convention.

Missionary meetings held at Columbus in October, and at Zanesville in December, were addressed by Mrs. Thomas Jenkins and by Mrs. L. F. Franklin.

In response to invitation Mrs. L. P. Franklin and Mrs. Augustus F. Whiting visited the branch at Delaware.

A "Neighborhood Meeting" was held in Gallipolis.

Mrs. Franklin reports that the subject generally followed for Mission study was "The Island World of the Pacific." In some cases libraries were purchased of the Church Missions House to make this course more instructive.

In the Dayton Convocation, Mrs. Buvinger reports every branch as either doing or giving something for Missions. One new branch has been formed at St. John's Chapel, Dayton. There have been two general meetings. At Middletown, Mrs. Jenkins spoke on the work in Ketchikan. In Urbana, Mr. Jenkins made an inspiring missionary address.

A number of the branches have had Mission study classes, and others have had program missionary meetings.

The progress, prospects and conditions of the Junior department, with its purpose of enlisting the interest of the young people and children in the missions of the Church, is encouraging and gratifying. A detailed account will be given by Miss Siebert, the Junior Officer. The importance and necessity of this work can be realized only when it is remembered that the boys and girls of today are the men and women of tomorrow upon whom increasing responsibilities will rest.

The work of the Church Periodical Club, so far-reaching in its beneficial effects upon the giver, the recipient and the Church, will be reported in full by the Correspondent, Miss Phillips.

At the Annual Meeting all the old pledges were renewed.

The salary of the teacher at Ketchikan is now paid from the United Offering. It was therefore decided to pledge the \$500.00 formerly given for that purpose as follows:

\$100.00, scholarship in Industrial School, Hashimoto, Japan.

\$100.00, scholarship in St. Andrew's Priory, Honolulu.

\$250.00, medical supply work in Bontoc, P. I.

\$100.00 was also appropriated as a discretionary fund for the making of new pledges by the Executive Board at the Triennial Convention. Accordingly the eight members of the Executive Board present at Richmond gave \$90.00 to the following objects.

\$50.00 to Bishop Nichols for building a wing for Chinese in hospital in San Francisco.

\$15.00 to Mrs. Lucian Kinsolving, of Brazil, for materials for embroidery work.

\$10.00 to Dr. Wm. Brown, to aid in editing the Prayer Book just translated into Portuguese.

\$5.00 to the Home of the Merciful Saviour, a Church Children's Home in Sacramento.

\$10.00 to Bishop Welles for Children's Home in Spokane.

The share of the Southern Ohio branch of the Woman's Auxiliary in the United Offering at Richmond was \$3,531.44.

By recommendation of Archdeacon Edwards, and endorsement of Bishop Vincent, the Building Fund of \$1,000 was divided between Ascension Mission, Wyoming, and the Mission of Carthage.

JUNIOR REPORT

The Junior Department of the Woman's Auxiliary has a year of prosperous activity to report. Throughout the Diocese there has been almost uniformly increased interest and effort, and the year has been marked by the number of new and efficient leaders who have come to the front. While the money value of the year's work shows no remarkable increase over that of last year, we feel that there has been a healthy and steady growth,—and that good and greater results will show in another year from this year's beginnings.

During the year the following parishes have started new work: St. Luke's Church and St. Paul's Cathedral, Cincinnati; Christ Church, Glendale; St. Andrew's, Dayton; Holy Trinity, Hamilton, and St. James, Piqua. In Christ Church, Dayton; St. Paul's, Columbus, and Trinity, Newark, Churches in which Junior Work already existed, second branches of the younger children have been formed, making a total of nine new branches organized in the Diocese. There have been twenty-eight active branches during the year, and Babies' Branch work has been carried on in ten parishes.

The total amount of money received during the year is \$429.59. All pledges have been paid and there is a surplus of \$87.21 in the Junior Department and \$29.58 in the Babies' Branches, making a total surplus of \$116.79 to be voted on at the Junior meeting. The value of boxes sent by Junior branches is \$124.60, bringing the total money value of the year's work to \$554.19. The Juniors were asked to give \$125.00 under appropriation, and they have exceeded this amount by \$25.00.

Interest in the study of missions has been greatly increased through the publication of a course of study arranged by Miss Tuite, of the Church of the Advent, and Mrs. George N. Eastman, of the Church of the Epiphany, Cincinnati. This course is based on the Junior pledges, and, through its suggestions, its material and methods, has been of great aid to branch leaders.

During the year there have been two leaders' conferences in the Cincinnati Convocation, both at the home of our Diocesan President; and one in the Dayton Convocation, at Urbana. There have also been two general gatherings of Juniors in Cincinnati, the first at the Church of the Advent, the second at Epiphany. These meetings have been most helpful and have tended toward a greater unity in the work.

In the Cincinnati Convocation, Miss Tuite has acted as an assistant to the Junior office, and her work in organizing new branches and in arranging leaders' meetings has been greatly appreciated.

The year's work of the Junior Department will be brought to a close on next Saturday, May 23rd, by a meeting of all the branches of the Diocese, to be held in the Church of the Advent, Cincinnati. This is the first independent annual meeting of the Juniors, and we earnestly hope that as many members of the Woman's Auxiliary as possible will, by their presence and encouragement, help us to make it as sucessful and enthusiastic as we want it to be.

The Junior work, though growing, has not yet come to half its possibilities, and in closing our report, we want to urge upon the branches of the Woman's Auxiliary a more active interest in this part of their work, which we all agree, I believe, in calling the most important part. If there is a Junior branch in your parish, will you not help it by your interest and encouragement? If there is none, will you not try to start one as quickly as is consistent with carefulness, so that in two years when it is time for the next Triennial, the Junior Department shall have reached more nearly its full strength?

PRESIDENT'S ADDRESS

My first word to you today, assembled as we are at our Annual Meeting, must be of my very great appreciation of the honor you conferred upon me when last we met. If it is true that "out of the abundance of the heart the mouth speaketh," that occasion must have been the exception proving the rule, for while my heart was full to overflowing my lips refused to utter the thoughts surging within. So, today, I beg you to accept my deep appreciation of the honor and believe that it will but stimulate me to greater effort, that your confidence may not have been misplaced.

And then, I would congratulate you most heartily, for, in spite of the great financial depression of the past winter, and the fact that many of our Parishes have been more or less disorganized, owing to their being without Rectors, we meet today with every pledge fully paid. This is a delightful surprise to your Executive Board, for less than a month ago we were confronted with a deficit of nearly \$500.00! It is no easy task to keep books, and it is equally hard for our beneficiaries to wait so long for our benefactions; and so I would urge, that whenever possible, you pay your pledges earlier in the year, thus relieving our Diocesan Treasurer and the Missionary Boards of the embarrassment inevitably accompanying such delay.

The event of special interest to your Executive Board was the Triennial in Richmond last October, when all but one of its members were present, each viewing with the other for the greatest enthusiasm and inspiration to bring home to those less privileged than they. This was in strong and delightful contrast to the meeting in San Francisco, six years ago, when your poor, lonesome President was the only member present.

The dominant note through all those busy days, so crowded with events of such unusual interest to Churchmen, was missionary through and through, and daily one saw the high and the low, the broad and the conservative Churchmen sinking their individual opinions and working side by side for the advancement of Christ's Kingdom among men. As that kingdom grows, so also do the responsibilities and privileges of its members grow, and much larger demands are made upon them for its maintenance; and so it seems wise to your Executive Board to suggest some readjustment of our pledges.

In 1878, after an earnest appeal from the Missionary Bishop of Western Texas, the support of a scholarship in St. Mary's Hall, San Antonio, was undertaken, and by a happy inspiration was named the Mary H. Rochester scholarship. For twenty-nine years it has been our pleasure to maintain this scholarship,

and thus keep with us the name and memory of one who, for twenty-four years, gave herself so lovingly and unstintingly to Auxiliary work in the Diocese. This was a "Special," in no way contributing to the appropriations of the Board of Missions. Now that conditions are so changed, and the Missionary District of Western Texas has become the Diocese of Western Texas, and the appropriations of the Board have necessarily been so largely increased, we suggest that we give up our scholarship in Western Texas and accept one among the Indians in South Dakota, either at St. Elizabeth's School, Standing Rock Reserve, or St. Mary's School for Girls, at Rosebud Agency, still preserving the name "Mary H. Rochester," which name we feel should be prominent in Southern Ohio Auxiliary Annals for all time to come, as testifying in a measure to our loving gratitude for all she did for our Auxiliary life. It has the additional advantage of counting on our apportionment of the \$100,000 annually asked from the whole Auxiliary towards the appropriations of the Board.

When we began giving \$10,000 per year towards the support of the twelve lace teachers among the Indians, Miss Carter was responsible for the salaries of all of them—\$300.00 for each one. Since the united Offering is devoted to the support of women workers, all but one are paid out of this fund, and so we suggest that for this next year, at least, we divert this Special of \$100.00 and give it to the Bishop of Arizona and New Mexico for St. Luke's Home, near Phoenix, Arizona, recently opened for consumptives, who flock in such large numbers to that part of our country.

The necessity for a larger outlay for work among the Colored people has become so imperative that we also recommend giving up our scholarship at St. Paul's, Lawrenceville, and increasing our gift of \$50.00 to \$100.00, allowing the Board to use it wherever it seems wisest among the Colored people. With these changes we would recommend the continuance of our other pledges, especially suggesting that we undertake to finish Ah Lam's education. As you see, Bishop Restarick speaks very highly of her, and sees no better work before us than equipping her for her life work.

These changes, if made, will bring our Diocesan contributions to the appropriations of the Board to \$830.00, and as many individual branches have extra parish pledges, we may hope to reach the amount asked of us.

"Specials" are very attractive, and it is a great pleasure to receive such letters as you have heard to-day from our over-worked and harassed missionary bishops, telling of the courage and help which come with unexpected gifts; but, first and always let us remember the reason for our existence—to be a helper to the Board of Missions—and then, when we have met these obligations, give to other objects, and in the words of one of our great missionary heroes: "Give and keep on giving until it

hurts." We note with much pleasure the advance made in contributions to the United Offering, and the number contributing; and let us all work for it with renewed effort, that when in 1910 we gather at our Father's Board none of those who should be with us be absent through our negligence; and while we older ones bring our gifts of loving adoration and praise, may some of our younger women be induced to give that most precious of all gifts—themselves—to help carry the message of peace and good will around the world. The advance made in our work among the Juniors is just cause for rejoicing, and, being built upon the broad and deep foundation of knowledge and prayer, bids fair to become an enduring structure. I beg that those of you who belong to parishes without Junior Branches give your Rector no peace until the younger members of their congregations also enter into their inheritance of being "co-workers with God."

I would also say a word for the Church Periodical Club and commend it to your careful consideration. At every General Convention I have attended I have heard so much of the great good it is accomplishing, the great help it is to our missionary bishops, the great pleasure and safeguard against temptation that it is to the exiles in lumber camps and isolated places, that I can not commend it too highly.

Before closing I would pay a word of loving tribute to our recent President. Forced upon her as the office was, under peculiar circumstances, she unhesitatingly accepted what she considered her duty in the matter, and in spite of many conflicting interests, remained faithfully at her post during her full term of service. I am sure that you, like myself, stood awed in the presence of her calm faith and courage at our last annual meeting, and feel that she left us an example of Christian fortitude to be emulated by us all.

Report of the Church Periodical Club for the Annual Meeting of
the Woman's Auxiliary, May 19, 1908.

In presenting this, her second report of the work of the Church Periodical Club in the Diocese, your correspondent has much pleasure in reporting that the promise of last year has in some measure been fulfilled, the work having grown to almost double that done a year ago. Six new librarians have been appointed in parishes where previously no work was done, and now our contributors are sending out regularly every week or month 212 periodicals, a gain of nearly 100. In addition to these periodicals sent regularly, your correspondent has sent away 4,413 odd papers and magazines, 348 books, 437 Christmas, Good Friday and Easter cards; 123 Church instruction tracts, 85 pictures, games, etc., and 4 gross of small flags. The several librarians have sent away 2,192 odd magazines and papers, 64 books, 202 Christmas and Easter cards, a total of 6,605 periodicals, 412 books, 639 cards, 123 instruction tracts, 85 pictures, games, etc., and 4 gross of flags with an additional six barrels whose contents were not enumerated. Contributions and subscriptions sent to the Central Office, \$28.00; contributed for stationery, postage, freight, and other necessary expenses of the correspondent, \$46.72, a total of \$74.72.

This material has been sent to individual recipients among the clergy and laity in all sections of the country, many of whom are dependent on the Club for reading matter; to missions in the North Carolina, Kentucky, and Virginia mountains; in Utah and Alaska; in Cuba, Porto Rico and Hawaii; the lumber districts of the North, and the mining regions of the West; to several army posts for the use of soldiers, especially those in the hospitals; and to the military prison at Ft. Leavenworth, Kansas. Over 500 Good Friday and Easter cards were sent to the Chaplain of Admiral Thomas' flagship Minnesota in response to a special appeal made by him to the Club for cards for his "boys," and it even furnished the flags for the Fourth of July celebration in one of our mission schools in North Carolina.

In the short space allotted, it is not possible to give an adequate idea of the missionary work accomplished by this Club. Some few instances, taken from many similar ones, will serve as illustrations. A clergyman in Alaska writes: "If anyone should keep abreast of the times, it is the clergyman, and this would be manifestly impossible were it not for the help of the Church Periodical Club." Another, speaking of the literature sent to a mission reading room, says: "This has caused many a stranger to look upon us as a friend, who probably otherwise never would have looked toward the Church, and a few magazines often give

us an entrance to places which would otherwise be closed to us." As the Government makes no provision for reading matter for the soldiers, several of the army chaplains, priests in the Church, have applied to the Club for a supply. One of them, in acknowledging some sent, says: "It is certainly a noble work you are doing, thus bringing a cheerfulness and harmless occupation into the lives of the soldiers, whose hardships are not understood by most civilians." The chaplain of the military prison at Ft. Leavenworth, Kansas, writes of a box of books sent: "I find it difficult to express my appreciation, but you may rest assured that these young men will be greatly helped and encouraged as the result of your efforts in their behalf." One of our missionaries in the Far West reports that through the direct influence of some Church instruction tracts and books sent him by the Club last winter, followed, of course, by his own efforts, two men, formerly unbelievers, are now contemplating coming into the Church, one of whom has already been baptized; the other, a college man, will probably offer himself for Holy Orders. Only a few weeks ago Bishop Tuttle expressed personally to your correspondent his pleasure at the help the Club is giving to the mission reading room at Logan, Utah, one of his old Mormon missions, where he said the two young priests in charge were doing a splendid work. One of these same priests a few days before had pronounced the Church Periodical Club "a great institution."

The work accomplished this year, while very encouraging, only shows what might be done if our Bishop's wish could be carried out and a branch of the Church Periodical Club established in every parish of the Diocese. To this end your correspondent asks the interest and help of the women of the Auxiliary. Should not Churchwomen make a wider application than to mere bodily food of Our Lord's command "to gather up the fragments, that nothing be lost" and consider it not only a duty but a privilege from their abundance to send at least the fragments to those whose shelves are scanty and tables bare of mental food?

Again your correspondent must acknowledge most gratefully the faithful work of the librarians, and the help and encouragement given her by the Bishop and our honored President, Mrs. Irwin.
