## ANNUAL REPORT OF THE SECRETARY

---

During the year 1923 there have been three business meetings of the Executive Board, meetings in the three Convocations were held in May, and the Annual Meeting was held in the Church of the Good Shepherd, Norwood, Ohio, on January 24, 1923.

One resignation from the membership of the Board must be reported. On account of ill health, Mrs. W. A. Stimson has been compelled to give up her work as Representative of the Church School Service League. This resignation has been accepted with sincerest regret, and deep gratitude for the work accomplished thru the Church School box work, which has been developed most successfully thru Mrs Stimson's service. As some readjustment is to be made in this work soon, no new representative of the League has been appointed.

The following reports are submitted by the Vice-Presidents of the three Convocations.

In Cincinnati, the monthly meetings of the Officers' Conference continue to be a source of great encouragement to all workers as they are a clearing house for the knowledge of the work in the Diocese. During Lent the study classes and program meetings comprised the greater part of the work. The book which was largely used, was "Wanted Leaders" by Bishop Bratton of Mississippi. In the late spring we worked, as a Convocation, on the St. Elizabeth's Hospital Dispensary list, which was almost fully completed. The contribution towards the Immigrant Fund of the Federation of Churches amounted to \$189.00 with every parish contributing. Three Auxiliary women are serving on the Board of the Federation. There have been a number of good speakers in the Convocation, among them being Bishop Page of Spokane, Miss Simrall and Miss Matthews, and Mr. Reinheimer. To date seven emergency packages have been sent from this Convocation. to Bishop McKim in Japan.

During the Vice-President's term of office she has visited nine parishes.

In the Dayton Convocation an Officers' Conference was held in Dayton with six branches represented. The meeting was an informal one, and the problem of the branches discussed. The consensus of opinion seemed to be that it is the lack of individual responsibility which is at the bottom of most of our problems, and to find the way to remedy that, is the biggest problem of all. To consecrate a little time now and then to reflection and personal prayer, coupled with an earnest desire to put first things first, would solve most, if not all, of the difficulties we encounter.

Several branches in this Convocation were represented at the Gambier Conference, and most of the branches had outside speakers during the year.



The Vice-President has visited seven branches, and attended two of the Officers' Conferences in Cincinnati.

The Columbus Convocation is reported as making satisfactory progress in most of the work of the Auxiliary. One bit of co-operation which has given splendid results is the giving of scholarships for the Gambier Conference from several of the branches. This we feel has helped in a small way the remarkable attendance of the young people at this Conference.

The Vice-President has visited two branches during her term of office.

The meetings of the Convocations were held on three consecutive days in May, at Epiphany Church, Cincinnati, on May 7th, in Christ Church, Springfield, on May 8th, and at the Chapel of the Holy Spirit, Columbus, on May 9th. Mrs. Wells, Mrs. Norton, Mrs. Van Keuren, Mrs. McGregor, and Mrs. Glenn spoke for the Diocese at each of these three meetings, while the Rev. B. L. Reinheimer told of the work of the Nation Wide Campaign, and it was our great privilege to have as our principal speaker, Mrs. George Biller, National Organizing Secretary.

One change in the number of branches in Southern Ohio must be reported. St. John's Mission, Fairview Heights, Cincinnati, has been closed, and the branch of the Auxiliary has been automatically disbanded. While this makes a numerical loss on our books, the service of the women of this branch will be given to neighboring parishes, and nothing will be lost in the working strength of the Auxiliary.

The number of branches of the Auxiliary in Southern Ohio now stands as 71, with 27 branches in the Cincinnati, 27 in the Columbus, and 17 in the Dayton Convocation, with 6 missions giving to the United Thank Offering.

In giving this, the last report of your present Board, we wish to close our three years' work with you in thanking you for your cordial support and co-operation, and in expressing our sense of gratitude for the privilege we have had in sharing in some small way in the work of the church in the Diocese.

## REPORT OF THE SUPPLY DEPARTMENT

The work of the Supply Department for the past year presents some unique features. Christ Church, Cincinnati, accepted as their allotment the complete assignment for the new hospital at Changshu, China, having the promised assistance of all of the women's and girls' societies in the Parish. As the work progressed, interest was aroused among the men also, and the Easter offering of \$1500.00 was voted for the hospital. In this way, Christ Church became responsible for the entire support of the hospital for one year.

St. Paul's Columbus undertook the supplies for the smaller hospital at Ponce, Porto Rico, and all of the other Auxiliaries in the Diocese worked for the St. Elizabeth's Hospital, Shanghai, China. This latter assignment was very large, but we filled it successfully, sending 2400 garments, etc., besides surgical dressings and dispensary supplies. In this work we were assisted by the G. F. S. Societies and the Church Schools and by one Men's Club. This completed our work for the Spring.

This Fall we have sent out ten personal boxes and two Catechist's suits as usual, and Christmas boxes to eleven of our women Missionaries. We sent our first allotment of Altar linen and choir vestments to a Mission in Jackson, Miss., and two large cases of garments from the Supply rooms, one to each of the stations for which we are working this Winter, and one box to the Seaman's Church Institute.

In answer to an emergency call from Tokyo, after the earthquake, seven packages of blankets and linen were sent, each package containing supplies for one bed. Two surplices were sent to the clergy of Japan in time to be used at the consecration of Dr. Motoda to be the first Japanese Bishop of the Church in Japan.

Looking back over the past three years, we can feel assured that our progress is real; that our knowledge is greater, our interest deeper, and our sympathies wider. Each year has brought new fields to broaden our vision of the Church's work. We have worked for our home Missions in the mountain districts, for the Indian and the Negro, and for Alaska. Our foreign work has gone to China, Japan, Porto Rico, Liberia and the Virgin Islands. Some of our offerings were small and some large, but all most thankfully received and gratefully acknowledged.

## REPORT OF EDUCATIONAL SECRETARY

In concluding six years of service as your Educational Secretary, I feel that I should give you some figures which would make it possible to pass judgment upon my work, but unfortunately the educational work by its very nature makes such a report difficult and also of questionable value. Numbers of study classes, program meetings, and missionary speakers prove to us certain interesting facts but they do not make clear to us whether we are reaching out in our work and touching new people each year. Unless we are continually widening the circle of influence of our classes and program meetings they are not the success that they should be. During the winter of 1923, the Educational Secretary held one training class for leaders, in Cincinnati, using as the textbook "Wanted Leaders." This was followed by regularly constituted mission study classes in six parishes of that Convocation and program meetings in seven others. During the twelve years of organized educational work, our insistence on mission study has resulted in developing a goodly number of well informed women, capable and willing to undertake leadership so that this fall the women of the diocese have been able to carry thro' an educational campaign for the N. W. Campaign in many of our parishes. This has not been done in the name of the Auxiliary but we can say, in all modesty, that such an undertaking would have been impossible except for the preceeding years of work done by the Auxiliary. In this type of work we have also the example of our Educational Secretary Miss Tillotson who left her office in New York temporarily to travel thro' Texas presenting the program of the Church. The Auxiliary exists, not for any self glorification but for every service which it can render to the Church and we of the Woman's Auxiliary of Southern Ohio have reason to rejoice if our labors in the past have been the foundation on which is being built a more wide-spread knowledge and a finer loyalty to the Church's program thro'out Southern Ohio.

## MINUTES OF THE FORTY-EIGHTH ANNUAL MEETING

---

The 48th Annual Meeting of the Woman's Auxiliary of Southern Ohio was held at Christ Church, Dayton, on Wednesday and Thursday, November 14 and 15, 1923. The opening service of Holy Communion was held at 10:45 A.M. on Wednesday, with Bishop Reese, celebrant and preacher, and the Rev. Philip Porter, assisting. 191 made their communions at this service.

Bishop Reese spoke of this Annual Meeting as the end of a chapter, and impressed upon us the fact that we must realize the affirmation of the continuity of God's blessing upon the work of the church, a blessing which is emphasized by St. Paul in the third chapter of Ephesians. Bishop Reese said that the best expression of the life of the church is "one family in God," and asked that we realize this family life, which should center around the altar, the extension of the table in the upper room. He spoke of the volunteers who have gone out from this Diocese and asked that we remember them always in our prayers, and closed by reminding us that the only definite program which in the long run will displace racial hatred is the bringing in the Kingdom of Christ.

Luncheon was served at 12:30 in the parish house.

At 1:30 P.M. the business meeting was called to order by the President, Mrs. Wells.

Mrs. Charles Bergen, President of the Christ Church branch of the Auxiliary, spoke a few words of cordial greeting.

The annual report of the secretary was read and approved.

Bishop Reese then spoke of the Scholarship Fund, and expressed his gratitude to the Auxiliary for making it possible for him to help prepare a young woman for service by sending her to St. Faith's. He asked that we continue this Fund, as the need is constant.

Mrs. Wells announced the appointment of the following committees. The Nominating Committee, consisting of Miss Catherine Morrison, Chairman, Mrs. Ozias and Mrs. Larcomb; and the Committee on Resolutions, Mrs. Charles Reade, Chairman, Mrs. Ronan and Mrs. Stimmel.

Miss Catherine Morrison reported that the name of Mrs. Allan McGregor of Springfield had been placed in nomination for President of the Woman's Auxiliary of Southern Ohio. No other nominations having been received, Mrs. McGregor's name was posted and the nominating committee was instructed to keep the nominations open.

The Treasurer, Mrs. Hubbard, then gave the report of the funds on her books, necessarily an incomplete report as her books cannot be closed until January. The account now stands,



Balance, \$803.80; Receipts, \$4554.79; Disbursements, \$4569.-06; Balance on hand, \$789.53.

Carrying out the purpose of the following resolution passed at Portland, "Resolved — That the subject of Proportionate Giving and Stewardship be commended to the members of the Woman's Auxiliary for special study and practise," Mrs. Hubbard presented the subject to the meeting.

Mrs. Hubbard then read a letter from one of the Sisters of the Transfiguration telling of the boys now attending St. Alban's School.

Mrs. Wells then gave her annual address, speaking of the joy the three years' work with the Auxiliary had brought to her, and of the support and co-operation given to her in the Diocese. She reviewed the work of the past three years and gave suggestions for the future, sounding a call to service in assisting the incoming Board.

Mrs. Van Keuren, Treasurer of the United Thank Offering, reported a total of \$8771.47 on hand. She spoke of the purpose of the United Thank Offering and told of the encouraging and discouraging developments in the work. Charts showing the proportion of the total number of women in each parish who are giving to the United Thank Offering were shown and explained.

Mrs. McGregor, Educational Secretary, gave few statistics in her report, saying that the value of educational work, by its very nature, cannot be measured by statistics, but that, in all modesty, the Auxiliary might feel that, but for the years of educational work in the Auxiliary, it would have been more difficult to undertake the Nation Wide Campaign educational work in the Diocese this fall.

The report of the Credentials Committee was given by Mrs. Wells, showing that 84 delegates representing 46 parishes have registered. A count of visitors attending the meeting was made showing 19 visitors present.

Mrs. Wells announced that the questionnaire for branch statistics for the Annual Report would be sent out soon and asked that they be returned promptly.

Mrs. Norton, Secretary of the Supply Department, gave her report, showing by charts that the reorganization of the Department has made it possible for every parish and mission to have a part in the work and also showing the increase in work. The value of last year's work amounted to \$12509.71. Letters were read from the workers in charge of St. Luke's Hospital, Porto Rico, and St. Elizabeth's Hospital, Shanghai, China, and also from Miss Molyneux in Alaska thanking the Auxiliary for supplies sent them.

Mrs. Norton then showed some charts demonstrating the responsibility of the individual at home to the work of the mission field.



Mr. Reinheimer then spoke of the Nation Wide Campaign, saying that it was the effort of a whole generation to advance the Kingdom of God in our church, and urged that we press on, as the real work of the Nation Wide is just beginning.

The business meeting was then adjourned.

In the evening at 8:00 o'clock an organ recital was given in the church. This was followed by a reception held in the parish house.

A celebration of the Holy Communion was held on Thursday morning at 7:30. Bishop Reese was the celebrant, with the Rev. Donald H. Copeland assisting. About 75 attended this service.

Breakfast was served in the parish house at 8:15.

An officers' conference was held in the church at 9 A.M.

The business meeting was opened at 9:45, and the meeting immediately proceeded to the election of a president.

Mrs. Lewis moved that the nominations be closed. The motion was seconded and carried.

The roll of parishes was called, showing 36 represented and eligible to vote.

The secretary read Article 5, Section 3, and Article 7, Section 1, of the Constitution governing the election of president.

Miss Morrison read the names of those nominated for President. Mrs. Allan McGregor, of Springfield; Miss Kate Anderson, of Dayton; and Mrs. O'Ferrall, of Piqua.

It was suggested that each parish voting should mark the name of their parish on the ballot. This suggestion was adopted, ballots were distributed, and the nominating committee instructed to act as tellers.

Mrs. Glenn, chairman of the Bishop Tuttle Memorial Fund, explained the purpose of the home which this special will provide. The total amount now on hand is \$1327.00.

Miss Catherine Morrison then reported for the nominating committee. Of 36 ballots cast, Mrs. McGregor received 32 votes, Miss Anderson 3, and Mrs. O'Ferrall 1 vote.

Mrs. McGregor was declared elected president of the Woman's Auxiliary of Southern Ohio and graciously accepted the office.

Miss Matthews, Chairman of the National Board of the Woman's Auxiliary, then spoke. She impressed upon us the extreme importance of the Auxiliary from the national view point, from our position as Auxiliary to the National Council, we must hold ourselves in readiness to serve the whole church. She spoke of Miss Lindley's trip to the mission field, and of



Miss Tillotson acting as Executive Secretary during Miss Lindley's absence. She told of the survey which has been made of the equipment and salaries given our women workers, and of the establishment of a devotional center at Racine, and spoke of the United Thank Offering, calling it "the heart" of the Auxiliary.

The report of the Committee on Resolutions was then given by Mrs. Ronan. These resolutions were acted upon separately.

The adoption of Resolution 1 was moved. "That the Woman's Auxiliary of Southern Ohio send greetings and best wishes to Miss Grace Lindley, assuring her of our earnest prayers for a safe journey and during her visit in the mission fields." Motion seconded by Mrs. Van Keuren and carried.

The adoption of Resolution 2 was moved. "That the Woman's Auxiliary of Southern Ohio be responsible for \$300.00 for the Bethany Home Scholarship. Motion seconded by Mrs. Ledding and carried.

The adoption of Resolution 3 was moved. "That the Woman's Auxiliary of Southern Ohio be responsible for \$300.00 for the Bishop Reese Scholarship for 1924." Motion seconded by Mrs. Lewis and carried.

The adoption of Resolution 4 was moved. "That we extend our thanks to the retiring Board for their untiring zeal and prayerful faithfulness in strengthening the work of the Woman's Auxiliary in Southern Ohio." Motion seconded by Miss Matthews and carried by a rising vote.

The adoption of Resolution 5 was moved. "That this body extend its thanks to Bishop Reese and the clergy for their services, and to the women of Christ Church and St. Andrew's for their delightful hospitality, and that we show the same by a rising vote." Motion seconded and carried.

Mrs. Hubbard then announced that the amount of the offering at the service on Wednesday morning was \$62.15. The offering at the Thursday service was \$21.47, making a total of \$83.62.

Dr. Charles Reifsneider, President of St. Paul's University, of Tokio, Japan, was then introduced. Dr. Reifsneider's story of the horrors of the destruction wrought by earthquake and fire, and the desolation left in the wake of the catastrophe can never be forgotten by those who heard it. He told of the destruction of our own church property, and then spoke of the wonderful way in which the Japanese nation has met this crisis. He told of our own workers, of the fact that among our own staff every life was saved, of the establishment of an independent Diocese in Japan, and of the raising of 29,000 yen since the earthquake for the support of that Diocese, and of the consecration of our workers shown in that great Eucharistic service held on the ruins



of Christ Church Cathedral, a service of thanksgiving that our church has been given the opportunity to show forth the love of Christ to a suffering nation.

Noonday prayers were then read by the Rev. Charles A. Reade.

The business meeting was adjourned for luncheon, which was served in the parish house at 12:30.

The meeting was resumed at 1:15 P.M.

Mrs. Mitchell moves that the amount of the offering at the two services be given to the Japanese Emergency Fund. Motion seconded and carried.

The minutes of the meeting were then read by the secretary and approved.

There being no further business, the meeting was adjourned on motion.

## CONSTITUTION AND BY-LAWS CONSTITUTION

### ARTICLE I

**Name.** — The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

### ARTICLE II

**Object.** — The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort the three great aims of the Church, namely: Missions, Religious Education, and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

### ARTICLE III

**Membership.** — Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

### ARTICLE IV

**Officers.** — The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

### ARTICLE V

**Duties.** — Section 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Section 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

Section 3. The President shall be elected at the second Annual Meeting next after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled



until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

Section 4. Each Vice-President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-President or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

Section 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

Section 6. The Box Secretary shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

Section 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Section 8. The Treasurer of the United Offering shall under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

Section 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work of the Diocese, carried on under the auspices of the Woman's Auxiliary.

## ARTICLE VI

**Meetings.** — Section 1. There shall be an Annual Meeting of this Association, or there may be semi-Annual Meetings. Every parish branch may send three delegates, including an executive officer; and every mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.



Section 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Section 3. Convocation meetings may be held on the call of the Convocation Officers.

Section 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

## ARTICLE VII

**Mode of Election.** — Section 1. In the election of a President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Section 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

## ARTICLE VIII

**Amendments.** — This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

---

## BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery and traveling expenses of officers and speakers.



4. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

5. The accounts of the Treasurer and of the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

6. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

---

## FINANCIAL POLICY

### I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-wide Campaign Quota is the least amount each parish should give.

### II

1. It shall be the duty of every branch to aid in raising the Nation-wide Campaign Quota of the parish.
  - (a) By urging an every-member canvass and assisting in carrying it out.
  - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
  - (c) By giving when necessary as an organization.

### III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
  - (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B—\$60.00	I—\$15.00
C—\$50.00	K—\$10.00
D—\$40.00	L—\$ 7.50
E—\$35.00	M—\$ 5.00
F—\$30.00	N—\$ 3.00
G—\$25.00	O—\$ 1.00



- (b) Each branch shall decide to which class it will belong.
- (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
- (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
- (e) Payment of the Central Expense is necessary for memberships in the Diocesan Branch of the Woman's Auxiliary.
- (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

#### IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
