PRESIDENT'S ADDRESS

Dear Women of the Auxiliary;

A year ago you called into office a new Executive Board and placed grave responsibilities on nine hesitant women, but your faithfulness and constant cooperation have made our tasks easy and our burden of responsibility light so that we feel only a sense of thankfulness for the privilege of working with you. We look back on the ten months during which we have been in office and think of it as a time largely spent in getting our bearings; but, fortunately for our work, plans were so well laid by the out-going board that there was no interruption in Southern Ohio's work.

Our secretary has given you a detailed report of the work which you have accomplished since January first, so that it becomes my privilege to speak to you of matters looking toward the future and especially of our relation with the Auxiliary outside our own diocese. In the past year we have visited (by proxy) our missionaries in many lands as we have sent our representative, Miss Lindley to carry greetings and encouragement to workers scattered all the way around the world. Through the pages of the "Spirit of Missions" we have been able to keep in touch with her and now, shortly after her return to the Church Missions House she writes: "One of the most constant realizations in the last months was the fact that we were very near each other. You have made me feel your interest and help in what I was trying to do for you in representing the women of the Church in our foreign missions." We rejoice in her safe return and are confident that her journey will bear rich fruit in a clearer understanding of conditions in the field, which will be of great value to the future work of the Auxiliary.

During Miss Lindley's absence, Miss Tillotson gave herself unreservedly to the many problems of the Executive Secretary's office and, most unfortunately, her health has suffered in consequence. It was our expectation, until very recently, that we would have Miss Tillotson with us to address this meeting and I am sure you all share with me a sense of keen disappointment and distress because of her ill health. Our former president, Mrs. Wells and also Bishop Vincent are prevented from being with us on account of illness. We will wish, I am sure to send greetings to each of them and to ask prayers for their speedy recovery to health.

This meeting is being held during the three set apart by this diocese for work preliminary to the Every-Member Canvas which is to occur on November the 23rd. There is no matter of greater importance to the Woman's Auxiliary. The Auxiliary is always heartily in sympathy with the Church's Program and concerned in its support by a loyal, concentrated Church. We read, therefore with interest and careful consideration the following

message sent by our National Executive Board at its meeting, Oct. 1 - 5 to the National Council:

"We, the members of the National Executive Board of the Woman's Auxiliary, are deeply concerned over the grave financial situation facing the National Council. We are even more alarmed by the probable cause of the situation than we are by the possible effect upon the Program of the Church. Believing that the apathy of many Church members is due to failure to use the Power of Christ to meet the needs of the World today, and conscious of our own luke-warmness, we have dedicated ourselves anew to our Saviour and will strive to give proof in our lives of our conviction that He is the only Way of life. Further, we offer, with your approval to try to awaken the women of the Church to such a conception of Christ that we may all become more effective instruments of His Power in the accomplishment of His purpose for the World. Finally, we declare ourselves willing and ready to co-operate in any plans which the National Council may set before the Church to meet the immediate emergency."

This message, you will observe speaks especially of the need of a spiritual awakening. Perhaps the emphasis has been too long on money. I believe most truly so, when I think of certain facts disclosed by one of our parishes. By careful record keeping, this parish has discovered that only 26% of its members attend a service oftener than once a month. Unfortunately this parish is not unique. If such conditions are prevalent, is it strange if the Church's Program lacks enthusiastic support? Can we expect people to wish to bring the Power of Christ into the lives of others, when they have not sought it for themselves or tried to use it in their daily lives? As Auxiliary members each one of us has a challenging task in our own parish, which is to prove our loyalty to the Church by our constant dependence on Her services and Her ministrations. And let us prove by our joy in our work that there are compensations in service within the Church that excel the satisfactions from work in any other field. I hope that the Auxiliary of Southern Ohio will undertake or will co-operate with some plan suggested by the National Board whereby we lay particular emphasis on complete self-surrender to Christ. So convinced is your Executive Board of the need of "dwelling with Christ" that we began our work this fall by going into a thirty-six hour retreat at Bethany Home and from the richness of that experience we feel better prepared for a winter of service for Our Blessed Lord. May we, your Executive Board urge upon each branch of the Auxiliary more constant prayer and more frequent Corporate Communion.

I wish also to call your attention to the recent statement of the National Council in regard to the Program for 1925. Figures prove that Church people have money and that the total giving of our people for Church objects has increased yearly (parishes and dioceses having been greatly benefitted) but the national and international work of the Church has not shared in

this increase. The National Council asks: "Are we losing our perspective? Are we in danger of sacrificing the whole to the parts?" The Auxiliary has answered by pledging itself to greater sacrificial labors for the Program of 1925. What shall we of Southern Ohio do? I believe that many of you feel as I do, a discontent until this diocese changes its ratio of giving to the National Council. This can only be done however, when we increase the total of our gifts. Will you go home prepared to do your utmost yourself, but also to do a harder thing than that, which is to patiently lead others to see what Christ's Presence in the world means to us all and what this world might become if we gave ourselves completely to His purposes for us.

Another General Convention is only ten months away from us now and the thought calls to mind the two great gifts which the women of the Church plan to present at that time; the United Thank Offering and the Woman's Auxiliary Special. Both of these gifts are so important that we shall devote some time to their consideration during this meeting. Miss Lindley writes that she was impressed during her visits in the East by the need for about fifty new women missionaries. If fifty should volunteer tomorrow we could not send one of them now on the United Thank Offering, and the number that we are able to send in the next three years depends entirely on the amount of the next Offering. Our missionaries are agreed also on the need for the best possible training to fit them for their work. We must, therefore not only have a larger United Thank Offering but we must also work toward a successful completion of our gifts to the Special. I trust that the women of Southern Ohio will keep both the Offering and the Special constantly in mind during the coming months and that we may send worthy amounts to New Orleans.

You have heard the reports of Bishop Reese and our treasurer in regard to our two scholarship funds and their value in the past makes me sure that you will wish to undertake to raise similar amounts for the coming year. Our secretary has read the recommendation of the Board with regard to a slight change in our Constitution. This is in the nature of a notice, no action being taken until our next Annual Meeting when opportunity will be given for a free discussion of the proposed change.

In conclusion, may I ask of you for the year 1925 the same loyalty and co-operation that marked your work in the past, so that the Auxiliary of Southern Ohio may continue to pray fervently, to labor diligently and to give even more liberally to make Christ known to all nations as their Saviour and their King.

ANNUAL REPORT OF THE SECRETARY

The Executive Board of the Woman's Auxiliary of the Diocese of Southern Ohio has held four business meetings since it entered into office January ninth. There have also been four Convocational meetings—one at the Church of the Good Shepherd, Athens, on May 1st; one at Calvary Church, Clifton, May 6th; one at Trinity Church, Troy, May 7th, and one at St. Peters, Delaware, May 8th.

The Board regrets that it was necessary to accept the resignation of Mrs. Charles Hamilton, Vice-President of the Columbus Convocation. Her successor, Mrs. Frank K. Schafer, of Marietta, was elected to fill the vacancy at the meeting held in Delaware.

The reports of the three Convocations are submitted by their Vice-Presidents, as follows:

In the Cincinnati Convocation the Officers' Conferences still remain the clearing house for Diocesan news and information. They have enjoyed hearing ten different speakers at these conferences, which have been very well attended. The Vice-President lead a study class during Lent at Nativity Church, Price Hill, and spoke before Auxiliaries in seven Cincinnati parishes. A new department of the Woman's Auxiliary has been opened at the Church of the Advent, Walnut Hills, composed of young women anxious to help in Auxiliary projects. Since September, Sister Edith Constance, on furlough from Wuhu, China, and Dr. Walter Pots, head surgeon of the hospital at Changsha, have spoken before various branches of the Auxiliary in this Convocation.

The Columbus Convocation held two meetings this year—one at Athens and one at Delaware. During the year the President, with one or more Board members, visited eleven branches in this Convocation, most of which are in remote parts that are more or less out of touch with Diocesan work.

The Dayton Convocation reports a neighborhood meeting at Middletown in April, with Hamilton and Oxford branches as their guests. One new branch has been added—that at Mechanicsburg, where on March 28th four members of the Executive Board, including Miss Matthews of the National Board, were present at a well attended meeting of their Auxiliary, which, however, was not formally organized until April. Every branch in this Convocation has contributed to the Supply Department and general interest and enthusiasm are increasing, as evidenced by voluntarily assumed obligations outside of the regular pledges and allotments.

A report of the educational work and that done in the Supply Department will be made separately by the secretaries responsible for this work and will appear elsewhere in this report.

A report of the year's work would be incomplete without mention of the United Thank Offering, the Bethany Home and

Bishop Reese Scholarships and the Bishop Tuttle Memorial, but these will be reported by those responsible for their collection.

At a meeting of the Executive Board held November 11th, a motion was made and carried that the Board recommend changing Article 5, Section 3 of the Constitution, reading "The President shall be elected at the second annual meeting next after the General Triennial meeting," to read "The President shall be elected at an annual meeting held at least one year after the General Triennial meeting," this recommendation to be acted upon at the next annual meeting.

The Auxiliary now has in Southern Ohio, 71 active branches and during the year various members of the Board have visited in 38 of them. It is our hope to come into personal contact with every branch of the Auxiliary in our work of the next two years.

REPORT OF THE SUPPLY DEPARTMENT

Sixty-Seven of the Seventy-One branches of the Auxiliary in Southern Ohio shared in the work of the Supply Department during the year 1924. Every branch in the Dayton Convocation, including the recently organized branch at Mechanicsburg, took part in the work. Three branches in the Columbus, and one in the Cincinnati Convocation were unable to contribute. Six of the Church Schools in the Diocese contributed towards the fund for hospital supplies, while the Girls Friendly Societies sent a contribution of linens for the hospital.

Through this co-operation we were able to complete the allotments for the Emerald-Hodgson Hospital at Sewanee, Tenn., and to send the clothing and linens needed at the missions in Dante, Sandy Ridge, and Grace House on the Mountain, Virginia.

Christ Church, Cincinnati, sent to St. Paul's School, Beaufort, N. C. the year's supplies needed at that school.

This fall eleven parishes in the Diocese sent to ten clergymen and their families and to one of our Deaconesses, boxes with supplies for their personal use. Three of our Indian catechists in South Dakota were supplied with suits, and ten of the women missionaries received Christmas gifts.

A shipment of knitted articles was sent in May from the Supply Department to our mission at Allakaket, Alaska, while a good supply of scarfs, socks, etc. was shipped in December to the Seamen's Church Institute at San Francisco, California.

Our work for the general missions of our church for the coming year is most varied. Shipments have already been made to the Fort Valley High and Industrial School at Fort Valley, Georgia, and to the Butor School in Liberia, Africa. A small shipment of articles for St. Barnabas' Mission for Lepers in Japan

has also been sent. The efforts of the branches in the Diocese will be concentrated during the coming months to furnishing the supplies needed for St. James Hospital, Anking, China, and for St. Barnabas' Mission for Lepers at Kusatsu, Japan, while Christ Church, Cincinnati has undertaken to supply the whole allotment for St. Mark's Mission, Nenana, Alaska.

REPORT OF THE EDUCATIONAL SECRETARY FOR 1924

Education is one of the most important phases of our Auxiliary work. Without the knowledge of the work which our Church is undertaking, and the understanding of some of its problems we cannot hope to be of much assistance to the National Council to whom we are Auxiliary. It is only as we know the needs of the Church; know of the splendid men and women who are carrying on the Church's work, their devotion, their struggles, yes, their very heroisms—that we get the inspiration, the enthusiasm and the burning desire to help. We must know not only them but the people among whom they are working. We need to know of the rapid change that has come over China and Japan, and the terrible social and industrial conditions that it has brought about. We need to know of the women and children, working long hours in mills and factories. We need to know of conditions in our own country. Our American Indians, our Negroes, the Immigrants at our very door. Unless we know of these, how can we help them? How can we even *want* to help them? So we urge the women of the Auxiliary to support educational work. It will not only strengthen and uphold the hands of our missionaries and leaders of our Church, but it will add tremendous interests to our own lives.

Educational work in this diocese has gone steadily forward this past year. We have been most fortunate in having several splendid institutes for training leaders. Miss Laura Boyer led one in Cincinnati which was particularly well attended, and which aroused such enthusiasm that every parish in the Cincinnati Convocation, with the exception of two, had study classes on Japan the following Lent. We are most happy that Miss Boyer is returning to this Diocese for a whole week this coming January. One remarkable result of her visit to Cincinnati was the educational work that was undertaken by Christ Church, Cincinnati. Beside a large study group for the women of the Auxiliary, lectures on Japan were given at the Rector's Chapel Class; two intensive days were held for the Married Branch of the Girl's Friendly Society, and for the Mother's Club; two lectures were given to the Evening Branch of the Auxiliary, and each group of the Girl's Friendly Society had two evenings during Lent devoted to the discussion of Japan. If any woman in that Church failed to hear of Japan, it was not because of lack of opportunity.

Miss Matthews led a one-day institute for leaders in Columbus which has shown the most marked increase in interest in educational work of any place in the diocese. Splendid classes were held during Lent. A still finer piece of work was the institute which they arranged and which was held in November. Miss Tillotson had expected to lead this, but as her health prevented her, Miss Margaret Marston from Boston, kindly consented to

take it. We are hoping for very great results from this institute.

Several of our women were able to attend the classes on China that were held at the summer conferences at Gambier, Racine, and Wellsley.

Our greatest problem is in those parishes that are geographically separated from the larger centers, where the leaders are unable to attend the training classes and institutes. We are planning to have Miss Boyer visit some of these smaller places and wherever possible to hold one-day institutes. The educational secretary will be very glad to visit any parish that needs her and give whatever assistance she can.

Fifty branches of the Auxiliary reported educational work for last year, either study classes or program meetings. The very large majority of these followed the plan suggested by the general Church and had Japan as the subject of their study. Of course each parish has the choice of its own subject for study, and as we are no longer auxiliary only to the Board of Missions, but to the National Council, which includes all of the work of the church, the choice of subjects is almost unlimited. We recommend, however that wherever possible, the subject selected by the National Board be followed, because of the larger amount of material ready for that subject, and also because the training classes will be based on it.

China is the country that has been selected for study this year, and the text book recommended is "China's Real Revolution" by Paul Hutchinson.

Why is it that only fifty of the 71 parishes reported educational work? Why not every parish? No parish is too small or too weak! We urge each president to appoint an educational secretary, or an educational committee, whose special duty will be to organize educational work.

Let us try to make the knowledge of the Church and what it is doing, of vital importance to every woman in our Auxiliary. Then knowing the need of the world, and knowing that Christ is its only hope may we more willingly give of ourselves, of our time, and of our money, that we may truly hasten the coming of His Kingdom to this Earth.

MINUTES OF THE FORTY-EIGHTH ANNUAL MEETING

The 48th Annual Meeting of the Woman's Auxiliary of Southern Ohio was held at St. James Church, Piqua, on Wednesday and Thursday, November 12th and 13th. Bishop Reese held the opening service at 10:45, celebrating the holy communion with Rev. H. S. Abelwhite assisting. 180 made their communions at this service.

Bishop Reese preached a most beautiful and inspiring sermon from the following words taken from the 43rd chapter of Ezekiel: "And He took me and led me up to the gate which looketh to the east, and behold the glory of the God of Israel came from the way of the east. So the Spirit took me up and brought me into the inner court; and I heard Him speaking unto me and the man stood by me." From this text, he brought to us the thought that first we must have a vision of the world as it may become, and then through fellowship with Christ and the strengthening of our own lives, we may have power to help bring the world to a realization of this vision.

After this service, luncheon was served at 12 o'clock in the building adjoining the church, and immediately after, at 1:30 the President, Mrs. McGregor, opened the business meeting. Forty parishes responded to roll call, with 78 delegates and 45 visitors.

The secretary read her annual report, and a motion was carried that this report be placed on file.

Mrs. Laybourne, the Treasurer, then read her report for the ten months to November 1st. This report showed a balance of \$1,415.72 in the treasury. Of this amount the Central Expense Fund showed a balance of \$947.71, which seemed large, but our expenses for 1925 will necessarily be heavy, as most of the work of the Supply Department will go to China. The Treasurer urged the members of the Auxiliary to continue their efforts in the matter of the two scholarships—Bethany Home and Bishop Reese—which were a little short of the required amount. Mrs. Steil moved, seconded by Miss Johnston, that we accept this report. Carried.

Mrs. Glen reported for the Bishop Tuttle Memorial Fund that the contributions received to date amounted to \$2,508.00. This is \$500.00 more than was pledged at the last triennial, but is \$500.00 short of the goal we had hoped to reach. She hopes to make Southern Ohio 100% in the matter of representation in this gift.

Bishop Reese spoke briefly concerning the Scholarship Fund, assuring the members of the Auxiliary of his appreciation of their efforts to raise this money and of the continued need for it,

as he has the names of several young women for whom he would be glad to have scholarships in the near future.

The President then appointed the following committee on Resolutions: Mrs. Harley Morrison, Mrs. Hull and Mrs. George Kaufman. Mrs. Hull was unable to serve and Mrs. Steil was appointed to serve in her place.

The President's annual address then followed, in which she stressed the importance of the devotional life of the members of the Auxiliary.

The secretary read a letter from Bishop Vincent and telegrams from Miss Tillotson and Mrs. Wells, expressing their regret at being unable to be present at the meeting.

Sister Edith Constance, who is home on furlough from Wuhu, China, gave a most interesting talk on her work there, expressing her great gratification at being able, through the Woman's Auxiliary, to do her part in educating the Chinese children.

Miss MacCracken reported for the United Thank Offering, that we had, with the amount on deposit in New York, and the Fall offering, a total of \$18,725.26. There was an increase in the number of women giving this fall, over last of 235. 43 parishes increased their offering over that of 1923. Mrs. Matthews moved that Miss MacCracken's report be accepted. Seconded by Mrs. Glenn; carried.

The program for the day having been completed, a motion that we adjourn until the following morning was carried.

In the evening a reception was held at the home of Mrs. Flesh, where a delightful time was enjoyed.

Bishop Reese celebrated the Holy Communion on Thursday at 7:30, with an attendance of eighty. Breakfast was served at the tea room next door, after which an Officers' Conference was held at 9:15. The business meeting was opened at 10:15 with a discussion of future plans of the different departments.

Miss McCune presented the work of the Supply Department, for Butor School, Liberia, Ft. Valley, Ga., Leper Colony at Kusatsu, Japan, St. James Hospital, Ankling, and St. Marks, Alaska. She asked that one of our efforts in 1925 be to raise the money for one hundred blankets for the leper colony, also knitted articles, especially long wristlets. Miss Matthews spoke of the need for 300 sheets and 300 draw sheets for St. James Hospital, Ankling, and announced that she would try to get 600 women in the Diocese to volunteer to give one sheet each.

Miss Johnston announced that the work in the Educational Department next year would be on China and that the book to be studied would be "China's Real Revolution" by Paul Hutchinson.

Also that Miss Laura Boyer would spend a week in Southern Ohio in January, beginning with the 18th. She will be in Portsmouth, Dayton and Cincinnati, and Miss Johnston suggested that parishes pay the expenses of their Educational Secretaries to any of these meetings it is possible for them to attend.

Miss MacCracken spoke for the United Thank Offering, saying that the work in the next six months will be of the utmost importance. She asked that every member stress the United Thank Offering in every way and aid in its collection.

The President read letters from two of our Prayer partners, Mrs. Standing at Soo Chow, China, and Deaconess Hart, at Hankow, China.

Miss Matthews presented the work of the National Board in a most interesting talk. She asked that every member read the November number of the Spirit of Missions—that they try to understand the program of the church, talk of it, pray about it and give to it.

The President then introduced Deaconess Fuller of the Diocese of Chicago, who told us of her work, and she asked especially that the women of the church make an effort to enlist women in life work for the church.

Mr. Abelwhite read the noonday prayers, after which adjournment for lunch was taken.

Mrs. Herron, of the House of Church Women, announced that Bishop Reese had appointed Mrs. D. C. Larcomb as Diocesan Correspondent of the Church Periodical Club.

Mrs. Steil then reported for the Committee on Resolutions. These resolutions were acted upon separately, as follows:

Resolution 1: "That the Woman's Auxiliary send messages to Bishop Vincent, Miss Tillotson and Mrs. Wells, expressing regret that they were unable to be present and the hope that they may soon be restored to health." Adoption moved by Mrs. Bowman. Seconded and carried.

Resolution 2: "That the Woman's Auxiliary be responsible for \$300.00 for the Bethany Home Scholarship for the year 1925." Adoption moved by Mrs. Randolph. Seconded and carried.

....

Resolution 3: "That the Woman's Auxiliary be responsible for \$300.00 for the Bishop Reese Scholarship Fund for the year 1925." Mrs. Daniels recommended that the \$300.00 be changed to \$500.00. After some discussion, Mrs. Daniels moved an amendment to the resolution that we increase the amount to \$500.00. Seconded and carried.

At the conference of the United Thank Offering workers, the following resolution was adopted: That the Annual meeting of the Woman's Auxiliary be requested to adopt the following resolution (4) "That the members of the Woman's Auxiliary stress the United Thank Offering for the year 1925, and aid in every way in raising the amount hoped for." Adoption moved by Miss Johnston. Seconded and carried.

Resolution 5: "That we extend our thanks to Sister Edith and Deaconess Fuller for the very interesting talks which they gave to us." Adoption moved, seconded and carried.

Resolution 6: "That the members of this body express their appreciation to Bishop Reese and Mr. Abelwhite and to the organist, Mr. King, for their services. Also to Mr. and Mrs. Flesh, the President of the Auxiliary, Mrs. Frank Hubbard and the members of St. James parish for their gracious hospitality, and that they voice the same by a rising vote of thanks." Adoption moved, seconded and carried by a rising vote.

Mrs. McGregor announced that the offerings at the two services had amounted to \$103.14. Mrs. Mitchell moved that the money be divided between the two speakers, to be used as they saw fit. Seconded and carried. Deaconess Fuller announced that she would use her share to apply on a much needed scholarship.

Miss Richardson, of Christ Church, Glendale, issued a cordial invitation to the members of the Auxiliary to come to Glendale for the next annual meeting in May, 1925. Moved by Mrs. Shafer that we accept this invitation. Seconded and carried.

Mrs. Steil suggested that we have a woman in the Diocese to act as secretary to vouch for proposed candidates for life work in the church. This suggestion was gratefully received by the President, who said that the matter would be discussed by the Executive Board and brought up at the next annual meeting of the Auxiliary.

The minutes of the meeting were then read by the secretary and approved.

There being no further business the meeting was adjourned on motion.

CONSTITUTION AND BY-LAWS CONSTITUTION

ARTICLE I

Name.—The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

ARTICLE II

Object.—The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

ARTICLE III

Membership.—Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

ARTICLE IV

Officers.—The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

ARTICLE V

Duties.—Section 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Section 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

Section 3. The President shall be elected at the second Annual Meeting next after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled

until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

Section 4. Each Vice-President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-President or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

Section 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

Section 6. The Box Secretary shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

Section 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Section 8. The Treasurer of the United Offering shall under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

Section 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work of the Diocese, carried on under the auspices of the Woman's Auxiliary.

ARTICLE VI

Meetings.—Section 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every parish branch may send three delegates, including an executive officer; and every mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

Section 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Section 3. Convocation meetings may be held on the call of the Convocation Officers.

Section 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

ARTICLE VII

Mode of Election.—Section 1. In the election of a President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Section 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

ARTICLE VIII

Amendments.—This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceeding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery and traveling expenses of officers and speakers.

4. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

5. The accounts of the Treasurer and of the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

6. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

FINANCIAL POLICY

I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-wide Campaign Quota is the least amount each parish should give.

II

1. It shall be the duty of every branch to aid in raising the Nation-wide Campaign Quota of the parish.
 - (a) By urging an every-member canvass and assisting in carrying it out.
 - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
 - (c) By giving when necessary as an organization.

III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
 - (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B—\$60.00	I—\$15.00
C—\$50.00	K—\$10.00
D—\$40.00	L—\$ 7.50
E—\$35.00	M—\$ 5.00
F—\$30.00	N—\$ 3.00
G—\$25.00	O—\$ 1.00

- (b) Each branch shall decide to which class it will belong.
- (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
- (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
- (e) Payment of the Central Expense is necessary for memberships in the Diocesan Branch of the Woman's Auxiliary.
- (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
