PRESIDENT'S ADDRESS

We come together in another Annual Meeting, following by only six months our last one, and yet those six months are the months during which we appear to make the most progress in the task to which we have given ourselves. The reports of the Secretary and Treasurer have shown you what progress we have made. Our gift to the Memorial of the Woman's Auxiliary to Bishop Tuttle has reached the gratifying sum of \$2,800.00 and will surely pass the \$3,000.00 mark with the addition of the offering at the meeting this evening. This gives proof of our conviction that adequate training is necessary for our missionaries and of our willingness to co-operate to meet this need. We must conclude, therefore, that the pledges made at our last Annual Meeting for the two Diocesan training Scholarships will be met now that you know that the time for using them draws near. One other financial obligation resting upon us, I must also call to your attention, although the treasurer has already stressed its importance. Never have we had more urgent need of money to supplement our other gifts to the Supply Department. I can say no more about the United Thank Offering than my great joy that we have been privileged to present this spring collection at the beautiful service this morning and my eagerness to know the amount. Will each of you who has been here today be present in spirit at least, on the eighth of next October at the great presentation service in Trinity Church, New Orleans?

Our thoughts during this afternoon and tomorrow will center largely in plans for the future rather than reports of the past, and two matters of very great importance will come up for your consideration; possible legislation at the Triennial and the plans for our own 50th Anniversary Celebration. It is with much joy that we welcome Miss Lindley to our meeting and listen to her, not only in an account of her recent visit to the mission stations, but also to hear from her the presentation of some of the matters which will come up for discussion at New Orleans. Every one of us owes it to the Church to enter as fully as possible into the experience of the General Convention and the Triennial meeting of the Woman's Auxiliary. It is the Church and not a group of delegates which meets next October. Are we all willing to make prayerful preparation for that meeting so that the Church may be open to the guidance of the Holy Spirit? I have said that we have almost finished the months in which we appear to make the most progress in our task of helping the Church, but I wonder if there is not one way in which we can make the next three summer months count beyond even these last six months. During these weeks when many of our usual meetings and activities discontinue, can we put that same time into quiet Bible reading, meditation and prayer? If such a plan were as conscientiously carried

through as our other plans for meetings, sewing and raising money are, I believe the results to the Church would outweigh anything we have done in the past. One suggestion in carrying out such a plan is the use of the leaflet, "Learning to know Jesus Christ through a study of the Gospels."

Your president and four other Southern Ohio women had the privilege of attending the Woman's Auxiliary Conference held in Taylor Hall, Racine, during Easter week. About thirty-five women, representing eleven dioceses, spent the four days together in conferences, services in the beautiful chapel and daily celebrations of the Eucharist. The happiest spirit of friendliness and sympathy was apparent in the group, due in large measure to the gracious hospitality of Mrs. Biller, who acts as hostess of Taylor Hall. Such a visit convinces one beyond a shadow of doubt of the tremendous value to the Church of Taylor Hall as a center for devotion and conference, and I hope that many of you may find an opportunity to attend some meeting in that lovely place.

During the eighteen months that the present Board has been in office, we have visited 38 branches of the 72 in the Diocese, and in each case it has been a pleasure to see the Church and to learn something of the history of the parish and the faithfulness and loyalty that built and sustained it through many years. Next year we, as the Woman's Auxiliary of Southern Ohio, pass our fiftieth birthday, and it seems fitting that we should mark it in some way that will prove our appreciation of the vision and faithfulness of the women who have served the Church in years past, especially those who have been called from our sight. Most recently one of these servants of Christ, our former president, Mrs. Wells, has passed within the veil to the life of larger service, but she lives with us still in the memory of her sweet personality and her zeal for the building of the Kingdom. May we be given grace to carry on the task which she so recently entrusted to our hands.

In conclusion, I wish to emphasize the task which we have undertaken as members of the Woman's Auxiliary to the National Council. What does it mean to each of us? Can it mean anything less than that we have offered ourselves as helpers to the whole work of the whole Church? The National Council, representing the Church in its corporate activities is faced with a deficit of one million dollars in the budget expenses of the Church, practically nothing having been done on advance work. Each year pledges to the Church's Program have been falling behind the Budget requirements, while the strictest economy has been exercised at Headquarters. Such a procedure cannot continue for long; but what shall the alternative be? A drastic cut of salaries of our missionaries, working now on inadequate salaries, the abandonment of all mission work in one of the fields where we are now working, or what other course would

you suggest if you were called upon to answer such a question? Is the American Episcopal Church unable financially to carry forward its present Program of helping spread Christian faith and Christian practice throughout the world? I am sure you answer with me "No." Then is this great Church of ours unwilling to make the sacrifice? I hope that there again you answer with me "No." But we of the Church are not thoroughly awake to the needs of the task and the urgency of the cause. I beg of you that during this summer you will read, meditate and pray about this corporate responsibility resting on our beloved Church, and perchance opportunities will come to us to be better helpers than we have ever been before.

ANNUAL REPORT OF THE SECRETARY

The Executive Board of the Woman's Auxiliary of the Diocese of Southern Ohio held four business meetings during the past year. The annual meeting of the Auxiliary was held May 25th and 26th in Glendale, with 404 persons present; at this time delegates were elected to the Triennial, which was held in New Orleans in October. Four Convocation meetings were held as follows: November 11th, at St. Andrew's, Dayton; November 12th, at Grace Church, Avondale; November 18th, at St. Paul's, Columbus, and November 19th, at Zanesville. All the Convocation meetings were well attended and much interest manifested.

In the Cincinnati Convocation the Officers' Conferences were well attended each month, keeping the members of each parish in close touch with the work going on in the Diocese. Speakers at the conferences during the past year have been the Rev. Maurice Clarke, Miss Simrall, Miss Matthews, the Rev. Chauncey, and Miss Colston, with discussions led by local church people. One Quiet Day was held at St. Luke's during Lent, the leader being the Rev. Stanley Cleveland. There were two Quiet Hours—one at Advent, led by the Rev. George Dunlap, and the other at Christ Church, led by Miss Grace Lindley. One hundred and sixty-three dollars and forty-five cents was collected in this Convocation for the Leper Fund, this work promoted by the Federation of Churches.

The Dayton Convocation reports Miss Boyer's Institute at Christ Church, Dayton, as being inspirational and the attendance good. The Convocation meeting at St. Andrew's, Dayton, November 11th, was well attended, their cordial hospitality, the splendid reports and Miss Matthews' meditation on "Our Discipleship" leaving a lasting impression. The Vice-President visited three branches during the year and many others were visited by the President and members of the Executive Board.

There were 74 present at the meeting of the Columbus Convocation held at St. Paul's, Columbus, November 18th, and 35 at Zanesville on the day following. Increased attendance from the out-lying districts shows renewed interest from that source, which is most gratifying. Some of these branches were visited by the President, Supply Secretary, Educational Secretary and the Vice-President of the Convocation.

The work of the Supply Department and that of Religious Education will be reported separately by their Secretaries and will appear elsewhere in this report. The amounts raised for the Bethany Home and Bishop Reese Scholarships will be found in the Treasurer's report.

The goal set for our United Thank Offering for the Triennium was \$30,000.00, and we are all proud of the fact that we

were able to present at the United Thank Offering service at New Orleans the sum of \$31,832.07, which, with additional amounts sent in, was increased before the end of the year to \$32,136.53. This was possible only through the splendid enthusiasm and co-operation of the women of the Diocese, especially those Thank Offering Treasurers who have conscientiously worked to make this offering possible. Two ideas in regard to the Thank Offering have been especially stressed during this Triennium—first, that every woman in the Church should know of her privilege in sharing in the offering; and second, that the spiritual side of the offering should be especially emphasized. Though the ideal for which we have worked has not yet been accomplished, we shall hope and work, in the coming Triennium, for a greater realization of the meaning of the Thank Offering, in the heart of every Church woman.

It is hoped that there will be a large attendance at the next annual meeting, which will be held November 16th and 17th, at Christ Church, Cincinnati, at which time we shall celebrate the fiftieth anniversary of the founding of our Auxiliary. Let us make this great celebration an opportunity for wider vision and greater service to our Church, hoping that by our efforts we may uphold the high standards set by those who laid the foundations for our organization and worked so splendidly to further its achievements during the past fifty years.

REPORT OF THE SUPPLY DEPARTMENT

The work of the Supply Department was carried on most satisfactorily during the past year. Sixty-eight of the seventy-one branches of the Auxiliary in the Diocese contributed, every branch in the Dayton Convocation co-operating, while one in the Cincinnati, and two in the Columbus Convocation were unable to contribute. Every branch in the Diocese contributed to the "Sheet Fund" for St. James Hospital, Anking, China.

Last spring Christ Church, Cincinnati, furnished all the supplies for St. Mark's Mission, Nenana, Alaska, a most remarkable contribution, the work being valued at \$2,515.97.

The Diocese sent supplies in the spring, which completed the allotments for the Butor School in Liberia, St. Barnabas' Mission for lepers in Japan, and St. James Hospital in China. The supplies were adequate to meet practically every request, and through funds contributed by the branches, bed spreads and blankets for St. James Hospital, and dispensary supplies, blankets and 45 pounds of chaulmoogra oil for St. Barnabas' Mission were provided. We were also able to send a generous check to St. Barnabas' Mission for capes for the leper women, and through the "Sheet Fund," so ably sponsored by Miss Matthews, 624 sheets were provided for St. James Hospital.

Shipments of knitted articles were sent from the Supply Department last spring to St. Mark's Mission in Alaska, while five boxes of knitting were sent at Christmas time to the Seamen's Church Institute in New York City.

The work for the year 1925-26 includes 7 personal boxes for clergymen of our church, 3 suits for Indian catechists, and 12 Christmas gifts for women missionaries. This work has been completed this fall. An allotment of linens and blankets has also been sent to Mrs. Biller for use at Taylor Hall, Racine, Wisconsin, and shipments have been made to the Frazier Mountain Mission in Virginia, and to St. Elizabeth's Mission at Whiterocks, Utah.

The allotments for the spring months of the year will complete the assignments for the Frazier Mountain Mission and for St. Elizabeth's, and will also care for the Tobake School for boys in Liberia, the Easter School for boys and girls at Baguio, Philippine Islands, and Trinity House, a mission at Richlands, Virginia.

Christ Church, Cincinnati, will supply practically the whole assignment for St. Luke's Hospital for men and boys in Shanghai, China.

The work is being well supported in the Diocese as the following summary for 1925 will show:

Certainly Study is one of the most important parts, for how can we intelligently do any of the other three unless we know for what we are praying, and working and giving. So do not put the educational part to one side, as something to be undertaken by just a few, or as something that has no legitimate right to the time set apart for Auxiliary work. It is Auxiliary work, and time for study should be a part of every Auxiliary program. Most of the Auxiliaries in Southern Ohio are now recognizing this fact, and out of 70 branches 56 have reported educational work, 3 have reported no educational work, and 11 have made no reply.

The particular subject for 1925 was China. During January Miss Laura Boyer led three very successful institutes, using "China's Real Revolution," by Hutchinson, as the text book. The first of these was held in Portsmouth, and the other two in Dayton and Cincinnati.

Forty-three discussion groups on China were held throughout the Diocese, which is several more than ever before. Besides these discussion groups there were a few on the Program of the Church, Peace, "The World and I," and several on the Bible. A number of the parishes had delegates or visitors to the General Convention give talks on what had taken place in New Orleans, and also a number of branches reported talks by missionaries from the field.

Latin America has been chosen as the special field for study this year, with "That Freedom," by the Rev. Arthur Gray, as the text book. However, we hope that no branch of the Auxiliary will feel that Latin America alone is sufficient, for it is the aim of the Educational Department to awaken in the women of the Church such an interest in our Church, and all that concerns it, both of its present work, its needs and its future plans, that it will become of very first interest in our lives. We most earnestly urge the more general reading of our Church papers, particularly the Spirit of Missions, which is the official paper of the National Council. Through it we can keep in touch with the work of all of the departments, as well with all of the different mission fields. We have had our interest

aroused in Japan and China, and now that we are turning our special efforts towards Latin America, in our interest for the new country, we do not wish to lose our touch with the others.

The past year has been encouraging, and the most hopeful sign is the more general interest that has been taken in educational work, not only in our own Diocese, but generally so over the entire United States. With increased knowledge, undoubtably comes increased interest, with its inevitable following of increased service, and prayers and gifts. For this let us be truly thankful.

MINUTES OF ANNUAL MEETING, MAY 25-26

The Annual Meeting of the Woman's Auxiliary of Southern Ohio for the year 1925 was held at Christ Church, Glendale, May 25th and 26th. The meeting was opened with a Communion service, with Bishop Reese celebrant, assisted by Rev. Chas. G. Reade, Rev. Dr. C. K. Benedict and Rev. Gilbert P. Symons, 328 making their communion. The United Thank Offering was presented at this service. The Rev. Stanley M. Cleveland preached from the following words in 1st Corinthians: "But we preach Christ crucified, unto the Jews a stumbling block, and unto the Greeks foolishness; but unto them which are called both Jews and Greeks, Christ the power of God and the wisdom of God."

Following the service, lunch was served to the delegates and visitors in the Parish House, following which the business meeting was opened in the church. Mrs. Moss, acting for the President of the Glendale branch, welcomed those present most cordially, after which Bishop Reese gave a short talk. He asked those present to think especially of three things—first the 80th birthday of Bishop Vincent on Monday, May 18th, with thankfulness for his life; second, our consideration of the two organizations, Woman's Auxiliary and House of Church-women, and the value of holding a meeting for each during the year; third, our continued support of the Bishop Reese Scholarship.

The Secretary's report of the work done in the Diocese in the past six months was then read, and upon motion of Miss Ellen Smith, was accepted and placed on file. The roll call showed 126 delegates present from 56 branches, and 179 visitors, 15 branches not being represented.

Mrs. Laybourne then read the Treasurer's report, showing the following balances in the different accounts:

Miss Thompson moved that this report be accepted. Carried. Mrs. Laybourne urged the completion of the two Scholarship Funds, and the amount needed by the Supply Department—\$1,000.00 for hospital supplies.

The President's address then followed, in which she spoke especially of plans for the Triennial and the celebration of the fiftieth anniversary of the Auxiliary in November, 1926.

Miss MacCracken then gave the report for the United Thank Offering. The spring offering was \$5,649.78, making the total to date \$24,654.32. Of this offering, the Cincinnati Convocation had \$3,477.54, the Dayton Convocation \$738.59, and the Columbus Convocation \$1,298.97. Four parishes in the Diocese had made no report on their United Thank Offering.

Miss Grace Lindley, National President of the Woman's Auxiliary in New York, then spoke about plans for the Triennial to be held in New Orleans in October. These plans naturally divide themselves into five groups—Services, Conferences, Business Meetings, Missionary Meetings, and Study Classes, of which there will be ten on the subject, "The Power of Christ." Business matters to be considered at this time are: The message sent to the National Council, Peace and World Relations, the United Thank Offering, Suggestions on the Financial Policy, and suggestions for promoting co-operation in carrying on the work of the Church.

Following Miss Lindley's talk, Miss Matthews presented plans for the celebration of the 50th anniversary of the Woman's Auxiliary in November, 1926. Copies of these plans were distributed among the delegates, who were asked to study them and be prepared to act on them the following day.

The President then appointed the following committees:

Mrs. E. P. Barr, St. James, Zanesville.

As this ended the business for the day, the meeting adjourned on motion of Mrs. Laybourne, the delegates and visitors going immediately to Bethany Home, where they were the guests of the Associates of the Sisterhood of the Transfiguration. Supper was served on the lawn of the Home, and all enjoyed the delightful hospitality of the Sisters. Returning to the Church at 7:45, the Rev. Stanley Cleveland gave a very

interesting account of work among the students at the University of Wisconsin, and Miss Lindley told of her trip around the world, speaking especially of our missionaries in China and Japan, Honolulu and the Philippines, and urging us to make it possible to send more workers to the Orient, where they are so sorely needed. The offering at the evening meeting was devoted to the "Special."

The following morning a communion service was held at 7:30, with the Rev. G. P. Symons celebrant. The business session was resumed at 9:30, opened with prayer by Rev. Mr. Symons. The President announced that Friday, September 25th, had been set aside throughout the Diocese as a Day of Intercession for the Triennial.

The Committee on Elections then reported the following names as nominees for delegates to the Triennial: Mrs. McGregor, Mrs. Mortimer Matthews, Miss Elizabeth Matthews, Miss McCune, Miss Johnston, Mrs. Leding, Mrs. Glenn, Mrs. Rigdon, Mrs. Bowman, Mrs. Perkins, Mrs. Whiting, Mrs. Laybourne, Mrs. Randolph, Miss Morrison, Miss MacCracken, and Mrs. Hollenbeck. A ballot was taken, and while the tellers were out, the meeting was resumed.

Miss Matthews reported that the campaign for sheets for St. James Hospital, Anking, China, had reached a successful conclusion. She had hoped to have the names of 600 women as donors of many sheets, and she announced that 605 women had given \$665.80. Of this amount \$504.00 will be sent to Anking for the sheets, and the remainder, \$161.80, will go to Miss McCune for other articles to be purchased by the Supply Department for this hospital.

Miss McCune then spoke for the Supply Department, commending the different branches for the excellence of the work being sent in and making a plea for further contributions for the \$1,056 needed for Hospital Supplies, only \$382.00 of which has so far been received.

The Educational work for the coming year was presented by Miss Johnston, who spoke of the summer conference at Gambier and the summer School for Religion, to be held at Racine for three weeks, beginning July 13th. The Auxiliary will study Latin America during the coming winter and the book to be used will be "That Freedom," by Dr. Gray. Miss Johnston announced that she had for distribution copies of a booklet by Miss Laura Boyer, called "A Search for Peace."

Mother Eva Mary then spoke on the work at Bethany Home, giving a most interesting talk, and explaining the great need for a new building, as the present one, which has been in use since the founding of the Home, is inadequate.

Mrs. Herron announced that 3,500 copies of the report of the Provincial House of Church-women would be had for distribution, showing what the women in the Province were doing and that the report would be read by each rector.

The Committee on Election of Delegates to the Triennial reported that 76 votes were cast, which resulted in the election of the following: Mrs. McGregor, Miss Matthews, Miss MacCracken, Miss McCune, and Miss Johnston. The ballot was then taken to elect five alternates.

The President urged all members to make more extensive use of their annual reports, so as to be better informed on matters pertaining to the whole Diocese.

The President then called for action on the plans for the celebration of the 50th anniversary of the Auxiliary, submitted by Miss Matthews. Mrs. Herron moved that the plans be accepted as submitted, seconded by Mrs. Leding. A general discussion of the details of the plans followed, after which the motion was carried.

At this time the tellers reported for the Committee on Elections, that 65 votes were cast, and that four alternates had been elected, as follows: Miss Morrison, Mrs. Leding, Mrs. Matthews, and Mrs. Laybourne. It was necessary to take another ballot to elect the fifth alternate.

Mrs. Mark Mitchell then supplemented the remarks of Mother Eva Mary regarding the new building for Bethany Home by saying that \$75,000.00 would be required for this, half of which had been promised by one person in the Diocese, and that it would be necessary to raise the other half by individual contributions. She urged every interested person to help in this matter.

The Committee on the Memorial for Mrs. Wells reported with a short sketch of her life and a beautiful tribute to her work in the Church, read by Mrs. Dorothy F. Hubbard, while all present stood. At the completion of this report all knelt for a moment in silent prayer.

The Devotional Hour was conducted at 11:30 by Miss Lindley, who led the noonday prayers.

Just before adjourning for lunch the tellers reported that the fifth alternate had not been elected, and another ballot was taken.

The business meeting was resumed at 1:30. The Committee on Elections for the Triennial reported that Mrs. Whiting had been elected as the fifth alternate, 67 votes being cast.

Mrs. Schafer moved that the following change be made in Article 5, Section 3, of the Constitution: "The President shall

be elected at an annual meeting held at least one year after the General Triennial meeting." This motion was seconded and carried.

The President then announced the following committees for the celebration of the 50th anniversary:

On the Compilation of the Book of Remembrance:

Chairman: Mrs. A. N. Whiting, Trinity Church, Columbus.

Vice Chairmen: Mrs. Dorothy F. Hubbard, Trinity Church, Columbus; Mrs. James Perkins, Advent, Cincinnati; Mother Eva Mary, Mrs. Mortimer Matthews, Christ Church, Glendale; Miss Judith Colston, Christ Church, Cincinnati, and Miss Bertha Buvinger, Christ Church, Dayton.

On the Fund to be Raised:

Chairman: Mrs. McGregor and the Vice-Presidents of the three Convocations, Mrs. Randolph, Mrs. Bowman, Mrs. Schafer.

Miss Morrison, of Christ Church, Cincinnati, and Miss Tuite, of Church of Advent, Cincinnati, both issued most cordial invitations to the Auxiliary to be their guests for the annual meeting and celebration of the 50th anniversary in 1926. It was moved by Mrs. Leding that we acknowledge both invitations and leave the decision to the committee.

The Treasurer announced that the offering at the evening service was \$101.83, making the total \$3,003.43 for the Memorial. The offering on Wednesday morning was \$10.01, and it was moved by Miss Colston, seconded by Mrs. Reade that this money be given to the Supply Department to buy Chaulmoogra oil for the lepers in St. Barnabas Mission, Japan. Carried.

Mrs. Leding read the following report of the Committee on Resolutions:

Resolution 1: "That the Secretary of the Woman's Auxiliary send a letter to Bishop Vincent, congratulating him on his 80th birthday, and expressing our loyalty and thankfulness for his years of splendid leadership." Adoption moved by Mrs. Leding. Seconded by Mrs. Henry Wood. Carried.

Resolution 2: "That the Woman's Auxiliary send a message to Miss Tillotson and Mrs. Allison expressing our love and

assuring Miss Tillotson of our prayers for her recovery." Adoption moved by Mrs. Leding. Seconded by Miss Lucy Matthews. Carried.

Resolution 3: "That the Woman's Auxiliary send a message to Miss Laura Boyer, assuring her of our prayers for her speedy recovery from the operation which she is to undergo very shortly." Adoption moved by Mrs. Leding. Seconded by Miss Colston. Carried.

Resolution 4: "That it is the sense of this meeting that the Woman's Auxiliary cannot legislate for the House of Church-women which was created by a canon of the Diocesan Convention, and is made up of many constituent bodies besides the Auxiliary." Adoption moved by Mrs. Leding. Seconded by Mrs. Randolph. Carried.

There was some discussion following the reading of this resolution, at the conclusion of which a motion was made by Miss Morrison that we respectfully ask the Bishop to appoint a committee representative of the organizations concerned, to confer with him in regard to the value of the House of Church-women. Seconded by Mrs. Blackburn. Carried.

Resolution 5: "That we extend our thanks to the Rector and the members of Christ Church and the Woman's Auxiliary for their generous hospitality, and that we voice the same by a rising vote of thanks." Adoption moved by Mrs. Leding and carried by a rising vote.

Resolution 6: "That we express our thanks and appreciation to the Sisters of the Transfiguration and the Associates of the Sisterhood for their delightful hospitality at Bethany Home." Adoption moved by Mrs. Leding. Seconded by Mrs. Laybourne. Carried.

Resolution 7: "That to Miss Grace Lindley and the Rev. Stanley M. Cleveland, the annual meeting of the Woman's Auxiliary is indebted for their fine inspirational addresses, which will long be remembered by those present." Adoption moved by Mrs. Leding. Carried by a rising vote.

After the Minutes of the Meeting had been read by the Secretary and approved, a motion to adjourn was made and carried, following which the Rev. Mr. Symons closed the meeting with the benediction.

In Loving Memory of Alice Salter Wells

Since our Woman's Auxiliary last assembled in Convention, our President for the preceding Triennial has passed from the seen to the unseen, from the temporal order to the eternal, from life here, into the life which lies beyond the experience we call death.

Mrs. W. T. Wells died in a Columbus hospital at 2 o'clock on Monday morning, April 27th, following an operation for gastric ulcer. She had been in failing health for several years, and in a serious condition for some months. She went into the operation with peace and serenity, sustained by the presence of Bishop Reese, and in the care of a surgeon in whom she had every confidence, a friend of hers and of her husband for many years.

Alice Salter Wells, daughter of a clergyman of the Church of England, was prepared by heredity, early environment, and training, for the call to the Presidency of our Woman's Auxiliary which came to her in 1920, and gallantly did she lead us for three years, visiting in that time every parish and mission branch in the Diocese, many of them many times. A resident of Columbus for a quarter of a century, a communicant of Trinity Parish for many years, her life was closely identified with the philanthropic work of the city, and the social service work of the parish.

During the war she was appointed chairman of the work of the Red Cross in Franklin County. The experience gained in this service prepared her for the work for which she will be noted in the annals of our Auxiliary, namely, the reformation of the Box Work of yesteryear into the Supply Department of today. The results as told in the statistics of the increase of that work during her term of office prove the wisdom of the choice of Mrs. Wells as the one to carry through the reorganization; but the written reports can never adequately tell of her efficiency, her vision, her tact, and her courage. It is too soon for us to forget how gently and firmly we were turned during her administration from making the things we wished to make for the mission school or hospital of our choice, to filling the allotment sent to us from headquarters for the mission work designated. Those of us who can compare the work under the two methods will testify to the broader knowledge of the mission field, the greater interest in the whole work of the Church, and the enthusiasm of co-operation gained by the change in method.

God in His wisdom opened the door into the more abundant life to His servant, Alice Salter Wells, in the autumn of her years, the ripeness of her personality.

In thanksgiving for her service to the Church through the Woman's Auxiliary of Southern Ohio, shall we not resolve to express in our lives her faith in furthering new ventures, her courage in facing new responsibilities, her humility as a servant of Jesus Christ, and her joy in promoting the cause of His Kingdom?

CONSTITUTION AND BY-LAWS

CONSTITUTION

ARTICLE I

Name.—The name of this Association shall be “The Southern Ohio Branch of the Woman’s Auxiliary to the National Council.”

ARTICLE II

Object.—The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

ARTICLE III

Membership.—Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

ARTICLE IV

Officers.—The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

ARTICLE V

Duties.—Section 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Section 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

Section 3. The President shall be elected at an annual meeting held at least one year after the General Triennial meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop’s approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop’s absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the

Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

Section 4. Each Vice President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-Presidents or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

Section 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

Section 6. The Box Secretary shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

Section 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Section 8. The Treasurer of the United Offering shall under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

Section 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

ARTICLE VI

Meetings.—Section 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

Section 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Section 3. Convocation meetings shall be held on the call of the Convocation Officers.

Section 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

ARTICLE VII

Mode of Election.—Section 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Section 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

ARTICLE VIII

Amendments.—This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery and traveling expenses of officers and speakers.

4. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

5. The accounts of the Treasurer and of the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

6. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

FINANCIAL POLICY

I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

II

1. It shall be the duty of every branch to aid in raising the Nation-wide Campaign Quota of the parish.
 - (a) By urging an every-member canvass and assisting in carrying it out.
 - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
 - (c) By giving when necessary as an organization.

III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:

- (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B—\$60.00	I—\$15.00
C—\$50.00	K—\$10.00
D—\$40.00	L—\$ 7.50
E—\$35.00	M—\$ 5.00
F—\$30.00	N—\$ 3.00
G—\$25.00	O—\$ 1.00

- (b) Each branch shall decide to which class it will belong.
- (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
- (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
- (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
- (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

IV

- 1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
