## PRESIDENT'S ADDRESS

Eighteen months have elapsed since our last Annual Meeting, which, as you remember was pushed forward to May to permit the election of delegates to the Triennial. At that time you instructed the Executive Board to carry out certain plans for the celebration of our Fiftieth Anniversary. With what satisfaction they have discharged this duty, you are now in a position to judge. I trust there is no one, having attended the service and presentation of the Book of Remembrance this morning, who does not think that we are immeasurably richer for having thus commemorated the loyalty and devotion that strengthened the Diocese, and through it the whole Church in the years that are past. It remains for us to decide upon certain uses of the Book of Remembrance which shall make it a continual source of encouragement and blessing to us.

As for our Anniversary Scholarship Fund, you must have rejoiced, as I have, over the large number and splendid amount of the memorial gifts sent to this fund. With almost \$8,000 given in this way, we can be reasonably sure that the parish offerings will bring us to our goal of ten thousand dollars. Rejoice as we do on this account, there is much more to be done if we would accomplish our purpose in raising this Fund for the Diocese. Our real intention is to assist in training young women, who will offer themselves for service in the Church and of course one important step has been taken when we have in hand a permanent endowment for training. But there remains the still more difficult task of finding the right young women for the Church's work. Young people are just as altruistic, just as eager to give themselves to high causes today as ever before but it rests largely upon our generation to convince them that they can do this most completely through the Church. I have wondered if the careless, half-hearted volunteer service we sometimes give the Church, may not have made them think less of the Church in choosing their vocation. Women of Southern Ohio can best accomplish their purpose of finding and training recruits for the Church's work, if they will dignify every effort they make to help the parish, diocese or national Church.

A sub-committee from the Committee on the Book of Remembrance is bringing in for your consideration a report, with resolutions pertaining to the future use of both the Book and the Fund.

At the Triennial a year ago your delegates assumed certain obligations for you which you are asked to consider today. Among them is the Corporate Gift, about which nothing has been said to you previously, awaiting this occasion when we would have completed our Anniversary Fund and



could assume new obligations. It is our privilege to have with us today the Chairman of the National Committee for the Corporate Gift and she will address you this afternoon.

At the Triennial, your delegates, along with that great body of women expressed themselves as determined to make effort to help raise the general Church quota. At eight Convocation meetings since then, I have endeavored to make clear the financial situation in this Diocese, but, lest someone should have failed to hear, may I repeat myself. The Diocese has promised to pay the full amount of its quota, \$66,600.00. Counting all that is available for this purpose, including pledges and special offerings, we are still lacking \$19,000 of the total amount and the Woman's Auxiliary is attempting to raise at least one thousand dollars of this. On your return home will you urge your branch to send in something immediately to this Budget Quota as the year's pledge must be paid by December 31st.

The other matter about which I wish to speak dates back to New Orleans too, when your delegates expressed themselves in complete accord with the Message sent from that body of women to the National Council. This Message expresses the conviction that the Church falters and fails today, because we, Her members, are apathetic, lukewarm, and unwilling to use the Power of Christ to meet our daily problems and duties. Further it pledges the Woman's Auxiliary to an effort to awaken all the women of the Church to a rededication of themselves in devotion and service to Our Blessed Lord. In the year since that time I think we can truthfully say that uppermost in the minds of many of us has been the question as to how we can fulfill that pledge. In some dioceses real progress has been made, carefully selected and trained "Messengers" have carried the Message of their own renewed convictions to other women, and thus a new and finer loyalty has been manifest. I hope you understand how prayerfully and splendidly this work has been done, and in what a spirit of love and self-sacrifice, for it seems never easy for us of our Communion to talk to others of the things nearest to us.

In our own Diocese, I regret to say that we have gone much more slowly, the only Diocesan plan which I can report being the Day of Intercession, and I rejoice to say that excellent reports concerning that day have come to the Executive Board. However, that was but one short step in what should be a steady if perhaps slow progress. At the same time women have come to a realization of their failure and need for renewed conviction; the men of the Church, especially our Bishops headed by the Commission on Evangelism have planned a clear call to the whole Church, through what has come to be known as the Bishop's Crusade.



Some of you may wish to know just what the Bishop Crusade is so I shall quote the answer of Bishop Darst, Chairman of the National Commission on Evangelism:

"Our object is to bring to the Church a fresh realization of its power and mission; to kindle again in the hearts of its members a passion for the souls of men; to arouse the Church from its lethargy and send it out clad in the shining armor of a great faith to complete the task committed to its hands; to sound a note of sacrificial devotion to a cause immeasurably bigger than ourselves."

You will observe that the Message is an expression on the part of the women of a need that is expressing itself also through the plans for the Crusade and that they may be recognized, therefore as parts of the same movement. The objective of the Crusade, as defined by the Commission on Evangelism, is as follows: A Call to Rededication to Jesus Christ in Life and Service by

Confession of Christ openly before men as Lord and Saviour.

Regular Daily individual and family prayer.

Understanding better the mind of Christ through daily Bible reading.

Seeking strength for service through worship and Sacrament.

Active service by every member of the Church.

Developing a deeper responsibility for bringing others to Christ.

Earnest effort to combat worldliness by more consistent practice of the Christian life.

Surely women of the Auxiliary who have accepted the Message as their own will wish to do every thing in their power to forward the Crusade. Two things are necessary to its success; wide-spread knowledge of the plan and its purpose, and a Church that is on its knees in prayer for the success of the movement. Both of these things each of us can do, and then offer ourselves as ready to do anything else as direct in outlining the plan for this Diocese. Remember that, no matter how small and unimportant our own part appears, we have the strength of a Church-wide movement behind us and the urgency of a God-given task. The Preface to the Reports of the Missionary Council of the Church of England sums up the world situation today in the following words:

"Great movements, volcanic in their force and extent, are shaking the foundations and altering the whole aspect of human society. Old races are awaking, new races are tingling with adolescence; and the younger generation everywhere, ignorant and untried though it be, is minded



to take command. There is need everywhere of the guidance and the constructive force which only the Christian Church can give. It is true indeed that fear reasserts itself. The demands we make are exorbitant, unprecedented; and the home difficulties are immense. What will the Church do in response? Will the offering of life be adequate? We who love the Church must needs be walking these days in fear. Yet we can abate no jot of our demands on that account. We take the risk. We believe that God has spoken and when God speaks, man's hope and strength are to obey."

If the Bishop's Crusade is God's way of bringing our American Church to play a worthy part in this great if perplexing day of the world's history, let us give ourselves to it with a ready will and thank God for the responsibility he has bestowed upon us.

In closing may I tell you how full of gratitude my heart is, that you have let me serve the Church, through this office to which you called me, three years ago. Your cheerful co-operation, your friendship have been priceless to me and I owe you, and especially the Executive Board a debt which I can never repay.



## ANNUAL REPORT OF THE SECRETARY

This has been an unusually active year for the Woman's Auxiliary in Southern Ohio. Although there has been no annual meeting since May, 1925, all departments of the work have gone on with increasing interest. The Executive Board has held five meetings since January, and Convocation meetings were held in the Spring in Urbana, Winton Place, Circleville and Athens, all of which were well attended. The meeting at Circleville showed the largest attendance, with 154 present, representing nine branches. The date of October 15th was set aside throughout the Diocese as a Day of Intercession and was very generally observed, with gratifying results in many instances. The president of one of our missions in Columbus writes: "It was the first time that we had ever tried to observe such a day and we felt it was quite worth while. Fourteen women came to the Communion service; 32 came at various times to the church during the day, and at all hours there was some one in the church for prayer and meditation."

In the Cincinnati Convocation the Officers' Conference held monthly meetings at the Diocesan House with special speakers, including Bishop Colemore of Porto Rico, and Bishop Seaman of Northern Texas. A Convocational picnic was held at Waynesville, June 10th, preceded by a corporate communion at St. Mary's Church. The Society of Friends generously offered the use of their church and parish house for the luncheon and afternoon meeting. Seven branches were represented and eight Diocesan officers present.

Members of the Executive Board have visited many parishes in the Diocese at various times during the year.

Interest in educational work in this Diocese has been increasing slowly. Many of the parishes still report very little interest, but more and more are sending in encouraging reports in regard to both study classes and devotional groups. In January at Christ Church, Cincinnati, Miss Matthews led a two-day class on the Message, using the Triennial reports and "The Aim and Motive of Foreign Missions," by E. Stanley Jones, as the text books. About one hundred people were present both days. The subject for study for 1925-1926 was Latin-America, with "That Freedom," by Dr. Gray, as text-book. Two normal classes of one intensive day each, were held for leaders. These were followed by tea, and most interesting talks by the Rt. Rev. Charles D. Colemore, Bishop of Porto Rico, who spoke of the work in his own particular part of Latin-America.

Three from this Diocese attended a conference which was held at Racine for the women of the Fifth Province. Twenty-six Dioceses were represented and the conference was so helpful that plans have been made to hold a similar one next year. Classes were held there on rural work, which



is to be the subject for study this winter. The book to be used is "Beyond City Limits," by the Rev. G. F. Goodwin. This book and that of Miss Boyer, "The World Call to the Church," are the two especially recommended to the Woman's Auxiliary for study this year.

The report of the work of the Supply Department at this time can cover only the work of the spring months, as the full year's report cannot be given until the allotments and personal boxes are completed in December. The shipments last spring were for St. Luke's Hospital, Shanghai, China—an allotment cared for by Christ Church, Cincinnati, with some assistance from the other auxiliaries. In addition to this work, supplies were sent to the Easter School Baguio, Philippine Islands; the Tnbake School in Liberia; Frazier Mountain Mission and Trinity House, two missions in Virginia; St. Elizabeth's Indian Mission in Utah; St. John's in the Wilderness, Allakaket, Alaska, and surgical dressings were sent to the Church General Hospital, Wuchang, China. The total value of supplies sent last spring was \$5,309.51.

Interest in the United Thank Offering has shown a decided increase during the past three years, and many parishes have given more this year than ever before. It is very gratifying that there has been quite an increase in the number of women giving to the United Thank Offering, and there are now several Missions sending offerings which have no organized branch of the auxiliary.

The work of carrying out the plans for the Fiftieth Anniversary of the founding of the Auxiliary in our Diocese, which we are celebrating during this meeting, has engaged a large number of women in the Diocese, including the Executive Board and a special committee headed by Miss Elizabeth Matthews. The Book of Remembrance and Anniversary Scholarship Fund, presented at the service this morning, will be a lasting tribute to the memory of the women who have served this Diocese so faithfully during the past 50 years. A committee from each parish has been working, selecting names for the book, and the raising of the Anniversary Scholarship Fund, the income from which is to train women for the Church's work, has been in the hands of our president and a treasurer selected in each parish.

The Executive Board wishes to close this report with an expression of appreciation of your loyalty and co-operation, which have helped so much in our work, and bespeak its continuance for those entering upon their three-year term of office.

## REPORT OF THE SUPPLY DEPARTMENT

The supply work continues to receive the support of the Auxiliary, generous response having been made to every appeal. That interest in the work is general may be seen from the fact that every branch in the Dayton Convocation co-operated, while only one in the Cincinnati, and two (2) in the Columbus Convocations have been unable to contribute.

Very generous gifts from the Girls' Friendly Society in the Diocese were given last spring, and contributed much to the success of the work.

The year's report shows that Southern Ohio sent supplies to widely scattered fields—touching distant spots where our church has established her missions, and where we have been privileged to share in the work by sending our boxes of supplies.

Christ Church, Cincinnati, following their usual generous custom, took the assignment for St. Luke's Hospital, Shanghai, China, and this allotment was completed with a little help from the Diocese.

The Diocese, as a whole, has sent gifts to the Church General Hospital, Wuchang, China; the Easter School, Baguio, Philippine Islands; The Tnbake School, Liberia, West Africa; St. John's in the Wilderness, Allakaket, Alaska the Seamen's Church Institute, New York City; St. Elizabeth's Mission, Whiterocks, Utah; Frazier Mountain Mission, Trinity House, Jackson Field House, and Grace House, four missions in Virginia; and to the Okolona School, Okolona, Mississippi, while the dispensary supplies for Christ School, Arden, North Carolina, have been sent, and shipments of used clothing have been made to St. Mary's School in South Dakota.

This varied list of hospitals, schools, and missions, in many lands, shows that we have contributed to the Oriental and African work abroad, while at home we have had some share in the work for the Indians, the American Church Institute for the Negroes, and the mountain people of the South. Personal boxes have also been sent to ten of our clergy and their families, while Christmas gifts were given to ten of our women missionaries.

This report for 1926 is typical of the work we have shared together for three years, a generous, cheerful co-operation on the part of the parish branches which has brought much grateful appreciation from the missions to which our supplies have been sent.

## MINUTES OF THE ANNUAL MEETING

The annual meeting of the Woman's Auxiliary of the Diocese of Southern Ohio was held in conjunction with the celebration of its fiftieth anniversary, at Christ Church, Cincinnati, November 16-18, 1926. The celebration began with a tea on Tuesday afternoon, given by the women of the Church of the Advent, in the parish house of Christ Church. During the afternoon there was held a sale of articles collected from our industrial missions; also an interesting exhibition of objects having an historical value in the Diocese, which had been gathered from various parts of the country. A conference for educational leaders was held at 4 o'clock in the parish house.

At seven in the evening, at the Gibson Hotel, was held a family dinner with 667 guests present. Our president, Mrs. Allan McGregor, presided and introduced Miss Elizabeth Matthews as toast-mistress. Mrs. W. H. Allison and Miss Emily Tillotson, both of New York and former members of our Diocese, made short addresses. Mrs. Allison spoke on social service work in the church, and Miss Tillotson on the kind of training required for workers in the field. Miss Matthews spoke of the different offices on the Executive Board, and short addresses were made by a representative of each office who had served on the Board in the past.

Wednesday morning at 8 o'clock a memorial service was held in Christ Church, with Holy Communion celebrated by Bishop Vincent, with Bishop Reese as Gospeler and Rev. G. C. Dunlop as Epistoler. They were assisted by Rev. Frank H. Nelson, Rev. Charles G. Reade and Rev. Gilbert P. Symons, 364 communicated. At this service the Book of Remembrance was presented by Mrs. A. N. Whiting, who had acted as chairman of the committee on the compilation of the book. With her were Mrs. Dorothy F. Hubbard, vice-chairman, and the president, Mrs. Allan McGregor. The book was received by Bishop Vincent, who blessed it at the altar. Mrs. McGregor then presented the memorial gifts, which were received by Bishop Reese, together with the offering, to make up the anniversary scholarship fund. At the close of the service, breakfast was served in the neighborhood of the church.

The business session was opened in the auditorium of the parish house at 10:45. Miss Catherine Morrison welcomed those present in the name of the women of Christ Church, to which Mrs. McGregor responded. The president then appointed as a committee on credentials, Mrs. Talcott Clarke, Christ Church, Glendale, and Mrs. Walter Scott, St. Andrew's Dayton. The secretary's report of the work of the executive board since the first of the year, was then read. Mrs. Schafer moved that we accept this report; carried. Mrs. McGregor read instructions on nominations for president



from the constitution, and appointed a committee on elections as follows: Mrs. Dorothy Hubbard, of Trinity, Columbus, chairman; Mrs. G. T. Lawton, Church of the Good Shepherd, Norwood, and Mrs. Ralph Fehr, Christ Church, Dayton. The following committee on resolutions was also appointed; Mrs. J. D. Herron, Holy Trinity, Madisonville, Mrs. Roland Baggott, Christ Church, Dayton, and Mrs. Lafayette Woodruff, St. Paul's, Columbus. The treasurer's report, read by Mrs. Laybourne, showed the following balances in the different accounts:

It was moved by Mrs. Bowman, seconded by Mrs. Herron, that this report be accepted and placed on file; carried.

Mrs. Clarke reported as follows for the credentials committee: From the Cincinnati Convocation, 57 delegates and 6 alternates; from the Dayton Convocation, 36 delegates and no alternates; from the Columbus Convocation, 29 delegates and no alternates; from Missions, 10 delegates and 2 alternates; making a total of 132 delegates and 8 alternates present from 50 parishes and missions. There were 170 visitors registered, 13 of whom were from other Dioceses. A total of 310 women registered.

The president read her address at the close of this report. She explained the purpose of the Book of Remembrance and the Anniversary Scholarship Fund, and urged the raising of at least \$1,000 toward the budget quota. She spoke especially of the Bishops' Crusade and asked us to work and pray for this movement.

Miss MacCracken read the report for the United Thank Offering. The total offering for the Spring and Fall, including interest to January 1, 1927, is \$11,335.38. This comes from 74 parishes and missions and represents gifts from approximately 3,100 women. It is about \$3,000 more than the offering for the corresponding year of the last triennium.

Miss Johnston, in reporting the work of the educational department, spoke of the joy she had experienced in her work as Educational Secretary. She asked that the president of each Auxiliary appoint some one in her branch to act as educational secretary and report same to the Executive Board. She also asked that some woman in each Auxiliary be responsible for obtaining subscriptions to the Spirit of Missions. She said that at the present time there are only seven parishes with representatives of this magazine. Miss



Johnston presented plans for the coming year and announced that she had literature for sale to promote these plans. She thanked the women throughout the Diocese for their patience and support.

Miss McCune, in speaking of the work of the Supply Department, reminded the women that no supplies should be sent to Columbus after Christmas. She asked that a formal resolution of thanks be adopted and sent to Mr. Frohock, expressing our grateful thanks and appreciation for his generosity and courtesy in allowing the Auxiliary space in his furniture store for the supply department for the past six years. She spoke of plans for the future work of the supply department, and emphasized the pleasure and satisfaction she had derived from her work as secretary of supplies. Having seen the box work of the Auxiliary carried on in a home under crowded conditions, Miss Lucy Matthews moved that we pass a resolution of gratitude to the Frohock Furniture Company for their generosity in providing a place for receiving and sending out the material for the Supply Department; seconded by Mrs. Perkins; carried.

Mrs. Bowman read a message from Grace Church, College Hill, containing a memorial to Mrs. Martha Bakewell Avery, who had just died at the age of one hundred years, after serving sixty years in the Auxiliary of that parish.

After the reading of noon-day prayers, Bishop Reese gave a few words of greeting, congratulating the Woman's Auxiliary on its achievements of the past fifty years and expressing his entire confidence in its future.

Miss Matthews then read and explained the proposed changes in the Constitution and By-Laws pertaining to the Book of Remembrance, these changes to be acted upon at the afternoon session.

Adjournment was then taken for lunch, the business session reconvening at 2 o'clock. After prayer by the president, the first order of business was the election of a new president from the following nominations, which had been posted during the morning: Miss Catherine Morrison, Mrs. J. D. Herron, Miss Mary Johnston and Mrs. Frank Schafer. Mrs. Schafer withdrew her name from the list of nominations, saying that as she was from the Columbus Convocation, and it was customary for the three Convocations to rotate when electing a president, that office should be filled this year from the Cincinnati Convocation. The committee on elections acted as tellers. After the ballot had been taken, the president introduced Mrs. Robert Burkham, St. Louis, Mo., who spoke on the Corporate Gift. At the close of this address, Mrs. Herron read the following resolution pertaining to the Corporate Gift: Resolved: That the Woman's Auxiliary of Southern Ohio pledge \$2,000 to the Corporate Gift, this sum to be raised during the coming two years and presented



at the next Triennial in Washington. Mrs. Herron moved the adoption of this resolution and Mrs. Steil seconded it. Miss Tuite amended the resolution to read \$2,500 instead of \$2,000 and Miss Johnston offered a second amendment, raising the amount to \$3,000. Discussion followed regarding the amount to be pledged, and on the request of the committee, the feeling of the house having been obtained, the amendments were withdrawn and the whole matter was referred back to the committee for further consideration. The secretary read a message from the Officers' Conference in Cincinnati, congratulating the Woman's Auxiliary of Southern Ohio on its 50th anniversary. The committee on elections reported through Mrs. Hubbard, its chairman, that Miss Catherine Morrison was elected the new president, the vote standing as follows: Miss Morrison, 33, Miss Johnston, 11, Mrs. Herron, 6. Miss Morrison acknowledged the election with a few remarks. Mrs. Herron reported that the committee on Resolutions had changed the amount to be given to the Corporate Gift raising it from \$2,000 to \$3,000. The resolution was then voted upon and carried.

Miss Matthews then took the floor to present the matter of changes in the Constitution and By-Laws to care for the Book of Remembrance and Anniversary Scholarship Fund, and recommended the following changes in the Constitution, to be acted upon at the next Annual Meeting:

#### **Article V.**

Sec. 3. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. ADD She shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office.

Add this new Section to Article V.

Sec. 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board but shall meet with it upon request.

The following changes in and additions to the By-Laws, were then acted upon; No. 3 to be changed and added to, to read as follows:

A Central Expense Fund shall be provided for printing, postage, stationery and traveling expenses of officers and speakers. ADD And the shipping charges of Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

Miss Matthews moved the adoption of this By-Law: seconded and carried. Miss Matthews recommended that the present By-Laws Nos. 4, 5 and 6 be numbered 7, 8 and 9, and that the following new By-Laws be added and numbered 4, 5 and 6:



#### **By-Law No. 4.**

New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

Miss Matthews moved the adoption of this By-Law; seconded by Miss Smith and carried.

#### **By-Law No. 5.**

When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Anniversary Scholarship Fund.

Miss Matthews moved the adoption of this By-Law: seconded by Miss Buvinger, carried.

#### **By-Law No. 6**

The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meetings of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of Art.

Miss Matthews moved the adoption of this By-Law: seconded by Miss Tuite and carried. Miss Matthews then read the following resolutions:

WHEREAS—The book of Remembrance has been given to the Diocese of Southern Ohio by the Woman's Auxiliary on the event of its Fiftieth Anniversary, and

WHEREAS—it is the plan of the Woman's Auxiliary that this Book shall be a continuous record of lives of exceptional service and devotion, and

WHEREAS—it has been decided to reopen the Book every third year, the year of the meeting of the General Convention, for the inscription of the names of those who have died within the Triennium, who are counted worthy of a place in the Book of Remembrance, and

WHEREAS—the next opportunity for the entering of names will be in the year 1928,



BE IT RESOLVED that in the year 1928, names of women who have died prior to the Celebration of our 50th Anniversary may be submitted to the Executive Board for inscription with more recent names, in those exceptional cases where the Parish Committee can state that the previous omission was due to an oversight or misunderstanding of the required conditions.

Miss Matthews moved the adoption of this Resolution; seconded by Mrs. Clifford Douglas; carried.

BE IT RESOLVED that the incoming and outgoing Presidents appoint a Custodian for the Book of Remembrance by resolution of the Annual Meeting, till the changes made in the Constitution are ratified at the next Annual Meeting of the Woman's Auxiliary.

Miss Matthews moved the adoption of this Resolution; seconded by Miss Buvinger, carried.

Miss Matthews then read the "Instrument of Trust," pertaining to the Scholarship Fund, as appended to these minutes, and asked that a resolution be passed empowering the Executive Board to execute this Instrument. Mrs. Reese moved that we change the name "Anniversary Scholarship Fund" to "Memorial Scholarship Fund." Motion seconded by Mrs. Woodruff and, after some discussion, carried. Miss Matthews moved that the delegates in Annual Meeting assembled, empower the Executive Board to execute the Instrument of Trust; seconded by Mrs. Leding; carried.

Miss Colston moved that a report of the Memorial Scholarship Fund be made by its Trustees at each Diocesan Convention; seconded by Mrs. Blackburn and carried.

The following Resolution was then read by Mrs. Heron, the chairman of that Committee:

RESOLVED: That we express our appreciation and thanks to Our Bishops and other clergy who served at our Memorial Service, and to the organist and choir for their share in adding to the beauty of the service of Holy Communion; The members of Christ Church, who have made us so welcome, and to the members of the Church of the Advent for the delightful tea; The various committees who have contributed to the success of our Fiftieth Anniversary; Those who provided the beautiful and appropriate table decorations for our Family Dinner; And that we express our very real gratitude to the speakers who brought us so much inspiration at our Dinner;



And finally that we go on record as to the great debt that we owe to our outgoing officers for their wise and untiring leadership.

Mrs. Herron moved the adoption of this Resolution; seconded by Mrs. Strong and carried.

Mrs. McGregor appointed Miss Judith Colston as Custodian of the Book of Remembrance, to serve until January 1.

At this meeting, Mrs. McGregor wore a silver cross given by Mrs. Rochester, the first President of the Woman's Auxiliary, to Mrs. James H. Perkins, Church of the Advent, Cincinnati. This cross had been given by Mrs. Perkins to the Woman's Auxiliary, to be worn by each President while in office.

Mrs. Laybourne then announced that the total sum raised by the Diocese for the Memorial Scholarship Fund was as follows:

Upon the announcement of this gratifying result, the entire assemblage rose and sang the Doxology.

The secretary then read the minutes of the meeting, following which on motion of Miss Ellen Smith, the meeting was declared adjourned.

## THE BOOK OF REMEMBRANCE

The Book of Remembrance was presented to the Bishop of the Diocese at the Memorial Service, November 17th, by Mrs. A. N. Whiting, Chairman of the Committee charged in May, 1925 with its compilation.

The Book is bound in dark brown morocco leather with wrought silver jeweled corners and clasps. It contains some two hundred pages, as follows: A Title page, a Dedication to the Women of the Diocese who have contributed to the upbuilding of the Church of Southern Ohio and have now entered Paradise, and three Prayers to be read at services when the Book is used. Then follow the pages devoted to the parishes, one for each, with the exception of a few large parishes that have each been accorded several pages. As the parishes are recorded chronologically, St. John's, Worthington, founded in 1803, heads the list. On each page are listed those names which the Parish Committee submitted to the Diocesan Committee. These names are entered by their baptismal names and surnames, in two parallel columns on the page, recorded in the chronological order of the date of their deaths. The lettering throughout is done by hand in old English script in black ink with the initial letters of the parish in red. The initial letters of the Dedication and the Prayers are illuminated in soft red and blue and gold. After the pages devoted to the existent parishes, appear the names of those that have been closed. In some of these, it has been possible to get the names of women who gave devoted service through them to the Church. Finally there are some fifty blank pages on which future parishes may be entered; as it is planned that this Book shall serve for the recording of many faithful lives for many years to come. On the final page, there appears "May these rest in peace and may light perpetual shine upon them. Amen."

The Book is the gift of some 50 women, who have served the Diocese as members of the Executive Board of the Woman's Auxiliary since 1900. It was made under the direction of Mr. F. C. D. Palmer of the Rose Bindery in Boston. The Book was on view in Christ Church Chapel, all day, after its presentation at the Memorial Service, November 17th, and was under the care of a Guard of Honor.

The actual Forms of Record submitted by each parish with the names chosen for the Book have been transcribed on permanent blanks and are filed in several leather volumes, which are known as the Archives of the Book of Remembrance. While these volumes are not things of beauty, they are invaluable for the human interest and the history they contain. The responsibility for securing the names and record forms for the Book, and directing its compilation, was in the hands of the following committee:

## INSTRUMENT OF TRUST

THIS INSTRUMENT OF TRUST, executed this.....  
.....day of December, in the year of Our Lord,.....,  
by the Woman's Auxiliary of the Diocese of Southern Ohio,  
to the Trustees of the Diocese of Southern Ohio, a corpora-  
tion, under the laws of Ohio, WITNESSETH:

That the said Women's Auxiliary hereby as-  
signs and sets over to the said Trustees, as a trust Fund, the  
sum of twelve thousand (\$12,000.00) dollars, more, or less,  
with accretions thereto, and accumulations thereof, as here-  
inafter provided, for and upon the following specified pur-  
poses and trusts:

(1) The initial and present amount of said Fund, be-  
ing a gift to the Church in Southern Ohio, upon the occasion  
of the FIFTIETH ANNIVERSARY of the said Woman's  
Auxiliary, the said Fund, accretions and accumulations,  
shall be known as the Memorial Scholarship Fund."

(2) The said Fund, with accretions and accumula-  
tions, as hereinafter provided, shall be invested and re-  
invested, from time to time, as occasion may require, and the  
income only, except as hereinafter provided, shall be used  
for the purpose of aiding the training of such Church Wom-  
en of the Diocese of Southern Ohio, for service in, or for the  
Church, either in the Home or Foreign fields, as shall be  
nominated to the Bishop, or in his absence, to the Ecclesias-  
tical Authority of said Diocese, by the Executive Board of  
the Woman's Auxiliary, of the Diocese, and approved by the  
Bishop or Ecclesiastical Authority.

(3) For, and during, such time as there may be no  
woman of said Diocese, who is an approved beneficiary for  
training, or, for such time as there may be a substantial  
balance of income unused, and upon a Certificate by the  
President, and Secretary of said Woman's Auxiliary, to said  
effect, or effects, the whole, or part, of said income, as the  
case may be, shall be allowed to accumulate and be added  
to the Principal of the Fund. A candidate may apply for aid  
in procuring such training for any type or form of Church  
Work, provided only that she agree to serve as a paid  
Church-Worker for three years after the completion of her  
training, and, if prevented from giving the whole, or part  
of said three years of service, to refund pro rata, the amount  
expended, on her training, except in very exceptional cases,  
such as failure in health, or other equally exceptional cases,  
all of which must be passed upon favorably by the Execu-  
tive Board of the said Woman's Auxiliary. This paragraph  
shall not be construed to place the Trustees of the Diocese  
under any obligation to enforce any such agreement.

(4) The income of said Fund, shall be paid, from  
time to time, by said Trustees of the Diocese, directly to such  
beneficiaries as have been approved as aforesaid, upon the



written order of the President and Secretary of the said Woman's Auxiliary, specifying in each and every of said written orders, the amount to be paid, and the name of the payee.

(5) It shall be within the power and discretion of said Executive Board to apply a portion of the Income thereof, to the education of approved beneficiaries, for, and during their last two (2) years in College, as well as for, and during their more immediate training for Church Work, provided, however, the aid given to any one beneficiary, shall not be for more than three (3) years altogether.

(6) Said Fund shall never be closed, but may be added to from year to year by said Woman's Auxiliary, or any of its Branches, or by individuals, by gift, or bequest, or by such repayments and accumulations, as may be made, or may accrue, pursuant to the provisions of paragraph three (3) provided only that such additions, gifts, bequests, repayments, or accumulations, shall be upon the same trusts, as herein otherwise provided.

(7) Upon the occasion of the Annual Meeting at the One Hundredth Anniversary of the Woman's Auxiliary of the Diocese of Southern Ohio, it shall be within the power and discretion of said Woman's Auxiliary, by a vote of two-thirds (2-3) majority of the delegates present thereat, to alter the details of the Trust hereby established, provided the fundamental purpose, which is declared to be the aiding in the training of Church Women generally for Church Work, be preserved.

## CONSTITUTION AND BY-LAWS

### CONSTITUTION

#### ARTICLE I

**Name.**—The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

#### ARTICLE II

**Object.**—The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

#### ARTICLE III

**Membership.**—Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

#### ARTICLE IV

**Officers.**—The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

#### ARTICLE V

**Duties.**—Section 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Section 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

Section 3. The President shall be elected at an annual meeting held at least one year after the General Triennial meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

Section 4. Each Vice President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall



be held at a Convocation meeting called for the purpose by the retiring Vice-Presidents or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the president in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

Section 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

Section 6. The Box Secretary shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

Section 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Section 8. The Treasurer of the United Offering shall under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

Section 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

## ARTICLE VI

**Meetings.**—Section 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

Section 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Section 3. Convocation meetings shall be held on the call of the Convocation Officers.

Section 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.



## ARTICLE VII

**Mode of Election.**—Section 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Section 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

## ARTICLE VIII

**Amendments.**—This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

---

### By-Laws

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expenses of officers and speakers, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.



6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of Art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

## FINANCIAL POLICY

### I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

### II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
  - (a) By urging an every-member canvass and assisting in carrying it out.
  - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
  - (c) By giving when necessary as an organization.

### III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
  - (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B—\$60.00	I—\$15.00
C—\$50.00	K—\$10.00
D—\$40.00	L—\$ 7.50
E—\$35.00	M—\$ 5.00
F—\$30.00	N—\$ 3.00
G—\$25.00	O—\$ 1.00



- (b) Each branch shall decide to which class it will belong.
- (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
- (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
- (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Women's Auxiliary.
- (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

#### IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
