PRESIDENT'S ADDRESS

To the Bishop and Fellow Members of the Woman's Auxiliary of Southern Ohio:

As you all know I have been to Alaska this summer, and I warn you that all my talk this winter will be colored by what I saw and heard there—salmon pink, as it were.

As I look over this fine gathering I am reminded right away of an Alaskan story. You know up there no human habitation is very permanent—tents, camps, villages and towns are here one day and gone the next. So it happened that two men from Alaska stood in New York before the Woolworth Building and its neighboring towers and one said to the other, "Say, Bill, this looks as if it is going to be a permanent camp."

This afternoon at our fifty-first Annual Meeting it seems to me that the Woman's Auxiliary of Southern Ohio is going to be a permanent organization.

Here and there I see new faces representing old parish branches for the first time, and some representing new branches. We have a special welcome for you and hope you will be with us often in the years to come.

Then there are the old friends. Each year our reunion grows more precious. As our knowledge of each other, and of our work, deepens and broadens we come to look upon these meetings as the red-letter days of the year.

Then those others whose faces are gone from us forever, but whose spirits are the more present—strengthening us and guiding us into greater freedom and truth.

I wish to speak of five of these women, and shall ask you to stand while I read their names and a few words of appreciation of their work among us.

Mrs. W. A. Chavous, President for several years of the Auxiliary of St. Philip's Mission, Columbus. St. Philip's is one of our oldest colored missions and is just about to become a parish, an end toward which Mrs. Chavous and her fellow workers of the mission have been working for years. We are glad to know that she died with this definite hope in her heart.

Mrs. Robert T. Hance, President of the branch at St. Paul's Cathedral, died this summer following an accident. Under discouraging circumstances of changed neighborhood conditions and uncertain plans she fought a brave fight, and with a small band of faithful workers kept the Auxiliary alive, taking part in all its activities. We shall miss her, for she had been our friend for years. However, we know that when a new St. Paul's arises her spirit will be present as one who rejoices.

Mrs. Robert Smith, of St. Stephen's Parish, Winton Place, Cincinnati, Treasurer of the Auxiliary. She was one of the founders of this parish, and a faithful worker of the Auxiliary for many years.

Mrs. Clayton H. Randolph, President of the branch at the Church of the Ascension, Middletown, and Vice-President of the Dayton Convocation during the last two terms—a woman we can ill spare in parish and diocese. Her rare qualities of mind and soul marked her as one of God's chosen vessels. It is with real sorrow that we add her name to those already written in our Book of Life.

Mrs. Mary M. Emery, of Christ Church, Cincinnati, died on October 11, thus ending a long life filled to overflowing with the romance of giving. It is many years since she attended an Auxiliary meeting, yet her great generosity, breadth of vision and deep interest in the cause of Christ throughout the world kept our work ever before her. In her will, in addition to other large bequests to the Church, she left \$50,000 to the National Woman's Auxiliary. We remember her before God with love, gratitude and thanksgiving.

"From Thy love as a Father,
O Lord, teach us to gather
That Life will conquer Death:
They who seek things eternal
Shall rise to light supernal
On wings of lowly faith."

I must add a few words to the Secretary's report of my visits throughout the diocese. It has given me the greatest pleasure, this going in and out among you, telling you of the work in general and hearing about yours in particular. I have loved sitting down with you at luncheon or over a cup of tea or evening refreshments, and being able to call you all by name at least once. I cannot always fit the right name to the right person when next we meet. I wish I had that gift of Kings—always to connect names and faces correctly—but, alas, I have it not! Nevertheless, I know that I know you and that you know me, and that we have much in common.

One thing that interests me is that you are all so different—the various branches, I mean—and that you always tell me about it. From my own parish branch, which is, I think, the oldest and largest, to the newest and smallest mission, I hear the same tale. And it is true. We are different, as different as the noses on our faces, and you have only to glance around to see how different that is. But, after all, all noses are created for the same purpose—to breathe through—to smell with. And all Auxiliaries have one mission—the extension of

Christ's Kingdom here on earth. Let us emphasize the thing we have in common above our differences and by so doing we shall realize more and more our corporate power, and with that realization our differences will be less and less important.

I think that, generally speaking, we do not quite understand the meaning of corporate power. We think of it, don't we, as a more or less level thing made up of averages, each one doing his or her share—no more, no less—and thereby generating quite a bit of power. But if, instead of thinking of it as a plain we should think of it as a mountain range, what then? A conglomerate mass of different heights rising from one level. Some peaks much higher than others, some few with their heads in the clouds—dreaming dreams and seeing visions!

This summer I have seen mountain ranges that fairly took my breath away—their stillness, their freedom, their farness, as if they were perfectly conscious that they carried within themselves, with their glaciers, their streams, their coal, their gold, enough motive power to move the world. It gave me quite a new idea of what corporate power could be. Would God the Church of Christ might come to the realization that it carries within itself enough corporate power to move the world!

So, realizing our common mission, let us take our problems and differences and turn them into opportunities for the common good, feeling each one of us that, through Christ which strengtheneth us, all things are possible.

We need not be afraid of doing too much, for we know that that is impossible. We might re-read to our own good Articles 12 and 14 of the Articles of Religion on Good Works and Works of Supererogation.

The actual dates set for the Lausanne Conference have come and gone. It is only as we realize our unity in Christ and desire it and practice it in our every-day lives that the work of the Conference lives or dies.

Our Memorial Scholarship Fund continues to grow, and the income from it will be available from next January. We have not as yet found the young woman who is to be the first to use it for special training in work for the Church, but I feel sure we shall find her and I ask you to add your prayers to mine that this fund may be a real force for good in our diocese and far beyond.

Now a word of our Southern Ohio workers who are already in the field: Sister Olivia, of the Community of the Transfiguration, has gone back to Hawaii and is again in charge of St. Andrew's Priory, our school for girls in Honolulu—the right woman in the right place. She has with her, as assistants, Sister Caroline, Sister Mabel, Mrs. Brown, of

Athens, Miss Phellis, of Mechanicsburg, and the Misses Jenkins. Sister Constance, Sister Ruth and Sister Helen, of Wuhu, China, have returned for the time being to the Mother House. Sister Ruth is to tell us tomorrow something of recent developments along the Yangtze. Miss Irene Gehring, of the Church of the Resurrection, Fernbank, Cincinnati, is also back, temporarily, we hope, from a nursing mission in China. She is helping Deaconess Beeson and Miss Tromey in the splendid work they are carrying on at St. Andrew's Mission, Addyston. Mrs. Standring has returned to Soochow. Miss Zimmerman has left the Department of Religious Education, where she was working so effectively under Mr. Clarke, and has gone to take up similar work in the Diocese of Ohio. These few we know of—I wish we had reports of all of them.

You will be asked during this meeting to act upon the changes in the Constitution, recommended last year, for the care of the Book of Remembrance.

Our next annual meeting will be held in May, 1928, when we shall elect five delegates and five alternates to represent the Woman's Auxiliary of Southern Ohio at the Triennial meeting in Washington in October, 1928.

In this connection, the Board has one recommendation to make—that the Annual Meetings of the Woman's Auxiliary of Southern Ohio be held regularly each May and Convocation Meetings each fall. This involves a slight change in the Constitution, and probably a change in the Auxiliary year to run from September to September instead of from January to January. We wish to do only what seems agreeable and advisable to the majority of the branches. We shall ask Miss Mary Johnston to speak to this recommendation during this meeting. We hope that you will listen attentively, talk it over this winter in your branches, and come prepared to discuss the matter and vote on it at the next diocesan meeting in May, 1928.

I spoke in my last letter to you of the year books. We have some extra ones here if you wish them. I ask you again to use them and to compare them from year to year. I consider this one (exhibit) an ideal year book and this one (exhibit) not worth the paper on which it is printed.

Dear friends, I want us to really live these two days at this meeting, to take in the reports, the talks on the various fields, the hymns, the prayers, with our whole beings, and to meet again tomorrow morning at our service of Holy Communion with renewed determination to prove more worthy, more trustworthy.

I shall not speak of the work of the various departments. The other members of the Board are here. The work is

theirs and only they can present it in its entirety. If there is anything you do not understand you will have opportunity to inquire about it at the Officers' Conferences tomorrow morning. When the real work of the Auxiliary is concerned I sometimes feel like the fifth wheel; the rest of the Board carry it on so well that there is little left for me to do.

And this reminds me of another Alaskan story: A man on snowshoes met another man with a dog sled. All the dogs immediately began to bark as all Alaskan dogs do. But they soon stopped barking and began to wag their tails in a friendly way—all but one dog who kept on barking in that wolfish tone that Alaskan dogs have. So the man on snowshoes said, "What is the matter with your dog? Doesn't he like me?" "Oh," replied the other, "don't pay any attention to him. He is just barking to keep from working!"

Now, I am the dog who goes about barking. The team that does the work you are now to hear from.

ANNUAL REPORT OF THE SECRETARY

To the Bishop, Madame President and Members of the Woman's Auxiliary of Southern Ohio:

Since its initial meeting on January 12, 1927, your Executive Board has held five meetings, thus showing how mindful its members have been of their duties and the responsibilities placed upon them.

Three Convocation meetings were held: April 26, 27, 28. The first of these was held in the Church of the Good Shepherd, Columbus, at which 150 were in attendance; the second at Christ Church, Xenia, with 128 present; the third at the Church of the Advent, Cincinnati, with 235 present. The same program served for each meeting, Deaconess Bedell, the speaker, telling in a simple way about her work in Stephen's Village, Alaska. The offerings presented at the Columbus and Dayton Convocation meetings were given to Deaconess Bedell to help in her work, while the offering presented at the Cincinnati meeting was divided equally between Deaconess Bedell, for her work, and the Diocesan Supply Department.

The Board regrets that Mrs. Stanley M. Cleveland, Christ Church, Glendale, could not continue her work as United Thank Offering Treasurer because of her family of young children. She therefore found it necessary to resign her office early in February. Miss Morrison was fortunate in securing Mrs. Cleveland K. Benedict, also of Christ Church, Glendale, to fill the vacancy, and Mrs. Benedict immediately took up her duties with characteristic enthusiasm.

Within the last ten months the Diocesan Auxiliary has lost through death three loyal branch Presidents: Mrs. Robert T. Hance, of St. Paul's Cathedral; Mrs. W. A. Chavous, St. Philip's, Columbus; Mrs. Clayton H. Randolph, Church of the Ascension, Middletown. Also a branch Treasurer, Mrs. Robert Smith, St. Stephen's, Winton Place, Cincinnati.

In the Cincinnati Convocation the Officers' Conference continues to function most successfully, interesting speakers being secured for the meetings which are held the first Friday of each month. The Board suggests that similar organizations might prove very helpful in the other two Convocations.

Since the House of Churchwomen has been discontinued, the Woman's Auxiliary sponsors the reports of work done in the In-As-Much Guild. The Vice-President of the Cincinnati Convocation states that in gathering reports of In-As-Much work she has been impressed with the desire frequently expressed to co-operate to the fullest extent in everything undertaken by the Woman's Auxiliary, and the wish to be informed of every means of helpfulness.

One Quiet Day was held in St. Luke's, Cincinnati, during Lent, the Rev. Spence Burton, S. S. J. E., of Boston, the leader.

We are happy to state here that since its reorganization the branch of the Church of the Good Shepherd, Columbus, is doing effective work. There is also a new Guild organization in St. Paul's, Oakwood, Dayton Convocation, where a generous box is being provided for the Supply Department. There is also a new branch established in St. Alban's, Bexley, Columbus Convocation, and here also work for the Supply Department will be undertaken. The work done in St. Margaret's Guild, St. James', Piqua, has been most encouraging, too. The branches at Nelsonville and All Saints', Columbus, have been given up, but we trust this is only a temporary condition in each branch.

The official date set for the spring collections of the United Thank Offering was Sunday, May 1, while Sunday, October 9, was designated by the U. T. O. Treasurer for the fall collections, and to date 67 branches have sent in their offerings. Mrs. Benedict will give a report in detail.

A healthy, increasing interest is shown in the work of the Educational Department. Four from this diocese attended the Conference held at Racine for educational leaders of the Fifth Province. The two principal courses studied were "A Discussion Course on the Bible," based on "Our Bible" of the Christian Nurture Series, and "A Church Awake," by Dr. Sturgis. These two are the courses recommended for the Woman's Auxiliary for the coming year, and it is most earnestly urged that the women will study them, for they will lead to what is most greatly needed, a more intimate knowledge of the Bible and the Book of Common Prayer.

Southern Ohio sent its President to the Conference held May 10-13 at Racine, where Miss Laura Boyer conducted "An Auxiliary Project Course."

The report of the Supply Department will cover the work done during the spring months; the full year's report can only be given when the allotments and personal boxes are completed in December. Shipments have been made to St. Luke's, Hospital, Tokyo, Japan; St. Mary's School for Girls, Springfield, S. D.; Christ School, Arden, N. C.; Stephen's Village, Alaska; the materials valued at \$3,103.46. Personal boxes have been sent to Rev. P. H. Smith and family, Jackson, Wyoming; All Saints', Vieques, Porto Rico; the San Juan Indian Mission, Farmington, N. M., and Rev. S. A. Morgan, Vicksburg, Miss. These personal boxes were valued at \$1,157.04.

The amount pledged to date to the Corporate Gift totals \$2,616.67, of which \$1,068.67 has already been paid. In the Cincinnati Convocation so far five parishes have pledged nothing, fifteen in the Columbus Convocation and three in

the Dayton Convocation. Already \$662.67 has been forwarded to Miss N. H. Winston, Louisville, Ky., the Treasurer, and we have specified that the money be applied to the work in Nenana and Haiti.

A copy of the "Instrument of Trust" with original signatures of the trustees of the diocese appended has been sent to your Secretary by Mr. Morrison R. Waite, Chancellor of the diocese. A report in detail will be made by the Chairman of the Book of Remembrance.

It has been the pleasure of the Executive Board of Southern Ohio to increase from \$25.00 to \$35.00 the annual dues to the National Board.

We regret exceedingly that seemingly no concrete work was done by the Diocesan Auxiliaries in the Bishops' Crusade movement this last spring. However, reports have come to us where branches have co-operated with their parish programs with rather favorable results.

We are glad of this helpful greeting from the Chairman of the Diocesan Altar Guild: "The message from the Diocesan Altar Guild of Southern Ohio this fall is a request to all the members of the Auxiliary to carry this good news back to their parish or mission telling them that the Altar Guild stands ready to be of service to those who need help in the supply of their altar fittings, especially the Eucharistic fittings. Those to whom the Guild has already been of some help, we hope we may do more, but we most particularly wish to hear from those who may have needs about which the Guild knows nothing. If a visit from the Chairman is desired, she will be glad to come in order to talk things over, or if anyone will write to Mrs. Herman Lackman, 3 Madison Lane, Cincinnati, she will respond promptly to any inquiries."

Within a short time now the branch Presidents will receive through the mails our annual questionnaire. Won't you, Madame Presidents, see that these reports are made just as complete as possible, so that a full and comprehensive record may be made of your activities? And please get them back to the Diocesan Secretary very promptly.

There are now 71 active branches of the Auxiliary in Southern Ohio, and during the ten months past your President has made visits in 57 of them. She has definite engagements to visit five other branches and several members of the Board have also made visits in a number of the branches.

In closing this report the Executive Board wishes you to know how grateful it has been for your splendid co-operation, for it has not been a light task to take up new work, embodying new experiences, endeavoring to "carry on" in the same high plane on which the preceding Executive Boards have functioned so successfully.

REPORT OF THE SUPPLY DEPARTMENT

The Supply Department has completed a very satisfactory and busy year, which, while it did not quite equal the previous year in monetary value, represented a real and united effort on the part of 66 parishes.

We have shipped eleven personal boxes, valued at \$3,500.35, to as many missionaries and their families, this amount including the eight Christmas boxes. Also there were seven institutional boxes valued at \$6,184.21.

The response to the appeal I sent out last spring for blankets and surgical dressings for St. Luke's, Tokyo, was splendid, over \$800.00 being sent in for that purpose.

Eight Christmas boxes were sent to missionaries by as many parishes, and credit has in each case been given them, and the same added to our quota. It is the desire of the National Executive Board of the Woman's Auxiliary that each missionary in the field, whether at home or abroad, should receive a Christmas box, and this is now included in our diocesan allotment.

Thank you each one for your loyal and splendid co-operation, and I hope that this year we may do even better.

REPORT OF THE EDUCATIONAL DEPARTMENT

In the Educational Department the past year has been devoted to the study of rural work. The text book used was "Beyond City Limits," by Rev. F. D. Goodwin.

Classes for leaders were held during February in Cincinnati, Columbus and Dayton with a combined attendance of 140 women. At the close of each class Rev. Mr. Foreman, the Secretary for Rural Work under the Department of Christian Social Service, spoke on rural work and aroused a great deal of interest in the subject.

As a result of these meetings, and the study classes that were held during Lent in 42 parishes, a very general interest was awakened. A fund for establishing a library on rural work was given; subscriptions to "Rural America" were sent to rural clergy.

Through the Church Periodical Club many books were circulated; \$50.00 was sent from one parish to a struggling rural church, and \$251.89 raised in the diocese to help pay for a seminary student specializing in rural work.

The Department of Christian Social Service asked for seven of these scholarships of \$500.00 each to place a seminary student during the summer months under the direction of a recognized leader in rural work. All of these scholarships were provided either by, or through, the Woman's Auxiliary inspired by the study of "Beyond City Limits."

An even more important result of this study was the definite encouraging and strengthening of many struggling missions and isolated congregations. Prestige has been added to rural work, and conditions and methods are being studied with a view to increasing and strengthening this very important part of the Church's work among our rural population.

THE CORPORATE GIFT

Although the National Chairman for the Corporate Gift, Mrs. Robert Burkham, of St. Louis, was present at our last Annual Meeting and explained in detail the project known as the Corporate Gift, it seems well to repeat some of that information for the benefit of those who were not in attendance at that time. The Corporate Gift is a very definite and concrete project, somewhat different from anything which the Auxiliary has done in the past, having had its inspiration from a particular period and circumstance in the life of the Church.

As you will remember, the Church, at the time General Convention met in New Orleans two years ago, was burdened with a debt of more than a million dollars, the lifting of which was assured by promises from the various dioceses. At the same time the National Council was instructed to operate in the future within the income promised by the dioceses even if this required drastic cuts in the budget. Since this income had not been sufficient previously to meet the operating expenses of the General Church Program, and since the dioceses were taking on themselves the additional task of lifting the debt, it appeared almost certain that the National Council would be unable to undertake any advance work projects during this triennium. In this juncture the Woman's Auxiliary pledged itself to raise one hundred thousand dollars during these three years, to be applied to buildings in the Advance Work Program, this fund to be known as the Corporate Gift.

The Corporate Gift is to provide funds for the erection of six buildings in the mission field—one hospital, two schools and three churches—thus typifying, as they do, the Church's three-fold ministry to man's body, mind and spirit. Money to this fund has come in so rapidly that already the \$25,000 promised to St. Agnes' School, Kyoto, has been paid and the building is practically completed. This is also true of St. Mark's School, Nenana, Alaska, to which \$15,000 has been given. Fourteen thousand dollars, which, with other gifts, makes possible the cathedral which Bishop Carson has been needing so desperately for his work at Haiti, has been forwarded to the Bishop and a recent number of the "Spirit of Missions" carries a picture of the building ready for the roof. As more money comes in, it will be forwarded to the other three projects—\$20,000 for St. Timothy's Hospital, Liberia; \$18,000 for the Church of the Resurrection, Baguio, Philippine Islands; and \$8,000 for the Church of the Nazarene, Livramento, Brazil, so that by the next Triennial we may have the joy of knowing that all the buildings are well under way.

And now just a word about our own share in this splendid work. You will remember that we pledged \$3,000 to this

purpose, and to date we have pledges for more than \$2,900 of this amount.

I am certain that we shall meet the full amount of our pledge to the National Committee, but I am concerned also that the money we send in shall be indicative of the interest and loyalty of every parish branch of the Auxiliary in this diocese. In order to make this truly our **Corporate Gift** to the Church let us all have a part in it.



MINUTES OF THE ANNUAL MEETING

The Fifty-first Annual Meeting of the Woman's Auxiliary of Southern Ohio was held in St. Paul's Church, Columbus, Ohio, October 26 and 27, 1927.

Bishop Rogers, of Ohio, the celebrant and preacher for the service of Holy Communion at 11 o'clock on Wednesday, the 26th, was assisted by Bishop Reese, Rev. Mr. Sweet, of St. Paul's, and Rev. Mr. Boss, of St. James', Columbus. Bishop Rogers took for his sermon lesson the 17th chapter of the Gospel of St. John. The topic was "Our Approach to Church Unity." There were present 239 who made their Communion.

Luncheon was served in the parish house adjoining the church, and then at 2 o'clock the business session, opened by the President, was also held in the parish house. Mrs. F. O. Granniss, President of St. Paul's Branch, welcomed the delegates and visitors, and Miss Morrison expressed the pleasure of the Diocesan Auxiliary at the opportunity afforded to meet in the new parish house of St. Paul's Church.

Bishop Reese welcomed the delegates in the names of the Bishops of Southern Ohio. He thanked them for their splendid co-operation in all that pertained to the work of the Church, and stressed the inspiration and benefit the smaller branches might receive by the contacts afforded at an annual meeting. He asked that all come to the service of Holy Communion on Thursday morning with prayerful hearts that we be given the will and desire to do more for the promotion of God's kingdom.

The Secretary read a letter from Bishop Vincent in which he expressed his interest in the work of the Woman's Auxiliary, and the regret that he could not be present at any of the meetings.

The President appointed a Credentials Committee as follows: Mrs. Ralph W. Hollenbeck (Christ Church, Springfield), Miss Sara Buckingham (Trinity Church, Newark), Mrs. Clifford Woodward (Calvary Church, Cincinnati). And a Resolutions Committee of: Mrs. Emily Ide (Trinity Church, Columbus), Miss Bertha Buvinger (Christ Church, Dayton), Mrs. Grace Graham (Church of the Advent, Cincinnati).

The Secretary's report showing the work of the Executive Board for the first ten months of this year was approved as read.

The Credentials Committee reported there were present 29 delegates and 17 visitors from the Cincinnati Convocation, representing 13 parishes and 1 mission; from the Columbus Convocation, 52 delegates and 96 visitors, representing 16 parishes and 4 missions; from the Dayton Convocation, 22 delegates and 22 visitors, representing 9 parishes and 2 mis-

sions, a total of 103 delegates and 135 visitors, representing 38 parishes and 7 missions.

The Treasurer's report showing a total balance of \$1,144.65 to October 17, 1927, was read. The balances in the different accounts were as follows:

Mrs. Monroe related the figures in her report to the health, the life of our organization. To date all but three branches in the diocese have paid pledges to the Central Expense Fund. Upon motion of Mrs. Granniss, seconded by Mrs. Lewis (St. Philip's, Circleville) and carried, the report as read was received and filed.

The President's address followed. Miss Morrison brought to our minds vividly the great good which might come from corporate power (the co-operation of the big and the little) if rightly used. She asked that our year books be intelligently used to show where we as individual branches stand in our common work.

Mrs. Benedict read the report of the United Thank Offering. The spring and fall collections amount to \$10,208.83 from 67 parishes and missions. This total is lower than that for the year 1926, but Mrs. Benedict hopes we may find the cause and correct it by putting the balance on the right side of the line in the future, and give—not only of our money, but our interest and our time.

Mrs. Mitchell in presenting her report of the work of the Supply Department asked that all completed supplies be sent in the early part of December. Two interesting letters have been received acknowledging supplies, one from Christ School, Arden, S. C., the other from St. Mary's School, Springfield, S. D.

Miss Johnston spoke of her plans for the Educational Department for the coming year, calling attention to the literature for sale to promote these plans. A helpful pamphlet outlining monthly programs was at hand for distribution to those interested.

The Book of Remembrance has been on view these two days in charge of Miss Colston, the Custodian, who presented her report to be printed elsewhere.

The Secretary read the amendment to Article 5, Section 3, of the Constitution, notice of the same having been given at the annual meeting in November, 1926, as follows: "She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. ADD: She shall also appoint a Custodian of the Book of

Remembrance, to serve for her term of office." And this entire new section to be added to be known as Section 10: "Section 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request." The Secretary moved the adoption of these amendments, seconded by Miss Elizabeth Matthews and carried.

Miss Johnston then spoke to the recommendation as moved and carried by the Executive Board at its meeting October 17, 1927, that "The Annual Meeting be held each year in May," thus necessitating an amendment to Article 5, Section 3, of the Constitution reading: "The President shall be elected at an annual meeting held at least one year after the General Triennial meeting, to serve for three years, but shall not be eligible for two consecutive full terms," to read, "THE PRESIDENT SHALL BE ELECTED AT THE ANNUAL MEETING NEXT AFTER THE GENERAL TRIENNIAL MEETING, to serve for three years, but shall not be eligible for two consecutive full terms." This recommendation to be voted upon at our next annual meeting, in May, 1928.

Mrs. Leding, President of the Woman's Auxiliary of Calvary Church (Clifton), Cincinnati, extended an invitation in the name of their rector, Rev. Mr. Slayton, and the membership of their branch, to meet with them on the occasion of our next annual meeting in May, 1928, the tentative dates being the 16th and 17th.

Miss Colston announced Thursday, November 17th, as Donation Day for the New Children's Hospital, Cincinnati, expressing the hope that many would take advantage of the opportunity presented to visit this haven for sick and suffering children.

Herewith the meeting adjourned to reconvene at 10 o'clock on Thursday morning in St. Paul's Parish House.

At 8 o'clock in the evening an inspirational meeting, addressed by Rev. G. Warfield Hobbs, editor of "The Spirit of Missions," New York, was well attended. Bishop Reese and Rev. Mr. Sweet were in the chancel of St. Paul's Church where the meeting was held.

For the Communion service at 7:30 on Thursday morning Bishop Reese was the celebrant, assisted by Venerable B. H. Reinheimer, Rev. Mr. Sweet and Rev. Mr. Clarke; 81 were present.

Officers' Conferences were held at 9:15, and at 10 o'clock the President opened the business session with prayers.

Mrs. McGregor, Chairman of the Corporate Gift, presented the object of this fund; a full explanation will appear in the year book.

Mrs. D. C. Larcomb, Diocesan Director of the Church Periodical Club, told of the many phases of this interesting and valuable work.

Sister Ruth, of the Community of the Transfiguration, gave a vivid picture of present developments along the Yangtse Valley, having been a devoted worker in St. Lioba's School, Wuhu, China.

The Venerable B. H. Reinheimer presented the Diocesan Program for 1928, "Our Membership in Three Parishes."

Mrs. J. D. Herron (Holy Trinity, Madisonville), Cincinnati, representing the Fifth Province of the House of Churchwomen, read the following resolution passed during the meeting of the Synod held at Taylor Hall, Racine, October 19 and 20, 1927: "The House of Churchwomen shall be the recognized body in this Province to function in all official contacts with the Woman's Auxiliary to the National Council and the Diocesan Branches within the Province."

Noonday prayers were read by the Rev. Mr. Donaldson, St. Paul's, Chillicothe.

The combined offerings of the two Communion services amounted to \$121.04. According to custom, the President asked for a motion disposing of this offering. Mrs. Dorothy Hubbard, Trinity Church, Columbus, moved that the entire amount be given to the building fund of Bethany Home, Glendale, Ohio. This motion was seconded by Mrs. Lewis, St. Philip's, Circleville, and carried.

The following resolutions were presented by Mrs. Emily Ide, Trinity Church, Columbus, who moved their adoption, seconded and carried:

RESOLVED, That we express our gratitude and deep appreciation to the Bishops and Clergy who officiated at our services, and to the organist and choir whose music helped to make those services such an inspiration to us all:

That we extend our heartfelt thanks to the speakers who gave us so much information and aroused our devoted enthusiasm;

To the women of St. Paul's parish, especially the Woman's Auxiliary, for their gracious hospitality and untiring zeal in making every arrangement for our comfort and entertainment.

BE IT RESOLVED, That the Woman's Auxiliary of Southern Ohio sends a message of greeting and congratulations to the Girls' Friendly Society in America celebrating its fiftieth anniversary in Boston the first week in November;

Also that the Woman's Auxiliary of Southern Ohio sends greetings and congratulations to the Woman's Auxiliary of Massachusetts, which is holding its fiftieth anniversary meeting in Boston the first week in November.

RESOLVED, That the Woman's Auxiliary of Southern Ohio expresses to Mrs. Whiting its deep regret at her absence from its annual meeting, and sends its love and best wishes, hoping that she will soon be quite well again.

REPORT OF THE BOOK OF REMEMBRANCE

Your Custodian of the Book of Remembrance begs leave to submit the following report:

At the conclusion of the annual meeting last year a safety deposit box was rented in the Central Trust Company, Cincinnati, and there the Book is kept. It has been taken out on the following occasions: The three Convocation meetings in the spring of 1927—On April 26 at Columbus in the Church of the Good Shepherd; on April 27 at Xenia in Christ Church; and April 28 in the Church of the Advent, Cincinnati.

It was also taken out to be photographed for the "Church Messenger," and early in June it was sent on to Boston to the Rose Bindery for the correction of five errors which had been detected. These corrections were made in such a manner as to render them invisible, and the Book was returned safely.

At the annual meeting in St. Paul's Church, Columbus, on October 26 and 27 the Book and Archives were again displayed, and many persons who had not been able to see the Book before were able to see and handle it.

As there was still a small balance on hand in the account of the Book of Remembrance, after all the expense of correcting the names had been paid, it was deemed best by the Custodian to turn the balance over to the Treasurer, it being the direction of the Auxiliary (Art. 5, Sec. 10), which she accordingly did.

This coming spring being the time for inscribing of new names to the Book, the Custodian has sent out letters to the President of each parish and mission in the diocese reminding them that now is the time to form their committees and to send in any new names. As soon as they notify the Custodian the necessary blanks will be sent to each parish to be filled in, and all these blanks must be returned to her by March 15.

It is a great and valued privilege—this of being Custodian of the Book of Remembrance—although also a heavy responsibility—and it is a real happiness as well as an inspiration to see the deep and growing interest and pride which the Book calls forth wherever it is displayed. As the years go by, this Book of Remembrance will prove an ever stronger influence among the women of this diocese, deepening, enriching the spiritual life in Church and making them ever more and more conscious of the reality of the Communion of Saints.

INSTRUMENT OF TRUST

THIS INSTRUMENT OF TRUST, executed this twenty-eighth day of December, in the year of Our Lord, 1926, by the Woman's Auxiliary of the Diocese of Southern Ohio, to the Trustees of the Diocese of Southern Ohio, a corporation, under the laws of Ohio, WITNESSETH:

That the said Women's Auxiliary hereby assigns and sets over to the said Trustees, as a trust Fund, the sum of twelve thousand (\$12,000.00) dollars, more, or less, with accretions thereto, and accumulations thereof, as hereinafter provided, for and upon the following specified purposes and trusts:

(1) The initial and present amount of said Fund, being a gift to the Church in Southern Ohio, upon the occasion of the FIFTIETH ANNIVERSARY of the said Woman's Auxiliary, the said Fund, accretions and accumulations shall be known as the "Memorial Scholarship Fund."

(2) The said Fund, with accretions and accumulations, as hereinafter provided, shall be invested and reinvested, from time to time, as occasion may require, and the income only, except as hereinafter provided, shall be used for the purpose of aiding the training of such Church Women of the Diocese of Southern Ohio, for service in, or for the Church, either in the Home or Foreign fields, as shall be nominated to the Bishop, or in his absence, to the Ecclesiastical Authority of said Diocese, by the Executive Board of the Woman's Auxiliary, of the Diocese, and approved by the Bishop or Ecclesiastical Authority.

(3) For, and during, such time as there may be no woman of said Diocese, who is an approved beneficiary for training, or, for such time as there may be a substantial balance of income unused, and upon a Certificate by the President, and Secretary of said Woman's Auxiliary, to said effect, or effects, the whole, or part, of said income, as the case may be, shall be allowed to accumulate and be added to the Principal of the Fund. A candidate may apply for aid in procuring such training for any type or form of Church Work, provided only that she agree to serve as a paid Church-Worker for three years after the completion of her training, and, if prevented from giving the whole, or part of said three years of service, to refund, pro rata, the amount expended, on her training, except in very exceptional cases, such as failure in health, or other equally exceptional cases, all of which must be passed upon favorably by the Executive Board of the said Woman's Auxiliary. This paragraph shall not be construed to place the Trustees of the Diocese under any obligation to enforce any such agreement.

(4) The income of said Fund, shall be paid, from time to time, by said Trustees of the Diocese, directly to such beneficiaries as have been approved as aforesaid, upon the written order of the President and Secretary of the said Woman's Auxiliary, specifying in each and every of said written orders, the amount to be paid, and the name of the payee.

(5) It shall be within the power and discretion of said Executive Board to apply a portion of the Income thereof, to the education of approved beneficiaries, for, and during their last two (2) years in College, as well as for, and during their more immediate training for Church Work, provided, however, the aid given to any one beneficiary, shall not be for more than three (3) years altogether.

(6) Said Fund shall never be closed, but may be added to from year to year by said Woman's Auxiliary, or any of its Branches, or by individuals, by gift, or bequest, or, by such repayments and accumulations, as may be made, or may accrue, pursuant to the provisions of paragraph three (3), provided only that such additions, gifts, bequests, repayments, or accumulations, shall be upon the same trusts, as herein otherwise provided.

(7) Upon the occasion of the Annual Meeting at the One Hundredth Anniversary of the Woman's Auxiliary of the Diocese of Scuthern Ohio, it shall be within the power and discretion of said Woman's Auxiliary, by a vote of two-thirds (2-3) majority of the delegates present thereat, to alter the details of the Trust hereby established, provided the fundamental purpose, which is declared to be the aiding in the training of Church Women generally for Church Work, be preserved.

IN WITNESS WHEREOF, the said Woman's Auxiliary in the Diocese of Southern Ohio, by Lucile S. McGregor, its President, and by Ellice P. Hollenbeck, its Secretary, and the Trustees of the Diocese of Southern Ohio, a corporation, as aforesaid, in evidence of its acceptance of this Trust, by Edward W. Strong, its Vice-President, and James H. Cleveland, its Secretary, have hereunto set their hands and seals, upon the day and year last above written.

CONSTITUTION AND BY-LAWS

CONSTITUTION

ARTICLE I

Name.—The name of this Association shall be “The Southern Ohio Branch of the Woman’s Auxiliary to the National Council.”

ARTICLE II

Object.—The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

ARTICLE III

Membership.—Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

ARTICLE IV

Officers.—The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

ARTICLE V

Duties.—Section 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Section 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

Section 3. The President shall be elected at an Annual Meeting held at least one year after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop’s approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop’s absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting.

In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

Section 4. Each Vice-President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-Presidents or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

Section 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

Section 6. The Box Secretary shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

Section 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Section 8. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

Section 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

Section 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request.

ARTICLE VI

Meetings.—Section 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an

executive officer; and every Mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

Section 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Section 3. Convocation meetings shall be held on the call of the Convocation Officers.

Section 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

ARTICLE VII

Mode of Election.—Section 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Section 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

ARTICLE VIII

Amendments.—This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expenses of officers and speakers, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

FINANCIAL POLICY

I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
 - (a) By urging an every-member canvass and assisting in carrying it out.
 - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
 - (c) By giving when necessary as an organization.

III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
 - (a) There shall be fourteen classes paying as follows:

 - (b) Each branch shall decide to which class it will belong.
 - (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
 - (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
 - (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
 - (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
