



It extends from the parish and community to the diocese and the world at large.

Some form of work should be found for every woman in your parish.

The diocesan officers of the Auxiliary stand ready now, as always, to assist branches in the planning and carrying on of the work.

Miss Lindley's beautiful Noonday Meditations, given in Washington, have been printed and may be obtained from our Educational Secretary, Miss Johnston. You will find them helpful.

May God add His blessing to all our work and worship done in His name. May He send us light to guide us, courage to support us and love to unite us now and always.

**SUGGESTIONS BASED ON THE FINDINGS OF THE TRIENNIAL  
MEETING OF THE WOMAN'S AUXILIARY IN  
WASHINGTON, D. C., OCTOBER, 1928**

---

**1. Personal Religion and Evangelism.**

- a. That we deepen our own personal religious lives until we are steeped in the Spirit of our Lord and Master, and the Practice of the Presence of God becomes a necessity.
- b. That we help others in their quest for a more complete life, through the process of friendship, using as aids to our undertaking: the ministry of books, of prayer, of the spoken word, of the Holy Communion, and of example.
- c. That we pray that all hesitation in witnessing for Christ be taken from our hearts, and that we fervently desire to share Him with others.

**2. (a) Domestic Missions.**

- a. Since every year hundreds of Churchwomen visit as tourists our Domestic Missionary field, both in this country and in our extra-continental possessions, that such persons should receive instructions and letters of introduction to the Bishops and workers in the field, and that they should be used as speakers on their return to the Diocese.
- b. That we inform ourselves concerning the work which is being done in all parts of the Domestic field, including the Indians, the Negroes and the Mountaineers, and recognize our responsibility to pass on to others intelligent information as to plans and policies.
- c. That in co-operation with all women's organizations of the Church we make the development of village and rural work a definite objective for the Triennium.
- d. That we recognize that to bring Jesus Christ into the lives of the many races of Hawaii and the Philippine Islands through our Mission Schools and Hospitals is the surest way of wiping out the ever-present race problem.

**2. (b) Foreign Missions.**

- a. That we keep ourselves informed concerning the Missionaries who have gone out from this Diocese to the Foreign Field, and of their return on furlough. That we inform them of all publications and items of interest concerning the Church at home, thus proving to them that they are an integral part of the life of the Diocese. That a closer relationship with them be established through the observance of the Noon-day Prayer for Missions, and that intercessions each for the other be offered at this time.
- b. That we ascertain whether there are any children of Missionaries in the schools or colleges of this Diocese and take definite steps to bring them in touch with the young people here at home especially during week-ends and holidays.
- c. That we also ascertain whether there are any foreign students in this Diocese and formulate plans to bring them into contact with our Christian home life, doing for them what we would like others to do for our own boys and girls.
- d. That since it has been found that a great encouragement to the missionary in the field would be the knowledge that every woman in the Church is backing the Maintenance Budget of the Church, we use our influence to see that all Parish Quotas are paid in full.

### 3. Social Service.

That we charge ourselves with the responsibility for inspiring the women of the Church:

- a. To acquire an intelligent understanding of the problems of the Community.
- b. To help educate public opinion as to these problems.
- c. To take our part in co-operating with Diocesan and civic social service agencies and with other Communions, when possible, in such opportunities for service as may be presented.
- d. To recognize that such co-operation with other Communions is one way of promoting Christian Unity.
- e. To realize that responsibility in the field of human relations is laid upon us by our Lord Himself, and that service to Him must include service to our fellow-men.

### 4. Gifts.

- a. That we take our part in raising between now and Epiphany, 1930, a Corporate Gift, the sum not to exceed \$100,000.00, the first \$25,000.00 of which shall be for the building of a Church in Santo Domingo City (this sum to be in hand by Easter, 1929), and that after Epiphany, 1930, we co-operate in whatever plans for Advance Work may be made by the National Council.
- b. That we co-operate at once with the Diocesan plans for sharing in the gift of \$1,000,000.00 for St. Luke's Hospital, Tokyo.

### 5. Religious Education.

- a. That we inform ourselves about the Church Boarding Schools in our Diocese and endeavor to kindle interest in them and be prepared to furnish information about them.
- b. That we co-operate in every way with the National and Diocesan Departments of Religious Education, and assist in their purpose of having Missionary education represented on the program of every Church School, Conference or Institute.
- c. That we promote subscriptions to "Findings in Religious Education" through the same channels as are used for the Spirit of Missions.\*
- d. That we help to make the Birthday Thank Offering Church-wide.
- e. That we offer assistance and encouragement to the Church's work in the various colleges and universities.
- f. That we urge the constant use of Daily Bible Readings, the Missionary Calendar and the reading and lending of inspirational books.\*

### 6. Publicity and Promotion.

- a. That we make more intelligent use of the great means of available material relating to subjects upon which the Woman's Auxiliary should be informed.\*
- b. That we familiarize ourselves with the methods of preparation for the Every-Member Canvass and give it our loyal co-operation during the intensive period of the work.
- c. That we make greater use of The Church at Work.\*
- d. That we secure and renew subscriptions to the Spirit of Missions, placing a subscription in every Public Library, and finding suitable women to act as parish representatives for the work.\*
- e. That we promote the wider use of Mission Study books and supplementary material for the same.\*

- f. That we increase the number of subscriptions to the national Church papers.
- g. That we give wide publicity to appeals for volunteers for the Mission field and circulate information about places where training for Missionaries and other Church workers may be had.
- h. That we make more use of Lantern slides and motion pictures of the Mission field.\*
- i. That we use simple dramatic plays and sketches to teach about various phases of our work.
- j. That we promote the sale of Mission goods at Parish and Diocesan meetings.

**7. Training.**

- a. That in order to meet the increasing demand and need for consecrated and trained workers for every department of the Church's work, especially for the Mission field, Rural work and in colleges, we seek to find and encourage possible candidates for such work, referring them to the Diocesan President of the Woman's Auxiliary.
- b. That we keep in touch with the training centers under the National Council in order to disseminate information and create interest in the securing and training of women workers for service in the Church.

**8. Enlisting Others.**

- a. That we discover and report all isolated Church women in order that they may be brought in touch with the fellowship and activities of Church life.
- b. That evening branches be formed providing programs for business women.
- c. That branches be formed for younger women offering a variety of forms of service for the Church.
- d. That the Woman's Auxiliary stands ready to assist the Young People's Fellowships in whatever way it may be asked to do so.
- e. That the Woman's Auxiliary co-operates very definitely with the Girls' Friendly Society, especially in its missionary activities.
- f. That we endeavor to keep in touch with young women in college inviting them after graduation to lead classes in Mission Study, Social Service, Parliamentary Law, etc., in connection with the Church.
- g. That we develop practical spiritual contact with the young mothers through the Little Helpers Department.

## ANNUAL REPORT OF THE SECRETARY

The year just closed has been a busy and an interesting one for the Woman's Auxiliary. The fifty-second annual meeting was held on May 16th and 17th in Calvary Church, Clifton, Cincinnati, the minutes of which are printed elsewhere in this yearbook.

For three years we had looked forward to the Triennial Meeting to be held in conjunction with General Convention in Washington, D. C., in October, 1928. We sent five delegates to the Triennial: Miss Elizabeth Matthews, Miss Catherine Morrison, Mrs. Allan McGregor, Mrs. Cleveland K. Benedict, Miss Mary E. Johnston and Mrs. Samuel L. Moyer as alternate. We feel that the Woman's Auxiliary of Southern Ohio held a distinctive place in the Meeting, for Miss Matthews was its Presiding Officer and Miss Johnston, our Educational Secretary, led one of the study classes on "The New Africa." Miss Morrison, our President, was made chairman of one of the important "Findings" committees, that of Personal Religion and Evangelism, while Mrs. McGregor served as a member of the Gifts Committee.

After the delegates' return from Washington the Convocation Meetings were held, four of them, in Grace Church, College Hill, on November 5th, for the Cincinnati Convocation; in St. Paul's Church, Greenville, on the 7th, for the Dayton Convocation; in St. John's Church, Cambridge, on the 8th; in St. Paul's Church, Chillicothe, on the 9th, for the Columbus Convocation. At this series of meetings your delegates and other visitors to the Triennial Meetings endeavored to impart some of the inspiration they had gained by passing it on through the means of reports of the several departments and relating other interesting experiences. Fully five hundred women in the three Convocations were reached, and the offering presented at each meeting was given to the new Corporate Gift Fund, of which Mrs. Allan McGregor, of Springfield, will again be the chairman for our diocese.

The year's work of our several departments will be reported separately, but it is fitting here to call attention to Mrs. Benedict's report of the United Thank Offering, for she was permitted through the co-operation of all our branches to place upon the golden alms basin in the unfinished Washington Cathedral on October 11th the sum of \$37,769.47 as a memorial to Miss Emily Tillotson, whose work as Educational Secretary was started in our own diocese. It is interesting to know that as a diocese we stand fifth in the United Thank Offering. Mrs. Benedict is most grateful for the work done by the U. T. O. branch treasurers, but feels that there are still many more women in our diocese who might be reached and who would like to have a share in this particular work. And just a word about our Corporate Gift. It was most gratifying to Mrs. McGregor to be able to report that \$3,451.77 had been given, our quota being \$3,000.00. In our supply work, too, we are rated fifth among the dioceses. Miss Johnston has worked very hard for the success of the Lenten study classes, twenty-one of which she personally conducted.

The treasurer of the trustees of the diocese reports the balance in the income account of the Memorial Scholarship Fund to be \$1,099.46 on December 31, 1928. Finding the right person to take advantage of the terms of our Scholarship has been a matter of great concern to your Executive Board members, but as though in answer to our earnest prayers we now have two promising candidates, one who desires to go into training to take up the college student work and the other to further fit herself for religious education work.

When plans for completing the chapel in Windham House, New York, were being considered it was suggested by the committee that Southern Ohio might wish to supply the altar as a memorial to Miss Tillotson. The appeal for funds sent out by our President was so generously met that in addition to the altar we were able to supply the cross, the paten, burse, stole and veil. It is our hope that students benefiting by our Memorial Scholarship may find it possible, while in training, to make Windham House their home.

A conference for diocesan officers and delegates to the Triennial Meeting was held May 7th to 10th in Taylor Hall, Racine, Wisconsin, to which our President was sent, representing Southern Ohio.

This year the officers' conferences are held under the leadership of Miss Elizabeth Matthews and Mrs. Carl S. Rankin (Grace Church, College Hill) as chairman and vice-chairman. Helpful and interesting addresses have been made by prominent speakers and workers, and matters of importance have in this way been brought to the representatives of the various branches of the Auxiliary, the first Friday of each month. This year the policy is a combination of that of recent years and that of several years ago—after the speaker the meeting is thrown open for discussion.

We have new work opening up at St. Alban's, Bexley, Columbus, and at St. Paul's Church, Oakwood, Dayton. An evening branch has been organized at Christ Church, Springfield, all of which is most gratifying and encouraging to us. In Columbus we have lost two branches, but gained one, the Mission of the Holy Spirit and the Church of the Good Shepherd uniting and now known as St. Stephen's Church. The branch known as The Frances Badger Guild has merged with the older auxiliary branch of All Saints' Church, Portsmouth, so that at present we have seventy branches of the Auxiliary in this diocese.

We cannot close this brief report without thanking you—each and every branch—for the cooperation so cheerfully given your Executive Board at all times.

## REPORT OF THE SUPPLY DEPARTMENT

The Supply Department during the year 1928 has sent its work literally to the four corners of the earth, to St. Cyprian's in North Carolina and to Deaconess Bedell in Alaska and to the Indians in Utah; to the House of Bethany in Cape Mount, Liberia, and to the Church General Hospital in Wuchang, China. Thus you have carried to those far-reaching spots the visible proof of your interest in the Church and her Missions.

Perhaps it would be well to remind you that the Supply Department is only a part of the financial policy of the National Church, and is a concrete and practical method of supplementing the appropriations which, allowed by the Church, are inadequate to meet the needs of the Missionaries and Institutions under them.

## REPORT OF THE EDUCATIONAL DEPARTMENT

Statistical reports mean very little in educational reports. This year they are encouraging, but what was even more encouraging was the interest shown in the study class book for the year, Dr. Sturgis' book, "The Church Awake." Your Educational Secretary feels that almost without exception more interest was taken in this book on more personal religion than has ever been taken in a strictly missionary field. Women showed a real desire to know more of their Church and her teachings.

Four Institutes were held—St. Paul's, Columbus; Christ Church, Cincinnati; St. Paul's, Chillicothe, and Epiphany, Urbana, with a combined attendance of 220 women from 41 different branches.

Ten outlying parishes were visited in company with the president, Miss Morrison, and Intensive Days were held in each. In every place we were most cordially welcomed, and a most gratifying spirit of help and interest was shown. We came away from each place feeling a very strong tie of friendship binding the diocese together.

Three hundred and thirteen copies of "The Church Awake" were sold, in comparison with 226 copies of "Beyond City Limits" in 1927, and 91 copies of "That Freedom" in 1926.

The text book for the fall of 1928 and spring of 1929 is "The New Africa," by Donald Fraser. Already a great many copies have been sold, and every evidence is that the women are going to undertake the study of Africa with a great deal of enthusiasm. The Educational Secretary led a class on this subject at the summer conference at Gambier, and one in Washington, during the Triennial Meeting of the Woman's Auxiliary. Preparations have been made for three Institutes, to be held early in January. Great need is felt for longer classes. The Intensive Day has been satisfactory in arousing the interest of new people, but the impression made at an Intensive Day is too fleeting, and we badly need the more sustained interest of the weekly classes. Let us hope that the coming year will see a much greater number of these longer classes.

## REPORT OF THE BOOK OF REMEMBRANCE

Your Custodian of the Book of Remembrance begs leave to submit the following report:

This past spring of 1928 being the time for the opening of the Book for inscribing new names (see By-Laws, Art. 4) your Custodian sent out letters to all the parishes reminding them of their privilege to send in names for inscription in the Book at this time. Of the 70 parishes 41 answered and sent in 112 names.

In April, therefore, the Book was sent to the Rose Bindery, in Boston, where it has been made, and the same man who inscribed the original names did these too. The gifts of money which accompanied these names were turned over to the treasurer, Mrs. James Monroe, and are duly entered in her report.

At the Annual Meeting held last May in Calvary Church, Clifton, these names were read aloud from the Book of Remembrance by Rev. Albert N. Slayton, Rector of Calvary Church, at an early celebration of the Holy Communion on Ascension Day.

According to the ruling as adopted by the Auxiliary in November, 1926 (see By-Laws, Art. 6) the Book of Remembrance is to be shown only at Annual Meetings; therefore it was not taken to the Convocation Meetings in the autumn of 1928. It will be seen at the next Annual Meeting, to be held in October or November, 1929, but the next time it will be open for the inscribing of new names will be in the *spring* of 1931. It is kept in the meantime in the safety deposit box belonging to the Custodian of the Book of Remembrance at the Central Trust Company, Cincinnati, Ohio.



## MINUTES OF THE ANNUAL MEETING

The fifty-second annual meeting of the Woman's Auxiliary of Southern Ohio was held in Calvary Church, Clifton, Cincinnati, on May 16 and 17, 1928. At the service of Holy Communion on Wednesday at 11 o'clock Bishop Reese was the celebrant, Rev. C. K. Benedict reading the Epistle and Bishop Vincent the Gospel, the Rev. A. N. Slayton, rector of Calvary Church, assisting. Dr. Frank H. Nelson, Christ Church, Cincinnati, preached the sermon, taking for his topic the fourteenth verse in the fourth chapter of the Epistle to the Hebrews: "Seeing then that we have a great high priest, that is passed into the kingdom, Jesus the Son of God, let us hold fast our profession." There were present 340 who made their Communion. At this service the spring presentation of the United Thank Offering was made, amounting to \$5,961.40.

Luncheon was served to 385 guests in Calvary's new parish house, and at 2:00 o'clock the business session opened in Calvary Church with prayer by the president, Miss Morrison. Bishop Reese, in his greeting, expressed his pleasure at being able to come back to us with renewed strength. He recommended that the Auxiliary assembled send a greeting to Bishop Vincent, to be received by him on May 18th, his eighty-third birthday.

Rev. Mr. Slayton, rector of Calvary Church, and Mrs. H. W. Leading, president of the Auxiliary, extended a very cordial welcome, expressing their happiness at being able to entertain this their first annual meeting in a quarter of a century. Miss Morrison responded to these greetings.

After the roll call by the secretary, the president appointed the following committees:

On Credentials: Mrs. Edward Henshaw, Grace Church, College Hill; Mrs. B. H. Reinheimer, Trinity Church, Columbus; Mrs. Chas. Owen, Heavenly Rest, Springfield.

On Resolutions: Mrs. W. M. Hastings, All Saints', Portsmouth; Miss Laura MacCracken, Epiphany, Urbana; Mrs. Anne L. Dobson, Holy Trinity, Madisonville. All resolutions to be sent in, in writing, by 10 o'clock on Thursday.

On Nominations: Mrs. Henry L. Scarlett, St. Paul's, Columbus; Mrs. W. W. Andrew, Redeemer, Hyde Park; Miss Lucy Matthews, St. Andrews, Dayton.

The secretary's report showing the work of the Executive Board for the past seven months was accepted as read.

The treasurer read her report, showing balances from January 1, 1928, to May 14, 1928, as follows:

Of the 71 branches, 70 paid their central expense pledges. There have been 16 increases to the central expense and one small decrease. Upon motion of Miss Johnston (Christ Church, Glendale), seconded by Mrs. Leding (Calvary, Clifton) and carried, the treasurer's report was ordered received and filed.

The president read her address, at the conclusion of which she read Miss Grace Lindley's letter announcing the death on May 12, 1928, of Miss Emily C. Tillotson, educational secretary.

Mrs. Wm. Scarlett (St. Paul's, Columbus) then took the floor to tell how Miss Tillotson was discovered in this diocese. Mrs. Scarlett moved that in memory of Miss Tillotson, and in gratitude for what her life has meant to this diocese, we make a special effort to increase our U. T. O. in the autumn. This motion received two seconds, Mrs. Lewis (St. Philip's, Circleville) and Miss Elizabeth Matthews (Christ Church, Glendale). Motion carried. Miss Matthews suggested that the whole amount of the triennium offering be laid on the altar in the Washington Cathedral this fall in thanksgiving for Miss Tillotson's life. The president appointed Mrs. Benedict, treasurer for the U. T. O.; Miss Elizabeth Matthews and Mrs. Wm. Scarlett a committee to see what can be done in this regard. She also appointed Mrs. McGregor (Christ Church, Springfield), Miss Matthews and Mrs. Angus C. Campbell (St. James' Church, Piqua) to bring in on Thursday a memorial on the life and death of Miss Tillotson.

Mrs. Mitchell, the supply secretary, reported that all the boxes had been sent out, and all the money promised had been paid in—all this work the result of love, sacrifice and prayer.

The credentials committee brought in their report, showing a total of 114 registered delegates and 252 visitors from 52 branches, 65 delegates and 204 visitors from the Cincinnati Convocation, 24 delegates and 19 visitors from the Columbus Convocation and 25 delegates and 29 visitors from the Dayton Convocation.

Miss Johnston, secretary of the educational department, reported that the Lenten study classes had proved to be most interesting; the study book this year filled a real need.

Mrs. McGregor, chairman of the Corporate Gift, explained the object of this fund had been to raise \$100,000.00 to put buildings in six mission fields. It is her hope that we may go about \$500.00 over Southern Ohio's quota of \$3,000.00, as \$3,216.00 has already been paid in, leaving \$220.00 in unpaid pledges still to be met.

Miss Frances Bussey, Provincial Representative on the Executive Board of the Woman's Auxiliary, gave a complete sketch of the plans already formulated for the Triennial meetings in Washington this coming October.

The president announced that the next item of business would be action on the change in the constitution, as recommended by the Executive Board. As the hour for adjournment had passed, Mrs. Mitchell (St. Luke's, Cincinnati) moved, seconded by Mrs. McGregor, and carried, that the recommendation of the board be put before the meeting,

but that action be postponed to the first item of business on Thursday morning. The secretary then read the resolution, copies of which had been placed in the hands of the delegates and visitors, that: "It was recommended by the Executive Board at its meeting held on October 17, 1927, and presented during the annual meeting in St. Paul's Church, Columbus, October 27, 1927, that the annual meeting be held each year in May, thus necessitating this amendment to the constitution: The president shall be elected at the annual meeting held next after the General Triennial meeting, making Article 5, Section 3, which now reads: The president shall be elected at the annual meeting held *at least one year after* the General Triennial meeting, to read: The president shall be elected at the annual meeting held NEXT AFTER the General Triennial meeting." Miss Susie Tuite (Advent, Cincinnati) moved that the resolution be adopted; seconded by Miss Elizabeth Matthews (Christ Church, Glendale). Miss Johnston (Christ Church, Glendale) spoke to this resolution bringing forth some of the advantages as well as some of the disadvantages should the recommendation be adopted.

Mrs. Mark Mitchell (St. Luke's, Cincinnati) moved that the meeting be adjourned; seconded and carried.

On Wednesday evening, the 16th, the delegates and visitors met at the home of Mrs. Cleveland K. Benedict, Beechlands, in Pleasant Ridge, for a picnic supper, where it was announced that the U. T. O. presented at the morning service amounted to \$5,941.40.

Thursday—Ascension Day—there was a service of Holy Communion at 8 o'clock, at which Bishop Reese was again the celebrant, Rev. J. L. Langhorne, St. Philip's, Northside, reading the Epistle and Archdeacon Reinheimer the Gospel. Rev. Mr. Slayton also assisted, and read the new names just inscribed in the Book of Remembrance. One hundred and seventy-five made their communion.

The first matter of business at 10:00 o'clock, after the opening prayer by the president, was action upon the proposed change in the constitution. Mrs. Leding (Calvary, Cincinnati) spoke, giving her reasons for not favoring the change. Mrs. McGregor moved that the debate be limited. Motion seconded and carried. The following took part in the discussion which followed: Miss Matthews, Mrs. McGregor, Mrs. Benedict, Mrs. Mitchell, Miss Colston and Mrs. Gordon Graham (Advent, Cincinnati), each presenting items of interest concerning the change. The motion was lost by one vote of the count required to pass the recommendation.

Next followed the election of delegates to the Triennial. The president explained the method of election, presenting the following names brought in by the nominating committee: Miss Matthews, Miss Morrison, Mrs. McGregor, Mrs. Benedict, Mrs. Moyer, Miss Mary Johnston, Mrs. Mitchell, Mrs. Monroe, Mrs. Wood, Mrs. Henry Scarlett, Miss Colston, Mrs. Baggott, Mrs. Henry W. Leding, Mrs. Chas. G. Reade (St. Stephen's, Winton Place). The president explained that Miss Elizabeth Matthews had been nominated for presiding officer at

the Triennial meetings in Washington, and therefore must be a delegate from Southern Ohio. Mrs. McGregor, as a member of the National Board, should also be elected. The tellers appointed were: Mrs. F. D. Heiny (St. Philip's, Northside); Mrs. Joseph Dodds (All Saints', Portsmouth) and Mrs. Alvan Talmadge (St. Paul's, Columbus).

While the tellers were out counting the votes, Mrs. Benedict presented U. T. O. plans for the fall, and announced that September 16th would be the date for the fall collection. Mrs. H. W. Leding (Calvary, Cincinnati) moved that the offering presented at the 8:00 o'clock service of Holy Communion, amounting to \$41.55, be given to the treasurer of the U. T. O. Motion was seconded by Mrs. Theodore E. Glenn (St. Paul's, Columbus) and carried.

Miss Colston, for the Book of Remembrance, stated that 108 new names, representing 41 parishes, had been read by Rev. Mr. Slayton at the altar this morning, Miss Emily Tillotson's name making the one hundredth and nine as from the diocese of Southern Ohio.

The committee on the memorial to Miss Tillotson reported through Mrs. McGregor, who read the following resolution and moved its adoption, the same to be spread upon the minutes of this meeting and a copy sent to Miss Tillotson's sister, Mrs. Ethel Allison, 21 Perry street, New York, N. Y. The motion, seconded by Miss Colston and carried:

"The Woman's Auxiliary of the Diocese of Southern Ohio, in its Annual Meeting, wishes to express its peculiar sense of loss in the death of Emily C. Tillotson, which occurred in New York City on May 12, 1928.

"Miss Tillotson was appointed by Bishop Vincent on October 3, 1911, to the office of Educational Secretary of the Woman's Auxiliary of the Diocese of Southern Ohio. Being the first to hold that office, she laid the foundation on which all our later work has been built.

"Her signal success as a leader, and her ability in developing leadership in others, quickly attracted attention at the Woman's Auxiliary Headquarters, and in January, 1914, she was called to the Church Mission House to be Assistant Secretary to Miss Grace Lindley, later becoming Educational Secretary of the National Woman's Auxiliary, which office she held to the time of her death.

"While her service rendered as a pioneer in adult education will always be remembered, her greatest contribution to the Church came from certain personal qualities which caused her to be one of the most widely loved women in the Church. Her unfailing courtesy, her graciousness of manner, her unselfish devotion to her task, and her ability to find and to draw out the best in others, these are the graces which made her a great leader, even beyond her intellectual ability and joyousness.

"Nor were her further qualities of personality, such as courage in the face of difficulties, won without a struggle, since, during two prolonged periods of her national service she was handicapped by

serious ill-health. Against depression and a haunting sense of failure she won a spiritual victory, and those closest to her knew it was gained through the Power and Companionship of her Lord Jesus Christ.

"Although the actual period of her residence and service in the Diocese of Southern Ohio was brief, she continued to count herself one of us, so that the ties of affection were never broken, and the women of Southern Ohio have been honored and distinguished by the service she has rendered to the whole Church.

"It is our earnest prayer that, in the strength of her example, we, the women of Southern Ohio, may give ourselves completely to the cause to which Emily Tillotson devoted her life,—the spread of the knowledge of the Glory of God in the face of Jesus Christ,—and that light perpetual may shine upon her as she beholds the King in His Beauty at this Ascensiontide."

Miss Sara Gaither, principal of Margaret Hall, a preparatory school for Girls at Versailles, Kentucky, told something of the curriculum and the life there.

Miss Mary Johnston spoke telling of the need of the support of the current expenses of the New Children's Hospital, and invited any interested persons to pay a visit to the hospital this afternoon.

The tellers reported 93 votes cast resulting in the election of Miss Matthews, Miss Morrison, Mrs. McGregor and Mrs. Benedict. A second ballot was cast to elect the fifth delegate.

While the tellers were out Mrs. D. C. Larcomb spoke of plans for the Church Periodical Club. Archdeacon Reinheimer told of the accomplishments in the diocese during the winter.

The tellers reported 92 votes cast on the second ballot, resulting in the election of Miss Mary Johnston, the fifth delegate. The election of alternates to the Triennial was next in order. Miss Matthews moved that the rules be suspended, and the five women receiving the five highest votes on the ballot be declared elected as alternates. Motion seconded and carried. The ballot was cast for the election of five alternates.

Miss Elizabeth Matthews conducted the devotional hour, "The First Convention of the Church," and led noonday prayers.

Adjournment was taken for luncheon in the parish house.

The afternoon session opened at 1:45 o'clock, the first item of business being the announcement of the five alternates elected, as follows: Mrs. Henry L. Scarlett, Miss Judith Colston, Mrs. Samuel L. Moyer, Mrs. Mark L. Mitchell and Mrs. James Monroe.

Mrs. Anne L. Dodson (Holy Trinity, Madisonville) presented these resolutions and moved their adoption, seconded and carried:

*"Resolved,* That, The Woman's Auxiliary of Southern Ohio expresses its appreciation to Bishop Vincent and to Bishop Reese for the

inspiration which they have given us in conducting the services of Holy Communion.

"II. That, The Woman's Auxiliary of Southern Ohio expresses its appreciation to the Rev. Mr. Slayton for his welcome and gracious assistance in all the activities of the Auxiliary in this annual meeting.

"III. To the Rev. Frank H. Nelson for his sermon which gave us a new vision of our relationship to God and to our fellow men.

"To the assisting clergy, organists and choir, who enriched and helped to make the service more beautiful.

"IV. *Resolved*, That, All speakers, especially Miss Frances Bussey, Provisional Representative on the National Executive Board, receive our hearty thanks for the clear and concise presentation of the work and plans for the future, which give us inspiration to go forward to higher tasks and achievements.

"V. *Resolved*, That, The Woman's Auxiliary of Southern Ohio express to the women of Calvary Church, including the motor corps, its sincere appreciation of their cordial hospitality and for their untiring efforts in providing for our comfort.

"VI. *Resolved*, That, The Secretary of the Woman's Auxiliary of Southern Ohio sends to Bishop Vincent on the occasion of his eighty-third birthday our hearty congratulations and best wishes for his continued good health and spiritual guidance to us in the future."

Miss Colston moved that flowers be sent to Bishop Vincent with this resolution. Motion seconded and carried.

Miss Adelaide Rigdon (Epiphany, Cincinnati) moved that thanks be extended to Mrs. Benedict and the Diocesan Board for the hospitality extended to the delegates and visitors on Wednesday evening at Mrs. Benedict's home. Motion seconded and carried.

Mrs. McGregor spoke in further explanation of the Triennial plans, the first meeting to take place on Tuesday, October 9, and lasting two weeks—to October 23.

The president announced that she had seen to it that flowers be sent to Miss Tillotson's funeral on Monday, May 14, as coming from the Woman's Auxiliary of Southern Ohio.

Upon motion of Mrs. Leding, seconded and carried, the president announced the adjournment of the fifty-second annual meeting of the Woman's Auxiliary of the Diocese of Southern Ohio.

## CONSTITUTION AND BY LAWS

### CONSTITUTION

#### ARTICLE I

**Name.**—The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

#### ARTICLE II

**Object.**—The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

#### ARTICLE III

**Membership.**—Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

#### ARTICLE IV

**Officers.**—The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

#### ARTICLE V

**Duties.**—Section 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

Section 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

Section 3. The President shall be elected at an Annual Meeting held at least one year after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She

shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

Section 4. Each Vice-President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-Presidents or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

Section 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

Section 6. The Box Secretary shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

Section 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

Section 8. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

Section 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

Section 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request.

## ARTICLE VI

**Meetings.**—Section 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every Mission branch one delegate. Except

in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

Section 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

Section 3. Convocation meetings shall be held on the call of the Convocation Officers.

Section 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

## ARTICLE VII

**Mode of Election.**—Section 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

Section 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

## ARTICLE VIII

**Amendments.**—This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

---

## BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be :

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expenses of officers and speakers, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

## FINANCIAL POLICY

### I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

### II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
  - (a) By urging an every-member canvass and assisting in carrying it out.
  - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
  - (c) By giving when necessary as an organization.

### III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
  - (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B— 60.00	I— 15.00
C— 50.00	K— 10.00
D— 40.00	L— 7.50
E— 35.00	M— 5.00
F— 30.00	N— 3.00
G— 25.00	O— 1.00

- (b) Each branch shall decide to which class it will belong.
- (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
- (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
- (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
- (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

### IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
