## PRESIDENT'S ADDRESS

---

One year ago you elected a president and three vice-presidents to serve you for three years. In turn five other women were chosen to undertake special tasks as secretaries and treasurers of work and funds for which we as an Auxiliary are peculiarly responsible. Eight inexperienced women were given responsibilities which would have been most difficult for them to meet if they had not felt behind them the corporate life of the Woman's Auxiliary of Southern Ohio.

And even in the short time of our service with you, we have grown to love the Auxiliary with an increased devotion which comes to any who have had the privilege of serving on a Diocesan Board. The response to every demand made upon you, the faithfulness of the branches to routine work, and the kindness and encouragement you give us, bring a deepening sense of the fact that we are really engaged in a common task of that church which is the Body of Our Lord Jesus Christ.

It has been my privilege during the past year to attend two meetings as your representative. The first, the conference of officers, held at Taylor Hall, Racine, Wisconsin, last May, and the second, the meeting of the Provincial Woman's Auxiliary, on October 15th and 16th, at Springfield, Illinois. This being the first meeting of the Provincial Auxiliary, and there having been no diocesan meeting at which delegates could be elected since the formation of the Provincial body, Bishop Hobson appointed five delegates and five alternates to represent you. A full representation from Southern Ohio attended, one of your delegates being Miss Elizabeth Matthews, who had served as president of the Provincial Auxiliary during the past year, and who was re-elected to succeed herself.

The officers in charge of special Auxiliary work will give you their reports. May I say how much I appreciate the spirit in which our new diocesan officers have taken over their appointed tasks. Their quickness to grasp details, and their ability in handling their departments, have made our first year together a real satisfaction, at least to your president.

A card index of the work of parish branches, which was started by Miss Matthews ten years ago, was brought up to date this summer, and while we may often doubt the value, or even the facts which statistics sometimes seem to prove, we may feel fairly certain of the accuracy of the figures of the number of women giving to our United Thank Offering. The increase in givers during these past ten years seems to us a most encouraging thing. The number giving ten years ago in the Cincinnati

Convocation was 796, Columbus 630, and Dayton 420, a total of 1,846; while in 1929 Cincinnati could report 1,536, Columbus 1,015, and Dayton 701, a total of 3,252, and an increase in ten years of 1,406, or an average of 140 every year. This increase marks a healthy growth, a splendid indication of the steady, faithful service of our United Thank Offering Treasurers. We can wish for no happier development of interest in the Auxiliary than a continuing growth in that great Offering of our United Thanksgiving, the heart and center of the work of the Auxiliary.

As we offer our thanks for the privilege of sharing in the corporate life of the women of the church, let us ask ourselves what membership in the Auxiliary should mean to us. We are Auxiliary to the National Council of our Church, and that Council, through its departments, reaches out to every duty which the church has to perform as the Body of Christ in the world.

Our objects are work, study and prayer, the three to be linked together, a trinity of obligation offered to us as members of Christ. If the Auxiliary is to be the real expression of woman's work in the church, it may well be our responsibility as individual members to carry that spirit of work, study and prayer into every bit of our life, re-vitalizing our whole way of living, especially by a more honest effort in prayer, and by an increased devotion in our use of the sacraments, by which we may be nourished and strengthened by the very Bread of Life. Our Lord offers us the inestimable privilege of being partakers of His most blessed Body and Blood, and the church teaches in the glorious liturgy of the Eucharist the benefits that may be given to us, no matter how unworthy we may be, if we come to the Sacrament prepared and anxious to secure help. Let us as individuals and corporately in the branches of the Auxiliary, make more use of this great sacrament.

Some of our discouragement and failure undoubtedly comes from a lack of faith on our part. Again we must bring to our assistance work, study, and prayer, for a faith which will carry us confidently through the difficulties we meet in our work and in our lives is not easily attained, or having been attained is not always easily kept.

Bishop Fiske, in a recent pastoral letter to his clergy, makes the following statement which we might apply to ourselves: "Unless we bear more consistent witness our own faith may fail. Faith is rarely, if ever, lost in one short, sharp experience. Faith goes because that which kept it alive has been neglected. We lose our faith when we cease to practice our religion. Men grow careless about prayer, communion, worship, and then wonder at finding themselves doubtful in belief. I know of no other realm of life where people expect knowledge to trickle into their heads without honest effort on their parts. I know of no other activity in which they expect to become expert without practice."

We know, of course, that the Auxiliary can go on to larger works, and that the only hindrance is our own failure, and yet, as we go about the Diocese, may we tell you that we rejoice in the work of the women? Often we know there is discouragement. Parish groups may seem to you small, and their accomplishments almost futile, for it is hard for isolated branches to see the whole strength of the Auxiliary. But we do well to remind ourselves that the great corporate body must be made up of many faithful members, women willing and ready to serve when and where they are needed, no matter how small the task, and daring to face the responsibility back of that task.

The Rev. Peter Green illustrates delightfully, in the following passage, what might well be our ideal. He says, "What will nerve and sustain us will be the realization that we are not working for ourselves, but for our Captain of Salvation and our fellow soldiers in the great war. I think we may learn a lesson from a friend of mine, an elderly working man, who being over sixty when the war broke out, joined the National Volunteers and was set to guard a railway bridge. At first there was great keenness, but as the years dragged on he was almost the only man who retained his first zeal. After the armistice some of his comrades were chaffing him about his drills, and watches, and nights on guard. 'What good did you do?' one of them asked. 'Nothing ever happened.' 'No,' he replied quite placidly, 'but I was there if I was needed. I felt I was doing my bit.' In the hour of England's need he had had his vision, and having once had that, nothing seemed to him trivial or useless, or wearisome. It is no light thing, in Christ's great war between good and evil, to know that we are there, if we are wanted, and, by his grace, are doing our bit."

We, as members of a teaching church, should know not only the need of the world, but the answer to that need in the Incarnation of the Son of God, and in that knowledge we should be ready to serve when and where we are called.

May God grant us the grace of our Lord Jesus Christ and the guidance of the Holy Spirit, that we may stand faithfully by our task, and bring to fruition the great opportunity entrusted to us.

## ANNUAL REPORT OF THE SECRETARY

---

*To the Bishops, Madam President and Fellow Members of the Auxiliary of Southern Ohio:*

Since taking over the Auxiliary work on January 17th, 1930, the present Executive Board has held four meetings and the work has gone steadily on.

There have been four Convocation meetings; three in the Spring; one at Newark and one at Middletown with Mr. Reinheimer and Miss Mary Johnston as speakers; and one at the Church of the Advent, Cincinnati, with Mr. Reinheimer and Mr. O'Farrell. These were splendidly attended. At Newark there were 102 delegates, not counting a generous number from their own branch. At Middletown, 141, and at the Church of the Advent, Cincinnati, 350. In June there was a picnic meeting at Pomeroy and early in October a meeting was held at Christ Church, Glendale, with an attendance of 400, to study Conference Convocations.

The Executive Board is continuing the scholarship to Deaconess Dellema J. King, from the Memorial Fund. She is studying at Northwestern University, Evanston, and at the Western Theological Seminary, Chicago, and we have had very appreciative letters from her, reporting satisfactory progress. One more payment after the first of the year will complete her scholarship.

Miss McCune and Miss MacCracken were sent by the Board to Racine, for the Woman's Auxiliary Conference held there from May 2nd to 7th. The work of the various departments of the Woman's Auxiliary will be reported separately by the Secretaries. Satisfactory progress has been reported by all.

Five delegates from our Diocese attended the Provincial Synod of the Woman's Auxiliary of the Fifth Province, held in Springfield, Illinois, October 14th, 15th and 16th. Those who went were Miss McCune, Miss Matthews, Mrs. Bone, Mrs. Larcomb and Mrs. McGregor.

We were fortunate in having Miss Marston speak to the Educational Secretaries and others interested, during late October, and are much indebted to Miss MacCracken for making this possible.

The Board reports with regret the death of Mrs. Burlingham, of Christ Church, Cincinnati.

Your President has made many visits throughout the various branches and has attended many conferences, alone, or with one or more members of the Board.

The Board wishes to express to the whole Auxiliary their appreciation of the co-operation they have met with everywhere.

## REPORT OF THE EDUCATIONAL DEPARTMENT

---

During the winter and spring of 1930 the World Mission of Christianity was the subject for study in forty-one parishes, which sent in a report of educational work. In this report were included classes on the Bible, various Mission fields, reports of the Jerusalem Conference, and some program meetings which covered this ground.

Eight women from Southern Ohio attended classes in Gambier, led by Miss Marston, our National Educational Secretary. One class on Adult Education, the other on the Woman's Auxiliary in the life of the Church. It is strongly urged by your Educational Secretary that the Educational Secretaries of the parishes take advantage of this excellent training in this coming year.

An all-day training class for the Educational Secretaries and others interested was held by Miss Marston, at Trinity Church, Columbus, on October 21st; at Christ Church, Springfield, October 22nd; and at Calvary Church, Clifton, Cincinnati, on October 23rd and the morning of the 24th.

A total of thirty-one parishes and a combined attendance of 105 were present at these three institutes. New ideas and methods of study and discussion presented at these classes were a real inspiration to those attending.

India is the special subject selected for study during the coming year; also "Our Expanding Church," by James Thayer Addison, has been recommended. One hundred and fifty copies of the study books suggested for use in the study of India have already been distributed, as well as other books on the subject. A library of fourteen books on India is in the hands of your educational secretary and will be gladly loaned to any one desiring them, for two weeks; also a list of books available at the Lending Library at 281 Fourth Avenue, New York City, which can be borrowed on the same terms, can be had for the asking.

In the educational work of the Woman's Auxiliary the women of the Church who have served so faithfully and well in many ways are finding inspiration for all forms of service, since the educational work is not a separate and isolated subject, but bound up in all the activities of the parish. Those parishes which are undertaking classes and discussion groups, not alone on the work of the Church, but on the issues of our day, in their relation to the teachings of Christ, are finding a vital interest in their subject, as they acquire not only knowledge, but the experience of comparing facts, thinking through their problems and arriving at conclusions.

The purpose of Religious Education is to give more abundant life; to give a capacity to live more happily and more fully, "Rejoicing in the knowledge of Thy Truth."

It is the suggestion of your educational secretary that the Annual Report of the Woman's Auxiliary for 1930, with its reports from all the departments of the work of the Woman's Auxiliary, be made a part of some meeting of the Auxiliary in each Parish as early in the year 1931 as possible.

## MINUTES OF THE ANNUAL MEETING

---

The Fifty-fourth Annual Meeting of the Woman's Auxiliary of Southern Ohio was held in Christ Church, Cincinnati, Wednesday and Thursday, November 12th and 13th, 1930.

At the service of the Holy Communion, on Wednesday at eleven o'clock, Bishop Henry Wise Hobson was the celebrant and preacher; Rev. Frank H. Nelson assisted, Archdeacon Ware read the Epistle and Rev. Allen W. Cooke, the Gospel. Bishop Hobson's text was from the twenty-first chapter of St. John, the fifteenth verse, "Simon, son of Jonas, lovest thou me?" He saith unto Him, "Lord, Thou knowest that I love Thee." He saith unto him, "Feed my lambs." Throughout his sermon he emphasized service.

Two hundred and ninety-four present made their Communion and the offering amounted to \$115.13.

Luncheon was served to 230 guests in the Parish House and at two o'clock the business session was opened by the President with the Creed and Prayer.

Miss Colston, president of the Auxiliary of Christ Church, extended a gracious welcome and the Rev. Frank H. Nelson made a short address of welcome, to which the chair responded.

After the roll call by the secretary, the chair announced the Credentials Committee, as follows: Mrs. Lawrence Laybourne, Christ Church, Springfield; Miss Miriam Blackmore, Grace Church, Pomeroy; and Mrs. W. F. Lillard, St. Paul's Cathedral, Cincinnati.

Miss McCune appointed a Resolutions Committee, to report on Thursday: Mrs. Clarke B. Firestone, Church of the Advent, Cincinnati, Chairman; Mrs. Carl Benst, St. Paul's, Dayton; and Mrs. Palmer Cordray, St. Paul's, Columbus.

The secretary's report followed and was accepted as read.

The credentials committee brought in its report, showing that there were present:

*Cincinnati Convocation*—Delegates 55, Parishes 20, Visitors 158, Missions 4.

*Columbus Convocation*—Delegates 20, Parishes 9, Visitors 3, Missions 1.

*Dayton Convocation*—Delegates 23, Parishes 10, Visitors 15, Missions 1.

*Total*—98 Delegates, 39 Parishes, 6 Missions, 176 Visitors.

Miss Kelton read the Treasurer's report, showing a total balance on hand of \$815.12. She has a balance of \$246.33 in the Central Expense Fund and \$514.16 in the Savings Account. Copies of the Treasurer's report were placed in the hands of the delegates and visitors, and she explained at length the Central Expense Fund.

Upon the motion of Mrs. Shell, Grace Church, Avondale, seconded and carried, the Treasurer's report was received and filed.

The President's address followed. She emphasized the importance of work, study and prayer, and the growth of faith through the practice of religion.

Mrs. Bone reported a total of \$5,828.27 for the Spring United Thank Offering. Four parishes had not reported at that time. For the Fall Offering, 32 parishes have already been heard from and among these are the four who were unable to report in the Spring. She has now over \$18,000.00 toward the Triennial Offering.

Next Fall the U. T. O. will come September 1st, in order to be ready for the General Convention, September 16th, in Denver.

Mrs. Laird reported that the work of the Supply Department for the first half year amounted to \$3,362.62. This Fall's work consists of 9 personal boxes and 11 Christmas boxes. Christ Church, Cincinnati, has taken the assignment for the Hudson Stuck Memorial Hospital at Fort Yukon, Alaska. Mrs. Laird told about the other assignments: St. Philip's Mission, Little Rock, Arkansas; Thompson Orphanage, Charlotte, North Carolina; True Light Industrial Work Hospital and Dispensary, Wuhu, China. More work will be done for this last mission and for St. John's, Boone, Virginia, next Spring.

For the Educational Department, Miss MacCracken reported that an all-day training class for educational secretaries and others interested was held by Miss Marston, National Educational Secretary for the Woman's Auxiliary, in Columbus, at Trinity, on October 21st; in Springfield, at Christ Church, October 22nd, and in Cincinnati, at Calvary, Clifton, on October 23rd and the morning of the 24th. A total of 31 parishes were represented at these three institutes and gained real inspiration from them. Eight women from Southern Ohio attended Miss Marston's classes in Gambier, at the Summer Conference. Miss MacCracken reported that India was the special subject selected for study this year, and "Our Expanding Church," by James Thayer Addison, has been recommended as additional reading. She also recommended very highly the "Woman's Auxiliary in the Life of the Church," and the "Spirit of Missions".

Mrs. McGregor, member of the National Board, told of the action of the National Council which gave Bishops in China

freedom to register schools at their discretion and told of the conditions in China which brought about this decision. Mrs. McGregor also explained that the Advance Work was now taking the place of the Corporate Gift and urged the Auxiliary to supplement, not supplant, the work of the Diocese in this matter.

Miss McCune announced that the Book of Remembrance and Records were on display in the church under the care of Miss Anderson.

The Secretary read a letter from Bishop Vincent regretting his inability to attend the meetings.

Miss Morrison read a beautiful resolution about Mrs. Burlingham.

There being no further business, the meeting adjourned.

---

In Christ Church, on Wednesday evening at eight o'clock, Mr. John W. Wood, Executive Secretary of the Department of Missions and Church Extension of the National Council, made a splendid address, which was well attended.

---

On Thursday morning, November 13th, Holy Communion was celebrated at 7:30 by Reverend Frank H. Nelson, assisted by Mr. Duer, Mr. Cooke and Mr. Hummel. Fifty-nine present made their Communion, and the offering amounted to \$11.95.

After breakfast in the Parish House, conferences of officers were held at 9:15.

The business session was opened at 10:00 A. M. by Miss McCune with the Creed and Prayers.

She reported a letter from Miss Lindley about a World Day of Prayer, February 20th, 1931, and urged co-operation in making it a success.

The Book of Remembrance is open next Spring for names.

Miss Morrison moved, Mrs. McGregor seconded and it was passed, to send messages to Mrs. Perkins and Mrs. Scarlett from the meeting.

Mrs. Roemler spoke for the Diocesan Altar Guild. She reported many gifts in different parts of the country and has lately had appeals from different points. She appealed for contributions and memberships to help fill these needs.

In reporting for the Church Periodical Club, Mrs. Larcomb expressed her gratitude for co-operation with the Auxiliary at large and for the Diocesan Altar Guild especially in establishing libraries in out lying districts. She mentioned the Peggy Rogan Memorial Library and the fund of the same name for buying books.

Each year the Church Periodical Club sends new books to missionaries for Christmas. She asked for these and appealed for personal forwarding of magazines.

The Auxiliary stood to receive Bishop Reese and listened to a short talk from him on the Spirit of Thanksgiving. We wish to express our deep felt appreciation of the benediction of his presence.

Mrs. Bone reported the meeting of the Woman's Auxiliary of the Fifth Province, October 15th and 16th, at Springfield, Illinois. The principal business was the adoption of a new constitution and election of officers. Miss Elizabeth Matthews was made president again. At one of the evening meetings several clergymen reported their work among the university students. Mrs. Bone spoke of the outstanding women of the meeting.

Miss McCune announced that Miss Lindley would be the speaker at the next Annual Meeting, in Columbus, May 13th and 14th, 1931.

Miss Matthews has been nominated by the National Board to preside at the meeting in Denver, September 16th, 1931, and Mrs. McGregor is chairman of the Triennial Program. Mrs. McGregor spoke of giving up Taylor Hall at Racine, and the work of Mrs. Biller among the Oriental students. Between 25 and 30 of them are located in universities in and around Chicago. A house near the University of Chicago has been purchased, not as large as Taylor Hall, but adequate. The Woman's Auxiliary could help the National Council with money toward their purchase.

Deaconess Williams, of Dante, Russell County, Virginia, spoke at 11:00 A. M. most interestingly on "The Highlanders of the South."

Miss Mary Johnston announced Donation Day at the Children's Hospital with a service at 10:00 o'clock next Thursday, November 20th. She spoke of the National Cathedral in Washington and the Bicentennial in 1932, and appealed to the group to take \$2.00 annual memberships to support it.

At twelve o'clock Noonday Prayers were read by Reverend Frank H. Nelson and at 12:10 Bishop Henry Wise Hobson spoke on the Diocese. He said the real success of the Auxiliary depends on our loyalty. We need a way of renewal, (1) intellectual renewal; we must be better informed on the aims and standards of the church; (2) further education in giving; (3) church membership.

Luncheon was served at 12:45 and at 2:00 P. M. the closing session began with a plea from the chair to subscribe to "The Spirit of Missions."

Miss Kelton announced that the offerings at the two Communions amounted to \$127.08. Miss Colston moved that the offering be divided between Deaconess Williams and Bishop Hobson's Discretionary Fund. This was seconded and passed.

Mrs. Firestone presented the resolutions for her committee and moved their acceptance.

#### RESOLUTIONS.

1. *Resolved*, That we members of the Woman's Auxiliary of the Diocese of Southern Ohio express our joy at the presence of our beloved Bishop Reese, whose words to us were a benediction.

2. *Resolved*, That we express our gratification at the presence of Bishop Hobson, ministering for the first time to this Diocesan body; and also of our appreciation for his uplifting sermon at the Corporate Communion service.

3. *Resolved*, That the Woman's Auxiliary will support Bishop Hobson in his work in the Diocese and will co-operate in every way with his plans as expressed in his appealing talk on Thursday morning.

4. *Resolved*, That we express our appreciation of the splendid and informative address of Dr. John W. Wood at the Missionary Mass Meeting.

5. *Resolved*, That we express our appreciation of the inspiring address by Deaconess Williams and of her fine work among the Southern mountaineers.

6. *Resolved*, That we express our appreciation of the beautiful services conducted by the Bishop, Dr. Nelson and other clergy, and to the organist and choir for their fine music.

7. *Resolved*, That we express our thanks and appreciation to the women of Christ Church, under the leadership of Miss Judith B. Colston, who provided so efficiently and cordially the hospitality for this occasion.

8. *Resolved*, That we express our appreciation of the work of the new Board in their plans and execution of this meeting.

## CONSTITUTION AND BY-LAWS

---

### CONSTITUTION

---

#### ARTICLE I

##### **Name**

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

#### ARTICLE II

##### **Object**

The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

#### ARTICLE III

##### **Membership**

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

#### ARTICLE IV

##### **Officers**

The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

#### ARTICLE V

##### **Duties**

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

SECTION 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

SECTION 3. The President shall be elected at an Annual Meeting held at least one year after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

SECTION 4. Each Vice-President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-Presidents or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

SECTION 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

SECTION 6. The Secretary of Supply Department shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

SECTION 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

SECTION 8. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

SECTION 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

SECTION 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request.

## ARTICLE VI

### **Meetings**

SECTION 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every Mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

SECTION 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

SECTION 3. Convocation meetings shall be held on the call of the Convocation Officers.

SECTION 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

## ARTICLE VII

### **Mode of Election**

SECTION 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

SECTION 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

## ARTICLE VIII

### **Amendments**

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

## BY-LAWS

---

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expenses of officers and speakers, necessary expenses of the Educational Department, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

## FINANCIAL POLICY

### I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

### II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
  - (a) By urging an every-member canvass and assisting in carrying it out.
  - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
  - (c) By giving when necessary as an organization.

### III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
  - (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B— 60.00	I— 15.00
C— 50.00	K— 10.00
D— 40.00	L— 7.50
E— 35.00	M— 5.00
F— 30.00	N— 3.00
G— 25.00	O— 1.00
  - (b) Each branch shall decide to which class it will belong.
  - (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
  - (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
  - (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
  - (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

### IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
