

## PRESIDENT'S ADDRESS

---

I know that farewells are expected from a retiring board, but I also know that we have no consciousness of ending our work in the Auxiliary; rather we feel that our three years of experience in diocesan work have given us a new vision of the Auxiliary, a deeper love for it, and a joy in knowing that the future stretches out with infinite fields of service for all of us in our Church.

We do want to express our continued gratitude to you for the support you have been to us in our special activities during these three years. The responsibilities which the board has naturally carried have been lightened by the knowledge of the steadfastness and willing co-operation of the parish branches, and I am speaking for our entire board when I say that we know the help the newly elected officers, whoever they may be, will receive in the support and loyalty of the Auxiliary of Southern Ohio.

This meeting does give us a chance to review the work of the past year, and you have heard in the report of our secretary of the work of the various departments.

In looking ahead, our immediate responsibility is the Every Member Canvass. Bishop Hobson will speak to us tomorrow of the Diocese, and I know that he will urge all of us to go home from this meeting resolved that we will try to be a real power in our various parishes this winter, for every effort will be needed to further the work of our church during this trying year.

May I read you a paragraph from a letter which has just been received from Miss Lindley? "The immediate effort before us is the Every Member Canvass. We can do much to see that it is really an *every* member one, both where we are canvassers ourselves, and where the canvass is carried out entirely by men. If the Church could receive pledges from every member, there would be no danger of curtailment in her work at home or abroad, and it is possible that we could save the day by getting new pledges. After that work is done we shall try to interest every woman in the United Thank Offering, for if we are not to have a lesser Offering in Atlantic City two years from now, we must increase the givers to it." Let us apply ourselves to these two specific tasks, remembering that the mission of our church may be endangered unless we do so.

As we look to the future and think anew of the possibilities of the Auxiliary we realize more and more fully that, as we are Auxiliary to the National Council, our work should include the whole mission of the church, and our program of work should be made to include every woman in the parish for service in the parish, the diocese, the community, nation, and the world.

Can we stop our complaint that some women in the parish are so busy in community work, or in the business world that they have no time for "Church" work? We know, as Church women, that all life should be integrated and motivated by our membership in the church, the body of Christ on earth, and the Auxiliary could definitely plan its work to make this more real in our lives. Could we not recognize that the woman who is doing community work is representing her parish in the community, that the teacher is doing a real service for the Church, that the business woman by her loyalty, her faithfulness, is also serving? Let us give them a place in our programs and bring home to them the fact that such service can be undertaken for the Church. Such a program would do much to further the best interests in our communities, as well as to make every activity of higher value in our own lives. To quote Miss Lindley again: "It is to be hoped that we may think through afresh what we mean by the expression 'Church work.' Is it running a meeting now and then, or is it taking our part in bringing a new Christian order which will be worthy of the name, Kingdom of God? That question should be followed by asking for what our organizations exist: are they ends in themselves, or means?"

As time goes on we cannot but feel that the committee for the program in Denver was under the guidance of the Holy Spirit in choosing the subjects around which the program was planned. Family Life, Interracial Contacts, International Relations, Property and Economic Conditions, and Religious Thinking Today grow more and more important as vital issues and problems of present day living, and we would urge your serious consideration of these topics during the coming winter.

And as we study the difficulties and tragedies of Family Life, let us also remember, with thanksgiving, the countless homes in our land where people are trying to live decently and happily together, and where every effort is being made to give the best to their children.

International Relations are of deep concern to all of us, and I was happy to hear recently a hopeful statement made by Dr. Libby, Secretary of the League for the Prevention of War. He spoke on the subject, "Are we moving towards peace or war?" and he said that within the last few months he had come to feel that he could truthfully answer, "We are moving towards peace, but with the war system on our backs."

Let us realize what that very question implies, "Are we moving towards peace or war?" A movement can be directed, and that direction may be our individual responsibility, for we must always remember that public opinion is a mighty power in the land, and we can take a definite part in molding that opinion. One way might be to ally ourselves with one of the many groups now bending every effort to secure peace for the world.

One of the growing concerns of those most interested in the welfare of our nation is the effect which present economic con-

ditions is having upon the morale of our people. It is absolutely necessary to administer relief, to make every effort to see that there shall be no starvation in this land of plenty, but we are realizing that a system which forces millions of our people to accept relief, with no opportunity given them of supporting themselves is a growing evil. It brings a bitter humiliation, a loss of self respect, and too often there comes an acceptance of idleness, with a loss of the will to work, which to those of us who know the value of work in one's life is a tragic thing.

And as we consider "Religious Thinking Today," I wonder whether there is an analogy between the relief situation today and the ineffectiveness of much of our own religious life. Have we accepted our Christian heritage with so little effort on our own part that we do not know how to appreciate it? We call ourselves Christians, followers of our Lord, and expect to be that with so little effort on our own part, when our Lord Himself felt power go out from Him at the touch which brought healing to others. The effective Christian lives in the history of the Church have been those so on fire at the thought of the love of God, that they have been wholly possessed by Christ. Is it so with ourselves?

And because our love has been so lukewarm, because we have taken our Christianity so lightly, we may not be able to pass on that precious heritage to a world which is hungry for more than bread. I heard Prentice Murphy, Secretary of the Children's Bureau in Philadelphia, speak in Columbus. He had been asked to come to Franklin County to help evaluate our work for children because he is one of the experts in that field, and yet he said, that while they made every effort to keep their work in the Bureau at the highest standard, his constant prayer was that his own children should never have to pass through it. He spoke of the hurried procedure of much of the social work of today, so much of it so impersonal, and I shall never forget his plea for a greater effort to understand people, and to think of ourselves in their place. He spoke of their loneliness, their longing for someone to understand them, and of the pity in the fact that there are so few who possess the knowledge and the sympathy to meet that great need of the world.

We often say that we cannot speak of our religion because it means so much to us. Is that really so, or is it that, in our hurried living, the desire and effort needed to know our Lord has been crowded out, and we dare not speak because we are ourselves uncertain in our devotion.

I wonder whether if we thought of our life in terms of eternity it would make some difference in our interests. Perhaps if we really thought more often of life as continuing forever, many of the things which occupy us might lose the value we place upon them. I think to many of us the things of true value, at least some of the things we would not wish to lose, are family, friends, and fellowship with people in some form of service. And is not

that fulfilling part of our Lord's great commandment, to love our neighbors as ourselves, not in selfish love of self, but remembering that only as we want, know, and possess the best can we give it to others?

And the consummation of all effort would be the giving of ourselves in obedience to that other great commandment, "Thou shalt love the Lord thy God with all thy heart, with all thy soul, and with all thy mind," knowing Him in love, in worship and knowledge of His will for us, in order that we may be useful members of His Church, and help in the building of His Kingdom on earth.

## ANNUAL REPORT OF THE SECRETARY

---

It is now eighteen months since our last Annual Meeting in May, 1931, and during that time the interest in the Auxiliary has not lapsed and the work has progressed satisfactorily. Four executive board meetings have been held this year and have been faithfully attended by the board members.

In each of the Convocations, meetings were held in the Spring with a very representative attendance. The Rev. Henry M. Hyde was the speaker at these in behalf of the Whitsunday Offering, and talks were given by a Sister of the Transfiguration.

Three educational institutes were held in the Fall, throughout the Diocese.

Splendid work has been done in the Cincinnati Convocation under Miss Tuite. In addition to the Convocation Meeting and the Educational Institute already mentioned, she has held meetings of the branch presidents where problems could be discussed and helpful plans made. In reply to an appeal from Mrs. Wade extra work was undertaken and a generous box was sent to Pine Ridge Mission in Nebraska. The educational department has met with fine co-operation here and inter-parish meetings have been held with illustrated talks on the missions for which the Auxiliary was working.

In the Columbus Convocation, Miss Anderson has established lending libraries in several of the more remote parishes and has secured good attendance at the convocation meeting at St. James, Zanesville, and at the educational institute at St. Stephens, Columbus. She also arranged three talks by Deaconess Williams at different parishes in this convocation.

In the Dayton Convocation, Mrs. Sandoe encouraged the attendance at the convocation meeting at St. Paul's, Oakwood, Dayton, and at the educational institute at Heavenly Rest, Springfield.

Deaconess Williams, of Dante, Va., a U. T. O. missionary, gave a series of very interesting talks in various parishes early in October. She spoke at Trinity, Columbus, at Chillicothe, at Newark, at Christ Church, Dayton, at Glendale and at Calvary, Clifton, in Cincinnati.

The work of the various departments of the Diocesan Auxiliary will be reported separately by the respective secretaries.

The educational department, under Miss MacCracken, has been very efficient. In addition to her institutes this fall, she has encouraged reading and study throughout the diocese, either through the Diocesan Lending Library or through New York. Many books have been sold in the various parishes.

Mrs. Bone reports a total of \$5,000 for the Spring U. T. O., encouraging results for these times. The Fall offering amounted to \$3,908.04, plus a little interest.

The records of the Supply Department will not be available until all the work is reported in December. The amount stands \$3,806.64 at present. Due to the low prices and the careful buying of Mrs. Laird the quantity of clothing and supplies sent is very creditable. The total for the year is \$6,324.59.

Four from our diocese, Miss McCune, Miss Matthews, Miss Johnston and Mrs. McGregor, attended the conference at Brent House, Chicago, on April 12th to 14th, and Miss McCune, Miss Matthews, Miss Johnston, Mrs. Bone and Miss Kelton went to Cleveland on October 18th to 20th as delegates to the Provincial Synod of the Woman's Auxiliary of the Fifth Province.

During the year the Executive Board has granted two scholarships from the Memorial Scholarship Fund; one for \$300 to Miss Carrie Fleming, of Columbus, for the completion of her undergraduate work at O. S. U. preparatory to studying for church work, and one to Miss Emily Aldrich, of Springfield, for \$700, beginning September 1, 1932. She is now studying at Columbia University and is living at Windham House.

Miss McCune sent out letters to all the parishes urging that a day of prayer be held for the special Whitsunday Offering. She also sent out petitions for disarmament at the request of Miss Lindley. She sent letters to the presidents urging co-operation in arousing interest in the Good Friday Offering. Our President and Miss Matthews made a survey of the missionary work in the diocese, during the summer. This survey covers the field of religious education in college work and the missionary work in suburban, rural and industrial centers and institutional social service work in the diocese. It has been sent to Bishop Crayton as part of the survey to be made of the missionary work in each diocese.

Two new branches of the Auxiliary have been formed in Cincinnati—the Sisterhood of the Transfiguration in Glendale and St. Simon of Cyrene, a colored mission near Lockland. St. John's, Columbus, has reorganized and is doing good work.

The president, together with other officers or alone, has made many visits throughout the diocese.

In closing this report we wish to extend to every branch our thanks for co-operating so splendidly with the executive board at all times and to bespeak the same loyal support for the incoming board.

## REPORT OF THE EDUCATIONAL WORK FOR 1932

---

Trying to evaluate Educational work is a little like trying to square the circle, but we can always make the attempt.

Reports from 47 Parishes finds 44 Parishes doing some definite work along educational lines.

An intensive day in each Convocation for the Educational Secretaries and others was conducted by your Educational Secretary. These were at Heavenly Rest, Springfield, on October 25th; at St. Stephen's, Columbus, on October 27th, and Trinity, Hartwell, on November 2nd, with a total attendance of 92 women. This represented, however, only 23 Parishes in the Diocese.

In evaluating our work we must not neglect to point out the weak spots, in order that we may remedy them, and I consider this representation of only about a third of the Parishes in the Diocese one of the weak spots of the Educational work.

Days and weeks have gone into the preparation for these days in the hope that each woman attending may find something of help and inspiration to carry back to her Parish. For the sake of the future of this work I appeal to the Parishes to make a point of sending two or three women to these days of training and conference, which come only once a year. A very hopeful sign for the future is the number of Parishes which are making definite programs for the women of the Church and in some cases for the Parish.

This planning beforehand is most necessary, for "No amount of consecration can make up for the wastefulness of unplanned work." The real work is of course done in the Parishes and many of the Educational Secretaries are doing very fine work.

The use of the lending library, which has increased from 35 books issued to 75 in the past year, is an indication of interest and real work on the part of Parish Educational Secretaries.

---

For the privilege of serving as your Educational Secretary for the past three years I am truly grateful. It has meant much more to me than I can express.

The co-operation and sympathy of the members of the Board has been a great help, and especially am I grateful to our President, not only for asking me to serve, but for her unfailing encouragement and sympathy.

As you know, probably, the subjects suggested for our study, for a part at least of our program for the coming year are, China and the American Indian. They are both timely and both tremendously interesting.

For China, in the great change from the customs and government of hundreds of years to modern customs and a democracy, there is need as never before of our understanding, our help, and our prayers.

The American Indian has always a claim upon us, and in taking this race for a subject of study we must put before us as a goal the understanding of the psychology of the Indians and an appreciation of his culture, and the finding of what our ideal may be for the future of the Indian child as he becomes a part of our civilization and becomes a citizen instead of a ward of the government.

We must not forget the book called the "Kingdoms of Our Lord," which contains the addresses before the Woman's Auxiliary at Denver, and the findings from those addresses. These should have some particular place in our year's work; they are too valuable not to have consideration and discussion, presenting as they do much of the best thought of our time.

For the future of the Educational work I would add just one word: that of hope and ideals to be attained, "Ideals long dwelt on become prayers, and prayers wrought in faith come true."

## MINUTES OF THE ANNUAL MEETING

---

The Fifty-sixth Annual Meeting of the Woman's Auxiliary of Southern Ohio was held at St. James', Piqua, on Tuesday and Wednesday, November 15th and 16th. At the service of Holy Communion on Tuesday at 11 o'clock, Bishop Henry Wise Hobson was the celebrant, Rev. Maxfield Dowell read the Epistle, and Rev. Upton Thomas the Gospel, Rev. Howard Ackerman assisting.

Bishop Boyd Vincent preached the sermon, taking for his text the 23rd verse of the 10th Chapter of St. Luke, "Blessed are the eyes which see the things which ye see." One hundred and seventy-five present made their communion. The offering amounted to \$92.37.

Luncheon was served to 169 guests and at 2 o'clock the business meeting was opened in St. James' Church by the president, with the Creed and prayers. After the roll call by the secretary, Miss McCabe, president of the Woman's Auxiliary of St. James', extended a gracious welcome, which was responded to by the chair.

The president announced the credentials committee as follows: Chairman, Mrs. George Kauffman, Trinity, Columbus; Mrs. Turner, Ascension, Middletown; and Mrs. Shell, Grace Church, Avondale.

The secretary's report followed and was accepted as read.

The chair appointed a resolutions committee to report back the early part of Wednesday afternoon, all resolutions to be in writing. Chairman, Miss Judith B. Colston, Christ Church, Cincinnati; Mrs. Henry M. Hyde, All Saints, Portsmouth; Mrs. Charles Bergen, Sr., Christ Church, Dayton.

The Committee on Nominations appointed by the chair follows: Chairman, Mrs. O. D. Steils, Trinity, Troy; Mrs. Paul Tindall, St. Mark's, Oakley; and Mrs. Theodore Glenn, St. Paul's, Columbus.

Committee on Elections, Chairman, Miss Eva Cleveland, Glendale; Mrs. Stanley Brehm, St. Paul's, Oakwood, Dayton; and Mrs. Henry Lewis, St. Philip's, Circleville.

Tellers for the Cincinnati Convocation, Miss Gertrude Cist, Grace Church, College Hill, and Mrs. Thomas Guess, Holy Trinity, Madisonville.

Tellers for the Columbus Convocation, Mrs. H. B. Cohen, St. Stephen's, Columbus, and Mrs. C. R. Christman, St. James, Zanesville.

Tellers for the Dayton Convocation, Miss Margaret Farrar, Trinity, London, and Mrs. Frederick Fischer, Heavenly Rest, Springfield.

The Chair read Article 7, Section 1, of the constitution governing the election of a president; nominations as far as possible to be in the hands of Mrs. Steil by 6 P. M. on Tuesday. A president and vice-presidents are to be nominated.

Miss Kelton read the Treasurer's report, showing a balance of \$661.80 in the central expense. She has turned over to Bishop Hobson \$861.89 for the Woman's Auxiliary Fund for the Bishop. She gave an interesting and encouraging comparison of this year's central expense and last year's, and made a plea for the prompt return of next year's pledge cards to help the new board. Upon the motion of Miss Smith, Wilmington, seconded by Miss Colston and carried, the treasurer's report was ordered received and filed.

The President's address followed, urging us to make our Christian lives effective by earnest work in every field of activity.

Miss Mary Johnston, our representative on the National Board, who has recently been elected Secretary of the Board, spoke of Mrs. Harper Sibley's report on the Layman's Missionary Inquiry, a committee, 35 in all, made up of seven denominations who spent nine months in India, Burma, China and Japan.

Miss Matthews spoke of the Good Friday Offering. She stressed its purpose and urged publicity for it so that offerings may be taken up each year to support this work and increase the interest in it.

Miss Matthews introduced Miss Martha Chow, of Korea, who spoke on the foreign student in America. She said the number of Oriental women coming to this country is increasing. She contrasted the relationship in Oriental and Occidental homes and made a plea for better understanding through the opening of American homes to these Oriental students. Brent House, in Chicago, is a haven for them.

Bishop Hobson announced the address by Bishop Perry, the Presiding Bishop, at Christ Church, Cincinnati, on Monday, November 21st, and Donation Day at the Children's Hospital, on Thursday, November 17th. After the meeting tea was served in the Parish House.

At 8 P. M., Mr. James Thayer Addison spoke to the delegates on China. He said China is undergoing five revolutions—political, economic, social, religious and educational. Only one-tenth of the people are now involved, but in a generation this tenth will have leavened the whole.

After the meeting a delightful reception was held at the home of Mr. and Mrs. Leo Flesh.

At the service of Holy Communion on Wednesday at 7:30, Mr. Maxfield Dowell was the celebrant, Mr. Phil Porter read the Epistle and Mr. Frederick Fischer the Gospel; sixty-five present made their communion. The collection amounted to \$21.10. Breakfast was served in the Parish House.

After the Officers' Conferences at 9:15, the business session was opened at 10 o'clock by the President with the Creed and prayers.

The Committee on Credentials reported 99 delegates and 14 visitors, from 39 parishes.

Cincinnati.....29 delegates, 14 visitors, 13 parishes.

Columbus.....29 delegates, 4 visitors, 11 parishes.

Dayton.....41 delegates, 36 visitors, 15 parishes.

Miss Morrison moved, Miss Matthews seconded and it was passed, that the offerings be given to the Auxiliary Fund for Bishop Hobson.

Mrs. Steil, as Chairman of the Nominating Committee, reported the following nominations: Mrs. Baggott, Christ Church, Dayton; Mrs. Harley Morrison, Calvary, Clifton; and Mrs. Wylie Mitchell, Ascension, Middletown, for President.

For Vice-President: Cincinnati—Mrs. Mark Mitchell, St. Luke's; Mrs. A. W. Shell, Grace Church, Avondale; Miss Eva Cleveland, Glendale; Mrs. J. Herron, Madisonville; and Miss Eshelby, Christ Church, Cincinnati. Columbus—Mrs. Hugh Bone, St. Alban's; Mrs. George Kauffman, Trinity, Columbus; Mrs. F. M. Carpenter, St. Alban's; Miss Louise Kelton, Trinity, Columbus. Dayton—Mrs. Lawrence Laybourne, Christ Church, Springfield; Mrs. Wylie Mitchell, Ascension, Middletown; and Miss Laura MacCracken, Urbana.

The President called for nominations from the floor. Nominations were declared closed.

Mrs. Bone reported a Spring U. T. O. of \$5,000.00. So far the Fall Offering totals \$2,107.86 from 34 parishes. She has sent out a larger number of envelopes and mite boxes than ever before. Deaconess William's visits throughout the diocese were a great inspiration.

Mrs. Farrar read the report of the Educational Secretary, in the absence of Miss McCracken. She told of the institutes held during October at St. Stephen's, Columbus, on October 27th; at Heavenly Rest, Springfield, October 25th; and at Trinity, Hartwell, on November 2nd. She felt disappointed that more parishes had not been represented at these institutes. She spoke of the increase in the use of the lending library. The subjects for study next year are China and the American Indian. She also urged a study of the addresses and findings before the Woman's Auxiliary at Denver.

Mrs. Laird reported for the Supply Department that most of the Spring work was sent to St. John the Baptist Mission in Flat Rock, North Carolina, and to St. Andrew's Hospital, Wusih, China, valued at \$911.74 and \$1,115.67. Christ Church, Cincinnati, took St. Andrew's Mission, Pine Bluff, Arkansas, amounting to \$641.00. The Cincinnati Convocation took an extra box for Pine Ridge Mission, Nebraska, valued at \$230.00. The total for this year so far is \$3,806.64. The Fall work is six personal boxes and twelve Christmas boxes, All Saints' Mission, Virgin Islands and Epiphany Mission, Spartanburg, South Carolina. Christ Church, Cincinnati, has taken the Crow Creek Mission as

their work. Mrs. Laird closed with a plea that the parishes send in their work as promptly as possible this Fall.

Bishop Hobson spoke on the Diocese. He said one of the opportunities of the times was a sifting of the work. There is unprecedented unemployment among the clergy and a minimum of help available for them. The Auxiliary Fund for the Bishop and the Discretionary Fund have helped in Southern Ohio. He spoke of the budget. We are facing a deficit of \$5,000.00 and he is reluctant to fail in any obligation to the National Church.

The parishes next voted by roll call. Miss Cleveland brought in the following report for the elections committee: Number of votes cast, 29; necessary for election, over one-half, 15, of which Mrs. Baggott received 27 and Mrs. Wylie Mitchell, 2.

The chair announced Mrs. R. L. Baggott elected as President for the ensuing three years, to take office January 1st. Mrs. Baggott made a short speech of acceptance. Miss Matthews, Miss Morrison and Miss McCune, as former presidents, all offered her their congratulations and co-operation.

Bishop Hobson read Noonday Prayers.

Meetings of the convocations were held for the election of Vice-Presidents.

Luncheon was held at 12:30.

At the afternoon meeting at 2 o'clock, the chair announced the following elections for Vice-President: Cincinnati, Mrs. Mark Mitchell, St. Luke's; Columbus, Miss Louise Kelton, Trinity; Dayton, Mrs. Wylie Mitchell, Middletown.

Miss Colston, as chairman, presented the following resolutions and moved their acceptance. Mrs. Sawyer moved, Miss Johnston seconded, that the resolutions be acted on separately. They were accepted.

#### RESOLUTIONS.

1. *Resolved*, That this Annual Meeting of the Diocesan Woman's Auxiliary express to the women and the parish and the rector of St. James' Church, Piqua, their warm appreciation of their gracious hospitality and the pleasure which it gave them to be their guests.

2. *Resolved*, That this meeting express to our Bishop, to the Rector of this parish, to the choir and organist, as well as to all the clergy who officiated at the services, their appreciation and thanks.

3. *Resolved*, That this meeting express their appreciation and thanks to the speakers, Miss. Martha Chow and the Rev. James Thayer Addison, for their interesting and illuminating addresses on the subject of missions and the Orient.

4. *Resolved*, That this Annual Meeting express to Bishop Vincent their gratitude and affection and their sense of privilege

which has been theirs to have had him as their preacher at their Corporate Communion on November 16th.

5. *Resolved*, That this meeting express to the President and Diocesan Board of the Woman's Auxiliary their appreciation of what they have done for the whole Auxiliary during their three years of office and to assure them of the affection and regret with which we take (temporary) leave of them.

6. *Resolved*, That this meeting send a message of greeting to Mrs. Allan McGregor, expressing their regret at her absence, but also their thankfulness that she, together with Miss Elizabeth Matthews, had been preserved from such great danger; that this meeting also send a message of affectionate greeting to Mrs. Theodore Irving Reese, and that they also send a message to the Educational Secretary, Miss MacCracken, expressing their regret that she has been prevented by illness from being present at this meeting.

7. *Resolved*, That the Woman's Auxiliary at this meeting express to the ladies of the First Presbyterian Church of Piqua their appreciation and thanks for their gracious hospitality and for the delicious luncheons they provided, and also to express to Mr. and Mrs. Leo Flesch their appreciation and thanks for their kindness in opening their home to the Auxiliary and giving them the great treat of seeing their collection.

8. *Finally, be it Resolved*, That the annual meeting of the Woman's Auxiliary of the Diocese of Southern Ohio renew for the ensuing year (1933-1934) their pledge of at least \$500 to Bishop Hobson for his Discretionary Fund.

The Secretary read the minutes of the meeting, which were accepted with corrections. Miss McCune pronounced the benediction and announced the adjournment of the Fifty-sixth Annual Meeting of the Woman's Auxiliary of Southern Ohio.

## CONSTITUTION AND BY-LAWS

---

### CONSTITUTION

---

#### ARTICLE I

##### **Name**

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

#### ARTICLE II

##### **Object**

The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

#### ARTICLE III

##### **Membership**

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

#### ARTICLE IV

##### **Officers**

The officers of this Association shall be the Bishop, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

#### ARTICLE V

##### **Duties**

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

SECTION 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

SECTION 3. The President shall be elected at an Annual Meeting held at least one year after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice-Presidents, to serve for three years. She shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

SECTION 4. Each Vice-President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her own Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice-Presidents or by the President. A Vice-President, with the approval of the President, may appoint any other Convocation officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

SECTION 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

SECTION 6. The Secretary of Supply Department shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

SECTION 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

SECTION 8. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

SECTION 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

SECTION 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request.

## ARTICLE VI

### **Meetings**

SECTION 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every Mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates, may vote on all questions before the house.

SECTION 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

SECTION 3. Convocation meetings shall be held on the call of the Convocation Officers.

SECTION 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

## ARTICLE VII

### **Mode of Election**

SECTION 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

SECTION 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

## ARTICLE VIII

### **Amendments**

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

## BY-LAWS

---

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expenses of officers and speakers, necessary expenses of the Educational Department, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

## FINANCIAL POLICY

### I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members, and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

### II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
  - (a) By urging an every-member canvass and assisting in carrying it out.
  - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
  - (c) By giving when necessary as an organization.

### III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner:
  - (a) There shall be fourteen classes paying as follows:

A—\$75.00	H—\$20.00
B— 60.00	I— 15.00
C— 50.00	K— 10.00
D— 40.00	L— 7.50
E— 35.00	M— 5.00
F— 30.00	N— 3.00
G— 25.00	O— 1.00
  - (b) Each branch shall decide to which class it will belong.
  - (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
  - (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
  - (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
  - (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

### IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
