## PRESIDENT'S ADDRESS

---

An old legend pictures Christ in Heaven. An Angel asks Him: "How many citizens hast Thou made?" "About six score," was the reply. The Angel said, "With this paltry number how canst Thou hope to conquer the world? Suppose they prove false and disobedient? What other provision hast Thou made?" "I have made no other provision," was the calm reply, "I am depending upon them." It is this faith which the Church is placing in her members.

The first obligation facing each parish is the Every Member Canvas, a project in which we are all vitally interested.

You will recall that General Convention adopted a new plan whereby mathematical quotas were abandoned and each diocese named the sum they felt could be paid to the National Council. This places upon each diocese an even greater responsibility than heretofore for the support of the Missionary program and does call for the interest and loyalty of every communicant.

The National Council proposes to each parish as the guide for its corporate effort and to every church member as the rule for his personal endeavor, this three-fold program

First, In terms of Christian Discipleship. The adoption and the realization of the aims of the Forward Movement; recognizing that, at the bottom of all the weakness in our organized Christianity is the feebleness of our apprehension of Christ the Saviour and the limitations of our acceptance of the demands He makes upon us.

Second, In terms of Christian Stewardship. The application and the prosecution of the annual "Every Member Canvas" not as a mere financial campaign, but as an annual event in a sustained program of education in Christian living and Christian Missions.

Third, In terms of Christian Partnership. A resolution to share whatever increase of life and wealth the new day brings. The sincere practice of this simple rule by individuals, parishes, and dioceses would work a miracle for us and do as much as anything to banish all necessity for quotas and apportionments and lead us into the joy and satisfaction of a great partnership of recovery.

Our Church papers have been giving us a great deal of interesting information about Bishop Kemper, that stalwart pioneer missionary whose Centennial is being celebrated this year. When we read of the hardships he endured, the sacrifices he made, the difficulties he overcame and the results he obtained, it brings us to a realization of what could be accomplished for the Church in the present day, if

the same spirit were manifest. It is to the vision and consecrated lives of such men as Bishop Kemper that we owe our beautiful Churches. The interest in Missions must not be permitted to lag or grow cold ; it is a responsibility of the Woman's Auxiliary "to carry out by united and systematic effort the three great aims of the Church, namely : Missions, Religious Education, and Christian Social Service, in the five fields of service : parish, community, diocese, nation and world."

I quote from an address by Bishop Cook at the recent meeting of the National Council. "A parish could not long exist without the diocese. Its life and well-being depends upon its union with the diocese in loyal devotion to work and interests of the diocese.

"In precisely the same way the very life and well-being of every diocese depends upon its loyal devotion to the work and interests of the whole Church."

It is not necessary to call your attention to world conditions today — you are all aware of them ; therefore, careful preparation should be made for the Quiet Day for Prayer which is to be observed throughout the world on Armistice Day, Monday, November 11, following the same plan as last year. The organization of the world seems to be without Christ, so that not only this day but every day our prayers should ascend to Almighty God for a better understanding between nations and peoples, that we may live peaceably as good neighbors.

Some months ago one of our Church periodicals was sued and a judgment for more than \$10,000 was obtained ; the case went to the Court of Appeals and if the judgment is sustained, the periodical may be compelled to suspend publication. The suit grew out of a campaign of the paper against indecent Motion Pictures. Just a few days ago Dr. Sidney Goldstein, Chairman of the Social Justice Commission of the Central Conference of American Rabbis, announced that Jews have already subscribed a sufficient sum with which to discharge the judgment. What godliness is thus made manifest and should inspire our unending gratitude.

Again, a Catholic church in western Michigan burned to the ground a short time ago ; the use of the Episcopal church was offered to them free of charge, until such time as their building could be replaced. They are holding two masses every Sunday morning, and a benediction service in the evening. Truly this is the way our Lord intended we should live. We are all children of the same Father and the same God is Father to us all.

We have the pleasure to report a new branch of the Woman's Auxiliary at St. Barnabas Mission, Cincinnati, under the direction of Miss Eleanor Gifford. They have undertaken an allotment from the supply department and have also sent a generous gift to the United Thank Offering.

Miss Elizabeth Lucas of Trinity Church, Columbus, was the recipient of the Memorial Scholarship Fund last year and has accepted a position as a United Thank Offering Worker at Laramie, Wyoming, to do religious educational work with the students of the University of Wyoming, also to do some teaching in a Girls' Preparatory School. We are justly proud of the girls who have gone on in church work by reason of the assistance we have been able to offer them from this fund.

In reviewing the work of the various departments for the past three years, perhaps we cannot report an increase as far as money value is concerned, but it does represent a greater sacrifice and devotion on the part of the parishes, to meet the requests made of them. These difficult years have been a true test of faith. The members of the Executive Board wish to express their deep and sincere appreciation for the generous and faithful manner in which you have responded. The knowledge that we had your confidence and co-operation has helped immeasurably to lighten our responsibilities. The next President and her Board will, I am sure, be accorded the same splendid consideration.

I cannot close without paying tribute to the members of my Board. Their helpful advice, loyalty to duty, and whole-hearted co-operation have been an inspiration. I am deeply grateful for the privilege of these pleasant associations. We have been a happy family.

May I convey to you my sincerest appreciation for the opportunity and joy of serving you for three years; you have all been so generous and kind and have given to me far more than I have been able to give to you. The friendly visits to your parish meetings, your cordial greetings, have been delightful, and the friendships made are priceless. God bless you every one.

## ANNUAL REPORT OF THE SECRETARY

---

In a general review of the year 1935 we wish to report that the Woman's Auxiliary of Southern Ohio has striven to complete every obligation and to advance in full measure all branches of our church's program.

A luncheon meeting for Presidents and Supply Secretaries of the Cincinnati Convocation was held on January 16 at the Church of the Redeemer, with Mrs. Flesh giving an interesting survey of the work and scope of the Supply Department.

The Mid-Lent meeting was held on the evening of March 8th at Christ Church. Miss Elizabeth Matthews, as a member of the National Council, gave a report of its work. A discussion, by the Rev. Frank Moore, of several books worthwhile for Lenten reading was followed by the introduction of the Rev. David Covell, newly chosen Executive Secretary of the diocese. Mrs. Worman spoke for the United Thank Offering, asking that the different branches keep their Offering up to the high standard attained before the Triennial Meeting.

A branch of the Auxiliary was formed at St. Barnabas Mission with Miss Eleanor Gifford as president. Wishing to express themselves immediately in terms of service, the new members requested an assignment from Mrs. Flesh—have given to the Central Expense fund—and also contributed to the United Thank Offering.

In Wyoming, the younger group of church workers have joined the Auxiliary and will make a strong branch.

The acting Vice-President, Mrs. Walter Tangeman, was invited to visit several parishes and tell of the inspirational "Conference of Church Workers" which she attended at Brent House.

Mrs. Herron, Grace Church, College Hill; Mrs. Morrison, Calvary, Clifton, and Mrs. Appleton of Grace Church, Avondale, were appointed as the Nominating Committee for the election of the Vice-President of the Convocation, to be held at the time of the next Annual Meeting.

There was a fine spirit of fellowship and interest in a series of three group meetings, arranged by Miss Kelton, in different parts of the Columbus Convocation, at which Mrs. Baggott and Mrs. Worman were speakers. These meetings were held as follows:

March 14th, Trinity Church, Columbus—9 branches represented with 48 present.

April 5th, Church of the Good Shepherd, Athens—4 branches with 26 present.

April 10th, St. Paul's, Chillicothe—3 branches with 36 present.

Miss Louise McCune of Trinity, Columbus; Mrs. M. E. Laird, St. Paul's, Columbus, and Miss Mary Anderson, St. Paul's, Chillicothe, were appointed as the Nominating Committee for the election of the Vice-President of the Columbus Convocation.

Mrs. Baggott and Miss Elizabeth Matthews went to St. John's, Cambridge, on March 7th, met with the women of the Parish and organized a branch of the Woman's Auxiliary, electing officers and leaving them with a tentative program of work.

At an Officer's Conference of the Dayton Convocation, held in the Spring by Mrs. Wylie Mitchell at Christ Church, Dayton, 35 members heard Miss Mary Johnston describe the work being done in the Children's Hospital.

Later they joined the members of the local Auxiliary for luncheon —at which time Miss Johnston explained the "Forward Movement."

Mrs. Ralph Fehr, Christ Church, Dayton; Miss Laura MacCracken, Epiphany, Urbana, and Mrs. Harry Gram, Christ Church, Springfield, were selected as the Nominating Committee for the election of the Vice-President of the Dayton Convocation.

On May 7-8-9-10 Convocation Meetings were held in Xenia, Glendale, Lancaster and Marietta, respectively, with Deaconess Fracker, United Thank Offering worker in Nevada, under Bishop Jenkins; Miss Olive Meacham, principal of the Julia C. Emery School for Girls in Liberia, and the Rev. David R. Covell as the speakers.

Mrs. Baggott and Miss Anderson were our delegates for the Gambier Summer Conference.

April 28th and October 6th were the days designated to receive the United Thank Offering.

Our study for this year is Latin America and the book "That Other America."

Miss Mary Van Loan, Christ Church, Dayton, was appointed by Mrs. Baggott to complete the term of Miss Bertha Buvinger, as Custodian of the Book of Remembrance.

Mrs. Baggott, Miss Anderson, Mrs. Otis J. Story, St. Paul's, Chillicothe; Mrs. Stanley Allen, Christ Church, Glendale, and Mrs. Walter Tangeman, Church of the Redeemer, Hyde Park, were present at the Conference of Church Workers held for the women of the Fifth Province at Brent House in May.

A signal honor was accorded our Educational Secretary, Miss Mary Anderson, with the invitation to lead the Educational Conference of the Provincial Meeting held this October in Rock Island, Illinois.

The unfinished business of last year is the proposed Amendment by Miss Elizabeth Matthews in the Constitution to read as follows:

In Article 5, Section 3, after the words "to serve for three years," insert "but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers, but immediately at the close of the General Triennial Meeting, to serve throughout the Triennium."

Then change "she" to "The President" at beginning of the following sentence, so as to read "The President shall also appoint a Custodian of the Book of Remembrance."

A copy of the following Resolutions from the Diocese of Southern Ohio was sent to the National Executive Board:

"WHEREAS, the Supply Department is such a necessity to the existence of the Mission Work in the Field, especially in these days of cut budgets, and

WHEREAS, it is such a factor in starting new branches of the Auxiliary and keeping them interested by giving them something concrete to do, and

WHEREAS, in the past Triennial, 1934, the value of the help through this department to the Mission Field amounted to \$617,000,

*Be It Resolved*, That the National Executive Board be asked to give it a part in the program of the next Triennial Meeting."

We now have 74 branches of the Woman's Auxiliary in the Diocese of Southern Ohio.

This 59th year brings to a close the work of your Executive Board for the past three years. They have held 11 meetings.

It has been a privilege to serve you—much has had to be done—accomplished only through the encouragement, at all times, of the women of our Auxiliary.

Let us remember these lines from our own Bishop Theodore Irving Reese:

"O Master of the hearts of men—make us Thy instruments in the redemption of the world—and in drawing all men unto Thee."

The above total of \$6,232.15 for the spring and fall allotments of 1935 compares with a total of \$6025.38 for the year 1934, a gain of only \$207.57. However, in considering this slight gain, several facts should be borne in mind; first, this total shows a substantial increase from our low point of \$4980.03 in 1933; second, and more important, is the fact that this slight gain definitely does not represent any actual falling off on our part, for we have met in full and without any plea for reduction the entire allotments sent us. Finally, in comparing this total to that of 1934, please bear in mind that the 1934 figure was augmented by a special gift of \$300.00 from the Central Expense Fund.

With these facts before you, you can see that, after all, our results this year actually constitute a substantial increase, so far as the individual efforts of our various Auxiliaries are concerned. To those of you whose efforts have made this result possible, I extend my heartfelt thanks. It is most gratifying to relinquish office with an appreciation of this cooperation which I have enjoyed.

## REPORT OF EDUCATIONAL WORK FOR 1935

---

During the second week of November three Educational Institutes were held in the Diocese; one at St. Johns, Worthington, Tuesday, November 12th, another at Christ Church, Dayton, on Wednesday, November 13th, and the last at the Church of the Advent, Cincinnati, Thursday, November 14th.

The missionary theme for the year is Latin America, and since the twenty nations that compose this great continent are among our nearest neighbors, it is a topic of great timeliness. Great political changes are taking place there, a renaissance of art and music is spreading through many of its nations, a new interest in religion is being shown, so that from many angles these countries challenge our interest and our need to know and understand their problems.

A fine amount of material for study and program building is available in the Lending Library now at the Diocesan House at 223 West 7th St., Cincinnati.

It was the privilege of your educational secretary to attend the Conference held last May at Brent House, Chicago. Not only did the delegates have intimate glimpses of the splendid work being done by Mrs. Biller with the Oriental students, but the Conference followed up the problems presented at General Convention and outlined in the pamphlet, "If We Be His Disciples." Miss Lindley, Miss Marsden and Mrs. Wade led interesting discussion groups, and Mrs. Biller contributed some viewpoints of her Oriental students. The evening's discussion by Dr. Block on the Forward Movement was one long to be remembered.

On October 15th the educational secretary attended the Provincial Meeting at Rock Island, Illinois, and led there the discussion of the Educational Work. In July, she attended the Summer Conference at Gambier. She urges again the greater use of this great source of training and inspiration that is available for our Young People, for Church School teachers, and for all the women of the Church.

## MINUTES OF THE ANNUAL MEETING FOR 1935

The Fifty-Ninth Annual Meeting of the Woman's Auxiliary of Southern Ohio held October 23rd and 24th, 1935, at Christ Church, Cincinnati, was opened at 11:00 o'clock, with a Service of Holy Communion.

The Rt. Rev. Henry Wise Hobson, D. D., was the celebrant, with the Rt. Rev. Norman S. Binsted, D. D., the Rev. Frank H. Nelson, D. D., and the Rev. David Covell assisting.

Two hundred and eighty-five made their communion.

Bishop Hobson announced as his text the thirty-first verse of the fortieth chapter of Isaiah: "But they that wait upon the Lord shall renew their strength; they shall mount up with wings as eagles; they shall run, and not be weary; and they shall walk, and not faint."

The offering at this service was \$84.17.

Luncheon was served to 300 guests in the Parish House, and at two o'clock the business session was opened by Mrs. Baggott, with prayers.

Mrs. Samuel Moyer welcomed the Convention in behalf of Christ Church and Mrs. Baggott responded.

After the roll call by the Secretary, the president announced the Credentials Committee, as follows:

The Chair read Article 7, Section 1, of the Constitution, governing the election of a president; nominations to be given to Mrs. Moyer by 6:00 P. M. on Wednesday.

Seeing that our Constitution has no provision for the election of Vice-President, a resolution was presented from the Executive Board, governing the election of the three Vice-Presidents, to take place the next morning. Notice of this had been previously given to the parishes.

Miss Kelton presented this resolution, and moved its adoption; it was seconded and carried.

The next item of business was action on the amendment to the Constitution as recommended by Miss Elizabeth Matthews at the last Annual Meeting in May, 1934, Christ Church, Dayton, and now presented by the Executive Board to read as follows:

In Article 5, Section 3, after the words "to serve for three years," insert "but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers, but immediately at the close of the General Triennial Meeting, to serve throughout the Triennium."

Then change "she" to "The President" at beginning of the following sentence, so as to read—"The President shall also appoint a Custodian of the Book of Remembrance."

Miss Matthews, by virtue of her position as a member of the National Council, was given the courtesy of the floor, and moved the adoption of this Amendment. It was seconded by Mrs. Worman and carried.

Mrs. Snediker, the Diocesan Treasurer, showed for the past ten months the following balances, copies of which were given to the delegates and visitors:

It was moved, seconded and carried that the Treasurer's Report be received and filed.

Mrs. Baggott, in her address, asked that our prayers should be for a better understanding between nations and peoples—that we may live peaceably together as good neighbors.

The Rt. Rev. Norman Binsted, D. D., from the Diocese of Tohoku, Japan, gave a fine description of the life and ideals of these people and said the Church of Japan of today moves on triumphantly because of the prayers and aid of the Woman's Auxiliary.

This completed the business for this session and upon motion the meeting adjourned.

At the finish of this very busy day, delegates and visitors were invited to the Parish House for a most pleasant social hour and tea as guests of Christ Church, Church of Our Saviour, Mt. Auburn and Holy Trinity, Madisonville, branches of the Auxiliary.

The Mass meeting in the evening was addressed by the Rev. Arthur Sherman, D. D., a member of the Staff of the Forward Movement Commission. He gave a detailed account of this work and urged an adequate program of education for each parish in its preparation.

The Jubilee Singers of the American Church Institute, under the direction of Dr. Patton and Mr. Blanton, sang most feelingly the spirituals of their race, so endeared to all.

A Celebration of the Holy Communion was held on Thursday morning at 7:30 o'clock.

The Rev. Meredith Wood, assisted by the Rev. Howard Melish, was celebrant. Thirty-six made their communion. The collection was \$12.40.

The business session at 9:30 o'clock was opened by Mrs. Baggott with prayers.

The Chair asked for nominations from the floor; nominations were declared closed and the ballot was cast.

Mrs. Worman reported, from a general survey of giving to the United Thank Offering, it was found the per capita gift ranges from 15 cents to \$2.61—with our own Diocese giving the full amount of \$2.61.

Mrs. Moyer, as Chairman, now reported the number of votes cast in the election as 39.

Miss Elizabeth Matthews received 35 and Miss Susie Tuite 4.

Miss Matthews was declared elected.

The Convention rose to receive the new President, who spoke most earnestly of the work she hoped might be accomplished during her term of office.

Miss Mary Anderson, the Educational Secretary, stressed the use of the Lending Library and told of the interesting material to be found in our studies for this year.

She will conduct Educational Institutes on November 12, 13, 14 in St. John's, Worthington; Christ Church, Dayton, and Church of the Advent, Walnut Hills, respectively.

The Supply Secretary, Mrs. Flesh, reported the total amount of the Spring Assignment, which is one-half of the year's work, amounted to \$3294.50.

She called special attention to the fact that the high duty in foreign countries will necessitate an increase in the amount of money rather than boxes as formerly sent.

Miss Kelton presented the resolution from the Executive Board, regarding election of Vice-President, as read on Wednesday to the Convention and asked that it be made an Amendment to the Constitution.

Miss Mary Johnston of the National Executive Board reported its action regarding Woman's work in the Church:

*"Be it Resolved:* That the National Executive Board recognize as Church Work (provided the worker herself accept it as such) any form of work that is done as an expression of a woman's religion, and we quote the Massachusetts Platform for Woman's Work in the Church:

I. Local Parish maintenance, which is not an end in itself but a means for building up a fellowship in Christ in order that the Church may complete her Mission.

II. Work which reaches outside the parish and which is undertaken and directed by the Church in the Community, diocese and world as a missionary responsibility.

III. Work in welfare and other enterprises not under the auspices of the Church, but undertaken by members of the parish in places where service is a fulfillment of Christ's mission.

Miss Owen, new Executive Secretary of the Church Mission of Help, explained its purpose and how it works in conjunction with the Church; that each girl shall be helped to a better understanding of herself and her problems, and the building up of self-respect.

Sister Olivia spoke for St. Simons of Cyrene, Lockland, telling of the establishment of their Young People's Center, and the splendid work being done among the children.

Bishop Hobson spoke on the Diocese; expressed his gratitude for the devotion and loyalty he had received from the women of the Auxiliary; for his Discretionary Fund and what he had been able to accomplish with it.

It was moved by Mrs. Rogan of Christ Church, Glendale, that the collections amounting to \$96.57 be divided between Bishop Binsted and The American Church Institute.

Noon-day prayers were read by Bishop Hobson.

Luncheon was served to the delegates and guests in the Parish House at 12:45 o'clock.

1. *Resolved*: That this meeting wishes to express its grateful appreciation to Bishop Hobson, to Dr. Nelson and the other clergy, and to the Choir for the beautiful and helpful opening service.

We also wish to thank the women of Christ Church, of Holy Trinity, Madisonville, of Our Saviour, Mt. Auburn, for their beautiful hospitality.

We would also express our gratitude to Dr. Sherman, Dr. Patton, Mr. Blanton and his singers for their inspiring words and music.

II. *Resolved*: The Woman's Auxiliary of Southern Ohio, in grateful appreciation of Bishop Hobson's leadership, wishes to continue the gift to his Discretionary Fund of at least \$500.00.

*In Memoriam*: The Auxiliary would express our thankfulness to God for the gift to the Church of Southern Ohio of the life work of Bishop Vincent.

And also for God's gift to the Woman's Auxiliary of the beautiful lives and examples of Mrs. A. N. Whiting and of Mrs. Charles G. Reade.

## CONSTITUTION AND BY-LAWS

---

### CONSTITUTION

---

#### ARTICLE I

##### Name

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

#### ARTICLE II

##### Object

The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Church, namely: Missions, Religious Education and Christian Social service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

#### ARTICLE III

##### Membership

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

#### ARTICLE IV

##### Officers

The officers of this Association shall be the Bishop, a President, three Vice Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

#### ARTICLE V

##### Duties

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

SECTION 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

SECTION 3. The President shall be elected at an Annual Meeting held at least one year after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice Presidents, to serve for three years; but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers, but immediately at the close of the General Triennial Meeting, to serve throughout the Triennium. The President shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

SECTION 4. Each Vice President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice Presidents or by the President. A Vice President, with the approval of the President, may appoint any other Convocation officers in her own Convocation and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall co-operate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

SECTION 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

SECTION 6. The Secretary of Supply Department shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

SECTION 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

SECTION 8. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

SECTION 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work, of the Diocese, carried on under the auspices of the Woman's Auxiliary.

SECTION 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request.

## ARTICLE VI Meetings

SECTION 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every Mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates may vote on all questions before the house.

SECTION 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

SECTION 3. Convocation meetings shall be held on the call of the Convocation Officers.

SECTION 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

## ARTICLE VII Mode of Election

SECTION 1. In the election of President any delegates may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

SECTION 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

## ARTICLE VIII Amendments

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

## BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be :

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish Election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expense of officers and speakers, necessary expenses of the Educational Department, and the shipping charges of the Supply Department ; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention ; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages ; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

## FINANCIAL POLICY

### I

1. The Auxiliary should be the Educational and Inspirational force in a Parish.
2. It should be the duty of the Auxiliary to educate its members and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

### II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
  - (a) By urging an every-member canvass and assisting in carrying it out.
  - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
  - (c) By giving when necessary as an organization.

### III

1. The funds of each parochial branch shall be raised at the discretion of the branch.
2. Diocesan Central Expense Fund shall be raised in the following manner.
  - (a) There shall be fourteen classes paying as follows:

A — \$75.00	H — \$20.00
B — 60.00	I — 15.00
C — 50.00	K — 10.00
D — 40.00	L — 7.50
E — 35.00	M — 5.00
F — 30.00	N — 3.00
G — 25.00	O — 1.00
  - (b) Each branch shall decide to which class it will belong.
  - (c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.
  - (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
  - (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
  - (f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

### IV

1. Specials assumed at the Annual Meeting are the responsibility of parochial branches.
