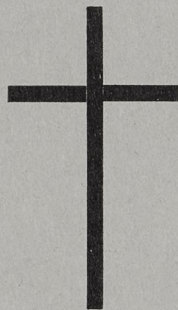

FOREWORD

To the Woman's Auxiliary in Southern Ohio:
Greetings!

I recommend to your careful consideration the following pages of our 1936 Yearbook, as the record of the year's accomplishments, activities and spiritual growth. Your diocesan officers present with thankful hearts the results of our first year in office and our mutual cooperation in strengthening the Church's work among the women in Southern Ohio to which diocese, because of Bishop Hobson's leadership in the Forward Movement and the fact that the General Convention and Triennial Meeting of the Woman's Auxiliary meets in Cincinnati next October, the whole Church looks for an example in Christian discipleship, unity of purpose and real adventure in making a better world.

At the autumn Convocational Meetings the parochial branches were asked to report on the best thing accomplished by the local Auxiliaries in making the Church go forward in 1936. This was a new feature at our meetings and it will be interesting to mark from year to year our growth in our conception of what is meant by "the Church" and "going forward." Too often we forget that the parish is but a tiny unit of the Church of which we are members; and that necessary as money is for advance, the creation of Christian character that comes through religious education, worship and prayer, and the courageous practice of Christian behaviour in every relationship is the main object of our existence as parish, diocese and nation in the one holy, catholic and apostolic Church. Thus parochial limits and interests must be transcended and the life in common permeated with the light and heat of missionary fervor, so that each and every one of us is deeply conscious that discipleship entails being a World Christian, willing to sacrifice family, wealth, life itself that Jesus Christ may be followed and obeyed in these difficult and chaotic times.

The Woman's Auxiliary has no lesser or lower purpose than this and in the light of such an ideal our accomplishments leave us humble and we are spurred on to make a much more earnest and united effort in 1937.

May I suggest that we seize the opportunity offered by next October to learn more about our Church, especially to enlist every woman in our congregations in the Woman's Auxiliary and as contributors to the United Thank Offering, to experience the wider fellowship afforded by our Annual Meeting in Cincinnati May 18-19, and the General Convention opening October 6, and finally to pray for God's blessing on our diocesan projects and undertakings as well as for the plans made for the General Convention?

May 1937 be a year in which good will may so increase that peace will be assured at home and abroad.

SECRETARY'S REPORT FOR 1936

In presenting to the members of the Woman's Auxiliary of the Diocese of Southern Ohio this report of the year 1936, your Executive Board feels that it can look back over this, their first year, as a hopeful beginning and trusts that in the year to come the results will be seen.

The Executive Board has held six board meetings during the current year together with one held last December for a Quiet Hour with our Bishop preceded by a celebration of the Holy Communion in Christ Church Chapel.

In accordance with the desire expressed by the President at the first Board meeting—held on Epiphany 1936—that the Board should make it one of its principal endeavors to make the Executive Board known personally to all the parish branches, every parish in the Diocese, with the exception of two, has been visited by some member of the Board.

On February 5, an Evening Convocation was held at Calvary Church, Clifton, at which 260 were present, the speakers being Mrs. Robert Happ of the National Executive Board, Miss Gwynedd Owen, newly appointed Executive Secretary of the C. M. H., and Mrs. John Campbell of the Campbell-Folk School, Brasstown, North Carolina, accompanied by Mr. Jacob Niles, who sang old mountain ballads.

During March, Miss Leila Anderson, one of the Secretaries of the National Executive Board, was in the Diocese for help in the educational work.

The Sixtieth Annual Meeting of the Auxiliary was held in May at St. James' Church, Zanesville, preceded by a meeting of the Executive Board the evening before.

Owing to the special efforts of the Woman's Auxiliary and the granting of two full scholarships for the Gambier Summer Conference, there were twice as many members of the Auxiliary there than ever before.

This fall there were three Convocational meetings held as follows: October 13, in the Dayton Convocation at Christ Church, Springfield, with 76 women present; October 14, in the Columbus Convocation at Trinity Church, Columbus, with 17 parishes represented and 110 present; October 15, in the Cincinnati Convocation at Grace Church, College Hill, with 310 present and every parish in the Convocation represented.

Miss Esther Brown, one of the Field Secretaries of the National Woman's Auxiliary, who had been lent us for the three months of September, October and November, was the chief speaker at all the meetings.

The Auxiliary sent as representatives to the meeting of the Synod of the Fifth Province held in Madison, Wisconsin during October, Miss Matthews, Miss Johnston, Miss McCune from the Executive Board and Mrs. Allan McGregor, Springfield, Mrs. Samuel L. Moyer, Christ Church, Cincinnati; to the Officers' Conference for

the Third Province held in Richmond, Virginia in November, Mrs. Roger K. Rogan, Mrs. Smith Hickenlooper, Mrs. Walter W. Tangeman, Mrs. Edward Wagner from the Executive Board and Mrs. A. Clifford Shinkle, Christ Church, Mrs. A. Burton Closson, Calvary, Mrs. Edwin Stackhouse, St. Alban's, Bexley, Mrs. Alden Graves, Worthington, from the Auxiliary at large.

Three committees have been appointed by the President during the year: (1) A Committee on the Revision of the Constitution, Miss Colston, Chairman, Mrs. Baggott, Miss McCune, Miss Johnston, Miss Catherine Morrison; (2) A Committee to study the question of recruiting young people: Mrs. Smith Hickenlooper, Chairman, Mrs. Tangeman, Miss Mary E. Johnston, Miss Hilda M. Shaul, Mrs. Wagner; (3) A Committee on formulating a new financial policy for the Auxiliary: Mrs. Alden Graves, Chairman, Mrs. Edwin Stackhouse, Mrs. A. Clifford Shinkle, Mrs. Charles Nunn, Holy Trinity, Hartwell, Miss Laura McCracken, Urbana. Besides these three the President appointed Miss Susie Tuite, Church of the Advent, head of a Committee to be chosen by Miss Tuite to gather full statistics of the women of the Cincinnati Convocation for use especially during the General Convention and Triennial Meeting next October.

Four new branches, we are pleased, to report, have been added to the Auxiliary list, namely: St. Andrew's, Addyston, an Evening Branch at Christ Church, Dayton, the Monday Club, Church of the Redeemer, Hyde Park, and a Junior Guild, St. Thomas', Terrace Park. In addition the President, Miss Matthews, has formed, from names given to her by the Rev. Smythe Lindsay of his Good Shepherd's Church, the Bishop's Chapter, among the isolated and scattered communities in the Diocese.

The Executive Board decided that the names of the six missionaries allotted to Southern Ohio by the National Executive Board as Prayer-Partners should be divided as follows: Cincinnati Convocation, Miss Mary Cornwall-Leigh, North Tokyo, Mrs. W. H. Standing, Shanghai; Columbus Convocation, Miss Charlotte Edwards, Diocese of Virginia, Sister Ruth Magdalene, C.T., Anking, China; Dayton Convocation, Miss C. E. Ogden, Canal Zone, Miss Helen Taylor VanVoast, Shanghai.

Besides the activities enumerated above, the President has attended meetings of the National Council and the Field Department and has been made Chairman of the Woman's Committee of the General Convention and member of the Executive Committee of the Convention. She has visited and spoken in 26 parishes besides attending the five Educational Days held by Miss Shaul and Miss Brown.

The Vice-President of the Cincinnati Convocation, Mrs. Walter W. Tangeman, has held three Officers' Conferences and has conducted jointly with Mrs. Arthur Sherman a Quiet Day at St. James',

Westwood and has visited and spoken in 16 different parishes besides serving as Secretary of the Semi-Annual Meeting of the Woman's Department of the Federation of Churches.

The Vice-President of the Dayton Convocation, Mrs. Alfred F. Burdoin has held one Officers' Conference, visited 11 parishes and has attended the Educational Days held in her Convocation this Fall by Miss Esther Brown.

The Vice-President of the Columbus Convocation, Miss Louise McCune has held one Officers' Conference at which 16 parishes were represented, has represented the Auxiliary at the Ohio Council of Churches Meeting in Columbus, has visited 4 parishes and attended the Educational Conferences last March and this November in Columbus and Athens. She attended the Gambier Summer Conference and has also written many letters and been in touch either by personal contact or by letter with each parish in her Convocation.

The Memorial Scholarship was granted this October to Miss Dorothy Scott,—formerly Director of Religious Education in Christ Church, Cincinnati—for further training at Teachers' College, Columbia University, New York City.

November 11, Armistice Day, the Auxiliary, as in the past, observed with special prayers and services in their parish churches and distributed 2500 of the special leaflets drawn up for that day by the National Executive Board.

In June, Miss Emily Aldrich, Field Secretary of the Department of Religious Education of the Diocese and former holder of the Memorial Scholarship of the Woman's Auxiliary left the Diocese to be married. Her place in religious education on the Auxiliary Board has been taken by Miss Hilda M. Shaul, newly appointed Advisor on Religious Education in the Diocese.

We have also welcomed at the meetings of the Executive Board Mrs. Joseph D. Herron, representing the Girl's Friendly Society and Mrs. Frances W. Larcomb representing the Church Periodical Club. This has been valuable as a symbol of the close association of the work of our several women's organizations and as a practical measure of insuring closer and more intelligent cooperation.

In closing this report of the work of a full and busy year your Executive Board feels most grateful to the branches and the individual members of the Auxiliary, who have given such enthusiastic and loyal support, and goes forward into this new and most important year of 1937, which will see our Diocese host to the Great General Convention and Triennial Meeting next October, trusting that we may so prepare ourselves and our Diocese that this coming Convention may be the great spiritual event it should be for us all.

REPORT OF THE UNITED THANK OFFERING

As I look back over the past year which has been such a happy and interesting one for me, I feel very grateful to have had the honor of serving my diocese as United Thank Offering Treasurer, and to have had the privilege of meeting so many of the women of the different parishes, especially the treasurers, to whom I owe a debt of thanks for their loyal support.

I have visited all of the parishes in the Dayton Convocation, all but one in the Columbus Convocation and all but twelve in the Cincinnati Convocation, and I have met all but seven of the treasurers.

In addition to the offerings from the parishes, individual gifts have come from four women of the Bishop's Chapter, and from Trinity Mission Guild, a group of women representing a defunct parish, who for years have supported the United Thank Offering as their one piece of church work.

An unusual venture in publicity was the United Thank Offering tea given at Christ Church, Cincinnati, in January, 1936, to the women of the Cincinnati Convocation. A committee of the treasurers took charge and did such splendid work that though the weather was very bad, about four hundred women came.

We are still far from our goal—"Every woman in every parish a supporter of the United Thank Offering by October 1937"—but that we have put our shoulders to the wheel has been proven by the addition of 561 women this year, by every parish in the diocese being represented in the offering; by three groups having all of their women giving; and by nine others being within ten of one hundred per cent.

We must now look toward next fall, each woman feeling the responsibility of getting all of our church women to unite in expressing their daily thanks by means of the Blue Box, so that we will carry to the Corporate Communion Service on October 7th, a gift worthy of being laid on His altar, and one which will show that we have truly gone forward in the past three years.

The work of the Supply Department has gone forward this year with industry and enthusiasm on the part of the women of the parishes of the Diocese of Southern Ohio. The boxes have come in promptly and the garments prepared for the Missions have been of exceptional quality and chosen with a fine consideration of those for whose use they were being sent.

The personal boxes were planned and packed with so much care and understanding that they carried to the recipients a great deal more than the actual contents—a spirit of Christian fellowship that could not help but encourage those who are serving us with so much self-sacrifice in the mission fields.

The supplies have gone to Liberia, China, Alaska, and, in our own country to the South, to the far West, and to North and South Dakota. We have served Negroes in Africa in Emery Hall School. Indians in the reservations of the Dakotas, and sick Chinese in Shanghai, besides Negroes and White persons in the Southern Mountain Districts of the United States.

As Secretary I have been privileged to meet with thirty-four of the parish groups and have appreciated their cordiality and co-operation. I feel sure that in the coming year their generosity and enthusiasm will continue and that, through their friendship, will be maintained the loyalty and gratitude of the missions for the Diocese of Southern Ohio.

REPORT OF EDUCATIONAL WORK IN 1936

When this Executive Board took office there was a vacancy in the position of Educational Secretary; not that this was not considered a position of the most vital importance but because no one had been discovered both capable and able to serve. It was decided to see what could be accomplished by dividing the territory and work, utilizing Extension Convocational Secretaries and a Central Program Committee on which men such as Dr. Sherman of the Forward Movement, the Rev. E. L. Haines, Chairman of Adult Education of the Department of Religious Education, and the Rev. Smythe Lindsay, editor of the Messenger consented to serve; Mrs. Chalmers Hadley undertaking to act as Chairman in addition to her work as Custodian of the Book of Remembrance. This arrangement, frankly an experiment, has been discontinued, although informal committees are being created from time to time to forward the educational work of the Auxiliary.

Meanwhile the Woman's Auxiliary Educational Committee was not idle. The plans of the Adult Committee and the literature of the Forward Movement were promoted and a coordinated program was proposed. Some parish groups carried on programs on the 1935-1936 missionary subject of "Latin-America" as a result of Educational Days held in the fall of 1935 by Miss Mary Anderson. Several excellent conferences were held especially those with Miss Leila Anderson who as Acting National Educational Secretary was in Southern Ohio for two weeks in March, visiting four university centers and certain chosen Auxiliary branches and Young Churchman groups. The Committee was already conscious that no matter how good work was on paper it required the leadership of one person trained in modern educational methods working on full time to carry the plans out into parochial life. Neither the new and more attractive library room nor the current books contained therein were being at all widely used, nor were the leaflets provided called for. The articles in the Messenger might or might not be read. In fact none of these methods could be counted on to guide parish Educational Secretaries. They required contact with and the encouragement of an officer such as is afforded the United Thank Offering Treasurers and Supply Secretaries by a member of the Diocesan Board. Miss Leila Anderson had suggested a new type of Executive Secretary for the Department of Religious Education as Miss Aldrich was leaving the Diocese to be married, an officer who would coordinate all groups, Church Schools, Young Churchmen, University students and the adults of our parishes, whether members of the Auxiliary or in other organizations. A person actually able to carry out this exacting program was found and Miss Hilda Shaul was secured under the title of Educational Advisor. Miss Shaul is a member of the Executive Board and only the limitation put upon her services by the many other demands for her attention makes the situation less than ideal.

At the Gambier Summer Conference, by the use of half scholarships and careful publicity, the women of Southern Ohio were better represented than for several years, attending specially chosen classes in the hope of developing parish leadership. The Cincinnati Fall Normal School was also urged upon the Cincinnati Convocation with a like hope, Forward Movement courses being specially provided.

This fall Miss Shaul's work for the Auxiliary has been supplemented by securing for three months the presence of Miss Esther V. Brown, National Woman's Auxiliary Field Worker. As the subject chosen for study in this diocese this winter of 1936-37 is "The American Negro" and the problems attending racial understanding and cooperation; Miss Brown, herself a Negro, was a most able leader. Her knowledge of the subject, being joint author with Miss Leila Anderson of "Toward Understanding Negro Americans," her own personality and objective method in presenting the questions of race, made her work in the Diocese of inestimable value. Of course the creation of a better public opinion with more cooperation between the two races and the righting of social conditions is a slow process and awaits parish and individual action as our study continues, overcoming prejudice and inertia. The Auxiliary hopes for real fruit from seeds sown at the five Educational Days led jointly by Miss Shaul and Miss Brown at five diocesan centers this fall at which some 225 persons were present from 50% of the parishes. Miss Brown's visit touched all phases of our diocesan life from the clergy to the Young Churchmen. Her longest stays were in our four Negro parishes and in our university centers.

This year's study has the unusual advantage of being a matter of lively interest since it bears on our own personal behaviour as mission study rarely can do, but in closing this report it is urged to make all issues of today that touch women subjects for study and action. There is no lack of material from such great themes as World Peace and Social Security down to the Auxiliary's new constitution and forthcoming financial policy; best of all there is the intelligent consideration of the wider opportunity for service within parochial branches and the making of a comprehensive program of activities covering all fields and vital religious interests which should enlist every woman and girl. Thus Parish Educational Secretaries must rethink the implications of their task and call into consultation all parish leaders that a parish may become an educational unit consumed with a passion to know more, love more and live more closely to Christ's ideals for His disciples.

The Sixtieth Annual Meeting of the Woman's Auxiliary in the Diocese of Southern Ohio was held on May 6th and 7th (Wednesday and Thursday) at St. James Church, Zanesville, beginning with a service of Holy Communion at 11:00 o'clock on May 6th at which the United Thank Offering was presented.

The Bishop was the celebrant and also the preacher, his text being taken from I Thessalonians, Chapter V, verses 16, 17 and 18—"Rejoice evermore. Pray without ceasing. In everything give thanks for this is the will of God in Christ Jesus concerning you." The Epistle was read by the Rev. Arch Hopper, rector of St. John's Church, Cambridge, the Gospel by the Rev. David R. Covell, Executive Secretary of the Diocese. Following the service the delegates went to lunch at the Y. W. C. A.

The annual business meeting was held in the church at 2:15 beginning with prayers, led by the President, Miss Elizabeth Matthews. The first order of business was a word of welcome from Mrs. Perry Smith, President of the Woman's Auxiliary of St. James Church, Zanesville, who spoke of her happiness in welcoming the first annual meeting ever held in that old parish,—the second oldest in the Diocese,—and of the especial gratitude the parish felt to the Auxiliary for the part it had played in training the four women who had gone from St. James into church work during the past years—namely, Deaconess Fracker, Deaconess Dieterle, Miss Cornelia Smith (Mrs. Elwood L. Haines) and Miss Isabel Colson. The roll was then called—55 parishes and missions responded (the largest number ever represented at any annual meeting so far having been 60, at Glendale, in 1918).

The President then announced two committees:

Credentials: Mrs. Joseph Cartmell, Christ Church, Springfield; Mrs. Otis Story, St. Paul's, Chillicothe; Mrs. Otis Jackson, St. Mark's, Oakley.

Courtesy Resolutions: Mrs. Henry Irving, Calvary Church, Clifton; Mrs. Edward Cook, St. Paul's, Oakwood, Dayton; Miss Grace Horton, Pomeroy.

The President did not appoint a Resolutions committee as she said the time of the meeting was too short to make one really useful, and she wished to have resolutions come in during the meeting from the floor as occasion for them arose.

A Guard of Honor for the Book of Remembrance was then announced by the President consisting of Miss Louise McCune, Trinity, Columbus; Miss MacCracken, Epiphany, Urbana; Mrs. Frances W. Larcomb, St. Paul's, Columbus; Mrs. W. R. Durgan, Church of the Advent, Walnut Hills; Mrs. Robert M. Christopher, Holy Trinity, Hartwell. Miss Matthews told the meeting that the silk cushion on which the Book was placed was the gift of the Diocesan Altar Guild in memory of their former president, Mrs. William Roemler—which memorial would be consecrated at the early service next morning by the Bishop.

The Secretary's report was then read and upon motion duly made and seconded, it was accepted as read.

The Treasurer, Mrs. Edward Wagner, then read her report covering the time from January 6th to May 6th, 1936—copies of which were distributed among the members. Upon motion made by Mrs. Frank K. Bowman, Grace Church, College Hill, and seconded by Miss Mary C. Thompson, Christ Church, Cincinnati, the report was accepted and ordered filed.

The President gave a short address taking as her text the words—"For Ye Are Members One of Another" and arranging her subject under three heads so long familiar to the Auxiliary of Study, Pray, Give.

She then presented to the meeting the members of the new Board and also the former presidents of the Auxiliary: Mrs. Mortimer Matthews, Mrs. William Scarlett, Miss Catherine Morrison and Miss Louise McCune, who were happily present at the annual meeting.

The Supply Secretary, Mrs. Smith Hickenlooper, next gave a report of her work and spoke with enthusiasm of the thrill it gave her to see such evidences of the concern of the women of the Diocese for the missionary work of the Church, and thanked them for their fine cooperation. The boxes from this Diocese go this Spring to St. Philip's Mission (colored), Little Rock, Arkansas; Mandan (Indian) Mission, South Dakota, and to the Mission of the Holy Spirit, Orleans, California (Indian). The two boxes to the Missions of St. John the Baptist and Epiphany, South Carolina, had been completed this Spring, the larger part of their contents having been dispatched last Fall. The St. Elizabeth Hospital Fund, Shanghai, China, had been more than completed—\$750.45 having been raised and the Household and Dispensary Fund had a balance in it, so Mrs. Hickenlooper had telegraphed to Mrs. Wade, chairman of the Supply Department at Church Missions House, New York, asking her about any urgent needs not yet taken care of. Of those submitted, Mrs. Hickenlooper had selected that of the Emerald Hodgson Memorial Hospital, Sewanee, Tennessee. She therefore moved that she be authorized to send \$100.00 from the balance of the Household and Dispensary Fund to Mrs. Wade for the said Memorial Hospital; Mrs. Lafayette Woodruff, St. Paul's, Columbus, seconded this and it was carried. If any more money should come in for the St. Elizabeth Hospital Fund, Mrs. Hickenlooper announced it would of course be added to the said Fund.

Mrs. Roger K. Rogan, Treasurer of the United Thank Offering, then gave her report, and announced the total for the Spring Offering—\$4,446.03, and also the date for the Fall Offering—October 18th. Mrs. Rogan then went on to speak of the task ahead in trying to reach approximately 5000 women in the Diocese who are not as yet giving to the Offering, and announced the contest for the best-designed poster for the United Thank Offering, offered to the girls

and young women of the Church by the National Executive Board of the Woman's Auxiliary.

Miss Matthews announced with regret the absence of the Chairman of the Educational Committee, Mrs. Chalmers Hadley. The report of the Educational work was given by a member of the Committee, Mrs. Lytle Zuber of St. Paul's, Columbus. Mrs. Elwood L. Haines then spoke on the coming Gambier Summer Conference, June 22 to July 3, dwelling on some of the courses of special interest to the Auxiliary and urging that at least 25 women go from this Diocese.

Miss Mary E. Johnston gave a brief report on the activities of the National Executive Board, saying that it was working hard on the program for the Triennial Meeting to be held in Cincinnati in 1937. She spoke of the general feeling that was reaching the Executive Board of the necessity for more definite teaching about the Christian faith and the essentials of Christian doctrine. The theme for the World Wide Day of Prayer to be observed as usual by the Church on Armistice Day, November 11, would be Missions. The Board was engaged in making an intensive study of the missionaries in the field, and the subject of pensions for them.

The time being 4:00 o'clock, the Bishop next addressed the meeting on the subject of the Diocese taking it up department by department, very briefly. He spoke especially of mission work in the Hocking Valley under Mr. John Stockham and the courage and ability with which he was tackling that most difficult and yet challenging field, also of the work in the West End of Cincinnati being done by St. Barnabas' Mission. He spoke also of the new venture—the School of Applied Religion—under the leadership of the Rev. Joseph Fletcher. This Diocese, he told the meeting, had given about \$23,000 to the deficit in the National Church. In conclusion the Bishop applied again very briefly the seven steps of the Forward Movement to parishes and explained in a few words some of the things this involved.

Following the Bishop's address the meeting adjourned for tea at the Rectory and dinner at the Y. W. C. A.

The meeting was resumed in the church at 8:00 o'clock that evening and was opened with the singing of the hymn "Jesus Shall Reign Where'er the Sun," and prayers. The President was in the chair and the Credentials Committee not being yet ready to report, she passed directly to the address of Dr. Lewis B. Franklin, whom she introduced to the meeting as Vice-President and Treasurer of the National Council, who had just returned from a visit to our Missions in China, Japan, the Philippine Islands, and Hawaii. Dr. Franklin then gave a most interesting account of the missionary work in those fields, speaking especially of the leper work under Miss Cornwall-Legh at Kusatsu, Japan, and its threatened curtailment owing to lack of funds. Miss Matthews added a few words of explanation about the leper settlement telling the meeting that \$8,000 was needed to carry on the work for the coming year. Various questions were asked indicating great interest in Dr. Franklin's address and Miss Catherine Morrison moved, seconded by Mrs. Roger

K. Rogan that the offering at the early service the following morning be sent to Dr. Franklin for this work at Kusatsu. This was carried.

The business meeting then adjourned and the Bishop conducted a half hour service of preparation for the Holy Communion the next morning.

The second day opened with a celebration of the Holy Communion at 7:30 a. m., the Bishop being the celebrant and reading the special prayers from the Book of Remembrance, also consecrating the memorial to Mrs. Roemler. This was followed by breakfast at the Y. W. C. A. and the meeting was called to order in the Church by the President at 9:30 o'clock. After short prayers the minutes of the previous day were read and after certain corrections, were approved.

The Credentials Committee—Mrs. Joseph Cartmell, Chairman, reported that in the Cincinnati Convocation, 26 branches were represented and a total of 92 persons present; in the Columbus Convocation, 20 branches with a total of 160; in the Dayton Convocation, 9 branches with a total of 32, making a grand total of 284 persons present. On motion duly seconded this report was accepted and ordered filed.

Miss Matthews asked that the Secretary be authorized to have the minutes of the second day approved by a special committee appointed for that purpose. Accordingly, Mrs. S. L. Moyer moved, seconded by Mrs. Weddell that the President appoint a committee consisting of herself, Miss Catherine Morrison and the Secretary to read over and approve the final minutes. This was carried.

Dr. Franklin was then given the floor to introduce the subject of National finances. He spoke of the "irreducible minimum" budget of \$2,313,000 of Atlantic City which had this year been further reduced by \$36,000. This sum represents about 90 cents from each communicant for all work under the General Church Program. Dr. Franklin emphasized the fact that information and interest were the basis of church giving, not financial ability.

Dr. Covell was then invited by Miss Matthews to speak on the subject of the financial policy of the Auxiliary. He had a proposed draft for such a policy. Questions were asked by several members and a discussion followed on the relative obligations of a parish as to parish budgets and general missionary giving. The Bishop rose to emphasize the difficulty of drawing hard and fast lines between what was missionary giving and regular parish expenses. Miss Louise McCune moved, seconded by Miss Catherine Morrison, that the whole question of the financial policy of the Auxiliary be left in the hands of a committee to be appointed by the President. This was carried.

The question of educating the younger women in the missionary work of the Church and its relation to community work was then brought up for discussion by Mrs. Edwin D. Stackhouse of St. Alban's, Bexlev, Columbus. It was moved by Mrs. Lytle Zuber, seconded by Mrs. Jack Neida of Trinity, Columbus, that the whole question of missionary education be referred to the Adult Education Committee. This was carried.

The Rev. Smythe Lindsay spoke briefly on his work in the Diocese for the isolated and lonely supported in part by the Bishop's Discretionary Fund. It was moved by Mrs. S. L. Moyer and seconded by Miss Louise Kelton, Trinity, Columbus, that the Auxiliary's pledge to the Bishop's Discretionary Fund of a minimum of \$500 be continued for the ensuing year. This was carried.

It was moved by Miss Colston and seconded by Mrs. Lafayette Woodruff that a report of the Memorial Scholarship Fund be made each year to the Annual Meeting of the Woman's Auxiliary by the Trustees of the Diocese. This was carried.

Miss Emily Aldrich, field worker of the Department of Religious Education, gave a short report of her work stressing the Young Churchmen's organization and activities. Short reports followed from Mrs. Frank K. Bowman, President of the Diocesan Altar Guild, and from Mrs. Frances W. Larcomb, Diocesan Secretary of the Church Periodical Club. Mrs. Larcomb stated that Southern Ohio ranks fifth in the amount given to the Church Periodical Club—\$829.56. Mrs. Roger K. Rogan gave a supplementary report on the United Thank Offering—70 parishes have given \$4,436.07—the number of women giving is 2,157. Brief noonday prayers were led by the President, Miss Matthews.

Miss Colston, Chairman of the Committee on Revision of the Constitution, presented the revised Constitution, article by article. Article VII, Section 3, which, having already been presented at the last annual meeting, was now ready for final action at this meeting. Miss Matthews and Miss Colston explained the reasons for the changes in the Constitution as proposed, these changes being chiefly in the date of the annual meeting and the mode of election of vice-presidents. It was therefore moved by Miss Colston and seconded by Mrs. Roger K. Rogan that this Article VII be treated as part of the whole revision and be acted on with the rest of the Constitution next year. This resolution was adopted.

At the request of the President, it was moved by Mrs. Lafayette Woodruff, St. Paul's, Columbus, seconded by Mrs. Edward Wagner, that the Executive Board be empowered to appoint the five delegates to the Provincial Synod meeting in October. This was carried.

It was announced that the offering at the early service had been \$93.00—this was afterwards increased to \$101.00—also that the number communicating the first morning had been 290, on the second 115.

The Committee on Courtesy Resolutions presented the resolutions thanking the Bishop, Dr. Franklin, the Rector, and members of St. James parish, Zanesville, for their inspiration and hospitality, and expressing regret at the absence from the meeting of Mrs. Baggott and Mrs. McGregor. Mrs. Henry L. Irving, Calvary, Clifton, moved, seconded by Mrs. Glenn of St. Paul's, Columbus, their adoption and they were passed by a rising vote.

The business of the meeting being over, the closing devotions—a litany, were led by the President and at 12:45, the motion to adjourn was made by Mrs. Roger K. Rogan—seconded by Mrs. Smith Hickenlooper and carried.

CONSTITUTION AND BY-LAWS

CONSTITUTION

ARTICLE I

Name

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council."

ARTICLE II

Object

The object of this Association is to carry out in the Diocese of Southern Ohio, by united and systematic effort, the three great aims of the Church, namely: Missions, Religious Education and Christian Social service, in the five fields of service, namely, Parish, Community, Diocese, Nation and World.

ARTICLE III

Membership

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

ARTICLE IV

Officers

The officers of this Association shall be the Bishop, a President, three Vice Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, and an Educational Secretary. These officers, with an appointee of the Church School Service League of the Diocese, shall constitute the Executive Board of the Association.

ARTICLE V

Duties

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

SECTION 2. The Bishop, when present, may preside at meetings of the Association and of the Executive Board.

SECTION 3. The President shall be elected at an Annual Meeting held at least one year after the General Triennial Meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other Diocesan officers, except the Vice Presidents, to serve for three years; but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers, but immediately at the close of the General Triennial Meeting, to serve throughout the Triennium. The President shall also appoint a Custodian of the Book of Remembrance, to serve for her term of office. She shall call meetings of the Association and of the Executive Board, and shall, in the Bishop's absence, preside at them. She shall exercise a general supervision of the work and further it in every way by her interest

and advice, and especially by an address at the Annual Meeting. In case of a vacancy in the office of President, such vacancy shall be filled until the next Annual Meeting, by appointment made by the Bishop and a committee of two selected by the Executive Board.

SECTION 4. Each Vice President shall be elected as soon as possible after the Annual Meeting at which the President is elected by the members of her Convocation, to serve for three years, but shall not be eligible for two consecutive terms. An election, either for a full or unexpired term, shall be held at a Convocation meeting called for the purpose by the retiring Vice Presidents or by the President. A Vice President, with the approval of the President, may appoint any other Convocation officers in her own Convocation and prescribe their duties. She shall preside at all meetings in her own Convocation. She shall cooperate with the President in promoting local intelligence and interest, and in directing local organization and work in her own Convocation.

SECTION 5. The Secretary shall keep the minutes of the Executive Board and of the Annual Meeting. She shall conduct all correspondence of the Association and of the Board, except as provided for in Section 6 of this article. She shall also make an annual report of the work done from data furnished by the other officers.

SECTION 6. The Secretary of Supply Department shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Secretary the work done.

SECTION 7. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except that from the United Offering; and shall also make an annual report of the same.

SECTION 8. The Treasurer of the United Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence or visitation, and shall report annually the amount on hand, and forward the Triennial offering.

SECTION 9. The duties of the Educational Secretary to be a general supervision of all Missionary Education work of the Diocese, carried on under the auspices of the Women's Auxiliary.

SECTION 10. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance. She shall not be a member of the Board, but shall meet with it upon request.

ARTICLE VI

Meetings

SECTION 1. There shall be an Annual Meeting of this Association, or there may be Semi-Annual Meetings. Every Parish branch may send three delegates, including an executive officer; and every Mission branch one delegate. Except in the election of a President, Executive Officers, when not delegates may vote on all questions before the house.

SECTION 2. The Executive Board shall meet at least twice a year. Five officers shall constitute a quorum.

SECTION 3. Convocation meetings shall be held on the call of the Convocation Officers.

SECTION 4. Delegates to the Triennial shall be elected from the active membership of the Auxiliary, by a majority of the delegates of the Annual Meeting next before the Triennial Meeting. Nomination of delegates to the Triennial may be made by any delegate to the Annual Meeting, and must be sent in, in writing, not later than the morning session of the Annual Meeting.

ARTICLE VII

Mode of Election

SECTION 1. In the election of President any delegates may nominate; all nominations must be written; all elections must be by ballot, and each Parish or Mission shall cast but one vote.

SECTION 2. Unless there be an election by a clear majority on the first ballot, the Chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

ARTICLE VIII

Amendments

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

BY-LAWS

The Executive Board shall determine the time of and place for the Annual Meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish Election of delegates shall take place during the month preceding the Annual Meeting, and be immediately reported by the local Secretary to the Diocesan Secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expense of officers and speakers, necessary expenses of the Educational Department, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names

being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a Parish Committee, consisting of the heads of all women's organizations within the Parish, acting with the Rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some Memorial Gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the Trust Fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the Annual Meeting of the Woman's Auxiliary, the Annual Service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its Treasurer in April and October except triennially in September.

8. The accounts of the Treasurer and the Treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

MEMORIAL SCHOLARSHIP FUND

INSTRUMENT OF TRUST

THIS INSTRUMENT OF TRUST, executed this twenty-eighth day of December, in the year of Our Lord, 1926, by the Woman's Auxiliary of the Diocese of Southern Ohio, to the Trustees of the Diocese of Southern Ohio, a corporation, under the laws of Ohio, WITNESSETH:

That the said Woman's Auxiliary hereby assigns and sets over to the said Trustees, as a trust Fund, the sum of twelve thousand (\$12,000.00) dollars, more or less, with accretions thereto, and accumulations thereof, as hereinafter provided for and upon the following specified purposes and trusts:

(1) The initial and present amount of said Fund, being a gift to the Church in Southern Ohio, upon the occasion of the FIFTIETH ANNIVERSARY of the said Woman's Auxiliary, the said Fund, accretions and accumulations shall be known as the "Memorial Scholarship Fund."

(2) The said Fund, with accretions and accumulations, as hereinafter provided, shall be invested and reinvested, from time to time, as occasion may require, and the income only, except as hereinafter provided, shall be used for the purpose of aiding the training of such Churchwomen of the Diocese of Southern Ohio, for service in, or for the Church, either in the Home or Foreign fields, as shall be nominated to the Bishop, or in his absence, to the Ecclesiastical Authority of said Diocese, by the Executive Board of the Woman's Auxiliary, of the Diocese, and approved by the Bishop or Ecclesiastical Authority.

(3) For, and during, such time as there may be no woman of said Diocese, who is an approved beneficiary for training, or, for such time as there may be a substantial balance of income unused, and upon a Certificate by the President, and Secretary of said Woman's Auxiliary, to said effect, or effects, the whole, or part, of said income, as the case may be, shall be allowed to accumulate and be added to the Principal of the Fund. A candidate may apply for aid in procuring such training for any type or form of Church Work, provided only that she agree to serve as a paid Church-Worker for three years after the completion of her training, and, if prevented from giving the whole, or part of said three years of service, to refund, pro rata, the amount expended, on her training, except in very exceptional cases, such as failure in health, or other equally exceptional cases, all of which must be passed upon favorably by the Executive Board of the said Woman's Auxiliary. This paragraph shall not be construed to place the Trustees of the Diocese under any obligation to enforce any such agreement.

(4) The income of said Fund, shall be paid, from time to time, by said Trustees of the Diocese, directly to such beneficiaries as have been approved as aforesaid, upon the written order of the President and Secretary of the said Woman's Auxiliary, specifying in each and every of said written orders, the amount to be paid, and the name of the payee.

(5) It shall be within the power and discretion of said Executive Board to apply a portion of the Income thereof, to the education of approved beneficiaries, for, and during their last two (2) years in College, as well as for, and during their more immediate training for Church work, provided, however, the aid given to any one beneficiary, shall not be for more than three (3) years altogether.

(6) Said Fund shall never be closed, but may be added to from year to year by said Woman's Auxiliary, or any of its Branches, or by individuals, by gift, or bequest, or, by such repayments and accumulations, as may be made, or may accrue, pursuant to the provisions of paragraph 3, provided only that such additions, gifts, bequests, repayments, or accumulations, shall be upon the same trusts, as herein otherwise provided.

(7) Upon the occasion of the Annual Meeting at the One Hundredth Anniversary of the Woman's Auxiliary of the Diocese of Southern Ohio, it shall be within the power and discretion of said Woman's Auxiliary, by a vote of two-thirds (2/3) majority of the delegates present thereat, to alter the details of the Trust hereby established, provided the fundamental purpose, which is declared to be the aiding in the training of Churchwomen generally for Church work, be preserved.

IN WITNESS WHEREOF, the said Woman's Auxiliary in the Diocese of Southern Ohio, by Lucile S. McGregor, its President, and by Ellice P. Hollenbeck, its Secretary, and the Trustees of the Diocese of Southern Ohio, a corporation, as aforesaid, in evidence of its acceptance of this Trust, by Edward W. Strong, its Vice-President, and James H. Cleveland, its Secretary, have hereunto set their hands and seals, upon the day and year last above written.

FINANCIAL POLICY

I

1. The Auxiliary should be the Educational and Inspirational force in a parish.
2. It should be the duty of the Auxiliary to educate its members and through its members the parish, to believe that the Nation-Wide Campaign Quota is the least amount each parish should give.

II

1. It shall be the duty of every branch to aid in raising the Nation-Wide Campaign Quota of the parish.
 - (a) By urging an every-member canvass and assisting in carrying it out.
 - (b) By giving through the Duplex Envelopes, or in any other method in use in the parish.
 - (c) By giving when necessary as an organization.

III

1. The funds of each parochial branch shall be raised at the discretion of the branch.

2. Diocesan Central Expense Fund shall be raised in the following manner:

(a) There shall be fourteen classes paying as follows:

(b) Each branch shall decide to which class it will belong.

(c) Each Parochial Treasurer shall yearly notify the Diocesan Treasurer to which class the branch belongs.

(d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.

(e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.

(f) Diocesan Dues to the National Organization shall be paid from the Central Expense.

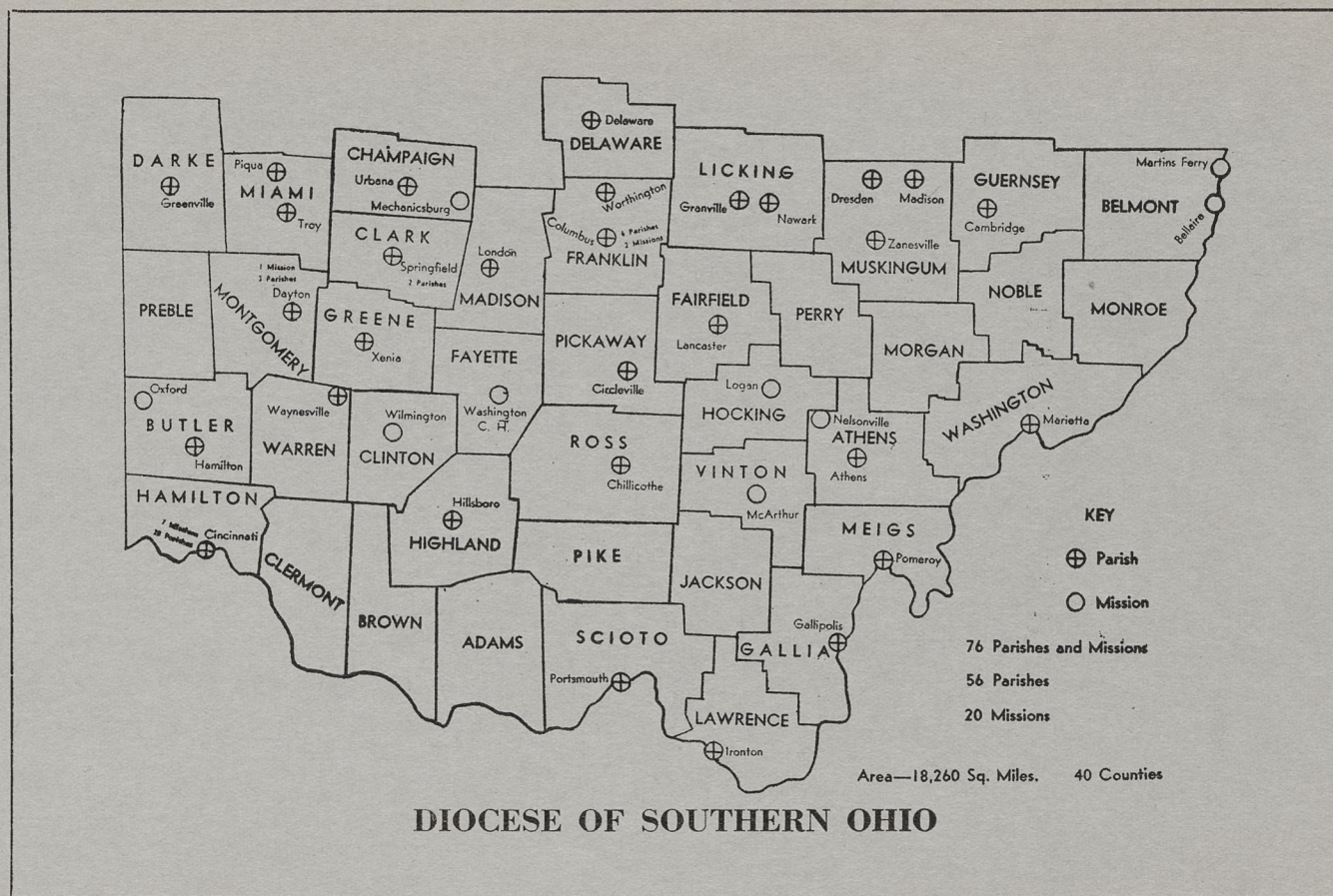
