
Noon-Day Prayer for Missions


The Prayer for the Woman's Auxiliary

REPORT OF THE SECRETARY OF THE WOMAN'S AUXILIARY

For the Year May 18, 1937—May 17, 1938

Right Reverend Sir, Madam President, Members of the Woman's Auxiliary: Your Executive Board presents this their last annual report with mingled feelings of thankfulness and sadness,—thankfulness that with your loyal co-operation they have been enabled to carry on the work of the Auxiliary with energy, and they hope with some degree at least, of success in this past year, and sadness that the time has now come to entrust their task to other hands.

The first part of the year was given over, as you all know, to the preparation for the General Convention and the Triennial meeting last October and the latter part to the task of seeking to realize and deepen the new knowledge which came to us all in that great experience. Your Executive Board has part in all the preparations for the Convention and Triennial, the President serving on the Executive Committee and heading up all the women's work in the programme for the Convention:—the United Thank Offering Treasurer, Mrs. Rogan, serving as Chairman of the United Thank Offering service; the Vice-President of the Cincinnati Convention acting as co-chairman of the Committee on Halls and Meeting Places of the Triennial; the Supply Secretary serving as chairman of the Credentials Committee, while other members of the Board served on such important committees as Registration, Young People's, and Hospitality. Where all served with such efficiency and devotion it seems perhaps invidious to single out anyone for special mention, nevertheless it is impossible to pass over the really outstanding achievement of the Chairman of the United Thank Offering Committee. Thanks in large measure to her planning and hard work, that service will remain to all who were privileged to take part in it as the perfect expression of the love and devotion of the women of the Church. The offering laid on the altar that day from this Diocese was one for which we can also give thanks—\$35,745.00 from four thousand women,—the second largest offering ever made by this Diocese,—the largest having been made in 1934, in Denver, \$38,104.49, and an increase in the number of givers during this past triennium of 1,000. After this achievement, Mrs. Rogan to the regret of the Board, felt unable to accept her appointment as Treasurer of the United Thank Offering for another three years' term. Accordingly the President appointed as her successor Mrs. Roger S. Woodhull, of St. Paul's Parish, Oakwood, Dayton, who has entered upon her new task with an enthusiasm and devotion which promise equally great results in the next three years.

Owing to the General Convention having absorbed so much of our energy and time during the autumn it was felt the usual autumn Convocation meetings would be inadvisable but in order not to lose the enthusiasm engendered by the General Convention and also to help the women of the Diocese realize its meaning in terms

of a vital and significant parish programme, a new plan was tried out, namely that of sending out teams of women to bring this message to the individual parishes. During the months of November and early December twenty-eight women serving on nine teams, visited thirty-one parishes, all of them with one exception being outside Cincinnati, and reached approximately 841 women, more than double the number who are ever reached by Convocation meetings. It was a new venture and to those who went out on the teams an almost appallingly difficult one; one felt so keenly one's inadequacy and the greatness of the task. In the very nature of the project it is difficult to evaluate its results in concrete form. But, nevertheless, your Executive Board, a member of which served on each team, hopes that it was not in vain and that some permanent values will result. Most of the ground work and the preparation for the visitations, may I say in passing, were made by Miss Mary Klemm who was appointed Field Secretary for the Women's Auxiliary, the first time such a position has been created, on September first to serve until this Annual Meeting in May.

The Vice-Presidents of the three Convocations have worked hard among the individual parishes and held and attended numerous meetings and conferences. In the Columbus Convocation a meeting was held during February at which fifteen parishes were represented with a total attendance of 133. In Dayton there was a conference with all the Educational Secretaries late last May and in February of this year, one with all the officers, fifty-four women from twelve parishes were present in Mrs. Burdoin's home to hear the President and the new United Thank Offering Treasurer. In the Cincinnati Convocation there have been two Convocational meetings,—on February 15—an all day one—at Christ Church, Cincinnati, with an attendance of 301 women from thirty parishes, and again on March 14 an evening one at Calvary Church, Clifton. Besides these two Convocational meetings the Vice-President held an officers' conference at the Diocesan House in January, and one in her own home on March 23 to introduce all the parish U. T. O. Treasurers to the new Diocesan U. T. O. Treasurer, Mrs. Woodhull, and again another in her own home on March 28 for all the parish presidents and the representatives of the Federation of Churches.

The work of the Supply Department, though in some degree curtailed by the time and energy necessarily devoted to the General Convention, has gone on most successfully and with the utmost loyalty and co-operation on the part of the individual parishes. Instead of the usual personal boxes last fall many of the largest Cincinnati parishes sent the equivalent in money. The boxes from the Diocese have gone this year to the following: St. Mary's Mission, Sagada, P. I.; St. Mary's, Hot Springs, Arkansas; St. Mary's-on-the-Mountains, Sewanee, Tennessee; Church of the Holy Apostles (this from Christ Church, Cincinnati); All Saints', St. Thomas, Virgin Islands; Patterson School, Ledgerwood North Carolina; St. Paul's Mission, Atlanta, Georgia; Baby's Ward, St. Luke's Hospital, Salt

Lake City (this from Christ Church, Glendale) ; New Bern Hospital, N. C. (gauze) ; and six personal and four Christmas boxes and a suit—with a total valuation of \$5,207.58. Every request sent to the Supply Secretary from Church Missions House has been met and the Hospital at New Bern—\$40.00 of gauze was a work of supererogation as Mrs. Hickenlooper asked for that over and above the requisitions received in the fall as well as the box to St. Mary's-on-the-Mountain, Tennessee.

The Memorial Scholarship Fund was used last summer to give Miss Flora Fender, the Educational Director of Calvary Church, Clifton, \$150.00 for a special course of six weeks at the Summer School of Columbia College. In the fall the Memorial Scholarship was given to Miss Thelma Howard, from St. Barnabas parish, Cincinnati, to take her training at the Church Army Training Centre, New York, \$650.00 being given for this purpose. The balance on hand in this fund is \$412.95.

It is with great pleasure that we report to you the formation of two new branches,—St. Hilda's Guild, Martin's Ferry, and St. Luke's, Granville, the number of branches now being 78.

The Board has held five meetings during the year and your Secretary has superintended the printing of the Supplemental Year Book—January 1 to June 15—to cover the additional period necessitated by the changing of year from May-May instead of January-January.

One of the most encouraging features of the past year has been the increasing closeness of the knowledge and relationship between the Church Mission of Help, the Church Parochial Club and the Girls' Friendly Society, as evidenced by the presence of representatives from each of these at all the meetings of the Auxiliary Board.

In bringing this already over long report to a close there is one member of our Board and that the most essential one of all, of whose activities I have made as yet no report, namely that of our President. These have been so multifarious and so varied in their scope that it seems impossible even to sketch them in . . . Besides presiding over the five Board Meetings, she was a member of the Executive Committee of the General Convention and head of all the woman's work ; she served on one of the teams for the parish visitations ; she has attended four meetings of the National Council ; was delegate to the Diocesan Convention ; she addressed the Annual Meeting of the Diocesan Auxiliary of Oklahoma, besides serving on the important Inter-racial Committee of the Auxiliary and also on the recently appointed Committee on Financial Policy of which Mrs. Allan McGregor has been appointed Chairman in place of Miss Mary E. Johnston, resigned ; she has also served on the Board of Strategy and Finance of the Diocese. What the Auxiliary in general, and the Executive Board in especial, owes to her wise leadership and her unrivalled knowledge of the whole Church

and the Mission Field, as well as to her wholesouled devotion to its cause, it is impossible to put into adequate words. It is enough to say that we were indeed fortunate to have her as our leader in this vitally important year of 1938. So—once more—it is with grateful hearts we turn over our stewardship to the new Executive Board, confident that the Auxiliary under their leadership will go on to greater and greater strength and that, like Timothy of old, they "will keep that which is committed to their trust."

PRESIDENT'S ADDRESS

May 17, 1938

The dominant note today in the hearts of your diocesan officers is thanksgiving for the opportunity given us to serve the cause of Christ through the Church in this diocese under a great bishop during the initial years of the Forward Movement, through the occasion of the General Convention's meeting in Cincinnati and the world-wide call given last summer to Christians to greater unity. Even though it has been a time of wars and rumors of wars with many a man's heart failing him because of fear, we have been reminded by our daily service for Him that Jesus Christ is indeed King; and we have experienced within this diocesan board a sustaining fellowship the theme of our Triennial meeting, that fellowship in faith and works which is being extended we hope in ever greater and fuller measure throughout our diocesan family and our worldwide brotherhood.

We are thankful too that the day approaches when we may hand on the responsibility for leadership in the Woman's Auxiliary in Southern Ohio to our successors. True, our term of office—due to a change in our revised Constitution,—is seven months short but three of these months are in the inactive summer period and I think I may say no Board has put in more hours of hard work than ours, due to the meeting of the General Convention last October.

It was because of this extra demand that at the last Annual Meeting, I announced the securing for our last ten months in office of a paid field secretary, her salary met by six interested women both on and off the Executive Board. I wish personally to testify to the consecrated and intelligent service given this diocese by Miss Mary Klemm. Only Miss Shaul and myself can know all that she has put into her work as about 50% of her time has been given to college and young people's work under the Department of Religious Education. I am sure you will want to wish Miss Klemm Godspeed as she leaves us for further study. We shall follow her and her future career with deep interest, feeling that she is at least an adopted daughter of Southern Ohio.

Fellowship is dependent on unity of spirit and co-operation in work; these your officers have striven to make their first objectives. The Woman's Auxiliary should be not only in a national but a diocesan sense auxiliary to all departments of the Church's life. For really efficient service there must be a co-ordinated program. To co-ordinate means to have action in common, a united movement, when necessary to adjust, to harmonize. I believe there should be but *one* program in a diocese so ordered that all our work may be *co-ordinated*. This is not easy to accomplish, it requires long time planning, joint meetings, better publicity, closer co-operation and a willingness to adjust our several plans for the good of the whole.

May I instance examples where we have made some advance and a few lines along which I believe the incoming board should proceed:

We have had of late in attendance at our Executive Board meetings the presidents of the so-called Co-operating agencies, (C.P.C., G.F.S., C.M.H.). There has been made a beginning in our mutual understanding of where we may supplement each other. We have much to give and much to learn from one another. Nationally there is a Joint-Committee of Woman's Auxiliary and Girl's Friendly Society leaders, exploring the possibilities of assigning different age groups as special interest areas severally to the national leadership and programs of these two organizations. Time is so limited at Board meetings with our officers coming from different localities in the diocese, that there has been little discussion of joint policies. Once a year, a meeting of selected officers might be held and devoted purely to mutual interests, working out a co-operative program.

There is a devoted staff of workers at our Diocesan House. Volunteers and professional workers invariably have to adjust themselves to fit into a co-ordinated program. It would pay the Church in this diocese to study more carefully where volunteer service on departments and committees could be more widely and widely used. At the moment we are failing to enlist or use much enthusiastic service. The Wayside Cathedral opens up vistas along many lines of personal work for men and women among the isolated, under-privileged or unchurched people of Southern Ohio.

The Publicity department asks for better news about our women's activities. Who can help to make the Messenger an even more interesting paper?

The proposed change in the date of our Diocesan Convention will call for adjustment in details of our Woman's Auxiliary Annual Meeting. I still believe we should meet in May and the Convention in January. Many dioceses have an Auxiliary meeting the day before the Diocesan Convention but no other diocese has so many women delegates to the Convention. Because of the problem of such a prolonged attendance of so many women, I have voted against the change but I foresee that it will at least be tried out and I am sure it is possible with Bishop Hobson's help to co-ordinate the two programs, making perhaps for the strengthening and enrichment of both.

One positive piece of co-operation with our bishop has rejoiced my heart. It was your general and generous response to my appeal in February for the deficit in the national budget. The sum of \$870.00 was pledged towards Bishop Hobson's promise of \$5,000.00 additional from this diocese. This came from 48 branches and three Convocational offerings and as far as I can judge was given cheerfully.

Our new Financial Policy—to be discussed tomorrow has wide implications. While its main provisions mean co-operation with our Field Department, it enjoins education and better discipleship—yet what department of the Church can function without both of these? And who can discover how to arouse the appetite among Church people for education and intelligent and independent thought?

I am amused and chagrined when I consider how little these past three years I have made of my opportunity to present the causes nearest my own heart. As a member of the National Department of Foreign Missions I have often failed to direct your attention outward from parish and diocese to the uttermost part of the earth, to Singapore our antipodes!

As for the study or any concerted action for World Peace, the thinking at our Triennial meeting was disheartening. We women should stress a positive, sacrificial program for Peace not a negative Pacifism. At the moment we seem to be working with both hands and not letting the left hand know what the right hand is doing—the weaker hand striving for boycotts and neutrality (negative things) while the stronger works for huge armaments against the time of America's entrance into a Defensive War!

Issues in our own communities on relief and housing, and state politics (Ohio has one of the most out-of-date penal systems and disgraceful prisons in the nation) require knowledge and action from Christian women. Thus could the Auxiliary best further Social Service.

The National Executive Board at the request of the General Convention has a committee of nine women Mrs. Robert Happ of South Bend, Chairman, co-operating with the General Convention Commission on the Marriage and Divorce Canon. This group hopes to make a positive contribution by its study of conditions and stressing Marriage as a *Career*. Can we in Southern Ohio help our younger church members with any constructive plans on this burning question of creating a Christian home, one of the major objectives of the Forward Movement?

Mrs. Henry Hill Pierce, one of the four women on the National Council, was the only woman at the recent meeting in Holland to form a World Council of Churches as a step towards final Church Unity, at least the only American woman. We have been stirred by the call to Unity—but how many of us have even read the Oxford and Edinburgh reports? In the moral bankruptcy of the League of Nations world peace awaits a United Church.

In the matter of better race relations within the Church, about which the Conference at Oxford spoke in no uncertain tone, thanks to the two visits of Miss Esther Brown and the Christian spirit shown by both races at our General Convention this board can report some slight progress in better understanding and in knowledge

of one another. We have still far to go. Our Negro branches are weak because they consist of professional or working women. We must adapt our Woman's Auxiliary programs and meetings so as to enlist the interest of a more varied group of Church members. Evening branches are a solution only in part as they vary greatly among themselves in the educational and economic backgrounds of their members. They present a challenge to us who have been able and accustomed to doing our "Church-work" by daylight, in our leisure time. Discipleship is an all-time job but special activities within the Church require a variety of schedules if we are not to confine our Auxiliary membership to one class or one age within a parish. Our future will not be bright if we neglect any section of our womankind.

This morning's service was planned as a demonstration of the worldwide, all-inclusive application of the gospel of Jesus Christ.

In closing I would quote from F. R. Barry's recent book, "What has Christianity to Say?" "There is in the end, only one way in which the Gospel can be made *convincing* that the Churches should themselves become societies in which people treat one another not in terms of income, class or privilege, color, nationality or party or any other accidental attributes but as sons and daughters of the Heavenly Father." And Barry adds "Perhaps they, the Churches—have hardly yet begun to do this!"

After nearly 2,000 years of the Good news of Jesus Christ who became Man that we might be made the sons of God! No wonder it is a bad, mad, sad World. We must pray with our Chinese brothers: "Lord, revive thy Church, beginning with me."

ANNUAL REPORT OF THE DIOCESAN TREASURER OF THE UNITED THANK OFFERING

December 3, 1937

At the beautiful Thank Offering Service held at Music Hall on October 7th, the women of Southern Ohio gave for the 1934-37 triennium \$35,744.34. This is \$2,360.00 less than what we gave in 1931, our largest gift, although we made a gain of almost \$8,000.00 over the offering of 1934. We now hold fourth place nationally. This is not entirely due to our efforts as Newark fell short of their 1934 offering and unless we take real strides forward in the next three years we will hardly maintain this position.

The following figures show the offerings of the first five dioceses for this triennium:

Diocese of Pennsylvania	\$80,152.25
Diocese of New York	76,307.67
Diocese of Massachusetts	44,807.46
Diocese of Southern Ohio	35,744.34
Diocese of Newark	34,533.60

The total amount of the offering for the three years from all dioceses was \$861,030.52.

Of this amount \$151,030.52 is going into the Pension Fund Capital Account and is to be named for Mrs. Soule, the founder of the Thank Offering. All the rest of the money will go for the training and maintaining of women in the mission field with a small amount for repairs on United Thank Offering buildings.

This is all very interesting, but the most thrilling figures and the ones which are really responsible for our gain of nearly \$8,000.00 in the triennium, are the ones showing the increase in the number of women giving:

In 1935	2795 women gave
In 1936	3389 women gave
In 1937	3793 women gave

This means that instead of a little over one-third of the women giving as was the case in 1935, now slightly less than one-half give.

As your retiring Diocesan Treasurer, I want to thank you for every effort you have made to increase the interest in the Thank Offering in your parish, and for your splendid support of me whenever I have called on you.

Mrs. Roger Woodhull of St. Paul's, Oakwood, Dayton, is my successor. She is starting as I did, with no experience in the work and feeling very timid. Will you please help her in every way possible?

This winter is the strategic time for us to hold all we have gained and not to allow interest to lag or members to fall away.

Please keep the United Thank Offering before the women of your parish, urging them to use their blue boxes often and thankfully.

I dislike giving up the work which has brought me so many splendid new friends and which has led me into such worth-while paths but as it seems necessary for me to do so, in parting, I can only say quite sincerely that I am at your service if I can be of help at any time.

Needless to say, my greatest pleasure is in reporting that within a week following Convention, my report of the Spring Offering is complete, all branches having co-operated by sending in amounts and number of women giving. This has been a real help and it is surely due to the zealous interest of the Parish United Thank Offering Treasurers. The increased number of givers is a most encouraging sign, all convocations reporting an increase over last Spring.

According to our records, there were in the Cincinnati Convocation ten parishes presenting their largest offering, and nine, the greatest number of givers; in the Columbus Convocation, three presented their largest offering and six their greatest number of givers in the Dayton Convocation, two had their largest offering and three, their greatest number of givers.

While the total of this Spring does not equal that of the Spring of 1937, yet the increase in number of givers is indicative of an increased interest which will, in turn, build up the amount of the offering.

REPORT ON EDUCATIONAL WORK

Several developments have taken place in the Department of Religious Education during the year. In an attempt to be helpful to all types of parishes the Church School Committee has extended its organization to include one representative from each parish and mission in the diocese. Ten sectional meetings have been held. A new Young People's Committee has been formed to act as advisors to the Young Churchmen Executive Committee and to work on program material. A Teacher Training Committee has come into being, under which two convocational committees have sponsored four-week seminars in religious education. The Woman's Auxiliary has co-operated in sponsoring and furnishing leadership for these Seminars. The Woman's Auxiliary tours, following General Convention, and the mission study of Rural America have likewise given impetus to the Church School and young people's groups. The field secretary, Miss Mary Klemm, has been of inestimable help to the Department, serving ex-officio and as a member of four committees, and also acting as leader at the College Workers' Conference and at numerous young people's meeting.

REPORT OF FIELD SECRETARY

September, 1937—June, 1938

Work with branches of the Woman's Auxiliary through speaking engagements and personal conferences, with young people through meetings in the convocation and diocese, work with the department of religious education through its adult education, college work, and rural curriculum committees, and consultation with the Auxiliary's Rural Work, Church Unity, and Church in the World Committees have been the areas of activity as field secretary this past year.

Members of the Rural Work of the Woman's Auxiliary included Mrs. Mary L. Dice and Mrs. G. I. Graham of Xenia, Mrs. Earl Estabrook and Mrs. Walter Mains of Greenville, Mrs. William Katker and Miss Nellie McCabe of Piqua, and Mrs. Leonard Wheeler of Troy. The group had mimeographed and distributed to educational secretaries in the diocese some facts about rural Southern Ohio as a background for the missions study subject for this year. At the annual meeting there were distributed copies of a list of rural missions near Southern Ohio to which women motoring in the summer might go, with highway routes to them. The committee made three recommendations to the annual meeting regarding services to educational secretaries for 1938-39.

The Church unity committee met nine times after its appointment in February, and has chiefly been concerned with educating itself on the issues involved in efforts toward church unity. Members of the committee included Mrs. W. B. White, Dr. Eliza Edwards, Mrs. George Barbour, Mrs. F. Jackson Daniel, Mrs. Clifford Chadwick, Mrs. Walter Tangeman, Mrs. Darwin Turner, and Miss Gwynedd Owen. The committee was responsible for promoting the World Day of Prayer among Episcopal women on March 4. The group has considered together the reasons for the historic divisions of the Church, and has studied the full reports of the Oxford and Edinburgh conferences. This committee drew its membership from parishes and missions in the city of Cincinnati.

The Church in the World committee was composed of Miss Louise McCune, Mrs. Charles Baird, Mrs. Lytle Zuber, Mrs. Laura Scott, Mrs. Chester Stine, the Rev. Mr. Stanley Plattenburg and the Rev. Mr. Almus Thorp, all of Columbus. This group sponsored an open meeting for Miss Alice Rex in Columbus on February 28 and a Quiet Day at St. John's, Worthington, on May 25. Miss Rex spoke on the Delta Co-operative Farm, from which she had just come after a year's work there in religious education. Bishop Jones of Antioch conducted the meditations at the Quiet Day in Worthington.

In co-operation with the department of religious education, opportunity was given the educational secretaries of the Columbus and Cincinnati convocations to "listen in" on the teacher training institutes of the two areas and to meet in a group to discuss applica-

tion of the principles of education to Auxiliary groups. The meetings were held the four Monday nights of February for Columbus and the four Monday nights of March for Cincinnati. Neither of the two groups was well attended by Auxiliary women.

The intelligent use of Forward Movement, National Council, and Woman's Auxiliary literature has marked the work of the branches of the Auxiliary in the diocese this year. The estimated distribution of free and purchased materials at the annual meeting alone was between 500 and 600 pieces.

Direct contact at least once with 34 branches was had during the year, with as many as six meetings with one branch. Co-operation with the department of religious education has included work with the adult education college work and the Wayside Cathedral curriculum committees, three meetings with local young people's groups, three convocational meetings, (of young people) and assistance with the Young Churchmen's Convention, the College Workers' Conference, and with the Leadership Clinic sponsored by the Young Churchmen of the diocese.

Assistance has been given several branches in planning programs and in securing speakers on the mission study subject for the year.

REPORT OF THE SUPPLY SECRETARY

During the year 1937-38 the Supply Department of the Diocese has shipped supplies amounting to \$5,207.58, to ten Missions and Hospitals, as Christmas presents to women missionaries in the domestic and foreign fields and, to six families of rectors in Missionary Districts.

Because of the Convention, the work in the parishes was started rather late in the fall, but, in spite of this delay, everything for the fall allotment was in, and the boxes were shipped at the regular time.

Christ Church, Cincinnati, sent a sum of money instead of a personal box to Rev. J. B. Clark, thereby giving an opportunity of trying this method, which was so warmly debated at the Convention. It will be interesting to hear the opinion of the members of the Auxiliary and also that of Mr. Clark apropos this way of giving.

It is with real regret that I turn over the duties of the office to my successor. For, although the work is hard, the compensations are great, and the friendship and knowledge of the parishes of the Diocese a real joy.

The Supply work is such an easy way of sharing and brings such satisfaction to all who help in it, that its value in the life of an auxiliary group is immeasurable.

May the incoming secretary have the same friendly co-operation as has been given to me these past years and the same happiness in working with and for the Parishes, in showing our friendship for those representing the Church in far distant places.

**MINUTES OF THE SIXTY-SECOND MEETING,
CHRIST CHURCH, DAYTON, OHIO**

May 17-18, 1938

The Sixty-Second Annual Meeting of the Woman's Auxiliary of the Diocese of Southern Ohio took place on Tuesday and Wednesday, May 17 and 18, at Christ Church, Dayton. The meeting began with a service of Holy Communion at which the United Thank Offering for the Spring of 1938 was presented—those parish treasurers who were able to be there presenting their parish offerings on the alms basin assisted by eight young girls from Cincinnati and Dayton, dressed in white with blue veils, and using the same blue bags to collect the offering from the rest of the congregation which had been used at the great United Thank Offering Service in Cincinnati on October 7, 1937. The sermon was preached by the Rev. Arthur M. Sherman of the Forward Movement Commission from the text St. John XII, V.32 "And I, if I be lifted up from the earth will draw all men unto me." The Bishop was the celebrant, assisted by the Rev. Phil Porter, Rector of Christ Church, Dayton, the Rev. Edmund H. Oxley of St. Andrew's, Cincinnati, the Rev. Ken Imai—the son of the first Christian convert made by Bishop Williams in Japan—and the Rev. Leighton T. Y. Yang of China, both these latter being students at present in the Graduate School of Religion in Cincinnati. Lunch was served in the parish house by the members of Christ Church.

The Annual meeting was opened in the church at half past two o'clock by the President, Miss Elizabeth Matthews with the singing of the hymn, "Through the Night of Doubt and Sorrow" (No. 539) and with short prayers. The first order of business was the introduction by the President of Mrs. Roland W. Baggott, president of the Christ Church, Dayton, branch of the Woman's Auxiliary who welcomed the Annual Meeting to Christ Church. The Secretary then called the roll—62 branches answering to their names, the largest number ever recorded at an Annual Meeting. The Secretary then read her annual report, which on motion duly made and seconded was accepted and ordered printed in the Year Book. The Treasurer, Mrs. Edward Wagner, then read her report for the year, copies having been distributed by the pages. Mrs. Marcus W. Crocker, St. Paul's, Columbus, moved that the Treasurer's report be accepted and printed in the Year-Book. The motion was seconded and carried. The President then read her address after which she stated that the report of the Trustees of the Diocese of Southern Ohio on the Memorial Scholarship Fund was on hand but it was too long to read to the meeting but it was open to any who might care to take the time to examine it.

The Field Secretary for the Woman's Auxiliary, Miss Mary Klemm, then made a report dwelling especially on the educational work done by her and her educational committees. These commit-

tees then reported briefly—Mrs. Earl Estabrooke, St. Paul's, Greenville, for the Committee on Rural Work; Mrs. Walter B. White, Church of the Redeemer, Cincinnati, for the Church Unity Committee; and Mrs. Charles G. Baird, St. Stephen's, Columbus, for the Church in the World Committee.

The president then announced the following committees:

Elections—Mrs. Frank H. Nelson, Christ Church, Cincinnati; Mrs. Cloyd Smith, Piqua; Miss Laura MacCracken, Urbana. Resolutions—Mrs. Mary L. Dice, Xenia; Miss Anita Fenton, Grace Church, Avondale, Cincinnati; Mrs. S. Donald Stone, Granville; Credentials—Miss Elizabeth Lucas, Chairman, Trinity Church, Columbus; Mrs. Lee Parrish, Trinity Church, Hamilton; Mrs. Edgar Tait, Urbana.

The Supply Secretary, Mrs. Smith Hickenlooper, then gave a short report dwelling on the variety of the fields to which the missions boxes from the Diocese have gone during the past Triennium, their value being \$13,750. She read a letter from the National Supply Secretary, Mrs. Wade, on the subject of the Hospital for Colored People at New Bern, North Carolina. As there is at present a balance of \$95.00 in the Household and Dispensary Fund, Mrs. Hickenlooper moved, seconded by Mrs. S. Donald Stone and Mrs. Marcus W. Crocker, that \$50.00 be taken from the fund and sent to the Hospital at New Bern for supplies and linens. The motion was carried.

The President then read the By-Laws for the conducting of nominations and elections for President and then introduced to the Annual Meeting the following: Mrs. S. Donald Stone, new Diocesan President of the Girls' Friendly Society; Mrs. David Larcomb, St. Paul's, Columbus, Ohio, newly elected National President of the Church Periodical Club; Mrs. Stanley Rowe, President of the Board of the Church Mission of Help; Sister Louise Magdalene of the Sisterhood of the Transfiguration, returned from China; Sister Thelma Howard now training under the Memorial Scholarship at the Church Army Centre in New York City; Mrs. Hobson; Dr. Arthur M. Sherman; Dr. E. H. Oxley; Rev. Ken Imai and the Rev. Leighton T. Y. Yang. The President told the meeting that to her regret Mrs. J. Vinton Blake, the newly elected Provincial Representative on the National Executive Board of the Woman's Auxiliary, was not able to be present owing to the severe illness of her husband.

Miss Matthews then presented to the Annual Meeting the chief speaker for the afternoon, the Rev. George VanBibber Shriver from Dornakal, India, who spoke on the subject of his work there and the present conditions and opportunities for spreading Christianity. At five o'clock it was moved and seconded that the meeting adjourn till the following morning at nine-fifteen. Tea followed immediately after the adjournment, served by the ladies of St. Paul's, Oakwood,

in the Christ Church parish house and St. Paul's Wayside Cathedral was drawn up in front of Christ Church for inspection.

At 6:30 the delegates and visitors sat down together at a dinner in the Hotel Biltmore, 281 being present. Miss Matthews opened the proceedings of the evening by turning the meeting over to the Bishop, who called on the following speakers to present different phases of Diocesan work: Miss Eleanor Gifford, who told of her work at Carbondale and in the Hocking Valley; Captain Estabrooke of the Church Army, now stationed at Greenville, who spoke of the work being done by the help of the Wayside Cathedral in the rural parts of Diocese; Canon Symons, who spoke on the Oxford and Edinburgh Conferences held last summer. After this, moving pictures of the Wayside Cathedral, as it goes about the Diocese, were shown. At the end of the meeting the new Diocesan United Thank Offering Treasurer, Mrs. Roger S. Woodhull, St. Paul's, Oakwood, announced the amount of the United Thank Offering presented that morning.

May 18th—an early service of Holy Communion was celebrated by the Bishop at 7 o'clock in Christ Church assisted by the clergy of that church, at which the prayers were read from the Book of Remembrance.

The Annual Meeting reconvened on the second day at 9:15 in the Church and was opened with short prayers by the President. The report of the Credentials Committee was made by the Chairman, Miss Lucas, as follows:

On motion duly made and seconded it was accepted. The report of the Nominations Committee was then made by the chairman, Mrs. Frank H. Nelson. She reported that the only name submitted had been that of Mrs. Hugh M. Bone, St. Alban's, Bexley, Columbus. This report was received by the President who then called for nominations from the floor. There being none Mrs. Roger K. Rogan, Glendale, moved—seconded by Mrs. Robert Sulzer, Wyoming, that the nominations be closed. This was carried by a rising vote. Mrs. S. Donald Stone then moved—seconded by Miss Louise McCune, Trinity Church, Columbus, that the secretary be empowered to cast the ballot for Mrs. Hugh M. Bone for President. This was carried. The secretary declared she had done so and that Mrs. Hugh M. Bone was the duly elected President.

The United Thank Offering Treasurer, Mrs. Roger S. Woodhull, then made her report again of the offering—\$5,752.72 this Spring with a gain over last Fall of 25 givers. Mrs. S. Donald Stone then spoke briefly on the subject of the Girl's Friendly Society dwelling especially on the opportunities for co-operation between the two organizations in the training of teachers. Miss Hilda Shaul, Advisor in Religious Education in the Diocese, spoke briefly on the subject of Religious Education.

At the president's request the secretary read to the Annual Meeting excerpts from a letter written from China by Miss Elise Dexter, Missionary, of the remarkable speech made by Madame Chiang Kai-Shek to the Christian Missionaries of all communions recently assembled to meet her in Hangkow. The president read some brief publicity notes about the splendid work being done by Sister Constance of the Sisterhood of the Transfiguration among the refugees at Wuhu, China.

The report of the Financial Policy Committee was then heard from the Chairman of the Committee, Mrs. Allan McGregor, Christ Church, Springfield. Miss Matthews introduced the report by stating the reasons for the necessity of revising the Financial Policy of the Auxiliary and stated that the present proposed policy was the work of a committee of seven women who had been selected by a larger group of women—five from each Convocation, who together with the Bishop and the President had been working on the Financial Policy. (Financial Policy as printed on page). Mrs. McGregor presented the Committee's report and moved its adoption which Mrs. Rogan seconded. It was then discussed article by article and the following delegates took part in the discussion: Mrs. Tangeman, Mrs. Richard Fowler, (St. Paul's, Oakwood, Dayton,) Mrs. S. Donald Stone, Miss Hilda M. Shaul, Miss Colston, Mrs. Burdoin, Mrs. Marcus W. Crocker, Mrs. Edwin D. Stackhouse, (St. Alban's, Bexley, Columbus) and the Bishop. After an hour and fifteen minutes of this discussion Miss Matthews announced that she was ready for the question and the motion for the adoption of the new financial policy was carried. Mrs. McGregor then moved—

seconded by Miss Louise McCune, (Trinity Church, Columbus) that an article governing the Central Expense Fund be put into the By-Laws by the action of the incoming Executive Board. This was carried.

Mrs. David Larcomb, newly elected National President of the Church Periodical Club, then had the floor and spoke briefly on the work of the Church Periodical Club in this Diocese and of the coming 50th Anniversary of the founding of the Church Periodical Club.

Mrs. Mary L. Dice, Chairman, then presented the report of the Resolutions Committee as follows, and moved its adoption:

It was seconded by the following: Article I by Mrs. Richard Fowler; Article II by the same; Article II by Mrs. Frank Biddle, (Church of the Redeemer, Hyde Park, Cincinnati); Article IV by Mrs. Roger K. Rogan, (Christ Church, Glendale); Article V by Mrs. Walter G. Sulzer, (Church of the Ascension, Wyoming); Article VI by Mrs. Katherine Ackert, (All Saint's, Portsmouth). The adoption of the Report of the Resolutions as a whole was seconded by Mrs. Lawrence Hall, (St. Barnabas, Cincinnati), and was carried.

The Committee on Resolutions recommends the following:

1. That the Bishop's Discretionary Fund be presented not later than the middle of October, 1938, instead of in November.
2. That the following names compose the Committee for the approval of the minutes of May 18th—Mrs. Sidney R. Teasdale, Mrs. Roger K. Rogan and Mrs. Edward Wagner.
3. That the offering at the 7 o'clock Morning Service of May 18th amounting to \$38.54 be given to the work of the Mission at Carbondale, Ohio.
4. For the Opening Service, the Committee wishes to thank Bishop Hobson and the assisting clergy, representing three races, which attested to the brotherhood of Christianity.
5. It desires to express its appreciation of the eloquent address of Dr. Arthur M. Sherman, and to thank the Rev. George van B. Shriver for his talk on India.
6. The Committee wishes to testify to the consecration and devotion of Miss Elizabeth Matthews which has made of her term of office as President, such a significant witness for Christ.
7. The Committee would thank Dr. Porter for the Services in Christ Church, and the ladies of the four Episcopal Churches in Dayton for their generous hospitality; also the organist, Mrs. Elizabeth A. Helmig, the choir and the pages for their efficient services.

8. The Committee recommends that a telegram be sent to Mrs. J. Vinton Blake and to Miss Catherine Morrison expressing regret that on account of illness, they could not be present at this meeting.
9. The Committee would express appreciation of the integrity and creativeness of the leadership of Miss Mary Klemm in her position as Field Secretary to the Woman's Auxiliary.
10. The Committee endorses two of the recommendations of the Rural Work Committee which are as follows:
 - a. That a postal card be mailed monthly throughout the year to educational secretaries, pointing out new materials, particularly in magazines, useful to use in the educational program.
 - b. That local educational secretaries be encouraged to ask libraries to set up a special shelf of books for supplementary reading by Auxiliary members, the books to be in the two fields of the mission study for the year.

The Committee feels that it cannot endorse the third recommendation:

- c. "That a meeting-by-meeting program be drawn up in the Fall for Auxiliaries in the Diocese with particular regard for local and Diocesan needs and interests."

It feels that this would be a backward step in educational work.

We move the adoption of these resolutions.

Miss McCune spoke briefly on the subject of the increasing demands being made on the Central Expense Fund, particularly from the ever-increasing cost of the Annual Meeting, and issued a word of warning against expecting it to assume too many obligations.

The President then announced that it had been necessary to order the leaflets for the World Wide Day of Prayer (Nov. 11th) at this time and that she had ordered the same number for the Diocese as last year (2,500).

The Annual Meeting then adjourned temporarily for the holding of the Vice-Presidential elections for the three Convocations. Upon reconvening the following results of the elections were announced: Cincinnati Convocation for Vice-President, Mrs. Roger K. Rogan, Christ Church, Glendale; Columbus Convocation for Vice-

President, Mrs. Jonas McCune, St. Paul's, Columbus; Dayton Convocation for Vice-President, Mrs. Brown Burleigh, Christ Church, Springfield.

Mrs. Hugh M. Bone, the new President-elect, then spoke a few heartfelt words of appreciation to the Auxiliary and expressed her hope that she would be enabled to carry on the work entrusted to her by the Auxiliary. There being no further business and the hour being now 12:45 the Annual Meeting, on motion by Mrs. Rogan and seconded by Mrs. Tangeman adjourned for the closing prayers which were taken by the Bisohp.

FINANCIAL POLICY

ARTICLE I

The Auxiliary by education and example shall be an inspirational force in the parish to establish a proper sense of Christian stewardship and to set a definite standard of giving.

We would stress that this should begin with the children in the home, and carry through the Church School and young people's organizations.

All financial efforts of the Woman's Auxiliary shall be consistent with the primary function of the Auxiliary, which is to support the whole program of the whole Church.

ARTICLE II

The Woman's Auxiliary has a financial responsibility toward the Parish, the Community, the Diocese, the Nation, and the World.

While this responsibility differs in individual parishes, no one of the five fields may be neglected for vital growth and development in parochial life.

ARTICLE III

It shall be the duty of every branch to aid in raising the parish pledge for the Church's program.

- (a) By urging a thorough every member canvass and helping with it.
- (b) By urging the adoption or retention of duplex envelopes, and by giving through this envelope system.
- (c) By giving as an organization when necessary.

ARTICLE IV

Special appeals are legitimate if endorsed by diocesan authorities.

ARTICLE V

Money-raising projects may be necessary and permissible, for their fellowship and for the development of leadership, as well as for financial gain, provided the methods used do not destroy values which the Church is trying to build up in the individual and the community.

CONSTITUTION AND BY-LAWS

Constitution

ARTICLE I

Name

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the United States of America."

ARTICLE II

Object

The object of this Association shall be to carry out by united systematic effort in the Diocese of Southern Ohio, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service in the five fields, namely: Parish, Community, Diocese, Nation and World.

ARTICLE III

Membership

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

ARTICLE IV

Officers

The officers of this Association shall be the Bishop ex-officio, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, an Educational Secretary, and a Custodian of the Book of Remembrance. These officers with any member of the National Executive Board resident in the Diocese, shall constitute the Executive Board of the Association.

ARTICLE V

Duties

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association and shall have power to adopt by-laws for the Association.

SECTION 2. The President shall be elected at the annual meeting held the spring after the General Triennial Meeting, to serve

for three years, but shall not be eligible for two full consecutive terms. She shall, with the Bishop's approval, appoint all other Diocesan (Auxiliary) officers, except the Vice-Presidents, to serve for three years, but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers, but immediately at the close of the General Triennial Meeting, to serve throughout the Triennium. The President shall call meetings of the Association and of the Executive Board, and shall preside at them. She shall exercise a general supervision over the work and shall further it in every way by her interest and advice. In the case of a vacancy in the office of President, such vacancy shall be filled until the next annual meeting by appointment made by the Bishop and a committee of two selected by the Executive Board.

SECTION 3. Each Vice-President shall be elected by the members of her Convocation to serve for three years, at the time of the annual meeting at which the President is elected, but shall not be eligible for two consecutive terms. A Vice-President, with the approval of the President, may appoint other convocational officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation, she shall co-operate with the President in promoting local information and interest and in directing local organizations and work in her own Convocation.

SECTION 4. The Secretary shall keep the minutes of the Annual Meeting and of the Executive Board, and shall give notice of meetings. She shall conduct such correspondence of the Association and the Executive Board as directed by the President. She shall also make an annual report to the Association from data furnished by the other officers and shall prepare and edit the year book.

SECTION 5. The Secretary of the Supply Department shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Association.

SECTION 6. The Treasurer shall record, receive, disburse and keep account of all money distributed, except the United Thank Offering; and shall also make an annual report of the same.

SECTION 7. The Treasurer of the United Thank Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence and visitation. She shall report annually to the Association the amount on hand, and shall forward the same semi-annually to the treasurer of the National Council.

SECTION 8. The Educational Secretary shall have general supervision of all educational work carried on under the auspices of the Woman's Auxiliary in the Diocese.

SECTION 9. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible, for the care of the Book of Remembrance, and for the promotion of the Memorial Scholarship Fund.

ARTICLE VI

Meetings

SECTION 1. There shall be an annual meeting of this Association each spring. Every parish and mission branch may send three delegates in addition to any officer of the Diocesan Board of the Woman's Auxiliary. Except in the election of a President, members of the Executive Board of the Woman's Auxiliary may vote on all questions before the house.

SECTION 2. The Executive Board shall meet at least twice a year, five officers constituting a quorum.

SECTION 3. Convocational meetings shall be held on the call of the convocational officers.

SECTION 4. Delegates and alternates to the Triennial Meeting shall be elected by the active membership of the Auxiliary by a majority of the delegates to the annual meeting next before the Triennial. Nominations may be made by any delegate to the annual meeting.

SECTION 5. Delegates to the Provincial Synod shall be chosen by the Executive Board.

ARTICLE VII

Mode of Election

SECTION 1. In the election of a president any delegate may nominate; all nominations must be written; all elections must be by ballot and each parish and mission shall cast but one vote.

SECTION 2. Unless there be an election by a majority on the first ballot, the chair shall announce the two names having the largest number of votes, and subsequent balloting shall be upon these two names until a majority vote is reached.

SECTION 3. Prior to the election of vice-presidents, a nominating committee in each Convocation shall be appointed by the vice-president at a meeting which shall precede the annual meeting. Such nominating committee shall select nominees to be presented for election at the Convocational meeting held in connection with or at the time of the annual meeting. Election shall be by ballot. Each delegate shall be entitled to one vote.

ARTICLE VIII

Amendments

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates present at any annual meeting, notice of such proposed amendment having been given at the previous (annual) meeting.

By-Laws

The Executive Board shall determine the time of and place for the annual meeting.

1. The Order of Business at any Annual Meeting shall be :

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish Election of delegates shall take place during the month preceding the annual meeting, and shall be immediately reported by the local secretary to the diocesan secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expense of officers and speakers, necessary expenses of the Educational Department, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. The Diocesan Central Expense Fund shall be raised in the following manner :

(a) There shall be fourteen classes paying as follows :

A—\$75.00	H—\$20.00
B— 60.00	I— 15.00
C— 50.00	K— 10.00
D— 40.00	L— 7.50
E— 35.00	M— 5.00
F— 30.00	N— 3.00
G— 25.00	O— 1.00

- (b) Each branch shall decide to which class it will belong.
- (c) Each parochial treasurer shall yearly notify the diocesan treasurer to which class the branch belongs.
- (d) The Central Expense shall be the first obligation of each branch, and shall be paid for the current year during the month of January.
- (e) Payment of the Central Expense is necessary for membership in the Diocesan Branch of the Woman's Auxiliary.
- (f) Diocesan Dues to the national organization shall be paid from the Central Expense.

Specials assumed at the Annual Meeting are the responsibility of parochial branches.

5. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a parish committee, consisting of the heads of all women's organizations within the parish, acting with the rector.

6. When a name is presented for inscription in the book of Remembrance, it shall be accompanied by some memorial gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the trust fund known as the Memorial Scholarship Fund.

7. The Book of Remembrance may be used at all Diocesan meetings, such as the annual meeting of the Woman's Auxiliary, the annual service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

8. Local receipts for the United Thank Offering shall be remitted to its treasurer in April and October except triennially in September.

9. The accounts of the treasurer and the treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

10. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.
