REPORT OF THE SECRETARY

January to May, 1937

Madam president, members of the Executive Board, Delegates and Visitors to the sixty-first annual meeting of the Woman's Auxiliary of Southern Ohio: My report to you as secretary will, happily, be a brief one, covering only the period from January to May, as in the Year Book of 1936, the secretary's report as therein contained, covers the whole year, carrying on where it left off at the Annual Meeting last May in Zanesville. (This is owing to the curious manner we are forced to hold annual meetings under our present Constitution whereby once in the triennium we hold two annual meetings within six months of each other and let eighteen months elapse before holding another!) The chief work of the secretary during the early part of the year was the preparation and printing of the year book which we had hoped to have ready for sending out to you by Ash Wednesday but owing to unforeseen delays such as floods, etc., it was not until the middle of March that it was finally finished and sent out to you. A good many changes were made in its general form and we hope you have considered these improvements. Unfortunately there are several bad mistakes in the printing of some of the names, for which I am very sorry and apologize to you for them and ask your indulgence. By the next year book, I will be much more experienced and we hope to make other changes still which will be improvements and which will make the book more valuable to you and consequently more used. Five hundred and twenty-five (525) copies were printed, seventy-five (75) more than last year, and they were sent out to all parish officers (excepting vice-presidents) as well as to all the clergy.

Your president, Miss Matthews, has presided at the three Board meetings held during these past six months (January to June 15), has attended one meeting (February) of the National Council, besides many meetings of the Executive Committee of the General Convention, and was present at the Diocesan Convention. She has visited and spoken in five parishes and has appointed two new committees, an Interracial Committee with herself as chairman, and a Committee on Standards, with Miss Shaul as chairman. Besides these activities your president has written personal letters to each one of the clergy of the Diocese, asking them to observe the Good Friday Offering for the support of our Church's work in Jerusalem.

In the Columbus Convocation the vice-president, Miss Louise McCune, has attended an all-day meeting of the Woman's Committee of the Ohio Council of Churches, and led the devotions at the World Day of Prayer in St. John's Parish, Worthington. She has written to each President in her Convocation, commenting on the report of her branches as shown in the year book, and has attended the meetings of your Executive Board in January and

May. She has held two conferences with the educational secretaries of nine parishes, and one with the presidents of five parishes.

In the Dayton Convocation your vice-president, Mrs. Alfred F. Burdoin, has visited four parishes and has helped to promote and has also attended the Educational Days held by Miss Shaul in Dayton during April. She has written personal letters to thirteen of the parishes, besides helping intensively both with her advice and her frequent presence at their meetings, the newly formed evening branch of St. Hilda's Guild, at Christ Church, Dayton. She has also attended the three meetings held by the Executive Board.

In the Cincinnati Convocation, the vice-president, Mrs. Walter W. Tangeman, held an evening convocation meeting on Wednesday, February 17, at the Church of the Advent, at which Bishop Clingman of the Diocese of Kentucky was the preacher, his subject being "Why Missions?" Between three hundred and fifty and four hundred were present at the meeting. The offering, amounting to \$252.24, was voted to Bishop Clingman, for help in the rehabilitation of his churches damaged by the flood. Mrs. Tangeman has also held two meetings for all the presidents in the Cincinnati Convocation; has acted as secretary for the annual meeting of the Woman's Department of the Federation of Churches held in Cincinnati on February 25; has visited and spoken in three parishes and has also attended many meetings of the General Convention Committee, besides the three meetings of the Executive Board.

There have been four meetings of the Interracial Committee. Your Executive Board takes great pride in calling to your attention the fact that our representative on the National Executive Board of the Woman's Auxiliary from Southern Ohio, Miss Mary E. Johnston, was elected last September to serve as chairman of the National Executive Board for the year September, 1936, to September, 1937. Of the rest of the work of your Executive Board you will hear in the reports from the other members themselves, from which you will be able to gather, we trust, the fact that they have not been idle and that under their leadership and with your loyal, faithful support, the work of the Woman's Auxiliary in the Diocese is, in this busy and momentous year of the General Convention, being carried on with wisdom and vigor.

PRESIDENT'S ADDRESS

May 18, 1937

The reports of our Secretary and Treasurer have given you a summary of the year's work, and our other officers will report shortly in greater detail on our usual Auxiliary projects. Past achievements are not so much part of the president's address as the future responsibility that grows out of them.

The main subject that concerns us all at the moment is the coming of General Convention and the Triennial Meeting of the Woman's Auxiliary next October. The Program of this Annual Meeting has been built around this event; especially will tomorrow's business session be largely devoted to this consideration. It is our earnest hope that this Annual Meeting will help us all perform better the office and service called for from us in October.

However the meeting of the Triennial in Southern Ohio may become—unless we plan wisely in advance—an actual detriment to the hostess diocese, should we allow ourselves to be diverted from our regular and required work or permit a sag in interest next November because of fatigue. A certain reaction may be unavoidable, part of the natural rhythm in life, but if on our guard we can check the tendency in ourselves and our parishes.

On the other hand, the experience of seeing the Church, of which we are component parts, in action, the resultant education, inspiration and fellowship should mean a tingling of new life throughout the diocese. It is the hope of your Executive Board that very many women in Southern Ohio will strive to be present in Cincinnati for some part of those two weeks and if this hope is realized next winter will present us with a challenge for forward work such as Southern Ohio has not known in a generation. We confidently expect that many a parish will want to reorganize its womanhood uniting Guild and Auxiliary in a more comprehensive and truly missionary program of worldwide service, enlisting many more of the younger women than heretofore. How this can be accomplished has been the question in our minds all winter.

We have come to the conclusion that the situation requires a new officer on full time, possibly only a temporary position which we shall term that of a field secretary—some one who can stay longer in a parish than any volunteer officer can—and in this belief on September 1 Miss Mary Klemm, for the past three years at the University of Cincinnati as Y. W. C. A. student worker, will become part of our diocesan staff working closely with Miss Hilda Shaul, undertaking some work with the Young Churchmen and college students, helping our parochial Woman's Auxiliary Educational secretaries where there are such officers, finding persons to fill the office in parishes where such do not now exist, training classes in the use of discussion, answering questions about program—and programs—the use of the plural narrows the word

—helping us to solve problems of organization, doing in fact all that our National field workers have been doing for some ten years elsewhere for the development of woman's work within the Church or better development of the Church through women. Miss Klemm's salary has been undertaken for ten months by members of the Executive Board and others interested.

Immediately following the General Convention the Preaching Mission—an interdenominational venture touching 28 cities in which Stanley Jones and Mrs. Sibley and Bishop Hobson all shared this past winter but which missed Cincinnati, will be with us from October 31 to November 3. It has seemed to the Executive Board that the usual fall Convocational meetings would be somewhat of an anti-climax in November. Many women will have been away from home as much as they will feel they can with household and family duties pressing on their attention. Cincinnati parishes will have had a feast of meetings.

Therefore we plan something different. In Cincinnati where it is easy for individuals from each parish to meet we shall plan a series of officers' conferences of varied sorts and as stimulating as possible by means of which we shall strive to carry out the findings of the Triennial and General Convention. Weather does not condition meetings so seriously in this Convocation and these meetings could be continued almost to Lent (March 2) and be considered a serious sustained effort for the training of parochial officers. Something on a smaller scale might be attempted in the city of Columbus.

In the other two Convocations with their scattered churches we ask your consideration of this plan: A visit by a team, consisting of perhaps two members of the Executive Board and two other qualified persons, to every parish for one full day during which to confer with all the women of the Church and its rector on the theme "What should the Convention mean in renewed life in St. James—or St. John's or Holy Trinity?"—as the case may be.

To reach something like thirty-six places in two or three weeks in November requires your cooperation. It will mean first accepting the day chosen for you by the Executive Board and accepting wholeheartedly the team whose itinerary carries them into your neighborhood. It will require further planning locally to serve a simple meal either at a restaurant or served by women of another communion. We shall fail in a difficult undertaking unless we reach as nearly 100 per cent of your womanhood as is humanly possible. This parochial visitation will mean hard work for your officers and others who will be asked to serve with them on these teams. But if this idea meets with your favor, the general outline, itinerary and dates can be set-up at our Board meeting June 7 and the details perfected in September.

To follow up this parochial plan of visitation we shall have Miss Klemm and Miss Shaul our Educational Advisor. Also at the

earnest request of our Board the National Executive Board has agreed that Miss Esther Brown may stay on in Southern Ohio after General Convention to build on the foundations already laid in her first visit. Miss Brown is a natural link between our study of this past year and the subject of the Church and Rural America. While in this diocese the Negro and Racial Problems are usually considered an urban question if we are to see Rural life in its national aspect, we must know of the crucial agricultural situation in the south. We should not study rural life in Ohio without seeing it in its larger frame, the national, political and economic aspects. Then there is our own diocesan venture of a "Wayside Cathedral." Our study should lead to effective cooperation from the Auxiliary with the Bishop and Field Department. Our Bishop's Chapter of the Woman's Auxiliary has not grown beyond its initial six members. We have an exceptional opportunity next winter to concentrate our efforts on the development of our own diocese,—the Church in smaller towns and rural areas.

The subject chosen for the foreign field is the Moslem World, this and the findings of the two great Ecumenical Conferences to be held in Great Britain this summer will widen our vision and keep us from becoming ingrown in our interests.

We have also to make a real attack on forming a new Financial Policy. You will recall that this was a main issue in Zanesville last May. Without discredit to an able Committee which you empowered me to appoint, there will be little to report at this meeting. One committee meeting was held last fall, but when I foresaw how crowded this Annual Meeting was to be and that National action in October either by General Convention or our own Triennial would certainly effect our decisions, I advised the Chairman, Mrs. Graves of Worthington, not to press for further meetings. I believe this Committee should be continued and enlarged, possibly three Convocational groups should discuss the problem of Auxiliary finances as related to parish, community and the diocesan and General Church programs. These Convocational groups should then send representatives to a smaller committee to bring in findings to us next May for adoption or still further study. Tomorrow there will be place made for Mrs. Graves to report any progress made to date.

The Supply Department will be reported to you by Mrs. Hickenlooper. I wish to call your attention to ways in which this work need not be curtailed next winter. I trust the Cincinnati branches of the Woman's Auxiliary will meet in September and omit October meetings during the General Convention. Some groups might hold a few summer sessions for sewing. The bulk of the responsibility falls in October on a few Cincinnati parishes, notably Christ Church. Can't more distant branches undertake more supply work in the fall, letting Cincinnati concentrate on the Spring allotment? Mrs. Hickenlooper may suggest trying out what the National Executive Board recommends—sending a check instead of pur-

chases when filling a personal box. We must not make any privilege of being hostess to the Triennial an excuse for failing to carry our share of work next winter.

There is a provision in the Constitution whereby the Diocesan United Thank Offering treasurer is henceforth to be appointed for the Triennium and at each Triennial Meeting present the fruit of the six offerings for which she alone has been responsible. Therefore if Mrs. Rogan will not allow me to re-appoint her for another three years, a new diocesan treasurer will be announced to you next fall to take office November 1 and to work closely with Mrs. Rogan in September and October. The Board will regret losing such a member as Mrs. Rogan but if family responsibilities prevent her accepting another term we shall try to follow on and build on her splendid service an enduring fabric. It is natural that in the third year of a triennium the offerings increase in size but there is no reason why the first offering following the presentation should fall so far behind the last made. Especially should we avoid this decline in Southern Ohio next April. Mrs. Rogan will propose a resolution for your consideration fixing a date for each fall and spring offering. Some believe this will be helpful. There are both pros and cons which there may be time to discuss tomorrow. If we are convinced that it is good to have one woman in the diocese responsible for a triennium it would seem wise if parishes would also come to this decision. It was disconcerting to have so many parochial treasurers change in January.

The Revision of our Constitution comes before you tomorrow. The most momentous change is the change in our year, allowing for the election of the diocesan president in May. This change to work with maximum efficiency should be synchronized with parish officers being elected in the Spring also. If we can have a greater measure of uniformity, we can print our Year Book in the summer and have a correct list of officers for our working year. We can use Gambier and other summer conferences for preparation for fall work; and we may be able to tide over the Christmas and January slump if we can plan our work as a unit. The Annual Meeting would fall in the second half of May and our financial year close May 31; a new president triennially taking office June 1 with a period of comparative leisure in which to pick her Executive Board.

This stipulation that the president chooses the major part of the Executive Board is I believe unique in our branch of the Auxiliary and we do not propose to change it. We think it works but at the time it was first enacted (1901) motor cars were rare indeed and the custom has grown up of concentrating a Board in the Convocation from which the president is elected. It is not part of our Constitution but a tradition somewhat rigorously adhered to that each Convocation has the office of President in turn. Personally long experience of the way in which this provision

works makes me unwilling to see it in the Constitution but neither should the custom be lightly set aside. However we should be free on occasion to pick the right woman irrespective of geographical location. The advantage of rotation in Convocation might be strengthened if every board was a diocesan board and potential leadership for the appointed officers chosen wherever found. There is the possibility now of developing individuals at the sacrifice of parochial development. Too inexperienced a board leads to weakness in diocesan leadership while the provision that no president is eligible for two consecutive terms seems sufficiently to guard the principle of rotation in office. Many an appointed officer could do better work during a second term than during her first and we know that nationally our quick turnover in Southern Ohio is regretted.

There is an amendment to the proposed revision of the Constitution which will be presented tomorrow by a member of the Executive Board. The revision as sent you provides for one delegate only from a branch (of the Auxiliary) in a mission—this follows the diocesan and General Convention provisions for representation and not that of the National Woman's Auxiliary which puts only the usual limitation of representation on the weaker places which often need the inspiration coming from attendance of a larger delegation than one lonely woman.

We are planning for a Nominating Committee for Vice-Presidents. Do you think it wise to provide for such for the President also? To date we have had only a Nominating ballot. Frankly this has made to all intents and purposes the outgoing Executive Board the Nominating Committee; as no outgoing president would risk an election without knowing that there was a candidate willing to accept if elected. Whether our present method works well is not for me to say. It is on the face of it more democratic than the choice of a Nominee by a small committee, whether actually it allows freedom of choice is for you to decide tomorrow. One further matter, in regard to allowing a parish where there are two or more branches representation of six or more delegates, ideally there is but one branch of the Auxiliary in a parish. Our Constitution recognizes this when in Article 7, Section 1, it allows but one vote for President from each parish or mission. The provision of two branches in a congregation has been permitted however because at times it seems the only possible way to include a new group or younger group of women. Ideally there should be but one branch in a parish with as many chapters meeting at different times as will allow for the inclusion of all sorts and conditions of age, tastes and abilities; never because of cliques or inability to work together!

Nothing is such an evidence of the failure of a parish to be doing the work of Christ among its members as quarreling or faction. An Auxiliary can hardly be a missionary agent in the

world where its existence has come about through any such circumstance. Worshipping and working together is the discipline that Christ demands of His followers, we are to work in harmony with those who differ from us having them supplement our weakness or maybe our very strength. We must learn to work with those whom we may even think we dislike! I wonder how many of you have had the salutary experience that has been mine this Spring of thoroughly disliking myself on occasion, disliking my fits of irritation and dispondency. I have found myself very hard to work with! Alas! for others! I can only trust that they are half as quick to make excuses for me as I am to find excuses for myself!

Finally you are to elect five delegates and five alternates to represent this Southern Ohio branch at the Triennial Meeting; nearer the time we shall pray for guidance to select wisely. Shortly I shall appoint an Elections Committee with other Committees to conduct our business. We shall want to vote our usual gift to Bishop Hobson's discretionary fund and to vote on the disposal of our Offerings.

There is much left unsaid even in this lengthy address, fortunately there are others to follow on our program able to say many things better than I, but no one has the welfare of the Church in this diocese or the outcome of the General Convention more at heart than your President.

REPORT OF DIOCESAN TREASURER OF THE UNITED THANK OFFERING

May 18, 1937

Having been ill for the past few days, I have had some extra time and I have been looking over the records which were handed over to me when I became Treasurer and which go back to 1931. It has been very interesting to see the steady growth of the United Thank Offering in the newer and smaller places, the year after year dependability of some of the older parishes and, recently, the amazing records that some parishes have made—notably those along the Ohio River—through and in spite of their great distress this past year.

I hope that the representatives of the churches in Gallipolis, Ironton, Marietta, Martin's Ferry, Pomeroy and Portsmouth will forgive me for mentioning their parishes, but I feel that the other women of the Church should know how magnificently these places have carried on in the face of repeated disasters.

St. Peter's, Gallipolis; St. Paul's, Martin's Ferry; Christ Church, Ironton, and All Saints', Portsmouth, had the largest offerings and largest number of women giving this spring, of which I have any record. St. Luke's, Marietta, came within a few cents of her largest offering (which was last fall) and had more givers than ever before. While Grace Church, Pomeroy, though not quite touching her largest offering (that of last fall, which was three times any previous one) still had more givers than ever before.

Taken by Convocations, twelve parishes in the Cincinnati Convocation had their largest offering this spring as far back as my records go (1931) and seven of these also had their largest number of givers. Five more parishes had the largest offering except for one other time with one of these having its largest number of givers.

In the Columbus Convocation, eight parishes had the largest offering this spring, as far back as 1931, and nine additional parishes their largest but one, with seven of the seventeen showing the largest number of givers.

In the Dayton Convocation, ten parishes had their largest and three more their next to largest offering this spring with five of the thirteen having the largest number of givers.

This means that thirty parishes out of seventy-six gave more this spring than they have at any time for at least six years, that seventeen more parishes gave more except for one other time in that same six years and best of all that twenty parishes had more givers this spring than at any other offering in the six years.

I cannot close without mentioning the four parishes that have reached our goal of 100 per cent: Holy Trinity, Oxford; St. Matthew's Mission, Bond Hill; Grace Church, College Hill; St. Mary's, Hillsboro.

And now I must get down to the dull business of figures but I hope that hearing of the great progress that so many of the parishes have made, will make the figures more alive and I want you to realize as I read them that in the offering for this spring, as against any other single offering back to 1931, every figure stands unchallenged, both in amount given, and in number of givers:

In response to these letters thirty-nine parishes sent in names. In all eighty-three names were recorded. This list of names was printed on leaflets and distributed at the early morning Memorial Communion Service in Christ Church, Cincinnati, on May 18 when Bishop Hobson read the list.

With these names were received various sums of money to be added to our Memorial Scholarship Fund; they totaled \$995.90.

The Diocese is indebted to Miss Judith Colston for a leather case in which to carry the book. In the fastening for this case, which was very ingeniously conceived and made by the Rose Hill Bindery, of Boston, Massachusetts, the gold was used from a ring which was presented to Mrs. Montgomery Rochester by the women of the Church of the Advent, Cincinnati, after twenty years of devoted service as the sole officer of their Woman's Auxiliary.

REPORT ON EDUCATIONAL WORK PRESENTED TO THE ANNUAL MEETING OF THE WOMAN'S AUXILIARY ON MAY 18

The educational work of the Woman's Auxiliary during the past year has focused about one of the missionary themes recommended by the National Woman's Auxiliary for the year 1936-37, The Negro in America. The Executive Board in looking forward to this study invited Miss Esther Brown, field secretary for the Woman's Auxiliary, into the Diocese for a period of three months and during September, October and November she made an outstanding contribution to the thinking not only of the Woman's Auxiliary groups, but also of the clergy (through the clericus and School of Applied Religion), college groups, Young Churchmen groups, Church School classes, and community organizations such as the University of Cincinnati Y. W. C. A. There were many more requests for her help than she had time to meet. Her influence has persisted through the year and as one sees Young Churchmen groups from all the Negro parishes in our diocese present at convocational meetings; as one hears such words as: "I never knew an intelligent Negro before"; "Miss Brown has changed my whole attitude toward members of the Negro race"; "Miss Brown was a disturbing influence to the status of the Negro," one realizes the extent to which she has made an impress upon our diocese.

Following the three convocational meetings during the week of October 11, 1936, at which Miss Brown spoke on the subject, "The Episcopal Church and the Negro," five educational days were held throughout the diocese during November. Two hundred and twenty-five persons from forty-two parishes (or 57 per cent of all parishes) were present. The programs for these days contained source material for the use of the local auxiliaries. Books totalling \$82.32 were sold. At each of the meetings a panel discussion took place on the subject, "Women in the Church Today."

Following these meetings came requests for advice and numerous books from the Woman's Auxiliary book shelf, as well as requests for leaders for discussion groups for a period of four or more meetings. Five parishes in one section united for these discussions under the leadership of Miss Mary Klemm, Y. W. C. A. secretary at the University of Cincinnati. Another parish discussion group was led by Mrs. Elwood Haines, former field secretary of religious education in this diocese.

After these educational meetings the Board authorized the formation of two committees, one an interracial committee for the purpose of bringing together members of two races for mutual understanding and action, and a standards committee to draw up a set of standards for judging the Negro study as it was carried on throughout the diocese. The interracial committee of ten mem-

bers has held monthly meetings since January, discussing for the most part questions pertaining to Church problems faced by various members of the committee. Their final meeting of the year will be held on Saturday, June 5, in cooperation with the educational secretaries of the Cincinnati Convocation. On Sunday, May 16, the educational secretaries of the Columbus Convocation voted to form an interracial committee for the purpose of fostering "better understanding and taking action in the field of social justice." An interracial committee has been appointed by the Dayton Convocation, subject to call in case of interracial discrimination.

The Standards Committee met in early February and planned for "follow-up" meetings suggested at the Educational Days. They decided to gather facts on recreation, education, employment, publicity, regarding the Negro situation in three cities and compile these facts for diocesan use. The Committee also listed the following standards for judging missionary study and sent them to all local auxiliaries before the meetings:

1. Have you read any Negro magazines or newspapers?
2. Have you investigated the attitude of daily newspapers toward the Negro race?
3. Have you read any books on the question of the Negro race?
4. Have you made any visits in connection with your study?
5. Have you seen any evidences of the change of attitude on the part of individuals or groups?
6. Have you discovered anything about Negro problems or thought from Negroes themselves?
7. Have you worked cooperatively with any Negro group?
8. Has your work influenced any other group in your parish?
9. Has your group or any one in it suffered for their interest in the Negro race?

Reports of the three meetings will be given by leaders of the groups at the close of this report. Suffice it to say here that the activities reported from twenty-seven parishes range all the way from deciding to take out a membership in the National Urban League for a clergyman to panel discussion on racial questions with representatives from two neighboring churches of other denominations who were likewise studying this subject. Each group of educational secretaries asked to have a second meeting before the close of the year. This second meeting of the Columbus Convocation, already held, had as its agenda a discussion of the possibilities in next year's study on Rural America, a presentation of the principles of discussion technique, and the consideration of the value of organizing an interracial committee in Columbus. The other two meetings will take place in the near future.

The educational work of the Woman's Auxiliary has not, of course, been limited to the study of the Negro. The schedules

of the various Executive Board members as they have spoken and held conferences throughout the diocese bespeak a wide education in the work and activity of the Church's life. The educational advisor herself has been asked to speak specifically on the Negro question but three out of eleven times. The other subjects requested were Religious Education (4), General Convention (2), Program Building (1), and Church Symbolism (1). (As a result of their interest in Symbolism one group is taking a trip to Grace Church, College Hill, and to the Jewish Synagogue on Lexington Avenue, Cincinnati.) In preparation for General Convention one enterprising branch undertook to secure the pictures of all bishops for a picture gallery or exhibit. The Educational Days revealed a variety of other subjects of study in use: Church History, Why Be a Christian? Altar Guild Work, Missionary Work in Virginia, Religion Among College Students, Religious Education of Children. The last subject was pursued in one branch for eight weeks with sixteen out of a possible thirty mothers in attendance.

Significant is the freedom of organization for education throughout the diocese—a few persons from one group studying by themselves or several parishes uniting in a study; a comprehensive series of meetings on one subject here and a series of unrelated subjects there; local leadership in one parish and outside leadership in another; on the one hand a study of the regular missionary subject, and on the other a subject of more immediate interest to the women. (However it must be added that several auxiliary groups decided against the study of the Negro for fear that it was too controversial).

Significant too has been the cooperation between the Adult Education Committee and the Board of the Woman's Auxiliary, both groups sponsoring the educational days of the Woman's Auxiliary and the "four-night" training institutes recently held in Columbus and Dayton with speakers on General Convention.

MINUTES OF THE SIXTY-FIRST ANNUAL MEETING

May 18-19, 1937

The Sixty-first Annual Meeting of the Woman's Auxiliary of the Diocese of Southern Ohio opened with a service of Holy Communion at Christ Church, Cincinnati, at 11:00 o'clock on Tuesday, May 18. The Rector, the Rev. Frank H. Nelson, D. D., was the celebrant, assisted by the Rev. Maxwell Long, of the Church of the Redeemer, Hyde Park, and by the Rev. William Howard Melish, of Christ Church, Bishop Scarlett, of Missouri, being the preacher. His subject was summed up in the words of the hymn immediately preceding the sermon, "Once to every man and nation, comes the moment to decide, in the strife of truth with falsehood, for the good or evil side." Immediately following the service, lunch was served in the Masonic Temple, three hundred and twenty being present.

The business session was called to order at 2:15 o'clock, in the Scottish Rite Auditorium of the Masonic Temple, by the President, Miss Elizabeth Matthews. Short prayers were said by the President who then spoke a few words of cordial welcome to the meeting, and also told why the Bishop had not been able to be present at the morning service, i. e. the death of the Rev. A. E. Boss, Rector of St. James', Columbus, and expressed our deep regret at his absence and at the cause of it. The Roll was then called by the Secretary, after which her report was read and upon motion made and seconded was accepted as read. The Treasurer, Mrs. Edward Wagner, then read her report, copies of it having been previously distributed to the delegates by the pages. She reported that since May 11, when the books had been balanced, \$21.50 had come into the Central Expense Fund, \$50 to the Supply Department, and \$55 to the Memorial Scholarship Fund. On motion duly made and seconded, this report was accepted and ordered filed. The President then read her address, after which Mrs. Smith Hickenlooper, Secretary of the Supply Department, gave her report, stressing the fine work done by the parish Supply Secretaries and likewise the challenge presented by the coming Triennial and General Convention for renewed effort next fall. After this report, the President of the Cooperative Society of The Children's Hospital, Cincinnati (Mrs. William Procter Matthews), was introduced by the President to make a special plea for sewing to be done for the hospital during the summer, in view of the fact that many of the parish auxiliaries will not open till November.

Mrs. Roger K. Rogan, Treasurer, then read her report on the United Thank Offering, in which she expressed her special thanks to the parishes along the Ohio River for the wonderful showing they had made despite the floods. It was moved and seconded that the report be accepted.

Miss Hilda M. Shaul, Advisor on Religious Education in the

Diocese, then submitted her report on the educational work of the past six months, which was followed by five-minute talks from three of the leaders in the educational work in the diocese on the subject of their study of the Negro: Mrs. Donald Stone, St. Paul's, Columbus; Miss June Dilts, St. Paul's, Oakwood, Dayton, and Mrs. William Carson, Holy Trinity, Madisonville, Cincinnati.

The President introduced Miss Mary Klemm, the newly appointed Executive Secretary of the Woman's Auxiliary in the Diocese and announced the Credentials Committee to be the following: Mrs. Samuel L. Moyer, Chairman, Christ Church, Cincinnati; Mrs. Cloyd Smith, St. James', Piqua; Mrs. George Springer.

Mrs. Chalmers Hadley, Custodian of the Book of Remembrance, made her report. She also read a letter from the holder of the Memorial Scholarship during the past year, Miss Dorothy Scott, formerly Religious Director at Christ Church, Cincinnati, to the Woman's Auxiliary thanking them for the privilege thus given her. The list of new names which had been inscribed in the Book of Remembrance this spring had been printed and were now distributed by the pages to the delegates.

The President summed up briefly to the meeting the annual report on the Memorial Scholarship Fund made to her by the treasurer of the Board of Trustees of the Diocese (Mr. Alfred M. Cressler). The current income from the Fund amounted only to \$440 but interest had accumulated so that the trustees had been able to give \$700 to Miss Scott. The Executive Board at their meeting held May 17 had voted to give to Miss Flora Fender, Director of Religious Education at Calvary Church, Clifton, the sum of \$150 to take special work this summer at Teachers' College, Columbia University. Miss Matthews spoke briefly also of the gift of the case for the Book of Remembrance by Miss Colston, and of the ring worked into the fastening of the case, once given by the women of the Church of the Advent, Cincinnati, to their beloved officer, Mrs. Montgomery Rochester, and now presented by them to the Auxiliary.

The Committee on the President's Address was then announced: Mrs. R. K. Loofbourrow, Chairman, Trinity, London; Mrs. A. E. Yoemans, St. Luke's, Marietta; Miss Catherine Morrison, Christ Church, Cincinnati; also the Committee on Courtesy Resolutions; Mrs. Roland C. Baggott, Christ Church, Dayton, Chairman; Mrs. Perry Smith, St. James', Zanesville; Mrs. H. C. Ackerman, Church of the Epiphany, Urbana.

The Committee on Elections was also announced by the President to be as follows: Mrs. Singleton Outhwaite, Chairman, Trinity, Columbus; Miss Louise Sandoe, Christ Church, Xenia; Mrs. Oliver G. Bailey, Church of the Good Shepherd, Norwood.

The Triennial Call was then read to the meeting by the Secretary,

after which the President announced the tellers for the ballots as follows: Mrs. John Greeno, Grace Church, College Hill, Cincinnati; Mrs. Roger Woodhull, St. Paul's, Oakwood, Dayton; Mrs. Samuel Bell-Boder, St. Margaret's, Dayton; Mrs. George Johnston, Christ Church, Glendale; and the Guard of Honor for the Book of Remembrance: Mrs. Conrey, Mrs. Gordon Graham, Mrs. George King, Mrs. Joseph Cartmell, Mrs. John Gilbert, Mrs. Thomas Asphaw.

Mrs. J. F. Morrison, our Provincial Representative on the National Executive Board, was next briefly introduced to the meeting after which the Credentials Committee reported from the Cincinnati Convocation; 22 parishes were represented and 7 missions with 69 delegates, 177 visitors and 9 of the Executive Board with a total of 255 from 29 branches. From the Columbus Convocation, 13 parishes, 2 missions, with 39 delegates, 12 visitors and one member of Executive Board. Total 50 from 15 branches. Dayton Convocation had 10 parishes represented and one mission with 28 delegates, 17 visitors and one member of the Executive Board. Total 11 branches with 45 present for a grand total of 55 branches represented, 144 delegates and Executive Board and 206 alternates and visitors.

Mrs. Edwin Allen Stebbins, of the Diocese of Rochester, was next introduced to the meeting by the President and made a very short address, followed by Miss Mary E. Johnston, who spoke briefly on the possible uses of the United Thank Offering of 1937. Following Miss Johnston's address, the President made a few announcements and invited all the delegates and alternates as well as the out-of-town visitors in the name of her mother and herself to a buffet supper at her home in Glendale that evening after which at 4:30 the meeting was declared adjourned until the following morning at 9:30 o'clock.

The second session of the Annual Meeting was called to order at 9:30 a. m., May 19, 1937, in the Masonic Temple, Cincinnati, Ohio, by the President, who read the opening prayers. The Secretary read the minutes of the opening session of May 18, 1937, which were approved. Miss Matthews requested authorization to have the minutes of the meeting of May 19 approved by a special committee, due to the fact that it was impossible to have them submitted at the closing session. Mrs. Hickenlooper moved that the chair appoint a committee to approve the minutes, seconded by Mrs. Rogan, carried. The President thereupon appointed herself, Miss Judith Colston as Secretary, Mrs. A. G. Kreimer as Assistant Secretary, and Miss Catherine Morrison, to act as such a committee.

The President announced that five delegates were to be elected to serve as representatives for the Diocese at the Triennial Meeting in the fall, and pointed out that such action did not preclude any individual from attending the Convention as a visitor, but that such delegates would officially represent the Diocese and

voice the opinion of the Auxiliary in such matters presented for consideration as the United Thank Offering and various questions upon which an expression might be required.

The report of the Elections Committee was submitted by Mrs. Singleton Outhwaite, of Trinity Church, Columbus, as follows:

Mrs. Mark L. Mitchell requested that her name be withdrawn from the ticket.

Miss Matthews announced that no names could be withdrawn but a reason could be stated why persons would be unable to serve if elected.

Mrs. Marcus Crocker moved that the report of the Elections Committee be received; this was seconded by Mrs. Donald Stone and carried.

The Chair then asked if there were any nominations from the floor; there being none such Mrs. Rogan moved that the nominations be closed, seconded by Mrs. Elwood Cook and unanimously carried. The pages distributed the ballots, the tellers collected them, and the polls were declared closed.

Miss Matthews announced that there were to be some changes made in the Constitution, and that although it was customary to have the Constitution first presented in full, this had been done in Zanesville and copies had also been sent to the parish branches, and unless there was some objection, it would not be read in toto, but she would instruct the Chairman of the Committee on the Revision of the Constitution to read it seriatim, and then it would be passed upon and adopted.

Thereupon Miss Colston, Chairman, presented the Report of the Committee on the Revision of the Constitution seriatim and moved its adoption, which Mrs. Roger K. Rogan seconded.

ARTICLE I

Name

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the United States of America."

It was pointed out that the change in this Article merely consisted in the addition of the words "of the Protestant Episcopal Church in the United States of America," as it was felt more dignified to include the name of the Church.

ARTICLE II

Object

The object of this Association shall be to carry out by united and systematic effort, in the Diocese of Southern Ohio, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service, in the five fields of service, namely: Parish, Community, Diocese, Nation, World.

A rearrangement of the sentences was the only alteration made in this Article.

ARTICLE III

Membership

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

Unchanged.

ARTICLE IV

Officers

The officers of this Association shall be the Bishop, ex-officio, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, an Educational Secretary, and a Custodian of the Book of Remembrance. These officers with any member of the National Executive Board resident in the Diocese, shall constitute the Executive Board of the Association.

This Article was unchanged except for the addition of the Custodian of the Book of Remembrance as a regular member of the Board.

ARTICLE V

Duties

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association, and have power to adopt by-laws for the Association.

There was no change in Section 1.

SECTION 2. The President shall be elected at the annual meeting held the spring after the General Triennial meeting, to serve for three years, but shall not be eligible for two consecutive full terms. She shall, with the Bishop's approval, appoint all other

Diocesan officers, except the Vice-Presidents, to serve for three years; but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers but immediately at the close of the General Triennial meeting, to serve throughout the Triennium. The President shall call meetings of the Association and of the Executive Board, and shall preside at them. She shall exercise a general supervision of the work and further it in every way by her interest and advice. In case of a vacancy in the office of President, such vacancy shall be filled until the next annual meeting, by appointment made by the Bishop and the committee of two selected by the Executive Board.

Attention was called to the fact that this was an important alteration, as it involves a change in the time of the election of the President.

It was pointed out that Section 2 of the old Constitution provided that: "The Bishop, when present, may preside at meetings of the Association and of the Executive Board," but that the Committee felt the Executive Board was capable of presiding over itself, and so that section had been eliminated and the above section substituted. Also, that in Section 3 of the old Constitution, relating to the appointment of Officers, in connection with the furtherance of the work of the organization it included the phrase, "and especially by an address at the Annual Meeting," and this had been omitted from the new Section 2.

The question was raised as to whether or not action on this Article should be deferred until action on the time of the Annual Meeting was taken. Miss Matthews ruled that this was the proper place for its consideration.

SECTION 3. Each Vice-President shall be elected by the members of her Convocation to serve for three years, at the time of the Annual Meeting at which the President is elected, but shall not be eligible for two consecutive terms. A Vice-President, with the approval of the President, may appoint other Convocational officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation, she shall cooperate with the President in promoting local intelligence and interest, and in directing local organizations and work in her own Convocation.

Attention was called to the phrase "promoting local intelligence," and it was suggested that this be changed, as it did not properly express the intent of the Section. Mrs. S. L. Moyer, Christ Church, Cincinnati, moved that the word "intelligence" be struck out and the word "information" substituted; seconded by Mrs. Hadley and carried.

SECTION 4. The Secretary shall keep the minutes of the Executive Board and of the annual meeting, and shall give notice of meetings. She shall conduct such correspondence of the Association and the Board as directed by the President. She shall also

make an annual report to the Association from data furnished by the other officers and shall prepare and edit the Year Book.

Miss Colston called attention to the fact that Section 5 of the old Constitution, for which this was a substitute, provided that the Secretary should conduct all the correspondence of the Association and of the Board, and that this was an impossibility, as there was certain business which of necessity must be transacted by various officers; hence this provision had been eliminated from the new section.

SECTION 5. The Secretary of the Supply Department shall receive and distribute all information relating to missionary boxes, and shall report annually to the Association.

There was no change in this section.

SECTION 6. The Treasurer shall record, receive, disburse, and keep account of all money distributed, except the United Thank Offering; and shall also make an annual report of the same.

No change.

SECTION 7. The Treasurer of the United Thank Offering shall under the direction of the Executive Board, promote this interest locally by correspondence and visitation. She shall report annually to the Association, the amount on hand, and shall forward the same semi-annually to the Treasurer of the National Council.

The addition of the last phrase is the only change.

SECTION 8. The Educational Secretary shall have general supervision of all educational work carried on under the auspices of the Woman's Auxiliary in the Diocese.

The only change was a slight rewording and the omission of the word "missionary" preceding the words "educational work."

SECTION 9. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible for the care of the Book of Remembrance, and for the promotion of the Memorial Scholarship Fund.

This Section had been altered; omitting the phrase "She shall not be a member of the Board, but shall meet with it upon request." and adding "and for the promotion of the Memorial Scholarship Fund."

ARTICLE VI

Meetings

SECTION 1. There shall be an Annual Meeting of this Association each spring. Every parish branch may send three delegates, in addition to any executive officer, and every mission branch one delegate. Except in the election of a President, executive officers may vote on all questions before the house.

This Article was amended by the elimination of the phrase "or there may be Semi-annual Meetings" and the addition of the words "each spring."

In the original constitution reference was made to "Executive Officers," whereas what was really meant was an Executive Board officer, and Miss Colston pointed out that it might be better to

say "any Diocesan officer of the Woman's Auxiliary." Mrs. Marcus Crocker moved that such a change should be made, seconded by Mrs. Chalmers Hadley and carried.

The question was then raised that this Article be amended further so as to have the same representation for missions as for parishes, and the advantages for such a change were pointed out by delegates from St. Mark's Mission, Oakley; the Mission of St. Simon of Cyrene, Lockland; the Mission of St. James, Westwood; also by Mrs. Tangeman, from the Parish of the Church of the Redeemer, Hyde Park. Mrs. Marcus Crocker, St. Paul's, Columbus, moved that this change be made, seconded by Mrs. Chalmers Hadley, Grace Church, College Hill, and the resolution was adopted, and Miss Colston then submitted the revised Section 1 of Article VI to read as follows:

"There shall be an Annual Meeting of this Association each spring. Every parish and mission branch may send three delegates in addition to any officer of the Diocesan Board of the Woman's Auxiliary. Except in the election of a President members of the Diocesan Board of the Woman's Auxiliary may vote on all questions before the house."

SECTION 2. The Executive Board shall meet at least twice a year, five officers constituting a quorum.

No change was made in this section.

SECTION 3. Convocational meetings shall be held on the call of the Convocational Officers.

No change was made in this section.

SECTION 4. Delegates and alternates to the Triennial Meeting shall be elected by the active membership of the auxiliary, by a majority of the delegates to the Annual Meeting next before the Triennial. Nomination may be made by any delegate to the Annual Meeting.

Attention was called to the fact that the provision regarding submitting the nominations in writing in the old constitution had been eliminated as it was always the privilege of any delegate to make a nomination at any time.

SECTION 5. Delegates to the Provincial Synod shall be chosen by the Executive Board.

It was explained that this was a new section which it had been thought best to add as it was difficult to elect delegates a long time in advance, and it was therefore thought if the matter was left to the Executive Board it would insure representation.

ARTICLE VII

Mode of Election

SECTION 1. In the election of President any delegate may nominate; all nominations must be written; all elections must be by ballot, and each parish and mission shall cast but one vote.

No change in this section.

SECTION 2. Unless there be an election by a majority on the first ballot, the chair shall announce the two names having the largest number of votes, and subsequent balloting shall be upon these two names until a majority vote is reached.

The word "clear" had been omitted before "majority," as it was thought that any majority should be clear.

SECTION 3. Prior to the election of Vice-Presidents a nominating committee in each Convocation shall be appointed by the Vice-President at a meeting which shall precede the annual meeting. Such nominating committee shall select nominees to be presented for election at the convocation meeting held in connection with or at the time of the annual meeting. Election shall be by ballot. Each delegate shall be entitled to one vote.

This is an entirely new section.

ARTICLE VIII

Amendments

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates present at any Annual Meeting, notice of such proposed amendment having been given at the previous meeting.

There was no change in this section.

Miss Colston then moved the adoption of this amended and revised Constitution, it was seconded by Mrs. Roger K. Rogan and unanimously carried.

The President then declared Miss Matthews, Mrs. Hickenlooper and Mrs. Rogan having received the required number of votes elected as delegates and announced that it would be necessary to have another ballot to elect two additional delegates. A second ballot was taken and the polls declared closed.

Miss Matthews introduced Mrs. Roger Kingsland of West Virginia, President of Third Province.

Bishop Hobson briefly addressed the meeting, pointing out that he was serving as chairman of the Hospitality Committee, and that a serious problem faced the committee in securing rooms for those attending the convention. He urged the individual parishes to make an effort to secure rooms in private homes and report at an early date. He announced that Mrs. Robert L. Black, Mrs. Frances S. Weyman and Rev. Harold Weaver were serving with him as vice-chairmen and were working diligently to provide adequate facilities.

An hour was then devoted to the discussion of the plans for the General Convention.

Miss Matthews declared Mrs. Baggott and Miss McCune duly elected as delegates, and called for a vote for five alternates.

A ballot was then taken and the polls declared closed.

Bishop Hobson requested cooperation in the furtherance of the use of the little booklet entitled "The Forward Movement, Day By Day."

Mrs. Loofbourrow, chairman, submitted the following report for the Committee on the President's Address, which was considered seriatim, and moved its adoption.

"Realizing that the main subject that concerns us at the moment is the coming of the General Convention and the Triennial Meeting in October:

Be It Resolved:

That every woman in Southern Ohio strive to be present in Cincinnati for some part of these two weeks, and that we accept this opportunity as a challenge for forward work such as Ohio has not known in a generation.

Seconded and unanimously carried.

That we endorse the plan of the Executive Board for parochial visitation, and accept the general outline, itinerary and dates which will be set up by the Board.

Seconded and unanimously carried.

That we wish to endorse our new Diocesan venture of the Way-side Cathedral and hope this will lead to effective cooperation from the Auxiliary to the Bishop and Field Department.

Seconded and unanimously carried.

That we endorse the continuance of \$500.00 to Bishop Hobson's Discretionary Fund.

Seconded and unanimously carried."

The report of the Committee was thereupon accepted by Miss Matthews.

Bishop Hobson extended thanks for the contribution to the Discretionary Fund on behalf of those whom the fund had aided.

Miss Matthews then gave a report on the Good Friday Offering, \$709.46 from forty-nine Parishes.

Mrs. Alden Graves reported that the Financial Policy Committee at a recent meeting had decided that the financial policy was not a matter which could be decided by a small group and they were therefore going to send out questionnaires, and requested that careful thought be given to the matter and the questionnaires returned to the Committee.

Miss Matthews announced that Mrs. Tangeman, Mrs. Woodruff, Miss Colston and Mrs. Burdoin, having received a sufficient number of votes, were duly elected as alternates.

Miss Matthews announced that the offering at the two services had amounted to \$145.22; \$95.38 at the opening service and \$49.78 at the early service on the second day, and requested a motion governing the disposition of this money.

Mrs. Gordon Graham moved that the offering be used for the Triennial expense fund or General Convention. No second.

Miss Mary E. Johnston moved that it be given to the Kusatsu Leper Fund; this was seconded by Miss McCune.

Mrs. J. P. Williams, Hamilton, moved that it be given to the Bishop's Discretionary Fund; seconded by Mrs. Woodruff.

Miss Matthews put this substitute motion to the vote and it was lost.

There was discussion on this matter, it being pointed out that the Bishop's Discretionary Fund was the obligation of the Auxiliary and the money therefore would be provided for it; it was the consensus of opinion that the offering should be donated to some other object. The President then put Miss Johnston's original motion to the vote and it was carried unanimously.

Mrs. Roger K. Rogan moved the following resolution for the United Thank Offering:

In order to get some expression of opinion on the matter, I would like to move that the date for the Corporate Communion and presentation of the United Thank Offering be the first Sundays in October and May, except in the year of the General Convention, when it must necessarily be somewhat earlier. I would also like to move that the parish United Thank Offering treasurers hold office where possible for the same length of time as the Diocesan treasurer; namely, three years immediately after one Triennial through the next. This was seconded by Mrs. Allan W. Cooke, Christ Church, Springfield.

There was considerable discussion regarding this resolution before. Miss Matthews put the motion to vote and it was carried.

Miss Matthews announced that following the meeting Bishop Hobson was leaving immediately to attend the 100th Anniversary of the Greenville Parish, whereupon Mrs. Burdoin moved that greetings be sent them from the Woman's Auxiliary at this meeting, and Bishop Hobson be requested to extend such greetings to them; seconded by Mrs. Marcus Crocker and carried.

Mrs. Baggott submitted the following report for the Committee on Courtesy Resolutions:

The Committee on Courtesy Resolutions desires to express its appreciation of the inspiring address of Bishop Scarlett at the opening meeting, to thank Bishop Hobson for the impressive

Memorial service and interesting address; also Dr. Frank H. Nelson for the services in Christ Church, also the assisting clergy; Miss Blanche Alter and Mrs. Richard Austin for the volunteer choir, and for the organ, and to express our sincere gratitude to Mrs. Mortimer Matthews and Miss Elizabeth Matthews for the gracious hospitality extended to delegates and visitors at their delightful home, and to thank Miss Susie Tuite and the hostesses who provided such cordial entertainment.

We wish also to thank Mr. Tateman for the use of the Masonic Temple, and to express our pleasure to the committee for the beautiful tea; also our thanks to the pages for their efficient services.

CONSTITUTION AND BY-LAWS

CONSTITUTION

ARTICLE I

Name

The name of this Association shall be "The Southern Ohio Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the United States of America."

ARTICLE II

Object

The object of this Association shall be to carry out by united systematic effort in the Diocese of Southern Ohio, the three great aims of the Church, namely: Missions, Religious Education and Christian Social Service in the five fields, namely: Parish, Community, Diocese, Nation and World.

ARTICLE III

Membership

Membership in this Association shall consist of those baptized women of the Diocese who agree to share in the work of the Auxiliary.

ARTICLE IV

Officers

The officers of this Association shall be the Bishop ex-officio, a President, three Vice-Presidents, a Secretary, a Secretary of the Supply Department, a Treasurer, a Treasurer of the United Thank Offering, an Educational Secretary, and a Custodian of the Book of Remembrance. These officers with any member of the National Executive Board resident in the Diocese, shall constitute the Executive Board of the Association.

ARTICLE V

Duties

SECTION 1. The Executive Board shall, subject to the Association, direct the active work of the Association and shall have power to adopt by-laws for the Association.

SECTION 2. The President shall be elected at the annual meeting held the spring after the General Triennial Meeting, to serve

for three years, but shall not be eligible for two full consecutive terms. She shall, with the Bishop's approval, appoint all other Diocesan (Auxiliary) officers, except the Vice-Presidents, to serve for three years, but the Treasurer of the United Thank Offering shall not be appointed at the same time as the other officers, but immediately at the close of the General Triennial Meeting, to serve throughout the Triennium. The President shall call meetings of the Association and of the Executive Board, and shall preside at them. She shall exercise a general supervision over the work and shall further it in every way by her interest and advice. In the case of a vacancy in the office of President, such vacancy shall be filled until the next annual meeting by appointment made by the Bishop and a committee of two selected by the Executive Board.

SECTION 3. Each Vice-President shall be elected by the members of her Convocation to serve for three years, at the time of the annual meeting at which the President is elected, but shall not be eligible for two consecutive terms. A Vice-President, with the approval of the President, may appoint other convocational officers in her own Convocation, and prescribe their duties. She shall preside at all meetings in her own Convocation, she shall co-operate with the President in promoting local information and interest and in directing local organizations and work in her own Convocation.

SECTION 4. The Secretary shall keep the minutes of the Annual Meeting and of the Executive Board, and shall give notice of meetings. She shall conduct such correspondence of the Association and the Executive Board as directed by the President. She shall also make an annual report to the Association from data furnished by the other officers and shall prepare and edit the year book.

SECTION 5. The Secretary of the Supply Department shall receive and distribute all information relating to the missionary boxes, and shall report annually to the Association.

SECTION 6. The Treasurer shall record, receive, disburse and keep account of all money distributed, except the United Thank Offering; and shall also make an annual report of the same.

SECTION 7. The Treasurer of the United Thank Offering shall, under the direction of the Executive Board, promote this interest locally by correspondence and visitation. She shall report annually to the Association the amount on hand, and shall forward the same semi-annually to the treasurer of the National Council.

SECTION 8. The Educational Secretary shall have general supervision of all educational work carried on under the auspices of the Woman's Auxiliary in the Diocese.

SECTION 9. The Custodian of the Book of Remembrance shall, under the direction of the Executive Board, be responsible, for the care of the Book of Remembrance, and for the promotion of the Memorial Scholarship Fund.

ARTICLE VI

Meetings

SECTION 1. There shall be an annual meeting of this Association each spring. Every parish and mission branch may send three delegates in addition to any officer of the Diocesan Board of the Woman's Auxiliary. Except in the election of a President, members of the Executive Board of the Woman's Auxiliary may vote on all questions before the house.

SECTION 2. The Executive Board shall meet at least twice a year, five officers constituting a quorum.

SECTION 3. Convocational meetings shall be held on the call of the convocational officers.

SECTION 4. Delegates and alternates to the Triennial Meeting shall be elected by the active membership of the Auxiliary by a majority of the delegates to the annual meeting next before the Triennial. Nominations may be made by any delegate to the annual meeting.

SECTION 5. Delegates to the Provincial Synod shall be chosen by the Executive Board.

ARTICLE VII

Mode of Election

SECTION 1. In the election of a president any delegate may nominate; all nominations must be written; all elections must be by ballot and each parish and mission shall cast but one vote.

SECTION 2. Unless there be an election by a majority on the first ballot, the chair shall announce the two names having the largest number of votes, and subsequent balloting shall be upon these two names until a majority vote is reached.

SECTION 3. Prior to the election of vice-presidents, a nominating committee in each Convocation shall be appointed by the vice-president at a meeting which shall precede the annual meeting. Such nominating committee shall select nominees to be presented for election at the Convocational meeting held in connection with or at the time of the annual meeting. Election shall be by ballot. Each delegate shall be entitled to one vote.

ARTICLE VIII

Amendments

This Constitution may be altered or amended by a two-thirds vote of the whole number of delegates present at any annual meeting, notice of such proposed amendment having been given at the previous (annual) meeting.

BY-LAWS

The Executive Board shall determine the time of and place for the annual meeting.

1. The Order of Business at any Annual Meeting shall be:

- (1) A Service of Holy Communion.
- (2) Roll Call.
- (3) The Annual Report of the Secretary.
- (4) Annual Report of Treasurer.
- (5) The President's Address.
- (6) New Business.
- (7) The Election of President.
- (8) Minutes.

2. Parish Election of delegates shall take place during the month preceding the annual meeting, and shall be immediately reported by the local secretary to the diocesan secretary.

3. A Central Expense Fund shall be provided for printing, postage, stationery, traveling expense of officers and speakers, necessary expenses of the Educational Department, and the shipping charges of the Supply Department; also for all expenses incurred in the care of the Book of Remembrance.

4. New names may be inscribed in the Book of Remembrance every third year, the year of the General Convention; such names being those of women who have died within the Triennium and have been selected as worthy of a place in the Book of Remembrance by a parish committee, consisting of the heads of all women's organizations within the parish, acting with the rector.

5. When a name is presented for inscription in the Book of Remembrance, it shall be accompanied by some memorial gift made through or by the parish entering the name on its pages; such memorial gifts shall be added to the trust fund known as the Memorial Scholarship Fund.

6. The Book of Remembrance may be used at all Diocesan meetings, such as the annual meeting of the Woman's Auxiliary, the annual service of the Girls' Friendly Society and the Diocesan Convention. The Book may not be shown at secular meetings or exhibited purely as a work of art.

7. Local receipts for the United Thank Offering shall be remitted to its treasurer in April and October except triennially in September.

8. The accounts of the treasurer and the treasurer of the United Thank Offering shall be audited and certified in the printed annual report of the Association.

9. These By-Laws may be altered or amended by a majority vote at any regular meeting of the Executive Board.

(f) Diocesan Dues to the national organization shall be paid from the Central Expense.
