QUIET HOUR

The Quiet Hour service was conducted by Rev. Churchill J. Gibson, D. D., the rector of the parish. He talked of the efficacy of prayer and of the importance of getting Christ within us. ADDRESS OF WELCOME

Mrs. John Ecker, Lexington, as hostess, welcomed the delegates. In her address, she spoke briefly of the name of the Episcopal Church at Lexington, and mentioned one or two facts in the spiritual life of General Lee.

BISHOP'S ADDRESS

The Bishop in his address had three points in mind: The beginning of the Woman's Auxiliary of the Diocese of Southwestern Virginia; the progress of the Woman's Auxiliary; and the future of this organization. He spoke of the unique position the Woman's Auxiliary held in the church, and expressed the hope that this organization might never lose its identity but continue its steady growth and progress.

He told how the volunteer method of giving, in contrast to assessment, had proved a success—no longer adopting the method of reducing to a minimum the amount given to God in the extension of His Kingdom, but trying to find a way to give as much as possible to carry on this work.

The Bishop also spoke of his great desire for a home in the Southwest for our young people, so that when they reached a certain point they would not have to be turned over to other churches to continue their education. He asked us to pray that

some day means might be gotten for such a home in our diocese.

In conclusion, he expressed his profound gratitude to our President for her faith and leadership as indicated by the work and progress of the organization.

PRESIDENT'S ADDRESS

The President in her address expressed regret that due to illness she had not been able to visit the different branches during the year as was her usual custom. However, she was glad to report that all seemed to be doing their utmost, and she felt encouraged by what had been accomplished.

In mentioning the election of officers at this Convention, the President asked that everyone vote carefully and prayerfully with the good of the organization at heart; leaving out the personal element and remembering the organization and its work.

She mentioned three new branches which have been added to our organization this year:

St. Peter's, Roanoke, Montvale and Clifford.

Mrs. Sioussat, president of the Maryland Branch, gave a brief talk, telling how the Auxiliary started when it was decided something must be done to conserve the energies of the women after the Civil War. This was done at a convention which met in Baltimore, beginning with what was called a female auxiliary composed of little societies banded together under their own bishops and rectors. Mrs. Sioussat in closing urged the women of the Auxiliary not to worry over the future and what was to become of the organization, but to direct their attention to the work and needs at hand.

Mrs. Ecker, the secretary of the meeting, read the report of the Woman's Auxiliary for the year ending October, 1925.

Miss Sally Logan added a few words to her talk of last night by calling attention to the needs of the community house at Richlands. She stressed particularly the fact that at present no help towards Christmas at the Sunday School had been provided.

Mrs. Pendleton and Mrs. Loving as briefly as possible told of their impression of the General Convention at New Orleans. They both emphasized the Conference for Peace, and the influence the Christian women of America could have in trying to bring about a positive method for peace, and not peace by mere chance.

Mrs. Baker urged every branch to subscribe to the Alaskan Churchman if possible. She said she had sent out thirty sample

copies to the different branches, and had only received one subscription.

Rev. Lloyd Craighill gave a brief picture of the school at Nanchang mentioning the church, parish room, courtyard, school rooms, etc., and telling what had been accomplished in the way of buildings for the school in the past four years. The latter part of his talk was taken up with the strikes and outbursts of the Chinese people in the last few months. Mr. Craighill attributed this largely to labor conditions, and to unfair treatment of the Chinese by foreigners. The latter made it very difficult to bring Christianity to the Chinese, and he thought a great deal of sympathy and a deeper trust on the part of the missionaries would be necessary in order to handle the situation.

At the evening services November 4th, Bishop LaMothe of Honolulu presided and gave an interesting talk on his work there. He has 30 parishes, 18 workers and 9 schools. His great need is efficient teachers that will stay.

The morning service November 5th, began with the Holy Communion at 7:30 a. m.

The second business session of the Woman's Auxiliary to the National Council Diocese of Southwestern Virginia was called to order November 5th, at 9:30 a. m. by the President.

The meeting was opened with prayer by Rev. Lloyd Craighill.

Roll Call, to which twenty-one branches responded, minutes read, corrected, and approved as corrected.

The Program Committee will have the programs printed and sent out as soon as possible.

PLEDGE COMMITTEE

Rev. Irvin H. Correll, head of the Church Publishing Society in Tokyo, gave an interesting talk about his work. Instead of each branch having one delegate for the first twenty-five members and one delegate for every fifteen members over twenty-five, it was moved and carried that each parish be represented by two delegates regardless of the membership, that one delegate be the president or her representative and the other be elected by the parochial branch.

MR. LEE'S ADDRESS

Mr. Edmund Lee of Anking, China, gave a most interesting talk. He first told of the Kuling School, a school in China for the children of our missionaries, and how this school had met the greatest hardship the missionaries had to face. Formerly, they had had to send their children back to this country in order to

educate them, and often did not see them again for several years. Through the Kuling School the children could remain with their parents until they were ready for college. The effect of this is felt by the whole missionary spirit in China; it removes the one real hardship in the lives of the missionaries in becoming separated from their children, and it does away with the natural feeling of resentment the children have had towards their parents and the missionary life in China on account of this separation. These children now have an opportunity to remain in China long enough to feel its appeal and the urge to return as missionaries to carry on the work of their parents.

Mr. Lee also spoke of the Anking Colored Cross Stitch Industry which was started by his wife several years ago. This industry has developed to such an extent that it now includes about one hundred women and fifty girls; it is a corporation, self-supporting in every way, with the proceeds going back into the organization. The women are taken care of when they are sick; their children are sent to Grace Church School; and though it is not necessary for the women to be Christians in order to belong to this industry, it is natural that the Christian influence will be felt and spread from one to another.

Mr. Lee closed his address by mentioning the fact that he was trying hard to raise \$40,000 for the Kuling School, and \$8,000 for Grace Church, and that he thought the next few years would be the greatest in interest and results for missionary work. He hoped he might see the day when China and America would be mutually helping each other.

SOCIAL FEATURES

The social features of the Lexington Convention were in the form of delicious lunches served both days in the parish room of the church, an automobile ride to places of interest in Lexington and an afternoon tea given by Mrs. Churchill Gibson in the beautiful colonial rectory.

The meeting adjourned to meet in Wytheville, October, 1926.
