The Eighth Annual Meeting of the Woman's Auxiliary, Diocese of Southwestern Virginia, met at Emmanuel Church, Covington, October 4th.

**Quiet Hour**

At 5:00 p. m. a Quiet Hour Service was conducted by the Rev. Dennis Whittle, the rector of the Emmanuel Church. His theme was the spiritual life of the individual and of the Woman's Auxiliary as an organization. He dwelt upon the importance of prayer and of the encouragement that the Auxiliary should give to the study of the Bible. This service was closed with the playing of "Abide with me" on the chimes of the Church.

### **Bishop's Address**

Bishop Jett in his address spoke of the vision, work, motive and joy of the Woman's Auxiliary. He reported on the educational fund which is a gift from the Woman's Auxiliary and told of the industrial school which he hopes to found for mountain children near Wise Courthouse.

### **President's Address**

In the President's address she gratefully acknowledged the co-operation of officers and members of the Woman's Auxiliary during the past year. She emphasized the devotional part of each meeting of the branches and asked for continued prayers for workers and gifts of lives. She closed by asking the Woman's Auxiliary to avail themselves of the impression made by the Bishops' Crusade.

Following the address of the President the other officers of the Diocese made reports of their year's work. These reports appear in full in the back of this Annual Report, therefore only a few striking things are mentioned here.

### **Noonday Prayer**

The noonday prayer was offered by the Rev. Amos Goddard, a returned missionary from Kiukiang, China.

### **Reports of Officers**

The reports of the educational secretary, Mrs. Thomas D. Lewis of the James River Convocation and Mrs. K. A. Grandstaff of the New River Convocation, showed signs of increased interest in educational work, thirty-two branches reporting mission study. At the suggestion of Mrs. Grandstaff it was decided to offer prizes to Sunday School pupils for the best essays on Bible subjects.

Mrs. Philip Pendleton, first vice-president in charge of education, talked on educational work in the diocese and requested each branch to try to be a standard branch and gave the requirements for it. She announced that another Institute for Study Class Leaders will be held in Roanoke on January 11 and 12.

The director of the C. P. C., Miss Mary Bell of Lynchburg, not being present, her report was read by Mrs. A. A. Onthank, delegate from Lynchburg. It told of books sent to missions and magazines and books sent to orphanages, hospitals and jails. This is a work which can be carried on locally as well as by mail, so every branch should send in a report of work done.

On Wednesday afternoon the special pledges were made by the Branches to the Missionary workers of the Diocese. As usual this interesting part of the program was entered into with much enthusiasm and \$415.00, besides clothing, books etc., were pledged to the needs of those faithful Soldiers of the Cross.

### Evening Service

A feature of the Wednesday evening service was the address given by the Rev. Amos Goddard of St. John's School, Kiukiang, Diocese of Anking, China. Mr. Goddard, for twenty-five years a missionary, is one of the heroes of our Chinese Missions, he having stayed until ordered by the American Commander to leave on a gunboat.

### THURSDAY

The Thursday morning Corporate Communion Service was conducted by Rev. Dennis Whittle, assisted by the Rev. H. H. Young.

Business sessions were continued at 9:30 and opened with prayer by the Rev. H. H. Young. After roll call and the reading of the minutes of the previous days meeting, Miss Julia P. Leache, the representative of the Alaskan Churchman in the Diocese, reported fifteen subscribers.

Dr. E. Reinhold Rogers gave a graphic account of the work at the Boys' Home to the Auxiliary. On motion of Mrs. Custis Peter, delegate from Radford, an especial offering was taken for a treat of candy and sweets for the Boys' Home. This was taken to the boys on Thursday afternoon by a committee appointed from the Auxiliary.

PRESIDENT'S ADDRESS 1927

In submitting her annual report, your president desires to make grateful acknowledgment of the hearty co-operation of all the Diocesan officers and the unfailing help they have given to all efforts for carrying on the work.

She desires to put on record her appreciation for the loyal support given by the parish branches as evidenced by their increased gifts both for United Thank Offering, Diocesan Pledges, Boxes and Supply Room and Specials. Also in the great increase in the number participating in the Corporate Gift this year as well as in the interested and well attended meetings she has been privileged to attend.

She also desires to express her appreciation for the letters written to our Prayer Partner, Miss Hildreth Cronshey, and she hopes every member of the Auxiliary in this Diocese is remembering her daily in our prayers.

She wishes to express her deep sense of her own inadequacy to the task before her and to assure you that if work has not been done, or not been done as promptly as it should have been, it has been due to no lack of interest on her part, but to the fact that all her time cannot be given to Auxiliary work although the office needs it.

During the past year new branches have been formed at Grace Church, Radford, and at Trinity Church, Boonesboro. They are operating for the present as Guild Auxiliaries in conformity with the provisions of the National organization for some small parishes;—that is, they agree to set aside a definite part of the time of each meeting for missionary program and to contribute to the pledges and obligations of the Woman's Auxiliary.

Your president has visited eighteen parish branches and has had the privilege of speaking at three of the Diocesan Days—Bedford, Madison Heights and Lexington—in behalf of the work of the Woman's Auxiliary.

At one of these meetings she had the opportunity of speaking to three groups of women in whose parishes there was no Auxiliary work.

Their questions and evident interest after the meeting was over lead us to hope branches may be organized before our next annual meeting.

She has written more than 150 letters and has distributed quite a good deal of literature.

She had the privilege of attending the Study Class and conferences of the Woman's Auxiliary at Sweet Briar and urges that more branches send delegates next year.

The Sunday School delegates cannot get the Auxiliary classes, as they are held at the same time that their own classes are in session, and the inspiration gained in Miss Louisa Davis' conferences is well worth the trip to Sweet Briar.

We wish to call your attention especially at this time to two specific pieces of work which each branch is asked to do.

1st: Appoint one woman in *your* branch to solicit subscriptions to the Southwestern Episcopalian and send her name to the Rev. J. Lewis Gibbs, Box 522, Staunton, Virginia, and *help her by subscribing*.

2nd: Appoint one woman in your branch to solicit subscriptions to the Spirit of Missions and send her name to Mr. John W. Irvin, 281 Fourth Ave., New York, and *help her* by subscribing.

These are two of the best ways we know in which you can disseminate knowledge of the work being done by the Church in our own Diocese and to the ends of the earth, and it is not possible that people who really *know* can remain indifferent to the call of the world's need.

Then let your president urge that time and thought be given to the devotional part of our meeting. Some branches have a chaplain whose work is just this.

Too often our prayers at meetings are hurried or haphazard. *Prayer is power*, whether it be personal prayer or public prayer, and we cannot place too much emphasis upon its importance. See that our prayers and our Scripture readings are correlated to the subject matter of our informing program at each meeting.

Which brings us to speak of the vital importance of that program of information at each meeting. Increased information of the missionary enterprise invariably means increased interest. Let us pray for workers and for the gift of lives for the work from our own diocese.

Our Study Class subject for next Lent is "A Church Awake." It is our earnest hope that each branch will study the book. Its intention is to capture every ounce of impression made by the Bishops' Crusade and so direct it into usefulness that many who were not touched by that magnificent movement may be reached and quickened by the torch passed from life to life.

Let us avail ourselves of this means of deepening our own spiritual life that we may be instrumental in bringing others to walk with us in the footsteps of our Blessed Lord.

Mrs. John Wyatt Davis, Second Vice-President not being present her report on the Corporate Gift was given by the President. This report showed the splendid work Mrs. Davis did in sending out information about this advance work undertaken by the Auxiliary.
