CONSTITUTION.

ARTICLE I.

The name of this society shall be "The Springfield Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

The object of this Society shall be, by means of union and systematic effort to diffuse Missionary information, to increase Missionary activity among women of the Diocese, to unite previously existing Parochial Branches of the Auxiliary, and to encourage the formation of societies where there are none.

ARTICLE III.

All Baptized women belonging to the Diocese, who desire to be members of this Society, shall be so regarded upon the payment of twenty-five cents per annum to the Diocesan Treasury.

ARTICLE IV.

The officers of this Society shall be a President, five Vice Presidents, Secretary and a Treasurer.

ARTICLE V.

The President shall call meetings and preside over them.

ARTICLE VI.

Section 1. The duties of the Vice Presidents to be as follows: The 1st Vice President to take the place of the President in her absence and to assist her in visiting. The 2d Vice President shall be the Diocesan President of the Junior Auxiliary and the 3d Vice President shall be the Diocesan President of the Babies Branch. The 4th Vice President shall be Diocesan Treasurer of the United Offering. The 5th Vice President shall be the Diocesan Educational Secretary.

Sec. 2. The 2d and 3d Vice Presidents shall appoint their own Secretary-Treasurer.

ARTICLE VII.

Section 1. The duties of the Secretary shall be to give notice of meetings and keep a record of them; to conduct the correspondence with Parochial Secretaries, and with the General Secretary of the Woman's Auxiliary; to keep a record of the "boxes" contributed by Parochial Branches or individual members of the Auxiliary; and to prepare an Annual Report for circulation in the Diocese.

Sec. 2. The Treasurer, under direction of the President, shall receive and disburse all general funds sent for any branch of Missionary work, or for the expenses of the Society. She shall keep a record of these, and of funds received and disbursed by Parish Branches, accepting receipts therefor, from Parish Secretaries. She shall present a full report at the Annual Meeting, and shall furnish the same to the Secretary to be incorporated in the Annual Report.

ARTICLE VIII.

Every Parish, with a Society or Societies working for Missions, shall be entitled to four delegates, who, with the General Officers, shall constitute the Executive Board. The first named of these four shall be the Corresponding Secretary for the Parish Branch.

ARTICLE IX.

The President, Vice Presidents, Secretary and Treasurer, together shall form a council for the purpose of devising means to interest the women of the Diocese not already interested, in the purposes of the Auxiliary, and (with the approval of the Clergyman in charge) to encourage the formation of Parochial Branches in Parishes where there are none.

ARTICLE X.

All Parish Guilds and Societies desiring it, shall be considered Branches of the Auxiliary upon the payment of the yearly Diocesan dues of 25 cents per capita; and will then send reports of money collected and work done. Delegates from all such societies will be expected at the General Meetings of the Diocesan Auxiliary.

ARTICLE XI.

This Association shall hold its Annual Meeting on the third (3d) Wednesday and Thursday in May, at such place as shall have been selected at the previous meeting. But for good reason the time and place may be changed by the President with the approval of the Bishop.

ARTICLE XII.

Special meetings may be called by the President at the request of three of the Parochial Branches.

ARTICLE XIII.

This Constitution may be altered at any Annual Meeting by a two-thirds vote of the Executive Board.

MINUTES OF THE MEETING.

The Twenty-Third Annual Meeting of the Woman's Auxiliary of the Board of Missions was held in Springfield on May 17 and 18, 1910.

On the afternoon of the 17th all delegates and visitors were delightfully entertained with an informal afternoon tea at the residence of the President, Mrs. J. C. White. Rev. and Mrs. J. H. Hopkins were among the guests, and Bishop Osborne brought with him several members of the Standing Committee of the Diocese, which had been in session in the morning.

In the evening at the Parish House of the Pro Cathedral, Bishop Osborne gave a talk on African Missions, illustrated by excellent stereoptican pictures.

Wednesday morning at 9:00 o'clock the Corporate Communion was celebrated in the Pro Cathedral, at which a large number were present. Immediately after the service the business meeting of the Auxiliary was held in the Parish House, with the following program:

First, Bishop Osborne made a brief address to the Auxiliary and asked them to consider especially the holding of a retreat in Champaign next September.

The President then made a welcoming speech and the Secretary called the roll, first of delegates, then of all persons present from each branch.

St. Paul's, Springfield, showed fifteen members present, with Mrs. Charles Hay, Mrs. Dresser, Mrs. Driscoll, Miss Hurst as delegates.

Christ Church, Springfield, showed fourteen members present, with Mrs. Pollard, Mrs. Gridley, Mrs. Stadden, Miss Archer as delegates.

Waverly had three members present: Miss Watson, Miss Hopson and Mrs. Rohrer, delegates.

Cairo was represented by Mrs. Candee.

Champaign was represented by Mrs. Sherman, Mrs. Stock, Miss White, Decatur sent Mrs. Hoster, Mrs. Metz and Mrs. Crawford.

Granite City had five members present and Mrs. Ibbotson, Mrs. Leighton, Mrs. Neisen and Mrs. Whitehead were delegates.

St. John's, Springfield, was represented by Mrs. Clark and Miss Bloomfield.

Jacksonville was represented by Mrs. Tomlin, Mrs. Jackson and Miss Wakely.

Alton sent three delegates, Mrs. Hayner, Miss Taylor and Mrs. Wead.

By motion the reading of minutes of last year's meeting was abandoned. The Secretary reported a flourishing new Auxiliary established at Granite City, and spoke of the help received from Miss Forbes, of Danville, and Miss Pompey, of Mt. Pulaski, where there are no Auxiliaries.

The President then read her annual address.

At twelve o'clock the Auxiliary united in the noon-day prayer for missions.

The Secretary was then asked to read the Constitution of the Society, and some changes being found necessary the President was authorized to appoint a committee to make two changes; one as to time and place of Annual meeting, and the other that the various Vice Presidents were each to have oversight of special departments of the work.

A motion was made and carried to give twenty-five dollars to Glen Carbon from our surplus fund, retaining enough to pay for our necessary expenses.

An invitation was received and accepted from Champaign to hold our next meeting in that city.

Meeting was then adjourned for luncheon, which was served in the Cathedral Parish House by the ladies from St. Paul's and Christ Churches.

At two o'clock the ladies assembled again and listened to a most interesting and eloquent address by Mrs. Hopkins, wife of the Secretary of the Fifth Department.

At the close of the address the meeting was adjourned till May 1911.

PRESIDENT'S ADDRESS.

Those of you who were present last year will recall that I had thought seriously of not making any address. After my second year in office there are so many things to speak of, I hardly know where to begin.

This may not have been a good year financially. Here in Springfield it has been a prayerful one. We have had a monthly service of intercession. Though the attendance has not been all we could wish, (I might say, not all we could expect), we do not measure the good by numbers. Who can count the benefit of united prayer? Just a quiet simple earnest asking God's blessing on the work near our hearts.

How?

The weary ones had rest; the sad had joy

That day, and wondered "how."

A plough-man, singing at his work had prayed

"Lord keep them now."

Away in foreign lands they wonder how

Their simple word had power;

At home the Christians, two or three, had met

To pray an hour.

Yes, we are always wond'ring, wond'ring "how,"

Because we do not see

Someone, unknown perhaps, and far away,

On bended knee.

During the year, the old Secretary's book has been found. In it is a later Constitution than the one read last year, as well as many interesting records of past years. The Constitution should be changed a little to meet present requirements. It should be printed each year in the report; also the names and addresses of all Parish Branch officers. To this end I shall ask each

Branch present to give the Secretary the necessary information before we adjourn.

I have received a number of appeals to which we have not responded. The demands for time and money are constantly increasing. The special appeal I wish to make today is for Personal Pledges for Diocesan Missions, or Church Extension in the Diocese. Our Pledges have not increased with the years. Can it be because we do not have an eloquent clergyman as deputy from the Synod to ask us? I think you will all say "no." Let us then give conscientiously without being asked.

I wish also to speak of the election of officers. This year Diocesan officers will be the only women eligible as delegates to the Tri-ennial meeting, at the time of the General Convention in Cincinnati. I will therefore ask in all kindness that you do not elect anyone out of courtesy merely. Courtesy is necessary in all our dealings; but it does not require that we shall disable the Master's work. Let your choice fall on capable, willing women. A member of the Western Michigan Branch wrote me about their unusually efficient organization. "We have no *dead wood*." I could preach a sermon on dead wood; what it does to the tree and what is done to it when a good gardner is in charge. It is cut off and burned. Please let us have life in every Branch, in every leaf and bud. We are weak and rather discouraged with ourselves. If every individual member did her real best no *dead twigs*—all pruned away—the whole Diocese would feel the added life and we would all take courage. Dare I suggest that some of us who profess and call ourselves Christians, are more alive, more willing-hearted towards our social and club affairs and all such things than we are towards our Christian duties? Do we spend ten dollars more easily to entertain—say at Bridge—than we do one dollar for the things that are really worth while? Let me leave this one thought with you with all love and seriousness. Take an inventory of yourselves; your lives. Balance your account with care. Try to see things in their right proportions—the things which are really worth while against those which are not. If each individual member of the Springfield Branch will do this faithfully and honestly, I will have no fear for the cause of Missions in this Diocese.

I hardly like to leave unmentioned the Laymen's Missionary Movement and the gathering of the Fifth Department in Grand Rapids last October; but time does not permit to go at all into GENERAL subjects of interest.

REPORT OF BABIES BRANCH.

According to an old adage, "Children should be seen, not heard." So the Babies' Branch will give a very brief report.

The Branch in Cairo has increased to 39 members and sends an offering of \$17.07, the largest in the Diocese.

The Branch in Danville goes on about as usual, with 7 members and an offering of \$6.37.

The Alton Branch has grown to 13, with an offering of \$5.51. The Secretary of this Branch has felt obliged to resign and no one has yet been found to take her place.

St. Paul's Branch, Springfield, is greatly reduced in number, as many have outgrown the Babies' Branch, and there seem to be few babies to take their places. There are 21 members, and an offering of \$8.11.

A Branch in Christ Chuhch, Springfield, is fairly well started, with a membership of 8, but no offering this year.

The total amount of offerings is \$37.06, with a balance from last year of \$2.31, making in all \$39.37.

REPORT OF JUNIOR BRANCH.

The Springfield Branch of the Junior Auxiliary feel that it has had, on the whole, a rather encouraging year.

Three new branches have been started since our last Annual Meeting and the four old ones have gone faithfully on with their work.

There was also one appeal outside of the Diocese for information in starting a Junior Branch.

Christmas boxes were sent to the Rev. J. R. Brooks, in charge of the colored work in Cairo, Ill., by four of our Branches.

One Branch has done a good work in helping one of our city missions. Two have contributed towards the United Offering, one towards the apportionment. Our youngest Branch is making rugs to earn money for its Christmas box; another Branch is learning to sew by making the clothes for the dolls that will go into the Christmas box.

One leader tells me of the interesting way the time of their meetings is divided. The first half hour is given to sewing, next half hour to lesson, reading and prayers, and the last half hour to recreation and games.

This arrangement sounds very attractive and might be a helpful suggestion for other leaders.

For the sake of those who are new as leaders in the Junior work, let me say a word or two. The Junior Auxiliary is a Missionary Society and its work must be for objects suggested by the Church's Board of Missions. Our work can be Diocesan, Domestic, Foreign—one or all. If the church to which the Juniors belong is a Mission, then they, as Juniors, can work

for their own church and get credit for it as Diocesan Missionary work, but if they belong to a Parish, then as Juniors they can not give their offerings to their own church, as that would not be Missionary work. Also there are many worthy objects, such as our city hospitals, for which the children love to work; but such work cannot be included in our Junior reports. It is only recently that our beloved Orphanage has been included in our Missionary work, and how glad we are that now our Juniors and others can do some of their Diocesan Missionary work by sending money and boxes to these little children in our See city.

The United work of the Juniors this year is the preparation of Christmas gifts for the girls and boys at St. Mary's-in-the-Mountain, Suwanee, Tenn. All the branches but one are contributing to this Christmas box.

The more united we are in our work, the stronger we will become. I feel pretty sure, if the leaders would confer with the Diocesan Secretary before taking up work suggested by some one outside of the Diocesan organization, our plans could be better carried out.

For instance, we should all contribute toward the United Offering and also pay our assessment towards the apportionment. Our assessment is \$20.00, and it seems that the fair way to do would be to divide this amount according to the strength of the Branches and ask a definite sum from each one. I hope that this can be done next year. And here let me make a plea for a Junior leader's conference. Could we not arrange such a conference, to be held at least once a year at the time of our Annual Woman's Auxiliary Meetings? I am sure that our Diocesan President will help us arrange this. Let us be a united organization, working along lines laid down by wiser heads than ours and carry out faithfully our three objects of prayer, study and work.

We have in our seven branches 63 Juniors, which shows how many of the Church's children in the Diocese are left who might swell our little Auxiliary into an army, which should do great things for Missions as we now do little things.

REPORT OF CHURCH PERIODICAL CLUB.

I resigned to the Bishop last spring, but at the earnest request of Mrs. Starbuck, I held over until after the yearly report was printed, or until my successor was appointed. I have not done much. I cannot write letters very well and when I do they are not often answered.

I am sorry to report that the Librarian at Cairo has nothing to report and has resigned. So far as I know we have no one in the Diocese now but myself.

I still send papers to Prof. Weeks at Lebanon. Mrs. Roberts sends "Spirit of Missions" to Philadelphia.
