PRESIDENT'S ADDRESS

To the Tennessee Branch of the Woman's Auxiliary:

MY DEAR FRIENDS AND CO-WORKERS:—It gives me great pleasure to once more welcome you in the grand old town of Columbia, where we have always been loyally entertained and made to feel thoroughly at home.

At our Diocesan Conventions every parish ought to be represented, and yet I notice some are not, thereby depriving themselves of the influence and instruction derived from such meetings, and losing the zeal and usefulness which would naturally result.

It is our purpose to review the work of the past year, discuss new ideas as to the carrying on of the work, urge the necessity of going *forward*, and to ask your full coöperation in the efforts needed.

After reviewing the work done last year, I cannot but congratulate you most heartily upon the work accomplished. You have met all your obligations to the Board of Missions and to your Diocese, although we have passed through a very trying financial year.

The Auxiliary is a part of the Church organization of the Diocese; we must therefore rise to a full and true appreciation of our position and duties. The *Spirit of Missions* says, "To be a Diocesan officer means that we must use our personal influence among women throughout the Diocese and coöperate with every officer of the Diocesan branch in extending *that* influence." Therefore, let us stand together with a determination to use our God-given gifts of influence, and not only increase our numbers, but, with a oneness of purpose, work on, climbing each day to greater heights and diffusing our influence, until every woman in *this* Church is doing her utmost in extending the missionary work throughout *this* Diocese and beyond its borders.

The Church, in her wisdom, has provided many ways in which the spirit of self-sacrifice can be put into practice. First, we must not neglect the assembling together and praying for those who

have given themselves to labor in the mission field; next, it is very important that we should know where our missionaries are located, and of the particular work in which they are engaged, so that we may keep in touch with them, pray for them in a general way and, individually, ask God's blessing on their special work—this is essential. We must also give of our substance, and in no better way can we do this than through the United Offering. This is the last year we can work on the Offering, which is to be presented at the General Convention in St. Louis, October, 1916. Let me therefore urge each member of the Tennessee branch to do everything she can, so that our contribution may be a worthy one.

The Juniors ask for your interest and assistance. We should have a Junior branch in every parish throughout this Diocese. Where the rector of a parish is vitally interested in Missions, visits his Junior branch and keeps in touch with its work, stimulating its members to a faith in prayer, then that branch is a live one and stands for something. We must appeal to our rectors to help us in this most important work.

The Educational Department is doing splendid work under its efficient Secretary, Mrs. Tyler Calhoun.

In closing, let me quote from the Minneapolis branch of the Woman's Auxiliary—in moments of depression, these words are comforting: "God never gives us an opportunity that we are not equal to, if we only try. Missions are God's business; He will not let them fail. Missions are our business; He will not let us fail."

Let us, therefore, turn with glad hearts and face the work of the new year.

REPORTS

SECRETARY'S REPORT

During the past year thirty-three branches have undertaken and reported active work. Three branches make no report.

Three hundred copies of the last Annual Report were printed and distributed amongst the Bishop and clergy of the Diocese, the diocesan and parochial officers of the Auxiliary, the Bishops and officers of the Province, and the general officers of the Board of Missions and the Woman's Auxiliary.

Twenty branches report having held a corporate communion on the Feast of the Annunciation and seven branches set aside another day for this purpose. One branch (Fayetteville) holds a weekly corporate communion for the members of the Auxiliary.

Seven branches joined in the work of federated missionary societies in their cities. This comprised study classes, lectures, missionary institutes, and programme meetings. The text-books used were "Acts of the Apostles," "Bible," "The Light of the World," Christianity and Civilization," "The Social Aspects of Foreign Missions," "China's New Day."

Your Secretary wishes to stress the importance of the meeting of the Auxiliary in the Province to be held at Sewanee in October next, and to ask for the interest and coöperation of every parochial branch of the Auxiliary.

It was moved by Mrs. Thomas F. Gailor, seconded and carried :

Resolved, That any branch not reporting active work from one Triennial to another should be erased from the list of active parochial branches.

The Rt. Rev., the Bishop, gave his Annual Address to the Auxiliary, and Mrs. Woodworth of White Bluff also spoke.

SECOND DAY

WEDNESDAY, May 5, 9 A.M.

The meeting was called to order and opened by the President in the usual manner.

Addresses by visiting missionaries being the order for the day, Miss Laura Bassett, of the Mission of Our Saviour at Jump Off, gave a forceful address on her work, and Archdeacon Windiate spoke in detail of the work under his jurisdiction at Monterey, Paradise Ridge and at other points. Mr. Manly of Monterey also spoke.

Mrs. Tyler Calhoun held a Study Session introductory to the work of Study Classes in general and the consideration of "The Social Aspects of Foreign Missions."

The meeting adjourned in order that the delegates might attend the opening service of the Eighty-third Diocesan Convention.

WEDNESDAY, May 5, 2 P.M.

The President opened the meeting in the usual manner.

Miss Clark of Paradise Ridge presented the work she and her sister are doing in caring for homeless infants. A voluntary offering was taken for this work and handed to Miss Clark.

Parish Reports were made and pledges taken for the ensuing year.

Report of the Primary Meeting of the Woman's Auxiliary in the Fourth Province, held at New Orleans in November last, was made, and it was resolved, on motion, that delegates to this meeting be instructed to vote on the matter of a Travelling Auxiliary Secretary for the Province in accord with the majority vote at the time of the meeting.

Mrs. C. H. Drane of Clarksville presented a resolution from the Clarksville branch, which was accepted by the Auxiliary and ordered sent to the Diocesan Convention as a Memorial from the Auxiliary. The Memorial read as follows:—

*Memorial to the Bishop and Members of the Eighty-third Convention,
Diocese of Tennessee, from the Woman's Auxiliary to the Board of
Missions, Diocese of Tennessee:*

By resolution of the Clarksville branch of the Woman's Auxiliary, presented to the delegates of the Woman's Auxiliary in Tennessee, assembled in annual meeting at Columbia, May 5th, 1915, it was resolved to memorialize the Bishop and the members of the Diocesan Convention as follows:

WHEREAS, The apportionment for General Missions is made up by gifts from the parishes, the Woman's Auxiliary, Sunday Schools, individuals and from other sources, the Treasurer of the Board of Missions keeping record of the same; and

WHEREAS, Such sums may be forwarded through parish treasurers, Sunday School treasurers, Auxiliary treasurers, or may be sent direct by

individuals, in order to be credited to the apportionment of the respective parishes,

Be it Resolved, That the Diocesan Convention be asked to change the system of recording gifts to Diocesan Missions in respect to General Missions.
