SECRETARY'S REPORT

During the past year thirty-three branches have reported active work. A new branch has been organized at Buntyn and the branches at Holy Trinity, Memphis, and at Morristown have been reorganized.

Twenty-one branches report having held forty-seven services of Corporate Communion, on the opening of the fall work; the Feast of the Annunciation; on other special days and in connection with the Pilgrimage of Prayer.

Plans carried out in the Diocese during the week appointed for the Pilgrimage of Prayer embraced noon-day prayers, quiet hours, meditations, daily prayer services, special Sunday services, roll-call answered by prayer at daily meetings, systematic individual prayer covering twelve hours each day throughout the week.

Features reported as having been most helpful to branches are lectures, meditations, quiet hours and quiet days, inspiration from individual members, letters from missionaries, systematic giving through duplex and other envelopes, the assigning of each member to a mission station, of which special study was made and reports given from time to time.

The apportionment; work amongst negroes; St. Luke's, Tokyo; St. Agnes's, Kyoto; Church General Hospital, Wuchang; and the United Offering have been brought specially to the attention of the branches.

EDUCATIONAL SECRETARY

In a recent letter from Dr. Gray, our retiring Educational Secretary, he says: "Though I am going to take up a new type of work, I do so with the firm conviction that the future expansion of the Church depends more than anything else on the activities of the educational department. Let me assure you that in Dr. William Sturgis, the new Educational Secretary, you have a leader in whom you will all rejoice, and under whom you can expect the work to go forward. It has been a personal grief to me that our last fight together has been so badly blurred by the oversale of *The New World*. I am sure you all know what the facts are: we calculated to a nicety that we had plenty of books to carry us through, and then, all of a sudden, at the last moment, orders began coming in from this and that place, by tens, and twenties, and thirties, with a result that we were not only unable to supply the books, but were not even able to answer the letters. We had something like two thousand letters in twenty days. A slight mathematical calculation will enable you to see that the force we have at the Mission House could not hope to handle such a tidal wave as that."

I am happy to report that the Diocese of Tennessee had her share in causing this "tidal wave." We had twelve Study Classes, thirteen Programme Meetings and six Reading Circles. For next year the Board is providing a series of texts, all based

on the Bible as a missionary study book. The following report shows how our work was distributed :—

MINUTES

TUESDAY, May 8th, 1917.

The Thirtieth Annual Meeting of the Woman's Auxiliary to the Board of Missions in the Diocese of Tennessee convened at Christ Church, Nashville, on Tuesday, May 8th, 1917, at 10 A.M.

The Rt. Rev. Thomas F. Gailor, S.T.D., Bishop of the Diocese, assisted by the Rev. H. J. Mikell, D.D., celebrated Holy Communion. The sermon was preached by the Rev. B. B. Ramage, rector of St. Luke's, Memphis.

At the conclusion of the service the Bishop spoke feelingly of the long-continued illness of Mrs. John Shortridge, the beloved Diocesan President, who was absent from the meeting for the first time in twenty-nine years.

Telegrams of greeting were ordered sent to Miss Julia C. Emery, Miss Grace Lindley, and to Mrs. M. E. Frye, of Rossview.

The meeting adjourned for luncheon.

TUESDAY, May 8th, 2:30 P.M.

The meeting was called to order as a Junior session by Mrs. W. E. Barnes, Junior Secretary-Treasurer.

Mrs. Haskell Rightor, Secretary-Treasurer of the Little Helpers, presided over a session devoted to the work of her department. Reports of these meetings will be found printed herein.

Mrs. W. H. DuBose assumed the chair and called for parochial reports. Pledge blanks for 1917-18 were distributed.

The meeting adjourned to attend a tea tendered the delegates by the Chancel Society at the Centennial Club.

WEDNESDAY, May 9th, 9:30 A.M.

The meeting was called to order and opened with prayer by the Vice-President, Mrs. W. H. DuBose. Addresses from missionaries on their work being the order of the day.

Mrs. Jennie Woodworth spoke of the activities under her care at White Bluff, and her remarks were supplemented by the Rev. Prentice Pugh, minister-in-charge.

Miss Augusta Long, of St. Raphael's, Monterey, spoke of the work being carried on at that mission center under Archdeacon Windiate.

The meeting adjourned in order to attend the opening service of the Eighty-fifth Annual Diocesan Convention.

WEDNESDAY, May 9th, 3:30 P.M.

The meeting was called to order and opened with prayer by Mrs. W. H. DuBose.

Minutes of the previous session were read and approved.

Mrs. W. H. DuBose opened a conference on the United Offering, and it was moved by Mrs. Ramage, seconded and unanimously carried, "That there be added to the Service of Corporate Communion, held in this Diocese on the Feast of the Annunciation, a second similar service on St. Luke's Day, October 18th, at both services the United Offering to be presented."

A conference on Missionary Boxes was led by Mrs. W. H. DuBose. Moved by Mrs. Gifford, seconded and carried, "That the delegates to this annual meeting pledge themselves to do all

in their power to see that gifts of Missionary Boxes do not fall off owing to national conditions."

A conference on Educational Opportunities was led by Mrs. Tyler Calhoun, and it was moved by Mrs. Loaring Clark, seconded and carried, "That the delegates attending the annual meeting of the Woman's Auxiliary in the Diocese of Tennessee pledge themselves to do all in their power to have some one person appointed in each parochial branch, whose business it shall be to disseminate missionary information, and who shall be called the Educational Secretary."

Prayers for two sick members were offered and the meeting adjourned.

THURSDAY, May 10th, 9:30 A.M.

The meeting was called to order and opened in the usual way by Mrs. W. H. DuBose.

The report of the Nominating Committee was made by Mrs. Charles Martin. It was moved, seconded, and after discussion, unanimously carried that the report be accepted.

Mrs. James H. Smith, of Clarksville, opened a conference on the New Junior Plan, and the following resolution was moved by Mrs. W. E. Barnes, seconded and unanimously carried: "That the New Junior Plan, adopted by the Board of Missions, be confirmed by the Auxiliary in this Diocese, and that this resolution be presented at the missionary meeting to be held this evening, and that the clergy and Sunday School superintendents be asked to coöperate in the change."

The Rev. W. J. Loaring Clark, D.D., invited the delegates to join the Diocesan Convention in order to hear addresses from the Hon. T. C. Rye, Governor of Tennessee, and Adjutant-General Rogan.

Mrs. Bolton Smith spoke at length on Colored Work, and particularly on the work carried on at Keeling. At the conclusion of her excellent paper, on motion of Mrs. Tyler Calhoun, it was moved, seconded and unanimously carried, "That the delegates to this annual meeting of the Woman's Auxiliary pledge themselves to do all in their power to extend the work of the Church amongst Negroes."

The scope and plan of work of the Daughters of the King was presented by several ladies under the chairmanship of Mrs. Joseph Gibson.

The Secretary spoke of the National League of Woman's Service, and asked that the Auxiliary as a whole tender to the State President, Mrs. Jesse Overton, their services in whatever capacity they are qualified to fill for the duration of the war in which we are participants.

It was announced that the next annual meeting will be held at St. Luke's, Memphis.

The minutes were read and approved, and the meeting adjourned *sine die*.

(4) That we, as the Woman's Auxiliary of the Diocese of Tennessee, do our part in the work of the Church Women of America in emulating the fine example of the Church Women of England in making our gifts not less, but greater, in this time of war.
