The Thirteenth Annual Assembly of the Daughters of the King was held in Trinity Church, Clarksville, January 14, in conjunction with the Ninety-second Diocesan Convention.

The session began at 10:30 with corporate communion, renewal of vows and quiet hour conducted by the Rev. Mr. Watts assisted by the Rev. Mr. Sharp. The sermon was preached by the Rev. Mr. Sharp of Nashville.

11:30—Registration of Delegates.

11:45—The Business Session was opened with affectionate greetings from our President, Mrs. C. M. Chilton.

Mrs. R. E. Mitchell, Chairman of Credentials, presented the following names of twenty-two members, representing twelve Chapters, as duly accredited delegates, and badges were presented by Mrs. L. M. McKoin.

Miss Emmie Tyler of Clarksville gave a most cordial address of welcome to all delegates which was graciously responded to by Mrs. Palmer Farnsworth of Memphis.

A rising vote of thanks was given the retiring officers. Mrs. Chilton requested that we co-operate with the Brotherhood of St. Andrew in every way we can to establish family prayer in the home.

Miss Matilda Porter, our Provincial Vice President, unable to be with us on account of illness, sent a most wonderful account of her missionary journey which was read by Mrs. Joseph Gibson.

Sixteen Chapters were organized in ten days. Mrs. Loaring Clark made a motion that we send a message to Mrs. Ewing and Miss Porter regretting their absence. It was decided to send Mrs. Ewing a telegram, and Mrs. Gibson, Mrs. Dismukes and Mrs. Wilson were appointed to take a personal message of love and greetings and also to say to her that her resolution on prayer had been passed.

Mrs. Kirwan's talk on the Sewanee Training School was most interesting. The Daughters held three conferences. The Rev. J. W. Shaad paid a beautiful tribute to the Daughters of the King.

A Chinese Priest at one of the conferences talked to the Daughters on "Women in China." Miss Anna Cummins, a Junior Daughter, gave some helpful thoughts and an account of the work of The Junior Daughters of the King, emphasizing the fact that through prayer we serve.

The next topic, "The Daughters of the King and Evangelism," by Mrs. Loaring Clark. Mrs. Clark stated all women may not be able to do personal work, but all could pray. If we are true and loyal Daughters we can make ourselves right with God.

A wonderful work of Evangelism started by a group of men at St. Paul's, Chattanooga, was told by Mrs. Clark. Mrs. Clark gave us a list of books we might read in this work of Evangelism.

An appeal was made to all Daughters to memorize the text found in St. Matthew 28:10. "Be not afraid. Go tell."

The first topic for the round table discussion was "Have you formed a prayer committee, and how it is serving?" lead by Mrs. Gibson.

Christ Church, Nashville, reports having a small box placed in the vestibule of the Church where requests for prayer are written and left. Each Daughter serves one month.

Mrs. Chilton reports a Prayer Committee of three serving at Calvary for one month, reporting to Dr. Blaisdell's prayer group on Sunday morning.

"Should Not We as Daughters Be Vitally Interested in the Church Mission of Help," by Mrs. R. E. Mitchell. Mrs. Mitchell said the Daughters of the King should be interested in this work. They could be of much service, helping the trained worker and assisting in various ways, not only visiting but above all with their constant prayers.

On account of two cases, helped through the Church Mission of Help, by Mrs. Mitchell set forth the true spirit

of the Daughters of the King. Through Prayer and Service these two young girls have been brought nearer to Christ. Mrs. Mitchell brought leaflets of prayer requesting the Daughters to use them for strengthening this much needed work.

The program for Bible Study arranged by Christ Church Chapter, Nashville, is ready and can be obtained from Mrs. Felix Ewing at 5 cents a copy.

Mrs. Dismukes told us of St. Luke's Community House, a work near and dear to all Episcopalians in Nashville. Much joy was expressed when Mrs. Dismukes announced that Miss Nolan had returned after an absence of two years. This work has been carried on since 1913. The cost is about \$300 a month. This year St. Luke's House will not be financed by the Community Chest as it has been heretofore.

The next topic for discussion was "Should Not the Junior Daughters Have Their Own Diocesan Head?" Mrs. Chilton said she thought she had thought of something new, but on looking over a Royal Cross found there had been a motion made and carried at the Triennial at Portland to that effect, and we will fall in line later.

Mrs. Chilton asked for a motion that we appeal to the National Council to call our annual meeting the Diocesan Assembly of The Daughters of the King instead of the Local Assembly, having the word local applied to the Assembly of Chapters in the same locality. The word Diocesan applied to Chapters in the State. A letter read from Mrs. Ewing explained the various departments of our work under the Provincial system.

Special prayers were offered for Mrs. Rudolph, President of Clarksville Chapter, who was unable to be with us on account of illness.

A motion made and passed by Mrs. Gibson that we pay the expenses of our State Officers to the annual meeting of the Diocesan Convention.

Mrs. Chilton suggests that where there are several chapters like Nashville and Memphis, a Chairman be appointed to look after details and arrangements.

The self denial fund was explained. This fund is used for the support of two missionaries and two Bible women in China, coming the last week in Epiphany.

The Master's Fund coming at Witsuntide, helps pay the first years training of a Deaconess.

4:30 P. M.—Memorial Service conducted by the Rev. Mr. Sharp for Miss Lucy Orgill, Daughter of Calvary Chapter.

It is with great appreciation we extend hearty thanks to all Daughters of the King in Clarksville for the cordial welcome and the true hospitality we received. The strengthening of old friendships, the forming of new, exchanging ideas in our work, and above all the privilege of assembling together, renewing our vows at the Altar, all working for one end, The Spread of Christ's Kingdom.

Mrs. Harry C. Gerhart, Correspondent, Clarksville, Tenn., emphasized several phases of the work of the Church Periodical Club in the Diocese: The soliciting of subscriptions to the Church papers for young and old that the state of passivity brought about by the lack of information be overcome.

In this effort she earnestly requested the co-operation of the clergy.

"A Church Paper in Every Family," is the slogan.

That upon the librarian and her corps of assistants depends the enlargement of the work which is developed by conditions of their own environments. They must arouse the interest and co-operation of the whole community. Our efforts are not bound by denominational lines but is a service for all who need.

That we supply our own institutions with acceptable reading matter, not only as a duty but a privilege, and be faithful in the obligations assumed.

Inform ourselves about the Travelling Libraries in the Diocese and the importance of Community Libraries at several stations.

Don't hoard magazines or books.

As our "Special" for this year, which must be considered an emergency call, we will help in the equipment of the library for the DuBose Memorial School. Money and lists of standard books are acceptable. Every parish in the Diocese will want a part. Consider it an individual responsibility now.

The Organization of the Church Mission of Help is a branch of the social service department. An interest in the work is growing rapidly. We have found valuable co-operation with the established agencies in Memphis and with the Nineteenth Century Club.

Number of Actual Cases handled during the year.....	26

We secured transportation, help pay board, furnish clothing, secure employment and help to reunite families. We handle all cases of the unmarried mother who comes through the Police Department. We visit the Ella Oliver Home and The Bethany Training Home once a week. Many visits are made to the home of The Good Shepherd. We have a service at the Ella Oliver Home once a month, have an Automobile Committee with twenty-five automobiles and the girls in the two institutions are taken out to ride once a week.

In connection with our unit we have a band of young married women called the Mother Goose Club with a membership of twenty. They hold meetings once a week, make layetts for such cases that come to the attention of the C. M. of H. They have furnished on an average of two layetts a month, since being organized in October, 1922. The members visit the Ella Oliver Home and the Bethany Training Home to help the girls with sewing. They have also vis-

ited the Maternity ward of the general hospital and whenever possible get in personal touch with the girls.

In October, 1923, Miss Christine Boylston, Organizing Secretary of New York, spent one week in Memphis and during this time addressed the Convocation of West Tennessee, held at Grace Church, visited the Nineteenth Century Club, held a conference to the Girls' Welfare Committee under the Council of Social Agencies of which Mrs. M. W. Searight is Chairman, and addressed the Unit of the Church Mission of Help in Memphis.

We were also instrumental in influencing the Council of Social Agencies to extend to Mrs. Martha P. Falconer of the American Hygiene Society of New York, also a member of the National Council of the C. M. H. to visit Memphis and make a survey of the work done by the local agencies in the field of protective work for women and girls. Mrs. Falconer made an address at one of our meetings on what is being done in other States to strengthen their social work legislation and to tie together the welfare work done by the Woman's Protective Bureau and Private Agencies. Miss Evelyne Chase of Nashville, assisted Mrs. Falconer, representing the Infant Maternity and Welfare Work, gave an interesting talk to our Unit.

Just as soon as we hear the outcome of Mrs. Falconer's report it is expected that the Council of Social Agencies will have a trained worker paid from the Community Chest which will enable us to carry on much better and more efficient work, and our Unit we hope, will become a real factor in the fight for Christ and His work against the power of evil and darkness.

A called meeting was held April 17 for the purpose of drafting a Constitution, to elect Heads for the unexpired terms of the Mission and the Extension Departments and to determine some way to finance the Extension Fund.

A Constitution was drawn up and sent to the Central Council to be approved.

Mrs. Hugh Anderson was chosen to fill the vacancy in the Mission Department; Mrs. F. C. McDonald, the Extension Department.

A motion carried for each member to bring 50 cents or more to the first meeting in September. In this way to finance the Extension Fund. It was most gratifying to have responses from four of our eight Branches: Christ Church, Nashville; Church of the Advent, Nashville; St. Paul's, Chattanooga, and St. Peter's, Nashville.

A Holiday Camp was held at Sulphur Springs, Tenn., from June 27 to July 11, at which sixty-four guests, including two clergymen, were entertained. The amount for board covered all expenses and left a balance of \$11 for future use.

Four new Branches have been organized during the year 1923, four Candidate Classes have been formed and one Scout Troop.

MINUTES OF ANNUAL MEETING.

The Fifth Annual Meeting of the Woman's Auxiliary to the National Council opened January 15, Trinity Church, Clarksville, with the Communion Service, The Rev. George O. Watts was the Celebrant, Bishop Maxon pronouncing the Absolution and Benediction.

Dr. E. P. Dandridge, Christ Church, Nashville, was the preacher.

Directly after the service the meeting was called to order by the President, Mrs. Loaring Clark, who asked the Rev. Chas. N. Tyndall, D. D., St. Luke's, Memphis, to conduct noon-day prayers. He also gave a brief impressive talk, stressing "Prayer." This was followed by a helpful, cheering message from Bishop Maxon.

Mrs. James Northington gave the address of welcome which was responded to by Mrs. Swick, South Pittsburg.

Our Honorary President, Mrs. John Shortridge, was presented by Mrs. Clark and in a few words expressed her love for the members of the Woman's Auxiliary.

The Secretary was instructed to send a message of greeting to Miss Tillotson and Woman's Auxiliary Secretaries at Church Mission House, Mrs. McCargo, who was unable to attend the Convention, Mrs. Rammage, Oxford, Eng.; Mrs. Troy Beatty, Mrs. Charles Drane and Mrs. Bolton Smith.

A letter from Bishop Gailor telling of some of the conditions in Japan was read by Mrs. Clark who reported having sent a message from the Women of Tennessee to Bishop Gailor and Dr. John Wood on the eve of their sailing for the Orient.

The year's work of the Woman's Auxiliary in the Diocese of Tennessee was reviewed by Mrs. Clark. She also spoke of what had been done for the Blind through the Department of Missions; work that had its inception in this Diocese.

After the Secretary's report Mrs. John R. Wheeler told of the work done in Middle Tennessee, followed by the report of East Tennessee read by Mrs. Ed Davidson, Chattanooga. Mrs. Wm. Marsh, Memphis, gave the report of West Tennessee.

Mrs. Clark announced that 10:30 a. m. would be the hour each morning for the opening sessions.

Luncheon was announced and the meeting adjourned.

AFTERNOON SESSION.

January 15, 2 P. M.

The afternoon session was opened by Mrs. Clark with prayers for our missionaries, under the Prayer Partnership.

The roll was called by the Secretary to which nine officers and forty-two delegates from seventeen parishes responded.

A request was made that all parish Church Service League reports be handed Mrs. McKoin.

Mrs. Gerhart announced a conference of the Church Periodical Club for Wednesday morning at 9:30.

An invitation was extended by Mrs. Clark to a reception at the home of Mrs. Hunter Merriweather, Wednesday afternoon from 4 to 6 o'clock. Officers of the various organizations were asked to assist.

Mr. Galliard, new Secretary of the Field Department, brought greetings from the National Council.

Miss Elizabeth Matthews and Mrs. Conrey were announced as speakers for Wednesday.

In the report of the Educational Secretary, Mrs. DuBose, more study of missions and of what the church is doing was stressed.

The books for study, as selected by headquarters, are: "Problems of Japan" and "Creative Forces In Japan."

These books should be ordered at once and Mrs. Dubose also suggested a copy of "The Story of the Program" being in each branch. Each study class program should be made as instructive and interesting as possible.

She then gave reports by parishes.

This was accepted with many thanks to Mrs. Walker for her arduous task.

The report of the Supply Department and Box Work was made by Mrs. Ring, who asked that parish reports be sent in promptly, not only to her but also to the Vice-President of the Convocation.

Miss Edmondson, White Bluff, emphasized quantity rather than quality in preparing boxes of clothing.

Although the Beatty Memorial Fund to date was short \$120, Mrs. Norvell reported that more than that amount was provided. Mrs. Clark asked Mrs. Norvell and Mrs. Otey Walker to assist her in presenting this fund at the opening of the Convention.

A brief, impressive talk was made by Mrs. Norvell explaining the origin of the Memorial to Bishop Beatty.

She said what fifteen dioceses will accomplish in three years the Diocese of Tennessee has done in one year.

Mrs. Norvell presented a resolution which was unanimously passed asking that Mr. Wright, Rector of Grace, Memphis, be permitted to designate the first holder of the Beatty Memorial Scholarship.

Professor Nelson of Hoffman St. Mary's, Keeling, gave a most interesting account of the school and expressed his deep appreciation of all assistance given by the Woman's Auxiliary and individual members.

A motion was made for each Convocation to give a \$50 scholarship to the school, Bishop Maxon suggesting that the students be selected from other districts than around Mason.

A map of Tennessee showing the counties in which the Episcopal Church IS and IS NOT working was shown by Bishop Maxon. He gave a most lucid account of the work being done in the Diocese, and made the following suggestions to the Woman's Auxiliary:

- 1.—To see that the apportionments are paid.
- 2.—Each Convocation endeavor to establish a church in its district thus changing on the map a black county to a white one.

- 3.—Holding Preaching Missions.

He closed with these words: "God will give you sense enough and strength enough for all He wants you to do."

Dr. Wright announced the meeting Tuesday night conducted by the Department of Religious Education, Dr. Dandridge to be the speaker.

Mrs. Mitchell asked for a meeting Wednesday morning of the Church Mission of Help, and also presented the following resolution:

"Since the Woman's Auxiliary in the Diocese of Tennessee is now working in the three fields of service—Missions, Social Service and Education, and since the Woman's Auxiliary is now privileged to do Social Service work.

Therefore, be it resolved by the Bishop Troy Beatty Unit of the Church Mission of Help that the attention of the Officers and Members of the Parish branches of the Woman's Auxiliary be called to the fact that the pledging of money to this work is now in the scope of their activities, and that any pledge made to the work of the Church Mission of Help will be deeply appreciated by this organization."

Dr. Wright offered the closing prayer.

WEDNESDAY, JANUARY 16, 1924.

Directly after the opening service of the Ninety-second Diocesan Convention the Woman's Auxiliary assembled in the Sunday School room of the Presbyterian Church.

Mrs. Clark called the meeting to order and opened with the Creed and Prayers. She then introduced Miss Elizabeth Matthews of the Department of Religious Education, National Council, and the National Executive Board of the Woman's Auxiliary, who took for her theme, "The Field of Religious Education."

She gave a most interesting talk and many helpful suggestions in regard to rearing children in a Christian atmosphere; stressing the need of more trained teachers in our Church Schools and of the co-operation of the parents with the teachers.

A discussion followed, after which Mrs. Clark made a few announcements of committee meetings, and then closed with prayer. The session adjourned for luncheon.

JANUARY 16, 2 P. M.

At 2 o'clock the meeting was called to order and Miss Matthews was asked to open with prayers.

The minutes of the previous day were read and approved.

Mrs. Clark reported having sent a message of loving greeting from the Woman's Auxiliary to Miss Lindiey who is in the Orient.

Mrs. Jas. M. Maxon gave the report by parishes of the United Thank Offering and presented the following resolution:

Resolved:

That the days for taking the U. T. O. Spring and Fall be changed to the Sundays following the Feast of the Annunciation and St. Luke's Day respectively. The clergyman in each parish being asked to preach a missionary sermon and the offering being taken while the congregation stands and sings "Holy Offerings, rich and rare, etc."

This was handed the Committee on Recommendations.

The meeting was turned over to Mrs. Harry Gerhart, Diocesan Officer of the Church Periodical Club, who introduced Mrs. Conrey of Ohio. She gave a splendid talk on the work done by the Church Periodical Club telling of many interesting incidents where postal cards, magazines, musical records, etc., had been of much value. She told of the good these had done in penitentiaries.

The work of the Church Periodical Club is not confined to the United States but its helpfulness is felt in foreign countries.

Mrs. Conrey closed her address with an appropriate quotation from Kipling.

Mrs. R. E. Mitchell took the chair and presided over the session of the Church Mission of Help.

She said that Mrs. Loaring Clark was an inspiration for this diocesan organization. It was formed by Bishop Gailor and given the name of "The Bishop Troy Beatty Unit."

The function of the Church Mission of Help is preventive and constructive rather than rescue and Mrs. Mitchell gave many touching accounts of lives brightened and uplifted by the wise counsel and tender ministrations of this splendid organization.

The Yearly Report was read by the Secretary, Mrs. Lowrance.

Announcement was made that cars would be at Trinity Church to convey the women to the home of Mrs. Hunter Meriwether where a reception would be held from 4 to 6 o'clock.

Mrs. McKoin, Diocesan Officer of the Church Service League, was asked to make a report. There are eleven active units doing splendid work and although not a Diocesan Organization it will still continue in the parishes.

Mrs. McKoin asked that parish reports be sent her and said she would be glad to furnish any desired information. She will hold the same office this year and communicate with each parish. It is hoped the Church Service League will be organized in the Diocese as it is nationally, with men and women on a Diocesan Committee. ffl

After the beautiful prayer of thanksgiving offered by Mrs. Clark the meeting adjourned.

THURSDAY, JANUARY 17, 1924.

The meeting of the Woman's Auxiliary was called to order by the President, Mrs. Loaring Clark. She introduced Dr. Lacey, the minister of the First Presbyterian Church, who responded with cordial greetings, then read the Fourth Chapter of John, closing with prayer.

Mrs. Henry Salmond, Diocesan President of the Girls' Friendly Society, was asked to take the chair and preside over the session of that organization.

The next speaker was Mrs. Davis Taylor who made a splendid talk on the Church School Service League.

A report from the Secretary of Prayer Partnership, Miss Susie DeBose, showed some branches most enthusiastic, a few rather slow to respond and eight not interested at all.

Dr. Mercer Logan, Monteagle, told of the total destruction by fire of the DuBose Training School, saying all is lost except the wonderful spirit of the people who directly after the fire knelt and thanked God that no lives were lost. The list of articles needed was given Mrs. Ring, Supply Secretary, to look after.

Mrs. Haskell DuBose told of the work done by our Missionary, Miss Brenner at St. Faith's, Yang Chow, China, training the Chinese women in Christian living and giving them a Christian education.

Prayers were asked for her and her co-workers.

Mrs. Clark read the list of our women missionaries.

Dr. Holland of Sewanee was welcomed as a new rector in the Diocese by Mrs. Clark and offered noonday prayers.

The report of the Missionary work of the G. F. S. was read by Mrs. Anderson of Nashville.

Mrs. McKoin told of the work accomplished by the Daughters of the King. Eighteen Chapters have been organized the past year making a total of thirty-six in the Diocese.

Report of the Credential Committee was read by Mrs. Underwood showing forty-two delegates and nine officers, representing seventeen parishes, were present.

Mr. John Fredson, a student at Sewanee and an Alaskan Indian, gave an interesting talk on not THE Church but OUR Church in Alaska.

He paid a loving tribute to Bishop Rowe and Arch-deacon Stuck—men who through self-denial and sacrifice accomplished such splendid work.

Luncheon was announced and the meeting adjourned.

JANUARY 17, 2:00 P. M.

The afternoon session was opened with prayer read by Mrs. Clark after which the minutes of the previous day were read and corrected.

The report of the Committee on Courtesy was read by Mrs. Marsh, and is as follows:

"We, the Committee, wish to express our hearty and grateful appreciation of the hospitality of the entire city of Clarksville. We feel that we are the guests of not only Trinity Parish but of the whole community. Especially do we appreciate the Christian fellowship shown us by the way in which the homes have been thrown open to us.

We desire to thank the Rev. and Mrs. Watts and all members of Trinity Parish, Dr. Dandridge for his inspiring

sermons, the organist and the choir for the beautiful music, Dr. Lacey and the Presbyterian Church for the use of the comfortable auditorium. Mrs. Hunter Merriwether and all who assisted in the reception given in her beautiful home; the press for the wide publicity given our meetings.

The example of Christian Unity and the spirit of co-operation have made our convention a memorable one.

Pledge blanks were distributed after which Mrs. Clark explained our National Special, Bishop Tuttle Memorial and a letter from Miss Nannie Hite Winston regarding it was read.

Mr. Killifer of Monterey was introduced by Mrs. Clark. He told of the growth of the Mission especially noticeable in the Sunday School and Library.

His request for copper screening for the windows was referred to the Supply Secretary, Mrs. Ring.

THURSDAY EVENING.

For the first time in the history of the Diocese one of the evening meetings of the Convention was devoted entirely to talks by the women on what has been accomplished through the women's organizations.

Thursday evening at 7:30 p. m., the closing meeting of the convention was held at Trinity Church with the Rt. Rev. James M. Maxon, D. D., presiding.

After the Processional Hymn, Creed and Prayers, Mrs. H. C. Salmond spoke on "The Girls' Friendly Society, Its Accomplishment and Development."

"The Church Mission of Help, Its Possibilities" was the subject of the talk given by Mrs. R. E. Mitchell.

Mrs. Harry Gerhart told of "The Church Periodical Club and What It Is Doing."

Miss Elizabeth Matthews of Southern Ohio gave many practical suggestions for the women of the Auxiliary on the matter of "The Church Service League."

"The Daughters of the King, Present and Future," was the subject of Mrs. John R. Wheeler's talk and Mrs. W. J. Loaring Clark spoke of the "Woman's Auxiliary, Our Aims for the Triennium."

Bishop Maxon made a short address, offered the closing prayers and pronounced the Benediction after which the Recessional was sung.

PRESIDENT'S MESSAGE.

Fellow Members and Friends of the Woman's Auxiliary:

My message to you, as your President, must be a condensation of what I said at our Annual Meeting.

I want to make it a very pointed and practical message—one that may help you in your service for the ensuing year—so I am not going to repeat all I said to you about the Memorial we have given the Diocese to our late beloved and honored Bishop Coadjutor, you know how happy this has made all of us, or about Japan and her Church and our work and responsibility there, or many other things of which I spoke, but I shall set before you some of the ideals which I know we should strive to attain.

We shall observe in our Devotional Life, Family Prayer with Daily Bible Reading; Grace before and Thanksgiving after meals; the Noon-Day Prayer for Missions; frequent Corporate Communion; Quiet Days; Meditations; Days of Intercessory Prayer as well as emphasize regular Church attendance. We must be prepared to give the reason for the Faith which lies within us.

For our Education and Information we shall organize and attend Study Classes, both for leaders and others; organize and lead Discussion Groups; see "The Story of the Program" is familiar to our women; urge attendance at Summer Conferences as well as do our utmost to see every Church family takes at least one Church Paper: "The Spirit of Missions," "The Living Church," "The Churchman" or "The Witness."

Then our Gifts—the expression of our loving service—for "Faith without works is dead"—We shall first be ready to give ourselves, our sons and our daughters for the work of the Church.

Then our United Thank Offering, our privileged gift of loving thanks. If there is any woman in the Church who does not yet know all about this great gift we shall inform her and see that she, and every other woman in our parish, is the recipient of a "Little Blue Box."

We shall complete our National and Provincial Specials as well as take our share in the two new pledges, one for the Church Mission of Help and the other for the three

scholarships at our Colored School at Keeling. Our parishes must know that the women of the Auxiliary are with them in their endeavor, not only to meet the Budget, but, to take care of some of the Priorities.

Then our Supply Department—Missionary Boxes in the Diocese for the DuBose Memorial Training School, the Hodgson-Emerald Hospital, White Bluff, Keeling, Monterey, Sherwood and the Sewanee Missions. Outside the Diocese we shall work as assigned by the National Office through our Supply Secretary.

We must stand shoulder to shoulder with the Commission on Faith and Order in its efforts to promote Christian Unity and be prepared to do all we can to further the work of the Young People of the Church, those who must "carry on" as we pass out.

I believe, too, that women have a very special part to play in the development of Evangelism throughout the Church and to use their influence in the matter of Personal Religion. "What think YE of Christ?" Each one of us must be ready to answer this question which has been the striking key-note of our days together this year and, above all, we must do the things we undertake thoroughly.

Individually, we shall not attempt to develop every ideal in this Message, but I pray each one of you will take up as many points as possible and make them yours: "Study to show thyself approved unto God, a workman that need not be ashamed."

Just a word, in closing, of thanks and warm appreciation for your loyalty to me and your splendid efforts, as evidenced by your growth in service, during the past few years. My love and good wishes will be with you and your officers always and, though I now serve in the ranks, my interest in and my enthusiasm for this greatest of all works are unabated, and I want each one of you to know that I am ready to serve you in any way in my power.

The Box work reports are splendid, every branch having filled its allotment.

The church women of Tennessee sent Christmas boxes to twenty-five disabled men at Oteen Hospital, Asheville, North Carolina.

In October, Mrs. D. D. Taber, the first Field Worker, appointed by the Extension Board as a United Thank Offering Worker, toured the state and gave most interesting and helpful talks.

The Woman's Auxiliary has lost by death, eight valued members.

REPORT OF VICE PRESIDENT, CONVOCATION OF EAST TENNESSEE.

Under the vigorous leadership of Bishop Maxon and our Dean, Dr. Whitaker, the Auxiliary has made some advance in 1923. We were fortunate in having, early in the year, a visit from Mrs. Taber, our U. T. O. field worker, who visited all the Branches and aroused new interest in the U. T. O.

In April, Knoxville had a visit from our Diocesan President, who addressed the Branches at a U. T. O. service, and also at a luncheon arranged in her honor by the Knoxville Branches. Invitations were sent to the other East Tennessee Branches to attend this meeting, but only two visitors came.

The Conference of Mountain Workers was in session at this time, so we were able to secure Miss Lindley and Mrs. Wade for our luncheon. Miss Lindley gave us a most inspiring talk and Mrs. Wade told of the box work which she has so well organized. Several of our Mountain Workers also made short talks. They were all invited to the luncheon, filling the room with loyal Auxiliary Women.

In October, in response to Bishop Maxon's request the East Tennessee Auxiliaries met him at Convocation in Cleveland. Ten members went from Knoxville, four from Chattanooga. Athens, Harriman and Cleveland were well represented.

In response to an appeal from Dr. Logan, all Branches present pledged themselves to assist his work by buying a much-needed encyclopedia for his school.

Bishop Maxon made a most stirring appeal for more interest in our own Tennessee missions, as well as in the oppor-tionment. As a result of his account of the needs of the mountain babies, two young members of St. John's Branch have organized a sewing club to supply layettes, and have already sent four complete ones to Mrs. Kilheffer. This is a voluntary work by young women who are doing their part in all regular Auxiliary work.

A new Branch has been established at Kingsport with fifteen members. Literature and U. T. O. boxes have been sent to them. By invitation of the Rev. Mr. Jahn I attended a reorganization meeting of the Epiphany Branch, which

is now St. James' Branch. The members accepted a suggestion that they should adopt the Epiphany Mission at Sherwood, in memory of their old name, and they have since sent a box of books and other articles to Sherwood. They will take their part in the allotment this year.

All the Branches have responded to every appeal for the boxes, the total report of value of boxes for 1923 is \$1,418.80, an advance over last year.

The interest in Study Classes and in all Mission Work has certainly increased, and the generous response to all my calls has made the work so pleasant, that I leave it with regret and with many thanks to the Diocesan officers, and to all the dear Auxiliary friends who have helped and supported me.

REPORT OF THE BISHOP BEATTY MEMORIAL.

At our Executive Board Meeting of the Diocesan Woman's Auxiliary in October, 1922, in addition to the usual work mapped out to be voted on at the Annual Meeting in January, 1923, our President, Mrs. Loaring Clark, presented the matter of a memorial to our late Bishop Coadjutor, the Rt. Rev. Troy Beatty, D. D. Several kinds of memorials were spoken of, when I suggested the raising of a Trust Fund, the interest from which should be devoted to the support of a student at one of our Church Schools, preferably Sewanee. This was adopted as the memorial that would be most fitting to one who had been so interested in Christian Education. Ten thousand dollars was decided upon as the amount, and Mrs. Clark, with the approval of the Bishop and the Bishop Coadjutor, appointed the undersigned Chairman of the Memorial Committee to work out a plan whereby the subject could be presented to the whole Church in the Diocese of Tennessee.

At the Diocesan Convention which met in Christ Church, Nashville, January, 1923, the subject was freely discussed at our annual meeting of the Auxiliary and very enthusiastically and unanimously adopted, several pledges being made by Parish Branches.

A resolution was drawn up by Dr. Loaring Clark and presented to the men of the Church in their Convention, which was approved by our two Bishops and by the Clerical and Lay Deputies present. Before the close of our meeting our loyal and honored Diocesan Treasurer, Mr. George M. Darrow, gave us, the women of the Auxiliary, great joy when he announced he had a special fund of over \$900 to contribute to the Beatty Memorial Scholarship Fund.

Thus auspiciously was begun, just a year ago the plan to honor the memory of one who had been active in the

missionary work of the Diocese and who laid down his life in the service of the Church.

In formulating the plans for securing the Fund two purposes were in view. First, to try to create a spirit of co-operation throughout the membership of the Church, so that the men, as well as the women of the Auxiliary, would lend their cordial support, even though it was the project of the Woman's Auxiliary, to be fostered and sponsored by that organization. Second, to endeavor not to let the matter drag along, but to secure the full amount within the year. To do this, committees of men and women were formed in every parish and mission, with an Auxiliary woman always as Chairman. Then were sent out circular letters explaining the whole plan, and packages of printed envelopes with blanks for names of Parish and individual contributors. May I state here with every package sent out, a prayer went with it asking the guidance of His Holy Spirit, inspiring all of us to unite in bringing the plan to a successful conclusion.

In February, 1923, I communicated with the Knights Templar of Tennessee through Mr. David Thompson of Nashville, asking the Commandery of which Bishop Beatty was Grand High Prelate at the time of his death, to join us in the Memorial. Word came back that the Knights Templar would give us \$1,000 when the women secured the other \$9,000. Later in the year Mr. Gifford of Memphis, husband of our Vice President of West Tennessee, presented the matter at the State meeting and secured the pledge of \$1,000. This promised gift meant much to us and heartened us mightily.

Mention must be made that gifts from the Parishes ranged from \$4 from a small mission, to \$2,132.50, this from St. Paul's, Chattanooga, which was raised in a four days' canvass of the Congregation.

This will stand out as a memorable meeting of the Woman's Auxiliary in Tennessee. Today is a red letter day in our history. We have not only met all of our pledges for the regular work, but we have by united effort attained the purpose we planned. We have more than \$10,000 to lay on His Altar and to be invested as a Trust Fund. We can with great fervor sing "Praise God From Whom All Blessings Flow."

In closing permit me to say it is always a precious privilege to testify of our love and regard for those whose memories we revere, and so it has been in this instance. It has given your Auxiliary Officers great happiness to have

such whole-hearted co-operation from the women in our Diocese, and through them from so many of the men. A feeling of greater solidarity exists among us today. I am sure for none of us could have accomplished this alone, but together it has been easy of accomplishment, and we all feel in having honored the memory of our late Coadjutor, we have honored ourselves.

PRESENTATION OF THE BISHOP BEATTY MEMORIAL

Wednesday, January 16, 1924.

A beautiful and impressive ceremony occurring at the opening service of the Ninety-second Diocesan Convention was that of placing on the Alms Basin the sum of more than \$10,000 given by the people of Tennessee in loving memory of the late Bishop Coadjutor, the Rt. Rev. Troy Beatty, D. D.

Mrs. Loaring Clark, Mrs. John Shortridge, Mrs. Otey Walker and Mrs. Chas. T. Wright were a committee who stood at the Chancel steps making the presentation and after the prayer of consecration by Bishop Maxon, Mrs. Clark read the following:
 To the Diocese of Tennessee:

The Rt. Rev. Thomas F. Gailor, S. T. D., Bishop;
 The Rt. Rev. James M. Maxon, D. D., Bishop Coadjutor; The Reverend Clergy; Delegates to the Ninety-second Convention; Officers and Delegates to Women's Organizations.

With profound thanks to Almighty God, it is our privilege to inform you that a Memorial to our late beloved Bishop Coadjutor, the Rt. Rev. Troy Beatty, D. D., has been

given by the Church people of this Diocese and others, and to present to the Diocese of Tennessee a sum of money exceeding \$10,000, to be known as "The Bishop Beatty Memorial Fund."

This Memorial Fund is to be invested as a Permanent Trust Fund, and the income used to educate a Theological Student, preferably at the University of The South.

One thousand dollars of this gift comes from the Grand Commandery of the State of Tennessee, with the request that there be placed on record its realization of the sterling worth of Bishop Beatty both as Knight Templar and as a leading Churchman; bearing in mind the fact that Tennessee Templars had been honored by his election as Grand Prelate of the Grand Encampment, which position he held with honor at the time of his death.

As Churchwomen who have been privileged to gather this gift, we ask, through resolutions passed unanimously at our sessions yesterday, that Grace Church, Memphis, of which Parish Bishop Beatty was Rector, be allowed to nominate to the Bishop, for appointment, the first holder of this Memorial Scholarship.

We praise God for the life and work of Bishop Beatty. "He rests from his labors but his works do follow him."

RESOLUTIONS

The Committee on Recommendations present the following resolutions:

First—To renew our co-operation and support to the Bishop and Bishop Coadjutor in all their wishes and suggestions.

Second—To carry out the wishes of our Bishop Coadjutor in helping to stir up interest in raising the apportionment, so that its quota will be met promptly. To use our influence in changing the dark counties to light counties as shown by his map. To aid in personal evangelism.

Third—To make our study perfect and concrete by using books especially prepared for us at headquarters, as recommended by our Educational Secretary.

Fourth—That the days for taking the United Thank Offering, spring and fall, be changed to the Sundays following the Feast of the Annunciation and St. Luke's days, respectively, for the year 1924; the Clergyman in each Parish being asked to preach a missionary sermon and the offering being taken while the congregation stands and sings "Holy Offerings, Rich and Rare."

Fifth—That the Auxiliary shall contribute \$300 to the Church Mission of Help, to extend the work of this organization in the Diocese.

Sixth—That the necessary amount be given Mrs. McKoin from the Extension Fund for stamps and stationery to be used in the correspondence of the Church Service League.

Seventh—That letters from officers be answered promptly; that reports to the Supply Secretary be sent not only to her, but to their respective Vice Presidents as well. In supplying boxes for the Mission Stations, that a greater number of garments of very serviceable material be considered, rather than the lighter weight material, as recommended by a Mission Worker.

Eighth—That a woman be appointed whose special duty shall be to suggest and plan days of quiet devotions and other methods of developing our spiritual life.

Ninth—That we ask the Convention to establish definitely the present status of the Bishop Quintard Memorial which was instituted by the Convention many years ago, and that a definite action be taken toward its completion, to which the Auxiliary pledges its aid.

Tenth—That the Supply Secretary be authorized to ask Mrs. Wade, National Supply Secretary, to substitute the needs of the DuBose Training School, as presented by Dr. Logan, for the allotment she is to assign the diocese of Tennessee for spring work.

**CONSTITUTION OF THE TENNESSEE BRANCH OF
THE WOMAN'S AUXILIARY TO THE
NATIONAL COUNCIL.**

ARTICLE I.—Name.

The name of this Association shall be the Tennessee Branch of the Woman's Auxiliary to the Presiding Bishop and Council of the Protestant Episcopal Church.

ARTICLE II.—Object.

The object of this Association shall be to carry out through the Diocese of Tennessee the three great aims of the Church, viz: Missions and Church Extension; Religious Education and Christian Social Service.

ARTICLE III.—Membership.

The Association shall be composed of those women who, being by Baptism members of the Church, are engaged in any department of Her work.

ARTICLE IV.—Officers.

The Officers of this Association shall be a President, three Vice Presidents (one for each Convocation), a Secretary, a Treasurer, an Educational Secretary, a Supply Secretary, a Secretary for Colored Work, a Secretary on Devotional Life, a Treasurer of the United Thank Offering, and a Secretary on Prayer-Partnership. They shall be elected annually and no officer shall serve longer than three years consecutively in any one office. These Officers shall form the Executive Committee of the Auxiliary.

ARTICLE V.—Parochial Branches.

A Branch of the Auxiliary may be organized in any Parish with the consent of the Rector of the Parish. Every Parochial Branch shall formally adopt this Constitution.

ARTICLE VI.—Duties of Diocesan Officers.

The duties of Diocesan President, Secretary and Treasurer shall be such as usually appertain to such offices.

ARTICLE VII.—Convocational Vice-Presidents

It shall be the duty of Convocational Vice-Presidents to stimulate the activity of all Parochial Branches of the Auxiliary within their respective Convocations; to form new Branches and distribute allotments for Box Work which they shall receive from the Supply Secretary. They shall make reports of the work accomplished in their Convocations at the Annual Meeting.

ARTICLE VIII.—Reports.

Each Parochial Branch shall make an annual report as soon after December 31 of each year as possible and not later than January 10 of the succeeding year. All financial reports must be closed on December 31.

ARTICLE IX.—Meetings.

There shall be one meeting of this Association each year, to convene about the same time as the Diocesan Convention. At all meetings of the Diocesan Association, each Parochial Branch shall have the right of representation by its President, or such a one as she shall designate, and one delegate for each twenty-five members reported to the Diocesan Officers and for whom Extension Fund Fees of at least 50 cents per capita have been paid.

ARTICLE X.—Plans of Work.

The Executive Committee shall devise modes and plans of work for the Association, and bring the same before the general meeting for its action thereon.

ARTICLE XI.—Organization and Rules
of Parochial Branches.

In any city, each Parochial Branch shall have its own officers and shall adopt such rules as to qualifications for membership, duties of officers, times and places of meeting, and other necessary rules, as it may see fit.

ARTICLE XII.

This Constitution may be amended at any annual meeting of the Diocesan Branch by vote of the majority, due notice of the proposed amendment having been given at least one month before the annual meeting to every Branch.
