PRESIDENT'S ADDRESS

Ladies:

Again we are gathered together in a united effort to carry the love of our Lord and His sacrifice to the unknown millions.

We can look back with joy and satisfaction to our last year's work and know that God's blessings have fallen bounteously upon us, and our efforts to spread His kingdom, despite our many weaknesses and shortcomings.

This has been a great and glorious year for we Auxiliary women, for God has found a way for us to prosper both spiritually and financially; notwithstanding that part of Texas which embraces the Diocese of Texas was visited by the most disastrous drought in many years.

Our Presiding Bishop says that we must "Pay, pray and perform." The Woman's Auxiliary changes that a little and Pray, Perform and then pay, but we always pay to the last cent.

This means, of course, that we have met every apportionment, and answered every call for help, and there have been many this year. None, however, has been more appealing and more pleasing than the sweaters sent to Nanana Alaska.

Following Bishop Quin's instructions we have marched valiently down each of the five great highways of our church work, carrying high the banner of our Lord. Striving each and every way to spread His Kingdom.

Our members have taught in the church schools, worked with the young people, cared for the sick, consoled the sorrowing, looked after the old and decrepid; in other words we have "prayed, performed and paid" all in His name and for His sake. Surely God has made His face to shine upon us, has shown us the way and blessed us in our efforts, so we are happy in a year well spent.

We have gained only two new branches this year but thanks to a saintly soul, known to the world as Mrs. Sartwell, Palacios, came back into the fold and says she is home to stay. The teachers in the colored school at Tyler have organized and I hope, will report here today.

Nearly every branch reports social service work done, likewise religious education has had both spiritual and financial growth in all branches. This is largely due to our very efficient

and willing Mrs. Thomas Rice, Educational Secretary. It is worth while to note that of all the study classes, Bible classes, group meetings, etc., that more branches report that the Every Woman Prayer Service was the most helpful.

We tried conscientiously and faithfully to aid the Bishop in the Church's program in the Diocese. We have the satisfaction of knowing that we did help. In many branches the members went further than the Bishop asked, and in one place I have in mind the members of the Woman's Auxiliary made themselves responsible for the quota, each member raising a certain amount. Let me add that they raised every dollar asked for.

Your President had the pleasure of meeting with eighteen Branches during the year. She averaged more than 150 letters per month. So she has not been without duties, but pleasant duties.

Our supply department is the wonder and the admiration of many Dioceses. The immense amount of work that you do, the willingness with which you serve and the liberality of your gifts make the orphans and missionaries happy and comfortable and the presidents of other dioceses wonder how you do it. We are most grateful to our Mrs. Sawyer for her most splendid work.

The precious privilege of giving back to God a small part of his gifts to us make the U. T. O. a most welcome and satisfying part of our work. I say to you frankly, ladies, that I think our Mrs. Catterall is a great blessing to our Diocese and I am sure I voice your sentiment when I extend to Mrs. Catterall our sincere gratitude for her untiring efforts with the United Thank Offering.

The Church Periodical Club, headed by our most indefatigable Miss Hester Mitchell, and aided and abetted by the ever willing-for-service Auxiliary Woman, has outgrown its short dresses and has put on a train and has arranged a programme of its own. I hope you all attended this meeting.

Our new Long Distance Secretary, Mrs. Alice Shutt has worked long and diligently this year that no isolated churchwoman in this Diocese should be without knowledge of the work of her church and an opportunity to make her United Thank Offering.

Mrs. Shutt writes them very wholesome interesting letters with the ever loving connection of the Church with her women.

The Font Roll has gone steadily forward under the able leadership of our own Mrs. Koehler, who decided to be separated from her first love, the Auxiliary. I wish we had more vitally interested women like her in this Diocese.

Auxiliary Day at Camp Allen was our big surprise and greatest joy during the summer months. I believe it was the hottest day of the year, but the weather man was no more hearty in his service than the hostess branches were in their welcome to the more than 150 ladies, representing 25 branches and several other States who gathered together that day. MINUTES OF THE TWENTY-FIFTH ANNUAL MEETING

The Annual Meeting of the Woman's Auxiliary of the Diocese of Texas was held in Trinity Parish, Galveston, in the parlors of the Y. W. C. A. on Tuesday, January the 26th, 1926. The meeting was preceded by a joint corporate communion of the Daughters of the King and the Woman's Auxiliary at 7:30 a. m., the Rev. Thomas Mabley and the Rev. DuBose Murphy, officiating. A brief address was made by the Rt. Rev. H. T. Moore, D.D., Bishop of the Diocese of Dallas. The offering was given to the Daughters of the King.

After the hymn "O Sion Haste" and opening prayers, Mrs. Rogers of Galveston delivered an address of welcome which was responded to by Mrs. J. E. Sheffield of Alvin. The President, Mrs. W. W. Turner of Webster, then took the chair and delivered an inspiring annual address.

The roll was called and twenty-two branches were present and eighteen absent. The reports made by the branches present were most encouraging.

Reports were made by the delegates to the Triennial. The first report was made by Mrs. T. J. Windham, her subject being "Missionaries and Schools." Mrs. Windham spoke of the devotion and consecration of our Missionaries and our responsibility in being ready and willing at

Mrs. F. M. Johnson of Eagle Lake made an interesting talk on "Outside Meets and High Lights" of the General Convention. She spoke of the spiritual inspiration that one felt at the United Thank Offering Service and of how wonderful Miss Lindley is both as an Executive and Spiritual leader. Especial mention was made by her of Miss Blacknall and her work in Alaska and of Miss Gertrude Heyward of St. Margaret's School, Tokio, and of Kuling School in the Diocese of Hankow, China, a school where the children of our Missionaries can receive an English education in China.

Mrs. Quin then made a report on "Resolutions and Pledges." Mrs. Quin spoke concerning the following resolutions which were passed at the General Convention:

Resolutions of Appreciation, Resolutions of Memorial for Bishop Tuttle and Miss Margaret Emery, a Resolution on Peace, a Resolution on Christian Unity, a Resolution on Cooperation with the Field Department, a Resolution on United Thank Offering, a Resolution on the Corporate Gift of \$100,000 to be made by the Women of the Church, a Resolution on the Spiritual Value of Prayer, a Resolution to attract Young People,

a Resolution to support Kuling School, a Resolution on the Message and miscellaneous resolutions.

Immediately after Mrs. Quin's talk Mrs. Catterall arose and offered the following resolution:

Since the delegates to the Triennial Meeting of the Woman's Auxiliary pledged our members to six rules, that have been fully explained by Mrs. Clinton S. Quin and beginning:

"We pledge the payment in full of all Church quotas" and since these rules or resolutions were sent as general information to the General Convention in New Orleans, and were the result of the Message of Dedication and offer of co-operation that were sent by the Executive Board of the Woman's Auxiliary to the National Council in October, 1924, the same being accepted and commended by the National Council and later ratified by the Auxiliary delegates in triennial meeting assembled in New Orleans in October, 1925. Therefore, Be it resolved that we, the members of the Woman's Auxiliary of the Diocese of Texas, desire to send a representative to the Diocesan Council, now in session, to declare our willingness to co-operate to the fullest extent of our ability with the Field Department of this Diocese in all future campaigns to secure the payment in full of all General Church quotas.

Mrs. Catterall made a motion that the Resolution be adopted by the Texas Branch. The motion was seconded and unanimously carried. The following Committee was appointed by the President to take the Resolution to the Diocesan Council, then in session from the annual meeting of the Woman's Auxiliary: Mrs. J. C. Tolman, Mrs. M. A. Wescott and Mrs. Proctor.

A talk was then made by Mrs. J. C. Tolman, president of the Woman's Auxiliary in the Seventh Province and member of the National Board, on "The Spiritual Side of the Triennial." Mrs. Tolman told of the Quiet Hour held in preparation for the United Thank Offering Service, of Miss Lindley's Noon-Day Meditations of the United Thank Offering Service, of the Day of Intercession and of the Closing Quiet Hour—wonderful occasions filled with inspiration and spiritual help, and dominated

throughout by the spirit of the message.

Talk was then made concerning the Minnie Taylor Memorial Fund by Mrs. D. C. de Maret of Bryan. Mrs. de Maret explained that the Minnie Taylor Memorial Fund of \$250 a year is to be used for the training of girls offering themselves for Church work. A motion was made by Mrs. W. P. H. McFadden of Beaumont that the Woman's Auxiliary of the Diocese of Texas pledge themselves to raise this Fund in memory of Miss Minnie Taylor. The motion was seconded by Mrs. Love of Cameron. Many beautiful expressions were made from the floor about Miss Minnie Taylor. The President announced that this Resolution would be voted upon under the head of New Business.

A very helpful and inspiring talk was made by the Rev. Mr. Lee of St. David's Church, Austin.

A report was made by Mrs. Tolman, Chairman of the Committee which carried the Resolution from the Woman's Auxiliary in annual meeting assembled to the Diocesan Council. Mrs. Tolman reported that the Resolution was received by the Diocesan Council with a rising vote of thanks.

The following committees were appointed:

The Committee on Resolutions—Mrs. Harris Masterson, Jr., Houston; Mrs. Gwynn of Eagle Lake, and Miss Janie Hawkins of Bay City.

The Tellers of Election: Mrs. Goodyear, Mrs. Hobson and Mrs. Tellepson, all of Houston.

Reports were then made by the Recording Secretary and the Treasurer, after which the Noon-Day Prayer for Missionaries all over the World was offered by the Rev. Mr. Lee.

The president announced the sale of handiwork from one of the Church's mountain institutions, The Appalachian School at Penland, N. C., the commission on sales to form a nucleus for a Triennial Delegate Fund.

Reports were then read by the Educational Secretary and the Long Distance Secretary, after which the meeting adjourned for luncheon.

The meeting was called to order promptly at 1:30 p. m. Miss Janie Hawkins of Bay City was appointed

Chairman of the "Win One For the Auxiliary" Campaign.

A report was read by the United Thank Offering Treasurer. A splendid report was made by Mrs. Cudliff from Lufkin on Auxiliary Day at Camp Allen.

A solo was rendered by Mrs. Lucian Minor of Galveston, which was greatly enjoyed.

The Minnie Taylor Memorial Resolution was adopted by the body with a rising vote.

Mrs. Bratton offered the following Resolution: Resolved, That it is the sense of this body that there should be a Convocational Meeting of the Woman's Auxiliary in each Convocation at least once a year and that the Vice President of each Convocation is hereby requested to call the Meeting and preside over the same. Mrs. Bratton made a motion that the Resolution be adopted. The motion was seconded by Mrs. Sawyer and passed.

A report was then made by Mrs. Tolman for Mrs. Lawrence on the Adult Summer Conference at Camp Allen.

The following ladies were elected delegates to the Provincial Synod: Mrs. W. W. Turner, Webster; Mrs. Geo. N. Yard, Galveston, and Mrs. W. P. H. McFadden, Beaumont. Alternates: Mrs. W. F. Warfield, Houston; Mrs. Alice Shutt, Houston, and Mrs. C. N. Humason, Lufkin.

Mrs. Turner and Mrs. Rice were elected as Representatives from the Woman's Auxiliary on the Church Service League Board.

The following report was made by the Nominating Committee: Mrs. Axford Hicks of Tyler, Vice President of the North East Convocation; Mrs. D. R. Peareson of Richmond, Vice President of the South West Convocation. Mrs. W. F. Warfield of Houston, Corresponding Secretary and Mrs. A. E. Schaeffer of Houston, Treasurer.

Mrs. Harris Masterson, Jr., of Houston made the following report for the Committee on Resolutions:

Resolved, That the Woman's Auxiliary of the Diocese of Texas in

Annual Council assembled place upon its minutes its appreciation of a devoted member, Grace Jaegger Kinsolving. That in her death the Auxiliary has lost one ever ready in spirit and indeed to further the work of this organization. That we recognize her genuineness and fineness expressed in her loyal support of the Missionary interests of the Church. That a message of love and sympathy be sent our Beloved Diocesan. That a copy of these Resolutions be sent to Bishop George H. Kinsolving and one to the Rev. Ovid Kinsolving.

Resolved, That a vote of thanks be tendered the good people of Galveston for their genuine hospitality and courtesy and their thoughtful plans for our comfort and happiness at this the Twenty-Fifth Annual Meeting of the Woman's Auxiliary.

Resolved, That a message be sent to Mrs. Desel expressing regret of her illness and of her inability to attend the Annual Meeting. That we offer a prayer for her complete recovery.

The Auxiliary had the great pleasure of having Bishop Quin with us at this time. Bishop Quin thanked the Auxiliary for the work accomplished during the past year and mentioned a number of places in the Diocese where he would like to have Auxiliary Branches formed.

It was moved and seconded that the amount of \$250.00 for the Minnie Taylor Memorial Fund be apportioned among the Auxiliary Branches by the Executive Committee. The motion was carried. Mrs. Alice Shutt pledged \$10.00 to the Minnie Taylor Memorial Fund.

It was moved and seconded that six hundred and fifty copies of the Year Book be printed this year. After discussion the motion was carried.

Mrs. Tolman said the closing prayer, asking God's blessing upon the work of the Woman's Auxiliary during the coming year. The meeting adjourned.

**THE ANNUAL REPORT OF THE RECORDING SECRETARY OF THE
TEXAS BRANCH OF THE WOMAN'S AUXILIARY
TO THE NATIONAL COUNCIL**

Madam President, and Members of the Woman's Auxiliary: It is a great privilege as well as a great pleasure to report on the meetings of your Executive Committee during the year 1925. The meetings have been well attended, full of interest and, under the leadership of our wonderful President, most helpful and inspiring to all present.

The February Meeting was held at Christ Church Parish House. At the earnest request of Bishop Quin, the Executive Committee unanimously decided to urged our Auxiliary Branches to do all possible to inform and educate the members of the Diocese concerning the Church's program. Upon the resignation of Mrs. H. P. Brown, of Austin, Mrs. F. M. Johnson, Jr., of Eagle Lake, was appointed Chairman of the "Bishop Tuttle Memorial Fund."

The March meeting was held at the residence of Mrs. Quin. Mrs. W. F. Warfield resigned as Long Distance Secretary and was elected Corresponding Secretary. Mrs. A. Shutt of Christ Church, Houston, was elected Long Distance Secretary; Mrs. J. C. Tolman, Provincial Secretary, gave an account of the National Board Meeting, from which she had just returned, in New York City, and also of a delightful visit to Miss Marie Turley at St. Faith's School.

The April meeting was held at Christ Church Parish House, Houston. Mrs. D. R. Peareson reported that the ladies of St. Thomas, Wharton, were ready to form an Auxiliary Branch. Splendid reports were made by Mrs. Turner of the Auxiliary work in Navasota and Bryan. She also reported the formation of a new Branch at St. John's Colored Mission, Tyler. It was decided at this meeting that we ask the Executive Board of the Diocese to set aside a day for the Woman's Auxiliary Conference at Camp Allen, Mrs. Turner suggesting that the Woman's Auxiliary have a picnic dinner on the grounds.

The May meeting was held at the home of Mrs. Warfield, the Corresponding Secretary. Mrs. Catterall requested that an assistant to the United Thank Offering Treasurer be appointed in each Convocation. It

was decided that the Vice President of each Convocation be asked to act as the assistants to Mrs. Catterall in the U. T. O. work. Mrs. Thos. Rice reported that the Executive Board had granted a day, Tuesday, July 14th, to the Woman's Auxiliary, at the Camp Allen Conference. The following Committee was appointed to plan the program for Camp Allen. Mrs. Bratton, Chairman, Mrs. Warfield, Mrs. Schaeffer and Mrs. Rice. A letter was read from Mrs. de Maret of Bryan, suggesting that the \$250 paid annually for the education of Miss Marie Turley be perpetuated as a memorial to Miss Minnie Taylor, the money to be used for the education of girls offering themselves for Church work. This suggestion was most favorably received by the Executive Committee.

The June meeting was held at the home of Mrs. Peareson, Richmond, Vice President of the Southwest Convocation. It was earnestly suggested by our United Thank Offering Treasurer, Mrs. Catterall, to give every woman in the Diocese an opportunity to contribute to the Fall Offering of the U. T. O., the final offering before the Triennial. A beautifully prepared letter by Mrs. Fred W. Catterall was gratefully accepted by the Executive Committee and Mrs. Catterall was asked by the Committee to mail a copy to every Branch in the Diocese and publish the same in the Texas Churchman. The Recording Secretary reported that Bishop Quin had expressed himself as being heartily in favor of having a Fund in memory of Miss Minnie Taylor to be used for the education of girls offering themselves for Church Work. The Committee accepted the Program for the Camp Allen Conference as prepared by the Program Committee.

There were no meetings of the Executive Committee held during the months of July and August.

The September meeting was held at the home of Mrs. T. J. Windham. The Executive Committee was unanimous in its opinion that Auxiliary Day at Camp Allen was a most inspiring and helpful day in the life of the Woman's Auxiliary and that the results would be far reaching in

our Auxiliary work. Much time was spent at this meeting in discussing the approaching Triennial and especially the United Thank Offering. It was decided that a letter be sent from the Executive Committee to each Auxiliary Branch in the Diocese stressing the great value and purpose of the United Thank Offering.

The October meeting was held at the home of Mrs. A. Shutt, the Long Distance Secretary. The greater part of the time at this meeting was spent in discussing the work among the isolated in the Diocese. Our Long Distance Secretary expressed herself as most anxious to care for all isolated members of our Diocese by giving them the opportunity to offer, to read our Church papers, and to be brought in close touch with the life of the Woman's Auxiliary. Prayers were said at this meeting for Bishop Kinsolving in the loss of his dear wife and the Corresponding Secretary reported that a telegram of sympathy had been sent from the Executive Committee to our beloved Bishop.

The November meeting was held at Christ Church Parish House, Houston. Encouraging reports were made by Mrs. Pearson at this meeting upon the new Branches at Wharton and Brenham. A very earnest talk was made by our President as to how we can better interest the young women of our Diocese in our Auxiliary work. Each member was asked by her to think and pray earnestly upon the matter, the subject to be further discussed at the next meeting. The following Nominating Committee was appointed:

Mrs. Goodyear, Clemens Memorial, Houston; Mrs. Hobson, Trinity, Houston; Mrs. Tellepsen, Church of the Redeemer, Houston.

The Officers to be elected are: Vice President of the North East Convocation, Vice President of the South West Convocation, Corresponding Secretary and Treasurer.

The December meeting was held at Christ Church Parish House, Houston. Our President again stressed the great importance of interesting the young women of the Diocese in the work of the Woman's Auxiliary. This matter was earnestly discussed. Many helpful suggestions were made and our President was asked to place this vital matter before the Auxiliary Council in Galveston.

The final meeting of the year was held in Eaton Hall, Trinity Church, Galveston, on January 5th, 1926. The greater part of the meeting was spent in arranging a program for the annual meeting of the Woman's Auxiliary to be held in Galveston on Monday, January 26, during the Diocesan Council.

REPORT OF THE EDUCATIONAL SECRETARY

To the President and Members of the Texas Branch of the Woman's Auxiliary:

When asked to assume the responsibilities of this office last year, it was with a deep sense of my lack of experience; but trusting to the generous offer of help from our dear retiring Secretary, the decision was made and the following report shows what your educational secretary has tried to do during 1925.

Eight meetings of the Executive Board have been attended, and two of the Diocesan Executive Department of Religious Education. Also the convocation held in May in Galveston.

Following the desire of the Woman's Auxiliary to aid and assist in every way possible our Bishops in carrying out the Church's program in the Diocese of Texas, copies of the program were sent to all branches so that all members might be thoroughly informed and also find out just where their share in the work for our Master would be most efficient.

A letter containing a call to Prayer was sent to all Branches asking them to hold an "Every Woman's Prayer Service" during the Lenten season. A suggested program was outlined in the letter. From letters received and from other sources of information it is gathered that much interest was manifested in this service. Leaflets, pageants, and some books have been sent out when requested and all letters received have been answered giving the desired information if possible.

Our Circulating Library has not been patronized to any extent this year, but a list of the books has been sent to the Texas Churchman for publication with the hope that it may reach the eyes of anyone not aware of its existence.

Reports from the recent questionnaire sent to all branches are on the

whole encouraging and show that for the most part branches have had some form of study class and that the text-book most generally used was "China's Real Revolution."

A letter approved of by the department of Religious Education and your Executive Board was sent out to all branches asking them for a contribution to the Adult Conference Fund. The response was good and amounted to eighty-seven dollars (\$87.00). A large and varied number of books, leaflets, etc., were secured for the Book Store at the Adult Conference. Owing to the inability of your Secretary to attend the conference your Executive Committee appointed Miss Marie Turley to take charge of the store. Your Secretary was instructed to write Mrs. L. M. Hogsett, a Religious Educational Specialist, asking her to favorably consider taking the Normal Training Class at the Adult Conference. Mrs. Hogsett kindly consented and a splendid class for leaders was conducted, the text book used being "That Freedom." The Committee on Adult Education created by the National Council is offering numerous courses for study classes for 1926, and the outstanding book is "That Freedom: A Study of Democracy in the Americas," by Dr. Arthur R. Gray. This is the course recommended for our Lenten study, and for collateral reading there is "The New World" by the same author. "Looking Ahead with Latin America" and "New Days in Latin America." Branches who have not studied "The Search for Peace" by Miss Laura F. Boyer will be well repaid by doing so.

Other courses recommended are: "Educational Opportunities of the Churchman," "A Grammar of Belief," "Our Bible," and "Christian Stewardship."

This report would not be complete

without a word for "The Spirit of Missions" and an expression of hope that it is in every Auxiliary Member's home. Every Camp Allenite will rejoice to know that plans are now being formulated for the Adult Conference so that it may be a banner year for the Camp; so don't go

back to your Parish or Mission without registering for the Adult Conference.

Asking your indulgence for the omissions of 1925, and begging your continued co-operation for 1926.

In December, I sent to each member a Church Calendar, a Prayer Leaflet, a leaflet I brought from New Orleans, a Christmas card and a letter. I also sent eight copies of The National Geographic Magazine, three copies Alaskan Churchman, The World and I, and sent every member's name to the Rev. Rhea at Beaumont for him to send The Texas Churchman to them direct.

I was able to put one member in touch with Mr. Stopford who supplied her with Sunday School lessons for her three children.

My heart was glad when I received

three good subscriptions to the United Thank Offering.

I had many hard luck stories from people whose cattle were killed because of the foot and mouth disease, others, whose crops were almost a failure because of the drouth. One member's case seemed very hard; she had bought a knitting machine and wool to knit stockings for a livelihood; and after having knit the stockings the firm went into bankruptcy and could not pay for her work.

But I had many pleasant happenings too: On Christmas eve my telephone rang and a strange voice told me that he was coming to thank me for my letters. So when he came I had a nice fire and a nice tea ready and I had a very pleasant two hours with him. His wife had had to be taken to a sanitarium and he wrote me in answer to my letter to her, so of course I answered his letter at once and that was what he came to thank me for. I found he was a compatriot of mine and of course I enjoyed it all the more.

I have thoroughly enjoyed the work I have undertaken and if I am spared for another year, I hope to do much better.

REPORT OF THE DIOCESAN TREASURER OF THE UNITED THANK OFFERING

My report for the year just ended is in your hands. Will you take it with you and let the women of your home church see what we have done through our little blue boxes.

The total for the year is \$3,580.34, which is a marked increase over any previous year. It was given by 47 parishes and missions. It would be interesting and helpful to know exactly the number of Blue Boxes in use, but I have never been able to get that information from all of our branches, and it would not include all who give to the U. T. O. Some give at the Corporate Communion only, and some send an occasional check.

You will notice that St. David's, Austin, is again the leader. There has been a noticeable increase from several parishes, large and small ones. And there are a good number of new contributors. They are Bastrop,

Brenham, St. Andrew's, Houston; Needville, Orange, Wharton, and St. John's Mission, Tyler. On the other hand, there are 5 missions on our list of contributors that sent nothing this year. I have made a list of towns where there are church-women who have no blue boxes. If you live near any of these towns or know any church-women living there, please act as a special committee and offer them some boxes, and send me their names. Anyway, if you can do nothing else, send me their names.

In the second column of my report you will see the amounts contributed during the three years, 1922-25, for the United Thank Offering that was presented in New Orleans, on Oct. 7, 1925. The total, \$8,703.29, represents an increase of more than 38% over our last U. T. O. The entire U. T. O. was \$912,841.30. Ten per cent of this will provide for our retired missionaries, the disabled ones, prevented by age or ill-health from serving longer in the mission field. It is a great satisfaction to us to think that we can provide for them to live in comfort.

Thirty thousand dollars will be used for two buildings, one in China and one in Japan. There are six young women in training, and two others offered themselves at our Triennial Service in New Orleans.

The remainder of the offering will maintain our United Thank Offering missionaries; 71 in the home field, 115 in the foreign field.

So much for the report, but before we take up the consideration of the new U. T. O., for which we shall work during the next three years, I shall consider one other point in retrospect. Many of you will remember that we hoped to take \$10,000 to New Orleans. If we can find the reason why we were not able to take that amount, it will help us to do better in the future. There were two reasons perhaps. On the first one, I can only speculate, but I believe you will agree with me that very probably those of us who have blue boxes did not remember them as often as we might have done. We

live in a continuous whirl, often rushing from one engagement to another, our minds occupied with many things. We often fail to notice the blessings that are freely given to us. A quiet hour, even a few moments for meditation would make such a difference! Let us keep our Blue Boxes where we can see them. They will remind us and we shall use them oftener.

But the especial reason why our offering was not as large as we had hoped it would be, was that we failed to convince a great proportion of our women that the United Thank Offering would be for them a privilege, a joy, and a means of growth in spiritual life. I need not tell you again that this offering in the Blue Boxes should come from all of our church women. The Auxiliary women know more about it, so it is their obligation to make it known. With the increased membership in the Auxiliary, we can make a still greater effort to tell our women of this offering and give out more and more Blue Boxes. Let us add to our slogan; To see that every church home has a Blue Box, to hold an offering that is given when the heart is thankful, and with a prayer.

There is just one more point. I must call your attention to the last paragraph on the card of resolutions. Despite the fact that we do not pledge or pay our full quotas, notwithstanding all the talk of re-adjustment, of better business methods, and of cutting down the number of missionaries, we retain this resolution; That to our united gifts shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to **give themselves**, or of their substance to the work of the Master in the Mission field.

That is also implied when we sing:
Give of thy sons to bear the message
glorious;

Give of thy wealth to speed them
on their way,
Pour out thy soul for them in prayer
victorious;

And all thou spendest Jesus will
repay.

CONSTITUTION OF THE WOMAN'S AUXILIARY, DIOCESE OF TEXAS

Article I—Name

The name of this Society shall be the Texas Branch of the Woman's Auxiliary to the National Council.

Article II—Object

The object of this Society is to serve The National Council in the work of the General Church, in the Department of Missions, Social Service and Religious Education.

Article III—Membership

The Church itself is the Missionary Society. Every baptized person is a member of this Society, therefore every baptized woman and child in this Diocese should be an active member of the Woman's Auxiliary.

Article IV—Officers

Section 1.—The Officers of the branch shall be a President, a Vice-President for each convocation, a Recording Secretary, a Corresponding Secretary, an Educational Secretary, a Supply Secretary, a Long Distance Secretary, a Treasurer and a United Thank Offering Custodian.

Section 2.—The officers shall constitute an Executive Committee to transact business of the branch when not in session.

Section 3.—A Committee of two shall be appointed by the Executive Committee to audit the Treasurer's account one week before the annual meeting.

Article V—Meetings

Section 1.—The annual meetings of the Texas Branch shall be held at the time and place of the Diocesan

Council, the exact time to be arranged by the Executive Committee.

Section 2.—The election of Diocesan Officers shall be held at the annual meeting by ballot. Each Parish Branch being entitled to one vote, unless the membership of said branch shall exceed twenty-five, in which case the branch shall be entitled to two votes. Each Diocesan Officer shall be entitled to a separate vote on all questions before the assembly.

Section 3.—A Committee on Nominations, consisting of three members, shall be appointed by the Diocesan President two months prior to the annual meeting.

Article VI—Amendments

This Constitution may be amended at any annual meeting by a two-thirds vote of delegates present; provided the amendment or amendments be submitted to each branch two months before the annual meeting.

BY-LAWS

Article I.—Duties of Officers

Section 1.—It shall be the duty of the President to preside at all meetings and to perform all other duties appertaining to the office.

Section 2.—It shall be the duty of the Vice-Presidents of the several convocations to perform duties of President in her absence, or at the request of the President, and to cooperate with the President in all Diocesan work, and to have general supervision of the work, each in her own convocation.

Section 3.—The Recording Secretary shall keep a record of proceed-

ings of all meetings, and prepare an annual report, and in the absence of the President and Vice-President shall call the meeting to order and act until a chairman is elected.

Section 4.—The Corresponding Secretary shall give notice of all meetings both of the Association and of the Executive Committee, and shall conduct a general supervision of the correspondence of the Society. She shall keep a record of the Parish Branches and the Officers.

Section 5.—It shall be the duty of the Educational Secretary to have a general supervision of the educational work of the Auxiliary in the Diocese; to secure a leader of Mission Study in each Parish Branch.

Section 6.—The Supply Secretary shall assign list of boxes obtained from Church Missions House to the various parishes and missions; shall have charge of preparation of any Diocesan box and shall present the combined report of all parish box work.

Section 7.—The Treasurer shall take charge of all moneys, except United Thank Offerings, disburse same according to instructions, and shall give annual report at the regular meeting. She shall also act as Chairman on Credentials.

Section 8.—The United Thank Offering Custodian shall furnish the Parish Branches with United Thank Offering boxes, and leaflets, and bring to their attention in other ways the purpose of United Thank Offering. She shall keep a list of contributors and make a semi-annual collection, and put these amounts out at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready, together with its accumulated interest, for presentation at the Triennial Session of the Woman's Auxiliary.

Section 9.—The Long Distance Secretary shall secure the names of Church women within the Diocese, who are not affiliated with any parish or missions, and endeavor to relate them through prayer and service to the work of the Woman's Auxiliary.

Section 10.—The Executive Committee shall have power to fill vacancies in its own body between regular elections.

Section 11.—Each Diocesan Officer shall make a report of her work at the annual meeting.

Article II—Dues

Section 1.—Operating expenses of this organization shall be met by an annual appropriation from each Parish Branch, the amount assessed to be at the rate of 25 cents per member. This appropriation shall be known as the Contingent Fund.

Section 2.—Each Parish Branch shall make an annual voluntary offering for an Educational Fund.

Article III—Meetings

The Executive Committee shall meet at least quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President, or by written request of two members of the Committee.

Article IV—Election of Officers

Section 1.—The Election of Officers to be held at the annual meeting by ballot, a majority of votes cast being necessary for the election to office.

Section 2.—The Committee on Nomination shall send out blanks to each Diocesan Officer and Parish Branch two months prior to the annual meeting, asking for nominations for officers to be elected for the ensuing year; each Convocation nominating its own vice-president in regular order, which ballot must be returned one month prior to the annual meeting.

Section 3.—The Committee on Nomination shall prepare a ballot containing names of two candidates for each office receiving the highest number of votes. This ballot shall be sent to each Diocesan Officer and each Parish Branch at least two weeks before the annual election, with instructions to place an "X" opposite the name of candidate for each office, or substitute any name desired. Said ballot shall be cast by the delegate of the Branch or the Chairman of the Nominating Committee. The result of each election shall be announced at the close of the meeting.

Section 4.—Term of office shall be for three years, officers to be elected in the following groups: (1) Presi-

dent, Long Distance Secretary, Recording Secretary, Educational Secretary; (2) the Vice-President of the N. E. and S. W. Convocations, Corresponding Secretary and Treasurer; (3) Vice-Presidents of the N. W. and S. E. Convocations, Supply Secretary and United Thank Offering Custodian.

Article V—Quorum

One-fourth of the members having a right to vote shall constitute a quorum at the annual meeting. Five members shall constitute a quorum at the meeting of Executive Committee.

Article VI—Elections

Section 1.—The election of Parish Officers shall be held at the meeting preceding the annual meeting and the Corresponding Secretary shall be notified at once of the names and addresses of the new officers for insertion in the year book.

Section 2.—Each Parish Branch

shall elect delegates for representation at the annual meeting.

Section 3.—At each annual meeting three delegates and three alternates to the meeting of the Provincial Synod shall be elected. In case the elected delegates and alternates are unable to attend, the Executive Committee, with the approval of the Bishop, shall appoint women to act in their stead.

Section 4.—At the annual meeting preceding the Triennial, five delegates and five alternates shall be elected. In case the elected delegates and alternates are unable to attend, the Executive Committee, with the approval of the Bishop, shall appoint women to act in their stead. These elections shall be by ballot.

Article VII—Amendments

These by-laws may be amended or suspended by a two-thirds vote at an annual meeting, provided notice is given of the proposed amendment or amendments at a previous meeting of the Executive Committee.
