

## PRESIDENT'S ADDRESS

### LADIES:

It is indeed a blessing to be able to meet here with you Hand Maidens of the Bishop and receive from you the reports of your year's work. You are always an inspiration to me and I am most grateful to Our Heavenly Father for so splendid a body of women gathered here under the banner of Our Lord.

This has been a year of hard work, pleasure and problems, both great and small, for you and for me, but by the help of our dear Lord we have solved them all and have come to this meeting with every pledge met, every promise fulfilled. Glad, O so glad, we are here and glad, O so glad for the many things accomplished last year and radiantly happy because of God's goodness to us, in giving us the opportunity of prayer, service and gifts.

This has been a great big year for the Auxiliary for since we have been made the Woman's Auxiliary to the National Council, our scope of work has been extended into the five fields and along many lines and your President has been busy trying to keep all lines straight and growing. Thanks to your ever loyal support and willing service she has succeeded beyond her hopes. Because of your efforts along all lines we have lifted high the banner of our Lord and carried it with unfaltering steps to the hill top where all Church women might view our efforts and the results and gain inspiration and desire for like service. Nearly all branches have grown in numbers, and all in works and grace—all have done their full part to plant the banner of Christ so firmly to the forefront that all might see and know the joys of service.

The reports of the Branches are a wonder within themselves and have made your Executive Committee very happy. I told you just now that all pledges had been paid and all promises fulfilled, but I didn't tell you of the many, many specials this Diocese has had. There was A. & M. College Fund for a place of worship, the Fund for a clergy to attend the Rural Conference, The Minnie Taylor Memorial Fund, which has made it possible to assist two girls, one

white and one colored, in getting an education.

Then how happy we were to get the opportunity to help Bishop Rowe with his forty little orphans; and those preserves and pickles that went forth so willingly to the Little House of Fellowship at Canyon where that consecrated little lady, Mrs. Andrews, is gathering together the girls and giving them the guidance they so much need. Do you know that every day in the Little House of Fellowship there is a prayer that God will bless and prosper the Women of the Auxiliary in the Diocese of Texas? Then, too, your Executive Committee, by its free will offering at each meeting has been able to help Bishop Quinn with his Divinity Students—In all of these good deeds you have had your part and it has been a cheerful, willing part that makes work all the more acceptable in the sight of God.

Every single call, from the four winds of the earth has been answered, money, food, clothing, books, fruit and flowers have gone forth from the hands of the Bishop's Hand Maidens, gladly, willingly, have we held up the hands of our Bishop, for we have done everything he has asked us to do. Recalling what our Mrs. Swift said last year—I am so glad he asks us, aren't you? And I sincerely hope that he will never hesitate to ask the Woman's Auxiliary for any service or gifts or prayer.

You, as a Diocesan Branch, should be congratulated upon the department heads—Mrs. Rice shows us the way, and it is a good way; Mrs. Sawyer provides work for willing hands, and does, like Mrs. Rice, a great deal of detail work. Mrs. Schaeffer keeps the record straight, writes myriads of figures every year. Have you ever had the pleasure of reading one of your Long Distance Secretary's letters to the isolated church woman? Then you have missed a treat, they are such sweet, interesting, churchly letters, that I am sure the heart of every recipient is made glad. Dear Mrs. Koehler worked faithfully to establish the Little Helpers; Mrs. T. W. Davidson has worked continuously with the Corporate Gift—The spiritual touch she gives her work makes it most appealing to us

all. This is the last year on the Corporate Gift and let us not be lacking when the Triennial rolls around. Your Recording Secretary, Mrs. Bratton, and your Corresponding Secretary, Mrs. Warfield, have been most efficient, and faithful.

How about the "Win One Woman for the Auxiliary?" Have you given Miss Hawkins the genuine help that she so richly deserves? Do you know that the manner in which this young lady has handled this department has brought praise from the four quarters of the United States with requests to know how it is done? You, young women, rally to her assistance, and you older women, hold the fort until the young girl gets there. What about the Church Periodical Club? Are you doing all that Miss Mitchell asks you? If not, I hope you will the coming year. She certainly deserves your best effort.

Now just a word about your most humble president. She has gone up and down the Diocese, traveling hundreds of miles, making dozens of talks, and praying thousands of times for the growth of the Auxiliary. It has been a work of pure joy for at every place I have found such splendid, consecrated women, always ready and always willing. Some have troubles and some have joys, but they are doing the best they can. There are many branches where every woman in the church is an active member of the Auxiliary. God grant that the time is not far distant when this will be the case in every parish and mission in the Diocese. I want every woman here to take this message back to her Branch; let each and every one of us pray each day this year that God will give all of our Church women the vision of the whole church and a keen desire for service and pray. All they need is an eye-opening vision and it is coming, and when it does there will be such an awakening in the church work that all the world will stand up and marvel at the spirit that pervades the Episcopal Church. I have

had the opportunity and precious, blessed privilege of meeting with 30 branches this year, and I know in my heart that our spiritual growth has been great, that the Woman's Auxiliary now has a more definite place in the heart of the Church women than ever before. Let's not go back, let's go on until we can proclaim to the world—we are one, in love, in service and in prayer.

Now let me thank each of you for your staunch, loyal support of our cause and beg you to redouble your efforts the coming year for the coming of Christ's Kingdom.

#### **Recommendations:**

That all four vice presidents hold their convocational meetings not later than November the 1st of each year, with the Bishop's Convocational meeting, if possible. That full reports of these meetings be made at our yearly meetings.

Let each and everyone of us rededicate ourselves to the work. Let's put more of our individual selves into the work because it is the individual effort, the individual service that counts.

Let us continue our help towards the Rural work for there is no more needy field of labor within our reach.

Offer yourselves and your branch as a whole for service in your Parish or Mission and stand firmly behind your Rector all the time.

Let us offer the Diocesan Branch, separately and as a whole, to our Bishop. Let him know we are ever ready, anxious and willing to serve him in any way possible.

That ways and means be found to enlighten our church people as to the work of the Woman's Auxiliary. A committee recently appointed by the Presiding Bishop reported back—"We haven't words at our command to express our deep appreciation of the splendid work done by the Woman's Auxiliary"—and still there are clergymen, laymen and women in this Church who do not know anything about the work of the Woman's Auxiliary.

#### **MINUTES OF THE TWENTY-SECOND ANNUAL MEETING OF THE WOMAN'S AUXILIARY, DIOCESE OF TEXAS**

The Twenty-Seventh Annual Meeting of the Woman's Auxiliary of the Diocese of Texas was held in St. David's Parish House, Austin, on

Monday, January the 16th, 1928.

The Meeting was preceded by a joint corporate Communion of the Daughters of the King and the Wom-

an's Auxiliary at 7:30 a. m. at St. David's Church, the Rev. C. A. Ross, and the Rev. Frank Rhea, celebrants. The offering was given to the Daughters of the King.

After the singing of the hymn, "O Zion Haste," and opening prayers led by the President, Mrs. Gilbert, of St. David's, Austin, delivered a few well chosen words of cordial welcome. The response was made by the President of the Woman's Auxiliary, Mrs. W. W. Turner of Webster.

The Memorial Service was held at which the names of those members of the Auxiliary who had died during the past year were read and a prayer said in their behalf. After this our President, Mrs. Turner, gave a beautiful annual address. The address and the recommendations made by her for the coming year's work will be printed in full in the Year Book.

The roll was called and thirty-five Branches were present and eight absent. There were no reports read but each delegate was asked to tell of the outstanding work done by her respective branch during the year's work. Some very helpful suggestions concerning Auxiliary Work were made in this way.

A splendid report was made by Mrs. Rice, the educational secretary. Mrs. Rice urged as many as possible in the Diocese to attend Miss Boyer's Institute to be held at Christ Church, Houston, on January the 23rd and 24th. She announced that the book for Lenten Study this year would be "The Church Awake" by Dr. Sturgis. Another book recommended by her was "Faith and Order" by Miss Laura Boyer and the regular use by all Auxiliary Members of "The Spirit of Missions."

A splendid report was made by Mrs. Davidson, chairman of the Corporate Gift Fund. Mrs. Davidson emphasized the three principles stressed by Our Saviour, the supreme value of the individual, the principle of brotherhood and the principle of service. She urged that the Branches study the needs of the six objects that they have undertaken to help in the Corporate Gift.

Mrs. J. C. Tolman, president of the Province of the Southwest and our representative on the National

Board, made a most helpful and inspiring talk. She told of the different members that are on the National Board and how a National Board Meeting is conducted.

It was our great privilege and pleasure to have our dear Bishop Kinsolving with us at this time. He admonished us to be loyal, faithful, and true in our service as Auxiliary Women. He urged us to fight the good fight, to keep the faith rejoicing, to cultivate the spirit of growing old gracefully and to have an optimistic outlook on life.

A talk on "The Devotional Life" of the Woman's Auxiliary was made by Mrs. Bratton, the recording secretary, who also led the noonday prayers for Missions.

A beautiful inspirational talk was made by Mrs. Franklin of St. David's, Austin.

A report was made by Mrs. de Maret, chairman of the Minnie Taylor Memorial Fund. Mrs. de Maret reported that we had helped with the education of Myra Reese at Columbia Institute, and that we had also helped a colored girl, Vera Lang, a student of St. Phillip's School, San Antonio. A request was read from Mr. Rhea, asking that we consider the name of Miss Vernon Lauden, a communicant of St. Mark's Parish for appointment to the Minnie Taylor Memorial Scholarship. After discussion the motion was made and carried that we give Bishop Quinn the balance on hand in the treasury of \$164 for the education of Myra Reese and that the full amount of the fund for 1928 be given for the education and training of Miss Vernon Lauden of Beaumont.

The following Committees were appointed:

The Committee on Resolutions—Mrs. Ruth Taylor, Houston; Mrs. T. L. Tosh, Beaumont; Mrs. J. P. Love, Cameron.

The Tellers of Election—Mrs. J. B. Dobbins, Mrs. Ellis and Mrs. Carlisle, all of Houston.

A most interesting report was made by Mrs. Quin of the Provincial Meeting held in San Antonio.

A report was made by Mrs. Caterall, the United Thank Offering Treasurer after which a most inspir-

ing talk was made on the meaning and purpose of the United Thank Offering by Mrs. Bremond of St. David's, Austin.

A most encouraging report was made by Miss Mitchell, chairman of the Church Periodical Club Work.

Mr. Engle from Bay City addressed the Council on the importance of Rural Work and thanked the Auxiliary for sending a delegate to the Conference on Rural Work at Madison, Wisconsin, last year. He asked, if possible, that we might send two delegates this year, one man and one woman. A motion was made to send two delegates to the Rural Conference and to pro-rate the cost of \$200 among the Branches, needed for that purpose. The motion was unanimously carried.

A report was then made on the A. & M. College work by Mrs. Noyes Smith, of Austin, chairman. An appeal for this work was also made by Mrs. Daup. The greatest interest was manifested in this matter by the Council. The motion was made and carried, after much discussion, that we give \$500 again this year to the A. & M. College Fund, this money to be pledged to the building of the College Chapel. It was decided that this amount of \$500 be pro-rated among the branches.

Mr. Bratton came on the Council floor and thanked the Auxiliary for the work they had done for the Colored Institute at Tyler, Texas. A small balance is still needed for this work, which Mrs. Turner assured Mr. Bratton would be paid.

The Auxiliary had the great pleasure of having with us at this time, Bishop Quin. Bishop Quin thanked the Auxiliary for the work accomplished during the past year. He spoke particularly of the Conference at Winslow, Arkansas, and asked the Auxiliary to lend their efforts towards its support.

Mrs. Turner announced that she would ask for a special offering for Miss Coral Clark, our own missionary from China, who has recently had an operation on her eyes, which was not successful. The Secretary was instructed to send a night letter to Miss Clark expressing the loving interest and sympathy of the Woman's Auxiliary in Council assembled.

The following report was made by the Nominating Committee: Mrs. W. W. Turner, President; Mrs. W. D. Bratton, Recording Secretary; Mrs. Thomas Rice, Educational Secretary; Mrs. Alice Shutt, Long Distance Secretary.

Mrs. Taylor of Christ Church, Houston, made the following report for the Committee on Resolutions:

Because of our dear Bishop Kin-solving's honoring us with his beloved presence, we wish to convey to him our resolution of thanks, not only for the privilege of being in his home city as its guests, but also for the most wonderful opportunity of hearing his dear voice again, with all its love and kindness and most especially for his beautiful outlook and optimism on life.

Be it resolved, therefore, that we send the Bishop a personal letter and that this resolution be drafted into our minutes.

Having so thoroughly enjoyed and greatly appreciated the gracious and generous hospitality of our hosts, and as a meager acknowledgement of the courtesies extended through St. David's and All Saints' Churches, be it resolved that the Texas Branch of the Woman's Auxiliary extends heartiest thanks to the Rectors, organizations and individuals who have contributed so largely to this happy, healthful meeting in our Capital City, Austin.

Inasmuch as Our Heavenly Father has seen fit to call from our midst into His Heavenly abode these dear women of the Auxiliary, be it resolved that the Woman's Auxiliary, through this Committee on Resolutions, wishes to express its deep sorrow at their passing but in its sorrow remembering that the Master has said unto each "Enter into rest, thou good and faithful servant." May their good work on earth reach its fruition in a dwelling place above. And also be it resolved that this resolution be printed into the minutes of this Meeting and also sent individually to each Auxiliary of a deceased member.

## REPORT OF THE DIOCESAN EXECUTIVE COMMITTEE OF THE WOMAN'S AUXILIARY, DIOCESE OF TEXAS, FOR YEAR 1927.

Madam President and Members of the Woman's Auxiliary:

The meetings of the Executive Committee of the Woman's Auxiliary during the year 1927 have been well attended and we feel that we have accomplished much for the work of the Master in our part of the vineyard. All the meetings during the year were held at Christ Church Parish House, Houston.

At the February meeting there were ten members present. At this meeting the importance of "The Message" was fully discussed and the Executive Committee decided to do everything in their power to help our Branches to realize the spiritual value of the Message and their responsibility of standing behind the quota for General Missions assigned to their parishes. Mrs. Turner said that she would prepare a letter to be sent to the Branches bringing this important matter to their attention. Mrs. Tolman spoke of the two Provincial pledges, one for the Little House of Fellowship in Canyon City, Texas, and the other for work at Farmington, New Mexico.

At the March meeting there were nine members present. The Devotional was led by Mrs. Warfield. Miss Mitchell, chairman of the Church Periodical Club work asked if the Auxiliary would help her in the Rural Work in the Diocese by placing books and the Spirit of Missions in the country homes. This request was favorably received by the Executive Committee. Mrs. Sawyer, the Supply Secretary, announced that the Lenten work would be for Miss Field at Bat Cave, North Carolina. A letter of congratulation was sent from the Executive Committee to the Rev. Dargan Butt upon the occasion of his ordination to the Priesthood. Mrs. Tolman told of her Crusade work at A. and M. College, and also of her

visit to The Little House of Fellowship. The Executive Committee voted that \$5.00 should be given to Mrs. Shutt, Long Distance Secretary, for literature to be distributed among the isolated of the Diocese. Mrs. Catterall, United Thank Offering Treasurer, announced that Ascension Day, May 26th, would be the day for the United Thank Offering service throughout the Diocese. She also said that our prayer partners for 1927 would be Deaconess Dorsey of California and Miss Hazel Gosline of St. Hilda's School, Wuchang, China. Mrs. Daup was present at the meeting and told of the work at A. & M. College.

There were ten members present at the April meeting. The devotional was led by Mrs. Shutt. Mrs. Pearson, chairman of the Southeast Convocation, reported that Taylor was ready to organize a branch of the Woman's Auxiliary. Mrs. Manton from Taylor was present with us at this meeting and Mrs. Turner explained to her as fully as possible the different phases of the Auxiliary work. Mrs. Schaeffer reported that she had sent out eight hundred copies of the Year Book. Mrs. Schaeffer was thanked for the splendid work done by her in getting out the Year Book. Miss Mitchell made an appeal for a library for the colored children at St. John's Mission, Tyler, Texas. Mrs. Tolman told of the Provincial Synod to be held in San Antonio in October, and said that Miss Boyer would be present at the meeting. It was decided to write Miss Boyer at once and ask her to come to Houston for an Educational Conference, if possible. It was decided at this meeting to ask the Branches to send jars of preserves and pickles to Mrs. Andrews for The Little House of Fellowship.

At the May meeting there were six members present. The Devotional

was led by Mrs. Turner. The treasurer was authorized by the Committee to send \$100 on the Provincial Pledge. Mrs. Shutt reported that she had sent more than two hundred pieces of literature to the isolated members of the Diocese during Lent. Mrs. Catterall told of her visit to the Church Missions House and Miss Lindley. She reported that she was having a United Thank Offering Poster made, a copy of which would be sent to each United Thank Offering Custodian in the Diocese. A request was received from the Rev. Mr. Bratton, chairman of the Department of Missions and Church Extension that the Auxiliary assist the colored mission at Tyler. It was decided to ask each branch to make a donation to this work.

There were no meetings of the Executive Committee during the months of June, July and August.

There were six members present at the September meeting. It was decided at this meeting to take \$75 from the Minnie Taylor Memorial Fund to help Vera Lang, a colored girl from Galveston, who was most anxious to finish at St. Philip's School in San Antonio. Mrs. Turner reported that she had sent out a letter to each Branch asking that money be sent to Bishop Rowe's orphans.

At the October meeting of the Executive Committee there were seven members present. Mrs. Shutt reported that she had sent out ten Blue Boxes to isolated members of the Diocese. The members of the Executive Committee were invited to attend the luncheon given to Miss Boyer by the Woman's Auxiliary of Trinity Church, Galveston.

The members of the Committee were also invited to attend the Interdenominational School of Missions to be held in Houston. Mrs. Turner gave a most interesting account of her visit to Austin, Brenham, Hempstead, Taylor and Georgetown.

There were six members present at the November meeting. The treasurer was instructed to send \$130

from the Minnie Taylor Memorial Fund to Bishop Quin for the education of Myra Reese. Mrs. Tolman reported that she had recently conducted a three day conference on Auxiliary work at Beaumont. Messages of sympathy were sent from the Executive Committee to Dr. Sears and Mrs. McFaddin. Mrs. Quin reported that she had given out Blue Boxes to the women of the colored mission in Houston. The following ladies were appointed by the president to serve on the Nominating Committee: Mrs. Dobbins of Trinity Church, Mrs. Ellis of St. Andrews and Mrs. Carlisle of Eastwood. It was announced that the meeting of the Southeast Convocation would be held at Wharton on December 7th. Mrs. Turner reported two new Branches of the Auxiliary at Brenham and Gulf. A letter was read from Mr. Lee concerning the Auxiliary Council to be held at Austin. A delightful report was made by Mrs. Warfield of the Provincial Synod Meeting in San Antonio.

At the December meeting there were seven members present. The greater part of this meeting was given up to arranging and planning the program for the Auxiliary Council to be held in St. David's Parish, Austin, January 16th. Plans were also carefully made for Miss Boyer's Institute to be held at Christ Church, Houston, January the 23rd and 24th. Much enthusiasm was shown about Miss Boyer's visit and it was decided that the Executive Committee would do all in its power to make the Institute a success in our Diocese.

The Executive Committee earnestly asks God's blessing upon the work of the Woman's Auxiliary during the coming year. Leaving those things which are behind, may we press on, with renewed consecration and vigor, with greater hope and vision to the prize of the high calling which is in Christ Jesus.

#### REPORT OF THE EDUCATIONAL SECRETARY

To The President and Members of

Auxiliary to The National Council:

Seven meetings of the Executive Committee have been attended, and three of the Diocesan Department of

### Religious Education.

Attended the Annual Meeting of the Woman's Auxiliary held in Houston, and had the textbook "Beyond City Limits" for sale as well as a number of other books and leaflets.

This sale of books was continued on Church Service League Day, and most of the books were sold.

A letter was sent to all of the branches asking for a continuance of their financial support to the Camp Allen Adult Conference Fund, and urging them to send some members to the Conference.

Plans were made to have the usual Book Shelf at Camp Allen, and a large number of books were ordered, but of course these orders were all cancelled owing to the postponement of the Conference.

In order to assist with the carrying out of the bi-monthly meetings of our branches, a good many copies of such information as could be gathered on the subjects in the book of programmes were typed and sent out when required.

Judging from the requests for information and suggestions asked for, one might infer that this new venture was helpful to the branches. In May a letter was sent to all branches with a list of the books suggested for collateral reading for Dr. Sturgis' new book, "A Church Awake" and also telling them of some new publications to come out in the fall. With the approval of the Executive Com-

mittee a book of suggested programmes for 1928 has been prepared and copies sent to each Branch.

The textbook that will be most generally used for the Lenten Study class is "A Church Awake," by William C. Sturgis, P.H.D. This book is intended for a follow up to the Crusade.

Miss Laura F. Boyer has prepared "Suggestions for Leaders" which will be found very helpful to those conducting a class.

Every Auxiliary woman will find Miss Boyer's new publication "Faith and Works" full of exceedingly valuable information, and the Bible class teacher will find the leaflet, "A Discussion Course on the Bible" to be very useful to the Bible student.

The adult Division recommends many books (some new, some old) for our study and reading in Bulletin No. 58, and the Auxiliary Woman's old standby, "The Spirit of Missions" in the November number has a revised list of books and leaflets. All letters received in 1927 were answered, and books or leaflets sent out when requested.

Thanking all for their co-operation in 1927, and praying that God may put into all of our hearts a greater desire to serve Him, and follow with humility the example of our Saviour.

The Woman's Auxiliary to the National Council pledged at the New Orleans Triennial, 1925, to raise \$100,000.00 in the next three years. Each Diocese has its quota.

The pledge for the Diocese of Texas is \$500.00.

More than two-thirds of our time has passed. We now have only six months more in which to round out our obligation.

Our National Officials are urging every Diocese to pay in its apportionment, for this, their last Corporate Gift year, before the first of June.

The entire Gift should reach Headquarters before Fall, so that the National report can be prepared for the General Council which meets next October.

In 1926 we fell short \$34.50 in the payment of our annual dues, but that \$34.50 plus the \$166.66 for 1927 has been paid up and a small balance is still in the Corporate Gift treasury.

## CONSTITUTION OF THE WOMAN'S AUXILIARY, DIOCESE OF TEXAS

### Article I—Name

The name of this Society shall be the Texas Branch of the Woman's Auxiliary to the National Council.

### Article II—Object

The object of this Society is to serve The National Council in the work of the General Church, in the Department of Missions, Social Service and Religious Education.

### Article III—Membership

The Church itself is the Missionary Society. Every baptized person is a member of this Society, therefore every baptized woman and child in this Diocese should be an active member of the Woman's Auxiliary.

### Article IV—Officers

Section 1.—The Officers of the branch shall be a President, a Vice-President for each convocation, a Recording Secretary, a Corresponding Secretary, an Educational Secretary, a Supply Secretary, a Long Distance Secretary, a Treasurer and a United Thank Offering Custodian.

Section 2.—The officers shall constitute an Executive Committee to transact business of the branch when not in session.

Section 3.—A Committee of two shall be appointed by the Executive Committee to audit the Treasurer's account one week before the annual meeting.

### Article V—Meetings

Section 1.—The annual meetings of the Texas Branch shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Executive Committee.

Section 2.—The election of Diocesan Officers shall be held at the annual meeting by ballot. Each Parish Branch being entitled to one vote, unless the membership of said branch shall exceed twenty-five, in which case the branch shall be entitled to two votes. Each Diocesan Officer shall be entitled to a separate vote on all questions before the assembly.

Section 3.—A Committee on Nominations, consisting of three members, shall be appointed by the Diocesan President two months prior to the annual meeting.

### Article VI—Amendments

This Constitution may be amended at any annual meeting by a two-thirds vote of delegates present; provided the amendment or amendments be submitted to each branch two months before the annual meeting.

### BY-LAWS

#### Article I.—Duties of Officers

Section 1.—It shall be the duty of the President to preside at all meetings and to perform all other duties appertaining to the office.

Section 2.—It shall be the duty of the Vice-Presidents of the several convocations to perform duties of President in her absence, or at the request of the President, and to cooperate with the President in all Diocesan work, and to have general supervision of the work, each in her own convocation.

Section 3.—The Recording Secretary shall keep a record of proceedings of all meetings, and prepare an annual report, and in the absence of the President and Vice-President shall call the meeting to order and act until a chairman is elected.

Section 4.—The Corresponding Secretary shall give notice of all meetings both of the Association and of the Executive Committee and shall conduct a general supervision of the correspondence of the Society. She shall keep a record of the Parish Branches and the Officers.

Section 5.—It shall be the duty of the Educational Secretary to have a general supervision of the educational work of the Auxiliary in the Diocese; to secure a leader of Mission Study in each Parish Branch.

Section 6.—The Supply Secretary shall assign list of boxes obtained from Church Missions House to the various parishes and missions; shall have charge of preparation of any Diocesan box and shall present the combined report of all parish box work.

Section 7.—The Treasurer shall take charge of all moneys, except United Thank Offerings, disburse same according to instructions, and shall give annual report at the regular meeting. She shall also act as Chairman on Credentials.

Section 8.—The United Thank Offering Custodian shall furnish the Parish Branches with United Thank Offering boxes, and leaflets, and bring to their attention in other ways the purpose of United Thank Offering. She shall keep a list of contributors and make a semi-annual collection, and put these amounts out at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready together with its accumulated interest, for presentation at the Triennial Session of the Woman's Auxiliary.

Section 9.—The Long Distance Secretary shall secure the names of Church women within the Diocese, who are not affiliated with any parish or missions, and endeavor to relate them through prayer and service to the work of the Woman's Auxiliary.

Section 10.—The Executive Committee shall have power to fill vacancies in its own body between regular elections.

Section 11.—Each Diocesan Officer shall make a report of her work at the annual meeting.

#### **Article II—Dues**

Section 1.—Operating expenses of this organization shall be met by an annual appropriation from each Parish Branch, the amount assessed to be at the rate of 25 cents per member. This appropriation shall be known as the Contingent Fund.

Section 2.—Each Parish Branch shall make an annual voluntary offering for an Educational Fund.

#### **Article III—Meetings**

The Executive Committee shall meet at least quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President, or by written request of two members of the Committee.

#### **Article IV—Election of Officers**

Section 1.—The Election of Officers to be held at the annual meeting by ballot, a majority of votes cast being necessary for the election to office.

Section 2.—The Committee on Nomination shall send out blanks to each Diocesan Officer and Parish Branch two months prior to the an-

nual meeting, asking for nominations for officers to be elected for the ensuing year; each Convocation nominating its own vice-president in regular order, which ballot must be returned one month prior to the annual meeting.

Section 3.—The Committee on Nomination shall prepare a ballot containing names of two candidates for each office receiving the highest number of votes. This ballot shall be sent to each Diocesan Officer and each Parish Branch at least two weeks before the annual election, with instructions to place an "X" opposite the name of candidate for each office, or substitute any name desired. Said ballot shall be cast by the delegate of the Branch or the Chairman of the Nominating Committee. The result of each election shall be announced at the close of the meeting.

Section 4.—Term of office shall be for three years, officers to be elected in the following groups: (1) President, Long Distance Secretary, Recording Secretary, Educational Secretary; (2) the Vice-President of the N. E. and S. W. Convocations, Corresponding Secretary and Treasurer; (3) Vice-Presidents of the N. W. and S. E. Convocations, Supply Secretary and United Thank Offering Custodian.

#### **Article V—Quorum**

One-fourth of the members having a right to vote shall constitute a quorum at the annual meeting. Five members shall constitute a quorum at the meeting of Executive Committee.

#### **Article VI—Elections**

Section 1.—The election of Parish Officers shall be held at the meeting preceding the annual meeting and the Corresponding Secretary shall be notified at once of the names and addresses of the new officers for insertion in the year book.

Section 2.—Each Parish Branch shall elect delegates for representation at the annual meeting.

Section 3.—At each annual meeting three delegates and three alternates to the meeting of the Provincial Synod shall be elected. In case the elected delegates and alternates are unable to attend, the Executive Committee, with the approval of the

Bishop, shall appoint women to act in their stead.

Section 4.—At the annual meeting preceding the Triennial, five delegates and five alternates shall be elected. In case the elected delegates and alternates are unable to attend, the Executive Committee, with the approval of the Bishop, shall

appoint women to act in their stead. These elections shall be by ballot.

#### **Article VII—Amendments**

These by-laws may be amended or suspended by a two-thirds vote at an annual meeting, provided notice is given of the proposed amendment or amendments at a previous meeting of the Executive Committee.
