President's Address

Ladies:

God has blessed us most bountifully again and has brought us here together that we may know of the good deeds of others and rejoice in the knowledge that our work has gone forward along every single line. The reports that have come in show a magnificent amount of work done in all the five fields, and a renewal of personal effort and sacrifice among the splendid women that go to make up the personnel of the Woman's Auxiliary of the Diocese of Texas.

To me, that name, means much, so much more than it ever did before my association with the Bishop's Hand maidens—First it means that there are groups of women in almost all Parishes and Branches in our Diocese who are willing to put aside self and say to the Master "Here am I, send me;" and He has sent you to do ten times ten thousand good deeds throughout this year. He has sent you to stand behind your Rectors, He has sent you to pray for others as well as yourself. He has sent you to feed those that were hungry, both physically and spiritually. He has sent you to cloth those without clothes and to console those in sorrow. He has sent you to the uninterested Church woman and made you His messenger that raised the veil of knowledge that she might know the joy that is yours because of service. He has sent you into the church schools, into the Choirs, into the young peoples work—into the jails, the sick room and wherever there was an opportunity to tell of the love God and the sacrifice of the Christ—He has made it possible for you to go "hither and thither" spreading the radiance of your dear Lord's love—isn't that great and glorious news? Isn't that quite enough to make us all happy and thankful to God for this opportunity of Service?

Again I am wishing, with all my heart, that each of you here might know what the other church women are doing. I wish I had the words and the power of speech to tell you just one tenth of the work that has been accomplished during the past year, despite Wall Street and a short cotton crop. I find this, my dear ladies, that God finds a way for you to do the things that He wants you to do. I

find that you never falter, God bless you, that you make all kinds of personal sacrifices to meet the demands that are made upon your strength, your time and your purse. But after all you are God's children and whatever you may have He gave it to you and what ever you may do it is an infinitesimal part of what He has done for you.

I have been accused of having been a Methodist before I came into the Church, well, I never was a Methodist, but, they have some fine characteristics that we could adopt and be better off. One of them is the gathering in of all God's children. Some times I think maybe we would do better if we would have a revival occasionally in the Auxiliary and get out and shout from the house tops about it so that all our people might know that we are busy in God's name and not in our own. I heard a very splendid Rector in this Diocese say recently that he believed in advertising, especially in the Church work, because there was something of value to be advertised, but in his opinion the one piece of work in our church that needed advertising was The Woman's Auxiliary—he called our attention to the joyful fact that we did all manner of good deeds at all times in all ways but that we eternally wrapped the cloak of silence about what we were doing—I believe he was just a little bit wrong about that cloak wrapping but I know he was right that we are too reticent about our good deeds. I am firmly of the opinion that if we would just let the church women know what we are doing and how much joy it brings that we couldn't keep the church women out of the Auxiliary and its good works.

I recently heard a Christian preacher say that we Episcopalians educated our preachers too much—that they, the Christian people, didn't educate their's enough because their converts were so filled with the Holy Ghost they couldn't wait to get educated, they had to go right now to tell the world. Now again we might copy from one of the denominations and go out among our women, radiating joy and happiness of our work to such an extent that all would want to come into a work that makes you happy all day

long. Do you, my dear Auxiliary women, know of a single thing in your church life, outside of the Holy Communion, that means even a small part as much to you as your Auxiliary work? Do you? Then why don't you let the world, the church world, know what it means to be an Auxiliary Woman—Why don't you tell your uninterested Church women that Jesus Christ himself glorified the cause you represent and personally set you forth to do the things that you can do in the Auxiliary. So let's make up our minds that we will so radiate our happiness and tell of our work that the other Church women cannot afford to be other than an active Auxiliary woman.

Again I am happy to tell you that all calls have been answered and that we can again start out on a new year with a clean sheet, ready for what ever comes to our hands.

Mrs. Thos. Rice has done double duty this year—she has served you most efficiently as U. T. O. Custodian and she has done equally as well as your Educational Secretary. Stand behind Mrs. Rice, by seeing that every one of your Church women have blue boxes—they are to be had in any number needed by asking Mrs. Rice. Then again if you have really fine ideas for the programme, and I know many of you have, write her and tell her about them. She needs help from you just as I do.

Likewise, let me say that your Executive Board has served you most

diligently and most faithfully, save and except your Vice Presidents. Not a word have we heard from any of them but our dear Mrs. D. R. Pearson, who is worth her weight in gold, and who held, according to your instructions, one of the very best Provincial meetings that it has been my pleasure to attend. I do hope that we may have a revival among our Vice Presidents, at least to the extent of holding the one meeting of the year they are instructed by the By-Laws to hold.

The Chairman of our special committees have served faithfully and successfully, there is Mrs. Sargent, who writes you about our Prayer Partners; Mrs. Demaret, who guides the destinies of the Minnie Taylor Memorial Fund, Mrs. McFaddin, who brought the Corporate gift to a successful end this year; Miss Janie Hawkins, who has headed up the Win One Woman for the Auxiliary work. This one piece of work has possibly attracted more attention Nationally than any other special work, since we have had letters from many, many places. Mrs. P. S. Tilson is the new Chairman for this work and I hope you will follow her lead in seeking out new members.

Now let me thank you individually and in groups for the splendid work you have done and let me add that I still Thank God every night and every morning for the privilege of serving with you.

MINUTES OF THE TWENTY-NINTH ANNUAL MEETING

The twenty-ninth annual meeting of the Woman's Auxiliary of the Diocese of Texas was held at the Y. W. C. A. at Beaumont, Texas, January 20, 1930.

There was corporate communion at 7:30 a. m. by Rev. W. Meade Brown, assisted by Rev. Hugh Murry.

The morning session was opened with hymn, with Mrs. Kirkpatrick of Beaumont presiding; followed by prayer led by Rev. G. C. Montgomery of Galveston.

On behalf of St. Mark's Parish and Auxiliary, Mrs. Kirkpatrick delivered the address of welcome.

Mrs. Tilson of Houston responded on behalf of the Woman's Auxiliary.

Next in order came a prayer by our beloved President, Mrs. W. W. Turner, followed by an inspirational talk. Her address will be printed in the Year Book.

Roll call was interspersed on the program throughout the day. All branches showing a very marked increased interest, especially along the educational lines. Most of the branches filled their respective quotas.

Mrs. T. J. Windham, chairman of the Bishop Kinsolving Memorial Scholarship Fund, made a most interesting report. The plan submitted by Mrs. Wyndham, and her committee and accepted by the Executive Board is in the form of a "Book of Remembrance." The gifts which accompany the names of our departed loved ones form a fund, the interest of which will be used to educate theological students from this diocese. The book is being made by the Cargill Company, Houston, Mr. Frank Clemens in charge. It will be bound in purple leather and illuminated by two gifted young women, Misses Grace Sands and Beatrice Matthaei of Trinity Church, Houston. Theirs is a work of love. Motion was made that letters of appreciation be sent these young ladies.

Mrs. Windham also reported that every clergyman and every Auxiliary President had been communicated with, telling of the plan and asking that a parish chairman be appointed. She made several talks before organizations explaining the plan. The response from a few parishes was most gratifying. The total amount subscribed to date being \$665.65.

She also asked that a suitable receptacle for the book be in the minds and hearts of the women, suggesting that this should be a memorial also.

The annual report of the recording secretary was read and approved.

No report from the four vice-presidents.

Mrs. Harris Masterson, Jr., made her report on the A. & M. land fund, the same being incorporated in the annual report. Mrs. Masterson was given a rising vote of thanks in appreciation for this splendid piece of work.

Mrs. Shutt, chairman of the Isolated, next made her report which is always an interesting one. Her's is truly a piece of personal evangelism.

Mrs. Warfield, corresponding secretary, being absent, her report was read by Mrs. Hopson, of Trinity, Houston.

It was with saddened hearts that we met together, for on Friday night, January 17, before our meeting on Monday, our most beloved and esteemed friend, Mrs. A. E. Schaeffer, Diocesan Treasurer, passed from our midst. Her loss will be keenly felt by the Executive Committee and all the Women of the Church.

Out of respect to Mrs. Schaeffer, her report was not read.

Mrs. Harris Masterson, Jr., was appointed to draft a letter of condolence and resolutions. Copies to be sent to Mr. Schaeffer and spread upon the minutes of the Executive Committee.

Mrs. F. R. Sawyer, chairman Supply Department, was unable to attend, but sent in her report, which was not read. It was decided to have it printed in the Year Book instead.

Mrs. Thomas Rice, United Thank Offering Chairman, next made her report, which was most encouraging. With few exceptions all parishes and missions sent in offerings. The offering for the spring was \$1,622.03; fall, \$1,654.15; making a total of \$3,276.18.

A motion was made and carried that a blue envelope with suitable label be sent to all holders of blue boxes in which to put the offering before placing it on the alms basin at the Corporate Communion services, Ascension Day and All Saints Day were chosen as official presentation days.

Inspirational speaker in the person of Rev. Dr. John R. Hart, Jr., Chaplain, University of Pennsylvania, was introduced. He spoke of our power of personality, the development of spiritual grace, that we should so live in the presence of God that our faces are a living revaluation of the two worlds and that our voices and our hand shake can be developed so that people will know of the spiritual side of our nature.

Noon-day prayer followed with special petitions for missions, also roll call and prayer in memory of the departed members: Mrs. S. E. Alden, Alvin; Mrs. H. F. Hilgartner, St. David's, Austin; Mrs. S. T. Hines, Bryan; Mrs. F. J. Gibson, Calvert; Mrs. W. T. Daly, Church of the Redeemer, Houston; Mrs. R. E. Latimer, Port Arthur; Mrs. W. H. Upton, Port Arthur; Mrs. A. E. Schaeffer, Christ Church, Houston; Mrs. Pratt Matthews, Nacogdoches; and Miss Ona Swann, Nacogdoches; and Mrs. F. W. Crutchfield, Nacogdoches.

The following committees were appointed: Resolutions, Mrs. Collin, Port Arthur; Mrs. McCallum, Temple and Mrs. Sands, Houston.

Elections: Mrs. Waldrop, Houston; Mrs. Wilson, Alvin; and Mrs. Airey, Columbus.

Adjournment for luncheon.

After a joint session with the Council, the afternoon session was opened with hymns and prayer. The report of the provincial delegates, Mesdames Masterson and Daup, were heard. Both were very interesting. For the lack of time, Mrs. Masterson did not finish her report. She brought back the fact that there is a great need for trained workers among our young people. This work being a most important factor and a work that is occupying the minds and hearts of the leaders of our great Church.

She also reported that there will be no Corporate Gift for women alone, but we are to take part in the advanced work for the Church's Program. Urged the observance of World Day Prayer.

No report of the Minnie Taylor Memorial Fund, Mrs. DeMaret being unable to attend.

No report of the Corporate Gift, Mrs. McFadden being at the bedside of her daughter in New Orleans.

Rev. Mr. Engle of Bay City was next presented who made a short talk on work in the rural field, urg-

ing the sending of a woman delegate to Madison, Wis., for instruction.

A motion was made by Mrs. Daup, seconded by Miss Mitchell, that we again give \$200.00 towards this work, the same being handled as in previous years.

Mrs. McClendon told of the work done on Grace Hall, Austin, that the deplorable condition of buildings reported by Mrs. King last year, had been repaired, but that more money was needed for refurnishing and that all donations be sent to Board of Regents, Robt. Walthall, Treasurer, Capitol Bldg., Austin, Texas.

Bishop Quinn paid us a visit of a few minutes, at which time he was questioned as to how the Woman's Auxiliary could help in the deficit of the Budget, that seemed to be puzzling the minds of the Council during the joint session.

After the Bishop had left, there was a general discussion, result being a motion made by Mrs. Rice, which carried by a substantial majority as follows: "That believing that the men will not allow our Diocese to have a deficit for the current year. We, the members of the Woman's Auxiliary of the Diocese agree to assume such deficit, should it exist, at the end of 1930, in order that our Bishop may be able to write headquarters that we accept our quota."

This resolution was sent over to the Bishop while the Council was in session.

Miss Edna Eastwood, National Secretary for Home Study, Department of Religious Education, was next introduced.

Miss Eastwood made a most interesting talk of how we can help in the Rural Work of the Church, particularly among the isolated, pointing out that the great move of Personal Evangelism can be realized most satisfactorily in this field. She left with us leaflets with suggestions on how this work may be carried on.

Miss Eastwood is a person of ability and charming personality. We deemed it a privilege to have her in our midst.

The election returns were read by Mrs. Waldrop of Houston:

It was moved and seconded that it be accepted as read.

The following resolutions were adopted:

"Whereas the members of the Woman's Auxiliary of the Diocese of Texas, appreciated the hospitality of the Rector and entire parish of St. Marks,"

"Whereas the Woman's Auxiliary appreciated the attendance of Rev. Dr. Hart and Miss Eastwood to the Council. Their messages will be a lasting benefit and an inspiration to all."

The assembly wished to express its appreciation to the presiding officers for their year's work and pledged their support for the coming year.

Also thanks for the use of the Y. W. C. A.

It was suggested that Mrs. Turner write memorial for Mrs. Shaeffer and same be spread on minutes;

"Whereas, our Heavenly Father did call to her rich reward and everlasting peace, our fine, sweet, loyal friend and faithful co-worker, Mrs. A. E. Shaeffer,

"Therefore, be it resolved: By this body of Church Women now in session, that we bow in submission to our Father's will, and point with pride to the full life of splendid service and good deeds of our dear friend and most willing co-worker in the Master's cause.

We are firm in the belief that her work on this earth will live long and redound to her honor and to the glory of God.

"Be it further resolved, that we here and now accept the torch of faithful service she handed us and pledge ourselves to carry on where she left off.

"Be it further resolved: That a copy of these resolutions be spread on our minutes and that a copy be sent to Mr. A. E. Shaeffer."

A special offering was taken at the sessions, amounting to \$12.30 which was turned over to Mrs. Windham to be used towards the Bishop Kinsolving Memorial Fund.

A message of regret was received from Mrs. Helen G. Garbade of Galveston.

Mrs. Turner presented check for \$101.00 from Mrs. J. M. Jones, Bryan, a gift for the altar at A. & M. Voted to accept check—also secretary to write letter of thanks to Mrs. Jones.

The following ladies were elected as delegates to the Provincial Meeting to be held in Little Rock, Ark., in October: Mrs. Thos. Rice, Mrs. J. W. Hopson, and Mrs. M. D. Carlisle.

After closing prayers the meeting adjourned.

REPORT OF THE DIOCESAN EXECUTIVE COMMITTEE OF THE WOMAN'S AUXILIARY, DIOCESE OF TEXAS, FOR THE YEAR OF 1929

Madam President and Members of
The Auxiliary:

The meetings of the Executive Board of the Woman's Auxiliary during the year 1929 have been well attended. All meetings were held at Christ Church Parish house, except one.

At the February meeting there were eight members and one visitor present.

The devotional was led by Mrs. Turner in the absence of Mrs. Quin, to whom it had been assigned.

Miss Mitchell reported new work for her department, the Church Pe-

riodical Club, at Cameron, also a very interesting piece of work out of Austin. Stated that Waco and Beaumont had resigned. She also reported having placed four Lecturn Bibles.

Mrs. Turner read the report of the meeting of the Woman's Auxiliary at Waco, prepared by Mrs. Hornbeck.

A letter was read from Milton J. Swift, expressing appreciation for the free will offering of thirty-four dollars sent him from the annual meeting at Waco to help carry on the work in New Mexico.

Permission was given Mrs. Schaeffer to have the Year Book printed and that one thousand copies be ordered.

It was also decided that this year's Year Book be a memorial to our late Bishop Kinsolving, the tribute to be written by Mrs. Turner, and the book to be bound in purple.

A letter was read from Mrs. Tolman from New York, suggesting that the Diocese of Texas make the United Thank Offering a tribute to Mrs. Catterall for the coming Triennium.

Our visitor, Artemesia Bowden, spoke in the interest of the St. Phillips Junior College, colored, San Antonio. She is trying to raise ten thousand dollars for the operation of the college.

March

At the March meeting there were nine members and two visitors present. Mrs. Rice, Educational Secretary, reported that there was quite a bit of interest this Lent in the study of the book "The New Africa."

Mrs. Sawyer, Supply Secretary, next made her report. She stated that all assignments were being well taken care of. Goose Creek and Baytown had asked for work.

Mrs. Schaeffer reported that the Year Book would be ready for immediate distribution in a few days and that nine hundred copies were ordered at the cost of \$143.00.

Mrs. McFaddin of Beaumont appeared before the body for information as to her duties as chairman of the Corporate Gift (she having been elected to this office at Waco.) Mrs. Rice made the suggestion to Mrs. McFaddin that in writing to the various branches, a chairman for each branch be appointed to present the idea to every organization in their respective parishes, in an effort to reach all the women of the Church.

Miss Mitchell stressed the transferring of magazines as a very important part of the work of the Church Periodical Club. She stated that the Diocese of Texas ranks eleventh in the C. P. C. work. She was very complimentary to the women of Bryan for the work done in the rural sections around Bryan.

Mrs. Tolman announced that Miss Grace Lindley's visit to this Diocese would be two days, April 5 and 6th. It was suggested that Miss Lindley visit Galveston, and that Mrs. Rice request Rev. Mr. Gibson that she be invited. In this, the board felt that more people would be given the opportunity to meet and hear her.

April

On April 2, the meeting was called to order by the president, and after the usual routine of business, the conferences to be held by Miss Lindley was discussed.

Mrs. Rice extended an invitation to the Board to attend the Conference at Galveston as guests of the Trinity Auxiliary.

All committees reported everything in readiness for Miss Lindley's visit. Mrs. Warfield, corresponding secretary, reported having written all branches informing them of the Conference.

Mrs. Thos. J. Windham appeared before the Executive Board to present the question of the Memorial to the late Bishop Kinsolving, as recommended at the Council at Waco. The matter was discussed and a plan suggested by Mrs. Tolman was considered, namely, "A Book of Remembrance." A committee composed of the following ladies: Mrs. Marie Windham, Chairman; Shirley G. Carlisle, Hortense P. Quinn, Virginia F. Warfield, Rosalie C. Tolman, was appointed by Mrs. Turner to consider the plan more fully.

Mrs. Windham made the first offering, a five dollar gold piece, which was turned over to the treasurer.

May

At the May meeting there were seven members present. The meeting was opened with prayers for the United Thank Offering, led by Mrs. Rice.

Mrs. Rice reported having had United Thank Offerings from seventeen branches, which she considered very encouraging. She also reported having written a letter to the Texas Churchman calling attention to the fact that the U. T. O. would be a tribute to Mrs. Catterall.

Mrs. Turner announced that Verna Lowden would not return to Chase House and that another candidate would be chosen.

Mrs. Windham submitted a report of the Committee of the Bishop Kinsolving Memorial Scholarship. Read a tentative letter that would be sent to Rectors and Chairman. The letter was indorsed by Bishop Quin and will be printed in the Texas Churchman. It was decided to send letters first to Auxiliary Branches and as time goes on to enlarge the circle.

June

The June meeting was opened by an inspirational talk by Mrs. Turner. She received her inspiration from conversation with a young woman whom she met on a recent visit to Freeport, after which she had prayers.

Mrs. Warfield reported having written to Miss Coral Clark at Austin.

Mrs. Rice reported that she had received the spring United Thank Offering from all but one or two branches. She announced that Waco had asked for one hundred Blue Boxes and the chairman there seemed very enthusiastic.

Mrs. Turner reported having received a letter from Rev. Mr. Daup asking for the use of the money in the A. & M. Chapel Land Fund. Mrs. Warfield was instructed to write Mrs. Harris Masterson, Jr., of Austin, who is chairman of this fund, asking her whether it was her pleasure to use the fund at this time.

A motion was made and carried that the expense of having the Book of Remembrance made be taken from the contingent fund. Also that the offering at the annual meeting be used for the same purpose.

There was no treasurer's report, Mrs. Schaeffer being out of the city.

Adjourned to meet the first Tuesday in September, unless notified of a change by the President.

September

The next meeting was held on September 10th, as luncheon guests at Mrs. Windham's new home. After lunch the meeting was called to order and opened with prayers led by Mrs. Harris Masterson, Jr., of Austin.

Mrs. Schaeffer made her report from May 1 to date, September 10.

A motion was made by Mrs. Tolman and seconded by Mrs. Rice to rescind the motion made at previous meeting to use money borrowed from the Contingent Fund towards financing the Book of Remembrance.

Followed by motion made by Mrs. Schaeffer to use the Triennial Delegate Fund and Camp Allen Adult Conference Fund instead. The motion carried. This latter fund to be ratified at annual meeting.

Mrs. Rice, U. T. O. Chairman, reported over \$16,000.00 in the Thank Offering Fund. She told of receiving

letters from the Church Missionary Calendar Company, urging the Diocese to use their calendar. Mrs. Turner requested Mrs. Rice to present the proposition at the Annual meeting in Beaumont.

Mrs. Rice also told of Vera Gang the young negress of Galveston who had previously attended St. Phillips in San Antonio aided by the Minnie Taylor Memorial Scholarship Fund. She now wants aid again. A motion was made and carried that ten dollars a month for eight months be given her.

Mrs. Tolman made announcement of the Synod meeting in Topeka, Kans., November 5, 6, and 7th, with Bishop Capers of West Texas presiding. Mrs. Turner to appoint two delegates.

Mrs. Masterson, Chairman of the A. & M. Chapel Land Fund, made a motion which carried that Mrs. Schaeffer turn over the money she has in the Land Fund to Bishop Quin with the request that he send it to Mr. Japhet, who is Chairman of the A. & M. Fund.

REPORT OF EDUCATIONAL SECRETARY

To the President and Members of the Woman's Auxiliary to the National Council in the Diocese of Texas.

During the year 1929 all meetings of the Executive Committee were attended with the exception of one, also attended a meeting of the department of Religious Education.

In January was present at the Annual meeting of Woman's Auxiliary in Waco and during the two days of the Council had copies of the textbook "The New Africa," for sale. From all accounts the interest in the study of this book was varied, some Branches reporting good work done others a lack of interest. In April the Woman's Auxiliary in our Diocese greatly enjoyed a two days visit from our National Secretary, Miss Grace Lindley. Conferences were held in Houston and Galveston, attended the latter and helped with the arrangements. Such meetings as the above are really an inspiration and ought to fill us with a greater zeal to press forward the work of the Kingdom.

Attended a Conference Day for women held at Beaumont, in October, gave a short talk on the United Thank Offering. This meeting was well attended and our Diocesan President gave an interesting and helpful talk on the scope of the Woman's Auxiliary.

A book that is well recommended as a second choice for the Branch not caring to study "Roads to the City of God" is "Our Common Life" by the Rev. Karl Block. Another outstanding book in the religious world, and the one we are asked to review is "The Great Conjecture," by Winifred Kirkland. It is a declaration of faith by a thinking woman who tries to understand the reality of Jesus in her daily life and finds the inescapable Christ.

All letters received during this year have been answered, and books sent out when asked for and had them on hand.

Praying that God will bless every effort of the Woman's Auxiliary in our Diocese for the carrying on of His work, and to fill us with a greater desire for service in His Church.

REPORT OF SECRETARY TO THE ISOLATED

Madam President and Fellow Workers:

I have 41 Isolated Church members with whom I keep in touch, 4 times a year I send them prayer leaflets provided by the Executive Board. I also send Church Calendars and other suitable helps. I write the beginning of Lent reminding them of that Holy Season and at Easter send Easter cards; at Christmas cards too, in all about 400 communications. I am also trying to get birthdays that I may send greetings. (In Mexico where I visited during the time government closed the churches. Bishop Quin provided Christian nature, Sunday School series which enabled a Sunday School to be started in a private home. The Sunday School has grown to nearly 100. They have built a Sunday School, paid for it—two-thousand dollars (\$2,000.00) and are now trying to find ways and means to furnish it. The church has had no rector for 15 months only a lay reader in charge. I have very few an-

swers to my letters, but what I do have are very encouraging. One member told me of a beautiful answer to prayer. Another tells me she hopes to have her home finished some time during the year. Also to have it dedicated, then start a mission in her home. I have written to my friends asking them to have a short service in their home at some convenient time on Sunday and to ask any friend or neighbor to join the leaflet service, a prayer, Bible reading and short sermonette to be provided by Mission Headquarters, but I have had no response so far.

I do not mention money except as a thank offering or at spring and fall I try to get a donation for our United Thanks offering when I invite any offering beginning at 10 cents which I enclose in our Christ Church offering.

Mrs. Tolman gave a splendid report as the Provincial representative on the Executive Board. She attended each meeting of the Board and was placed on the Field Committee, United Thank Offering Committee, and the Publication Committee.

I.

Corporate Gift

\$45,000 was reported raised and objects were named. We are taking the liberty of eliminating the further proceedings concerning this Gift, and will quote the January Spirit of Missions, which says that, "In view of recent developments it

was decided that we do not undertake any further separate Corporate Gift, but use our present efficient Committee under Mrs. Burkham, to carry out our full share in the Advance work of the Church."

At this point Miss Edna Eastwood, Secretary for Home Study, from the National Church, was introduced. She had definite suggestions to make about programmes for the rural community, Prayer, Study, Service, Pleasure—each has a place in rural work.

The Rev. Mr. Foreman, Chairman for the rural work of the Church made the following suggestions:

1. That Diocese have rural work programme,
2. That Diocese have rural work committee to carry out programme,
3. That Auxiliary sponsor Church School in a rural district,
4. Maintain women workers in rural districts,
5. See that isolated are ministered to,
6. Observe 5th Sunday after Epiphany as Rural Life Sunday,
7. Urge use of Rogation days as stressing rural work.
8. Send young person to Provincial School,
9. Establish W. A. bed in parishes,
10. Subscribe to Rural Messenger, \$1.00 a year.

II.

Enlisting Others

Miss Beecher, daughter of Bishop Beecher, is a clear thinker and clever leader. Her conference was on "How to Interest Young Women in the Work of the Church."

She suggested:

1. That young women should organize and hold their separate meetings with an occasional meeting with the older branch.
2. Material for study may be found in "Findings on Religious Education," published quarterly.
3. If young women are interested in Social Service, material may be found in the book, "Building the City of God."
4. If interested in Family Relations Institute—get in touch with Dean

- Lathrop, 281 Fourth Avenue.
5. Give Blue Boxes with explanation.
 6. Have dues include subscription to "Spirit of Missions."
 7. If you would follow up the interest of young women in Child Training and Study Mrs. Marston will answer all questions at 281 Fourth Avenue.
 8. A Social Service Committee may meet with similar one from older Branch and perform a real service in the community.
 9. During Lent every woman of the Church should become an Auxiliary member and nothing but Missions should be studied.
 10. May unite with older branch on box work.
 11. Each organization should report to Parish Council.

Girls Friendly

The lady who spoke made the assertion that the Girls Friendly was a recruiting agency for Officers of the Auxiliary. This brought out the question: "How can we recruit from girls, who, for the most part, are not Episcopalians? The answer was that with proper leadership such officers could be trained.

III.

Christian Social Service

Dean Lathrop said, "Jesus Christ is the basis for Social Service." Read his Meditations on the Lord's Prayer. He asks the women of the Auxiliary:

1. To visit women in jails, penitentiaries, alms houses and hospitals.
2. Take them reading matter.
3. Observe Social Service (3rd Sunday after Epiphany.)
4. Read "Building the City of God."
5. Get moral questions before the Community.

Box Supply Work

Mrs. Wade told of the growth of this work from \$2,000.00 valuation to \$300,000.00. Please study Missions to which boxes are sent. She finds a lack of knowledge concerning disposition of contents of boxes.

Mountain Missions sell the contents. All sizes of sweaters are always in demand—sheets and shoes come next on the list. The Parish Box Secretary should take charge of all boxes in the Parishes—one means of bringing the whole Parish together.

Provincial Pledge

Bishop Howden of New Mexico, told the Auxiliary of what this pledge has meant to his Indian work. The money was used to equip an operating room which ministers to over 900 Indians during the year. Bishop Seaman also told of what this pledge had meant to his work at the Little House of Fellowship, Canyon City. A discussion as to whether this pledge should be used in or out of the Province for the next three years, resulted in a vote, to apply \$1500.00 a year for the next three years, to the Helen Dunlap School, Winslow, Arkansas.

IV.

Religious Education

The last day was Educational Day. It was opened with the Holy Communion followed by a Meditation on "Feeding the 5000" by Bishop Quin.

The business of the day was well begun by the election of Mrs. John Hamilton Moore of West Texas as Educational Chairman of the Province, after the reading of the Educational Chairman's Report. The day was given to an Educational Institute conducted by Miss Frances Bussey, Educational Secretary; W. A. Diocese of Milwaukee, and member of National Board from Vth Province. We cannot too strongly recommend Miss Bussey as an Educational Leader of exceptional ability.

Our study this year is to be the Jerusalem Conference, Roads to the City of God, Basil Mathews is the book chosen, although Miss Bussey recommends other books; "The World Mission of Christianity;" "A Faith for the World," etc.; in fact any book on the Jerusalem Conference may be studied. The purpose is to get results of this Conference before the Auxiliary and the Church. Some suggested ways:

1. What is the Conference for?
2. Think about it.
3. Form your own conclusions.
4. Read all you can on the subject.

A. Suppose you were going as a Missionary to make Christ known to those who have never heard of Him? How would you proceed? After a long discussion these points were brought out. We would present:

- I. God as a Father.
- II. (God the Son—Incarnation.)
(God's great family.)

III. Immortality—on dwelling of the Holy Spirit.

IV. Sacraments.

B. What are the chief obstacles to the spread of Christianity at home and abroad?

I. Luke-warm Christians.

II. Hypocrites.

III. Un-Christ like Characters.

IV. Personal lives.

Conclusion:

Our Lord has become Life to us and we feel that we must share that Life.

Like St. Paul we must give up certain things that we may know Him better—To do this we must:

1. Study His Life and Teachings.

2. We must pray for others and ourselves.

3. We must meditate, it takes time to know Our Lord.

4. We must use the Sacraments.

As we come to know Him we will realize "the Excellency of the Knowledge of Jesus Christ."

CONSTITUTION OF THE WOMAN'S AUXILIARY, DIOCESE OF TEXAS

Article I—Name

The name of this Society shall be the Texas Branch of the Woman's Auxiliary to the National Council.

Article II—Object

The object of this Society is to serve The National Council in the work of the General Church, in the Department of Missions, Social Service and Religious Education.

Article III—Membership

The Church itself is the Missionary Society. Every baptized person is a member of this Society, therefore every baptized woman and child in this Diocese should be an active member of the Woman's Auxiliary.

Article IV—Officers

Section 1. The Officers of the branch shall be a President, a Vice-President for each convocation, a Recording Secretary, a Corresponding Secretary, an Educational Secretary, a Supply Secretary, a Long Distance Secretary, A Treasurer and a United Thank Offering Custodian.

Section 2. The Officers shall constitute an Executive Committee to transact business of the branch when not in session.

Section 3. A Committee of two shall be appointed by the Executive Committee to audit the Treasurer's account one week before the annual meeting.

Article V—Meetings

Section 1. The annual meetings of the Texas Branch shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Executive Committee.

Section 2. The election of Diocesan Officers shall be held at the annual meeting by ballot. Each Parish Branch being entitled to one vote, unless the membership of said Branch shall exceed twenty-five, in which case the Branch shall be entitled to two votes. Each Diocesan Officer shall be entitled to a separate vote on all questions before the assembly.

Section 3. A Committee on Nominations, consisting of three members, shall be appointed by the Diocesan President two months prior to the annual meeting.

Article VI—Amendments

This Constitution may be amended at any annual meeting by two-thirds vote of delegates present; provided the amendment or amendments be submitted to each Branch two months before the annual meeting.

BY-LAWS

Article I—Duties of Officers

Section 1. It shall be the duty of the President to preside at all meetings and to perform all other duties appertaining to the office.

Section 2. It shall be the duty of the Vice-Presidents of the several convocations to perform duties of President in her absence, or at the request of the President, and to cooperate with the President in all Diocesan work, and to have general supervision of the work, each in her own convocation.

Section 3. The Recording Secretary shall keep a record of proceedings of all meetings, and prepare an annual report, and in the absence of the President and Vice-President shall call the meeting to order and act until a chairman is elected.

Section 4. The Corresponding Secretary shall give notice of all meetings both of the Association and of the Executive Committee and shall conduct a general supervision of the correspondence of the Society. She shall keep a record of the Parish Branches and the Officers.

Section 5. It shall be the duty of the Educational Secretary to have a general supervision of the educational work of the Auxiliary in the Diocese; to secure a leader of Mission Study in each Parish Branch.

Section 6. The Supply Secretary shall assign list of boxes obtained from Church Missions House to the various parishes and missions; shall have charge of preparation of any Diocesan box and shall present the combined report of all parish box work.

Section 7. The Treasurer shall take charge of all moneys, except United Thank Offerings, disburse same according to instructions, and shall give annual report at the regular meeting. She shall also act as Chairman on Credentials.

Section 8. The United Thank Offering Custodian shall furnish the Parish Branches with United Thank Offering boxes, leaflets, and bring to their attention in other ways the purpose of United Thank Offering. She shall keep a list of contributors and make a semi-annual collection, and put these amounts out at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready together with its accumulated interest, for presentation at the Triennial Session of the Woman's Auxiliary.

Section 9. The Long Distance Secretary shall secure the names of Church women within the Diocese, who are not affiliated with any parish or missions, and endeavor to relate them through prayer and service to the work of the Woman's Auxiliary.

Section 10. The Executive Committee shall have power to fill vacancies in its own body between regular elections.

Section 11. Each Diocesan Officer shall make a report of her work at the annual meeting.

Article II—Dues

Section 1. Operating expenses of this organization shall be met by an annual appropriation from each Parish Branch, the amount assessed to be at the rate of twenty-five cents per member. This appropriation shall be known as the Contingent Fund.

Section 2. Each Parish Branch shall make an annual voluntary offering for an Educational Fund.

Article III—Meetings

The Executive Committee shall meet at least quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President, or by written request of two members of the Committee.

Article IV—Election of Officers

Section 1. The Election of Officers to be held at the annual meeting by ballot, a majority of votes cast being necessary for the election to office.

Section 2. The Committee on Nomination shall send out blanks to each Diocesan Officer and Parish Branch two months prior to the annual meeting, asking for nominations for officers to be elected for the ensuing year; each Convocation nominating its own vice-president in regular order, which ballot must be returned one month prior to the annual meeting.

Section 3. The Committee on Nomination shall prepare a ballot containing names of two candidates for each office receiving the highest number of votes. This ballot shall be sent to each Diocesan Officer and each Parish Branch at least two weeks before the annual election with instructions to place an "X" opposite the name of candidate for each office, or substitute any name desired. Said Ballot shall be cast by the delegate of the Branch or the Chairman of the Nominating Committee. The result of each election shall be announced at the close of the meeting.

Section 4. Term of office shall be for three years, Officers to be elected in the following groups: (1) President, Long Distance Secretary, Recording Secretary, Educational Secretary; (2) the Vice-President of the N. E. and S. W. Convocations, Corresponding Secretary and Treasurer; (3) Vice-Presidents of the N. W. and S. E. Convocations, Supply Secretary and United Thank Offering Custodian.

Article V—Quorum

One-fourth of the members having a right to vote shall constitute a quorum at the annual meeting. Five members shall constitute a quorum at the meeting of Executive Committee.

Article VI—Elections

Section 1. The election of Parish Officers shall be held at the meeting preceding the annual meeting and the Corresponding Secretary shall be notified at once of the names and addresses of the new Officers for insertion in the Year Book.

Section 2. Each Parish Branch shall elect delegates for representation at the annual meeting.

Section 3. At each annual meeting three delegates and three alternates to the meeting of the Provincial Synod shall be elected. In case the elected delegates and alternates are unable to attend, the Executive Committee, with the approval of the

Bishop, shall appoint women to act in their stead.

Section 4. At the annual meeting preceding the Triennial, five delegates and five alternates shall be elected. In case the elected delegates and alternates are unable to attend, the Executive Committee, with approval of the Bishop, shall appoint women to act in their stead. These elections shall be by ballot.

Article VIII—Amendments

These by-laws may be amended or suspended by a two-thirds vote at an annual meeting, provided notice is given of the proposed amendment or amendments at a previous meeting of the Executive Committee.
