Praying for God's richest blessing on His work in the Diocese and especially to give to each of us a greater desire to follow the steps of our blessed Lord and Master, Jesus Christ,

REPORT OF THE THIRTY-FOURTH ANNUAL MEETING OF THE WOMAN'S AUXILIARY ASSEMBLED AS THE ASSOCIATED CHURCH WOMEN OF THE DIOCESE OF TEXAS

Held in St. Pauls, Waco, January 21 and 22, 1935,
with Mrs. Thomas Rice presiding

Mrs. E. H. Catlin opened the meeting by explaining the purpose of the meeting which was a unified purpose and a coordination of all organizations, and the general theme was "The Way of Discipleship."

Miss Anna B. Hill, of St. Pauls Parish, extended greetings from Waco.

The President appointed Mesdames Dobbins, Hipp and Spotts as the Committee on Dispatch of Business. A motion was made that the Program be adopted and followed as printed.

Mrs. W. G. Franklin, of St. Davids, Austin, was asked to make the roll call. There were 17 missions and 26 parishes answering roll call.

Mrs. Rice appointed Mesdames Caruthers and Tinker as timekeepers.

The Resolution Committee was named as follows: Mesdames Ziegelmeyer, Watts, Brown and Tellepsen.

Mrs. Cortes Pauls, Treasurer, made her annual report, and reported that the books had been audited and found in good order.

Mrs. Tolman gave Mrs. Hubbell's annual report on the U. T. O., which was some findings and resolutions from the General Convention.

Mrs. Posey, Supply Department Chairman, gave her report and asked that every one view the Diocesan Box on display.

Miss Sarah White, of St. Lukes, Tokyo, gave a very inspiring and graphic talk about her work among the nurses.

Three speakers were then introduced to give their impressions of the General Convention. Mrs. Gibson, of Galveston, described the services and told how thrilling and spectacular they were.

Mrs. Goddard, of Marlin, gave a very illuminating and full summary of all findings. "God centered and not man centered" was the keynote struck as to discipleship.

Mrs. Harris Masterson, Jr., of Austin, summed up the talks of the various committees of the General Convention in a most interesting manner.

These talks concluded the morning order of business, and adjournment was made to go to St. Pauls House for a visit.

Mrs. Cavin, of Grace Hall, University of Texas, told of her enthusiasm in her work and she urged that church people send their girls there.

Mrs. Ford, St. Lukes, Houston, made a report on the colored Summer Conference at Galveston.

The Questionnaire Committee was announced: Mrs. Quin, Mrs. Catlin, Mrs. Carlisle.

The Rev. Mr. Goddard followed with an enlightening talk on Discipleship in the Diocese.

Mrs. Olivia Fuller, of Houston, brilliantly covered the two subjects of Discipleship in Community and Nation.

Then Dr. Francis Wei, of China, in his brilliant, personal and practical way told of Discipleship in the World.

Mrs. Watts Brown, of Navasota, reported for the Resolutions Committee, as follows:

A very important resolution was offered, as follows:

Resolved—That the women of the Diocese of Texas assembled in annual meeting to represent their respective parishes and missions express their desire that there shall be one Board for Women's Work in the Diocese through which all parish organizations may report to the National Executive Board of Woman's Auxiliary. That parishes and missions may carry on their women's work as best suits their needs but that we all pledge ourselves to unity of purpose and service in the five fields and that the Diocesan Board of the Woman's Auxiliary be asked to so amend its constitution and by-laws as to in-

clude all reports of women's work in the Diocese with the exception of the Daughters of the King, which reports to its own National Organization. Be it further resolved that the present members of the House of Church Women meet with the Women's Auxiliary Board to help in the reorganization work.

Be it further resolved that we continue to assemble in Annual Council for our share in the extension of the Kingdom.

Motion made and seconded to adopt resolution. *Carried.*

Mrs. Reed, of Austin, read the Memorial and prayer for those gone on into higher service.

Four new members at large were elected to New Board:

The Board members have been very faithful in attendance and work and with such loyal workers in the Kingdom His work has been furthered.

It was with regret that two Board members' resignations were accepted: those of Mrs. Warfield, Corresponding Secretary; and Mrs. Harold Robinson, Educational Secretary. Mrs. Kiber, of Beaumont, accepted the office of Corresponding Secretary.

Mrs. L. T. Hubbell, who is untiring in her United Thank Offering work, reported that the final offering was \$5,869.20 from this Diocese.

Letters of thanks, sympathy, cheer and of a business nature have been promptly attended to by our past and present Corresponding Secretaries.

The Supply Work, under Mrs. George Posey, has been ably handled and all as-

signments have been accepted and extra cash sent to Mrs. Ward in response to her plea for a deficit.

Mrs. Catterall, Chairman of Isolated, has done a beautiful piece of work. She has 54 active members, 27 of whom correspond with her. Her Church School by correspondence is rapidly growing and she pleads for names of isolated people.

Mrs. Robinson, Educational Secretary, whom we shall miss on the Board, has so ably handled her Department and has made up a most interesting program, Japan being the subject from January to September; then selected subjects for fall.

Mrs. Tilson, New Member Chairman, has been most proficient and has reported many new members,—173 in all.

Miss Helen Lyles, who is attending St. Margarets School, Berkeley, California; and Vera Gang (colored), who is at the Bishop Tuttle Training School, Raleigh, North Carolina, are the two recipients of the Minnie E. Taylor Scholarship Fund. Both are doing splendid work, and the Board as well as all Auxiliary members should feel very satisfied.

Deaconess Dorsey has retired, and Miss Blanche Harris, of Bat Cave, North Carolina, has succeeded her.

Mrs. Allen, Spirit of Missions Chairman, has been untiring in her efforts to get subscriptions, and it is her earnest desire that 1935 will see a real active drive on in each Parish for our own Spirit of Missions.

Miss Giesecke, Recruiting Chairman, always has a very active report to make for the Y. P. S. L., whose work is going steadily forward.

Mrs. Windham, Book of Remembrance Chairman, is most enthusiastic and reports that the fund is almost \$3,000.00. She urges that more people use this means of love and remembrance for their loved ones and friends who have gone into the life beyond.

Mrs. Waldrop, Church Periodical Club Chairman, has faithfully carried on and as usual under her department four hundred Ditty Bags were given out at Christmas. She and her workers keep the magazines moving.

Mrs. Quin, an honorary member, as always, is an asset to any Board, and throughout the year she has brought inspiration and has taken it out to the Diocese, and as program chairman for the Council prepared a most interesting one.

Mrs. Tolman, honorary member, successfully, as is customary with her, plan-

ned and carried out an Adult Conference at Camp Allen, August 27 to September 7, and during the year has been through the Diocese extending the work in many directions.

At the joint December meeting with the House of Church Women, Bishop Quin spoke of his hope for a unified program for Women's Work in the Diocese and that he hoped the women might be able to work out some plan and that they might be thinking of themselves as the Associated Women of the Church. MADAM PRESIDENT AND MEMBERS OF THE AUXILIARY:

We feel sure you are eager for the success of this memorial; so let us press forward and increase our investment which now is \$2,000.00, thereby gaining more interest to be applied on the scholarship available fund. The annual interest of \$120.00 falls far short of the need. We have now in our savings account \$527.67. We can double this amount this year if we but renew our effort. Here are some suggestions as to ways of increasing our gifts and offerings:

1. Remind our Rectors to observe St. Marks Day by holding a Corporate Communion Service in memory of Bishop Kinsolving.

2. Instead of sending flowers which soon perish to funerals have names of our loved ones and members of the Daughters of the King, guilds, choirs, vestry, church school teachers and Y. P. S. L. who have entered the larger life inscribed in the Book of Remembrance, a gift accompanying each name.

3. Additional gifts may be sent on anniversaries of death and birthdays.

4. Some one in each parish who knew and loved Bishop Kinsolving should be appointed to take charge of this work, thus adding a personal interest.

During the past year twelve names received and inscribed making a total of 270. This is indeed good considering the distressing times of the past few years.

Thirteen parishes participated in observing St. Marks Day. The total offering being \$39.69.

Pilgrimages were made to Galveston and Huntsville.

Last March we renewed the fire insurance policy on the Book of Remembrance. We have a Maintenance Fund to take care of this bill, stamps and other incidentals. An offering of \$10.06 was made at a Corporate Communion Service in Tyler last year at the Annual Meeting. This amount was added to a balance

REPORT OF GUILDS

MADAM PRESIDENT AND MEMBERS OF THE AUXILIARY:

Thirteen Guilds responded to a request to fill in the work they were doing in the five fields of service. From these reports I will try to give you an idea of the work of Guilds over the Diocese. The Parish work is the most outstanding.

Parish work includes paying for choir vestments, laundry for same, salary of organist and janitor, keeping church lawn, equipping kitchen with dishes, pots and pans and stove, furnishing lockers for choir vestments, paying for altar supplies and caring for them, and serving Lenten lunches, entertaining Y. P. S. L.,

giving Communion breakfasts, paying for the entertainment of the Service Guild, giving Parish dinners and annual parties, and helping with paving fund.

In Community work such things are done as, art exhibits, flower shows, work with Red Cross, and other community organizations. Community church services, sending boys and girls to Camp Allen, helping the Community Chest, donating to firemen's picnic, donations to Red Cross, Christmas and Thanksgiving Boxes to needy, furnishing Thanksgiving dinner for Orphans' Home, and clothing two boys in a home.

In the work of the Nation there are missionary boxes sent, student at Suwanee

helped, ditty bags are sent to the sailors, and the Quiet Day of Prayer is observed.

In work for the World there are missionary boxes, ditty bags sent to China through Red Cross, and donations to a church in Alaska.

This shows that Guilds are working in all the five fields of service except the

Diocese. There are things done for the Diocese, but they have not been reported as such. But all reports show the varied work of Guilds and also that they stand ready to meet any need at any time.

REPORT OF GRACE HALL—AUSTIN

Grace Hall has enjoyed another year as a residence for University women. During 1934 the Hall has been well filled. The number of applicants has greatly exceeded the present capacity of the Hall, and many students have been turned away for lack of space. Prospects for the spring semester are excellent. This volume of patronage has made possible the addition of many comforts to the living quarters. The present need is for clothes-closets and southern exposure sleeping porches. The addition of the latter will so enlarge the capacity of the building as to make their construction a self-liquidating project.

Grace Hall girls participate in all campus organizations, and have representation in the Glee Club, the Light Opera Club, Riding Club, Curtain Club, Y. W. C. A., several literary societies, honorary language fraternities, Home Economics Club and Sports Association. The director works in close contact with the Dean of Women and her staff, and in all matters of disciplinary detail and administration conforms to the University standard. Instructors and officers of the University are frequent visitors at the Hall, and a personal attitude of understanding and appreciation between students and faculty is encouraged. Student labor is employed wherever possible, the standard rate of compensation for University employees being offered. Students have part-time employment at Grace Hall doing yard work, washing dishes, serving in the dining room, and operating the private telephone exchange.

In January, at the time of the annual Diocesan Student Council, Grace Hall offered its living room for the Sunday meeting and afterwards served dinner to the visiting students, who were guests of the Sunday Club. In the fall we entertained Mr. Wedel, National Secretary of

Student Work. At Thanksgiving the Reverend and Mrs. Wilson of Bryan and six cadets representing the Episcopal Club of A. & M. were invited to a morning dance and luncheon. At this time mothers and fathers from several parishes in the State joined our group.

Coöperative relations with the student work at All Saints, and with the parish have continued. Girls at Grace Hall serve as the Altar Guild the third Sunday of each month. Their activities also include teaching Sunday School and singing in the choir. A Grace Hall girl was presented for confirmation with the spring class. The annual parish dinner at which Bishop Quin was the guest speaker was held at Grace Hall during November. All Saints Sunday School Christmas party was given here for the third time. Residents furnished a tree for the children, gave toys, and assisted in receiving and entertaining the group. The girls enjoy the Sunday Club meetings at Gregg House and attend student services at the Chapel. In every way we are aiming to make Grace Hall an integral part of the Church's program, and an aid to the student work here at the University of Texas.

One of the happiest results of the year 1934 is shown in the financial statement attached. We have been able to clear entirely our indebtedness to the Diocese. As we have sufficient applications to cover all vacancies for the spring term, the deficit of \$1,900.91 quoted in the accompanying financial report will be taken up on the receipt of the spring term payments in February and it is anticipated all debts will be liquidated during the ensuing year.
