## REPORT OF THE THIRTY-FIFTH ANNUAL MEETING OF THE ASSOCIATED WOMEN OF THE DIOCESE OF TEXAS

Held in Palmer Memorial Church, Houston, January 20  
and 21, 1936, with Mrs. Thomas Rice presiding

The Annual Meeting of the Associated Women of the Diocese of Texas was held January 20, 1936, at Palmer Memorial Church, Houston. The president, Mrs. Rice, called the meeting to order at 9:30, with Mrs. H. N. Tinker leading the devotional, for which the Forward Movement was the subject. Mrs. Tinker very ably brought "Let Us Think About Church" before us and in a most graphic way likened it to a Body with Christ as the head, the most important part.

Words of greeting were extended to the ladies by Mrs. Neville, representing Palmer guild.

After the reading and acceptance of the minutes of the Annual Meeting in Waco, Mrs. Rice, the president, announced the program committee as committee on dispatch of business, as follows: Mesdames Quin, Catlin, Adamson, Flanagan, C. C. Womack, Randolph Bryan. Mrs. Womack announced the program and it was moved and seconded that program be carried out as planned by the committee.

Mrs. Olivia Fuller, of Houston, next spoke on "If We Be His Disciples, What Then?" which was a most inspiring talk as well as practical Christianity. Mrs. Fuller very clearly showed that Christians should connect up their religion with their personal life and ought to take it into such questions of the day as racial, political, international and economic.

Roll call was then made with 42 parishes and missions answering.

Mrs. Dalrymple, chairman of Ditty Bags, reported that 505 bags had been sent to Port Arthur and Houston, and very appreciative letters had been received from both institutes. She was very much pleased to report that she had received more than was asked for,—a very gratifying thing!

Rev. Mr. Gibson, of Galveston, chairman of the Camp Allen Committee of the Department of Religious Education, spoke of "Proposed Camp Allen Cabins," which

are sorely needed for the convenience of adult campers. Six one- or two-room cottages are needed and it was thought that during the nine months when Camp Allen was not in session they could be used by Diocesan families. After the talk about the cabins it was moved and seconded to put \$500 as a minimum and Mrs. Newell and Mrs. Pauls were the committee to work out a plan of collecting the money. It was thought proration was the best method.

Motion made and seconded to name the first cabin "Bishop and Mrs. Quin's."

Mrs. Cavin, of Grace Hall, Austin, deserves a great deal of credit. She reported that there are 65 girls there, with 25 of our church girls, all active in All Saints. All debts are paid and \$1800 has been cleared.

Mrs. Catterall, chairman of Isolated, reported that her Church School by Mail was growing and the adult work was most gratifying.

Mrs. Pauls, treasurer, filed report and a letter was read from Mr. Kellner that books had been audited and found correct. The secretary was instructed to write a note of thanks to him for his gracious service.

The Resolutions Committee was named as follows: Mrs. J. B. Dobbins and Mrs. Sydney C. Collin.

Mrs. Quin led the noonday prayers after which the meeting adjourned for lunch at Trinity Church.

The women met in study groups after lunch, each lasting an hour and a quarter. They were President's group, United Thank Offering, Supply, Christian Social Service, Religious Education and Parish. After the study groups there was a joint session for forty-five minutes, then the women reconvened. Mrs. Cudlipp read the memorial and prayer for those gone into the life of higher service.

The interest shown in the study groups was very great and they proved very worthwhile.



Mrs. Hubbell brought out the fact that the United Thank Offering was larger and that the spiritual interest was greatly improved and that there was a real sense of joy in her heart over the results.

Mrs. Windham, chairman of the Book of Remembrance, reported that there was an increase last year in parishes participating in St. Mark's Day celebration.

Mrs. Tilson, chairman of new members, reported that 277 had been added.

The meeting adjourned for the day.

The Tuesday morning session was opened with a hymn and Mrs. Carlisle led the devotional.

Mrs. Womack, chairman of Dispatch of Business, reported that order of business should be followed.

The secretaries made their reports which were filed.

The Nominating Committee reported that the following women had been elected :

Mrs. Allen, Spirit of Missions chairman, asked that it be given more publicity and that the rectors talk about it.

The Amended Constitution and By-Laws was presented and it was moved and seconded to adopt same with corrections as made. Carried. Filed.

A letter was read from Mrs. Carlisle, resigning as vice-president of the Executive Board. The Council voted to accept the resignation with regret.

### MADAM PRESIDENT AND WOMEN OF THE DIOCESE:

The Executive Board of the Associated Women of the Diocese of Texas, affiliated with the National Council through the Woman's Auxiliary, held its quarterly meetings during 1935 and, through the loyal and earnest efforts of the members, much work has been accomplished.

The Board in 1935 has done much under the gracious and efficient leadership of Mrs. Rice, its president. Its biggest task was the work on the Amendments to the Constitution and By-Laws and the findings of the Questionnaire at last Council, which resulted in the knowledge that only about one-half of the women workers are communicants.

Another change was to set St. Luke's Day, October 18, as the Fall United Thank Offering Corporate Communion.

Mrs. Posey, whom the Board shall miss very much, has finished a very successful year as Supply Secretary. All assignments have been filled and several new branches have asked to share in the work.

Mrs. L. T. Hubbell, United Thank Offering Treasurer, has carried on the work in a most consecrated manner and looks forward to a bigger and finer triennium.

There is no finer work done than that of Mrs. Catterall, Chairman of the Isolated. Her Church School by correspondence has grown and she hopes will continue to do so.

Mrs. Catlin, who during the year was elected Educational Secretary, has done a splendid piece of work. She sent out suggested programs and has been most interested in building better programs.

Mrs. Tilson, New Member Chairman, has been most faithful and efficient, and has reported 97 new members through the year.

Miss Helen Lyles, a recipient of the Minnie E. Taylor Scholarship Fund, has completed her training and has accepted a position in the Diocese of North Texas. Vera Gang (colored), the other recipient, will complete her training this year at the Bishop Tuttle Training School, Raleigh, North Carolina. The Board has been very much pleased with the work done by these young women and wish Miss Lyles God's blessing in her work.

Mrs. Allen, chairman of Spirit of Missions, has been most energetic and untiring in her work. She hopes that 1936, being the Centennial Year of the magazine, will bring renewed interest.

Miss Giesecke, Recruiting Chairman, reported much progress in the Y. P. S. L. and the Church School groups. Under her capable leadership these young people do and accomplish things.

# BOOK OF REMEMBRANCE AND BISHOP KINSOLVING SCHOLARSHIP

## MADAM CHAIRMAN AND ASSOCIATED WOMEN OF THE DIOCESE:

We are glad to report an increase in names received, gifts, offerings from St. Mark's Day Services and the number of parishes participating in these services.

As usual letters were sent to each clergyman in the Diocese asking him to hold a Communion Service on St. Mark's Day in memory of Bishop Kinsolving. A list of the parishes participating in this service is as follows: Trinity, Houston; St. James, Taylor; St. Georges, Port Arthur; St. Pauls, Waco; St. Marys, Lampasas; Epiphany, Burnet; Epiphany, Calvert; St. Marks, Beaumont; Calvary, Richmond; All Saints, Austin; St. Johns, Columbus; Christ, Eagle Lake; St. Pauls, Navasota; St. Stephens, Houston; Grace, Georgetown, and St. Davids, Austin. We hope this number will increase more and more until this memorial service is generally observed throughout the Diocese.

Pilgrimages were made to the Church of the Redeemer, Houston, and to Camp Allen, for the Adult Conference. We were much gratified at the interest manifested at the conference and the fine offering which was made on this occasion will be used for the maintenance of the Book of Remembrance.

The \$1,000 gold bond, which was purchased from the West Securities, in July, 1930, matured July 1, 1935, and this money was deposited in the savings account at the Second National Bank, Houston, until such time as it can be invested advantageously. The total in the savings account is \$1,730.79.

The fire insurance policy for \$1,000 was renewed.

The interest from our investments of \$2,000, amounting to \$120, was paid to Mr. J. Cooke Wilson, for the Bishop Kinsolving Scholarship.

Nineteen (19) names were received making a total of 289.

## REPORT OF WORK DONE FOR ISOLATED CHURCH MEMBERS IN THE DIOCESE OF TEXAS DURING THE YEAR 1935

The present organization has completed two years of work under the auspices of the Bishop, the Diocesan Department of Christian Social Service and the Associated Women of the Church in the Diocese.

There are 71 names on the list, most of them representing families of from two to six people.

There are 27 children in the Church School by Mail. We use the Christian Nurture Series of lessons, supplemented by instruction and question sheets printed in the Diocese of New Hampshire. There are 2 in pre-school course, 9 kindergartens, 6 intermediates, 8 juniors and 2 specials.

There are two lending libraries—for adults and for children. The *Texas*

*Churchman* and Forward leaflets are sent to every family, also special leaflets, greeting cards and Bibles and Prayer Books when desired.

Bishop Quin has offered us a scholarship for Camp Allen.

Recently this work was transferred to the Department of Missions and Church Extension; Rev. Everett L. Jones, of Waco, chairman.

Expenses were paid by appropriations from Department of Christian Social Service, \$10.00; Associated Women of the Church, \$19.40, and other contributions. Respectfully submitted,

## CONSTITUTION OF THE WOMAN'S AUXILIARY IN THE DIOCESE OF TEXAS

### ARTICLE I—*Name*

The name of the organization shall be The Associated Women of the Church in the Diocese of Texas; affiliated with the National Council through the medium of the Executive Board of the Woman's Auxiliary.

### ARTICLE II—*Object*

The object of this association being committed to the building of the Kingdom, is to aid the National Council in the work of the Church, in all departments, and in the five fields of service; the parish, community, diocese, nation, and the world.

### ARTICLE III—*Membership*

SECTION 1. Any woman or girl in the Diocese serving the Church may become a member of this association.

SEC. 2. The members of this association in a parish or mission together with such other women as are willing to co-operate shall constitute a parish or mission organization.

SEC. 3. Any group of women approved by the Executive Board, and the Bishop, may coöperate in the work of this association.

SEC. 4. Each organization or coöperating group shall make an annual report to this association.

### ARTICLE IV—*Officers*

The Officers of the Organization shall be a President and Vice-President, a Vice-President for each Convocation, a Recording Secretary, a Treasurer, a Corresponding Secretary, an Educational Secretary, a Supply Secretary, a Secretary to the Isolated, a United Thank Offering Treasurer, and the following appointed chairmen: Guilds, Social Service, Altar Guilds, Choir Guilds, Circles, and such organizations of women; Girls Friendly Society, Church Periodical Club, Young People's Service League, Membership Chairmen, Minnie E. Taylor Memorial Fund, Prayer Partner Chairmen, and Chairmen for Spirit of Missions, Diocesan



Budget, Church School Committee, Bishop Kinsolving Memorial, and such others as may be found necessary.

SEC. 2. The Officers shall constitute an Executive Committee to transact business of the branch when not in session.

SEC. 3. The Treasurer's books must be audited at least ten days before the annual meeting.

#### ARTICLE V—*Meetings*

SEC. 1. The annual meetings of the Texas Organization shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Executive Committee.

SEC. 2. The election of Diocesan officers shall be held at the annual meeting by ballot. Each parish or mission is entitled to one vote for every twenty-five members or less. If there are more than fifty members, the organization is entitled to two more delegates. These delegates should be elected at the annual parish meeting or at a general meeting of the women's organizations.

SEC. 3. A committee on Nominations, consisting of three members, shall be appointed by the Diocesan President two months prior to the annual meeting.

#### ARTICLE VI—*Amendments*

This Constitution may be amended at any annual meeting by two-thirds vote of delegates present; provided the amendment or amendments be submitted to each organization two months before the annual meeting.

### B Y - L A W S

#### ARTICLE I—*Duties of Officers*

SEC. 1. It shall be the duty of the President to preside at all meetings and to perform all other duties appertaining to the office.

SEC. 2. It shall be the duty of the Vice-President to act in case the President is unable to serve.

SEC. 3. It shall be the duty of the Vice-Presidents of the several convocations to coöperate with the President in all Diocesan work, and to have general supervision of the work, each in her own convocation.

SEC. 4. The Recording Secretary shall keep a record of proceedings of all meetings, and prepare an annual report, and in the absence of the President and Vice-President shall call the meeting to order and act until a chairman is elected.

SEC. 5. The Corresponding Secretary shall give notice of all meetings both of the Association and of the Executive Committee and shall conduct a general supervision of the correspondence of the organization. She shall keep a record of the parish women's organizations and the officers thereof. She shall send to each parish president, one month before the annual meeting, three copies of the itemized report sheet. Two copies should be returned, when filled out, to the Diocesan President, by January 5; one copy to be retained by the organization.

SEC. 6. It shall be the duty of the Educational Secretary to have general supervision over the educational work of the women's organizations of the Diocese; to secure the names of leaders of religious education study in each parish organization.

SEC. 7. The Supply Secretary shall assign list of boxes obtained from Church Missions House to the various parishes and missions; shall have charge of preparations of any Diocesan box and shall present the combined report of all parish box work.

SEC. 8. The Treasurer shall take charge of all moneys, except United Thank Offering, disburse same according to instructions and shall give annual report at the regular meeting.

SEC. 9. The United Thank Offering Treasurer shall furnish the offering boxes, leaflets, and bring to their attention in other ways the purpose of United Thank Offering. She shall keep a list of contributors and make a semi-annual collection, and put these amounts out at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready, together with its accumulated interest, for presentation at the Triennial session of the Woman's Auxiliary.

SEC. 10. The Secretary to the Isolated shall secure the names of Church women



within the Diocese, who are not affiliated with any parish or missions, and endeavor to relate them through prayer and service to the work of the Church.

SEC. 11. The Executive Committee shall have power to fill vacancies in its own body between regular elections.

SEC. 12. Each Diocesan Officer shall make a report of her work at the annual meeting.

SEC. 13. All books should be closed December 31, and the reports should be in the hands of the President by January 5.

#### ARTICLE II—*Dues*

SEC. 1. Operating expenses of this association shall be met by an annual appropriation from each parish organization of women, the amount to be apportioned according to the number of members; or as near thereto as is possible. This shall be known as the Maintenance Fund.

SEC. 2. Each organization shall contribute in proportion to its desire, to the pledges of this association, for missions, religious education and social service; and to such other objects as may be recommended by the Executive Board, or at the annual meeting. This constitutes the budget.

SEC. 3. There shall be a Finance Committee composed of the President, Treasurer, and one other appointed by them, to prepare the budget and to decide upon the tentative apportionment for each parish organization.

#### ARTICLE III—*Meetings*

The Executive Committee shall meet quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President, or by written request of two members of the committee.

#### ARTICLE IV—*Election of Officers*

SEC. 1. The election of Officers to be held at the annual meeting by ballot, a majority of votes cast being necessary for the election to office.

SEC. 2. (A) A Nominating Committee shall be appointed at the October Executive Board meeting to prepare the ticket.

(B) The election shall be held at the annual meeting.

SEC. 3. The term of office shall be three years. No officer shall serve more than two consecutive terms.

SEC. 4. Officers shall be elected in the following groups:

(A) President, Vice-President, Secretary to the Isolated, Recording Secretary, Educational Secretary.

(B) Vice-President of Northeastern and Southwestern Convocations, Corresponding Secretary, Treasurer.

(C) Vice-President of Northwestern and Southeastern Convocations, Supply Secretary, United Thank Offering Treasurer.

#### ARTICLE V—*Quorum*

One-fourth of the members having a right to vote shall constitute a quorum at the annual meeting. Seven members shall constitute a quorum at the meeting of the Executive Committee.

#### ARTICLE VI—*Elections*

SEC. 1. The election of Parish Officers shall be held at the meeting preceding the annual meeting and the Corresponding Secretary shall be notified at once of the names and addresses of the new officers for insertion in the Year Book.

SEC. 2. At the annual meeting preceding the Provincial Synod, three delegates and three alternates shall be elected. This election shall be by ballot. In case the elected delegates or alternates are unable to attend, the Diocesan President shall, with the Bishop's approval, appoint women to act in their stead.

SEC. 3. At the annual meeting preceding the Triennial, five delegates and five alternates shall be elected. This election shall be by ballot. In case the elected delegates or alternates are unable to attend, the Diocesan President shall, with the Bishop's approval, appoint women to act in their stead.

#### ARTICLE VIII—*Amendments*

These By-Laws may be amended or suspended by a two-thirds vote at an annual meeting, providing notice is given of the proposed amendment or amendments at a previous meeting of the Executive Committee.
