Amen.

Bishop Quin's Prayer

Dear Heavenly Father, we ask Thy blessings upon the women of the Church in this Diocese, united in Thy name and for Thy sake.

Give us a sense of reality when we say, "Thy Kingdom come," and guide us to our part and share in the bringing in of that Kingdom.

We offer unto Thee anew each day our souls and bodies, a living sacrifice.

To the Associated Women of the Church in the Diocese of Texas:

In spite of the handicaps of travel, tire and gas rationing, and the many additional burdens that Church Women are carrying since our last Annual Meeting, it is gratifying, indeed, to be able to report that the work of the Women in the Diocese of Texas has gone steadily forward during the past year.

As your President, I have presided at the four regular meetings of the Board. The average attendance was 80%, which fact alone speaks volumes for the earnestness and devotion to duty of your Diocesan Officers.

At the invitation of the Rev. Mr. Sumners, and with the Bishop's approval the May meeting of the Board was held in Austin and was attended by members of both the local Parishes and visitors from surrounding towns.

I have attended all but one meeting of the Department of Missions and have also attended meetings of the Budget, and Constitution and By-Laws Committees.

It has been my privilege to attend Convocation and Area meetings in Port Arthur, Navasota, and at St. Paul's, Park Place, and the annual meeting of the women of St. Mary's Bellville.

This year, we were represented at the Provincial Synod by three delegates and at the Conference of Christian Social Relations by one delegate.

Blanks for the yearly report were sent to each Parish President early in December, and a letter reviewing the year's work, and calling special attention to the most important aspects of that work was written to each President at the same time.

We deeply regret the resignation of two of our members this year. They are: Mrs. E. V. Gross, Publicity Chairman, and Mrs. Baker Duncan, Vice President of Northwest Convocation. Mrs. Roderick Montgomery of Trinity Church, Houston, has succeeded Mrs. Gross, and we are most happy to have her on the Board. We ask your continued cooperation with her in her efforts to publicize the work of the Women of the Diocese via the medium of "The Texas Churchman."

During the past year we have lost by death two former members of the Board. They are Mrs. E. H. Catlin and Mrs. Virginia Warfield. May God give us grace to follow the good examples of these who have served Him and are now at Rest.

Recognition of the value of the work of the Diocesan Officers was acknowledged at the Clergy Conference in September by Bishop Quin and the assembled Clergy when one hour of their time was given to several members of the Executive Board to present an outline of the Women's Program with special emphasis on the work of the U. T. O., Supply Department Rural Education Ditty Bags, Church Periodical Club, Christian Social Relations, the Educational Chairman, and the Unified Program in general.

We are grateful for this opportunity, and judging from the question and answer period that followed we feel that we have made decided steps toward greater cooperation between the Clergy and Diocesan Officers.

This report rounds out my three years of service as President of the Associated Women of the Church in the Diocese of Texas, and I cannot bring it to a close without a word of humble gratitude.

It has been an honor to serve as your President, and I am deeply grateful to the members of the Executive Board for their loyalty and unfailing help, and to every woman in the Diocese for her confidence and cooperation.

This has been a busy year, and the years ahead are going to be busier and harder. May we be given the strength and the grace to meet each day with renewed determination and zeal; and with God's help we shall continue to go "Forward in Service."

He exhibited the portable altars used by the Chaplains, also the silver Church Cross given to all boys in the service.

All the Associations had an organized plan of study for the year. Most of them were following suggestions from the Department of Education. Many studied "Christian Roots in American Democracy" by Arthur E. Holt. Some began the studies on South America.

CHRISTIAN SOCIAL RELATIONS WOMEN'S REPRESENTATIVE

Your representative on the Diocesan Department of Christian Social Relations reports as follows:

In January, I attended in Oklahoma City the Provincial meeting of the Department of Christian Social Relations called by the Rev. Dr. Almon R. Pepper, Executive Secretary of the National Department. We attended meetings for two full days. Dr. Pepper discussed with us the program of the Department of Christian Social Relations of the National Council. I returned and prepared for you a two years' suggested program, covering the part of the program that your Diocesan Department thought could be executed in the Diocese of Texas.

We prepared and mailed 150 copies of this suggested program to all the parishes

and missions and to the members of the Executive Board of the Associated Women. Special mention of the program was made in the Bi-monthly Bulletin of the National Department by Dr. Pepper.

From this program came many inquiries concerning the legislative suggestions. We then prepared a bulletin explaining each legislative objective and sent 1,150 copies of them to all churches in the Dioceses of Texas, Dallas, West Texas and District of North Texas, to our state legislators and Governor. Many letters have been received promising the support of these measures at the next legislature.

We are urging all women of the Diocese to write to their lawmakers to vote for these measures when they are presented for passage. Mrs. Violet Greenhill, Chief of the State Child Welfare Department, is sponsoring all of these measures. *We are helping her* with our letters and cards to do something that is needed very badly to help the work of the Child Welfare Department.

I have made 42 calls to Army Hospitals, taking flowers and then sending sick cards to all Episcopal boys in the Houston area that I could contact. I have also asked Houston clergy to call on these boys. Your Chairman asked Houston churches for games for the sick at Ellington Hospital. The response was splendid. I took 6 car loads of books and magazines to camps.

The Department gave your Chairman \$50 to buy games and cards to place on troop trains and boats. The boys were delighted to have these gifts. It is a long way across the water with only a deck of cards or two to while away the time.

The Executive Board of the Associated Women gave your Chairman \$75 to purchase a portable altar for an outpost. A bronze plaque was given us to place on the altar, reading "To the Glory of God"—The Associated Women of the Diocese of Texas." Some day we may hear where this altar was used.

I have carried the work of the Department to Bellville, Eagle Lake, Port Arthur, and in Houston, to Trinity Church, Good Shepherd, St. Mary's, St. James', and St. Paul's.

Your Chairman is a member of the Army and Navy Commission of the Diocese and as such went to Alice, Texas, and spoke on the work that is being done in the Diocese of Texas. I have given 50 Prayer Books and War Crosses to soldiers and WAACS, 17 in Dallas to WAACS on their way to a training center.

With several other members of the Executive Board, I attended the Clergy Conference at Camp Allen and spoke on the work of the Department of Christian Social Relations.

The Department offered the following Resolution at the last meeting of the Executive Board of the Associated Women:

Resolved: That the Executive Board of the Associated Women of the Diocese goes on record as approving the plan of the Department of Christian Social Relations to bring to the attention of the Executive Board of the Diocese the fact that Church workers within parishes and missions of the Diocese have no Social Security or Retirement Protection; therefore it is urged that necessary steps be taken to correct this injustice.

The Rev. Mr. Riemann, Chairman of the Department, will present the Employees Retirement Plan of the Church Life Insurance Corporation at the Diocesan Council.

EDUCATIONAL CHAIRMAN

During the year 1942, continued emphasis has been placed on the value of regular well planned educational programs for women's groups. On the recommendation of the National Educational Secretary, Miss Avis Harvey, particular emphasis has been placed on the theme *Freedom Through Christ*. This theme includes the four subjects which

the entire Church has been asked to study by the Forward in Service Commission, namely: "Bases for a Just and Durable Peace," "Christian Family Life," "Race Relations", and "Latin America."

A circular letter was sent to the educational chairman or president of women's groups in every parish and mission in the Diocese with this information and

instructions as to ordering necessary material.

Visits have been made, when requested, to women's meetings held in numerous parishes and missions and talks made on all phases of women's work in the Church. Requests for information and for educational materials have been answered by mail and many personal conferences have been held with the educational chairman or president of women's groups.

Books and pamphlets necessary for the use of chairmen in promoting educational work have been procured from the funds allotted for this purpose. These materials will form part of the permanent Diocesan Library and may be borrowed on request of parish and mission educational chairmen.

I have attended all Executive Board Meetings of the Associated Women, served as a member of the program committee for the Annual Meeting, and attended the Forty-first Annual Meeting held at the Council in Waco.

As your representative on the Department of Christian Education, I have attended all of the meetings of the Department, served on the Committee to plan the Diocesan Mite-Box Presentation Service, and attended that service held in Bryan.

I attended the Church School Workers' Conference sponsored by the Department and held at Camp Allen in August, and led a discussion for teachers of the junior age group on Methods and Materials.

Two meetings of the Diocesan Committee on Cooperating Educational Centers were attended. Dr. D. A. McGregor, Chairman of the National Department

of Christian Education, was present at one, and Miss Charlotte Thompkins, a member of his staff, at the other. The work at the center for this Diocese, Trinity, Galveston, is progressing satisfactorily, and a second center is to be established soon in a smaller parish in the Diocese.

At the request of the Chairman of the Department, I spoke to the 1942 Clergy Conference on the *Opportunities Offered to the Diocese by the Department of Christian Education*.

Also, as a representative of the Department, I attended a meeting of the United Christian Education Advance—an interdenominational project held under the auspices of the International Council of Religious Education.

I have kept in constant touch with the members of the Diocesan Educational Committee and appreciate, more than I can say, their co-operation.

In closing, I would like to repeat the last paragraph of my 1941 report:

"Realizing that educational work functions not as a separate unit in women's work, but runs as a thread through the fabric of the whole structure, the members of the Executive Board of the Associated Women and members of the Department of Christian Education are untiring in their efforts to take advantage of every opportunity to further the educational phase of our women's work. For the share that I have had in working with them and with each one of you, I am deeply grateful."

RURAL EDUCATIONAL CHAIRMAN

In January a new feature was begun: The mailing of "Home Prayers" once a month, except the three summer months, to the Isolated in the Diocese. "Home Prayers" is a mimeographed sheet, written by the Rev. Allen W. Clark, of Calvary Church, Danvers, Mass., and sent out under the auspices of the Province of the Northeast. Each copy consists of a Bible Reading Reference, a 300 word sermon, and a closing prayer. A number of the Isolated have written appreciatively of this service, and the plan is to continue it.

The Forward Day-by-Day booklets were mailed regularly during the year to the

Isolated. For the past three years the cost of the booklets has been a contribution from Miss Maude Dixon of Christ Church, Houston.

In September, a nine months' supply of Church School material (Christian Living Series) was sent to eight Isolated children. One of the girls who has received this material the past three years is now teaching younger children in one of our Mission Churches.

During the year contributions for the United Thank Offering were received from three Isolated women.

At Christmas checks for \$2.50 and \$3.00 were received from two Isolated

women, expressing their appreciation of the contact they have with the Church through this department. One of these women wrote that she planned to make regular contributions in the future.

Total expenditures for the year, covering stationery, postage, Church School

material, Home Prayers, amounted to \$44.10.

Gross, I have written a letter to the Rector, or the Priest in charge, or to an interested and responsible lay person in every parish and mission in the Diocese, asking for the appointment of a reporter for the Texas Churchman. Of seventy-eight persons addressed, thirty-five have replied, furnishing names and addresses of regular reporters. I then wrote to these thirty-five reporters, and readdressed the clergy who had not replied, asking specifically for the sort of news suitable for the report of the women's work, published monthly in the Texas Churchman. Those who have replied have sent in much excellent and newsworthy material, and it is hoped that the others will follow suit.

I have written an article for the "Texas

Churchman" each month, combining as much of the news received about the women of the Diocese as it is possible to include in so limited a space as has been at our disposal. If the space be granted us, with the adoption of a new budget, we shall hope to have a whole Women's Page as a regular feature of the Churchman. It is devoutly to be hoped that such funds will be available. Free communication and exchange of ideas between small and large parishes, between rural and urban churches, lead to a lively interest, and to a broader sense of fellowship and responsibility among the sometimes widely separated, even isolated, readers of our Diocesan paper.

REPRESENTATIVE YOUNG PEOPLE'S WORK

As your representative for Young People's Work on the Executive Board of the Associated Women, the Adviser in Christian Education reports as follows:

I attended all meetings of the Executive Board, and the Diocesan Council at St. Paul's, Waco. A report was submitted at each meeting on the activities sponsored for the youth of the Diocese by the Department of Christian Education.

It is hoped that behind the words and figures contained herein may be visualized the real values that have come to boys and girls, to their leaders, and to the Diocesan life. The women of the Church through their cooperative and loyal efforts have had a large share in making these values possible. To them we express our appreciation.

An over view of the most important meetings and conferences for youth and their leaders will indicate how the Department has sought to fulfill its responsibilities to young people. The list includes:

An all-day meeting of the Diocesan Church School Commission for the purpose of giving such guidance as was needed to projects for the Church Schools.

A meeting of the Lenten Offering Committee to outline the promotional program and to plan the 1943 "Guide for Church School Leaders," a booklet for teachers, and a printed bulletin to be distributed to every Church School pupil.

Fifth Annual Conference of Church School Workers at Camp Allen. Attendance 78, representing 20 Church Schools. Discussion of practical methods and materials, through group conferences, proved particularly helpful to the workers.

Fifth Diocesan Festival Service for the Presentation of the Lenten offering. Attendance in spite of rubber shortage—200, representing 25 Church Schools. The total Lenten Offering was \$4802.89, which was \$388.53 less than that of 1941. 12 schools increased their offering 20% or more, 12 others showed some increase, 3 remained the same, and 27 had a decrease. A good educational program was carried on in most of the schools through the suggestions and helps offered in the "Guide for Leaders."

Two all-day meetings of the Young Churchmen's Executive Board with 75% of its members present at each meeting. The program for the Sixth Annual Council and activities for the year were planned.

Seven area meetings for Young Churchmen. The theme was "Forward in Prayer and Worship," with special emphasis on the Rule of Life. Attendance—322, representing 38 churches. Seventy-two more personalities were touched this year than in 1941 when Convocational meetings were held.

A Negro Young Churchmen's Rally, which used the same theme and schedule as the area meetings. Attendance—15, representing 3 missions.

Sixth Annual Council of Young Churchmen at Camp Allen. "The Challenge of the Crisis to Christian Youth" proved to be a timely and excellent theme to stimulate and guide the thinking of the young people. Attendance—209, representing 23 parishes, 10 missions, and 92 youth groups.

Five camps and conferences at Camp Allen: Junior Boys' and Girls' Camps, Young Adult's Conference, the Church School Workers' Conference, and the new venture of a Young People's Conference. 271 campers and leaders shared in the splendid program of the summer.

"The Guide Lines for a Parish Educational Program," published by the National Council, was used extensively as the basis for determining courses and activities for Church Schools throughout the Diocese. The Birthday Thank Offering showed an

increase of \$55.25 over 1941 and totalled \$175.20 from 27 Church Schools. On the basis of the assignment from National, the Christmas Box project went "over the top" again:

The Department has continued to emphasize the program of the United Movement of the Church's Youth and has publicized through meetings, letters, and "The Texas Churchman": The Rule of Life, Whitsunday Corporate Communion for all confirmed young people, Youth Sunday Observance and the Youth Offering. The response to all projects except the Youth Offering has been gratifying. Only 11 churches shared in the offering as compared with 20 last year. The total offering was \$125.12, or \$46.60 less than in 1941. Congratulations are extended to the young people of Christ Church, Houston, for their offering of \$43.44.

The Rev. P. W. Henckell was appointed recently as chairman of the Youth Commission, which will meet in January to plan an intensive and extensive interpretation program for the activities of the Young Churchmen and the United Movement of the Church's Youth. To further its purpose, the Commission will help also to expedite the program planned by the Young Churchmen's Executive Board to carry forward its work among young people.

Three-day Leadership Training Institutes were conducted for the Church School workers of St. Mark's, Beaumont, and St. Mark's, West University Place. Two to three days each were devoted to the educational programs of Trinity, Galveston, Christ Church, Tyler, and St. Paul's, Waco. The discussion of methods and materials with the Rectors, Church School Superintendents, teachers, youth workers, and other leaders was carried on through group meetings and personal conferences.

1942 showed a marked seriousness about the work done in Christian Education by youth and adults alike through their churches and in connection with the Diocesan program. This same seriousness characterized meetings, and conferences, resulting in the increased effectiveness of programs.

FORTY-SECOND ANNUAL MEETING

MINUTES

The Associated Women of the Church in the Diocese of Texas met in Annual session January 26, 1943, in Houston, Texas. The meeting opened at 11:00 a. m.

Mrs. W. E. Japhet, President, called the meeting to order in the Guild Hall of Christ Church, Houston, Texas.

After the opening hymn, "Rise, Crowned with Light," greetings were extended from the Houston Churches by Mrs. A. Balfour Patterson of Christ Church.

The following announcements were made: that Mrs. George D. Wilson would

act as Chairman of Dispatch of Business; Mrs. T. W. Sumners would be the pianist; and that Mrs. John McWhirter, Mrs. Carrol Winston, Mrs. Peggy Weaver, Mrs. Joseph Lockett, Mrs. C. A. Russell, Mrs. C. J. Mullings, Mrs. Henry Brant and Mrs. J. C. Hines would be the pages.

The News sheets and reports of the Executive Officers were distributed to the delegates and visitors.

The Diocesan Officers were introduced.

Mrs. H. F. Selcer, Trinity, Marshall, was appointed Courtesy Chairman.

Mrs. C. H. Stevens, Rural Education, called attention to the poster on Rural Education.

The Noon-day Devotionals were given by Mrs. Charles S. Sumners, St. David's, Austin, Texas.

The meeting then adjourned to meet again promptly at 2:00 p. m.

Tuesday Afternoon, January 26, 1943

The afternoon session of the Associated Women of the Church in the Diocese of Texas, was called to order at 2:00 p. m. by the president, Mrs. W. E. Japhet.

The meeting opened with prayer led by Mrs. Earl Milstead, St. David's, Austin, which was followed by the hymn, "O Sion, Haste, Thy Mission High Fulfilling."

Roll call revealed 85 delegates and 58 visitors present, representing 26 parishes and 8 missions.

Mrs. H. K. Arnold, chairman of the Constitution Committee, presented the following changes in the Constitution and By-laws:

Article I—to include both name and object. Section 1 being name and Section 2 being object. Motion made, seconded, and carried that the change of Article I be accepted.

Article II—MEMBERSHIP—to include a statement of what constitutes good standing as a parish or mission organization. Mrs. Gates moved the adoption of the changes in Article II. Seconded, motion carried.

Article III—OFFICERS—to combine the office of Recording Secretary and Corresponding Secretary, and to include as elected officers all the Chairmen of standing committees, already outlined in the Year Book, with the addition of a chairman of a Permanent Nominating Committee. The immediate past-president is included as a member of the Executive Board. Motion made and carried that the changes in Article III be accepted.

Article IV—MEETINGS—Section 4, to state that members of the Executive Board shall be entitled to vote at the Annual Meeting. Motion made and carried that changes in Article IV be accepted.

BY-LAWS

Article I—Duties of Officers.

Section 19—The members of the National Council, the wife of the Bishop, and the past president shall serve in an advisory capacity on the Executive Board.

Article II—Dues.

Section 3—Change the Finance Committee so that it shall be composed of the President, the Treasurer, and the four Convocational Vice-presidents.

Article IV—Election of Officers.

Section 3—Change the groups as follows:

- (a) President, Vice-president, Educational Chairman, Church Periodical Club Chairman, Nominating Chairman, Publicity Chairman.
- (b) Vice-presidents of the Northeast and Southwest Convocations, Secretary, United Thank Offering Treasurer, Treasurer, Rural Education Chairman, Ditty Bag Chairman, Devotional Chairman.

- (c) Vice-presidents of the Northwest and Southeast Convocations, Supply Department Chairman, Camp Allen Chairman, Bishop Kinsolving Memorial Fund Chairman, Christian Social Relations Chairman.

Article VII—Amendments—Add Roberts Rules of Order to be used as the authority on procedure.

A motion was made and carried, that the changes in the By-Laws be accepted.

The hymn, "Come, Gracious Spirit" was sung.

Report of the Budget Committee was given by the Chairman, Mrs. A. J. Dow, when the Budget for 1943 was presented as follows:

Mrs. Dow reported that at the Executive Board meeting, it had been voted to send \$100.00 to the Presiding Bishop's Fund for World Relief; \$45.00 toward the Bishop Rowe Memorial Fund for the building of a Diocesan House in Alaska; and \$500.00 for a handicraft building at Camp Allen. A motion was made and carried that the Budget, as presented for 1943, be accepted.

Mrs. Quin explained that in the Diocesan Budget, there is a fund for the expenses of 5 Clergy and Laymen, five women and three youth representatives to the Triennial and the Special Fund in the Budget of the Associated Women of the Church, helps with the expenses of the five women delegates.

Mrs. H. K. Arnold, Chairman of the Nominating Committee, presented the following names for election of Officers under Group A.

There being no nominations from the floor, Mrs. Gates made a motion that the nominations be closed and the report of the Nominating Committee be accepted.

Mrs. Coddou made a motion that the secretary be instructed to cast the vote for the officers as presented by the Nominating Committee. Duly seconded, motion carried.

The secretary cast the vote for the officers as presented by the Nominating Committee.

Mrs. H. K. Arnold, chairman of the Nominating Committee presented the following for proposed delegates to the Triennial:

The vote was cast by ballot and while waiting for returns, Mrs. Quin told of the plans for the Triennial Convention as prayerfully planned by the National Board.

Due to conditions, the time of the Triennial will be shortened to eight days, and since the government is using so many buildings and hotels, and the restrictions on travel, the number of persons attending the Triennial will have to be curtailed; hence, only the delegates will be received at the meetings, thus greater responsibility will be placed on each delegate to bring the most of the meetings back to the Diocese and Parishes.

Mrs. Robert Lester, Supply Box Chairman, told about the Supply Box on display, which is to be sent to the Indian Missions (St. Anne's, St. Mary's and St. John's). Atmore, Alabama.

Mrs. Gates told of the accident which had befallen Mrs. T. J. Windham, and asked that the secretary write a note of condolence to Mrs. Windham and that flowers be sent from this body.

Mrs. Selcer made a motion that a free will offering be taken for flowers for Mrs. Windham, whereupon, she amended the motion to be a gift instead of flowers. Seconded, the motion as amended, carried. Mrs. Gaines was appointed Chairman of a committee to purchase the gift.

Announcements were made regarding the meetings on Wednesday.

Mrs. Carl Smith, Church Periodical Club Chairman, explained the printed report and that a better report will appear in the year book due to more parish reports having been received.

Wednesday, January 27, 1943

The meeting of the Associated Women of the Church in the Diocese of Texas was again called to order at 9:30 a. m. by the President, Mrs. W. E. Japhet, in the Guild Hall of Christ Church, Houston.

The meeting opened with prayer by Mrs. Charles S. Sumners, St. David's, Austin.

The minutes of the afternoon session of January 26th, were read and accepted.

Mrs. C. S. Quin made a motion that the report of the balloting committee showing the result of the election of Alternates to the Triennial be included in the minutes of the previous afternoon session. Seconded, the motion carried and the names were inserted as read in the previous minutes.

Mrs. George D. Wilson, Program chairman, gave an outline of the program for the inspirational part of the meeting.

Devotionals were led by Mrs. Brady Cole, of St. Stephen's, Houston.

Mrs. Richard S. Watson, Trinity, Houston, gave a most timely and interesting talk on "What have we that we may invest for God?"—stressing the great need of investing ourselves for God through mind, body, and spirit.

Mrs. Percy V. Pennybacker, Jr., All Saints, Austin, held a discussion on the practical application of the theme, "Adjustments and Responsibilities in a Changing World," when different individuals reported on specific instances in their departments.

Mrs. Julia Coddou, chairman of the Christian Social Relations, told of the plans for the department. She reported on the favorable results of the meeting of the Texas Conference of Social Welfare, held recently, in Austin, when the eight legislative objectives of the department were endorsed by the A. A. U. W., American Legion, American Legion Auxiliary, Parent-Teacher Association Congress, Federation of Club Women, Bar Association, Junior League, County Judges and Commissioner's Association, League of Women Voters, Business and Professional Women, County Advisory Commission, and Texas Welfare Agencies. She stressed the very important resolution known as S. J. R. No. 3, which is a joint resolution calling for the submission on the proposed Constitutional Amendment giving the legislature "Power by general laws to provide under such limitations, restrictions and regulations, as may be deemed by the legislature expedient, legislation providing financial aid to dependent children to conform with the Federal Security Act in its present form." In other words, it is to ask for a Constitutional Amendment that the legislature may pass laws to insure this aid, just as we did for the Old Age Pension. She suggested that now was the time for each individual to write to their representative urging his support for this resolution S. J. R. No. 3.

Mrs. George D. Wilson outlined the plan of the educational program for the coming year. The women of all parishes and missions have been asked to co-operate through the study of the following four subjects:

Basis for Just and Durable Peace, Race Relations, Christian Family, and Latin America. The packets for these subjects of study may be obtained from the Department of Christian Education, 1117 Texas Avenue. Each Parish Educational Program chairman is asked to plan a definite program on each of the above subjects with individuals assuming their share in the educational work.

Incidents of practical applications of the Theme "Adjustments and Responsibilities in a Changing World" were cited by representatives of many parishes, St. Paul's, St. James', Palmer Memorial, Houston; St. Phillip's, Palestine, and All Saints, Austin.

Suggestions for material for study groups were made as follows:

Mrs. M. D. Gates recommended Pearl Buck's book, "America and the World Today"; Mrs. W. H. Hogue, the booklets on the follow up of the Malvern Conference and the Delaware Conference; Mrs. Pennybacker, "Christian Women in the Home" by Dr. Robert Sutherland.

Area Meetings, which develop greater fellowship and understanding, were discussed and substitutions for these were suggested; that we plan to visit other meetings when possible and that the Texas Churchman be used to promote programs in different vicinities. From this discussion came this one valued thought, that each individual budget her time considering the need of the Church first, relative to mind, body, and soul.

Mrs. Lee Dittert, Bellville, the newly elected Devotional Chairman, was introduced.

Bishop Quin blessed the Missionary Box on display, which is to be sent to the Indian Missions (St. Anne's, St. Mary's, and St. John's) Atmore, Alabama.

The Chairman, Mrs. W. E. Japhet, extended thanks and appreciation to the women of Christ Church for the lovely decorations of the Guild Hall.

Mrs. Eugene Haynie, St. David's, Austin, announced a History of St. David's had been compiled and that the books could now be purchased.

Mrs. H. F. Selcer, Trinity, Marshall, expressed appreciation of the body to the women of Christ Church and the Associated Women of the Church in the Diocese of Texas for the splendid and very interesting meetings.

The Forty-second Annual Meeting of the Associated Women of the Church in the Diocese of Texas was adjourned and dismissed with prayer by the Right Reverend Clinton S. Quin, Bishop of the Diocese of Texas.

I only hope that the thoughts of those whose books and articles I have read, together with my own thinking, may give us a springboard for discussing our problems of adjustments and responsibilities in this changing world.

This changing world—what a phrase! Events move so swiftly that we cannot say the words before another change has taken place somewhere. Is it any wonder that there is confusion in our minds when there is such confusion all about us?

Save! Invest! Do without! Do your part for the Red Cross—knit, sew, roll bandages, join the Motor Corps, the Canteen! Do your part for Civilian Defense! Entertain Service men! Join the WAVES, the WAACS, the WASPS! Plant a Victory Garden! Buy War Stamps and Bonds! Invest! All of this sound at home while the noise of bombs and battle comes to us over the air. The con-

fusion of sound is terrific. Where can we find some order out of this chaos?

"God is our hope and strength, a very present help in trouble."

The words of a very familiar hymn come to me:

God is working His purpose out
As year succeeds to year;
God is working His purpose out,
And the time is drawing near;
Nearer and nearer draws the time,
The time that shall surely be,
When the earth shall be filled with the
glory of God
As the waters cover the sea.

What can we do to work God's work,
To prosper and increase
The brotherhood of all mankind,
The reign of the Prince of Peace?
What can we do to hasten the time,
The time that shall surely be,
When the earth shall be filled with the
glory of God
As the waters cover the sea.

What have we that we may invest for God?

Let us try to be very simple and very realistic in answering that question. We have *ourselves* to invest for God—mind,

body, and spirit. If it is that simple, you are thinking, then why go any further? It isn't quite so simple if we face with perfect honesty the problems involved.

If we would invest our minds for God, what would we encounter? This is not just another war we are fighting; it is a world revolution—a social revolution—a people's revolution, in fact. Our old modes of thought are not adequate to fit the present pattern.

Where we once had a problem of race more or less limited to three areas in this country, the Negro in the South, the Oriental on the West coast, and the Indian on various reservations, now we have a world problem. Africa, India, the South Pacific, Alaska, China, Japan, Latin America—the problem covers the whole earth.

We still have our own racial minorities which are our immediate concern—13,000,000 Negroes limited in opportunity because of race, Japanese Americans, many of them Christian citizens as you and I are, interned because of race, to mention only two.

In her radio talk on "Undergirding the Racial Minorities," given in her series last year on "Women in a Changing World," Miss Edith Lowry says, "Still another group that is suffering intensely now because of misunderstanding is the European refugee. With the involvement of the United States in the war, the position of these newcomers who have not yet become citizens is difficult and trying and we recognize the problem the Government faces in these days of tension. Only in a land of Christian ideals could strangers take refuge as they have done. Technically they are 'enemy aliens' and yet, having suffered for the sake of the democratic way of life, they have even more zeal and passion to defend the democracy of America. Their foreign accent sets them apart and in these days of tension, suspicion surrounds them. The national agencies of the churches are trying to aid them but in our own communities they need our friendship and Christian love. . . .

"The history of racial minority groups is one of the most tragic pictures ever re-

corded and is a complete denial of the ideals of Christ. Because of race some are denied equal educational opportunities, recreational facilities and health services that we claim are essential to childhood. Because of race, full participation in community life and the use of the ballot are denied some citizens of America. Because of race, some citizens have been denied justice before the law."

In Sunday's *Houston Post* appeared this small article: "Archbishops Ask England to Give Jews Sanctuary."

LONDON, Sunday, Jan. 24.—(AP) The archbishops of Canterbury, York and Wales appealed to the British government Saturday "to give a lead to the world" by declaring its readiness to cooperate with the Allied and neutral countries in finding an immediate sanctuary for Jewish refugees from Axis countries.

"The bishops of England and Wales," the joint statement issued in the name of the whole Anglican episcopate said, "declare the sufferings of these millions of Jews and their condemnation, failing immediate rescue, to cruel and certain death, constitute an appeal to humanity which is impossible to resist."

Time Magazine of a week or so ago quotes Dr. McGregor of our own National Council in his address to New York clergymen:

"He offered an immediate three-point program: (1) the church must 'insist that there is a God who is the final authority over life'; (2) develop 'international life . . . by strengthening her missions work'; (3) 'find a new pattern of interracial relationships . . . Men and women of all races are one family in Christ.'"

News Week of January, 1943, gives an account of the organization of a powerful group of 38 Protestant leaders into the "Christian Conference on War and Peace." Our own Presiding Bishop Tucker is one of them. They announced a formation of principles backed by a program for action. One of their aims is "the elimination of race discrimination."

What can we do to work God's work,
To prosper and increase
The brotherhood of all mankind,
The reign of the Prince of Peace?

Let us take another look at what we encounter if we invest our minds for God. What of our economic problem?

I should like to recommend to you a series of books by Stuart Chase, the general title of which is "When the War Ends." Only two have been written so far, "The Road We Are Traveling: 1914-1942" and "Goals For America: A Budget of Our Needs and Recourses." Four more are to follow. I feel like the reviewer in the *Christian Century* who said after reading the first, "this reviewer is prepared to jump right off the deep end and declare that every American who takes responsibility for helping anybody else think—and this includes members of families—should place his order sight unseen for the entire half-dozen, to be delivered as they are published in the next few months."

Let me give you Mr. Chase's picture of certain needs and desires as he states them in "The Roads We Are Traveling," page 83.

"If you hold your ear close to the ground, you can hear a muffled roar echoing around the whole world. It does not come from bombs, or thunder on the Russian front. It is the voice of the people demanding security and an end to the paradox of plenty. It is the revolt of the masses asking for the food which farmers let rot upon the ground or dump into the streams. This subterranean roar is the most powerful force in the world today. Statesmen who listen to it will be upheld. Statesmen who shut their ears will be buried, no matter how lofty their sentiments about freedom and initiative.

Science and invention have put an adequate standard of living within the reach of every family in the great industrial nations. Ultimately it will be within the reach of every family in the world. The mass of the people know this. Yet the standard of living which they might have does not come through to the great majority of them. Why does it not come through to them? It is there for all to

see—13 million bales of cotton in storage, 500 million bushels of wheat in granaries in the United States, 60 million bags of coffee burned in Brazil—why does it not come through? The authorities reply that the market cannot tolerate it, or that the laws of property forbid it. Do you think these answers, however legal and logical, are going to satisfy the masses? They are asking a revolutionary question which demands a revolutionary answer."

Again quoting Mr. Chase in his "Goals For America" (pages 3, 4):

"Someday the bombers will be grounded, the bugles will sound, and the war will end. All-out total wars cannot be maintained indefinitely. If the end comes within the next three or four years, the physical picture of the American economy promises to look something like this:

A vast force of trained workers in the war industries to be demobilized and shifted to peacetime occupations. They may be expected to insist vigorously on re-employment.

An industrial plant greatly expanded, especially for the production of machinery and such materials as light metals, rubber, other synthetics and plastics.

Machine tools—the machines which make machines—in great profusion.

An agricultural plant specializing in crops of high nutritional value, and capable of supplying far more than our own population.

A very great increase in electrical energy.

A vast budget of postponed wants to be filled—houses, clothing, automobiles, tires, radios, washing machines, durable consumers goods of all kinds. Incidentally, many consumers will have stored up purchasing power with which to buy them.

An insistent call from abroad for American food, supplies and industrial equipment.

An imperative demand for public works neglected during the war—conservation, hospitals, highways, schools, water systems, sewer systems, irrigation, transport facilities, and the like.

A promise of freedom from want to be redeemed.

Americans will find themselves with plenty of tasks to do. They will have the trained man power, the plant, the energy, the raw materials, the machine tools, to do it with. . . . There should be no material reason for not carrying American civilization forward, as well as supplying many victims of the war beyond our borders. We shall be physically equipped to do both.

Shall we be mentally prepared?"

Mr. Walter D. Fuller, president of the Curtis Publishing Company and Chairman of the Board of the National Association of Manufacturers, warned four hundred Pennsylvania bankers at Atlantic City that the people's revolution was coming fast.

"One thing is certain, the people of this country are fighting this war for a better world in which to live. They would like to get it through democracy, liberty and free enterprise. But they are determined to have this better world of greater security one way or another, and if they don't get it through present principles they will look elsewhere.

"The handwriting is on the wall. We either must cut the cloth to fit that pattern or the reformers and demagogues will.

"This country cannot return to 'the good old days' after this war, because those days just weren't good enough. They were the days when 28 million people were receiving some form of public assistance; when there were 10 million unemployed; when there was want amidst plenty. They were the days of idle money, idle men and idle plants." ("Goals for America," page 19.)

Quoting from the *Fortune* poll for July, 1942.

Mr. Chase gives us an insight into what the American masses want as he found it in the *Fortune* poll for July, 1942.

"They do not want a comprehensive system of 'socialism'—25 per cent for it, 40 per cent against it, 34 per cent on the fence. But 74 per cent of them want medical care for everyone who needs it; 74 per cent want old-age pensions for

every citizen over sixty-five; 68 per cent want jobs for everyone in public work if private work is not available; 58 per cent want unemployment compensation during the interim.

"Twice as many Americans believe that after the war life will be better than before, as believe the contrary; and more than twice as many believe that a young man will have more opportunity after the war than he had before.

"If the poll is reliable, it is manifest that the majority of Americans are looking for a better world when the war ends. They do not want new 'systems' or new ideologies, but they want jobs, public works, medical care and social security. They want the deed, not the word." ("Goals For America," pages 19, 20, 21.)

We could go on and on with the many problems crowding upon us — international relationships; what of our preparation for the peace that is sure to come; what of Christian family life today and tomorrow? Any settlement of these problems is impossible unless we are willing to invest our minds for God in seeking the answers.

We need also to invest our bodies for God. Certainly I never remember to have been so body-conscious before, do you? We in America are limited in our enjoyment of anything in the world we wanted for the first time in our lives. Oh, some of us may have had to do without some things, when our funds were low, but the chances are that we have all lived very comfortable lives. Now we are rationed, and our bodies are suddenly aware of the possibilities of discomfort, even though few of us here have really felt any discomfort as yet.

Classes of all sorts are offered to us—nutrition, first aid, home nursing, nurses' aid. Medical science has offered us every possible combination of vitamins for every known deficiency. We are indeed body-conscious.

How may we invest our bodies for God?

Our Lord gave us the answer. The body was so important to Him that He made it a part of His last service for us: "This is my body which is given for you."

Let us be quite honest for a moment. We are again in the midst of confusion, for so much is demanded of our time that our bodies are extremely weary. We try to crowd so many things into our lives that we do things by halves and then we are ashamed. The pressure of the Red Cross, Civilian Defense, and other war work is tremendous, and I don't minimize the importance of one bit of it. We must do it, but we cannot do it all. Most of us make the mistake of doing too much. We want to get on the band wagon; so we crowd our time with *doing* things. Many of us have lost our perspective.

One of Dr. Fosdick's earliest books, written years ago, made a lasting impression on my mind. The title of it is "Twelve Tests of Character." The heading of one of his chapters always brings me up short when I think about it—"First Things First." Are we really putting 'first things first'?

"This is my body which is given for you. Do this in remembrance of me."

St. Paul has taught us that the Church is the body of Christ and that we are all members of that body. How many of us have ever thought of our bodies in that sense, as part of Christ's body? We treat our Church responsibilities so casually, never realizing that our absence means the severance of a part of that body which is vital to its life. Our physical presence in our Church and in its work is our first and most important payment on the investment of our bodies for God.

"Lord, what a change within us one short hour

Spent in Thy presence will avail to make!

We kneel, how weak! We rise, how full of power!"

Do you think we shall ever learn the joy and power that can come to us if we invest our bodies for God?

Last and briefly, we have our spirits to invest for God. That is a simple but fundamental truth. We can know a lot

about many problems of the day; we can work our bodies to death, but the Kingdom of God is either brought nearer or is hindered for an unknown time by the spirit within each of us as we go about our daily living.

Do we have the courage of our convictions, or do we have any convictions?

Christ commanded: "Love thy neighbor as thyself," but what if our neighbor happens to have a yellow skin, or a red skin, or a black skin, or a brown skin?

Christ taught: "If a man sue thee for thy coat, give him thy cloak also," but do we really want better standards of living for all men enough to share with them the privileges that have always been ours?

Christ commanded: "Love the Lord, thy God, with all thy heart, and with all thy soul, and with all thy mind," but are we willing to face the implications of this command?

Our souls, hearts, spirits—call it what you will—our whole attitude toward the problems of the world is determined by the extent to which we actually practice the presence of God in our lives. Archbishop Temple in his book, "The Hope of a New World," says, "This world can be saved from political chaos and collapse by one thing only, and that is worship."

What have we that we can invest for God?

"Here we offer and present unto thee, O Lord, our selves, our souls and bodies, to be a reasonable, holy, and living sacrifice unto thee."

CONSTITUTION OF THE ASSOCIATED WOMEN OF THE CHURCH IN THE DIOCESE OF TEXAS

ARTICLE I—NAME AND OBJECT

Section 1. The name of this organization shall be The Associated Women of the Church in the Diocese of Texas.

Section 2. Being committed to the building of the Kingdom of God, the object of this Association shall be (a) to aid the Bishop, the Executive Board of the Diocese, and the National Council through the medium of the Executive Board of the Woman's Auxiliary to the National Council, (b) to promote the work of the Church in all Departments in the five fields of service: the Parish, the Community, the Diocese, the Nation, and the World.

ARTICLE II—MEMBERSHIP

The members of this Association shall consist of all womens' organizations in the Diocese of Texas.

Any parish or mission organization which (a) shares in the Maintenance Fund, the United Thank Offering, and the Supply Department; (b) makes an annual report to the President of the Association, shall be considered in good standing.

ARTICLE III—OFFICERS

The officers of the Association shall be a President, a Vice-President, a Vice-President for each Convocation, a Secretary, a Treasurer, a United Thank Offering Treasurer, the following Chairmen of Committees: Devotional, Educational, Nominating, Supply Box, Church Periodical Club, Christian Social Relations, Bishop Kinsolving Memorial Fund, Publicity, Rural Education, Ditty Bag, Camp Allen; Representatives of the Young People's Work and of the Daughters of the King, and such others as shall be found necessary.

These officers and representatives, together with members and ex-members of the National Executive Board, the wife of the Bishop of the Diocese, and the immediate past-president, shall constitute an Executive Board to transact business between Annual Meetings, and to suggest general plans for the development of the women's work in the Diocese.

ARTICLE IV—MEETINGS

Section 1.—The Annual Meeting of the Association shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Executive Board.

Section 2. Each parish or mission is entitled to vote through its delegates. Organizations of less than twenty-five members are entitled to one delegate, up to fifty members, two delegates, up to seventy-five members, three delegates, more than seventy-five, four delegates. If there is no organized women's work, the rector or priest in charge or the Bishop may appoint a delegate.

Section 3. Each parish and mission is expected to be represented at the Annual Meeting.

BY-LAWS

ARTICLE I—DUTIES OF OFFICERS

Section 1. It shall be the duty of the President to preside at all meetings and perform all other duties appertaining to the office, including sending out of report blanks, annually in December, to all parishes and missions.

Section 2. It shall be the duty of the Vice-President to act in case the President is unable to serve. She shall be the Chairman of the Year Book Committee.

Section 3. It shall be the duty of the Vice-Presidents of the several Convocations to co-operate with the Diocesan President of the Associated Women, and the Deans of the Convocations in all Diocesan work, each in her own Convocation. She shall preside at the women's meetings of her Convocation and act as a liaison officer with the Diocesan Board of the Associated Women. She shall serve as a member of the Finance Committee and of the Permanent Nominating Committee.

Section 4. It shall be the duty of the Secretary to keep a record of proceedings of all meetings, prepare an annual report, and in the absence of the President and Vice-President call the meeting to order and preside until a Chairman is selected. She shall also keep a correct list of Officers and their addresses, give notices of all meetings, both the Annual Meetings of the Association, and other meetings of the Executive Board, and shall keep a record of the women's organizations in the parishes and missions and the Officers thereof. She shall carry on the correspondence of the Executive Board at the direction of the President.

Section 5. It shall be the duty of the Treasurer to take charge of all monies (except the United Thank Offering and the Bishop Kinsolving Memorial Fund), disburse same according to instructions, and shall give a report of same at the Annual Meeting. The Treasurer's books shall be audited at least ten days before the Annual Meeting. The Treasurer shall be Chairman of the Finance Committee referred to in Article II, Section 3, By-Laws. Any lapsed balances that are in the Treasury in December, may be re-allocated by the Diocesan Executive Board, if it seems expedient, to take care of other urgent needs.

Section 6. It shall be the duty of the United Thank Offering Treasurer to furnish Blue Boxes and U.T.O. leaflets and call attention in other ways to the purpose of the United Thank Offering. She shall devise means of placing a Blue Box in the hands of every woman of the Diocese. She shall keep a list of contributing organizations, and receive semi-annual offerings. Each year she shall render a report of the progress of the offering, and each third year make it ready for presentation at the United Thank Offering service of the Women of the Church.

Section 7. It shall be the duty of the Devotional Chairman to be responsible for the devotions at all Executive Board meetings and the Annual Meeting. She shall answer any requests that come from parishes and missions concerning devotional programs and suggest or send material. She shall mail literature to be used on the first Friday in Lent for the World Day of Prayer and shall also cooperate in the observance of the Church Wide Day of Prayer, November the eleventh.

Section 8. It shall be the duty of the Educational Chairman to cooperate with the Educational Secretary of the National Board of the Woman's Auxiliary and follow such recommendations as are sent out by the National Educational Secretary; to supervise the educational work of the women's groups in the Diocese; to report plans and activities to the Executive Board of the Associated Women of the Diocese at each regular meeting; to keep the Department of Christian Education, of which she is a member as a representative of the Associated Women, informed of her work with the women's groups, and to report to the Executive Board of the Associated Women, the activities of the Department of Christian Education.

Section 9. It shall be the duty of the Nominating Chairman with her Committee to present names for officers and Chairmen to be elected at the Annual Meeting, for delegates to Provincial Synod and Triennial Meetings and names to fill vacancies on the Executive Board between Annual Meetings.

Section 10. It shall be the duty of the Supply Chairman to assign to the various parish and mission organizations lists of boxes as requested by the National Supply

Secretary, and to have charge of preparation of any Diocesan box. She shall promote throughout the Diocese interest in the work of the Supply Department.

Section 11. It shall be the duty of the Church Periodical Club Chairman to promote interest throughout the Diocese in supplying literature, etc. to missionaries and other persons who are unable to provide literature for themselves, also, to Church schools, reading rooms, libraries, hospitals and other institutions. She shall mail literature to be used on the first Sunday in May (Church Periodical Club Sunday) to each Rector in the Diocese.

Section 12. It shall be the duty of the Chairman of Christian Social Relations to act as representative of the Associated Women of the Church to that Department. To attend all Department meetings and to carry out to the best of her ability the program as outlined by the Department. The Chairman shall seek to stimulate interest and cooperation in the work, and to urge the Women of the Church throughout the Diocese to participate in the general program of the Department of Christian Social Relations.

Section 13. It shall be the duty of the Bishop Kinsolving Memorial Fund Chairman to have charge of the Book of Remembrance, to stimulate interest in the Fund, to receive and account for memorial gifts.

Section 14. It shall be the duty of the Publicity Chairman to serve as liaison officer between parishes and missions throughout the Diocese, using the Texas Churchman as a means of keeping these women in touch with each other and with the news of the Diocesan and National Church organizations. The Chairman shall constantly work toward increasing the circulation of the magazine "Forth." The office shall serve as a clearinghouse of ideas of practical helpfulness and of news of general interest.

Section 15. It shall be the duty of the Rural Education Chairman, under the direction of the Bishop, to contact people of the Diocese who are unable to receive the ministration of the Church, and supply them with literature.

Section 16. It shall be the duty of the Ditty Bag Chairman and her Co-Chairman to secure Ditty Bags for the Seamen's Institutes in Houston and Port Arthur to be distributed on Christmas morning.

Section 17. It shall be the duty of the Camp Allen Chairman to cooperate with the Director of Camp Allen, particularly in securing the help of the Women's organizations in furthering interest in and supplying the needs of Camp Allen.

Section 18. The Executive Board shall have the power to fill vacancies in its own body between regular elections.

Section 19. The members of the National Council, the wife of the Bishop and the Past-President shall serve in an advisory capacity on the Executive Board.

Section 20. Each Diocesan officer shall present a written report of her work at each Executive Board Meeting and at the Annual Meeting.

Section 21. All books shall be closed on December 31st, and all reports shall be in the hands of the President by January 5th.

ARTICLE II—DUES

Section 1. Operating expenses of this Association, such as printing of the Year Book, supplying prayer leaflets, and other incidental expenses in connection with the Women's work in the Diocese shall be met by a Maintenance Fund, which shall be raised as follows: Parishes and Missions shall decide in which class they belong and pay accordingly, annually.

Class A	\$30.00	Class C	\$10.00
Class B	\$20.00	Class D	\$ 5.00 or less

Section 2. Each parish and mission organization shall be asked to contribute in proportion to its ability to the pledges of this Association, and to such other objects

as may be recommended by the Executive Board or voted at the Annual Meeting. This, together with the Maintenance Fund, constitutes the Budget.

Section 3. There shall be a Finance Committee, composed of the President, the Treasurer and the four Convocational Vice-Presidents to prepare the Budget and to decide upon the tentative apportionment for each parish organization.

ARTICLE III—MEETINGS

The Executive Board shall meet quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President, or upon written request of two members of the Board.

ARTICLE IV—ELECTION OF OFFICERS

Section 1. The election of officers shall be by ballot and shall be held at the Annual Meeting, a majority of votes cast being necessary for election.

Section 2. The term of office shall be three years. No officer, except the Treasurer, shall serve more than two consecutive terms.

Section 3. Officers shall be elected in the following groups, one group each year:

(a) President, Vice-President, Educational Chairman, Church Periodical Club Chairman, Nominating Chairman, Publicity Chairman.

(b) Vice-Presidents of the Northeast and Southwest Convocations, Secretary, United Thank Offering Treasurer, Treasurer, Rural Education Chairman, Ditty Bags Chairman, Devotional Chairman.

(c) Vice Presidents of the Northwest and Southeast Convocations, Supply Department Chairman, Camp Allen Chairman, Bishop Kinsolving Memorial Fund Chairman, Christian Social Relations Chairman.

ARTICLE V—QUORUM

One-fourth of the members having a right to vote shall constitute a quorum at the Annual Meeting. Seven members shall constitute a quorum at the meetings of the Executive Board.

ARTICLE VI—ELECTIONS

Section 1. At the Annual Meeting preceding the Provincial Synod three delegates and three alternates shall be elected. This election shall be by ballot. In case the elected delegates are unable to attend, the Diocesan President shall, with the Bishop's approval, appoint delegates in their stead.

Section 3. At the Annual Meeting preceding the Triennial, five delegates and five alternates shall be elected. This election shall be by ballot. In case the elected delegates or alternates are unable to attend, the Diocesan President shall, with the Bishop's approval, appoint delegates in their stead.

ARTICLE VII—AMENDMENTS

These By-Laws may be amended or suspended by a two-thirds vote at an Annual Meeting.
