

DO YOU KNOW?

1. What is THE ASSOCIATED WOMEN OF THE DIOCESE OF TEXAS?
The Associated Women of the Diocese of Texas is the over-all organization of Church women, set up to serve the Church in every phase of its life and in all fields of its activity. (Associated Women is just another way of saying: Woman's Auxiliary.)
2. Who belongs?
Every baptised woman is eligible and is theoretically a member, but women become *active members* upon joining in the work of a parish group or guild.
3. What is the goal of the Associated Women?
The goal is that *every* woman of the Church shall assume her responsibility for the whole mission of the Church.
4. What is meant by the UNIFIED PROGRAM?
The unified Program means that all parish guilds and organizations, while retaining their own group work and projects, also work with and through the general organization of the Associated Women, towards the program of the National Church.
5. How do members seek to carry out this Program?
Through: Worship, Study, Service, Gifts and Fellowship in the five Fields of service: Parish, Community, Diocese, Nation and the World.
6. What activities in the national program are the parishes expected to support?
ALL. But to be an active member of the Associated Women of the Diocese, the parish organization must support the United Thank Offering, the Supply Box and pay their diocesan assessment.
7. How can Business and Professional Women participate?
By having an organization, which takes its part in the program of the local parish and the National Church. By the Associated Women having one or more night meetings, when the Business Women may meet with the other groups of the parish and discuss the whole program of the church.
8. What is meant by Co-operating Organizations?
Co-operating Organizations are church organizations which have their own national set up (as Daughters of the King and the Church Periodical Club, etc.) but who do cooperate with National Woman's Auxiliary and participate in the parish unified program.
9. How is the diocesan budget met?
Woman's work should be financed through a carefully prepared budget, covering the five fields of service. Each parish and mission organization of women is assessed its fair share for the diocesan budget.
10. How can the resources at National Headquarters be used by parish women?
 1. Find out what is available, through the Diocesan Officers or by writing directly to 281 Fourth Ave., New York 10, N. Y., to the Executive Secretary of the National Woman's Auxiliary. Use this material for worship and study. (Set up a parish library to lend such material.)
 2. ACT. When asked to co-operate on any part of the national program, seek information first, then act.

11. Why do we have Provincial Organization?

The General Convention and the Triennial Meetings are held only every three years, but the Provincial Synod meets during the other two years, for education and promotion. This includes discussion of the problems and projects within the province. The whole program of the Church may be interpreted to a greater number in these smaller meetings, and plans may be made to integrate the programs of the dioceses.

12. What can Diocesan Officers do for parish groups?

- a. They can help parish groups set up or improve their parish organization.
- b. They can explain and interpret the work of the various national departments, as, United Thank Offering, Christian Social Relations, etc.
- c. They can help parish groups to get acquainted with the material available from the national church; to find new ways to carry out the national program and feel closer to the national church.

13. What can women in mission churches do for the diocese?

They can participate in the program of the Associated Women: Worship, Study, Service, Gifts, and fellowship. Specifically they can take part in the United Thank Offering, the Supply Box and pay their part of the diocesan budget.

14. What can one woman do?

- a. Worship—individual and corporate prayers.
- b. Study—To increase knowledge of the Church, of its heritage, its projects and current problems.
To create an understanding of the need in the mission field.
To understand the economic and social problems of the day, that are of vital concern to the Church.
- c. Service—Teach in Sunday School
Help Young Peoples' Groups
Call on newcomers
Do Altar work
Help in every member canvas
Take part in community projects
WORK FOR YOUR CHURCH
- d. Gifts—through: United Thank Offering, Church Periodical Club, Supply Box, Support Diocesan Associated Women's Budget
The gift of one's time, one's talents, one's money, one's self.
- e. Fellowship—
Interdenominational
Inter-racial
International
Fellowship in the parish—meetings, dinners, calling.

OUTLINE OF BUCHANAN DAM CONFERENCE
with
MRS. EDWARD G. LASAR,
Provincial President, the Leader

I. PROGRAM BUILDING

The Program must be a unifying force, using the talents of All the women, and reaching all age groups. In order to combat the chief problem—that of attendance at meetings—the program must be broader than that of any other organization in the community, and must be broader than that of any other thing by which *our* organization is judged.

The four angles from which the program should be considered are:

1. What is the purpose of the program?
 - a. Is it to develop the interest of the women?
 - b. Is it to advance the work of the Church and deepen the spiritual life of the parish?
 - c. Or is it just to build attendance?
2. How good is it?
 - a. Will it bring women back who came for the first time?
 - b. Will it interest and draw into the work of those who have come out of a sense of loyalty to the Church; to the rector; to the group president?
3. Does it have a place to use the talents of All the women of the Church?
 - a. Those who arrange flowers well
 - b. Have musical ability
 - c. Can sew
 - d. Write well
 - e. Like to take care of children, etc.
4. Evaluation (at the last meeting). Did it
 - a. Foster fellowship of the BIG type—in parish, community and World?
 - b. Challenge the intellect?
 - c. Gain new people?
 - d. Help the responsibility assumed by the organization such as: the Supply work; the Diocesan Budget; United Thank Offering, etc.?
 - e. Was it timely?
 - f. Did it help the women to grow spiritually?

The program *should* be planned by the Program Chairman AND a committee. The results are much better than when planned by the chairman alone, or by the rector, or by the officers of the organization. The qualifications of the members of this program committee are:

- a. Community-minded.
- b. Alert to what goes on in the world.
- c. Have social vision, and know the qualifications of people.
- d. Have wide acquaintance—not get in a rut and use the same people over and over again.
- e. Have imagination and willingness to try something new
- f. Unafraid of criticism
- g. Do what is best for the greatest number.

II. CORRELATION OF WORSHIP WITH SPECIAL STUDY SUBJECTS AND SERVICE PROJECTS

For a time the worship part of the program consisted merely of an opening prayer, and maybe a closing prayer. Now that worship has again become popular, women are asking for aids in making the devotional part of the program both meaningful and helpful.

How do YOU plan a worship service? The devotional chairman should be familiar with the subject matter of each program, and make hers an integral part of the whole. Be sure to suit the devotional to your group; vary it; have different women take part in it.

Suggested Forms

1. Meditations
2. Litanies
3. Review of religious book or article
4. Biography of a great missionary
5. Music (Bring great music of the Church to the group; learn new hymns yourselves)
6. Invite a guest from another denomination to give the devotions
7. Let the women write their own statement of Faith

The spiritual content of the program is the most important of all. When you are considering the 5 fields of women's work, the first 3—worship, study and service—are more important than the last 2—fellowship and gifts. The program is to further the Kingdom of God and to deepen our spiritual lives. If this is done, the fellowship and gifts will come.

III. HOW TO USE PUBLISHED MATERIALS IN PROGRAMS

The publications of our own Church, coming to us from 281 Fourth Avenue, New York 10, N. Y., have much for us—the "Tell Us About" series; When You Organize, etc.; U.T.O.; Supply Department; the 4 Commission Reports, with Design For Action as a guide.

'Clip' National and Provincial letters.

Current events from Church periodicals.

Material from World Council of Churches, and Federal Council of Churches.

Visual Aids—movies, slides, maps, collections, pictures, etc.

Vary the programs by having dialogues; plays; pageants; book reviews; panel or round-table discussions; quiz programs.

Remember in a missionary program it is the SUBJECT, not the book which is important.

IV. ESSENTIALS OF LEADERSHIP TRAINING

Here are three things a leader must keep in mind:

1. A leader is an interpreter of the spiritual life.
2. Leadership is only effective if it multiplies itself (trains others for leadership)
3. There is an inborn URGE for
 - a. self-preservation
 - b. self-expression
 - c. self-assertion

A leader can obtain interest in the following ways:

1. By action—spread around information before a meeting
2. By demonstration—showing the need for the work or for the program
3. By presenting assembled facts
4. By emotional appeal
5. By stimulating group conversation and discussion

Some of the requisites for leadership.

- a. Make use of the members' talents and specialties, placing each person in the job she can do best.
- b. Create ways for others to participate in the work.
- c. Place self in the background, avoiding 'self advertising'.
- d. Never separate self from the group, placing group above self.
- e. Generate ideas, show and direct, but give chairman full responsibility. Leaders should never assume the responsibilities of a chairman or of a committee if they fail to execute a job.
- f. Recruit workers from all types—timid and bold; influential and uninfluential; new and old.
- g. Be willing to administer at the point of need, but stay conscious of ALL needs (at home and abroad), never absorbed in one.
- h. Give more of yourself than you have. This can be done by prayer, thus developing your inner resources. Love humanity, be tolerant, fair, unbiased, and at all times considerate.
- i. Work for the good of the whole—never for any personal credit.
- j. Teach as leaders. Read the Gospel according to St. Matthew to see how Jesus trained His leaders.

The ESSENTIAL of women's work in the Church is that it advance the religion OF Jesus, not the religion ABOUT Jesus.

OFFICERS REPORT FOR 1947

PRESIDENT'S REPORT

At the end of the year 1947, it is again my duty and privilege to report to you on the work which has been done by your Executive Board. At the beginning of the year, the Board set up two objectives; first, that we again arrange for and support Area Meetings and try personally to meet even more and more of the women in the parishes and missions; second, that we would encourage the parish organizations to draw more women into the active work of the Church. As regards the first objective, many Area and Convocation meetings have been held, where excellent programs have been planned by the respective Vice Presidents and it is a pleasure to report that these meetings have been larger than at any previous time. The interest shown by those attending has been most gratifying. As to the second objective, we can only know how successful that has been, when the parish reports are all in and they can be compared with the previous year. However, many parish presidents have reported that they made a great effort to interest all women in the work of the Church and have drawn more women into the work. Your Board will continue to work on this objective in 1948. The Church badly needs the strength to be gained by the interest and work of all its women, but more than that, the women need the strength, courage, and comfort that will come from their renewed faith in the mission of the Church.

Your Executive Board continued the policy of 1946, of meeting in various parts of the Diocese; thus giving the women of the Board the privilege of knowing more women and giving the women of the parishes the opportunity to know the members of the Board and to sit in on a business meeting. From the side of fellowship, these meetings have been well worthwhile; but there is some doubt in the minds of many of the Board members as to whether women in the parishes have become better informed about the work of the Church in the Diocese and in the world, because of these meetings. Meetings were held in Austin, Marshall, Bellville and Waco, and in each city the Board was entertained with gracious hospitality.

A meeting for the Executive Board members of the Diocese of Texas, the Diocese of Dallas, the Diocese of West Texas, and the Missionary District of North Texas, was arranged by the Board of the Texas Diocese. This meeting was held in June, at the Lodge of the Lower Colorado River Authority, on Lake Buchanan, and we had the great pleasure of having for a discussion leader for the meeting, Mrs. Edward G. Lasar, President of the Women's Auxiliary of the Southwest Province. This meeting seemed so worthwhile both because of the opportunity to meet the women of the other Diocesan Boards in the state and because of the great wealth of material and information brought to us by Mrs. Lasar, that it was voted to make it an annual affair. The Diocese of Dallas will make arrangements for the meeting in 1948.

Your president has served as a member of the Diocesan Bi-Racial Commission, the Diocesan Christian Social Relations Commission and the Commission to study the need for Christian Training School for Women in the Diocese of Texas. Other members of the Board have served on the same and other commissions and the reports of these meetings has kept the Board

informed about Diocesan work. We are grateful for the privilege of serving on these commissions.

The Vox Feminarum Committee which was set up after the Council of 1947, has done a dignified and creditable piece of work. Only time can tell if this work has also been effective.

We look ahead.

At this time the world is staggering under the terrible burden of selfishness, greed, suspicion, fear and hate. There is no peace in the world or in the hearts of men. Only the love of God can heal such a world; only Christian men and women, people like you and me, can demonstrate what that love means to us. Many, many believe that the time to build for peace is very short. Let us pray that in 1948, we as Christian women may overcome the unchristian areas in our own lives and become acceptable channels for the healing love of Christ.

REPORT FROM THE CONVOCATION VICE - PRESIDENTS

The Vice-Presidents of the four convocations in the Diocese of Texas, who serve as liaison officers between parish presidents and the Diocesan officers, have many opportunities to further the work of the Associated Women in their convocations. Through their visits to the parish and mission organizations, they become better acquainted with the women and are able to serve more efficiently on the two committees to which they are assigned; nominating and finance. They learn what the parishes want presented to the board and in turn help the Diocesan officers make the contacts they need in their convocations, thus coordinating the work of the parish, diocese and nation.

Area meetings, where two or more churches meet together, may be arranged by the Vice Presidents, and they also assist the Dean of the Convocation in developing the women's programs of the Convocational meetings. These group meetings give the women of the Church a broader view of the Church's program, for they meet their Diocesan officers, as well as the women of the other parishes, thus profiting through the exchange of ideas and experiences.

Southeast Convocation

I have attended three board meetings, served on the program committee for the 1947 Council in Beaumont, and on the finance and nominating committees. Since that time copies have been mailed to individuals who have requested help. Upon request, copies were sent to the provincial President and to the Executive Secretary of the National Executive Board. The Devotional Chairman adds fresh material to the bibliography as it becomes available. It is earnestly hoped that this guide has been of some service for it was prepared with a deep sense of responsibility and humility.

The Devotional Chairman was present at all Board Meetings, gave brief devotional talks at two and read prayers at the other two. Two area meetings were attended and a talk given at one.

In June the excellent Tri-Diocesan Conference at Lake Buchanan was attended and I feel this department gained immeasurably from it. I was asked to plan the devotions for this meeting.

In the year to come may we walk the road of fellowship with the risen and eternal Christ.

REPORT OF DEPARTMENT OF CHRISTIAN EDUCATION

It is with real regret that I write this final report as Educational Chairman—a report that will be rather general in order to cover my two years in office.

The number of interested women serving as parish and mission educational chairmen has grown steadily, as the scope of the subject matter studied. More and more groups now have educational programs planned to include all phases of women's work in the Church. Most women have come to think of their programs not just as a study of Missions, but as the means of knowing our Church's work at home and abroad, of understanding more fully our personal obligations to the Church and to Society, and of co-ordinating all women's activities.

There have been many requests for program material and for information of all sorts. I must commend the women for their use of the wonderful Triennial material that has been and still is, available. The 4 Commission Reports along with Design for Action and Bishop Dun's Meditations are certainly as fine as anything that has come out of a Triennial meeting. They are the type that may be successfully used long after this Triennium has been completed.

As a member of the Department of Christian Education it has been possible for me to interpret the work of the Associated Women to that body, and to gain an overall picture of the educational program of the Diocese for all age groups. Serving thus as a contact person has been both a privilege and a pleasure. I would remind you that in the office of the Department at 1117 Texas Avenue, Houston, are many books, pamphlets, and visual aids that may be borrowed. They will greatly add to the interest and efficiency of your programs.

Each spring a letter with information about program building is sent out. Along with it is the information received from Miss Avis Harvey, National Educational Secretary, regarding new materials and subject matter; a Missionary Education Movement leaflet and Family Week folders. These have gone to the educational chairman or president of each parish and mission women's group in the Diocese. The last packet also had a copy of the Report of Planning and Action Committee of the Triennial Meeting.

I have spoken to Area Meetings and to various parish and mission groups when asked, and have attended all Department and Board Meetings.

I am most grateful to the members of the educational committee—Mrs. Clinton S. Quin, Miss Lynette Giesecke, Mrs. George D. Wilson, Miss Elva Shone, Mrs. Earl Powell, Mrs. H. H. Sharpe, Mrs. H. C. Roch and Mrs. P. W. Hirst—for their co-operation and assistance. They have brought to our meetings the viewpoint of the large, medium and small parish and mission in city and town churches. We have written 6 "Do You Know . . ." papers on the following subjects:—Private Prayer; Corporate Worship; What the Episcopal Church Stands For; Christian Symbolism; Church Organization; and The Annual Report Book. We sincerely hope they will help the program planners and also act as "fill-ins" when needed.

Since there have been so many requests for simplified information about program building, I have had printed a very brief outline of the conference held last June at Buchanan Dam with Mrs. Edward G. Lasar, Provincial President, the leader, in the hope that it will be as much help to you as the conference was to me.

My successor in office has my very best wishes. May she have the splendid co-operation and fine contacts that I have enjoyed. Thanks so much for giving me the opportunity of serving.

REPORT OF DEPARTMENT OF CHRISTIAN SOCIAL RELATIONS

The Christian Social Relations committee is the most important committee of your parish; the foundation stones of our Christian faith is its heart. The Lord gave us two great commandments "To love the Lord thy God with all thy heart" and the second "To love thy neighbor". This committee tries to carry out these two great commandments. If we love our God with all our hearts we will, in our homes, our churches and our communities practice this spirit of love and our task of building God's kingdom on earth will follow in our entire program of the Church.

How has your department carried out this program this year?

We have (1) shared by the tons, our clothing, food, and other supplies with others through contributions to the Church World Service, (2) contributed generously to the Presiding Bishop's Fund—this year's million was reached but remember next year we have another to raise!—and (3) by sponsoring legislative bills recommended by the National Executive Board of the Woman's Auxiliary. I am glad to report that the women of the Church have responded with more than fifteen hundred letters in 1947 to State Legislators. Emphasis was given to state bills concerning Child Welfare. Bills that are now in Congress and need your action are:

Indian Affairs ..
Conscientious Objectors
Immigration
Japanese-Americans
Minimum Wage
Military Training
Federal Aid for Education

The department is to continue to urge you to send aid to Europe and your money to the Presiding Bishop's Fund in 1948.

I would like to tell you about a community service the Church of the Redeemer, Houston, is giving. They call the proper agencies and find the blind and aged in their neighborhood that need individual help and then adopt them, give them the little things that make them more comfortable and happier. That is doing the Church's work!

I have met all calls to visit churches with the Department's Message, attended all Executive Board Meetings, and two department meetings. It has been a privilege to serve you this past six years. I have received an education I could not have paid for. I have learned about the Great Heart our Church has and what it is doing to be a "good neighbor". If each church and mission in our Diocese (both men and women) co-operate more closely with the leadership offered by the national department of Christian Social Relations, they, too, will learn that this Great Heart, to beat properly, must begin its beats with them.

May God bless each and every one of you in your labors for our Dear Lord.

REPORT OF SUPPLY DEPARTMENT

The Supply Department is one of the oldest programs of service in the Woman's Auxiliary. There are two ways the work is carried on:

- (1) Our provision of boxes sent to missions and institutions at home and abroad. They contain clothing, new and used, to enable missionaries to meet the needs of the people they serve. The boxes also contain household goods, hospital supplies, first aid kits and layettes.
- (2) Our money sent to the National Supply Secretary to be used for special purchases of supplies.

Every spring the Bishops of the diocese and missionary districts which are aided through the supply work send to the National Supply Secretary a list of missions needing aid. She writes to the heads of these missions for estimates of their requirements. The assignments sent to the diocesan branches are taken from these lists. Your Diocesan Chairman divides these requests and sends each parish chairman her assignment.

REPORT OF PERSONNEL COMMITTEE

The greater part of this past year's work for the Personnel Committee has been spent in organizing; in finding out what can be done in this field and the most expedient way of accomplishing this work. The office of Personnel Chairman was established about two years ago by the National Council in order to provide a liaison between college age women and the opportunities offered by the Church in its many fields of work.

A Committee composed of Mrs. Penrose Hirst, St. Timothy, Houston; Mrs. Ralph Miller, St. Paul's Waco; and Mrs. Gray Blandy, All Saint's, Austin, has been set up to work with me.

Last February Dr. Mary Alice Jones, a woman well qualified in Personnel work, was speaker during Religious Emphasis Week at the University of Texas for the Women at this Committee's invitation. For 1948 a College Conference for Women has been planned for March 12, 13 and 14 at Lake Buchanan with Miss Helen Turnbull as the leader. Miss Turnbull is Directress of Windham House, which is a Graduate School for Episcopal Religious Education Workers held in connection with Columbia University in New York City.

The Clergy of this Diocese have been asked to send in the names of women of college age in their parishes so that they might be invited to this Conference.

Mrs. Blandy and I have been attending the coffee hour held on Friday afternoons at Gregg House, All Saint's Chapel, Austin for the Episcopal Students at the University of Texas.

During the past year I have attended several meetings of the Vocational Commission in Houston, and have attended the meetings of the Committee to make recommendations for the establishment of a Graduate School for Directors in Christian Education in connection with the Presbyterian Seminary in Austin.

The purpose of this Department is to keep people, living in communities where there is no Episcopal Church, in touch with their Church. This is done by sending them religious literature each month and the Forward booklets as they come out. We also invite those living in the vicinity to area meetings, and ask the parish priests nearest them to keep in touch with them.

REPORT OF REPRESENTATIVE OF BUSINESS AND PROFESSIONAL WOMEN

Women engaged in business and professions do not feel that they can discharge their responsibility to their Church merely by attending Sunday morning worship services. In many parishes they have spontaneously organized chapters which meet at night and which have a definite part in the Women's Associations of the respective parishes. They assume definite quotas of the association budgets and take part in the association projects. This, of course, is the ideal situation.

In 1947 the Business and Professional Women of the Diocese had a special program during the Annual Council. At the March meeting of the Executive Board, a representative of the Business and Professional Women was added to the Executive Board. Some progress has been made in helping local chapters to coordinate their work more closely with their women's associations and in stimulating interest in forming new chapters. It is hoped that this program will gain momentum in 1948.

REPORT OF REPRESENTATIVE OF CAMP ALLEN

Our camping season was successful, but the number of campers was slightly less than in previous years. A total of six hundred sixty-four persons used the camp during the summer, but of these, only two hundred seventy-four were campers.

Because there had been no definite decision made as to what should be done with Camp Allen after the camp at Hearne gets under way, no major repairs were undertaken. Mr. R. J. Stewart as Chairman of Properties, was quite busy with minor repairs which were necessary to the operation of the camp.

All the curtains in the campers' cabins were taken down, and those not too badly wornwere mended and washed. New curtains were made for one cabin. The material for these was purchased with some of the money given each year to the Special Fund by Trinity, Houston.

Plans for the Camp at Hearne are going forward. A Camp Survey Committee has been organized and has held three meetings, the purpose of which has been the working out of a total program for camping in the Diocese, including the advising about the architecture and the planning of the camp site or sites.

A recommendation has been submitted to the Diocesan Board that Camp Allen be retained because

- (1) Since it has operated for a quarter of a century, it lends an air of stability in a changing world
- (2) It is immediately closer to a larger number of communicants.
- (3) Being located on the bay, it offers different opportunities than does Hearne
- (4) Its facilities with improvements can be used for a number of years and, if sold, what it would bring would be only a very small part of the total amount needed to develop the Hearne camp.

REPORT OF REPRESENTATIVE OF CHURCH PERIODICAL CLUB

Appeals for reading matter comes from all over the world as well as this country. They are received from Bishops, clergymen and missionaries, hospitals, schools and individuals. The purpose of the Church Periodical Club is to endeavor to supply these needs. 1948 will be the sixtieth anniversary of the founding of the club. We hope to have every parish and mission working next year to replace the library of Central Theological College, Tokyo, which was completely destroyed during the war. The plan of this project is to ask for donations of new books, old books, and money.

There are forty-seven parishes in the Diocese who are doing C. P. C. work. Money has been sent for the Student Book Fund, National Book Fund, Tokyo project and Foreign Missions. Several subscriptions to scientific and professional magazines have been given to Missionaries who have returned to their posts since the war. Old hymnals and books were sent to China and to the Philippine Islands.

Church School books and 1,000 religious pictures were sent to China. The recipient wrote that a bible verse in Chinese was written on each picture and presented to the children of the mission school. Hundreds of magazines have gone to the inmates of the Prison at Huntsville. Magazines are taken regularly to hospitals in Houston, Galveston, and Austin by the local C. P. C. secretaries. A Library Cart is maintained for the patients at St. David's Hospital, Austin.

REPORT OF REPRESENTATIVE FOR YOUNG PEOPLE'S WORK

This brief evaluation of the youth program highlights some strong and weak points in the Church School and Young Churchmen's movements, as well as gives statistics to tell the story of progress and indicate where active interest and support of the women can and will strengthen youth work in the local church and the Diocese of Texas.

Advance in the leadership training program continued to a marked degree through the Vacation Church School Institutes, six Lenten Offering institutes, the Church School Workers' Annual Institute and Conference, the Negro Junior Conference and Youth Seminar, the Young Churchmen's Council, and through an increased number of local institutes for youth workers held by

the Department staff. Programs and leadership were eminently good, but some parishes and missions still fail to derive the greatest benefits for their young people—due to lack of representation.

The Vacation School project grew into a real movement through an enlarged, active committee, who did a fine job of promotion and provided excellent supplementary materials for recommended course. Results: more than double the number of schools held this year over last—22, enrolling 1223 pupils and 226 leaders. Was your church one of the 22 that sponsored a school? If not, here is a splendid opportunity for religious training for the children in your church and community! Young people's teams trained for 8 days in Houston, and conducted successful schools in Conroe, Dickinson, Alvin and Burnet, reaching 120 of the pupils reported above.

Traveling institutes on the Lenten Offering project in six areas of the Diocese were attended by 319 Workers (over half), representing 40 Church Schools. Instead of one Festival Presentation Service, there were three held—in Austin, Palestine, and Houston. Result: 840 attended as against 300 in 1946, including a choir of 223 as against 100, and 42 schools as against 30.

An outstanding program was presented by the Rev. Walter Williams, St. Mark's, Denver, Colorado, to the Church School workers at their annual Institute and Conference. 98 leaders attended the Institute; 108 were at the Conference; 137 different leaders, representing 25 parishes and only 4 missions. Here again is an unusually fine opportunity for the women of the Church to strengthen the youth program by encouraging leaders to share in the training program, providing scholarships and where needed, supplying transportation.

Although a carefully planned and prepared program was presented at the Negro Junior Conference and Youth Seminar, attendance was small. Representation showed 1 from St. Luke's, Houston; 7 from St. John's, Tyler, the greatest distance from the site of Prairie View; and 8 from Prairie View. Total—16.

Only official delegates and adult youth leaders were invited to the Annual Young Churchmen's Council this year. Many young people, clergy and other leaders who attended report "the best Council ever!" 144 were in attendance, representing 24 of the 43 parishes, 1 of the 6 aided-missions, and only 1/6 of the active missions. The figures speak for themselves! Were the young people from your parish or mission represented? Why not make plans now to do whatever is necessary to have representation at the Council next August!

Local and Diocesan youth activities need the continued interest and active support of the women of the Church, both as individuals and as groups. May you seek new opportunities and ways to strengthen this vital work!

**FORTY-SEVENTH ANNUAL MEETING
THE ASSOCIATED WOMEN OF THE CHURCH IN THE
DIOCESE OF TEXAS
MONDAY**

The Associated Women of the Church in the Diocese of Texas met in Annual Session, January 26, 1948, at St. David's Church, Austin, Texas. The Forty-seventh Annual Meeting was called to order at 9:30 A. M. in the Fellowship Hall of the First Southern Presbyterian Church, Austin, by the president, Mrs. P. V. Pennybacker, Jr.

The meeting opened with the singing of Hymn 553, "Go Forward Christian Soldiers," which was followed by prayer led by Mrs. J. Lee Dittert, Bellville, Texas, who served in place of the Diocesan Devotional Chairman, Mrs. Wayne Buchanan, who was absent.

Mrs. Edward Clark of St. David's Church, Austin, welcomed the delegates in behalf of the Austin Churches, and Mrs. W. N. Dudley of Holy Trinity Church, Dickinson, responded on behalf of the delegates.

Roll call of the parishes and the missions revealed 157 delegates, 56 visitors, and 26 Board members present.

The president introduced the program chairman, Mrs. C. T. McCormick, All Saints Chapel, Austin, who announced the theme of the meeting as "Go Forward Christian Soldiers."

Mrs. Starr Kealhofer, Church of the Good Shepherd, Austin, was introduced as Chairman of Dispatch of Business.

The president called for the report of the nominating committee. Mrs. R. W. Byram, Chairman, presented the following slate of officers: Vice President, Mrs. Fred Catterall, Jr., St. David's Church, Austin; Vice President Southeast Convocation, Mrs. Norman A. Bussey, St. George's Church, Port Arthur; Vice President Northwest Convocation, Mrs. C. H. Harrison, St. Paul's Church, Waco; Supply-box Chairman, Mrs. Sidney Smith of St. Stephen's Church, Houston; Personnel chairman, Mrs. W. E. Keys, All Saints' Chapel, Austin; Church Periodical Club Chairman, Mrs. Roy Buchanan, Christ Church, Nacogdoches; Recording Secretary, Mrs. Clinton Wolston, Jr., Holy Trinity Church, Dickinson; Camp Allen Representative, Mrs. A. M. Moellenberndt, Houston; Christian Social Relations, Mrs. William B. Spencer, St. John's Church, La Porte; Educational Chairman, Mrs. A. L. Selig, Christ Church, Houston; Publicity Chairman, Mrs. Malcolm G. Baker, St. John the Divine, Houston; Member-at-Large, Mrs. J. T. Bagby, St. James Church, Houston. A motion was made by Mrs. Byram and seconded by Mrs. Watford, that the report of the nominating committee be accepted. The motion carried. Mrs. A. J. Dow moved the nominations be closed and the secretary cast the ballot. Her motion was seconded by Mrs. Baker Duncan. The motion passed. The secretary then cast the ballot for the slate of officers presented by the nominating committee.

Miss Patty Williams, Trinity Church, Marshall, Constitution Chairman, presented the following proposed changes in the constitution and by-laws: No changes in the constitution. Suggested change in Article 1, Section 10 of the by-laws; changed to read: The Nominating chairman shall, with her committee composed of the four convocational Vice-Presidents, present nominees for officers and chairmen, to be selected at the Annual Meeting, for delegates to the Provincial Synod and to the Triennial meeting, and she shall further present nominees to fill vacancies on the Board between Annual meetings. Mrs. Geo. D. Wilson representing Trinity Women's Association, Houston, pro-

posed amending the suggested change to include: Previous to the Annual meeting the president shall mail to all Parish Presidents a list of offices to be filled at the Annual meeting together with the nominations. Miss Williams accepted the amendment to her proposed change. Mrs. Rummel, St. Timothy, Houston moved the amended proposed change be accepted. The motion was seconded but did not pass.

A motion was made by Mrs. Julia Coddou and seconded by Mrs. C. H. Ruebeck that Article 1, Section 10 be accepted as it now stands in the by-laws plus the addition of the clause: ". . . and she shall further present nominations to fill vacancies on the Executive Board between Annual Meetings." The motion carried.

The second change in the by-laws proposed by the constitution chairman was in Article III, Section 4, changed to read: The term of each officer shall be two years, with the exception of the United Thank Offering Chairman, whose term shall be three years, to correspond with the Triennum. No officer shall serve more than two consecutive terms, except the Treasurer and any officer who shall have served one half of one term, shall thereafter serve only one term. The motion was made by Mrs. Ernest Rogers, St. Marks, Houston, that this change be accepted. The motion was seconded and carried.

Third proposed change was Article VI, Section 1: Strike out the last line, which says: The immediate past president shall serve for one year on the Board, immediately following her term of office. A motion made by Mrs. John Moore and seconded by Mrs. Byram that the change be accepted was passed.

Mrs. Ben Phillips, Chairman of the Finance Committee then presented the proposed budget for the year 1948,

Mrs. Phillips moved that the proposed budget be accepted, the motion was seconded by Mrs. Coddou, and passed.

A motion was made by Mrs. Alice Bruce Currin and seconded by Mrs. R. W. Byram that letters of appreciation be written to Mrs. Kreisle, President of the Women of the First Southern Presbyterian Church and to their rector, Rev. Flynn Long, thanking them for the courtesy of allowing the meetings of the Associated Women and their committees to be held in the Fellowship Hall. The motion passed.

It was moved by Mrs. John Moore and seconded by Mrs. Byram that the Educational Chairman be asked to contact the Educational Chairmen in the parishes recommending study of United World Federalists by individual groups in each parish. The motion carried.

Mrs. Coddou proposed amending the motion to include study of the Marshall Plan and call for action on the Marshall Plan right away. Mrs. Moore accepted the amendment and the motion carried.

The meeting was then turned over to the program chairman, Mrs. C. T. McCormick, who introduced the Rev. John DeForest Pettus of Santa Barbara, California. Mr. Pettus spoke on the work of the Church in Southwestern China. Following his talk a collection of \$245.43 was collected for the support of the work he described.

Mrs. James McClendon was then introduced. She reported on the actions taken at the men's meeting being held simultaneously with ours.

After a short prayer led by Mrs. Lee Dittert, the meeting was adjourned.

The afternoon session was opened at 3:30 by the President, Mrs. Pennybacker. The meeting was immediately turned over to the Program Chairman, Mrs. McCormick, who introduced the speaker, Mrs. Edward G. Lasar, who gave a most inspiring lecture on LEADERSHIP TRAINING. This was followed by a Question period. (See outline of Buchanan Dam Conference.)

After a prayer by Mrs. Lee Dittert the meeting was adjourned.

TUESDAY

The meeting was called to order by the president at 9:30 A. M., January 27, 1948, in the Fellowship Hall of the First Southern Presbyterian Church Austin, Texas.

The meeting opened with the singing of Hymn 289, which was followed by prayer led by Mrs. Wayne Buchanan, Diocesan Devotional Chairman.

Minutes of the last meeting were read and after minor corrections, they were approved.

A motion was made by Mrs. David Smith, Church of the Redeemer, Houston, and seconded by Mrs. E. W. Japhet, Christ Church, Houston, that the Executive Board be empowered to approve the minutes of the meeting now in session.

Mrs. Selcer gave a short talk of appreciation for the service rendered by the retiring members of the Executive Board, namely: Mrs. Scott Myers, Mrs. John M. Moore, Jr., Mrs. Robert Lester, Mrs. J. H. McDonald, Mrs. Julia Coddou, and Mrs. H. C. Brandt.

Mrs. Starr Kealhofer, Chairman of Dispatch of Business read the order of business for the day as follows: Subject—Christian Social Relations. Talks by Mrs. Hiram Salisbury, St. Stephens Church, Houston; Mrs. John Henderson Foster, Christ Church, San Antonio; and Mrs. J. J. Slaughter from the Diocese of Dallas. Following these talks officers conferences will be held with the

following groupings: Presidents and Vice-Presidents (both outgoing and incoming), Devotional Chairmen and Educational Chairmen, Supply Box Chairmen and U.T.O. Chairmen, Publicity Chairmen and Personnel Chairmen, Church Periodical Club Chairmen and Christian Social Relations Chairmen. The Book of Remembrance will be displayed at the close of the meeting.

Mrs. John M. Moore, Jr., then introduced Mrs. Hiram Salisbury who spoke on Christian Social Relations work in general. As a key to this work she mentioned a change from doing "for" to doing "with". It is religion functioning socially, a matter of relationships. She enumerated some of the functions of the National Board of Christian Social Relations as providing information on family relations, legislative matters involved, social insurance, race relations, importance of and need for United Nations, public education, and world relief. Matters before us at present include the problem of federal aid to parochial schools with the ensuing danger of church and state being brought together. Another matter before us at present is the Bishop's fund for world relief. The National Church hopes to raise \$1,000,000 every year for three years for this purpose. Further projects functioning at present include various phases of health and welfare service including hospitals, homes for children and aged, and co-operative projects.

Mrs. John Henderson Foster of Christ Church parish, San Antonio was then introduced. She talked on Christian Social Relations at Christ Church. The main source of funds for this work at Christ Church is the annual San Antonio Garden Pilgrimage from which several thousand dollars are derived each year. \$3,500 is set aside by the finance committee for Christian Social Relations work which is guided by a committee of eight made up of Christian Social Relations chairmen from each guild. They have compiled a card index containing information on every woman in the parish as to her abilities, interests, etc., and this file has been exceedingly helpful to the planning board in setting up its various projects. The board sponsors a central volunteer bureau for training volunteer workers. A major project of the women of Christ Church has been the cancer ward in Robert B. Green Hospital. Here the women last year donated \$3,000 which was augmented by \$12,000 donated by the Junior League for salaries of nurses and nurse's aids in the cancer ward. In addition to the money involved, a number of trained volunteer workers from Christ Church have donated their services to further the work in the cancer ward.

Final speaker of the morning was Mrs. J. J. Slaughter of Dallas who spoke of the Christian Social Relations work in the Diocese of Dallas. She mentioned that Christian Social Relations include world relations, race relations, social relations, and industrial relations. A major project of the committee in the Diocese of Dallas is the sponsoring of Deaconess Crow who works through the city mission at a salary of \$50 per month. Deaconess Crow visits patients at the Tuberculosis Hospital and at the convalescent homes, and the inmates at the jail. Similar helpful visits are made by members of the Brotherhood of St. Andrew. Additional projects of the committee include helping at the Light House for the Blind, Ft. Worth All City Orphans Home, and encouraging the Womens' Action Committee for Lasting Peace. She concluded her talk with a sentence characterizing Christian Social Relations. "Don't forget other people."



MINUTES OF THE SECOND ANNUAL MEETING BUSINESS
& PROFESSIONAL WOMEN OF THE DIOCESE ST.
DAVID'S EPISCOPAL CHURCH, AUSTIN TEXAS
3:30 P. M. SUNDAY, JANUARY 25, 1948

The second annual meeting for Business and Professional Women of the Episcopal Church of the Diocese of Texas met Sunday, January 25, 1948, at 3:30 p. m.[†] at the Parish House, St. David's, Austin, Texas. Mrs. Alice Bruce Currin, of Trinity Church at Houston, presided. Miss Marcia Hoskins of all Saints', Austin, acted as secretary, and Mrs. E. R. McSpadden of Good Shepherd, Houston, gave the Devotional.

Stating that she is the representative of Business and Professional Women on the Executive Board of the Associated Women of the Diocese, Mrs. Currin offered to assist in working out solutions of organizational problems of any business and professional women's group in the diocese. She asked us to give thought to the following three factors: (1) adopting a program that will fit into our busy schedules; (2) that none of us ever will say that we are too busy to belong to a church organization; and (3) that the chief objective of this meeting shall be to find ways and means of developing more participating in Parish affairs by Business and Professional women.

Seventy-four representatives of 18 parishes answered automatic roll call. Mrs. Percy V. Pennybacker, Jr., President of the Associated Women of the Diocese, was introduced; she expressed her happiness over the good attendance and welcomed the group to Council.

Mrs. Currin then introduced our guest speaker, Mrs. Clinton S. Quin, in a most effective way by making clear that she was so able to tell us how a busy person can find time to do Church work. She said that Mrs. Quin budgets her time and energy carefully and then applies a well developed sense of values to see that all of the claims on her attention are given priority ratings and handled accordingly. This allows time for her participation in community, diocesan, and national affairs, without neglecting her own home and family.

In a most inspirational and convincing manner, Mrs. Quin revealed the need of such a budget in our individual lives to enable us to participate more effectively in Church and Community affairs. She suggested the following points:

1. To develop a better understanding of the needs of the world.
(We, as Christians, are responsible for developing fellowship in the community.)
2. To find out the Church plan for meeting these needs so that we as individuals or as groups may participate in this plan.
(She added at this point that no plan can come alive until we make it our own. Attending Church as an onlooker allows the stream of church life to pass us by. Therefore, for our work to be effective, we must reach every woman and inspire better cooperation.)
3. To develop active participation in Parish programs.
(Have something definite for each parishioner to do. Business and Professional Women's time belongs mainly to their jobs and thus makes it hard for them to participate actively in the program of the Church. However, because they are already well trained and efficient, the general planning committee should outline work in each Parish so that this group will be able to take a definite part. All available

talents, skills and abilities of working women should be discovered and used, so that this group will become an integrated part of the Associated Women—not just a night appendage.)

4. To see that each group, including Business and Professional Women, shares in the budget of the Associated Women of the parish; in the supply box work; in the United Thank Offering, and other projects. Someone in the chapter should obtain from the Rector the names of all Business and Professional Women in the Parish and contact them, inviting them to meetings.
(Especially do Business and Professional Women need to overcome the feeling of "Oh, let us do this one project and please don't ask us to do anything else, we haven't the time." This attitude cuts them off from the stream of parish life.)
5. To aspire to be leaders wherever we are and in whatever we are doing, and to assume our fair share of responsibility. A well planned and smoothly functioning parish program doesn't just happen. All groups, or chapters, must work together. A parish yearbook comparable to the Diocesan yearbook is helpful to each Parishioner.

Mrs. Quin emphasized the fact that Christian fellowship in the Church offers us an opportunity of sharing in what Christ wants us to do, and is a constant day by day challenge.

In the discussion period, reports from each group on how its members participated in the Church projects were given.

Mrs. Maxwell, president of the Associated Women of the Diocese of Dallas, announced that the National Council at 281 Fourth Avenue, New York 10, N. Y., has a book entitled "At the Desk Next to Mine" which she thought might be helpful to the groups of Business and Professional Women.

The meeting was adjourned at 4:45 p. m.

The 28th Annual Assembly of the Daughters of the King met in St. David's Church, Austin, Sunday, January 25th, 1948, at 3:30 P. M. with Mrs. Henry C. Brandt, presiding. Two verses of the hymn were sung followed by the motto of the Order and a prayer.

The address of welcome was given by Mrs. John C. Mackay of St. Catherine's Chapter, Austin, and the response by Mrs. Violet C. Greenhill, Trinity Chapter, Houston.

The minutes of the previous meeting and the treasurer's report read and accepted. Roll call showed 21 delegates, 20 members and 20 visitors—this number was increased by 20-odd late comers who chose to hear the Bishop's report.

The president gave a condensed report of the year's activities and thanked all members for their co-operation. She made special mention of the two new chapters at Orange and College Station—thus increasing our membership.

Mrs. L. W. Matteson made a splendid report on the Endowment Fund and told of the object—to maintain a field worker. She reported that the Diocese of Texas leads in contributions to this fund. The amount is \$132.50, contributed this year.

In the absence of the chairman of the Trinity fund, Mrs. A. F. McClellan, the report was read by Mrs. O. C. Bryan, who told of the purchase of a communion service sent to St. John the Baptist, Tyler (negro). There is a balance of \$328.75 in this fund.

A wonderful report was made by Carolyn Patterson of St. Stephen's, Houston, for the four Junior chapters—Trinity, St. Mark's and St. Stephen's of Houston and St. Augustine of Galveston. It is encouraging to know that this work is progressing and thus training our young women to become senior Daughters and spread Christ's Kingdom and strengthen the spiritual life of the church.

The necrology report was made by Mrs. Paul R. Coffey of St. Mark's. During the past year the Daughters of the King have sustained a deep loss in the active membership by death of:

She was an inspiration and a guide to other devoted and loyal members.

A short dedicatory prayer followed this report.

Letters were read from the Rev. Mr. Doremus, Texas City, Mrs. W. H. Hinson, sister of Mrs. Windham and from Mrs. Shannon, the national president of the Daughters of the King. She told of the death of the late president, Mrs. Pedder. She suggested that we begin thinking about the Triennial in San Francisco in 1949 and begin to prepare an exhibit from the Diocese of Texas.

We had short talks made by Mrs. S. W. Wells, of the Diocese of West Texas, who is national chairman of the Endowment Fund, by Mrs. Quin, Mrs. W. E. Japhet and Mrs. Pennybacker, president of the Associated Women of the Diocese.

An address was made by the Rev. Balfour Patterson who said that the Daughters could act as a shock troop. As the divine spark came to the apostles and permitted God to work through them so might the Daughters of the King, with God's direction, prove the channel through which may flow the spirit of Evangelism. With this thought he challenged the Daughters of the King "Go ye into all the world" to every mission. The Daughters should be consistent in their Christianity.

A short greeting from Bishop Quin was most welcome as he gave us words of encouragement and commendation. He urged us to heed Bishop Sherrill's recommendation for the lenten study book—"Revive thy church—beginning with me" by Shoemaker.

A study of the handbook created quite a bit of interest. Mrs. Wells proved very valuable in this discussion.

BE IT RESOLVED That this Assembly express appreciation to the Rt. Rev. Clinton S. Quin, Bishop Hines, the Rev. Mr. Patterson and the Rev. Mr. Gibson, the diocesan officers, the members of the St. Catherine's Chapter, the members of St. David's Church and all others who helped to make this Assembly a success.

Mrs. P. W. Kittrell, chairman of the nominating committee presented the following slate: President—Mrs. Frank Brady, Christ Church, Houston; Vice-President—Mrs. Francis Woessner, Trinity, Houston. There were no nominations from the floor. Moved and seconded that the nominations be closed and the secretary instructed to cast the ballot.

The retiring president called upon the Rev. Robert T. Gibson to install the new president, Mrs. Frank Brady, who accepted this office with words of humble appreciation asking for the prayers and co-operation of each member of the Order. The Rev. Mr. Gibson closed our meeting with prayer.

This report would be incomplete without a word of appreciation to Mrs. Mackay, president of St. Catherine's Chapter, All Saints Church, the other members of that Chapter and to the women of St. David's for their very warm hospitality and gracious entertainment.

CONSTITUTION OF THE ASSOCIATED WOMEN OF THE CHURCH IN THE DIOCESE OF TEXAS

Article I—Name.

The name of this organization shall be The Associated Women of the Church in the Diocese of Texas.

It is affiliated with the National Council of the Protestant Episcopal Church of the United States of America through the medium of the Executive Board of the Women's Auxiliary.

Article II—Object.

The object of this Association shall be to relate the entire womanhood of the Diocese to the whole task of the Church, through a program of worship, study, service, gifts, and fellowship in the five fields of service: the Parish, the Community, the Diocese, the Nation, and the World.

Article III—Membership.

The members of this Association shall consist of all women's organizations in the Diocese of Texas.

Any Parish or Mission organization which (a) shares in the Maintenance Fund, the United Thank Offering, and the Supply Department; (b) makes an annual report to the President of the Association, shall be considered in good standing.

Article IV—Officers and Chairmen.

The officers of the Association shall be a President, a Vice-President, a Vice-President for each Convocation, a Secretary, a Treasurer, a Parliamentarian and a United Thank Offering Treasurer.

There shall be the following Chairmen: Devotional, Educational, Nominating, Supply Box, Christian Social Relations, Bishop Kinsolving Memorial Fund, Publicity, Rural Education, Camp Allen, Ditty Bag Chairman and Co-Chairman, Personnel Chairman, a Church Periodical Club Director, and such others as shall be found necessary.

Article V—Meetings.

Section 1. The Annual Meeting of the Association shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Executive Board.

Section 2. Each Parish or Mission shall be entitled to vote through its delegates. Each organization shall be entitled to as many as four delegates. If there be no organized women's work, a delegate may be appointed by the Rector, Priest in Charge, or by the Bishop.

Section 3. Each Parish and Mission is expected to be represented at the Annual Meeting.

Article VI—Amendments.

This Constitution may be amended at any Annual Meeting by two-thirds vote of the Delegates present, provided the amendment or amendments be submitted to each organization two months before the Annual Meeting.

BY - LAWS

Article I—Duties of Officers.

Section 1. The President shall preside at all meetings, and perform all other duties appertaining to the office.

Sec. 2. The Vice-President shall preside and assume the duties of the office of President in case she is unable to serve. She shall be the Chairman of the Year Book Committee.

Sec. 3. The Vice-President of the several Convocations shall co-operate with the Diocesan President, and the Deans of the Convocations in all Diocesan work, each in her own Convocation, and act as a liaison officer with the Diocesan Board. She shall serve as a member of the Finance Committee and Nominating Committee.

Sec. 4. The Secretary shall keep a record of proceedings of all meetings, and in the absence of the President and Vice-President, call the meeting to order and preside until a Chairman is selected. She shall also keep a correct list of Officers and Committee Chairmen with their addresses; give notices of all meetings, both the Annual Meetings and the Executive Board, and shall keep a record of the women's organizations in the Parishes and Missions and the Officers thereof; she shall carry on the correspondence of the Executive Board at the direction of the President, including sending out report blanks in December to all Parishes and Missions.

Sec. 5. The Treasurer shall have charge of all monies (except the United Thank Offering and the Bishop Kinsolving Memorial Fund), and distribute same according to instructions. The Treasurer's books shall be audited during the first two months of each year, and the Treasurer shall mail to each Parish or Mission President a copy of the budget, as set up for the next year, at least one month before the Annual Council Meeting. She shall also serve as Chairman of the Finance Committee referred to in Article II, Sec. 3, By-Laws.

Sec. 6. The Parliamentarian shall pass on any question of Parliamentary Procedure. She shall serve as Chairman of Constitution and By-Laws Committee whenever Amendments to the Constitution or By-Laws are to be considered.

Sec. 7. The United Thank Offering Treasurer shall promote the work of the United Thank Offering and furnish Blue Boxes and U.T.O. leaflets to all Parishes and Missions. She shall devise the means of placing a Blue Box in the hands of every woman in the Diocese. She shall keep a list of contributing organizations and receive semi-annual offerings. She shall keep the Diocese informed of the progress of the offering and each third year make it ready for presentation at the United Thank Offering Service of the Women of the Church.

Sec. 8. The Devotional Chairman shall keep in touch with all Parishes and Missions, furnishing suggestions and material for Devotional programs. She shall mail literature to be used on the first Friday in Lent for the World Day of Prayer, and shall also co-operate in the observance of the Church-Wide Day of Prayer, November the eleventh. She shall be responsible for the devotions at all Executive Board meetings and the Annual Meeting.

Sec. 9. The Educational Chairman shall co-operate with and follow the recommendations of the Educational Secretary of the National Board of the

Women's Auxiliary; report plans and activities to the Executive Board of the Associated Women of the Diocese at each regular meeting; keep the Department of Christian Education, of which she is a member, as a representative of the Associated Women, informed of her work with the Women's groups; and report to the Executive Board of the Associated Women, the activities of the Department of Christian Education.

Sec. 10. The Nominating Chairman shall, with her committee composed of the four convocation Vice-Presidents, present nominees for officers and chairmen, to be selected at the Annual Meeting, for delegates to Provincial Synod and Triennial Meeting, and she shall further present nominees to fill vacancies on the Board between Annual Meetings. At least one month before the Annual Council the Chairman shall mail to all parish Presidents a list of the offices to be filled at the Annual Meeting, together with the nominations to be presented at the Annual Meeting. A short statement of the qualifications of each nominee shall be attached to such notice.

Sec. 11. The Supply Chairman shall assign to the various Parish and Mission organizations lists of boxes as requested by the National Supply Secretary and have charge of preparation of any Diocesan box. She shall promote throughout the Diocese interest in the work of the Supply Department. She shall present semi-annual reports to the National Supply Secretary.

Sec. 12. The Church Periodical Club Director shall promote interest throughout the Diocese in carrying out the purpose of the C. P. C. which is to bring together those who have reading matter to share and those who for one reason or another do not have it. Especially is she to encourage the sharing of suitable literature with Missions, Church Schools, reading rooms, libraries, hospitals, theological students and other places and persons as the occasion may arise. The first Sunday in May is designated as C. P. C. Sunday and it will be her duty to remind the Parishes of same.

Sec. 13. The Chairman of Christian Social Relations shall seek to stimulate interest and cooperation in the work of the Department of Christian Social Relations and to urge the Women of the Church throughout the Diocese to participate in its general program. She shall act as representative of the Associated Women of the Church to that Department, attend all meetings and carry out to the best of her ability the program as outlined by the Department.

Sec. 14. The Bishop Kinsolving Memorial Fund Chairman shall have charge of the Book of Remembrance, stimulate interest in the Fund, and receive and account for memorial gifts.

Sec. 15. The Publicity Chairman shall serve as liaison officer for the women throughout the Diocese, using *The Texas Churchman* as a means of keeping Parish and Mission groups in touch with each other and with the news of the Diocese and National Church. The Chairman shall work constantly toward increasing the circulation of the magazine "Forth." The office shall serve as a clearing house of ideas of practical helpfulness and of news of general interest.

Sec. 16. The Rural Education Chairman shall, under the direction of the Bishop, contact people of the Diocese who are unable to receive the ministration of the Church, and supply them with literature.

Sec. 17. The Ditty Bag Chairman and her Co-Chairmen shall secure Ditty Bags when requested for the Seamen's Institutes in Houston and Port Arthur to be distributed on Christmas morning.

Sec. 18. The Camp Allen Chairman shall cooperate with the Director of Camp Allen, particularly in securing the help of the Women's organizations in furthering interest in and supplying the needs of Camp Allen.

Sec. 19. The Personnel Chairman shall cooperate with, and follow the recommendations of, the Personnel Chairman of the National Board of the Women's Auxiliary and use her best efforts to interest the young women of the Diocese in training for vocational work in the Church.

Sec. 20. Each Diocesan officer shall present a written report of her work at each regular Executive Board meeting and at the Annual Meeting.

Sec. 21. All books shall be closed on December 31st, and all reports shall be in the hands of the President by January 5th.

Article II—Finance.

Section 1. Operating expenses of this Association, such as printing of the Year Book, supplying prayer leaflets, and other incidental expenses in connection with the Women's work in the Diocese shall be met by a Maintenance Fund.

Sec. 2. Each Parish and Mission organization shall be asked to contribute in proportion to its ability to the pledges of this Association, and to such other objects as may be recommended by the Executive Board or voted at the Annual Meeting. This, together with the Maintenance Fund, constitutes the Budget.

Sec. 3. There shall be a Finance Committee, composed of the Treasurer and the four Convocational Vice-Presidents, to prepare the Budget and to decide upon the tentative apportionment for each Parish organization.

Article III—Election of Officers

Section 1. The election of officers shall be by ballot and shall be held at the Annual Meeting, a majority of votes cast being necessary for election.

Sec. 2. The Secretary may be instructed to cast the ballot when there is only one nominee for an office.

Sec. 3. Only officers and duly accredited delegates may vote at an election.

Sec. 4. The term of each officer shall be two years, with the exception of the United Thank Offering Chairman, whose term shall be three years, to correspond with the Triennium. No officer shall serve more than two consecutive terms, except the Treasurer and any officer who shall have served half of one term, shall thereafter serve only one term.

Sec. 5. Officers shall be elected in the following groups, one group each year:

- (a) Vice-President Northwest Convocation, Vice-President Southeast Convocation, Supply Box Chairman, Christian Social Relations Chairman, Personnel Chairman, Church Periodical Club Chairman, Publicity Chairman, Vice-President, Recording Secretary, Educational Chairman, Camp Allen Representative, Member-at-Large.
- (b) President, Vice-President Northeast Convocation, Vice-President Southwest Convocation, Nominating Chairman, Rural Education Chairman, Bishop Kinsolving Memorial Fund Chairman, Constitution Chairman, United Thank Offering Chairman, Devotional Chairman, Treasurer, Members-at-Large (2), Ditty Bag Chairman.

Article IV—Quorum.

One-fourth of the members having a right to vote shall constitute a quorum at the Annual Meeting.

Article V—Elections.

Section 1. At the Annual Meeting preceding the Provincial Synod five delegates and five alternates shall be elected. In case the elected delegates are unable to attend, the Diocesan President shall, with the Bishop's approval, appoint women to act in their stead.

Article VI—Executive Board.

Section 1. The Officers, Committee Chairmen, three Members-at-large, Adviser in Christian Education, a representative from the Daughters of the King, representative from the Young Churchmen, the wives of the Bishop and Bishop Co-adjutor of the Diocese, together with members and ex-members of the National Executive Board who reside within the Diocese, shall constitute the Executive Board of the Association.

Sec. 2. The Executive Board shall transact business between the Annual Meetings, suggest general plans for the development of the Women's work in the Diocese, fill vacancies within the Board between Annual Meetings and re-allocate any lapsed balances that are in the Treasury at the end of the year.

Sec. 3. The Executive Board shall meet quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President or two members of the Board.

Sec. 4. Thirteen members shall constitute a quorum at Board meetings.

Article VII—Amendments.

These By-Laws may be amended or suspended by a two-thirds vote at any Annual Meeting.

FOR A PRESIDENT


