## DO YOU KNOW?

1. What is THE ASSOCIATED WOMEN OF THE DIOCESE OF TEXAS?

The Associated Women of the Diocese of Texas is the over-all organization of Church women, set up to serve the Church in every phase of its life and in all fields of its activity. (Associated Women is just another way of saying: Woman's Auxiliary.)

2. Who belongs?

Every baptized woman is eligible and is theoretically a member, but women become *active members* upon joining in the work of a parish group or guild.

3. What is the goal of the Associated Women?

The goal is that *every* woman of the Church shall assume her responsibility for the whole mission of the Church.

4. What is meant by the UNIFIED PROGRAM?

The Unified Program means that all parish guilds and organizations, while retaining their own group work and projects, also work with and through the general organization of the Associated Women, towards the program of the National Church.

5. How do members seek to carry out this Program?

Through: Worship, Study, Service, Gifts and Fellowship in the

five Fields of service: Parish, Community, Diocese, Nation and the World.

6. How can we be sure Worship is given first place in our women's meetings?  
Start the New Year with Installation Service (see back of book) a Corporate Communion Service when possible. This service of dedication gives a spiritual tone to the work undertaken by the officers and encourages them to plan a year of thought-provoking devotionals for their meetings.
7. What activities in the national program are the parishes expected to support?  
ALL. But to be an active member of the Associated Women of the Diocese, the parish organization must support the United Thank Offering, the Supply Box and pay their diocesan assessment.
8. Is money enough?  
No, each year a study program should be given to learn the work done by the National Church in Missions and what we do through our United Thank Offering and Supply Box. Such help is obtained from the chairmen of Religious Education, United Thank Offering and Supply Box.
9. How can Business and Professional Women participate?  
By having an organization, which takes its part in the program of the local parish and the National Church. By the Associated Women having one or more night meetings, when the Business Women may meet with the other groups of the parish and discuss the whole program of the church.
10. What is meant by Co-operating Organizations?  
Co-operating Organizations are church organizations which have their own national set up (as Daughters of the King and the Church Periodical Club, etc.) but who do cooperate with National Woman's Auxiliary and participate in the parish unified program.
11. How is the diocesan budget met?  
Woman's work should be financed through a carefully prepared budget, covering the five fields of service. Each parish and mission organization of women is assessed its fair share for the diocesan budget.
12. How can the resources at National Headquarters be used by parish women?
  1. Find out what is available, through the Diocesan Officers or by writing directly to 281 Fourth Ave., New York 10, N. Y., to the Executive Secretary of the National Woman's Auxiliary. Use this material for worship and study. (Set up a parish library to lend such material.)
  2. ACT. When asked to co-operate on any part of the national program, seek information first, then act.
13. Why do we have Provincial Organization?  
The General Convention and the Triennial Meetings are held only

every three years, but the Provincial Synod meets during the other two years, for education and promotion. This includes discussion of the problems and projects within the province. The whole program of the Church may be interpreted to a greater number in these smaller meetings, and plans may be made to integrate the programs of the dioceses.

14. What can Diocesan Officers do for parish groups?
  - a. They can help parish groups set up or improve their parish organizations.
  - b. They can explain and interpret the work of the various national departments, as, United Thank Offering, Christian Social Relations, etc.
  - c. They can help parish groups to get acquainted with the material available from the national church; to find new ways to carry out the national program and feel closer to the national church.
15. What can women in mission churches do for the diocese? They can participate in the program of the Associated Women: Worship, Study, Service, Gifts, and Fellowship. Specifically they can take part in the United Thank Offering, the Supply Box, pay their part of the diocesan budget, and send delegates to council.
16. What can one woman do?
  - a. Worship — individual and corporate prayers.
  - b. Study — To increase knowledge of the Church, of its heritage, its projects and current problems.  
To create an understanding of the need in the mission field.  
To understand the economic and social problems of the day, that are of vital concern to the Church.
  - c. Service — Teach in Sunday School.

## 2ND ANNUAL LAKE BUCHANAN CONFERENCE, 1948.

"Effective Program for a Witnessing Church" was the theme at the second annual conference June 15, 16 and 17 of the Executive Boards of the Woman's Auxiliaries of the Dioceses of the State of Texas.

Mrs. H. W. Whinfield, President of 5th Province, was leader. After detailed discussion of techniques of program planning, the conference divided into groups who put into practice the points brought out. The following are examples of the type of program planning that is done in A WORKSHOP.

### 10 TIPS ON PROGRAM PLANNING

#### 1. KNOW YOUR PEOPLE.

Do your best to discover what makes them "tick". If what you have for them to do is something better than they can think up for themselves, you've won.

#### 2. PLAN YOUR WORK AND WORK YOUR PLAN.

Almost all of us agree on the need for planning our work in advance, because if we don't, confusion results. However, it doesn't do a bit of good to plan your work unless you are ready to work your plan. Many a plan looks fine on paper but somehow or other never materializes.

#### 3. SHARE THE PLANNING.

A lot of people enjoy planning; so it isn't fair to do all the planning and then just tell other folks to carry out your plan.

#### 4. EMPHASIZE EXPLORATION.

Try to give each person a chance to find out things for herself. This is hard to do if we set out to have everyone do the same thing in the same way. Make an opportunity for each to fit herself into the program and do the thing she is interested in.

#### 5. ENTHUSIASM IS CATCHING.

Yes, enthusiasm is catching, but you can't catch it where it isn't. Put it where others can catch it. Even the tone of your voice helps!

#### 6. WORK ON AN "ACHIEVEMENT" PROGRAM.

It's lots more fun to work with a definite goal in sight. Always have an objective.

#### 7. Anticipation BUILDS INTEREST.

It's pretty hard to get people interested in events that are coming if they don't know what those events are. Therefore it is a good idea to plan the high spot for your program many months in advance and let people know about them.

#### 8. HAVE A THEME EACH MONTH.

Try to give a different experience each month. Even a year's program can be pretty aimless unless it is pointed up!

#### 9. STAGE IT WELL!

Naturally you are not a stage manager or director of dramatics

but in order to get the most out of your program you must plan in such a way that you get the greatest possible effect. Make use of all the "showmanship" you can muster.

10. **KEEP IT FUN.**

The best of us like to be merry. Auxiliary can be "fun." Your women have a "fun yard stick" with which to measure what we are trying to get them to do. Even work can be fun if we approach it in the right way.

## PROGRAM WORKSHOP

### World Mission of the Christian Church

This program is planned for an average size parish, not too small or yet too large. The Women in the parish will take care of all committees, but will bring in outside speakers.

- I. **OBJECTIVE:** To educate and quicken the interest of the women in the world mission of the church.
- II. **PROGRAM — PURPOSE:** To further the world mission of the christian church.
  - a. **TITLE:** They Found the Church There.
  - b. **Method of presentation:** A panel discussion.
    1. **Necessary Arrangements:**
      - a. Choose three speakers and a moderater, who have special ability and qualifications.
      - b. First panel member to take the Pacific Islands and the Church. Second panel member to take China and the Church. Third panel member to take Japan and the Church. Moderator to bring out through discussion the steps of "finding" the Church, in the Islands of the Pacific and in China and even in Japan.
    2. **Committee Assignments:**
      - a. Planning Committee, to arrange for whole meeting and make necessary arrangements for the program.
      - b. Exhibits (or visual Education) committee, to arrange atmosphere through charts, maps, handwork and products of the places to be mentioned.
      - c. Music and worship committee: (Jesus Shall Reign) Hymn No. 480, in old Hymnal, No. 542, new Hymnal.  
Read poem: "The Black Angel"  
Scripture: Matthew 28: Verses 19 and 20.  
Prayers: A Missionary's Thanksgiving, (page 64, Prayers Old and New). For Workers in Lonely Places, (page 8, A Calender of Prayer for Missions).  
Close meeting with singing: Christ for the World We Sing, No. 486, old Hymnal, No. 537 new Hymnal.
      - d. **Promotion and Publicity.**  
Use Church bulletin, local Newspapers, postcards to remind members, posters in Parish House, and Telephone.

- e. Resource Material used:
  - “They Found the Church There,” by Van Dusen.
  - Design for Action,
  - The Strength to Build, Unit 4, on The World Mission of the Christian Church.
  - Personal experiences of men, women and chaplains who *were there*.
- f. Visual aids — Exhibits.
- g. Follow Up Committee: To strengthen mission work. Findings and recommendations, given in report of Findings Committee.
- Action Committee: To see that recommendations are given publicity and carried out. (These two committees may report at the next meeting, or at more than one meeting.)

## REPORT ON THE WOMAN'S AUXILIARY MEETING, PROVINCE OF THE SOUTHWEST

### IN RE: "WORM'S EYE VIEWS" . . .

One seldom takes issue with a Bishop—even a Coadjutor. But word has gotten around that after hearing Bishop Hines present what he called a "worm's eye view" at the recent Diocesan Council, there were some who felt that having a REAL "worm's eye view" was NOT among those privileges accorded a Bishop—even a Coadjutor!

With this opinion in mind may I, as the most junior member of the Diocese of Texas delegation to the Provincial Synod, present my credentials as a bona fide "worm's eye viewer"? The last week in October 1948 Mrs. P. V. Pennybacker, Mrs. Fred Catterall, Jr., Mrs. Julia Coddou, Mrs. J. M. Moore Jr. and your accredited Worm's Eye journeyed to St. Louis, Missouri for a meeting of the Seventh Province, the Province of the Southwest. I come from a middle-sized church in a middle-sized town in the middle of Texas and this was my first time to see our Church at work in one of the larger fields. The challenge and the wonder of it are with me yet!

### FROM THE HIGHWAYS AND BYWAYS . . .

The tremendous scope of the Synod as seen in St. Louis was fascinating. Dioceses and missionary districts that make the Seventh Province are Missouri, West Missouri, Kansas, Salina, Arkansas, Oklahoma, New Mexico and Southwest Texas, Dallas, North Texas, West Texas and Texas. The Woman's Auxiliary report lists some 42,350 women as representing the church in this area, and names about 392 parish and mission groups.

I was very much interested in the many different types of women who came to the Synod. There were the ultra-sophisticated and fashionably dressed "city gals," there were the wide-eyed and well shod townswomen, there were the modestly turned out and fascinating women from rural and missionary areas. There were all shades and varieties of churchmanship exhibited both by the delegates and the clergy present. All were welcomed and found a place—all came to share a common task—all represented the Episcopal Church at work—all of us knelt together as one body in Christ.

To say it was thrilling is a rank understatement—to say it was unforgettable is but to state a simple truth.

### FLING OUT THE BANNER . . .

Business as such became a lively tool in the hands of experienced officers. The Budget emerged not as mere figures but rather as the personalities the figures represented—for instance, the young people themselves who will use and work with the \$500 allotted them for 1949; the native Liberian teachers who will be aided by a \$200 scholarship fund; the Bishop of Hankow, China—Bishop Tsang—who was granted a discretionary fund of \$300. This budget is supported by diocesan pledges.

You will be interested to know that Mrs. P. V. Pennybacker was chosen to chair the important new "Program and Conference Committee." Her report as President of the Diocese of Texas was

enthusiastically received and commented upon frequently. Mrs. Julia Coddou presented a comprehensive report on the Christian Social Relations work in the Province. Mrs. J. M. Moore Jr. was in charge of exhibits from the Diocese of Texas.

Reports of other presidents showed wide and varied activity and program among the women in the Province, with four main things receiving chief impetus: the United Thank Offering, the development of the personal devotional life, leadership training, and the unified program for women's work. It was also noticeable that an increasing amount of attention was being given all phases of Youth Work.

#### THE V.I.P.I.\* . . .

MRS. ARTHUR SHERMAN spoke on OUR TASK IN A DISORDERED WORLD, basing her suggestions to the women on her experiences during trips to the Orient (the Philippines and China), the International Conference in Canada, the Amsterdam Conference, and the Lambeth Conference.

MRS. CLINTON S. QUIN presented in her own vivid way an unforgettable picture of the visit she and our Bishop had in England this past summer during the Lambeth Conference.

THE RIGHT REVEREND HENRY KNOX SHERRILL, Presiding Bishop of the Church, discussed with the Provincial delegates some of the problems which are facing our Church at work in the world today, and made some suggestions on possible ways of meeting these problems.

GENERAL LEE, head of the Brotherhood of St. Andrew, addressed the joint luncheon, giving from the layman's point of view a discussion of the vital problem facing churchmen today—are you willing to witness to God by taking your place as a leader in the world peace movement?

NATIONAL OFFICERS, such as the Reverend John Heuss of the new Department of Christian Education and Mr. Jordan of the Department of Promotion were kept overtime by large joint meetings deep in discussion of plans and work throughout the National Church. The high calibre of leadership available to us through the present national staff, both lay and clerical, is most inspiring and gives a vision of much accomplishment possible ahead.

#### OF FROGS IN BIG AND LITTLE PONDS . . .

Throughout the Synod was stressed the idea of the parish as the center of the church, but also was faced the fact that there is nothing more limiting than a parish that lives for itself alone. Every personality connected with this meeting left the challenge for us to give to each individual group, be it six or six hundred, the WORLD WIDE VISION of our Church and the WORLD WIDE TASK which it faces.

In each discussion group, in every speech there was inescapable emphasis on the fact that without the cooperation of each small parish group none of the fine visions and detailed plans and exten-

sive expenditures of the National Council can hope for more than 20% effectiveness.

What are YOU doing about your 80%?

#### YOUR PART IN THIS 80% . . .

Analysis of the Synod reveals general trends of discussion and thought grouping the outstanding present problems we face much as follows:

Stewardship  
Education  
Personnel

Lack of world-wide vision  
Christian Social Relations in toto  
*Immediate* need of Evangelism

Suggested means of meeting these problems were definite and provocative. They are usable by individuals and groups alike. Here is something YOU can do about it:

#### STEWARDSHIP:

1. Work for better education, principally adult, regarding the total program of our Church
2. Become and secure more consecrated laymen and women
3. Help to secure better trained TEACHING clergy

#### EDUCATION:

1. Take the time and trouble to train better lay-teachers for Sunday School and adult programs
2. Have more GOOD training institutes
3. Enlist interested lay people in church work
4. Cooperate actively with the new Department of Christian Education

#### PERSONNEL:

1. Find yourself people interested in lay and clerical work and show them the opportunities for fascinating service
2. Use channels such as young people's organizations and the thousands of unchurched for enlistment sources

#### LACK OF WORLDWIDE VISION:

1. Use of unified programs
2. Incorporate actively in parish and mission education

#### CHRISTIAN SOCIAL RELATIONS:

1. The primary relationship—do unto others
2. Study the displaced persons problem—plan action
3. Study, work and support the United Nations program
4. Bring out and study plans of action for local and state problems of social relations

### IMMEDIATE NEED OF EVANGELISM:

1. The primary relationship—"Lord, revive Thy Church, beginning with me."
2. Seek the unchurched in your local communities
3. Spread the word of need of workers in definite foreign mission fields—interest specific people

### BRIGHTEN THAT CORNER . . .

St. Louis is a long way from home for some of us. Friends and workers even within the Church can seem remote and unknown occasionally. To many of us in smaller churches in our own local communities it seems from time to time that the "flickering torch we yield" individually is such a terribly tiny pinpoint of light to help in piercing such a vast darkness.

And yet if you are ever lucky enough to catch a glimpse of the larger Church in action the vast tapestry of light which is her Vision and Spirit is unavoidably recognized. And one cannot escape the realization that such a gleaming, such an illumination, is utterly impossible—it could not be—except for the myriad of tiny lights kept alive in the hearts and in the hands of individual churchmen in their own home towns.

## OFFICERS REPORTS FOR 1948

### PRESIDENT'S REPORT

To the Associated Women of the Diocese of Texas:

At the end of the year 1948, and the beginning of the centennial for our diocese, it is my privilege to report to you on the state of the work of the women—what have we done—you and your Executive Board, working together. There has been marked progress, for which we are all grateful, but there are still many, many things to do, which are a challenge to us, as Christian women.

For the year 1948, the Executive Board outlined certain things which we hoped to accomplish in the new year, or at least show some improvement:

1. The first of these was to bring ever more and more women into the active work of the church, until we had reached the ideal of *every woman* in the Diocese giving the best of her talents in the work for God's Kingdom. There has been some gain in this field, but not enough. We are not trying as we are capable of doing, to interest all women, to learn what *their* special talents are, to recognize *their* potential leadership and through fellowship with them help them to find *their* work in the church. This work should become a crusade for all of us.

2. We called for the help of every woman to carry the good news of the United Thank Offering, to all our organized groups. The number of women who are using the "blue boxes" to help express their gratitude to God, for our blessings, has increased. But it is not enough! Too many women are being denied, or are denying themselves the great privilege of sharing through the United Thank Offering.

3. We are proud of the response to the Presiding Bishop's Fund for World Relief. May we keep this cause in our hearts and minds, as long as there is need for food, clothing and material relief.

4. We have been active in our Christian Social Relations and Evangelism work. Many parish organizations have given generously to express their faith in democracy and brotherhood. Some have not yet seen that no one, no parish, no country can live for themselves alone. This is truly One World, in our needs, and our problem is to see that it becomes One World in spirit.

5. Interest in Youth Work has increased among the women. This is very heartening.

6. The response to the Amsterdam Questionnaire was practically one hundred percent. This and other work with the Council of Church Women has been outstanding.

7. The replies to the questionnaire sent out by the National Executive Board, in cooperation with the United Council of Church Women, on Segregation and Minority Groups, was less than fifty percent.

8. The educational program in many places has taken on new life and the will to study has increased. This is most encouraging.

9. Publicity about and the work for the resolution on Fuller Participation of Women in the Life of the Church, has been handled in an efficient and dignified way, by Mrs. Davis Faulkner. We are in

no way discouraged about this matter, those things which are right in God's work, will end in the right way.

For all the excellent work which has been done by the various departments, not mentioned here; by the Members-at-Large, by our capable Secretary and Treasurer and Nominating Chairman, and the Honorary Members I am most appreciative.

For the reports from the parishes and missions, which have shown Christian women, in action; for the great personal friendship and loyalty which has been shown your president, I am deeply grateful and in humility want to thank each of you, for the work you have done, for the example you have set, for all of us. I will try to follow your lead and to live up to your expectations, with God's help.

Since this will be my last report to you, as President of the Diocesan Women, I would like to leave this thought with you: People everywhere, in the pew next to us, in our town, in the countries across the world, are longing for and seeking the security of God's love. May we as Christian women never forget that what we are and what we do is tremendously important to them. It expresses more than any word we can say, how deep is our feeling of security and peace in the living Christ. May we never cease to pray for the needs of others and that we in our lives and deeds may recognize these needs and so order our lives that we can pray sincerely and fervently for the coming of Christ's Kingdom. Lord, revive Thy Church, beginning with me.

I sincerely feel that the work of the United Thank Offering has been extended in our diocese this year. An increase is shown over last year not only in the amount of the offering, but in the number of contributors, which is more important. Not until every woman in the diocese is thoughtfully and prayerfully using a blue box will our goal be realized.

I have had the faithful and interested cooperation of every United Thank Offering Secretary in the diocese, as well as the help of the vice-presidents of the four convocations.

There were 82 churches out of the 90 churches in the diocese that sent in Thank Offerings in 1948. The spring offering represented 75 churches and the fall offering 78 churches.

City-wide services were continued in Austin and Houston.

All records, correspondence and distribution of materials in connection with the work of the Thank Offering is up-to-date. 2,000 blue boxes and 5,000 pieces of literature were sent out during the year.

## REPORT OF CHRISTIAN SOCIAL RELATIONS CHAIRMAN

January 1948 - January 1949

Christian Social Relations encompasses so many phases of Christian life and problems that it is a vast field, limited only by the time and effort you—either individually or as groups—are willing to devote to it.

In a simple analysis Christian Social Relations is simply the actual application of the teachings of Christ to the needs of man. At the Buchanan Dam conference our inspiring leader brought out that the spiritual needs and the physical needs of man are so closely allied (using the Cross as a symbol) that you can not reach out before you reach up and that you can't reach up without reaching out. It might seem that the efforts of the Christian Social Relations committees tend more toward the physical than toward the spiritual, but it must be borne in mind that when you better man's physical condition or environment, you place him in a more receptive mood to approach him spiritually.

With that thought in mind I urge you to participate to the fullest extent possible in the various programs of the National Church: United Thank Offering, Supply Box, Presiding Bishop's Fund, Kinsolving Memorial Fund, Church Periodical Club, etc.

You may be interested to learn that in addition to participating in these various programs, St. George's of Port Arthur has for the past two years been contributing \$50.00 per month to Bishop Huang in China to pay the salaries of native workers in his diocese. It is my understanding that St. Philip's of Palestine has also contributed to Bishop Huang's program. This, to my mind, is an outstanding piece of work being done by a *comparatively small group of women* and is cited as an example of the possibilities in the field.

One of the most urgent needs of the day is proper care for the aged. A survey and study of this problem is one that we might well adopt as a major project. Older people face many real prob-

lems today: physical handicaps, unemployment, inadequate housing, and lack of normal social contacts. Members of the Episcopal Church are concerned about the large number of our own Church people who are improperly cared for in their old age. Any thoughts or suggestions on this matter will be welcomed.

Since the Texas Legislature was not in session in 1948, there was little to be done in that connection. You will probably have various legislative matters brought to your attention during the coming year.

Your Chairman met with the Associated Women in April at Holy Trinity, Dickinson; September, Church of the Redeemer, Houston; November, St. George's Port Arthur, and St. George's, Texas City. I found the women in these parishes not only extremely *interested* in the welfare of their own communities, but *actively engaged* in serving the needs of their parishes and surroundings.

Your Committee is interested in knowing of your activities and problems. You can be very helpful in setting out a constructive program by advising us of your present activities and contemplated expansion of your program. Your Chairman is ready at all times to meet and confer with you.

I attended the Annual Council in Austin in January; the quarterly meetings of the Executive Board, and the Buchanan Dam Conference, at which I received a great deal of knowledge, help and inspiration.

Miss Turnbull was ably assisted by Miss Mary Louise Villaret, Educational Director for the Diocese of West Texas, our own Lynette Giesecke, both former students of Windham House, the Rev. Gray Blandy, representing Episcopal Student work at the University of Texas, the Rev. P. W. Hirst, Student chaplain for Episcopalians at the University of Houston, Mrs. Joseph Mares, a very interesting lay speaker from Dickinson, and Bishop Hines who spent an afternoon with us and gave a very inspiring talk on women's work in the Church.

It was very gratifying to the Personnel Committee that the Executive Boards of the Dioceses of Texas voted this past June at

their annual meeting to make the conference an annual one to be supported by all the Dioceses, and the second conference is to be held again this March.

#### REPORT OF SUPPLY BOX CHAIRMAN

The Supply Department is the channel through which the women of the church provide clothing, household and institutional supplies to both domestic and overseas mission areas. These needs are met with both goods and, when more practical, money to purchase same.

Your diocesan supply secretary works directly under the National Secretary who sends out the assignments from her office. Requests are made to her by the Bishops of dioceses and missionary districts.

We of the Diocese of Texas are usually given three assignments per year which are divided among the various parishes and missions by your Supply Secretary and whenever possible the parishes and missions are expected to take part in this work as the demand grows each year.

A group of women (one from each convocation) working with the Devotional Chairman in an effort to develop and deepen the prayer and worship life of the women of the diocese.

*How is this done?*

1. By studying, evaluating and making available to individuals and groups the best material for either group or individual needs.
2. By meeting with groups to plan quiet days and retreats.
3. By suggesting methods of prayer that will quicken church women to their responsibility in strengthening the spiritual life of the home, the nation and the world.
4. By being available for consultation when needed.
5. By working closely with program chairmen when plans for year are being developed in order to give real spiritual meaning to programs, and to relate the devotions to the subject matter of each meeting.
6. By working with the U. T. O. Chairman to help develop a consciousness of our manifold blessings for which we should give thanks.

May the work of God's Kingdom go forward in our own lives, and in our associations with our fellow men.

## REPORT OF THE CHAIRMAN OF THE BUSINESS AND PROFESSIONAL WOMEN

The work with business and professional women of the diocese has gained considerable momentum during the past year. The fine talk which Mrs. Quin gave at our meeting in Austin last January inspired several groups to organize and I have tried to work from this springboard. Minutes of the meeting have been helpful through the year. A chapter president quoted from them to me quite recently.

Among the new chapters, which now are flourishing, are those at the church of the Good Shepherd, Houston; St. Mark's, Beaumont; St. Stephen's, Houston. St. Marks Chapter in Houston has become reactivated.

Meeting with these new groups, as well as with some of the old established chapters, has been most interesting and inspiring to me. Certainly, I have got more out of it than I have been able to put into it.

Most of the business and professional womens' chapters are well integrated with the unified program of the women of the church. And they are making their contributions to general parish work. For instance, at one small church with no parish secretary, the business and professional women regularly handle the bulk of the mail for the rector; an active member of another chapter now is doing publicity for the Christmas play of St. John's school; a chapter president, who is particularly qualified by training and experience, is serving as co-chairman of her church's building fund campaign; and it is traditional for still another chapter to serve breakfast for the annual Men's Advent Corporate Communion.

Those parishes which use the available professional talent of their working women benefit and it helps to give these women a sense of belonging that some of them may not have had before. In a number of parishes the presidents of these chapters are automatically on the executive boards of their women's associations and this is as it should be. Several associations plan one night meeting a year so that all of the women of the church can attend.

These are specific ways that closer integration is being developed now. Further work in this direction and the selection of suitable names for these chapters should be objectives for next year.

ment "Church School by Mail." Two children were given scholarships to the Midget Session at Camp Allen this year.

There are 136 names on the adult mailing list and 23 on the children's.

Mrs. McBride has asked that I include in this report a special plea for help with her "Church School by Mail." She feels that we should all seek out, not only Episcopalians but those children who are unaffiliated with any church, who are living in isolated sections.

Will you please cooperate with Mrs. McBride and me in our efforts to bring the Church to the isolated?

#### REPORT OF REPRESENTATIVE FOR YOUNG PEOPLE'S WORK

As the year 1948 draws to a close and "stock taking" is the order of the day, a review of the record made by the boys and girls in our Church Schools and by the Young Churchmen of the Diocese shows marked progress. These young people and their adult leaders have

been about our "Father's business" with unwearying diligence. Briefly, here are some of the results that are most noteworthy:

The local youth program, where the real test of effective work may be applied, has been strengthened. Church Schools have increased in membership, quality of work has improved, leaders emphasizing more and more the best educational values of the day in training boys and girls for Christian living and citizenship, beginning with the home and extending "unto the uttermost parts of the earth." Young Churchmen have evidenced renewed zeal in "bringing others to the Master"—evangelism has been stressed continually by the young people themselves in plans and activities for the year.

On the Diocesan level, regular activities were carried forward with outstanding increase in interest, attendance, and *representation* of parishes and missions, e.g., at the Lenten Offering Institutes and Festival Services, Vacation Church Schools, the annual Church School Workers' Conference at Camp Allen and the Young Churchmen's Council, the latter having the most representative group that has ever attended a youth Council in the Diocese. Two new enterprises for the further development of youth were initiated, namely, the Traveling Institutes on Vacation Church Schools, and the Young Churchmen's Workshop at Camp Allen to train young people in sponsoring and leading Vacation Schools in missions and in their local churches. Both the institutes and workshop met with enthusiastic response and real success!

As a vital, meaningful program of Christian education for youth filters through our churches, new members—children and parents—are brought into "the fellowship," and those already sharing the privileges and responsibilities of this continuing fellowship, receive fresh interpretations of truth and renewed enthusiasm and strength for the glorious task of Kingdom building. The women of the Diocese have contributed tremendously to this infiltration through their active interest and leadership in local and Diocesan projects. They have given generously of their time and substance to provide scholarships to Camp Allen and the Youth Vacation School Workshop for missions. Many and varied are the ways in which you have aided in the development of the youth program, and we are deeply grateful!

With your continued cooperation, the boys and girls of the Diocese of Texas can eagerly look forward in faith to the new day with its ever-widening opportunities for service to the glory of God.

#### CHURCH PERIODICAL CLUB REPORT FOR 1948

The Church Periodical Club celebrated its sixtieth anniversary this year. Starting in 1888 as one woman's practical solution to a problem, the C. P. C. has grown until it is today one of the cooperating organizations of the National Council, with a director in each diocese, and a secretary in nearly every parish through the country.

The purpose of the Church Periodical Club is to supply with religious and secular magazines, books, new Christmas and Easter Cards, all kinds of games and pictures, etc. to the Church's mission-

aries, clergy, missions, schools, and individual lay people both at home and abroad.

In each parish and diocese the work is self-supporting, each group having its own means of raising the necessary funds for local work and for contributions to the general work, such as the National Book Fund, Quin Student Book Fund, and the Tokyo Project.

Joining the C. P. C. is as simple as putting a plain wrapper around your already read magazine and mailing it to your C. P. C. friend in Arizona or Maine, in Alaska, Puerto Rico, or Liberia.

At the triennial meeting held in Philadelphia in September 1946, the Church Periodical Club voted to undertake a special project for the next three years. This was to be the task of raising at least \$5,000 for books for the library of the Central Theological College in Tokyo.

To date \$3,393.66 has been received leaving at least \$1,606.34 to be raised between now and next September.

It is earnestly hoped that when we meet in San Francisco next fall, Mrs. A. R. McKechnie, as Chairman of the fund will be able to announce with pride that the C. P. C. has completed its project.

All members and friends of the Church Periodical Club are asked to make the first Sunday in May of each year a day of remembrance, praying especially at the Holy Communion that the workers may have faith and perseverance and the work be a means of bringing many into the kingdom of God.

#### REPORT OF CAMP ALLEN REPRESENTATIVE

Camp Allen was attended this year by three hundred seventy persons. Of this number fifty were leaders; one hundred forty church school workers, and one hundred eighty campers. In 1947 there were two hundred seventy four campers.

This decline in attendance was directly due, of course, to the Polio scare, but, even after taking that into consideration, the Camp Allen Committee feels that the people of our Diocese do not use camp as training potential leaders for the Church and that they could train more if they had them to train.

In order to create more interest, the Chairman of one Committee is sending a letter to all women's organizations in the Diocese. He suggests that the women might help by (1) Talking Camp Allen (2) Bringing a group down some weekend for a retreat, quiet day, conference, etc. (3) Setting aside a sum in the budget for the establishment of scholarships.

The Committee is hopeful that the Diocese may become so conscious of the important work Camp Allen is doing that it will assume more and more the responsibility of upkeep in order that the committee may concentrate all its efforts upon the improvement of the program.

# MINUTES OF ASSOCIATED WOMEN, JANUARY 24, 1949

## TRINITY CHURCH, HOUSTON, TEXAS

### MONDAY

The Associated Women of the Church in the Diocese of Texas met in Annual Session, January 24, 1949, at Trinity Church, Houston, Texas.

The Forty-Eighth Annual Meeting was called to order at 2:00 P. M. in Trinity Church, by Mrs. Fred W. Catterall, Jr., Vice-President, presiding in the absence of the President, Mrs. Percy V. Pennybacker, Jr.

A prayer of guidance was given by Mrs. Wayne Buchanan, Devotional Chairman, and Hymn 535, "Rise Up O Men of God" was sung.

Mrs. Charles H. Stevens was introduced as the Chairman on Dispatch of Business.

Mrs. Ralph Gunn, Christ Church, Houston, Texas, speaking for Mrs. James Haralson, President of the Associated Women of Christ Church, welcomed the delegates and visitors of the session, and graciously thanked the women of Trinity Church for the use of the church as a meeting place. The response was given by Mrs. Starr Kealhofer, Church of the Good Shepherd, Austin.

Mrs. Catterall presented the Program Chairman, Mrs. Arthur Knapp of Trinity Church, Houston, who in turn introduced Mrs. Theodore O. Wedel, Member of the National Auxiliary Executive Board, who gave a very interesting and enlightening talk on "Learn to Live." Mrs. Wedel stressed the need of better religious education both at home and for Foreign Missions.

Roll call of the Parishes and Missions revealed 213 Delegates, 190 Visitors, and 29 Executive Board Members, a total of 432 persons.

Mrs. John Moore, Jr. of Richmond, Texas, introduced Mrs. C. S. Harrington, delegate to the Amsterdam Assembly, who gave a very descriptive and inspirational review of the activities of the World Council of Churches. She emphasized the importance of Missions throughout the world, knowing the Leaders in your own church and what Reconstruction of the world means to displaced persons throughout the world.

Mrs. Ben Phillips, Chairman of the Finance Committee then presented the proposed budget for the year 1949:

TUESDAY

January 25, 1949

The meeting was called to order by the President at 9:00 A. M., January 25, 1949, in Trinity Church, Houston, Texas.

The meeting was opened with the singing of Hymn 554, "Lead On O King Eternal." A short Devotional talk was given by the Devotional Chairman based on "Sharing Our Knowledge," which was followed by prayer led by Mrs. Buchanan.

Mrs. Pennybacker expressed her regret at not being able to attend the opening session.

The minutes of the last meeting were read, and after minor corrections, approved.

The President asked Mrs. Charles Stevens, Chairman of the Dispatch of Business, to announce the program for the morning.

The Nominating Chairman, Mrs. Byram, presented the following slate of officers:

Mrs. Byram moved that this report be accepted. This was duly seconded and carried. The President called for nominations from the floor, there being none, Mrs. Kittrell moved that nominations be closed. Seconded and carried. Mrs. Julia Coddou made a motion that the Secretary be instructed to cast the ballot. This motion was seconded and carried and the Secretary then cast the ballot for the slate of officers presented by the nominating committee.

Mrs. Pennybacker presented the new officers and Mrs. P. W. Hirst, Personnel Chairman, Mrs. Thomas Hale, Vice-President of the Central Convocation and Mrs. R. M. Thomson, Jr., Altar Guild Chairman, also new members of the Board.

Miss Patty Williams, Constitutional Chairman, presented the following proposed changes to the Constitution and By-Laws:

Constitution: Article IV.

Add Altar Guild Chairman to the list of Chairmen.

A motion was made that this be added, seconded and carried.

By-Laws:

Sec. 5. The Treasurer shall have charge of all monies except the United Thank Offering, the Bishop Kinsolving Memorial Fund, the Supply Box and the Church Periodical Club. Mrs. Wayne Buchanan made a motion that this addition be made. The motion was seconded and carried.

Sec. 10. The Nominating Chairman shall, with her committee composed of the (strike out four and make it five) Convocational Vice-Presidents. Mrs. James Allen made a motion that this change be made. Seconded and carried.

Sec. 20, changed to read: The Altar Guild Chairman shall bring to the Executive Board the specific needs in the way of linens and other equipment, of the new missions in the Diocese, and such other altar needs as may come to her attention. She may through publicity in the Texas Churchman set forth such needs to the Diocese; or anyway she may devise, try to meet these needs, with the cooperation of the Executive Board. A motion was made that this item of duties of Altar Guild Chairman be added to By-Laws. The motion was seconded, and carried.

Sec. 20 shall become Sec. 21, and Sec. 21 shall become Sec. 22. Mrs. Bussey made a motion that the numbering be changed. The motion was second and carried.

Article III — Election of Officers:

Sec. 4. Where it says, "No officer shall serve more than two

consecutive terms, etc.," shall be changed to read: No duly elected member of the Executive Board shall serve more than two terms —etc. Mrs. Atkisson, St. Mark's Church, Beaumont, Texas, moved that this section be accepted as read. Motion was seconded.

Mrs. Byram made a substitute motion that the matter of election of officers be referred to the Committee to revise the Constitution and By-Laws. This motion was seconded and carried.

The President called for a vote on the original motion. Motion lost.

#### Article IV — Quorum

Strike out entire Article IV and changed to read:

#### Article IV — Election of Delegates

Sec. 1. At the Annual Meeting preceding the Provincial Synod, five delegates and five alternates shall be elected. In case the elected delegates and alternates are unable to attend, leaving less than the number of five representatives, the President of the Executive Board shall, with the Bishop's approval, appoint women to act in their stead.

A motion was moved and seconded that this change in By-Laws be accepted. Motion carried.

Sec. 2. At the Annual Meeting preceding the Triennial, six delegates and one six alternates shall be elected, one of the delegates and one of the alternates to be a Negro woman. In case the elected delegates and alternates are unable to attend, leaving less than the number of six representatives, the President of the Executive Board shall, with the Bishop's approval, appoint women to act in their stead. The sixth delegate represents a minority group numbering at least 250.

A motion was made that this Section be added. Duly seconded, motion carried.

#### Article V—Strike out entire article and change to read:

#### Article V — Quorum

Sec. 1. One fourth of the members having a right to vote shall constitute a quorum at the Annual Meeting.

Motion by Mrs. Catterall that this be left to the Committee on Revision of the Constitution. Motion seconded and carried.

Sec. 2. Eighteen members shall constitute a quorum at a Board Meeting.

A motion by Mrs. Selig that this change be made. The motion was seconded and carried.

### Afternoon Session

The meeting was called to order by the President at 1:30 P. M. January 25, 1949, in Trinity Church, Houston, Texas.

The meeting was opened with the reading of the minutes of the morning session by the Secretary. After correction, the minutes were approved.

Mrs. Stevens announced the order of business for the afternoon session.

Mrs. Wayne Buchanan made a motion that the Executive Board be empowered to approve the minutes of the afternoon session at the next Board meeting. Duly seconded, the motion carried.

Mrs. Byram, Chairman of the Nominating Committee, presented nominations for delegates to the Triennial meeting in San Francisco. The panel of nominees presented by Mrs. Byram were:

A motion was made by Mrs. James Allen that nominations be closed. Motion seconded and carried.

The President asked Mrs. W. B. Gardner, Mrs. Hiram Salisbury, and Mrs. Sam Lyons to act as tellers.

Votes were cast by secret ballot and the committee retired to count the votes.

The program continued and Mrs. Knapp presented Mrs. Stanley Swift, who in turn, presented the other members of the program. It was a most entertaining and interesting quiz program based on the United Thank Offering. Those taking part in the program were:


Mrs. Stevens announced the meeting places for the officer's group meetings.

### MINUTES OF THE THIRD ANNUAL MEETING

**Business and Professional Women of the Diocese,  
Christ Church, Houston, Texas, January 23, 1949**

The third annual meeting for Business and Professional Women of the Episcopal Church of the Diocese of Texas met Sunday, January 23, 1949, at 3:00 o'clock p.m., at Christ Church, Houston, Texas. Mrs. Alice Bruce Currin, of Trinity Church, Houston, presided. Mrs. Emma Butler of St. Stephen's Church, Houston, acted as secretary, and the Reverend Arthur S. Knapp, Rector of Trinity Church, Houston, gave the Devotional.

The minutes of the last meeting were read and approved.

Forty-six representatives of sixteen parishes answered automatic roll call.

Mrs. Currin then introduced our guest speaker, Mrs. Theodore O. Wedel, stating that she is the wife of Canon Wedel of the Washington Cathedral, that she has been recently elected President of the Associated Women of the Diocese of Washington, is a member of the Executive Board of the Women's Auxiliary to the National Council, and is Chairman of the Department of Christian Social Relations of the United Council of Church Women.

Mrs. Wedel opened her talk by stating that she was always glad of an opportunity of speaking to business and professional women, that she wanted organizations such as ours to feel closer to the Women's National Executive Board, that there are a great many business women in the Church and that many are beginning to be aware of the business women in the Church. It is only the last 10 or 15 years that Churches are waking up to the fact of the great potentialities of the business women, that some of the most able women in the Church are those in the business world. She stated that business women are a distinctive part of the working of the Church. She asked us to think of the contributions we can make to the life of the Church. Very often the business women have more time than the so-called "women of leisure" as they have learned to use and budget their time. Mrs. Wedel divided her talk into three parts:

1. Why I think the Church work and the Church and Christian religion are so important right now.
  - (a) Increased power of destruction of life makes Peace a must.
  - (b) Christian Faith of enough individuals makes Christian Nations.
  - (c) Christian Faith is the only thing that can save the world.
2. What is our place, as women, in this business of the Christian Church.
  - (a) Think and study about policy making of Church.
  - (b) Be willing to be leader of study classes, or at least take part in one.
  - (c) Be an Evangelist.
  - (d) Attend church services.
  - (e) Give financial support.
3. What do we do about it? Get beyond the 2nd grade in our religious education.
  - (a) Entering into the fellowship of the Church—in wholehearted cooperation.
  - (b) Taking part in the women's organizations of the Church.
  - (c) Attending conferences, and meetings such as this one.

- (d) Reading religious magazines, reading about the Church, reading books about religion.
- (e) Getting study groups together, even if only three or four in a group. It may be the nucleus for a great movement.
- (f) Missing no opportunity to learn. Being better informed Christians makes better Christians.
- (g) Praying more. Doing something about our devotional life.
- (h) Learn about United Thank Offering and make it a part of your devotional habits.

The meeting adjourned at 4:15 p.m.

## CONSTITUTION OF THE ASSOCIATED WOMEN OF THE CHURCH IN THE DIOCESE OF TEXAS

### Article I — Name.

The name of this organization shall be The Associated Women of the Church in the Diocese of Texas.

It is affiliated with the National Council of the Protestant Episcopal Church of the United States of America through the medium of the Executive Board of the Women's Auxiliary.

### Article II — Object.

The object of this Association shall be to relate the entire womanhood of the Diocese to the whole task of the Church, through a program of worship, study, service, gifts, and fellowship in the five fields of service: the Parish, the Community, the Diocese, the Nation, and the World.

### Article III — Membership.

The members of this Association shall consist of all women's organizations in the Diocese of Texas.

Any Parish or Mission organization which (a) shares in the Maintenance Fund, the United Thank Offering, and the Supply Department; (b) makes an annual report to the President of the Association, shall be considered in good standing.

### Article IV — Officers and Chairmen.

The officers of the Association shall be a President, a Vice-President, a Vice-President for each Convocation, a Secretary, a Treasurer, a Parliamentarian and a United Thank Offering Treasurer.

There shall be the following Chairmen: Devotional, Educational, Nominating, Supply Box, Christian Social Relations, Bishop Kinsolving Memorial Fund, Publicity, Rural Education, Camp Allen, Personnel, Church Periodical Club, Business and Professional Women, Altar Guild and such others as shall be found necessary.

### Article V — Meetings.

Section 1. The Annual Meeting of the Association shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Executive Board.

Section 2. Each Parish or Mission shall be entitled to vote through its delegates. Each organization shall be entitled to as many as four delegates. If there be no organized women's work, a delegate may be appointed by the Rector, Priest in Charge, or by the Bishop.

Section 3. Each Parish and Mission is expected to be represented at the Annual Meeting.

### Article VI — Amendments.

This Constitution may be amended at any Annual Meeting by two-thirds vote of the Delegates present, provided the amendment or amendments be submitted to each organization two months before the Annual Meeting.

## BY - LAWS

### Article I — Duties of Officers.

Section 1. The President shall preside at all meetings, and perform all other duties appertaining to the office.

Sec. 2. The Vice-President shall preside and assume the duties of the office of President in case she is unable to serve. She shall be the Chairman of the Year Book Committee.

Sec. 3. The Vice-President of the several Convocations shall co-operate with the Diocesan President, and the Deans of the Convocations in all Diocesan work, each in her own Convocation, and act as a liaison officer with the Diocesan Board. She shall serve as a member of the Finance Committee and Nominating Committee.

Sec. 4. The Secretary shall keep a record of proceedings of all meetings, and in the absence of the President and Vice-President, call the meeting to order and preside until a Chairman is selected. She shall also keep a correct list of Officers and Committee Chairmen with their addresses; give notices of all meetings, both the Annual Meetings and the Executive Board, and shall keep a record of the women's organizations in the Parishes and Missions and the Officers thereof; she shall carry on the correspondence of the Executive Board at the direction of the President, including sending out report blanks in December to all Parishes and Missions.

Sec. 5. The Treasurer shall have charge of all monies (except the Church Periodical Club, Supply Box, United Thank Offering and the Bishop Kinsolving Memorial Fund), and distribute same according to instructions. The Treasurer's books shall be audited during the first two months of each year, and the Treasurer shall mail to each Parish or Mission President a copy of the budget, as set up for the next year, at least one month before the Annual Council Meeting. She shall also serve as Chairman of the Finance Committee referred to in Article II, Sec. 3, By-Laws.

Sec. 6. The Parliamentarian shall pass on any question of Parliamentary Procedure. She shall serve as Chairman of Constitution and By-Laws Committee whenever Amendments to the Constitution or By-Laws are to be considered.

Sec. 7. The United Thank Offering Treasurer shall promote the work of the United Thank Offering and furnish Blue Boxes and U.T.O. leaflets to all Parishes and Missions. She shall devise the means of placing a Blue Box in the hands of every woman in the Diocese. She shall keep a list of contributing organizations and receive semi-annual offerings. She shall keep the Diocese informed of the progress of the offering and each third year make it ready for presentation at the United Thank Offering Service of the Women of the Church.

Sec. 8. The Devotional Chairman shall keep in touch with all Parishes and Missions, furnishing suggestions and material for Devotional programs. She shall mail literature to be used on the first Friday in Lent for the World Day of Prayer, and shall also co-operate in the observance of the Church-Wide Day of Prayer, November the

eleventh. She shall be responsible for the devotions at all Executive Board meetings and the Annual Meeting.

Sec. 9. The Educational Chairman shall co-operate with and follow the recommendations of the Educational Secretary of the National Board of the Women's Auxiliary; report plans and activities to the Executive Board of the Associated Women of the Diocese at each regular meeting; keep the Department of Christian Education, of which she is a member, as a representative of the Associated Women, informed of her work with the Women's groups; and report to the Executive Board of the Associated Women, the activities of the Department of Christian Education.

Sec. 10. The Nominating Chairman shall, with her committee composed of the five convocation Vice-Presidents, present nominees for officers and chairmen, to be selected at the Annual Meeting, for delegates to Provincial Synod and Triennial Meeting, and she shall further present nominees to fill vacancies on the Board between Annual Meetings. At least one month before the Annual Council the Chairman shall mail to all Parish Presidents a list of the offices to be filled at the Annual Meeting, together with the nominations to be presented at the Annual Meeting. A short statement of the qualifications of each nominee shall be attached to such notice.

Sec. 11. The Supply Chairman shall assign to the various Parish and Mission organizations lists of boxes as requested by the National Supply Secretary and have charge of preparation of any Diocesan box. She shall promote throughout the Diocese interest in the work of the Supply Department. She shall present semi-annual reports to the National Supply Secretary.

Sec. 12. The Church Periodical Club Director shall promote interest throughout the Diocese in carrying out the purpose of the C. P. C. which is to bring together those who have reading matter to share and those who for one reason or another do not have it. Especially is she to encourage the sharing of suitable literature with Missions, Church Schools, reading rooms, libraries, hospitals, theological students and other places and persons as the occasion may arise. The first Sunday in May is designated a C. P. C. Sunday and it will be her duty to remind the Parishes of same.

Sec. 13. The Chairman of Christian Social Relations shall seek to stimulate interest and cooperation in the work of the Department of Christian Social Relations and to urge the Women of the Church throughout the Diocese to participate in its general program. She shall act as representative of the Associated Women of the Church to that Department, attend all meetings and carry out to the best of her ability the program as outlined by the Department.

Sec. 14. The Bishop Kinsolving Memorial Fund Chairman shall have charge of the Book of Remembrance, stimulate interest in the Fund, and receive and account for memorial gifts.

Sec. 15. The Publicity Chairman shall serve as liaison officer for the women throughout the Diocese, using *The Texas Churchman* as a means of keeping Parish and Mission groups in touch with each other and with the news of the Diocese and National Church. The

Chairman shall work constantly toward increasing the circulation of the magazine "Forth." The office shall serve as a clearing house of ideas of practical helpfulness and of news of general interest.

Sec. 16. The Rural Education Chairman shall, under the direction of the Bishop, contact people of the Diocese who are unable to receive the ministration of the Church, and supply them with literature.

Sec. 17. The Business and Professional Women's Chairman shall work with the Organized Business and Professional Women's Guilds, helping them with their programs, and suggesting ways and means of making them more of an integral part of the Associated Women. She shall also organize guilds for the business and professional women, where ever she can in the Diocese, encourage more and more groups to so organize and carry on the full work of a guild.

Sec. 18. The Camp Allen Chairman shall cooperate with the Director of Camp Allen, particularly in securing the help of the Women's organizations in furthering interest in and supplying the needs of Camp Allen.

Sec. 19. The Personnel Chairman shall cooperate with, and follow the recommendations of, the Personnel Chairman of the National Board of the Women's Auxiliary and use her best efforts to interest the young women of the Diocese in training for vocational work in the Church.

Sec. 20. The Altar Guild Chairman shall bring to the Executive Board the specific needs in the way of linens and other equipment, of the new missions in the Diocese, and such other altar needs as may come to her attention. She may through publicity in *the Texas Churchman* set forth such needs to the Diocese; or anyway she may devise, try to meet these needs, with the cooperation of the Executive Board.

Sec. 21. Each Diocesan officer shall present a written report of her work at each regular Executive Board meeting and at the Annual Meeting.

Sec. 22. All books shall be closed on December 31st, and all reports shall be in the hands of the President by January 5th.

#### Article II—Finance.

Section 1. Operating expenses of this Association, such as printing of the Year Book, supplying prayer leaflets, and other incidental expenses in connection with the Women's work in the Diocese shall be met by a Maintenance Fund.

Sec. 2. Each Parish and Mission organization shall be asked to contribute in proportion to its ability to the pledges of this Association, and to such other objects as may be recommended by the Executive Board or voted at the Annual Meeting. This, together with the Maintenance Fund, constitutes the Budget.

Sec. 3. There shall be a Finance Committee, composed of the Treasurer and the four Convocational Vice-Presidents, to prepare the Budget and to decide upon the tentative apportionment for each Parish organization.

### **Article III — Election of Officers**

Section 1. The election of officers shall be by ballot and shall be held at the Annual Meeting, a majority of votes cast being necessary for election.

Sec. 2. The Secretary may be instructed to cast the ballot when there is only one nominee for an office.

Sec. 3. Only officers and duly accredited delegates may vote at an election.

Sec. 4. The term of each officer shall be two years, with the exception of the United Thank Offering Chairman, whose term shall be three years, to correspond with the Triennium. No officer shall serve more than two consecutive terms, except the Treasurer and any officer who shall have served half of one term, shall thereafter serve only one term.

Sec. 5. Officers shall be elected in the following groups, one group each year:

- (a) Vice-President Northwest Convocation, Vice-President Southeast Convocation, Supply Box Chairman, Christian Social Relations Chairman, Personnel Chairman, Church Periodical Club Chairman, Publicity Chairman, Vice-President, Recording Secretary, Educational Chairman, Camp Allen Representative, Member-at-Large.
- (b) President, Vice-President Northeast Convocation, Vice-President Southwest Convocation, Vice-President Central Convocation, Nominating Chairman, Rural Education Chairman, Bishop Kinsolving Memorial Fund Chairman, Constitution Chairman, United Thank Offering Chairman, Devotional Chairman, Treasurer, Chairman for Business and Professional Women, Altar Guild Chairman and two members-at-large.

### **Article IV — Election of Delegates.**

Sec. 1. At the Annual Meeting preceding the Provincial Synod, five delegates and five alternates shall be elected. In case the elected delegates and alternates are unable to attend, leaving less than the number of five representatives, the Diocesan President shall, with the Bishop's approval, appoint women to act in their stead.

Sec. 2. At the Annual Meeting preceding the Triennial, six delegates and six alternates shall be elected, one of the delegates and one of the alternates to be a Negro woman. In case the elected delegates and alternates are unable to attend, leaving less than the number of six representatives, the Diocesan President shall, with the Bishop's approval, appoint women to act in their stead.

### **Article V — Quorum.**

Section 1. One fourth of the members having a right to vote shall constitute a quorum at the Annual Meeting.

Sec. 2. Eighteen members shall constitute a quorum at a Board Meeting.

## **Article VI — Executive Board.**

Section 1. The Officers, Committee Chairmen, three Members-at-large, Adviser in Christian Education, a representative from the Daughters of the King, representative from the Young Churchmen, the wives of the Bishop and Bishop Co-adjutor of the Diocese, together with members and ex-members of the National Executive Board who reside within the Diocese, shall constitute the Executive Board of the Association.

Sec. 2. The Executive Board shall transact business between the Annual Meetings, suggest general plans for the development of the Women's work in the Diocese, fill vacancies within the Board between Annual Meetings and reallocate any lapsed balances that are in the Treasury at the end of the year.

Sec. 3. The Executive Board shall meet quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President or two members of the Board.

## **Article VII — Amendments.**

These By-Laws may be amended or suspended by a two-thirds vote at any Annual Meeting.


