To The Women of the Church

CALLED UNTO HIS HOLY FELLOWSHIP is still the theme for study and devotions in this second year after our triennial meeting. Just what does that mean for us as individuals? First it means we are Christians, and we should recall that as Christians, we are living under the influence of Jesus, and whatever we do, or whatever we say, or whatever we are, should be measured by the influence of Jesus in our lives.

The world is in dreadful confusion now, but we are Christians and we can be different if we have the courage and the faith to live up to our precious heritage. There are three things we can do:

KNOW SOMETHING: Know our bible, study it. Know what our church stands for, study our new Christian Educational material. Form small groups, for study and prayer. Be an informed Christian, an informed member of our church.

BE SOMETHING: Have the courage to be a Christian! Be not like so many now, who are only **against** things and persons—be for Christianity and let our friends and neighbors know by our attitude towards them and towards life, that we are trying to live in a holy fellowship.

DO SOMETHING: We have the whole program of our church as a field in which to work—the United Thank Offering, in which every woman should be sharing; the Christian Social Relations work with the Displaced Persons, with legislation, with making our communities better places to live; the great, new Christian Education program, with its emphasis on redemption, through love and reconciliation through our relationship with God and our fellow man; and so on through our entire field of work. Know that these are only channels through which God can use us, in this confused and un-Christian world, to help bring in His kingdom.

This is a time for deep analysis, when men and women must search their souls, and search for the implications of membership in any organization and its relevancy for our times. If we believe in the Christian way of life, work for it! If we believe that Christ is our Lord and Saviour, act like it! **Study, pray and work.** For We are called unto His Holy Fellowship.

WOMAN'S AUXILIARY CATECHISM
ASSOCIATED WOMEN
(In the Diocese of Texas)

—QUESTIONS—

WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL is the name given collectively to all women of the Protestant Episcopal Church who pray, give or work for it. What does this mean to you, and me?

OFFICERS of groups within a parish are elected to further the interests of their own groups. Isn't that enough responsibility without added overall inter-group planning?

METHODS are orderly procedures. How does one proceed to build a Unified Program? Through Planning Councils, Inter-group Committees, Mass meetings?

ACTIVITIES vary in interest groups. How can members be persuaded to look beyond their own interest group?

NATIONAL COUNCIL is the name given to the committee of men and women who carry administration of our Church between General Conventions. Isn't that remote from our local Woman's Auxiliary groups?

STUDY, SERVICE, WORSHIP, GIFTS, FELLOWSHIP, form the framework of the Woman's Auxiliary program? How can they suggest an overall theme?

AUXILIARY is another word for helper. How can our Auxiliary groups best live up to this name?

UNITY denotes a state of one-ness. Why is it desirable to have unity of program within a parish?

X represents, in mathematics, an **unknown** quantity. What does it suggest in the work of church women?

INFORMATION and understanding are essential to intelligent action. Isn't our concerted effort more effective if all women respond to it with similar preparation?

LIFE and vitality depend on total cooperation and coordination of members of a body. How does this apply to women's groups in a parish?

IDENTITY involves individuality and distinctiveness. Will the identity of the Woman's Auxiliary be lost if every woman's group is considered part of it?

AUTONOMY leaves us with the right of self-government. Can individual parish groups retain autonomy even though there is overall program planning?

RELIGION and prayer undergird all that the Woman's Auxiliary stands for. Are they not, therefore, our greatest integrating force?

YOU and **YOU** and **YOU** and **I** are the Woman's Auxiliary. Shall we try for a closer relationship between groups in our parishes, that we may offer our maximum of strength to God?

—ANSWERS—

"WE, being many, are one body in Christ, and every one members one of another." This sentence from the Epistle to the Romans accents our indivisibility in the Life of the Church.

OVERALL planning and open-mindedness should facilitate the work of officers and of members, because a widened horizon is stimulating to freedom and growth in the Life of the Church.

MINDS must be made up by those who are actually involved. Meet! Discuss needs and assets. Group dynamics will bring to light common interests in the Life of the Church.

ADOPT an overall theme or project. Study it or give to it or cook for it or pray for it or sew for it or discuss it, respecting and sharing each other's expression of stewardship.

NATIONAL STAFF members of the Woman's Auxiliary and our National Executive Board, elected at Triennial, bridge this apparent gap, interpret needs, suggest program material to keep us abreast of it all.

SITUATIONS vary, all parishes have unique ones, pet projects and individual genius. Use these for the mortar when you build. Study them, pray for them, they will suggest others.

AUXILIARY groups work through universal channels such as the Supply Department, United Thank Offering, etc. Additionally they respond to opportunity for service within the parish, diocese, nation.

UNIFIED PROGRAMS are the most valuable means of attaining common purpose and consequent accomplishment in the Life of the Church.

X suggests, in the work of church women, an **unknowable** quantity which is the sum of all the talents of all the women dedicated to the Life of the Church.

INTER-GROUP MEETINGS are an excellent medium for giving all women a chance to be alert to the important goings-on in the Life of the Church and all women should attend them.

LIKE the members of the human body, individual women's groups may feature specific functions, but all must be headed in the same direction and toward the same goal.

IF there is any woman's group **not** considered part of it, then the identity of the Woman's Auxiliary **will** be lost for its distinctiveness is that it claims **all** women active in the Life of the Church.

ALL women of the parish meet together a stated number of times per year in addition to regular meeting of autonomous groups. There is some give and take, no regimentation.

RELATION in thought between prayer and conduct is not that conduct is supremely important and prayer may help it, but that prayer is supremely important and conduct tests it."

YES, the yardstick of our progress should be willingness of you and me to recognize the call to coordination of effort for the good of all in the Life of the Church.

OFFICERS REPORTS FOR 1951

During the past year of 1950 there have been five regular meetings of your Diocese Board. We have had four very fine area meetings and two convocational meetings.

Once again it is my pleasure to greet the delegates and visitors to our annual meeting.

A personnel conference for young women was held last Spring at Camp Capers and an inter Diocesan Conference in June in Amarillo for Board members. Two outstanding events which took place this year in our Diocese were the opening of a spacious house for the student center at the University of Texas and the Dedication of St. Stephen's School on All Saints' Day. I'm sure we were all filled with joy that we have had a small share in helping these projects.

I have had the opportunity of meeting many of you this year in your own parishes, and as the annual reports began to come in they meant much more to me than before. We have received only sixty-eight reports at this date—this represents about seventy-five per cent of the associations. Some indicate substantial progress, while others reveal a need for extra assistance of some nature.

We have grown! Last year from approximately the same number of reports we had 6,701 women communicants, while we now have 10,000. Instead of 3,010 active women in 1950, we have 4,030. There are only five parishes who do not have the unified program. Every parish reports a United Thank Offering. Only four had a perfect record, with every woman taking part in the U. T. O. Six parishes have no devotions at their Meetings. Eleven have no planned Educational program. Seven report no Supply department. Nineteen no Church Periodical club chairman. Thirty no Christian Social Relations chairman. Forty-six no Personnel chairman. I do not feel discouraged over this because I am sure that the lack of understanding of these departments is what has caused them not to be a part of every parish program.

Christian Social Relations means "showing Christ in your community". Every parish must have a Christian Social Relations secretary. It has been suggested that we have two—one to keep in touch with community social work and one to keep up with congressional movements dealing with social reforms, etc.

The story of personnel work must reach each parish. It is one of the most vital stories in the history of the Church—enlisting young women in using their Church as a vocation.

Supply is still our greatest missionary promotion. Let us not forget that your parish may be the one who has sent in this negative report. Will you make it your business to find out when you go back home? If you find that it is your parish, DO SOMETHING ABOUT IT!

I received a letter from Mrs. Arthur Sherman, our Executive Secretary, in which she quoted a message from a calendar she had received from a Chinese friend: a quotation from Habakkuk 3:17-18, "Although the fig trees shall not blossom, neither shall fruit be on the vines; the labour of the olive shall fail, and the fields shall yield no meat; the flock shall be cut off from the fold and there shall be no herd in the stalls; yet I will rejoice in the Lord, I will joy in the God of my Salvation". She says, "such faith is the fruit of our missionary work. As we pray daily for peace let us constantly hold up in prayer our Chinese christian leaders". "Committed unto us". Let us make a renewal of our committment. Let us build our lives on prayer, seeking Him first and then trying to live with our fellow men the Christian way.

FIRST VICE-PRESIDENT OF PROMOTION

I attended the Annual Diocesan Meeting of the Associated Women in January at Waco. During the year I was present at four Diocesan Board Meetings. Attended an area meeting in Galveston held at Grace Church. Also participated on the program. With the help of the Promotion Committee the 49th Annual Report was compiled and edited. Over 1200 copies were distributed in the following manner.

Packages were sent to the Presidents of 90 churches. A year-book for each current officer. A request was sent to each President she have a conference with her clergy and present him one at this time and go over her program and work with him so he would have an understanding for the work of each Chairman. Ask his help and suggestions in getting the program over. The Clergy is an ex-Officio of the Associated Women.

Single copies were sent to 150 individuals, including our Bishops, Board Members, Contact persons in unorganized missions of the Diocese. To those Presidents of the Southwest Province we had addresses of and to the members of the National Board and to our Provincial President.

Two news letters were sent to the Parish Residents. More would have gone out had news from our Chairman and Parish Presidents been channelled to this department. It is sincerely hoped more news items will be shared with us about the activities of its groups and their accomplishments this year. As it is definitely interesting and stimulating to others to hear what is being done by other groups.

Talks on "How to Deepen the Devotional Life in a Parish" were made to Associations in Austin and Angleton and to two in Houston.

I believe there has been a deepening of the spiritual life in many of the Associations. I desire to help more Associations with special aid, and will do so when I am asked for it.



REPORT OF CHAIRMAN OF PERSONNEL 1950

The term "Personnel" as used in connection with the program of the Associated Women has to do with women workers in the Church. It means recruiting women, training, and placing them, and keeping in touch with them in their work. There is urgent need in the Church today for women in a number of strategic posts. Securing the right woman for its widening vocational opportunities is one of the most important tasks facing the Church. Finding the right person solves problems; accepting the wrong person creates problems.

This statement from the folder "Tell Us About Personnel" sums up the responsibility of the Personnel Committee of the Associated Women in the Diocese of Texas.

We have tried to use channels already set up for presenting the needs to the right people. At Vacation Church School Workshops, Diocesan Summer Conferences, Young People's Meetings, and Business and Professional Women's Meetings we have called to the attention of young women in school and business the opportunities for service through the Church.

In March 1950 at Camp Capers in the Diocese of West Texas a Vocational Conference for College Women was held. Thirty young women from the five Dioceses and Districts of the State spent a week-end together considering how one acts as a Christian in any calling and learning about specific vocational opportunities for women in the Episcopal Church.

On several College campuses at the time of a "Career Day" program we have had the opportunities in the Church presented.

We have kept in touch with the two women workers in the field from this Diocese—Miss Sara White in Japan and Miss Gloria Jameson in Montana, with one now in training at the Philadelphia Divinity School—Mrs. Robert Reid, and have also been aware of our responsibility to those women serving in this Diocese in full time Church jobs. We are looking forward to the summer of 1951 when we hope to have several of our own girls "on the job" in the Diocese through summer service opportunities made available to them in some of our parishes and missions.

In response to a request from Miss Gammack, the Personnel Secretary on our National Staff, we made a contribution from our Minnie B. Taylor Fund to supplement a sadly depleted National Scholarship Fund to help in the training of women preparing for Church vocations.

As your elected representative in this field of Personnel, I am aware of my responsibility and shall endeavor to discharge it, but like all other phases of our program the job can be done effectively only when every woman in the Diocese recognizes her responsibility to see that our finest young women know of this kind of service to which our Lord through His Church may be calling them.

UNITED THANK OFFERING

Report for 1950

It is my belief that more and more women in the Diocese of Texas are entering with enthusiasm into the great work of the United Thank Offering. We are coming to consider it a privilege and a way through which we may daily express our thanks to God for all his wonderful blessings, which flow so abundantly into the lives of all of us.

All records, correspondence, and distribution of materials in connection with the work of the United Thank Offering is up-to-date.

2,000 blue boxes; 3500 pieces of literature; and 3000 blue envelopes were sent out during the year. The two sets of colored slides which we own has been of inmeasurable benefit in arousing interest as well as in sustaining it in this field. By asking for it a large number of women over the Diocese have seen it.

Summary

Eighty-three churches out of 97 in the diocese sent in a Thank Offering in 1950. The Spring Offering showed 81 churches represented and the Fall Offering showed 77 churches represented. I feel as if Prairie View and Bellaire came into the Diocese a bit too late to send in an offering, but they are included in the 97 churches which the fall report shows.

St. Mark's, Gladewater and St. James', La Grange, had 100% participation in both offerings. St. Stephen's, Huntsville; St. Thomas's, Rockdale; St. Mark's, Bay City; and St. John's, Palacios, each had one 100% participation.

 Christian Social Relations embraces anything we do for, or give to our fellowman — this fact was brought out in workshops at Triennial. One of the worst faults of Christians is taking conditions for granted, but there is the challenge that social and political conditions would change for the better if we would do something about them. We agree that Social Relations cover all contacts of our daily lives — the problem is to make them Christian, by sending men with Christian attitudes to represent us in all fields of government and by serving on Boards and committees in our Community and being alert to unmet needs in our community as well as the world. We can express our purpose to cultivate better Christian Relations through

During 1950 your Secretary attended all the necessary detail of correspondence, etc. to keep the affairs of the office in current condition.

I attended three of the quarterly board meetings, but was unable because of illness to attend the Council at Waco and the Amarillo conference. I have answered the invitations of various church groups to meet with them and have sent information and literature to those groups requesting same.

Our major project in 1950 was cooperation with Church World Service, through our National Council, on their Displaced Persons program. This required many hours of necessary detail, upon which I shall not elaborate. We were given some wonderful publicity in this connection in the Houston papers, resulting in literally hundreds of inquiries relative to sponsorship of Displaced Persons. Out of these inquiries we were able to actually secure sponsorship for around fifty of these people (almost twice our quota). Some of these people have arrived and are scheduled to arrive soon. There have been many unforeseen delays in the program. It is to continue throughout most of 1951, so there is still time to file applications. We've covered the "first mile," let's make the second a better one.

In connection with a program for this new year, we could select no better slogan for our work in the file of Christian Social Relations than that adopted as a slogan for Church and Economic Week (Jan. 14th to 20th): "THE HERALD OF A BETTER DAY." Four hundred churchmen gathered at the 1950 Detroit conference on The Church and Economic Life said: "The Gospel is concerned with all the activities of man, individual and social. Therefore, the Christian faith is relevant to the economic order."

Our Christian Social Relations Chairmen, one of the most important offices in the parish, are the guardians in the church and in their communities of the

social order. What are you in your community or your parish doing toward this end? What would an analysis of your efforts during the past year show in Christian influence in your community; in relieving the suffering and bettering conditions for your fellow-men?

Some of our parishes are doing more than their share, but they are unfortunately the exception. Some are doing nothing at all, in spite of the fact that there has never been a time when there is so much to be done. There are reforms to be made, legislation to be enacted to correct unfavorable conditions, relief to be given to the sick and needy, which includes those spiritually ill, as well as those physically afflicted. Could we select a better program for ourselves for this new year than to prepare for and make possible a "better day"? In this troubled, unsettled era, when world conditions seem almost beyond us, there is one thing which it is possible for us all to do — we can all set our own house in order. The net result of this is self-evident. If everyone in the world had his house in order, there would be no unrest — no heart-break — no disbelief — no insecurity. If it is true that "charity begins at home," certainly each of us can help toward a better world order by setting our own affairs in order, then reaching out to help those who are not in position, frequently through no fault of their own, to help themselves.

We all look forward to "The Herald of a Better Day." It can begin with you — today!

We have served as supply-base to St. Michael's Mission to the Arapahoe Indian at Ethete, Wyoming and in addition to new supplies have sent over 1,000 pounds of good warm used clothing which has enabled them to supplement their wardrobes thereby filling a very definite need.

Our assignments have been quite heavy as needs have grown and prices have risen but these will be met as we have always done in the past. Supply is still our greatest missionary promotion.

In June I was one of the three members of the Executive Board to attend the inter-diocesan Conference in Amarilla, with Mrs. West as leader, and served as secretary for one session.

I served on the program committee for the 1951 council, attending the meeting in Galveston July 29th.

The Annual Bishop Quin dinner for Houston Business and Professional Women was postponed this year in deference to the Bryan Green Mission, but requests that it be held this spring are being heard.

It was a real privilege to serve on the board.

REPORT ON YOUTH WORK

The Diocese has recently been divided into 10 areas, regardless of Convocation lines, for the cooperative working units of the YOUNG CHURCHMEN of the Diocese of Texas. The key cities are: SE Houston, NW Houston, Beaumont, Galveston, Nacogdoches, Tyler, Austin, Waco, College Station, Wharton.

Each area has as chairman, a young person, with an adult adviser. The young people, plus half of the adult advisers, from the Executive Board of Young Churchmen; the 10 advisers form the Youth Commission of the Diocese. The Rev. Gordon Charlton is chairman of the Youth Commission of the Department of Christian Education, and Chief Adviser to the Young Churchmen's Executive Board. The Bishops, Canon Hutcheson and Miss Baldwin are ex officio members of both the Commission and Board.

For an informed Associated Women's group, it is important that the parish and mission Associated Women know what the young people are doing and thinking, and to give them a helping hand. These young Churchmen are in their training period — for Associated Women participation, for vestrymen, for Church leadership in every field of endeavor.

CHRISTIAN EDUCATION CHAIRMAN REPORT

The past year has been most satisfactory to your Education Chairman. I have had the privilege of welcoming into the Associated Women of the Diocese, St. Francis, St. Michael's, St. Matthew's, and Bellaire, all of Houston, also St. Francis' of Prairie View. These new groups are enthusiastic and co-operative and promise to be a very real asset to our Diocesan Women's program.

We have been so fortunate to have had Dr. John Huess of the National Council on Christian Education to visit us this year. He stimulated much interest in the new Educational curriculum planned for both adults and children. Canon Ward was also a visitor to a number of churches where he made inspirational talks on adult education. Most of our Women's groups have received with enthusiasm "The Holy Scriptures" and "Chapters in Church History," the first two books in the "Christian Teaching" series.

My mail has been quite heavy with requests for help on program planning and I have sent out many of the study programs recommended by National Council. "Consider the Bible" has been the most popular of the planned programs.

When I sent out the spring packet containing a letter to each of the Christian Education chairmen and brochure of suggested programs, the response was most gratifying. It proved to me that the women of the Diocese do not throw Christian Education material away without a glance at it. The cards I sent out to each parish, requesting a picture of the Church and a program plan or year-book for the Associated Women, were answered promptly. As those who attended Council meeting at Galveston can testify there were very few parishes who did not send in some kind of a picture or program.

It has been a wonderful experience to have served for a year as Christian Education Chairman for the Diocese and I know it has helped to further my own education.

BOOK OF REMEMBRANCE

Report of the Bishop Kinsolving Memorial Fund 1950

The Bishop Kinsolving Memorial Fund is a fund, the interest on which is used to educate young men from the Diocese of Texas, for the ministry of the Episcopal Church. Bishop Quin has reported that the Diocese of Texas has more young men in Seminaries than any other Diocese in the nation. Let us urge all our people, both men and women, to participate in this memorial fund.

This Book has a three-fold purpose. It is a beautiful memorial to the late Bishop Kinsolving.

Secondly it gives all of us an opportunity to perpetuate the names and memory of our loved ones by having their names inscribed in the Book; and

Thirdly, the Book furnishes the Bishop with a trust fund the interest on which is used toward helping young men in the Seminaries. This past year there has been such a great need for funds that an item has been placed in the Diocesan budget.

The Rev. Edmund H. Gibson opened the meeting with prayer. The Rev. Frank Doremus, assisted by the Rev. David McBride, the Rev. Claxton Munro and the Rev. Edmund H. Gibson officiated at the Holy Communion. The Rev. David McBride led the service of Renewal of Vows.

An inspirational meditation was given by the Rev. Claxton Munro on the subject of "Faith in Jesus Christ." He said, "There has been a universal feeling through the ages that forgiveness is accomplished through sacrifice. Forgiveness is accomplished through Christ on the Cross. HAVE YOU A UNITED THANK OFFERING BOX?

**CONSTITUTION OF THE ASSOCIATED WOMEN OF THE CHURCH
IN THE DIOCESE OF TEXAS**

Article I — Name.

The name of this organization shall be The Associated Women of the Church in the Diocese of Texas.

It is affiliated with the National Council of the Protestant Episcopal Church of the United States of America through the medium of the Executive Board of the Women's Auxiliary.

Article II — Object.

The object of this Association shall be to relate the entire womanhood of the Diocese to the whole task of the Church, through a program of worship, study, service, gifts, and fellowship in the five fields of service: the Parish, the Community, the Diocese, the Nation, and the World.

Article III — Membership.

The members of this Association shall consist of all women's organizations in the Diocese of Texas.

Any Parish or Mission organization which (a) shares in the Maintenance Fund, the United Thank Offering, and the Supply Department; (b) makes an annual report to the President of the Association, shall be considered in good standing.

Article IV — Officers and Chairmen.

The officers of the Association shall be a President, a Vice-President of Promotion, a Vice-President of Prayer and Worship, a Vice-President for each Convocation, a Secretary, a Treasurer, a United Thank Offering Treasurer, a Secretary of Christian Education, a Secretaray of Christian Social Relations, a Secretary of Personnel, a Secretary of Supply and a Parliamentarian.

There shall be the following Chairmen: Nominating, Bishop Kinsolving Memorial Fund, Rural Education, Camp Allen, Church Periodical Club, Business and Professional Women, Altar Guild and such others as shall be found necessary.

Article V — Meetings.

Section 1. The Annual Meeting of the Association shall be held at the time and place of the Diocesan Council, the exact time to be arranged by the Diocesan Board.

Section 2. Each Parish or Mission shall be entitled to vote through its delegates. Each organization shall be entitled to as many as four delegates. If there be no organized women's work, a delegate may be appointed by the Rector, Priest in Charge, or by the Bishop.

Section 3. Each Parish and Mission is expected to be represented at the Annual Meeting.

Article VI — Amendments.

This Constitution may be amended at any Annual Meeting by two-thirds vote of the Delegates present, provided the amendment or amendments be submitted to each organization two months before Annual Meeting.

BY-LAWS

Article I — Duties of Officers

Section 1. The President shall preside at all meetings, and perform all other duties appertaining to the office.

Sec. 2. The Vice-President of Promotion shall preside and assume duties of the President in case she is unable to serve. She will direct the Department

of Promotion whose purpose is to promote an understanding of the Church's work and to stimulate interest in all other departments through publicity, speakers bureau, yearbook and any other means she may devise.

Sec. 3. The Vice-President of Prayer and Worship shall be responsible for Retreats and Quiet Days, the observance of Inter-denominational World Day of Prayer and Churchwide Day of Prayer. She shall also prepare materials for devotional services at the Annual Meetings and Diocesan Board Meetings. She shall keep in touch with all Parishes and Missions, furnishing suggestions and material for Devotional programs.

Sec. 4. The Vice-President of the several Convocations shall cooperate with the Diocesan President, and the Deans of the Convocations in all Diocesan work, each in her own Convocation, and act as a liaison officer with the Diocesan Board. She shall serve as a member of the Finance Committee and Nominating Committee.

Sec. 5. The Secretary shall keep a record of proceedings of all meetings, and in the absence of the President and Vice-President, call the meeting to order and preside until a Chairman is selected. She shall also keep a correct list of Officers and Committee Chairmen with their addresses; give notices of all meetings, both the Annual Meetings and the Executive Board, and shall keep a record of the women's organizations in the Parishes and Missions and the Officers thereof; she shall carry on the correspondence of the Executive Board at the direction of the President, including sending out report blanks in December to all Parishes and Missions. An Assistant Secretary may be appointed by the President who will be a non-voting member of the Diocesan Board.

Sec. 6. The Treasurer shall have charge of all monies (except the Church Periodical Club, Supply, United Thank Offering and the Bishop Kinsolving Memorial Fund), and distribute same according to instructions. The Treasurer's book shall be audited during the first two months of each year, and the Treasurer shall mail to each Parish or Mission President a copy of the budget, as set up for the next year, at least one month before the Annual Council Meeting. She shall also serve as Chairman of the Finance Committee referred to in Article II, Sec. 3, By-Laws.

Sec. 7. The United Thank Offering Treasurer shall promote the work of the United Thank Offering and furnish Blue Boxes and U. T. O. leaflets to all Parishes and Missions. She shall devise the means of placing a Blue Box in the hands of every woman in the Diocese. She shall keep a list of contributing organizations and receive semi-annual offerings. She shall keep the Diocese informed of the progress of the offering and each third year make it ready for presentation at the United Thank Offering Service of the Women of the Church.

Sec. 8. The Christian Educational Secretary shall co-operate with and follow the recommendations of the Education Secretary of the National Board of the Women's Auxiliary; report plans and activities to the Executive Board of the Associated Women of the Diocese at each regular meeting; keep the Department of Christian Education, of which she is a member, as a representative of the Associated Women, informed of her work with the Women's groups; and report to the Executive Board of the Associated Women, the activities of the Department of Christian Education.

Sec. 9. The Christian Social Relation Secretary shall seek to stimulate interest and co-operation in the work of the Department of Christian Social Relations and to urge the Women of the Church throughout the Diocese to participate in its general program. She shall act as representative of the Associated Women of the Church to that Department, attend all meetings and carry out to the best of her ability the program as outlined by the Department.

Sec. 10. The Personnel Secretary shall co-operate with, and follow the recommendations of, the Personnel Secretary of the National Board of the Women's Auxiliary and use her best efforts to interest the young women of the Diocese in training for vocational work in the Church.

Sec. 11. The Supply Secretary shall assign to the various Parish and Mission Organizations lists of boxes as requested by the National Supply

Secretary and have charge of preparation of any Diocesan box. She shall promote throughout the Diocese interest in the work of the Supply Department. She shall present semi-annual reports to the National Supply Secretary.

Sec. 12. The Church Periodical Club Director shall promote interest throughout the Diocese in carrying out the purpose of the C.P.C. which is to bring together those who have reading matter to share and those who for one reason or another do not have it. Especially is she to encourage the sharing of suitable literature with Missions, Church Schools, reading rooms, libraries, hospitals, theological students and other places and persons as the occasion may arise. The first Sunday in May is designated a C.P.C. Sunday and it will be her duty to remind the Parishes of same.

Sec. 13. The Parliamentarian shall pass on any question of Parliamentary Procedure. She shall serve as Chairman of Constitution and By-Laws Committee whenever Amendments to the Constitution or By-Laws are to be considered.

Sec. 14. The Bishop Kinsolving Memorial Fund Chairman shall have charge of the Book of Remembrance, stimulate interest in the Fund, and receive and account for memorial gifts.

Sec. 15. The Nominating Chairman shall, with her committee composed of the five convocation Vice-Presidents, present nominees for officers and chairmen, to be selected at the Annual Meeting, for delegates to Provincial Synod and Triennial Meeting, and she shall further present nominees to fill vacancies on the Board between Annual Meetings. At least one month before the Annual Council the Chairman shall mail to all Parish Presidents a list of the offices to be filled at the Annual Meeting, together with the nominations to be presented at the Annual Meeting. A short statement of the qualifications of each nominee shall be attached to such notice.

Sec. 16. The Rural Education Chairman shall, under the direction of the Bishop, contact people of the Diocese who are unable to receive the ministration of the Church, and supply them with literature.

Sec. 17. The Business and Professional Women's Chairman, shall work with the Organized Business and Professional Women's Guilds, helping them with their programs, and suggesting ways and means of making them more of an intergral part of the Associated Women. She shall also organize guilds for the business and professional women. Wherever she can in the Diocese, encourage more and more groups to so organize and carry on the full work of a guild.

Sec. 18. The Camp Allen Chairman shall co-operate with the Director of Camp Allen, particularly in securing the help of the Women's organizations in furthering interest in and supplying the needs of Camp Allen.

Sec. 19. The Altar Guild Chairman shall bring to the Executive Board the specific needs in the way of linens and other equipment, of the new missions in the Diocese, and such other altar needs as may through publicity in the Texas Churchman set forth such needs to the Diocese; or anyway she may devise, try to meet these needs, with the co-operation of the Executive Board.

Sec. 20. Members-at-Large will be assigned duties by the President.

Sec. 21. Each Diocesan officer shall present a written report of her work at each regular Executive Board meeting and at the Annual Meeting.

Sec. 22. Any Board member may appoint, with approval of the President, such persons as she may deem necessary to assist her in the performance of her duties.

Sec. 23. All books shall be closed on December 31st, and all reports shall be in the hands of the President by January 5th.

Article II — Finance.

Section 1. Operating expenses of this Association, such as printing of the Year Book, supplying prayer leaflets, and other incidental expenses in connec-

tion with the Women's work in the Diocese shall be met by a Maintenance Fund.

Sec. 2. Each Parish and Mission organization shall be asked to contribute in proportion to its ability to the pledges of this Association, and to such other objects as may be recommended by the Executive Board or voted at the Annual Meeting. This, together with the Maintenance Fund, constitutes the Budget.

Sec. 3. There shall be a Finance Committee, composed of the Treasurer and the five Convocational Vice-Presidents, to prepare the Budget and to decide upon the tentative apportionment for each Parish organization.

Article III — Election of Officers.

Section 1. The election of officers shall be by ballot and shall be held at the Annual Meeting, a majority of votes cast being necessary for election.

Sec. 2. The Secretary may be instructed to cast the ballot when there is only one nominee for an office.

Sec. 3. Only officers and duly accredited delegates may vote at an election.

Sec. 4. The term of each office shall be three years with no re-election to the same office. Member serving two years or more of unexpired term shall not be re-elected to same office. The Treasurer may serve more than one term.

Sec. 5. Officers shall be elected in the following groups, one group each year:

- (a) Triennial Year. President, Vice-President of Central Convocation, Vice-President Southwest Convocation, Treasurer, Christian Social Relation Secretary, Altar Guild, Nominating Chairman.
- (b) Vice-President of Promotion, Vice-President of Prayer and Worship, Vice-President Northwest Convocation, Recording Secretary, United Thank Offering Treasurer, Personnel Secretary, Church Periodical Club, Camp Allen.
- (c) Vice-President Northeast Convocation, Vice-President Southeast Convocation, Christian Education Secretary, Supply Chairman, Parliamentarian, Bishop Kinsolving Memorial Fund Chairman, Business and Professional Women Chairman, Rural Education Chairman.

Sec. 6. At the Annual Meetings each year, a Member-at-Large shall be elected to serve one year only. Nominations shall be made from the floor. A former Diocesan Board Member is not eligible.

Article IV — Election of Delegates.

Section 1. At the Annual Meeting preceding the Provincial Synod, five delegates and five alternates shall be elected to serve for one year. In case none of the elected delegates are able to attend, the Diocesan President shall with the Bishop's approval, appoint women to act in their stead.

Sec. 2. At the Annual Meetings preceding the Triennial, six delegates and six alternates shall be elected to serve three years. One of the delegates and one of the alternates shall be a Negro Woman. In case the elected delegates and alternates are unable to attend, leaving less than the number of six representatives, the Diocesan President shall, with the Bishop's approval, appoint women to act in their stead.

Article V — Quorum.

Section 1. The majority of the members having a right to vote shall constitute a quorum at the Annual Meeting.

Sec. 2. A Majority shall constitute a quorum at Board meetings.

Article VI — Diocesan Board.

Section 1. The Officers, Committee Chairman, three Members-at-large, Advisor in Christian Education, a representative from the Daughters of the King,

representative from the Young Churchmen, the wife of the Bishop and wife of the Bishop Co-adjutor of the Diocese, together with members and ex-members of the National Executive Board who reside within the Diocese, shall constitute the Diocesan Board of the Association.

Sec. 2. The Diocesan Board shall transact business between the Annual Meetings, suggest general plans for the development of the Women's work in the Diocese, fill vacancies within the Board between Annual Meetings and re-allocate any lapsed balances that are in the Treasury at the end of the year.

Sec. 3. The Diocesan Board shall meet quarterly, time and place to be decided by that body. A called meeting may be held at the request of the President or two members of the Board.

Sec. 4. The Executive Committee composed of President, 1st. Vice-President, 2nd Vice-President, Secretary and Treasurer shall have the authority to act in emergency between Diocesan Board Meetings.

Article VII — Amendments.

These By-Laws may be amended or suspended by a two-thirds vote at any Annual Meeting.

Robert's Rules of Order to be used as the authority on procedure.

Reverend Sir, the members of the Woman's Auxiliary of Church have indicated their faith and trust in these women by electing them as their officers for the coming year. On behalf of the Auxiliary, I present them to you for installation.

I install you into the office of to which you have been elected; and may God grant you grace and wisdom faithfully to exercise the duties thereof.

Mrs. Wm. M. Douglas, Chairman of Camp Allen was introduced and she announced that the Executive Board has voted to donate a sum of \$250—to purchase a public address system for the camp.

The following were introduced as the Courtesy Committee: Mrs. Fred Gilbreath, Mrs. Irma Warren and Mrs. H. A. Salsbury.

The President gave her report for the year 1950.

Mrs. Ben Phillips, Program Chairman, was introduced. She announced that discussion groups would be held in the afternoon and all delegates should be prepared with their problems. These problems would be presented at the group meetings for discussion.

The meeting reconvened at 2:30 p. m. The guest speaker, Mrs. David B. West of Minneapolis was presented by the Program Chairman.

The delegates and visitors were divided into six groups for discussion periods; the group leaders being Mrs. W. E. Japhet, Mrs. H. C. Fitzgerald, Mrs. Joe Davis, Mrs. J. L. Allen, Mrs. A. L. Selig and Mrs. B. R. Parrish.

The Devotional Chairman gave the Benediction and the meeting was adjourned.

Tuesday, January 23, 1951

The meeting was called to order by the President, Mrs. Starr Kealhofer at 9:30 a. m. in the First Baptist Church in Galveston. The meeting was opened with the singing of the hymn, "Dear Lord and Father of Mankind" and a prayer by the Devotional Chairman, Mrs. J. L. C. McFaddin.

The Dispatcher of Business, Mrs. Fred Catterall, gave the order of business.

The minutes of the opening session were read by the Secretary, Mrs. J. Bob Lewis, and after slight correction, approved.

The Executive Board was introduced to the Women by the secretary calling the name and office on the Board.

Mrs. Ben Phillips read letters of thanks from 3 missionaries to whom the Associated Women sent Christmas checks.

The Treasurer, Mrs. Ben Phillips, Trinity Church, Galveston, presented the proposed budget for the year as follows:

Mrs. Phillips made a motion that the budget be accepted and the motion was seconded and carried.

The Secretary gave a report on the attendance which revealed 226 delegates and 101 alternates and visitors and 26 members of the Executive Board. Total 353.

Named to serve one year as delegates to the Provincial Synod were Mrs. Starr Kealhofer of Austin, Mrs. J. J. Menke of Hempstead, Mrs. C. L. Hufsmith of Palestine, Mrs. John D. Kelley and Mrs. C. R. Darling of Houston. Alternates were Miss Lucille Duffy of Palacios, Mrs. L. A. Peterman of Navasota, Mrs. Carroll Allen of Lufkin and Mrs. C. H. Harrison of Waco.

Mrs. J. R. Spillet made a motion that this report be accepted. This was duly seconded. The President called for nominations from the floor. There being none, a motion was made that the nominations be closed and the secretary be instructed to cast the ballot. This motion was seconded and carried and the secretary then cast the ballot for the panel of officers and delegates presented by the Nominating Committee.

The question of a Spring Conference to be held for the Church Women of the Diocese came up for discussion. The secretary read the following recommendation—"The Executive Board recommends to the Associated Women that

a Spring Conference be held in April at Lakeview, the Methodist Camp, 12 miles out from Palestine."

This was discussed and explained by Mrs. P. W. Hirst, Mrs. Joe N. Davis and Mrs. P. V. Pennybacker, Jr., Board members. Questions were asked from the floor. Mrs. W. J. Kelley, St. Stephen's, Houston made a motion that the recommendation for a Spring Conference be accepted and that a committee be appointed by the President to work out plans and details. The motion was seconded and carried by an almost unanimous vote.

The following committee was named by Mrs. Kealhofer to plan the conference; Mrs. John Moore, Mrs. Joe Davis, Mrs. A. L. Selig, Mrs. Wayne Buchanan, Mrs. P. V. Pennybacker, Jr., Mrs. C. R. Darling, Mrs. Fred W. Catterall, Jr., Mrs. Stanley Swift.

The President introduced Mrs. W. E. Japhet who gave the following findings from the group discussions, held on Monday afternoon:

1. It was practically unanimous that the division of churches and missions according to communicant strength was most desirable.
2. If possible, more time should be allotted to such discussion groups.
3. Certain groups would like a workshop for those particularly interested in special phases of work, such as:—U.T.O., Supply Dept. and Adult Education.
4. It would be advisable to have more and smaller groups, as some were as large as 50 to 75 and were more or less unwieldy.

Miss Nance Fowles, Houston, was introduced and spoke briefly on **The Girls' Friendly Society**.

Announcement was made concerning the visit of Mr. Paul Rusch to Houston on Feb. 3-6.

Mrs. F. Gilbreath, Chairman of the Courtesy Committee read the following resolution:—

Be it resolved that: The Associated Women of the Diocese of Texas at the close of the 50th meeting held simultaneously with the 102nd Council, express appreciation for all courtesies extended by the host church, Trinity: by the First Baptist Church, Dr. Fickett and his congregation in affording a pleasant meeting place: by the hospitable people of Galveston.

And we also express appreciation for the assistance of those from outside the Diocese who participated in the excellent programs.



Duties of Parochial Officers.

*The Woman's Auxiliary to the Board of Missions is
Parochial, Diocesan and General.*

It is the duty of each Parochial Branch to report, through its Secretary, annually, to the Diocesan Secretary and it is the duty of the Diocesan Branch to report annually through its Secretary to the General Secretary at the Church Missions House in New York.

It is also the duty of each Parochial Branch to send delegates to the Annual Meeting of the Diocesan Branch, and to take pains to understand the rules which govern the Diocesan Branch by becoming familiar with its Constitution as *it is only in this way that delegates can vote intelligently.*

It is the duty of each Parochial Officer to understand the Constitution, and also the three ways in which the Auxiliary is asked to give money to help the Board of Missions.

1st. By the money required to meet the appropriations made by the Diocesan Branch at the Annual Meeting, generally collected from each Parish in the envelopes, and known as the General Fund.

2nd. By the money required to supply material for boxes.

3rd. By the money given towards the triennial Thank offering, known as the United offering, because the women of the Auxiliary all over the United States unite in making this offering.

It is also the duty of each Parochial Officer to own a copy of the Diocesan Constitution and to read each Annual Report of the Diocesan Branch, to know the names and addresses of the Diocesan Officers, and to write to them, preferably to the Vice-President of her own district, or to the Corresponding Secretary for information regarding any matter connected with the Auxiliary which she may not understand.
