## REPORT FOR THE YEAR 1933.

During the year 1933 three meetings were held with a total attendance of 217 - six branches being represented.

A pageant was presented, at St. Paul's Church, at the close of Convocation in February. Due to the untiring efforts of our president and Mrs. Hamilton Park this was a great success and it was, I understand, the only effort of this kind attempted within the Province.

The afternoon programs at the three meetings included a review of the book "The Layman's Inquiry on Re-Thinking Missions," papers on Alaska, and an address by Dean Bartlam, of the Diocese of Sacramento, on "The Church and a Changing World."

During Lent the Ogden branch made and contributed to the Auxiliary a complete baby layette and the Salt Lake City branches made various articles for St. Mark's Hospital.

Early in the year a Social Service department was formed with Mrs. Eywater appointed as chairman of the department.

The district contributed \$5.00 to a fund being collected by the Provincial President which money was to be used for the musical education of a blind boy in Los Angeles.

The women of this district took active part in the World Day of Prayer on November 11th at which time the women, in continuous attendance offered prayers during the entire day.

Our treasury suffered the loss of some money through the failure of the Western Building and Loan Society, however we expect in the very near future to receive all or a good percentage of the amount.

At the fall quarterly meeting we received and ac-

Letters of greeting were sent to the branch at Duchesne and to the mission at Tenana, Alaska, and flowers and a letter of sympathy to one of our members who was ill at St. Mark's Hospital.

No special allotment was made to this district during the year 1933 so, contrary to the usual custom, no missionary box was sent from here.

Although the past year was one of the depressing period which has affected everyone in all walks of life, we are looking forward with courage and eager expectancy to brighter and better times. Our district has held its own with others in the province, larger and more influential and we have every right to feel that we have carried on under trying circumstances and that a little more effort put forth will yield a richer harvest.

I.  
NAME.

This organization shall be known as the Utah Branch of the Woman's Auxiliary to the Board of Missions.

II.  
Object.

The object of this organization shall be to unite the women of the District in prayer, study and service for the extension of Christ's Kingdom throughout the world.

III.  
Officers.

The officers shall be a President, Vice-Presidents in number equal to the number of parochial organizations of the Auxiliary in the District, A Secretary; a Treasurer, and a United Offering Secretary.

There shall be an Executive Committee composed of the officers.  
The officers shall serve for not more than two successive terms.

IV.  
Members.

All baptized women in the District are members of the Auxiliary.

V.  
Branches.

Local branches of the Auxiliary may be formed in any city or parish or Mission in the District. In Missions where no local branch can be formed, the Missionary in charge may appoint an Auxiliary Secretary, who shall be the representative of the District Auxiliary to the local Guild.

VI.  
Meetings.

An Annual meeting of the District Auxiliary shall be held at the time of the Annual Convocation of the District, at which meeting reports ~~fixing~~ shall be made by the officers, the local branches, the Auxiliary Secretaries, and affiliated organizations, such as the Junior Branch and the Babies Branch; Officers for the ensuing year shall be elected, plans for the future made, and any necessary business transacted.

VII.  
Duties of officers.

The President shall preside at meetings of the Auxiliary, and of the Executive Committee, or shall designate one of the Vice-Presidents to act in her place, and shall have power to call meetings of the Executive Committee. The Secretary shall keep in touch with the local Secretaries to unite and encourage the work in the District, and keep a record of the meetings of the Auxiliary. The Treasurer shall receive and disburse all funds raised by local branches for Missionary work other than the United Offering, and she shall present an Annual report of monies so handled. The United Offering Secretary shall have charge of the distribution of the United Offering boxes, and shall make semi-annual collections from them through the local Secretaries. The Executive Committee shall direct the affairs of the Woman's Auxiliary in the intervals between the Annual meetings.

VIII.  
Amendments.

Amendments to this Constitution may be made at any annual meeting when presented in writing and adopted by a vote of two thirds of those present.
