EIGHTH ANNUAL CONVENTION.

"Non sibi sed aliis."

The eighth annual meeting of the Vermont Branch of the Woman's Auxiliary was held in St. Thomas' Church, Brandon, Tuesday and Wednesday, 28th and 29th of September, 1886. The President, Mrs. Theo. A. Hopkins, called the meeting to order at three P. M. Tuesday. The Recording Secretary, Mrs. Parker, being absent, Mrs. Laura M. Gray, of Burlington, was elected Secretary pro tem. The report of the Committee on the division of our work into five Missionary districts being called for, was presented, and read by Mrs. Thomas H. Canfield, Chairman of the Committee:

Mrs. President and Ladies of the Auxiliary in Vermont:

In my work of visiting various Parishes in Vermont, I have everywhere been struck with the want of general knowledge of, and consequent lack of interest in, the great subject of Missions. As we grow more and more absorbed with the thought that Mission work is the life of the Church, that our Saviour was Himself the first Missionary, and that we are among those to whom that far-reaching command was given, "Go ye into all the world and preach the Gospel to every creature, and lo! I am with you alway, even to the end of the world," (only that the end of the world is 1,900 years nearer than it was then), so much the more should we be anxious to shape our work in Vermont to meet those whose hearts have not been stirred, whose minds have not been trained, and who as yet have not understood the breadth and depth and height of our work. To this end we have watched the methods of other Dioceses, and feel confident that a plan similar in some respects to that followed in Connecticut or Central New York would meet our needs,—which is a division of our Diocese into five Missionary districts. Over each district two lady managers must be appointed, whose duty it will be to visit every Parish and Mission Station, to stir up an interest and *keep it up* in one or all departments of Missionary work. These departments are several: First, the giving of information; second, the collecting of money; third, the making up of boxes of clothing, etc., for Missionaries' families, schools, and hospitals. And when this is well followed, Mrs. Twing stands ready with further suggestions. In each district quarterly meetings should be held among themselves in different places, where the various rectors would doubtless do their part

in holding a morning service, the sermon for women especially, followed by the Holy Communion, and at night Missionary addresses that would instruct and aid the general hearers. Once a year, if so organized that we can work in harmony and method throughout our Diocese, we might venture to invite some outside Missionary to make the circuit of our district meetings, who would bring to us his live experience, fresh from the field, causing us to feel surely that the Church abroad and at home is *one*.

In order to give the members of the Convention time to fully consider the subject, the Convention then adjourned until Wednesday morning, 9 o'clock.

The Rector, the Rev. Mr. Tilley, and Mrs. Tilley gave a very pleasant reception at the Rectory Tuesday evening, which was generally attended by the delegates and members of the Parish.

WEDNESDAY MORNING, 9 A. M.

September 29th, 1887.

Morning Prayer was read by the Rector, the Rev. Mr. Tilley, assisted by the Rev. Mr. Weeks, of Enosburgh Falls, and the Rev. Mr. Hooper, of Newport.

Immediately after the service the Convention was called to order by the President, and proceeded to the election of officers for the ensuing year. The following ladies were unanimously elected:

The division of the Diocese into Districts was then taken up, and Mrs. Keith, of Sheldon, by special request, gave a very interesting account of a meeting held in Franklin County, as follows:

"The ladies of Grace Church, Sheldon, desiring a second visit from Mrs. Thos. H. Canfield, as Diocesan Mission Visitor, resolved to make an attempt to hold the first Vermont Missionary district meeting, September 8, 1886, so as to be able to give a stronger inducement to Mrs. Canfield to take the trouble to come to us again. We therefore, after arranging with her, invited all the Clergy of Franklin County, through our Rector, the Rev. Dr. Bailey, as well as Bishop Bissell, and Boone, of Shanghai, China, now visiting in Vermont, to be present and to take part in the public services of that day, as well as any ladies of the various Parishes in the county who could make it convenient to come. We arranged for a bountiful lunch, furnished by the various members of the Parish, to be served at Mrs. Keith's, next to the Church. The choir practiced special music, and the young ladies dressed the Church elaborately with flowers; all seemed interested, and every one ready to assist with pleasure and heartiness. The Bishops, to our great regret, were unable to attend, other engagements preventing; but all the Clergy of Franklin County were with us—Rev. Dr. Swett, of Highgate Falls, Mr. Burgess, of St. Albans, Mr. Weeks, of Enosburgh Falls, Mr. Geo. H. Bailey, of Richford, besides the Rector, Rev. Dr. Bailey. There were representatives present from St. Albans, Highgate, Swanton, Rice Hill, and Enosburgh Falls, and Mrs. Canfield was cordially welcomed by us all. Our services began Thursday, with morning Prayer and sermon by the Rev. Thos. Burgess, on the text, "She has done what she could," followed by the Holy Communion. After service, lunch was served at Mrs. Keith's. Then at 2.30 P. M. we went back to the Church, where the Rev. Dr. Bailey opened with Prayers our Woman's private meeting, when Mrs. Canfield talked and read to the ladies, about sixty being present, interesting them for about an hour and a half with various topics of Missionary intelligence. The evening Missionary service was well attended, the Church being filled to hear the various addresses from the clergy on different Missionary topics. As we parted with one another, many expressed themselves as highly gratified and profited by the services of the day.

The general feeling was, "Why can we not hold such meetings often? They are but little trouble, and do us all good; why could we not have them quarterly?"

The Convention then adjourned for divine service, to meet at 3 o'clock
P. M.

The sermon before the Auxiliary was delivered by the Rt. Rev. Wm. J. Boone, D. D., Missionary Bishop of Shanghai, China, after which the Rt. Rev. Bishop proceeded to the order for the administration of the Holy Communion, assisted by the Rector of the Parish.

WEDNESDAY, September 29, 1886, 3 o'clock P. M.

The Convention met pursuant to adjournment, and resumed the unfinished business of the morning, the division of the Diocese into Missionary districts.

Resolved, That the Diocese be divided into five Missionary districts for one year's Auxiliary work, and that a Committee of ladies be appointed for each District, to arrange for Missionary meetings to be held during the year.

At the urgent solicitation of many of the ladies present, Mrs. Canfield, of Burlington, consented to visit the various districts whenever specially requested to do so, and will be happy to assist in this new order of work to the best of her ability.

It is advised that these meetings comprise, as at Sheldon, Morning Service, with Missionary sermon and Holy Communion; a noon collation, and a business meeting in the afternoon, to compare notes and devise plans for mutual help; and that in each case the Parish Secretary send a report of the meeting to our Corresponding Secretary, Mrs. C. E. Allen, Burlington.

The following resolutions were then offered and adopted:

Resolved, That Mrs. F. W. Smith be appointed to represent the Vermont Auxiliary at the general meeting in Chicago in October, as a substitute for Mrs. Howard F. Hill.

Resolved, That the Secretaries of Parish societies be hereby directed to send the names of delegates to the annual meeting to the recording Secretary, with credentials signed by the Rector as heretofore. The Secretary shall make a list of such names, with liberty to substitute others, if so directed by the Parish Secretary. Each member answering to her name when the roll is called shall become a member of the Convention, thus dispensing with examination of credentials at the annual meeting. But delegates applying for admission may bring credentials to the meeting.

Resolved, That the Secretaries be authorized to draw upon the Treasurer for necessary expenses.

Resolved, That a special meeting of the officers of this society be held annually, during the session of the Diocesan Convention, immediately after the Bishop's address, and that the annual reports of the Secretaries and Treasurers be made to that meeting, and that the members of the annual convention be considered members of said meeting, and have a voice in that meeting, if present.

Resolved, That the thanks of the Auxiliary be hereby tendered to the ladies of Brandon, for their kind attention and hospitality.

The Auxiliary was invited to hold its next annual meeting, in 1887, in Immanuel Church, Bellows Falls, and the invitation was accepted.

After which the Convention listened to addresses from Bishop Bissell, Rev. Mr. Hooper and Rev. Mr. Weeks.

The ladies had expected to have Mrs. Boone with them at this meeting, but were disappointed, as she was unable to come, owing to illness. Bishop Boone exhibited samples of exquisite Chinese work, pictures of native clergy, and books used in missionary work.

The Treasurer read the names of the Parishes who contributed to the General Fund quarterly. A vote of thanks was directed to be sent to Bethel for their frequent contributions to the General Fund.

The usual Missionary meeting was held in the evening. Addresses were made by Bishop Bissell, Bishop Boone, Mr. Weeks, and other Clergymen present.

Warm resolutions of thanks were passed to Bishop Boone, the Rev. Mr. Weeks, our Diocesan Missionaries, whose addresses, as well as those from our Bishop, added greatly to the interest of the Convention.

The general feeling of the Convention was that we have reason to thank God and take courage, and that the Vermont Auxiliary is capable of taking an honorable place among that noble band of Sister Societies which throughout the Union are doing such good and growing work in the service of our Divine Master.

On motion of Mrs. Allen, the Convention adjourned to meet at Bellows Falls, at such time as may be fixed upon by the officers at their meeting at Burlington in June next.

CONSTITUTION

OF THE

VERMONT BANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

ARTICLE I. This association shall be known as the Vermont Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II. The object of this association is to aid the women of our congregations in Church work, whether for the Parish, the Diocese, or for our general missions.

ARTICLE III. Any society or association of women working for either of the purposes thus indicated may be in union with this Branch, and may be represented in its meetings by such a number of delegates, not exceeding five, as it may elect.

ARTICLE IV. The officers of this Branch shall be a President, two or more Vice Presidents, a Treasurer, a Recording Secretary, and a Corresponding Secretary, who shall be elected annually.

ARTICLE V. The President shall preside at all meetings of the Branch, unless the Bishop of the Diocese be present, and chooses to preside *ex-officio*.

ARTICLE VI. The Vice Presidents shall preside in the absence of the President, in the order of their election.

ARTICLE VII. The Treasurer shall have charge of the funds of the Branch, and shall pay out the same according to the directions of the association.

ARTICLE VIII. The Recording Secretary shall keep a roll of the delegates in attendance at the meetings, and shall also keep the record of the proceedings of the Branch.

ARTICLE IX. The Corresponding Secretary shall conduct the correspondence of the Branch with the affiliated associations, the Secretary of the Woman's Auxiliary, and others.

ARTICLE X. This Branch does not propose to interfere with work which the associations are doing for the Church in their several localities, yet it would recommend that each such association should select

some time in the year to work especially for the cause of our General Missions, in connection with the Woman's Auxiliary.

ARTICLE XI. It is recommended, in case the Convention of the Diocese approve that course, that members of these associations, under the direction of their Clergy, charge themselves with the circulation of the pledges for our Diocesan Missions, and, if necessary, the collection of the same.

ARTICLE XII. The Constitution shall only be altered or amended by a vote of delegates representing two-thirds of the associations in union with this Branch.

ARTICLE XIII. By-Laws in accordance with the Constitution may be adopted or altered at any meeting.

ARTICLE XIV. The annual meeting of the Branch shall be held on such day of September, October or November as shall have been appointed at the previous meeting. The President shall at any time call a meeting of the Branch, on the written request of three parish societies.

BY-LAWS.

By-LAW 1. Any society or association of women working for either of the objects indicated in the Constitution may be received into union with the Vermont Branch of the Woman's Auxiliary to the Board of Missions, at any annual meeting of the same, by a vote of a majority of the members present, upon presenting a certificate from the Rector of the parish, or from the Missionary in charge, or, in the absence of either, from the Senior Warden, setting forth that such society or association is duly organized for Church work.

By Law 2. The Convention of the Vermont Branch shall be composed of delegates from the several societies in union with the Branch, who are hereby authorized to act and vote upon all questions, upon presenting credentials signed by the President and Secretary of the society which they propose to represent, certifying that they have been duly elected at a regular meeting of said society, as delegates to the Convention.

By-LAW 3. In case there should not be, for any reason, an election of officers, as provided for in the Constitution, those previously elected shall hold their offices until others are chosen.

BY-LAW 4. All the officers of the Diocesan Auxiliary shall be entitled to all the privileges of the floor, and to speak and to vote upon all questions which shall come before the Convention.

BY-LAW 5. The funds collected by any society for the Vermont Branch, for any object, shall be held by the Treasurer, and paid out on the order of the President for that special object.

BY-LAW 6. The President, Treasurer, and Secretaries of this Society shall be elected by ballot, after open nomination.
