Resolved, That the members of the Auxiliary wish to express their regret that their President, Mrs. H. H. Baxter, feels herself unable to accept a re-election. They appreciate how much is due to her devotion and wish to thank her for the years of faithful service that have contributed so much to the success of our work. The sympathy of every member of the Auxiliary is extended to her with the most sincere wish and prayer that she may be restored to health and strength.

Resolved, That she be made an honorary member of this Association, with power to vote at all the meetings.

On motion of Mrs. Gilson,

Resolved, That a request be made to the Convention in June, that the money held by Mr. Charles Parker for the enrollment fund, be added to the general fund, that the interest can be used in furthering missionary work.

On motion of Mrs. Canfield,

Resolved, That the women of the Auxiliary will endeavor to raise from (1) to three (3) dollars each to present to the general triennial meeting of the Woman's Auxiliary, to be held in Minneapolis in 1895.

On motion of Miss Mary E. Roberts,

Resolved, That the ladies of the Auxiliary unite in heartily thanking the Rector and Ladies of St. Luke's Parish for their most cordial hospitality.

On motion of Mrs. Chas. E. Allen,

Resolved, That the parish branches be requested to make more than the usual effort to be represented at their next convention, as business will come before them that can only be settled by a two-thirds representation of the parish branches.

An invitation was extended by the Parish at Woodstock to hold their next annual meeting with them, which was accepted.

The Convention then adjourned.

DISTRICT MEETINGS.

Early in June, 1892, a district meeting was held in Trinity Church, Rutland. Morning service was held at eleven o'clock, followed by a celebration of the Holy Communion, the sermon being preached by the Rev. William F. Weeks of Brandon. Luncheon was served at one o'clock by the ladies of the Parish, in the Rectory.

At three P. M. a missionary meeting was held, addresses being made by the Rector and Miss Julia C. Emery, General Secretary of the Auxiliary, and a paper by the Rev. William J. Harris, D. D., Missionary of the Diocese, was read by Miss Mary E. Roberts, in which he gave a brief account of his work since January.

A notable feature near the close of our luncheon was the parting words of welcome and encouragement given to us by our dear, feeble Bishop, who had braved the very inclement weather, at great risk to himself, that he might be present with us, as he told us in voice trembling with emotion "perhaps for the last time." He bade us go on with the noble work in which we were engaged with renewed vigor and courage, for we could do nothing that would be of greater helpfulness and lasting benefit to the Diocese of Vermont, as well as to the Church at large, and assured us that the Woman's Auxiliary was a work in which our Bishop placed the

greatest confidence and reliance. Commending us and our work to the guidance of the Almighty, he bid us farewell—as it proved *for the last time*, and took his departure for home at three o'clock in the afternoon, with the Rt. Rev. Bishop Atwill, who was also far from well, leaving us to finish our business, and the Clergy to conduct the evening missionary meeting.

CONSTITUTION
OF THE
VERMONT BRANCH OF THE WOMAN'S AUXILIARY TO THE
BOARD OF MISSIONS.

ARTICLE I. This association shall be known as the Vermont Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II. The object of this association is to aid the women of our congregation in church work, whether for the parish, the Diocese, or for our general mission.

ARTICLE III. Any society or association of women working for either of the purposes thus indicated may be in union with this Branch, and may be represented in its meetings by such a number of delegates, not exceeding five, as it may elect.

ARTICLE IV. The officers of this Branch shall be a President, two or more Vice-Presidents, a Treasurer, a Recording Secretary, and a Corresponding Secretary, who shall be elected annually.

ARTICLE V. The President shall preside at all meetings of the Branch, unless the Bishop of the Diocese be present, and chooses to preside *ex-officio*.

ARTICLE VI. The Vice-Presidents shall preside in the absence of the President in the order of their election.

ARTICLE VII. The Treasurer shall have charge of the funds of the Branch, and shall pay out the same according to the directions of the association.

ARTICLE VIII. The Recording Secretary shall keep a roll of the delegates in attendance at the meetings, and shall also keep the records of the proceedings of the Branch.

ARTICLE IX. The Corresponding Secretary shall conduct the correspondence of the Branch, with the affiliated association, the secretary of the Woman's Auxiliary, and others.

ARTICLE X. This Branch does not propose to interfere with work which the associations are doing for the Church in their several localities, yet it would recommend that each such association should select some time in the year to work especially for the cause of our general missions, in connection with the Woman's Auxiliary.

ARTICLE XI. It is recommended, in case the Convention of the Diocese approves that course, that members of these associations, under the directions of their clergy, charge themselves with the circulation of the pledges for our Diocese Missions, and, if necessary, the collection of the same.

ARTICLE XII. The Constitution shall only be altered or amended by a vote of delegates representing two-thirds of the associations in union with this Branch.

ARTICLE XIII. By-Laws in accordance with the Constitution may be adopted or altered at any meeting.

ARTICLE XIV. The annual meeting of the Branch shall be held on such day of September, October or November as shall have been appointed at the previous meeting. The President shall at any time call a meeting of the Branch, on the written request of three parish societies.

BY-LAWS.

BY-LAW 1. Any society or association of women working for either of the objects indicated in the Constitution may be received into union with the Vermont Branch of the Women's Auxiliary to the Board of Missions at any annual meeting of the same, by a vote of majority of the members present, upon presenting a certificate from the Rector of the parish, or

of the Missionary in charge, or in the absence of either, of the Senior Warden, setting forth that such society or association is duly organized for Church work.

BY-LAW 2. The Convention of the Vermont Branch shall be composed of delegates from the several societies in union with the Branch, who are hereby authorized to act and vote upon all questions, upon presenting credentials signed by the President and Secretary of the society which they propose to represent, certifying that they have been duly elected at a regular meeting of said society, as delegates to the Convention.

BY-LAW 3. In case there should not be, for any reason, an election of officers, as provided for in the Constitution, those previously elected shall hold their offices until others are chosen.

BY-LAW 4. All the officers of the Diocesan Auxiliary shall be entitled to all the privileges of the floor, and to speak and to vote upon all questions which shall come before the Convention.

BY-LAW 5. The funds collected by any society for the Vermont Branch, for any object, shall be held by the Treasurer, and paid out on the order of the President for that special object.

BY-LAW 6. The President, Treasurer and Secretaries of this society shall be elected by ballot, after open nomination.
