**Forty-Seventh Annual Meeting**  
of the  
**VERMONT BRANCH OF THE WOMAN'S AUXILIARY TO THE  
NATIONAL COUNCIL**

The Forty-seventh Annual Meeting was held in St. Peter's Church, Bennington, May 12 and 13, 1925.

**TUESDAY EVENING, MAY 12**

Evening Prayer was said at 8 o'clock by the Rector, the Rev. James Elmer McKee, Bishop Hall reading the lessons and closing prayers.

The sermon by the Rt. Rev. Samuel Babcock Booth, Bishop Coadjutor, from the text in Isaiah, 4:3, 4, 5, was a strong appeal to the Church to awake to a renewed vision and determination, to loyalty to ideals and reality of things eternal; to face the facts in the Church's work with a spirit and interest based on a real conviction.

**WEDNESDAY, MAY 13**

The Holy Communion was celebrated at 7:30 o'clock by the Bishop of the Diocese, assisted by the Rector. Morning Prayer was said at 9:30.

The Convention was called to order in the Parish House at 10 o'clock for business, Bishop Hall presiding. The Committee on Credentials, Miss Annie T. Smith, Burlington, Mrs. B. F. The Executive Council has considered the advisability of transferring the Parishes of Bethel, Randolph and Royalton from the Windsor District to the Montpelier District, and recommended that the change be made. On motion the recommendation was accepted and it was voted to make the change.

A printed, itemized report of the work of the Supply Secretary and of the Treasurer was distributed, which presented the details clearly and expeditiously. Mrs. Rickert's report showed a good amount of work done and was most complete and interesting. There was a question calling forth a lively discussion as to what could be included locally as Auxiliary work, and on suggestion of the Bishop the officers are to consider the problem at their next Council and report at the next Annual Meeting. Miss Boyer from the Church Missions House was called on and explained the manner of handling the appeals as they came in and went out at headquarters, and assured us that an effort was made to give a fair deal to everyone and not give especially well known and popular workers more than their rightful share of help at the expense of some of the less well known sections.

The Treasurer's report, presented by Mrs. Perley, was very encouraging. Mrs. William F. Jones gave an interesting report of the year's work of the Junior Auxiliary. The report of the Church Periodical Club was read by Mrs. Sargent, in the absence of the Secretary, Mrs. Joseph Reynolds.

The Bishop appointed Mrs. Joseph Reynolds Secretary of the Church Periodical Club; and the President appointed Mrs. Pearl F. Blodgett First Vice-President, and Mr. Charles F. Chapman Auditor.

Mrs. Gilbert presented a verbal report of her work as Educational Secretary. The Convention adjourned to a most bountiful luncheon served by the ladies of the Parish.

At 2:15 the meeting was called to order and we listened to a most interesting talk on Educational Work by Miss Laura Boyer, Assistant Educational Secretary, from the Church Missions House. Miss Boyer outlined ways in which educational work could be made attractive by using tactful methods to meet varying conditions and described what might be done with program readings, discussion, groups, simple plays and talks.

Mrs. John White of Sherburne followed with a very interesting account of the community work being done under the auspices of the Mission at Sherburne, showing the progress made by helping women to better conditions in homes through systematic instruction, which gives them an opportunity to produce handiwork that is readily salable. She asked the interest of her listeners in this work of the Neighborhood Exchange, which will be housed in a new shop near the Rectory, and where woven rugs and other attractive products of the looms will be on exhibition to tourists.

That a history of the Diocesan Branch be prepared, in anticipation of the Fiftieth Anniversary of the Auxiliary in Vermont, recommending Miss Constance R. Wheeler as the one best fitted to compile it, and that we strive to make the event, in every way, a memorable occasion.

The resolution was unanimously adopted.

On motion the Auxiliary voted to extend an expression of sympathy to Mrs. Alfred G. Miller, and her family, who was called from the meeting by bereavement in her home, and the Secretary was instructed to convey the same.

An invitation to hold the next Annual meeting in Rutland was extended by Trinity Church delegates, and it was referred to the Executive Council.

A rising vote of appreciation and thanks was given the Parochial Auxiliary and other officers of St. Peter's Parish for their kindness and hospitality at this meeting.

The Minutes of the Meeting are to be submitted to the Bishop for approval before printing. The business meeting was declared adjourned.

Evening Prayer was said in the Church at 4:30, and at 7:30 the Rev. Edward McKinley of Northfield gave a practical address on "The Religious Training and Spiritual Growth of our Young People." Bishop Hall gave a very plain, helpful talk on how Vermont stands regarding its Missionary assessments and contributions in 1924, as indicated by the annual parish reports, justly criticizing some demands as exorbitant but saying "We are not doing what we might, and ought." As members of the several Parishes the Auxiliary members were urged to help counteract and improve some deplorable irregularities as to contributions, to have all organizations report to the Parish Treasurer, and to use their influence to have Parish accounts kept and audited according to business and common sense methods.

This closed the Forty-Seventh Annual Meeting of the Vermont Branch of the Woman's Auxiliary to the National Council.

**REPORT OF THE SECRETARY OF THE JUNIOR AUXILIARY TO THE  
NATIONAL COUNCIL**

The work of the year 1924 has been carried forward with great zeal in some of the Branches and in others with much less enthusiasm. In some cases the cause of this falling off is this—the older girls go away to school and the younger ones cannot carry on so effectively at first, hence smaller results. On the whole it has been a satisfactory year. In the Lenten season comfort bags were made for Seaman's Church Institute, New York. This was quite different from the work usually given the Juniors and really was quite pleasing. The Christmas boxes were sent to several different Missions in the Mountains of Virginia and North Carolina, carrying the cheer of the Christmas season to many children who otherwise would have, perhaps, been bereft of that joy.

Such good letters of appreciation were received from Mrs. Rowles at the Mission at Rustburg, who received most of the gifts sent from the Diocese, and nothing encourages the Juniors so much as to receive an account of Christmas in Mission Schools.

A branch at Lyndonville was started in the fall and contributed to the Christmas work.

Whatever the changes of the Junior Auxiliary (which is working on the same lines as the Church School Service League under the supervision of Miss Withers of the Department of Religious Education) will be, do arouse and encourage the work of the young girls, to give of the best to the Church, to use their enthusiasm for its work and to stimulate them to work as never before for the tasks that remain undone.

## REPORT OF THE BURLINGTON DISTRICT

From January 1, 1924 to December 31, 1924

Again I have to report with uncertainty the number of members in the eight Branches of the Burlington District because I have not received replies to all the questionnaires, but I have every reason to think the number remains about the same as last year, between 180 and 190.

Some Branches met once a month and some every two weeks during the working year, but the banner Branch, is as usual, the Young Woman's Branch of Saint Paul's, Burlington, which has held meetings very regularly once a week, and sent a fine box at Christmas to the Mission at Sherburne.

All the Branches except two have contributed towards a box destined for the colored Archdeaconry of Western North Carolina. The value of the contributions will be reported by the Supply Secretary.

I have been unable to visit the Branches that I did not visit last year, but I met the Winooski Branch at an exceedingly pleasant meeting held in Burlington, at the home of the Rev. Mr. Reynolds, and I have attended three meetings of the Young Woman's Auxiliary of St. Paul's, Burlington.

Two District meetings were held during the year. The first at Burlington, February 13, when we had the pleasure and profit of hearing Miss Lincoln, from the Diocese of Western Massachusetts, tell about the methods used by the Western Massachusetts Auxiliary in their Supply Department.

The second was held at Shelburne, October 8, when we were so fortunate as to listen to very helpful addresses given by the Rev. Dr. Richardson of Burlington and the Rev. Mr. Crichton of Vergennes, as well as addresses from three of our Diocesan officers—our Educational Secretary, our Supply Secretary and our Treasurer.

District meetings might profitably be used as meetings for discussion, from time to time, as there is so little routine business connected with them. Discussions could be planned beforehand and would doubtless lead to increased interest.

I am glad to report that at practically all local meetings devotional exercises have opened or closed them.

**REPORT OF THE MONTPELIER DISTRICT****From January 1, 1924, to December 31, 1924**

There are four Branches in the Montpelier District:—Barre, Webster-ville, Montpelier and Northfield. Barre, Montpelier, and Webster-ville joined at Advent in work for the North Carolina Missions at Morganton, and Montpelier also sent one of the small Christmas gift boxes requested for Mission workers.

For Specials, the Branch is represented in gifts for the Bishop Tuttle Memorial, Japanese Reconstruction and the Near East Relief, beside local Social Service, both within and without the Church. Regular meetings of the Auxiliary were held during Lent in Montpelier and Webster-ville. Barre held monthly meetings from October till May, and for programs took up the work of Missions, Foreign and Domestic. The Barre Branch should be commended for regular monthly meetings with Mission Study, and for its active Junior Branch.

This was a very good year in our District. All Branches gave generously toward the Mission Box, and, in addition, did a goodly amount of other missionary work and carried on local work and study.

Our Mission box was sent to the Rev. Charles M. Jones, Crow Creek Mission, Grosse, South Dakota. The Rev. and Mrs. John White of Sherburne assisted in the purchase of blankets for the box. St. Luke's at Fair Haven furnished a white stole for Mr. Jones, and Zion Church at Manchester furnished him a green stole.

St. Thomas' at Brandon sent a Christmas box to Cathedral School at Havana, and the following places received assistance from the district: St. Phillips' Mission, Little Rock, Arkansas; Allen, South Dakota, (Reverend Dallas Shaw); St. Augustine's School, Raleigh, North Carolina.

I regret to announce the death of Mrs. George Woodbury of Castleton, a most devoted church worker and helpful member of our auxiliary.

Two District Meetings were held during the year, the first on July 30 at Hydeville, with an attendance of 94 delegates and several visitors. This was called the most interesting meeting that the members of our District have ever had. Luncheon was served to the gathering by the Hydeville Branch, assisted by members from Fair Haven. Speaking, both forenoon and afternoon, was interesting and helpful.

The second meeting was held at Manchester Center on September 24, with an attendance of 79. This was also a most interesting and encouraging meeting of forenoon and afternoon sessions. Luncheon was served by the Manchester Center Branch. A collector was taken at this meeting, amounting to \$34.93 which by vote of the meeting was used to purchase household linen for the Missionary Box, and for such other items as would not otherwise be provided for.

I would earnestly urge summer meetings for our Vermont Branches. The meetings may serve to stimulate work in the smaller Parishes, and they arouse much interest in all localities, for it is easier to get people to attend meetings in pleasant weather and when the motoring is good. The District is planning to hold other meetings during the coming season, and we are invited to hold one of these at the Church of Our Saviour at Sherburne in July.

**CONSTITUTION AND BY-LAWS**  
**VERMONT BRANCH WOMAN'S AUXILIARY**

NAME

**Article I.**—This Association shall be known as the Vermont Branch of the Woman's Auxiliary to the National Council.

OBJECT

**Article II.**—Its object shall be the acquirement and diffusion of missionary intelligence and the increase of missionary activity among the women of the Church in the Diocese. This shall be understood to include social service and religious education.

OFFICERS

**Article III.**—The officers of the Branch shall be a President, as many Vice-Presidents as there are Missionary Districts in the Diocese—one for each District—a Secretary, a Supply Secretary, an Educational Secretary, General Secretary of the Junior Auxiliary, a Treasurer, and the Secretary of the Church Periodical Club. These shall, together, constitute the Executive Council.

ELECTIONS

**Article IV.**—(1) To Office; Election of officers shall take place at the Annual Meeting, the mode of nomination and terms of office being defined in the By-Laws. (2) To membership: Applications approved by the Executive Council shall be presented after roll-call at the Annual Meeting by the Secretary.

DUTIES OF OFFICERS

**Article V.**—It shall be the duty (a) of the President to preside at all meetings of the Branch and its Executive Council (except when the Bishop of the Diocese is requested to preside ex-officio) to appoint from the newly-elected Vice-Presidents a First Vice-President, to appoint all the committees save when the Assembly claims the right to do this, and to do all else usually pertaining to her office; (b) of the First Vice-President, to perform the duties of the President in her absence; (c) of all the Vice-Presidents, to act, under the President, as Directors of the Branch in the respective Districts—their duties as such being defined by the By-Laws—and to prepare for each Annual Meeting synopses of work done during the year in their Districts; (d) of the Secretary to give notice of all regular meetings of the Branch, to keep a roll of the delegates in attendance, and a record of such meeting, to be printed annually; (e) of the Supply Secretary, to conduct the correspondence of the Branch with the Supply Department of the Church Missions House, New York, to send out quotas to local Branches, and the blanks for

reports, and to have charge of the Diocesan Bureau of Supplies, if such a bureau is established, to send out blanks for application for admission, credentials, reports, etc.; to prepare for each Annual Meeting; (f) of the Educational Secretary, to visit Parishes in the interest of Mission Study, and as far as possible to promote Normal Study Classes; (g) of the Secretary of the Junior Auxiliary to stimulate the interest in and knowledge of missions, and to unify the missionary work of the children of the Church, both for objects within and without the Diocese; (h) of the Treasurer, to take charge of all funds of the Branch, to pay out the same upon its order or that of the Executive Council, to prepare a report for each Annual Meeting, and to do all else usually appertaining to her office; (i) it shall be the duty of the Executive Council to arrange and announce the business for each Annual Meeting, posting the same beforehand in the porch of the church where held, and to arrange in general the work of the Branch.

#### PRIVILEGES OF OFFICERS

**Article VI.**—The officers of the Branch shall be entitled at all meetings to all privileges of the floor and to the right of voting. The privilege of the floor will belong to past officers, also to visiting officers from other Dioceses or from the National Auxiliary.

#### ELIGIBILITY AND REPRESENTATION

**Article VII.**—(1) To membership: Any organization of women of the Church in the Diocese presenting satisfactory credentials shall be eligible to membership in the Branch, to which it shall report its missionary work except such as done in its own Parish. The first organized society in each Parish may send three, and those subsequently formed two, delegates to the Annual Meeting; but no delegate shall be entitled to a seat until her credentials have been accepted.

(2) To office: Any member of the society being a communicant of the Church shall be eligible to any office in its gift, but no member shall hold more than one office at a time.

(3) Delegates from Junior Branches will not vote under sixteen years of age.

#### MEETINGS

**Article VIII.**—The Annual Meeting of the Branch shall be held on such days of April, May or June as the President may appoint. The Semi-Annual Meeting of such Diocesan officers and delegates to the previous Annual Meeting as may be able to attend shall be held on a day and at a place appointed by the President.

#### QUORUM

**Article IX.**—A majority of members present shall constitute a quorum for amendments to its Constitution.

## AMENDMENTS

**Article X.**—Amendments to the Constitution of the Branch must be presented on paper at an Annual Meeting, and be voted upon at the next Annual Meeting.

(2) Amendments to the By-Laws may be presented and voted upon at any general meeting, but all By-Laws must accord with the Constitution.

## BY-LAWS

### 1—Nomination

The officers of this Association shall be nominated by a Nominating Committee of three, said Committee to be elected at the preceding Annual Meeting.

### 2—Appropriations

The appropriations for the year shall be made at the Annual Meeting, at which time an Auditor shall be appointed by the President.

### 3—Reports

Each organization in the Branch shall fill out report blanks for the year's work, ending with December thirty-first and send them to the Vice-President of the District, to be by her forwarded to the Corresponding Secretary without delay.

### 4—Annual Directors

The duties of the Vice-Presidents shall be to direct the work in their respective Districts; to form classes for missionary study; to disseminate missionary literature; to visit and encourage existing societies and to form new ones where none exist, and to arrange for such District Meetings as shall subserve these purposes. They shall obtain the President's approval of their plans of work, and shall from time to time confer with her about them.

### 5—Delegates

The names of the delegates to the Annual Meeting shall be sent, as early as practicable, both to the Recording Secretary and to the Secretary of the organization which is to entertain the Branch.

### 6—Vacancies

In case of a vacancy in any Diocesan office, the place shall be filled by the Executive Council until the next Annual Meeting.
