The Forty-Ninth Annual Meeting

was held in

Trinity Church, Rutland, Vt., May 11-12, 1927

WEDNESDAY, MAY 11

At four o'clock, a meeting of the Executive Council of the Auxiliary was held in the Parish House with twelve members present. Various matters were brought up for discussion, such as: The best time to hold the District Meetings; the time and place of the semi-annual Executive Meeting in the fall; the matter of the constantly increasing cost of printing the annual reports, etc.

It was voted that the Secretary should send to Mrs. Seward Webb a note of appreciation of her generous contributions and interest in the work of the Auxiliary.

Miss Clark, the new Educational Secretary, was present and plans for that department were discussed.

At 8 o'clock a meeting was held in the Parish House under the direction of the Church Mission of Help. Rt. Rev. A. C. A. Hall presided and the speaker of the evening was Miss Mabel Thomas, of the Thomas School, Rowayton, Conn. Miss Thomas spoke on the science of developing children and young people, physically, mentally and morally so that they might function normally. Cases were explained where slight physical defects caused most discouraging mental and moral conditions. In the Church Mission of Help Work it is necessary to find out what conditions and influences have developed waywardness and to correct these and substitute wholesome influences. Bishop Hall gathered it all up into the spiritual significance that although science and psychology are most helpful, without the guidance of the Holy Spirit permanent work cannot be accomplished.

THURSDAY, MAY 12

At half past seven Holy Communion was celebrated, the Rt. Rev. A. C. A. Hall officiating, assisted by the Rector, the Rev. Morgan Ashley.

Morning prayer was read at nine o'clock by Rev. Morgan Ashley, assisted by Rev. E. Briggs Nash.

The business session was called at 9:30 in the Parish House. Bishop Hall in the chair and Mrs. W. H. Wills, President, assisting. The Credentials Committee consisted of Mrs. George Lassor, Rutland, chairman, Mrs. W. H. Tasker, Brattleboro, and Mrs. Scott, St. Johnsbury. There was an excellent attendance at the noon day intercessions with commemoration of the departed members; and 152 sat down to luncheon in the Parish House of the Methodist Church. On reassembling at the Trinity Church the Treasurer's Report was read and explained by the Treasurer, Mrs. W. F. Perley of Bellows Falls. A

printed proof sheet copy of this report and also the report of the Supply Secretary had been placed in the hands of each delegate. Mrs. Perley also mentioned \$88 in the bank which was not in her report, this being money put aside for the Alter Guild. This report was accepted. A letter of thanks from Miss Elmandorf at St. Augustine's School, Raleigh, N. C., was read. In connection with the Treasurer's report, Mrs. Wills spoke of her plan for the presentation of the U. T. O. at the Noon-day Intersessions. She also explained the announcement of the two discussion groups to be held at 2 o'clock—one on executive work and one Mission Study. This is a new venture, a sort of Round Table, it is hoped it may prove helpful to the Auxiliary. Mrs. Wills told the convention of a plan which she has to go this summer taking with her the Educational Secretary and two others, up one side of the State and down the other to visit the branches, coming into closer touch with the workers, learning their needs and being of all possible service in their problems.

Next the report of the Supply Secretary, Mrs. L. R. Rickert, of Barre was read and accepted. Mrs. Rickert stated that all District Reports should be in each year by December 31st., so that she might complete her own report with less haste. Appreciation was expressed for the thorough and painstaking manner in which both Mrs. Perley and Mrs. Rickert have done their work.

Mrs. William F. Jones in reporting the work of the Junior Auxiliary stressed the importance of training the young people in missionary work—prayer, study and giving are the lines this training should follow. Her report was accepted in the usual way.

Mrs. Joseph Reynolds of Burlington read her report as Secretary of the Church Periodical Club, this was accepted. She asked that more magazines might be contributed as they are so greatly needed. The increase in Postal rates unfortunately makes a difference in the magazines sent.

Mrs. Jones, who has charge of the quota for this diocese toward the Corporate Gift, was asked to tell what progress is being made. She reported a very good response already, although this money is not due until April 1928. The sum of \$1,000,000 is being raised by the women of the Episcopal Church to be used for buildings in six

mission fields—hospitals, churches and schools. Mrs. Jones has in cash and pledges \$495.71 at present.

A rising vote of thanks was given Miss Constance R. Wheeler, of Burlington, for the excellent courses she has made out for Mission Study classes the past two years; these have been very generally used during the Lenten Season.

Bishop Hall appointed Mrs. Joseph Reynolds of Burlington, Secretary of the Church Periodical Club, and Mrs. Wills appointed Mr. Charles Chapman, of Woodstock, Auditor.

The following were elected to serve as a Nominating Committee for 1928: Chairman, Mrs. J. M. Ayres, Bennington; Mrs. G. R. Brush, Arlington and Mrs. C. M. Rublee, East Berkshire.

It was interesting to hear from Bishop Hall that the motor van for which Bishop Booth has been raising money would be dedicated, with two others on Ascension Day at the Cathedral of St. John the Divine. These motor vans, which open up into little chapels are sent out by the Church Army of England, with two young Englishmen in charge of each. The cost is \$1,000 each, \$800 for the van and \$200 for gasoline. When one was offered to Vermont, Bishop Booth undertook to raise the money and has been so successful that the van was to start into Vermont June 1st. Services will be held wherever a group can be gathered together; it seems as though it

might be a great inspiration to those who live in remote districts.

Adjournment was then made for Noon-day Intersessions which were said in the church by Rt. Rev. A. C. A. Hall. At this time the United Thank Offering was brought by a delegate from each branch and we had a humble replica of the Triennial presentation. The amount received was \$504.87.

Luncheon was served at one o'clock in the Methodist church Parish Rooms. Promptly at two o'clock groups formed in the Parish House for discussion, Mrs. J. A. Waterman of Burlington led the groups on executive matters, and Miss Constance R. Wheeler of Burlington had charge of the Mission Study Group.

At three o'clock the convention assembled once more in the church for the Missionary meeting which was to close the session. At this time the committee on appropriations brought in their report and it was accepted as follows:

The speaker of the afternoon was Rev. E. M. Blakeslee of Pottersville, N. Y. Mr. Blakeslee is pastor of four congregations in a rural New York community and his talk concerned religious work among the farmers and people of the small towns. He related some of his own experiences and told of the establishment of schools for country clergymen at some of the agricultural colleges. Here the ministers are taught the practical side of the farmer's life and given instruction in organizing community social affairs.

Bishop Hall in closing the 49th convention of the Woman's Auxiliary, commended the women on the progress made in parliamentary procedure, telling of most informal and amusing ways of conducting business years ago. He urged us to continue to make progress in all details. Recalling the many ways in which the Woman's Auxiliary has been helpful to the Diocese, Sherburne was mentioned, and Bishop

Hopkins Hall, Church Mission of Help, a work that claims the help and sympathy of all.

Bishop Hall emphasized the fact that we must cultivate a spirit of prayer to "consider church needs and means of meeting these needs. Come out of a life of prayer to do your work. Works then will be with power and actions wise. Prayer will bring in God's aid without which all is of small avail. Cultivate the fellowship of God and call others into that which you yourself are experiencing."

**Report of The
JUNIOR AUXILIARY TO THE NATIONAL COUNCIL,
for the year 1926.**

Ten branches have reported sending Christmas boxes and being otherwise active during the year 1926. Lack of leaders has hindered the work in some places and in others "no children in the parish" has been the reason for inactivity, but in these ten branches most excellent work has been done and a good foundation laid for the future good of the church and its missions.

How much better work any one of us can do along the line of our early training and how much easier it will be for the Juniors to give their best for our Lord's work when the needs of the Missionaries are taught them in early life.

The three aims of the work are Prayer, Study and Giving. Don't neglect the first and the best plan for carrying out the second is to tell clearly and concisely the story of Missionary endeavor and then ask questions to bring out the young girls' ideas. Make the story short, then they will anticipate another at the next meeting. Explain why we send Christmas boxes and why the Missionaries are in the different Mission fields and what they have to do there and why the Juniors have any responsibility in helping them by sending Christmas gifts to the children in Mission schools.

Besides the Christmas boxes sent to Panama Canal Zone and Porto Rico, the Juniors have given \$25.00 and other sums either for the parish or the community. There is also the hope there may be the gift of life, from this group of eager, interested young people, for the Missionary work.

The Juniors were asked to send six dollars to Cuba with which to purchase Christmas gifts and two classes in the church school in Christ's Church, Montpelier, sent three dollars and the Juniors of St. James', Woodstock, sent the other three. Most appreciative thanks were received for this money.

Total value of the boxes was \$74.70 and the amount of money given was \$38.84, making a total of \$113.54.

To the Officers and Members of the Vermont Branch of the Woman's Auxiliary to the National Council:

Your Vice-President begs to submit the following report:

That interest in the work of the Auxiliary is increasing is evident. Quotas have been cheerfully and promptly met and there seems to be a satisfactory growth in Mission Study. CONSTITUTION AND BY-LAWS.**Vermont Branch Woman's Auxiliary****NAME**

ARTICLE I.—This Association shall be known as the Vermont Branch of the Woman's Auxiliary to the National Council.

OBJECT

ARTICLE II.—Its object shall be the acquirement and diffusion of missionary intelligence and the increase of missionary activity among the women of the Church in the Diocese. This shall be understood to include social service and religious education.

OFFICERS

ARTICLE III.—The officers of the Branch shall be a President, as many vice-Presidents as there are Missionary Districts in the Diocese—one for each District—a Secretary, a Supply Secretary, an Educational Secretary, General Secretary of the Junior Auxiliary, a Treasurer, and the Secretary of the Church Periodical Club. These shall, together, constitute the Executive Council.

ELECTIONS

ARTICLE IV.—(1) To Office; Election of officers shall take place at the Annual Meeting, the mode of nomination and terms of office being defined in the By-Laws. (2) To membership: Applications approved by the Executive Council shall be presented after roll-call at the Annual Meeting by the Secretary.

Duties of Officers

ARTICLE V.—It shall be the duty (a) of the President to preside at all meetings of the Branch and its Executive Council (except when the Bishop of the Diocese is requested to preside ex-officio) to appoint from the newly-elected Vice-Presidents a First Vice-President, to appoint all the committees save when the Assembly claims the right to do this, and to do all else usually pertaining to her office; (b) of the First Vice-President, to perform the duties of the President in her absence; (c) of all the Vice-Presidents, to act, under the President, as Directors of the Branch in the respective Districts—their duties as such being defined by the By-Laws—and to prepare for each Annual Meeting synopses of work done during the year in their Districts; (d) of the Secretary to give notice of all regular meetings of the Branch, to keep a roll of the delegates in attendance, and a record of such meeting, to be printed annually; (e) of the Supply Secretary, to conduct the correspondence of the Branch with the Supply Department of the Church Missions House, New York, to send out quotas to local Branches, and the blanks for reports, and to have charge of the Diocesan Bureau of Supplies, if such a bureau is established, to send out blanks for appli-

cation for admission, credentials, reports, etc.; to prepare for each Annual Meeting; (f) of the Educational Secretary, to visit Parishes in the interest of Mission Study, and as far as possible to promote Normal Study Classes; (g) of the Secretary of the Junior Auxiliary to stimulate the interest in and knowledge of missions, and to unify the missionary work of the children of the Church, both for objects within and without the Diocese; (h) of the Treasurer, to take charge of all funds of the Branch, to pay out the same upon its order or that of the Executive Council, to prepare a report for each Annual Meeting, and to do all else usually appertaining to her office; (i) it shall be the duty of the Executive Council to arrange and announce the business for each Annual Meeting, posting the same beforehand in the porch of the church where held, and to arrange in general the work of the Branch.

PRIVILEGES OF OFFICERS

ARTICLE VI.—The officers of the Branch shall be entitled at all meetings to all privileges of the floor and to the right of voting. The privilege of the floor will belong to past officers, also to visiting officers from other Dioceses or from the National Auxiliary.

ELIGIBILITY AND REPRESENTATION

ARTICLE VII.—(1) To membership: Any organization of women of the Church in the Diocese presenting satisfactory credentials shall be eligible to membership in the Branch, to which it shall report its missionary work except such as done in its own Parish. The first organized society in each Parish may send three, and those subsequently formed, two delegates to the Annual Meeting; but no delegate shall be entitled to a seat until her credentials have been accepted.

(2) To office: Any member of the society being a communicant of the Church shall be eligible to any office in its gift, but no member shall hold more than one office at a time.

(3) Delegates from Junior Branches will not vote under sixteen years of age.

MEETINGS

ARTICLE VIII.—The Annual Meeting of the Branch shall be held on such days of April, May or June as the President may appoint. The Semi-Annual Meeting of such Diocesan officers and delegates to the previous Annual Meeting as may be able to attend shall be held on a day and at a place appointed by the President.

QUORUM

ARTICLE IX.—A majority of members present shall constitute a quorum for amendments to its Constitution.

AMENDMENTS

ARTICLE X.—Amendments to the Constitution of the Branch must be presented on paper at an Annual Meeting, and be voted upon at the next Annual Meeting.

(2) Amendments to the By-Laws may be presented and voted upon at any general meeting, but all By-Laws must accord with the Constitution.

By-Laws

1—NOMINATION

The officers of this Association shall be nominated by a Nominating Committee of three, said Committee to be elected at the preceding Annual Meeting.

2—APPROPRIATIONS

The appropriations for the year shall be made at the Annual Meeting, at which time an Auditor shall be appointed by the President.

3—REPORTS

Each organization in the Branch shall fill out report blanks for the year's work, ending with December thirty-first and send them to the Vice-President of the District, to be by her forwarded to the Corresponding Secretary without delay.

4—ANNUAL DIRECTORS

The duties of the Vice-Presidents shall be to direct the work in their respective Districts; to form classes for missionary study; to disseminate missionary literature; to visit and encourage existing societies and to form new ones where none exist, and to arrange for such District Meetings as shall subserve these purposes. They shall obtain the President's approval of their plans of work, and shall from time to time confer with her about them.

5—DELEGATES

The names of the delegates to the Annual Meeting shall be sent, as early as practicable, both to the Recording Secretary and to the Secretary of the organization which is to entertain the Branch.

6—VACANCIES

In case of a vacancy in any Diocesan office, the place shall be filled by the Executive Council until the next Annual Meeting.
