Annual Report

OF THE RECORDING SECRETARY OF THE WEST MISSOURI BRANCH OF
THE WOMAN'S AUXILIARY.

*To the Rt. Rev. E. R. Atwill, D. D., Bishop of West Missouri, and Women
of the Auxiliary:*

The West Missouri Branch of the Woman's Auxiliary, is composed of twenty-three branches, including four Junior branches. One new branch was organized November 26th, 1897, at Wyatt Park, St. Joseph.

A unique branch, which has not yet reported to us, has been formed at Brookfield, by several devout persons, whose eyes have been closed to earthly sight, but into whose souls the light of God's eternal day shines with holy radiance. It has been named "The Blind People's Auxiliary." Miss R. J. Turner is President.

The three regular meetings of the year have been held, with an increased attendance of delegates and interested members. A deeper and more wide-spread interest seems to be felt, and a more intelligent knowledge of the needs to be met has been gained.

I am sure if there were more general information in regard to the aims and realizations of this organization of earnest, Christian women, there would be more active encouragement given by the clergy, and more Church women would engage in the altruistic and divinely appointed work of giving physical and spiritual aid to those both at home and those afar off, who need such assistance.

Our Bishop said in his last annual address to the Council of the Diocese: "Every congregation, however small, should have its Auxiliary."

The sermons at the regular meetings were preached by Dean Bodley, of Topeka, Kans., the Rev. Cameron Mann, D. D., and the Rev. J. Stewart Smith, of Kansas City.

At the business meetings those present were given the pleasure and benefit of addresses pertinent to Auxiliary work by Miss Emery, of New York; the Rev. Mr. Francis, of Tokio, Japan, and Mrs. Millspaugh, of Kansas.

The reports from the branches have been more fully made out and more promptly sent in than in the past, but there is yet room for improvement.

Two rules were adopted, which, if complied with, will facilitate the transaction of business, and greatly relieve the Recording Secretary and Treasurer. They are: 1st.—That all reports and moneys be sent to the Recording Secretary ten days before the meeting at which they are to be reported, and if not sent in by the day before said meeting, that the books be closed and they be not reported until the next following meeting. 2d.—That the Treasurer of each branch open the Mite boxes, count the money and send it to the Custodian of the Mite boxes, in the form of check, draft or money order, ten days before the meeting at which it is to be reported.

The offerings made at the regular meetings were, at Grace Church, Kansas City, May 13, 1897, sent to Miss Emery, for general Auxiliary work, \$10.60; at St. Mary's, Kansas City, November 4, 1897, sent to St. Margaret's School, Tokio, Japan, \$30.00; at St. Mark's, Kansas City, February 3, 1898, sent to the Brierley Memorial, Cape Palmas, Africa, \$10.35. The \$25.00 of Mite box money which is appropriated annually for general Auxiliary work has been sent to Miss Emery.

The special fund started and carried forward by Mrs. H. G. Algeo, for the purpose of assisting in paying the salary of a missionary in the diocese has been happily completed and \$500.00 placed in the hands of the Bishop, to be used in that way.

The Archdeacon, the Ven. J. S. Moody, is an earnest and enthusiastic advocate of the work of the Woman's Auxiliary, and will be of great assistance to us in arousing interest and organizing new branches.

As full an account of work done in the diocese as is possible to give will be found in the Parish reports. Some of that work does not appear on our books and therefore is not found in the statement of the Treasurer.



CONSTITUTION
OF THE
WEST MISSOURI BRANCH
OF THE
WOMAN'S AUXILIARY.

Adopted May 14, 1891; Amended April 21, 1892.

ARTICLE I.

This society shall be called the West Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any parish, but by united and sympathetic action to increase the interest, and to unite all parishes in the diocese in the various branches of the Church's missionary work.

ARTICLE III.

All baptised women of the diocese of West Missouri, who so desire, shall be regarded as members of this society.

ARTICLE IV.

The officers shall be a President, six Vice-Presidents, two Secretaries (a Corresponding and a Recording Secretary), and a Treasurer, to be chosen at the annual meeting.

ARTICLE V.

The diocese shall be divided into six districts, each of which shall have a President and Secretary, the President to hold the office of Vice-President in the Board.

ARTICLE VI.

There shall be a Board of Managers, consisting of the President, the Vice-Presidents, Secretaries, Treasurer, and parish representatives. Nine of these shall constitute a quorum for the transaction of business.

ARTICLE VII.

Each parish shall be represented in the Board by its officers and not more than four delegates chosen by the Rector, or, if the parish have no Rector, by the Parish Society.

A membership fee of 50 cents per year shall be paid by all delegates.

ARTICLE VIII.

The payment of \$1 per year to the Diocesan Treasurer shall constitute any one an honorary member of the Board of Managers. These honorary members shall be entitled to seats, but not to vote, and shall not be counted in making a quorum.

ARTICLE IX.

There shall be three meetings of the Board of Managers each year, to be held as follows: The first Thursdays in November and February, and the annual meeting for the election of officers, which shall be on the day following the diocesan convention. The annual meeting shall be a general meeting of the society, and shall be directed by the Bishop of the diocese. Meetings shall be held in any church in the diocese or chapel designated by the President.

ARTICLE X.

Special meetings may be called by the President at the request of any five of the managers.

ARTICLE XI.

1. The President shall call meetings and preside over them.
2. The first Vice-President, or, in her absence, any of the other Vice-Presidents, shall take the duties of the President in her absence.
3. The Corresponding Secretary shall conduct the correspondence of the society; send notices of the meetings and shall send a full report of them annually to the Secretary of the Woman's Auxiliary in New York.

The Recording Secretary shall keep a record of the meetings, receive all moneys, and make a record of them before paying the same to the Treasurer. She shall also prepare an annual report for circulation in the diocese, a review of which shall be presented to the Diocesan Council.

4. The Treasurer, under the direction of the Board, shall receive and disburse all moneys sent to the society for any branch of missionary work, and for the expenses of the society, presenting a report of the same at each meeting of the Board.

5. The President of each district shall call and preside over meetings in her district, and transact all business. There shall also be sent from each district a list of the delegates from each parish in the district to the Recording Secretary ten days before the annual meeting.

ARTICLE XII.

The parish delegates are to report to the President or Secretary of their district all work done for missions and all money raised for missions by the women of their parishes; also all new work undertaken for missions. They are to attend the regular meetings of the Board and to carry back to their parish societies missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in missions.

ARTICLE XIII.

This Constitution may be altered or amended at any meeting of the Board, notice having been given at a previous meeting, by a two-thirds vote of the members of the Board of Managers present.

The districts shall be Kansas City, St. Joseph, Sedalia, Springfield, Carthage and Chillicothe.
