

ANNUAL REPORT
of the
Recording Secretary of the West Missouri Branch of the
Woman's Auxiliary to the Board of Missions.

*To the Rt. Rev. E. R. Atwill, D. D., Bishop of Western Missouri,
and Women of the Auxiliary:*

Another year of earnest, prayerful work has closed. We have much reason to be thankful, for more has been accomplished than in any previous year since the Auxiliary has been organized in this diocese, and yet we have fallen far short of our possibilities and of our hopes.

New branches have not been formed, but by the efforts of some of the vice-presidents, interest has been aroused in several small parishes, where there are no branch organizations, and they have responded to the call with results, which measured by their numbers and ability, might well cause larger and stronger churches to realize that their zeal and labors have not reached the limit of achievement.

The work of the Woman's Auxiliary will undoubtedly extend and grow, until in all the parishes, active branches will be formed, that will work with united purpose and effort, to hold up the hands of our Bishop, and assist him in establishing the church in our own diocese, as well as to render aid to the General Board of Missions, in carrying the blessings of the gospel beyond our own borders.

The three regular meetings of the Auxiliary have been held during the year. They were quite well attended and full of interest.

At the February meeting we were honored by the presence of Bishop Tuttle of Missouri. In the morning he preached a sermon of appreciation and encouragement, and

in the afternoon gave a talk full of words of wisdom and advice.

We had also with us that day Miss Lillis Crummer, a missionary teacher of China, who was home on a vacation, after the exciting and trying experiences she had passed through during the uprising in that country. She gave a most interesting and instructive account of the work, especially in schools and hospitals.

It is very important and desirable that these meetings be well attended, for without knowledge of the missionary and auxiliary work, little interest can be felt, and less help given.

Any parish that invites the Auxiliary to hold a meeting in its church will most gladly entertain delegates from all the branches in the diocese.

If answer to prayer is promised where "two or three are gathered together," how much greater blessings our faith could claim, if a band of devoted women from a whole diocese would unite in supplicating the throne of grace.

Compared with the world wide and almost overwhelming need for Christian civilization, the little assistance we can give is so small that it seems hardly worth the doing, but we should remember that Christ said of the widow's two mites, "Of a truth I say unto you that this poor widow hath cast in more than they all; for all these have of their abundance cast in unto the offerings of God; but she of her penury hath cast in all the living that she had." Our offering, however small, will find favor in His sight.

CONSTITUTION
OF THE
West Missouri Branch of the Woman's Auxiliary.

Adopted May 14, 1891; Amended April 24, 1892.

ARTICLE I.

This society shall be called the West Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any parish, but by united and sympathetic action to increase the interest, and to unite all parishes in the diocese in the various branches of the Church's missionary work.

ARTICLE III.

All baptized women of the diocese of West Missouri, who so desire, shall be regarded as members of this society.

ARTICLE IV.

The officers shall be a President, six Vice-Presidents, two Secretaries (a Corresponding and a Recording Secretary), and a Treasurer, to be chosen at the annual meeting.

ARTICLE V.

The diocese shall be divided into six districts, each of which shall have a President and Secretary, the President to hold the office of Vice-President in the Board.

ARTICLE VI.

There shall be a Board of Managers, consisting of the President, the Vice-Presidents, Secretaries, Treasurer and parish representatives. Nine of these shall constitute a quorum for the transaction of business.

ARTICLE VII.

Each parish shall be represented in the Board by its officers and not more than four delegates chosen by the Rector, or, if the parish have no Rector, by the parish society.

A membership fee of 50 cents per year shall be paid, in advance, by all delegates.

ARTICLE VIII.

The payment of \$1 per year to the Diocesan Treasurer shall constitute any one an honorary member of the Board of Managers. These honorary members shall be entitled to seats, but not to vote, and shall not be counted in making a quorum.

ARTICLE IX.

There shall be three meetings of the Board of Managers each year, to be held as follows: The first Thursdays in November and February, and the annual meeting for the election of officers, which shall be on the day following the diocesan convention. The annual meeting shall be a general meeting of the society, and shall be directed by the Bishop of the diocese. Meetings shall be held in any church in the diocese or chapel designated by the President.

ARTICLE X.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XI.

1. The President shall call meetings and preside over them.
2. The First Vice-President, or, in her absence, any of the other Vice-Presidents, shall take the duties of the President in her absence.
3. The Corresponding Secretary shall conduct the correspondence of the society; send notices of the meetings, and shall send a full report of them annually to the Secretary of the Woman's Auxiliary in New York.

The Recording Secretary shall keep a record of the meetings, receive all moneys, and make a record of them before paying the same to the Treasurer. She shall also prepare an annual report for circulation in the diocese, a review of which shall be presented to the Diocesan Council.

4. The Treasurer, under the direction of the Board, shall receive and disburse all moneys sent to the society for any branch of missionary work, and for the expenses of the society, presenting a report of the same at each meeting of the Board.

5. The President of each district shall call and preside over meetings in her district, and transact all business. There shall also be sent from each district a list of the delegates from each parish in the district to the Recording Secretary ten days before the annual meeting.

ARTICLE XII.

The parish delegates are to report to the President or Secretary of their district all work done for missions; and all money raised for missions by the women of their parishes; also all new work undertaken for missions. They are to attend the regular meetings of the Board and to carry back to their parish societies missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in missions.

ARTICLE XIII.

This Constitution may be altered or amended at any meeting of the Board, notice having been given at a previous meeting, by a two-thirds vote of the members of the Board of Managers present.

The districts shall be Kansas City, St. Joseph, Sedalia, Springfield, Carthage, and Chillicothe.

STANDING RESOLUTIONS ADOPTED AT GENERAL MEETINGS.


"All reports and moneys shall be sent to the Recording Secretary ten days before the meeting at which they are to be reported, and if not received by the day before the meeting, the books shall be closed, and dilatory reports and accounts passed until the next meeting."

"The Treasurer of each Branch shall open the mite-boxes, count the money, and send it, or its equivalent, to the Custodian of the mite-boxes, ten days before the meeting at which it is to be reported."

MAY 19, 1898.

"WHEREAS, The delegates' dues and other amounts given to the diocesan treasury have been found insufficient to cover the expenses of diocesan meetings and the needs of the Auxiliary, which deficiency in the past has been met by individuals, or taken from the mite-box money, which would otherwise go to the Bishop;

"We resolve. That each parish Branch be taxed ten cents per annum for each member, the amount to be forwarded by every Branch each year to the Recording Secretary before the May meeting."
