ANNUAL REPORT

**of the Recording Secretary of the Diocese of West Missouri Branch
of the Woman's Auxiliary to the Board of Missions.**

To the Rt. Rev. Sidney C. Partridge, Bishop of the Diocese of
West Missouri, and Women of the Auxiliary:

I hereby present my annual report of the work done by the officers
and parish branches of the Woman's Auxiliary of the Diocese of West
Missouri, during the year 1913-1914.

There have been but two regular meetings, one in January and
one in May. On account of our Bishop and President attending the
Triennial in October, the fall meeting was omitted. The January
meeting brought to us many inspiring words from those who attended
the Triennial, the delegates bringing home splendid reports from the
sessions which most interested them.

My report this year shows a small volume of receipts. We can ac-
count for this change in but one way, the separating of the Diocesan
work from the Board of Missions.

Our pledges have been all that we could hope for, Dr. Stover, the
Medical Missionary to China, being our additional pledge to our year's
work.

We have a new president, Mrs. J. D. Ritchey, who has long
shown great interest in all Auxiliary work, and we feel most fortunate
in having Mrs. Ritchey as our leader. It was with deepest feeling of
regret that I gave up my Auxiliary relations with our retiring president,
Mrs. S. E. Woodstock, whose faithfulness to and untiring patience
with the Woman's Auxiliary will long be remembered by those who
worked closely with her.

The Junior reports show increased interest; three new branches
have been formed.

May our efforts be earnest, our prayers sincere and may our
Heavenly Father guide us daily in our Mission work.

ANNUAL REPORT OF VICE-PRESIDENT

**In Charge of Junior Department,
From May 14, 1913, to May 14, 1914.**

I have been in receipt of a continuous flow of information, both in form of leaflets and letters from the Church Missions House on the subject of the plan adopted last October.

These leaflets and information I have endeavored to place in the hands of the Junior leaders of the Diocese and put forth every effort to reach as nearly as possible the high standard suggested by them. In this the leaders have given me their faithful support.

I have made special effort to increase the number of subscribers to the Spirit of Missions and urged Junior leaders to aid in the formation of branches of Little Helpers. Mrs. Pugsley reports the addition of three new branches.

Have appointed special officers as suggested by plan, to look after Section III, the United Offering and the educational work, each of whom are reporting work done and interest awakened.

At close of year we find we have one branch strictly Section III, and one branch composed of both II and III; another branch of older girls doing Junior work this year and calling themselves Chapter B of the Woman's Auxiliary, expecting to do Woman's Auxiliary work next year.

Have suggested to the two societies of the Brotherhood of St. Paul that they make a concerted effort to become an organization recognized by the Diocesan Council in November, 1914, and proffered the aid of the Juniors to help the Brotherhood increase its numbers.

Have held short conference with Bishop Partridge on the subject. Also held short conferences with our Bishop and Archdeacon Johnson, asking their aid in the organization of new Junior and Brotherhood branches in other parishes and smaller towns in Diocese.

Have urged the increase of the Edward Atwill Nearing Memorial Fund and reminded the directresses of the slogan for last year—"General Missions," our first and largest gift. Asked for pledge to the new subject—that of the Departmental Missionary Plan.

Have corresponded with leaders regarding the Pine Ridge, S. D., Christmas appeal for 1913, the Alaska appeal for the May, 1914, box. One of the branches sent a Christmas, 1913, box to Africa. Have received pledges for Christmas, 1914, from most of the branches. This box goes to Mr. Deloria, Standing Rock Mission, S. D., and Miss Davis, Callaway, Va. The "Easter Gift" of a prayer desk went to Liberal, Kansas, Bishop Griswold, the Salina Missionary District.

Our "Circulating Library" Fund has received the gift of two books, one from Mrs. Burris of Grace Church, Kansas City, and one from Miss Bryan, Springfield, Mo., for which we are very grateful.

REPORT OF CHAIRMAN
Educational Committee Junior Department of the
Woman's Auxiliary.

May 14th, 1914.

The work of this committee did not begin until some time in November, so it has been somewhat limited.

At that time a meeting of the Junior directresses was called by Mrs. Reid, vice-president in charge of Junior Department. Ten directresses responded. The chairman of this committee gave them some short talks about the Normal work that had been given us in New York City at the time of the general convention. Subjects discussed were:

1. Purposes of Missionary Study.
2. Methods of Missionary Study.
3. Preparation.
4. Leaders' Qualifications, etc.

A list of ten books on China, twelve books on Methods for Teachers, and an itemized list of suggested helps for material, typewritten by Mrs. Stoll, the other member of this committee, was sent to all Junior directresses.

This was all that was accomplished this year. I would suggest that for the coming year it would legitimately be within the jurisdiction of this committee to work with a like committee from the Woman's Auxiliary in planning for institutes, not necessarily on such a large scale as was our pleasure to have here two years ago, but one which might include subjects for discussion, such as has been previously mentioned under the head of Normal work; then methods of raising our U. O., how best to use missionary study in our Sunday Schools.

These committees working together could consider ways and means of introducing missionary study in all our Sunday Schools; this to include missions not only abroad but in our own diocese.

CONSTITUTION
of the West Missouri Diocesan Branch of the Woman's Auxiliary
to the Board of Missions.

ARTICLE I.

The name of this Association is The West Missouri Diocesan Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is to increase by united effort and sympathetic action, the interest of all the Parishes and Missions of this Diocese in the Missionary work of the Church.

ARTICLE III.

All baptized women of this Diocese are regarded as members of this Association.

ARTICLE IV.

The officers of this Association shall be, the Bishop, ex-officio, a President, three Vice-Presidents, (one of whom shall be elected from a parish outside of the See City) a Recording Secretary, a Corresponding Secretary, and a Treasurer, all of whom, except the Bishop, shall be elected at the Annual Meeting next after the General Triennial Meeting, and shall serve three years; but the President shall not be eligible for two full consecutive terms.

The President, when elected, shall appoint and define the duties of an Educational and Organizing Secretary, a Mite Box Treasurer, a United Offering Treasurer, a Little Helpers' Treasurer and such committees as she may deem expedient, each to serve one year; and any vacancy occurring in these appointments shall be filled by the President for the unexpired term.

Any vacancy occurring in any of the elective offices shall be filled by appointment by the Board of Managers until the next regular meeting, at which time the vacancy shall be filled by election for the unexpired term.

The duties of the officers shall be those usually appertaining to their respective offices and such additional duties as may from time to time be prescribed by the By-Laws.

ARTICLE V.

There shall be a Board of Managers consisting of the Diocesan officers and the Presidents of the Parish Branches. This Board shall meet one month before each meeting of the Auxiliary, and at other times upon the call of the President.

It shall be entrusted with the management of the affairs of this Diocesan Branch of the Auxiliary and shall have power to transact all business that may come before it.

ARTICLE VI.

There shall be three regular meetings during the year, namely, one in November on the Thursday following the council, one on the fourth Thursday in January and one on the Thursday next before Ascension Day, which shall be the annual meeting of the Woman's Auxiliary. Special meetings may be called by the President at any time.

ARTICLE VII.

Each Branch shall be entitled to representation at all meetings by its officers and four delegates chosen by itself.

Each Branch shall pay in advance such membership fees as may from time to time be fixed by the By-Laws.

ARTICLE VIII.

This Constitution may, with the approval of the Bishop, be amended at any regular meeting of the Auxiliary, by a two-thirds vote of the delegates present.

BY-LAWS.

1.

The order of business at all regular meetings shall be as follows:

1. Divine Services.
2. Roll Call.
3. Reading of Minutes.
4. President's Address.
5. Report of Secretary.
6. Report of Treasurer.
7. Report of Corresponding Secretary.
8. Report of Educational and Organizing Secretary.
9. Report of Branches.
10. Reports of Committees.
11. Unfinished Business.
12. New Business.
13. Elections.

2.

The Recording Secretary, in addition to the regular duties of the office, shall prepare an Annual Report for circulation in the Diocese.

3.

The Corresponding Secretary, in addition to the regular duties of the office, shall make annually a full report of the work of the Diocesan Branches to the General Secretary of the Woman's Auxiliary in New York.

4.

Parish and Mission elections of delegates shall take place during the month preceding the Annual Meeting and be immediately reported by the Local Secretary to the Diocesan Secretary.

5.

A current expense fund of one hundred dollars shall be provided annually for printing, postage, stationery and expense of speakers; and the amount shall be apportioned among the various Parish and Mission Branches by a committee of three appointed by the President.

6.

All elections shall be by ballot.

Any delegate may nominate.

Unless there is an election by a clear majority on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

7.

Each Branch shall pay an Annual Membership fee of fifty cents for each delegate and officer and no delegate or official shall be entitled to vote unless all the dues and assessments of her Branch shall have been paid in full.

8.

No part of the current expenses of the Association shall be paid from the funds contributed for Missionary purposes.

9.

Nine members of the Board of Managers shall constitute a quorum.

10.

These By-Laws may be altered or amended or suspended at any meeting by a two-thirds vote of the members present.

BY-LAWS OF THE JUNIOR DEPARTMENT

—of the—

Woman's Auxiliary of the Diocese of West Missouri.

ARTICLE I.—Officers.

The officers of the Junior Department shall be a President, who shall be "the Vice-President of the Woman's Auxiliary, in charge of the Junior Department;" an Educational Secretary appointed by the President, with the approval of the President of the Woman's Auxiliary; and a Secretary and Treasurer elected in the Junior Annual Meeting.

ARTICLE II—Duties of the Officers.

Sec. 1. The President shall have general supervision over the work of the Junior Department and endeavor to further it. She shall preside at the Junior meetings and shall report the work of the Junior Department at the Annual Meeting of the Woman's Auxiliary.

Sec. 2. The Educational Secretary shall plan for a course of study, and collect and circulate all necessary information pertaining to Mission Study in the Junior Department, and shall make a report at the Annual Meeting of the Woman's Auxiliary.

Sec. 3. The Secretary shall keep the minutes of the Junior Meetings and shall receive and record the Junior offerings and forward them to the Treasurer. She shall also prepare the Junior Annual Report of the Auxiliary.

Sec. 4. The Treasurer shall receive the Junior offerings from the Secretary and disburse them as they are designated, and shall report

the same at the Annual Meeting of the Woman's Auxiliary and the Junior Annual Meeting.

Sec. 5. The President of the Woman's Auxiliary and the Junior Officers shall constitute a Board, which shall have power to transact all urgent business that may come before it during the time between the Junior Meetings.

ARTICLE III.—Meetings.

Sec. 1. There shall be two meetings of the Junior Department a year. If practicable, on the Saturday following the October meeting of the Woman's Auxiliary and on the Saturday following the May meeting of the Woman's Auxiliary. Of these two meetings, the one nearest the Annual Diocesan Council shall be called the Annual Meeting.

Sec. 2. The representation at these meetings shall be the officers and four delegates from each Junior Branch, the delegates being chosen by the Branch. Officers and delegates shall pay yearly dues of twenty-five cents each.

Sec. 3. The Treasurer of each Branch shall send all moneys of the Branch to the Secretary five days before the Annual Meeting.

Sec. 4. Special meetings may be called by the President at any time.

ARTICLE IV.—Current Expense.

There shall be a Current Expense Fund raised by an assessment on each member of each Branch of ten cents a year, and the delegates' dues of twenty-five cents each.

ARTICLE V.—Credentials.

Delegates to the Junior Meetings shall be accredited upon the payment of Delegates' Dues and the Current Expense Per Capita Tax of their respective Branches.

ARTICLE VI.—Mode of Election.

There shall be a nominating Committee of three appointed by the President. Elections shall be by ballot. A majority vote elects. Unless there shall be a clear majority vote on the first ballot the chair shall declare the two names having the largest number of votes and subsequent ballots shall be upon these two names, until a majority vote is reached. Any vacancy occurring in the elective offices shall be filled for the unexpired term, by appointment by the President.

ARTICLE VII.—Amendments.

The By-Laws may be repealed or amended at either Junior Meeting by a two-thirds vote of the delegates present, notice of such proposed change being given at the previous Junior Meeting and the Woman's Auxiliary concurring.
