## **MEMBERSHIP**

The membership of the Woman's Auxiliary is composed of those women who by virtue of their baptism are already members of the Missionary Society, and who, recognizing the responsibilities such membership entails, take an active part in this association also.

No membership fee is required by the General Auxiliary.

Feast of Annunciation Day, March 25th, is the day set aside for the Quiet Day in the Church for all women. Meditations will be held on this day—the time and place given later.

## **DIRECTIONS FOR PARISH SECRETARIES**

1 The Box Directress of the Diocesan Branch has on hand letters sent from the Church Mission House, stating needs of missionaries, hospitals, and schools in the Mission field. When your branch is ready to start work, write to her for such letters.

When your branch has undertaken the work for which your selected letter calls, notify the Box Directress at once, sending her the name and address in such letter, and your own address and parish. It is of the utmost importance that immediately after such decision all rejected letters be returned to the Box Directress.

Write to the Missionary at once, stating when and from whom he may expect a box.

Write to the Missionary as soon as the box has been dispatched, also to the Box Directress with statement concerning value of box.

## ANNUAL REPORT

### of the Recording Secretary of the Diocese of West Missouri Branch of the Woman's Auxiliary to the Board of Missions

To the Rt. Rev. Sidney C. Partridge, Bishop of the  
Diocese of West Missouri, and the Women of the Auxiliary:

I hereby present my annual report of the work done by the officers  
and parish branches of the Woman's Auxiliary of the Diocese of West  
Missouri during the year 1915-1916.

Two regular meetings of the Woman's Auxiliary were held during  
the year, the third or mid-winter meeting being omitted because of the  
Provincial meeting of the Southwest being held here. This meeting,  
known as the Synod, was held in Kansas City in February, covering  
a three days' session. It was well attended and the interest manifested  
was very gratifying and we all feel that much benefit accrues to the  
Diocese by reason of it. It was during this Provincial meeting that  
the women organized in a simple form, under the name of the Woman's  
Auxiliary to the Board of Missions in the Province of the Southwest,  
and adopted a constitution for the government of its work. Your Sec-  
retary is most happy to report an increase of working branches in the  
Woman's Auxiliary. We have at this time nineteen organized  
branches, and nine different groups of women doing Auxiliary Work to  
the Board of Missions; however, not as yet organized.

I wish to call special attention to the work of our Juniors, who are  
organizing new branches throughout the Diocese and may our women  
extend any help or encouragement possible to Junior workers in their  
parish.

O, Almighty God, Who art the guide and support of those who  
serve Thee, give light to our path and strength to our hearts, we be-  
seech Thee.

## **REPORT OF EDUCATIONAL SECRETARY**

**From May, 1915, to May, 1916.**

While the Mission Study Class of this Diocese is still in its infancy we feel that a good foundation has been laid.

The Synod, with its Missionary exhibits and the inspiration received from Miss Lindley, who conducted a Normal class during the meeting of the Synod, did much to strengthen this foundation.

A Bible class, with Bishop Partridge as its leader, was held each week during Lent in St. Paul's Church. This was for all church women.

Kansas City Trinity branch, in addition to the regular meetings, met each week in Lent for study. St. John's met four weeks and St. Mark's two weeks, using "The Conquest of the Continent" as their text-book. St. George's had a special class: three weeks of Lent on "The Last Week," in addition to their regular meetings. St. Paul's had "Missionary Heroes" as the subject of study this year. St. Mary's has Missionary readings at each regular meeting. Christ Church, St. Joseph, had conferences each Friday during Lent. Their subject was "Prayer." Christ Church, Springfield, had "The Gospel of St. Matthew" under the leadership of their Rector. St. John's, Springfield, had Missionary readings at each meeting. The branch at Lexington reports having studied "The Conquest of the Continent," "Why and How of Foreign Missions," "The Spirit of Missions," and "Work in the Tennessee Mountains." The Study Class at Savannah has read three different text-books during the year. Lamar reports a very interesting course of study. They have had Bible study, papers and readings on Missionary subjects during the year. They met every week during Lent. The new and enthusiastic branch at Carthage met each week in Lent and studied "The Conquest of the Continent." The faithful little branch at Warrensburg continues to do fine work. "Modern Heroes" is their subject. Owing to the visit of our president, Nevada did some Mission study work on Alaska during Lent. As other results of her visits we expect to have Missionary readings in Monett, Joplin and Webb City. The Preparatory Study Class of Kansas City is most zealous in the study of Missions.

By request most of the parishes have appointed a branch educational secretary.

The secretaries, by their faithfulness, have been a great aid in promoting Mission Study.

## **REPORT OF THE VICE-PRESIDENT**

**In Charge of the Junior Department**

**From May, 1915, to May, 1916**

Commendation must be given our Junior leaders for their earnest work of the year just closed. Commendation is also due our young officers for the stand they have made to aid in the systematic arrangement of their duties. In both of these points I have found a great ad-

vance this last year. The largest and most successful meeting of our history held recently, was the direct work of a program committee appointed in January. The imposing sight of upwards of 135 children, boys and girls, in the procession was the reward of earnest co-operative work and prayer. The talks from our Bishop and the Clergy made the meeting a decidedly instructive one. We are preparing for an educational meeting of the Board of Directresses in the autumn.

Boys and girls of Junior age and of the age of the St. Paul's Brotherhood have been meeting at Lexington doing local work under the direction of Mrs. MacKellar; also at Sedalia. The latter place has the work of the Camp Fire Boys and Girls.

The prayer desk fund, known as our Junior Easter Gift for 1916, was presented to the St. Luke's Excelsior Springs fund.

On the resignation of Miss Buechle, Miss Alice Beneke, of Grace Church, Carthage, was appointed in January to take charge of section 1 of the Diocese.

The Junior Extension Work in the Diocese carried on by the educational secretary, Mrs. Burr and her assistants, deserves special mention.

Our United Offering has increased.

Our Little Helpers has increased in branches and money.

Our cash pledges have increased.

## CONSTITUTION

### of the West Missouri Diocesan Branch of the Woman's Auxiliary to the Board of Missions

#### ARTICLE I.

The name of this Association is The West Missouri Diocesan Branch of the Woman's Auxiliary to the Board of Missions.

#### ARTICLE II.

Its object is to increase by united effort and sympathetic action, the interest of all the Parishes and Missions of this Diocese in the Missionary work of the Church.

#### ARTICLE III.

All baptized women of this Diocese are regarded as members of this Association.

#### ARTICLE IV.

The officers of this Association shall be, the Bishop, ex-officio, a President, five Vice-Presidents, one First Vice-President, one from each of the three deaneries and one in charge of the Junior Department, a Recording Secretary, a Corresponding Secretary, a Treasurer and an Auditor, all of whom, except the Bishop, shall be elected at the Annual Meeting next after the General Triennial Meeting, and shall serve three years; but the President shall not be eligible for two consecutive terms.

The President, when elected, shall appoint and define the duties of an Educational Secretary, a Mite Box Custodian, a United Offering Treasurer, Box Directress, and such committees as she may deem expedient, each to serve one year; and a vacancy occurring in these appointments shall be filled by the President for the unexpired term.

Any vacancy occurring in any of the elective offices shall be filled by appointment by the Board of Managers until the next regular meeting, at which time the vacancy shall be filled by election for the unexpired term.

The duties of the officers shall be those usually appertaining to their respective offices and such additional duties as may from time to time be prescribed by the By-Laws.

#### ARTICLE V.

There shall be a Board of Managers consisting of the Diocesan officers and the Presidents, Secretaries and Treasurers of the Parish Branches. This board shall meet on Thursday, one month before each meeting of the Auxiliary, and at other times upon the call of the President.

It shall be entrusted with the management of the affairs of this Diocesan Branch of the Auxiliary and shall have power to transact all business that may come before it.

#### ARTICLE VI.

There shall be three regular meetings during the year, namely: one in November, on the Thursday following the Council; one on the fourth Thursday in January and one on the Thursday next before Ascension Day. Should Ascension Day fall on Thursday the meeting will be held on the Thursday preceding that day, and will be the Annual Meeting of the Woman's Auxiliary.

#### ARTICLE VII.

Each Branch shall be entitled to representation at all meetings by its officers and four delegates chosen by itself.

Each Branch shall pay in advance such membership fee as may from time to time be fixed by the By-Laws.

#### ARTICLE VIII.

This Constitution may, with the approval of the Bishop, be amended at any regular meeting of the Auxiliary by a two-thirds vote of the delegates present.

## BY-LAWS

### 1.

The order of business at all regular meetings shall be as follows:

1. Divine Services.
2. Roll Call.
3. Reading Minutes.
4. President's Address.
5. Report of Secretary.
6. Report of Treasurer.
7. Report of Auditor.
8. Report of Corresponding Secretary.
9. Report of Educational Secretary.
10. Report of Box Directress.
11. Reports of Parish Branches.
12. Reports of Committees.
13. Unfinished Business.
14. New Business.
15. Elections.

### 2.

The Recording Secretary, in addition to the regular duties of the office, shall prepare an Annual Report for circulation in the Diocese.

### 3.

The Corresponding Secretary, in addition to the regular duties of the office, shall make annually a full report of the work of the Diocesan Branches to the General Secretary of the Woman's Auxiliary in New York.

### 4.

The duties of the Treasurer shall be to receive all money, receipt for same and disburse under the directions of Parish Branches and the Society. She shall render a report at all regular meetings.

### 5.

The duty of the Auditor shall be to examine and audit the books of the Treasurer before each meeting.

### 6.

Parish and Mission elections of delegates shall take place during the month preceding the Annual Meeting and be immediately reported by the local secretary to the Diocesan Secretary.

### 7.

Delegates and alternates to the Auxiliary meeting at the time of the Triennial Council shall be elected at the Annual Meeting in May preceding the meeting of the Triennial Council.

8.

A current expense fund of one hundred dollars shall be provided annually for printing, postage, stationery and expense of speakers. The amount shall be appropriated among the various Parish and Mission branches by a committee of three appointed by the President.

9.

All money shall be sent to the Treasurer one week before each meeting.

10.

There shall be a nominating committee of five appointed by the President one month before the election of officers.

11.

Any member may nominate from the floor.

12.

All elections shall be by ballot.

Any delegate may nominate.

Unless there is an election by a clear majority on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

13.

There shall be an executive committee consisting of the President, First Vice-President, Recording Secretary and Treasurer. This committee shall transact such business as may be necessary between meetings of the Board.

14.

Each Branch shall pay an Annual Membership fee of fifty cents for each delegate and officer and no delegate or official shall be entitled to vote unless all the dues and assessments of her Branch shall have been paid in full.

15.

No part of the current expenses of the Association shall be paid from the funds contributed for Missionary purposes.

16.

Nine members of the Board of Managers shall constitute a quorum.

17.

These By-Laws may be altered or amended or suspended at any meeting by a two-thirds vote of the members present.

## BY-LAWS OF THE JUNIOR DEPARTMENT

—of the—

### Woman's Auxiliary of the Diocese of West Missouri

#### ARTICLE I.—Officers.

Sec. 1. The officers of the Junior Department shall be a President, who shall be the Vice-President of the Woman's Auxiliary in charge of the Junior Department; a Vice-President for each section; a Recording Secretary, a Corresponding Secretary, a Treasurer, who shall be elected in the Junior annual meeting next after the General Triennial meeting and who shall serve three years; a United Offering Secretary, an Educational Secretary and a Librarian, who shall be appointed by the President with the approval of the President of the Woman's Auxiliary.

#### ARTICLE II.—Duties of Officers.

Sec. 1. The President shall have general supervision over the work of the Junior Department and endeavor to further it. She shall preside at the Junior meetings and shall report the work of the Junior Department at the Annual Meeting of the Woman's Auxiliary.

Sec. 2. The three Vice-Presidents shall have supervision over the work of their respective sections, and shall report its work to the President at each quarterly and annual meeting.

Sec. 3. The Recording Secretary shall keep the minutes of the Junior meetings and send copies of same to each branch within ten days after the meeting. She shall receive and record the Junior offerings and forward them to the Treasurer; and shall prepare the annual report.

Sec. 4. The Corresponding Secretary, in addition to the regular duties of the office, shall make an annual report of the Diocesan Branches to the General Secretary of the Woman's Auxiliary in New York.

Sec. 5. The Treasurer shall receive the Junior offerings from the Secretary and disburse them as they are designated, and shall report the same at the quarterly and annual Junior meetings.

Sec. 6. The United Offering Secretary shall furnish the branches of the Diocese with United Offering boxes and leaflets, and bring to their attention in other ways the purposes of the United Offering. She shall keep a list of contributors, and make semi-annual collections and turn them over to the United Offering Secretary of the Woman's Auxiliary. She shall render a report of the offerings at the quarterly and annual Junior meetings. She shall serve as chairman of the committee on United Offerings.

Sec. 7. The Educational Secretary shall collect and circulate all necessary information pertaining to Mission study in the Junior De-

partment, and shall make a report to the President at each quarterly and annual Junior meeting. The Educational Secretary shall serve as chairman on a committee on Mission Information.

Sec. 8. The Librarian shall be custodian of the West Missouri Lending Library. In addition to the regular duties of a Librarian, she shall mail out and receive all books, and perform such duties as may fall to the office.

Sec. 9. The President of the Woman's Auxiliary and the Junior Diocesan officers and leaders shall constitute a board which shall have power to transact all urgent business that may come before it during the time between the Junior meetings.

#### ARTICLE III.—Meetings.

Sec. 1. There shall be an annual meeting of the Junior Department on the Saturday preceding the Annual Meeting of the Woman's Auxiliary; and two quarterly meetings on the Saturday preceding the quarterly meetings of the Woman's Auxiliary.

Sec. 2. The representatives at these meetings shall be the officers and not more than four delegates from each Junior Branch. Officers and delegates shall pay yearly dues of ten cents each.

Sec. 3. The Treasurer of each Branch shall send all moneys of the Branch to the Secretary ten days before the Annual Meeting.

Sec. 4. Special meetings may be called by the President at any time.

#### ARTICLE IV.—Current Expense.

There shall be a Current Expense Fund raised by an assessment on each member of each Branch of ten cents a year, and the delegates' dues of ten cents each.

#### ARTICLE V.—Credentials.

Delegates to the Junior Meetings shall be accredited upon the payment of Delegates' Dues and the Current Expense Per Capita Tax of their respective Branches.

#### ARTICLE VI.—Mode of Elections.

**There shall be a Nominating Committee of three appointed by the President.** Elections shall be by ballot. A majority vote elects. Unless there shall be a clear majority vote on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached. Any vacancy occurring in the elective offices shall be filled for the unexpired term by appointment by the President.

#### ARTICLE VII.—Amendments.

The By-Laws may be repealed or amended at either Junior Meeting by a two-thirds vote of the delegates present, notice of such proposed change being given at the previous Junior Meeting and the President of the Woman's Auxiliary concurring.

#### STANDING RULE—(Suggested).

A written resignation by parish leader should be sent to the priest in charge of the parish and to the Vice-President in charge of the Juniors of the Diocese upon retirement from office.
