MEMBERSHIP.

No membership fee is required by the General Auxilinry.

The Woman's Auxiliary Department of The Spirit of Missions is, by order of the Board of Missions, the official organ of the Woman's Auxiliary.

Feast of Annunciation Day, March 25th, is the day recommended by the General Auxiliary for a Quiet Day in the church for all women.

ANNUAL REPORT

of the Recording Secretary of the Diocese of West Missouri Branch of the Woman's Auxiliary to the Board of Missions.

*To the Rt. Rev. Sidney C. Partridge, Bishop of the
Diocese of West Missouri, and the Women of the Auxiliary:*

Of first importance in our year's work was the Pilgrimage of Prayer. Coming as it did, at the hottest season of the year, and during the street car strike, the proposed union services were impossible. Still, individually, we did our best, and all found help in its observance. The closing week in the autumn was faithfully kept in almost every parish.

We were much disappointed in not having our Missionary Institute on account of illness in the family of the leader, Miss Withers, but we have that to look forward to this autumn.

We had the great pleasure of having Mrs. Biller of the Church Missions House at our November meeting and later Deaconess Hargreaves of the Philippine Islands visited the Diocese.

A new feature of the year's work was the Union Diocesan Box, the success of which is largely due to the committee in charge, Mrs. Hudson, Mrs. Casperson and Mrs. Child. This box brought responses from quarters that had long been silent to appeals.

There have been two changes in the personnel of the Diocesan officers. Mrs. Murray, our faithful Educational Secretary, resigned on account of ill health. Mrs. J. C. Howard, of Grace-Trinity, was appointed her successor. It was with regret we accepted the resignation of Mrs. Johnson, our Corresponding Secretary. Having taken over the duties of her husband, who is in France, she found it impossible to continue her work in the Auxiliary. At the May meeting Miss Maria Bacon was elected in her stead.

The President has visited nearly all the Auxiliaries in the Diocese with very good results. Twenty-eight Parishes are represented in the Parish Reports. It is most gratifying to welcome a new branch from Calvary Mission, Lees Summit, organized by that faithful worker, Miss Eugenie Cordell.

Three regular meetings have been held: in November, at Calvary Church, Sedalia; in January, at St. Mary's, Kansas City; in May, at St. Paul's, Kansas City. There was an unusually large attendance on the Quiet Day, held by Bishop Partridge at St. Paul's, Kansas City, on the Feast of the Annunciation.

During Lent there were numerous study classes in the different Parishes. The study class for prospective leaders, held once a month under the leadership of Mrs. Lowe of St. George's, deserves especial

mention. Attendance upon this class is a privilege, and more women should avail themselves of it.

The Big Sister movement inaugurated by our President has made good headway. Without seeming to impute effeminacy to the clergy, it must be admitted that, so far, they have been more active Big Sisters than the Auxiliary women. Still, some of us have made a beginning.

The Treasurer reports all bills paid and all obligations met and a little over. All honor to the Treasurer!

It is with great pleasure we announce that Mrs. Nathaniel W. Hopkins of St. Paul's, Kansas City, has accepted the Diocesan leadership in the new war work planned by the Church Missions House this fall. We bespeak hearty co-operation and support for Mrs. Hopkins from all the Parish Branches.

A Normal study class, for Diocesan and Parochial officers, was held once a month, conducted by Mrs. Frederick M. Lowe. "The Lure of Africa" was the text book recommended.

Grace and Holy Trinity had a large class with Mrs. Snow as leader.

St. John's class was conducted by Mrs. Stewart.

At Plattsburg, a reading from the Spirit of Missions at each meeting.

St. Joseph reports a splendid class.

At Carrollton, Rev. Mr. Craft gave lectures on Church History; also a Missionary study class.

Carthage held a class in connection with their year's program.

Pleasant Hill has a class started under the leadership of Miss Cor dell.

St. Margaret's Chapter of the Woman's Auxiliary had a very interesting class and accomplished a great deal.

We hope to have a class in each parish for the coming year.

Report of Vice-President in Charge of the Junior Department

From May 12, 1917, to May 11, 1918.

Vice-Presidents of Sections II and III report an enrollment of 131 members in our Diocese from nine to eighteen years. No report from Section I Vice-President, but some cash has been forwarded our Recording Secretary. This enrollment represents seven parishes, with three branches of Section II and four branches of Section III meeting separately, and one branch of Sections II and III meeting jointly.

Have held correspondence with Lexington, Joplin, Sedalia and Springfield regarding organization work.

We regret the loss of St. John's Kansas City Branch and hope to have them with us this coming year. Holy Trinity, Kansas City, when it had completed its pledge made to January 1, 1918, co-operated with Grace Church Branch and henceforth will be known as Grace and Holy Trinity, working under one leader.

We take pleasure in acknowledging the aid of St. Phillip's, Joplin, and of Calvary Church, Sedalia, Sunday Schools, on our Christmas boxes for 1917, and Calvary Church, Sedalia, on our May box for 1918.

Three appeals were filled in West Missouri Junior circles for Christmas; one to Gaston County Missions, Gastoria, N. C.; one to St. Elizabeth's, White Rocks, Utah; and one to St. Paul's Mission,

White Horse, S. Dak. Our May, 1918, box is on its way to Rowland Hall, the Diocesan School, Salt Lake City.

The gift of our prayer desk went to Pleasant Hill Mission in our own Diocese, where a former Junior leader and her sister are doing wonderful work.

The classified list of our West Missouri Lending Library is now ready for actual service in the Province of the Southwest, and we are glad to welcome the Rev. A. W. S. Garden as our President of Board of Trustees, who came to us the past year on the resignation of the Rev. Edward Henry Eckel as Secretary of the Province. We would wish here to thank Mr. Eckel for his most efficient and scholarly advice and personal efforts and time given to prepare the Library for us. Copies of the list have been distributed at three Diocesan Councils this week, having come direct from the printers to be presented at our annual meeting at St. George's Parish House May 11th.

The following Sunday Schools are using the "Christian Nurture Course" or some "Missions in the Sunday School" plan: Christ Church, St. Joseph; Grace and Holy Trinity, St. Paul's, St. George's, Kansas City; and Grace Church, Carthage.

We have most interesting appeals from Advent Mission, Columbia, Tenn., and San Juan Indian Mission, New Mexico, where Miss Peters is with the Navajos, for our Christmas appeal for 1918.

CONSTITUTION
of the West Missouri Diocesan Branch of the Woman's
Auxiliary to the Board of Missions.

ARTICLE I.

The name of this Association is The West Missouri Diocesan Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is to increase by united effort and sympathetic action the interest of all the Parishes and Missions of this Diocese in the Missionary work of the Church.

ARTICLE III.

All baptized women of this Diocese are regarded as members of this Association.

ARTICLE IV.

The officers of this Association shall be, the Bishop, *ex-officio*, a President, a First Vice-President, a Vice-President from the Northern section of the Diocese, a Vice-President from the Southern Section of the Diocese, and a Vice-President to have charge of the Junior Department, a Recording Secretary, a Corresponding Secretary, a Treasurer, and an Auditor, all of whom, except the Bishop, shall be elected at the annual meeting next after the General Triennial Convention, and shall serve three years; but the President shall not be eligible for two consecutive terms.

The President, when elected, shall appoint and define the duties of an Educational Secretary, a Mite Box Custodian, a United Offering Treasurer, a Box Directress, and such committees as she may deem expedient, each to serve one year. A vacancy occurring in these appointments shall be filled by the appointment of the President, ratified by the Board of Managers.

Any vacancy occurring in any of the elective offices shall be filled by appointment by the Board of Managers until the next regular meeting, at which time the vacancy shall be filled by election for the unexpired term.

The duties of the officers shall be those usually appertaining to their respective offices and such additional duties as may from time to time be prescribed by the By-Laws.

ARTICLE V.

There shall be a Board of Managers consisting of the Diocesan officers and the elected officers of the Parish Branches. This Board shall meet on Thursday, one month before each meeting of the Auxiliary, and at other times upon call of the President.

It shall be entrusted with the management of the affairs of this Diocesan Branch of the Auxiliary, and shall have power to transact all business that may come before it.

ARTICLE VI.

There shall be three regular meetings during the year, namely: the third Thursday in November, the first Thursday in February and the Thursday following the Annual Council in May.

ARTICLE VII.

Each Branch shall be entitled to representation at all meetings by its officers and four delegates chosen by itself.

Each Branch shall pay in advance such membership fee as may from time to time be fixed by the By-Laws.

ARTICLE VIII.

This Constitution may, with the approval of the Bishop, be amended at any regular meeting of the Auxiliary by a two-thirds vote of the delegates present.

BY-LAWS.

1.

The order of business at all regular meetings shall be as follows:

1. Divine Services.
2. Roll Call.
3. Reading Minutes.
4. President's Address.
5. Report of Secretary.
6. Report of Treasurer.
7. Report of Auditor.
8. Report of Corresponding Secretary.
9. Report of Educational Secretary.
10. Report of Box Directress.
11. Reports of Parish Branches.
12. Reports of Committees.
13. Unfinished Business.
14. New Business.
15. Elections.

2.

The Recording Secretary, in addition to the regular duties of the office, shall prepare an Annual Report for circulation in the Diocese.

3.

The Corresponding Secretary, in addition to the regular duties of the office, shall make annually a full report of the work of the Diocesan Branches to the General Secretary of the Woman's Auxiliary in New York.

4.

The duties of the Treasurer shall be to receive all money, receipt for same, and disburse under the directions of Parish Branches and the Society. She shall render a report at all regular meetings.

5.

The duty of the Auditor shall be to examine and audit the books of the Treasurer before each meeting.

6.

Parish and Mission elections of delegates shall take place during the month preceding the Annual Meeting and be immediately reported by the local Secretary to the Diocesan Secretary.

7.

Delegates and alternates to the Auxiliary meeting at the time of the Triennial Council shall be elected at the Annual Meeting in May preceding the meeting of the Triennial Council.

8.

A current expense fund of one hundred dollars shall be provided annually for printing, postage, stationery and expense of speakers. The amount shall be apportioned among the various Parish and Mission branches by a committee of three appointed by the President.

9.

All money shall be sent to the Treasurer one week before each meeting.

10.

There shall be a nominating committee of five appointed by the President one month before the election of officers.

11.

Any member may nominate from the floor.

12.

All elections shall be by ballot.

Any delegate may nominate.

Unless there is an election by a clear majority on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

13.

There shall be an executive committee consisting of the President, First Vice-President, Recording Secretary and Treasurer. This committee shall transact such business as may be necessary between the meetings of the Board.

14.

Each Braach shall pay an Annual Membership fee of fifty cents for each delegate and officer and no delegate or official shall be entitled to vote unless all the dues and assessments of her Branch shall have been paid in full.

15.

No part of the current expenses of the Association shall be paid from the funds contributed for Missionary purposes.

16.

Nine members of the Board of Managers shall constitute a quorum.

17.

These By-Laws may be altered or amended or suspended at any meeting by a two-thirds vote of the members present.

BY-LAWS OF THE JUNIOR DEPARTMENT

—of the—

Woman's Auxiliary of the Diocese of West Missouri.

ARTICLE I.—Officers.

Section 1. The officers of the Junior Department shall be a President, who shall be the Vice-President of the Woman's Auxiliary in charge of the Junior Department; a Vice-President for each section; a Recording Secretary, a Corresponding Secretary, a Treasurer, who shall be elected in the Junior annual meeting next after the General Triennial meeting and who shall serve three years; a United Offering Secretary, an Educational Secretary, who shall be appointed by the President with the approval of the President of the Woman's Auxiliary.

Sec. 2. The West Missouri Lending Library shall be governed by a Board of Trustees consisting of six members, who shall be the Provincial Secretary of the Southwest, the President of the Woman's Auxiliary, the Vice-President of the Woman's Auxiliary in charge of the Juniors, and a Junior representative from each of the three deaneries—the first three by virtue of their office to be ex-officio members, and the three Junior representatives to be elected at the annual meeting next after the General Triennial.

ARTICLE II.—Duties of Officers.

Section 1. The President shall have general supervision over the work of the Junior Department and endeavor to further it. She shall preside at the Junior meetings and shall report the work of the Junior department at the Annual Meeting of the Woman's Auxiliary.

Sec. 2. The three Vice-Presidents shall have supervision over the work of their respective sections, and shall report its work to the President at each quarterly and annual meeting.

Sec. 3. The Recording Secretary shall keep the minutes of the Junior meetings. She shall receive and record the Junior offerings and forward them to the Treasurer, and shall prepare the annual report.

Sec. 4. The Corresponding Secretary, in addition to the regular duties of the office, shall make an annual report of the Diocesan Branches to the General Secretary of the Woman's Auxiliary in New York.

Sec. 5. The Treasurer shall receive the Junior offerings from the Secre-

tary and disburse them as they are designated, and shall report the same at the quarterly and annual Junior meetings.

Sec. 6. The United Offering Secretary shall furnish the branches of the Diocese with United Offering boxes and leaflets, and bring to their attention in other ways the purposes of the United Offering. She shall keep a list of contributors. She shall render a report of the offerings at the quarterly and annual Junior meetings. She shall serve as chairman of the committee on United Offerings.

Sec. 7. The Educational Secretary shall collect and circulate all necessary information pertaining to Mission study in the Junior Department, and shall make a report to the President at each quarterly and annual Junior meeting. The Educational Secretary shall serve as chairman on a committee on Mission Information.

Sec. 8. The President of the Woman's Auxiliary and the Junior Diocesan officers and leaders shall constitute a board which shall have power to transact all urgent business that may come before it during the time between the Junior meetings.

ARTICLE III.—Meetings.

Section 1. There shall be an annual meeting of the Junior Department on the Saturday preceding the Annual Meeting of the Woman's Auxiliary; and two quarterly meetings on the Saturday preceding the quarterly meetings of the Woman's Auxiliary.

Sec. 2. The representatives at these meetings shall be the officers and not more than four delegates from each Junior Branch. Officers and delegates shall pay yearly dues of ten cents each.

Sec. 3. The Treasurer of each Branch shall send all moneys of the Branch to the Secretary ten days before the Annual Meeting.

Sec. 4. Special meetings may be called by the President at any time.

ARTICLE IV.—Current Expense.

There shall be a Current Expense Fund raised by an assessment on each member of each Branch of ten cents a year, and the delegates' dues of ten cents each.

ARTICLE V.—Credentials.

Delegates to Junior Meetings shall be accredited upon the payment of Delegates' Dues and the Current Expense Per Capita Tax of their respective Branches.

ARTICLE VI.—Mode of Elections.

There shall be a Nominating Committee of three appointed by the President. Elections shall be by ballot. A majority vote elects. Unless there shall be a clear majority vote on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached. Any vacancy occurring in the elective offices shall be filled for the unexpired term by appointment by the President.

ARTICLE VII.—Amendments.

The By-Laws may be repealed or amended at either Junior Meeting by a two-thirds vote of the delegates present, notice of such proposed change being given at the previous Junior Meeting and the President of the Woman's Auxiliary concurring.

STANDING RULE—(Suggested).

• A written resignation by parish leader should be sent to the priest in charge of the parish and to the Vice-President in charge of the Juniors of the Diocese upon retirement from office.
