## CONSTITUTION.

### ARTICLE I

The name of this organization shall be The West Missouri Diocesan Branch of The Woman's Auxiliary to the Presiding Bishop and Council.

### ARTICLE II

Its object shall be to increase, by united effort, the interest of all Parishes and Missions of this Diocese in the missionary work of the Church.

### ARTICLE III

All baptized women of this Diocese are regarded as members of this Auxiliary.

### ARTICLE IV

The head of this Auxiliary shall be the Bishop, ex-officio. The officers shall be: a President; a First Vice President; a Vice President from the northern and a Vice President from the southern section of the Diocese; a Recording Secretary; a Corresponding Secretary; a Treasurer and an Auditor, all of whom, except the Bishop, shall be elected at the Annual Meeting next after the Triennial General Convention, and shall serve three years. The President shall not be eligible for two consecutive terms.

The duties of these officers, other than as prescribed by the By-Laws, shall be those usually appertaining to their respective offices. The President shall appoint and define the duties of: an Educational Secretary, a United Thank Offering Treasurer, a Box Directress, a Finance Committee and such other committees as she may deem expedient, each to serve one year. A vacancy occurring in these appointments shall be filled by the President. A vacancy occurring in any of the elective offices shall be filled by the Board of Managers until the next regular meeting when it shall be filled by election for the unexpired term.

### ARTICLE V

There shall be three regular meetings during the year: an Annual Meeting on the Thursday following the Annual Council in January; a meeting the first Thursday in May that does not fall on Ascension Day; and a meeting the first Thursday in November that does not fall on All Saints' Day.

### ARTICLE VI

Each Parish Branch shall be entitled to representation at all meetings by its officers and four delegates elected by itself. Each Branch shall pay in advance such Delegates' dues as shall be fixed by the By-Laws.

### ARTICLE VII

This Constitution may, with the approval of the Bishop, be amended at any regular meeting of the Auxiliary, by a two-thirds vote of the Delegates present, after thirty days written notice to each Parish Branch.

## BY-LAWS.

1. The Order of Business at all meetings shall be as follows, except that the Secretary's Report and Parish Reports shall be given at the Annual Meeting only:

8. Report of Corresponding Secretary.	16. Elections.

2. The Recording Secretary shall prepare an Annual Report for circulation in the Diocese.

3. The Corresponding Secretary shall make annually a full report of the work of the Auxiliary to the General Secretary of The Woman's Auxiliary in New York.

4. The Treasurer shall receive all monies, receipt for and disburse the same under the direction of the Parish Branches and the Auxiliary. She shall render a report at all regular meetings.

5. The Auditor shall examine and audit the books of the Treasurer before each regular meeting.

6. There shall be a Board of Managers consisting of the Diocesan Officers and the elected Officers of Parish Branches. This Board shall meet on the first Monday of each month and at other times upon call of the President. It shall be entrusted with the management of the affairs of the Auxiliary and shall have power to transact all business that may come before it. Nine members of the Board, representing at least four Parishes, shall constitute a quorum.

7. There shall be an Executive Committee consisting of the President, the First Vice President, the Recording Secretary, the Corresponding Secretary and the Treasurer, which shall transact such business as may be necessary between the meetings of the Board.

8. Parish and Mission election of Delegates shall take place during the month preceding the Annual Meeting and be immediately reported by the Branch Secretary to the Recording Secretary.

9. Delegates and Alternates to the Auxiliary Meeting held in connection with the Triennial General Convention shall be elected at the May Meeting preceding.

10. Each Branch shall pay an annual fee of fifty cents for each delegate and officer and no delegate or officer shall be entitled to vote unless the dues and assessments of her Branch have been paid in full.

11. A Current Expense Fund of not less than \$200.00 shall be provided annually for printing, postage, stationery and the expense of speakers. This amount shall be apportioned among the Parish and Mission Branches by a Finance Committee of three appointed by the President.

12. All monies shall be sent to the Treasurer one week before each meeting.

13. No part of the current expenses of the Auxiliary shall be paid from funds contributed for Missionary purposes.

14. All nominations shall be by ballot.

15. All elections shall be by ballot. Unless there is an election by a clear majority on the first ballot the chair shall declare the two names having the largest number of votes and subsequent ballots shall be upon them until a clear majority is reached.

16. These By-Laws may be amended or suspended at any meeting by a two-thirds vote of the Delegates present.

17. In any contingency not covered by the Constitution and By-Laws the Auxiliary shall be governed by Longan's Parliamentary Rules.

#### STANDING RULES.

That there be a Missionary Sunday every year, emphasizing the United Thank Offering. (Apr. Board, 1919)

That the Memorial Roll be framed and hung in a suitable place. (May, 1919)

That each woman in the Auxiliary be taxed 5c a month to provide a fund for the traveling expenses of Delegates to the Triennial. (Nov. 1919)

That a fund be provided for the use of the Educational Secretary. (Nov. 1919)

That notices of Board meetings be sent out one week in advance; notices of Annual and Quarterly meetings, two weeks in advance. (Nov. 1919) (Jan. Board, 1920)

That a fund be created for necessary traveling expenses of Officers in the Diocese in the interest of Auxiliary work. (Nov. 1920)

### THE PRESIDENT'S ADDRESS.

When the plans for the Nation Wide Campaign were laid before us we were immediately thrilled by the thought that at last the whole Church was to co-operate in the work so dear to us—the Church's Mission—and the next instant saddened at the thought that perhaps the Woman's Auxiliary would no longer be needed. But one of the things that every woman knows is that there is always a place for her peculiar work, and that young things especially are almost sure to have need of her love and motherly care. So from the vantage of our fifty years of usefulness we can contemplate these young things—the Presiding Bishop and Council—the Nation Wide Campaign—all the other wonderful new plans—with certainty that we are needed, and we have been told by those in authority, in no uncertain tones, that we are likewise wanted.

Of course, as Churchwomen, our first obligation is to the quota of our own parish in the Nation Wide Campaign. But the very fact of our continued membership in the Woman's Auxiliary shows that we expect to do something beside our parish pledge. This same fact brings with it certain responsibilities: the first and foremost being the work of the supply department, or, as we usually say, the box work. This is the one real obligation laid on us by headquarters.

It is however, expected, that as a branch of the Auxiliary, in gratitude for the privilege of sharing in at least part of 'fifty years' splendid work, we will have a share in raising the Jubilee, or Emery, fund.

Of course we still have the United Thank Offering. That is so near our hearts that it hardly seems an obligation, and in our affection for it we must remember that gifts to it come after, and must never interfere with, our regular giving.

This Auxiliary is a part of the Auxiliary of the Province of the Southwest, and as such, obligations undertaken by the Provincial Auxiliary are ours. We have therefore a part in sending a medical missionary to Mexico.

Now whatever else we do is real generosity, in that we do it, not because we have to, but because we want to; not because it is demanded but because it is needed, and as we have been blessed and prospered, so we desire to share our possessions and extend our blessings. Therefore our pledge committee has some other recommendations to make to us. These other pledges will be found somewhat changed. It seemed wise to your board of managers to drop, this year, the Margaret Atwill pledge and to re-

duce the sums of two other memorial funds. They felt that no memorial should be kept up indefinitely, and that these funds should not be large enough to cripple the rest of our work.

I am sure that these and the other recommendations of our pledge committee will be met with the Auxiliary's usual generosity and loyalty.

Loyalty is perhaps the outstanding characteristic of the Woman's Auxiliary. We have been loyal to the Board of Missions. We have been loyal to those whom we have sent out to represent us in the field, at home and abroad. Dean Robbins says of us: "You will no more fail these men on the firing line of Christendom than you would have found it possible to fail our soldiers in France." He speaks truly: we shall not fail them. We shall not fail the Presiding Bishop and Council; we shall not fail our own Bishop and Diocese; we shall not fail our officers in this Auxiliary; we shall not fail our officers in the parish branches. Because the loyalty of the Woman's Auxiliary has its roots in the right place. Dean Robbins has expressed it for us: "Our religion is a religion of loyalty, and our loyalty is Christ-centered. We do not work for the rector of the parish to which we happen to belong. We do not work for the parish. We do not even work for the Church at large. We work in the Church and under the oversight and guidance of those in authority, but we work for our Lord Himself, whose we are, and whom we serve."

And so it is with the fullest confidence that your officers here start on the work for the year. What has been done in the months since our election you will hear in our secretary's report. If it seems to you a somewhat meagre record please remember that conditions are not yet entirely settled and that we have tried to avoid the performance of some new brooms that, in attempting to live up to their reputation for sweeping clean, simply raise a great dust.

## ANNUAL REPORT

of the Recording Secretary of the Diocese of West Missouri Branch  
of the Woman's Auxiliary to the Presiding Bishop and Council.

To the Right Reverend Sidney C. Partridge, Bishop of the  
Diocese of West Missouri, and Women of the Auxiliary:

The year of 1920 has been full of promise and has brought  
some changes.

One important change was the revision of the Constitution,  
which was most ably handled by Mrs. J. J. Rieger and her associates.

The Box work has been changed by the Church Missions  
House in New York, this Diocese being given full responsibility  
for supplying the needs of Pocosan Mission, in the mountains of  
Virginia. This work is under the care of our Box Directress, Mrs.  
Benjamin Brown, who has already demonstrated that the work is  
in able hands.

Another change is the institution of a regular monthly Board  
meeting, which comes on the first Monday of each month, from  
October to June. These meetings are proving of great value.

The Reverend Mr. Sanford who was for long in our work  
among the Indians, as a missionary, was with us in October, and  
gave interesting talks, telling us much of the work and needs  
among the Indians. He spoke before four of the city parishes.

Mrs. Biller, of the Church Missions House of New York, was  
with us for ten days in early December. She visited Lexington,  
Sedalia, Springfield, Carthage, Lamar, Nevada and Marshall. She  
also spoke before the Clericus, attended our December Board  
meeting at St. Mark's, spoke to young ladies at St. George's, to  
the ladies of St. Andrew's, and to St. Paul's Auxiliary. This last  
was an open meeting and was attended by the city parishes. Her  
presence and words brought enthusiasm and increased interest  
which will be a source of inspiration for the future.

In accordance with the recommendation of the Church Service  
League, there was a day of meditation and prayer at St. Mary's  
Church, on St. Andrew's day, conducted by the Rev. R. N. Spencer  
of Grace and Holy Trinity, which was of mutual benefit and profit  
to all who attended. These days should not pass without a large  
and representative attendance, for they are the means of deepening  
and enlarging our own spiritual life.

The Quarterly meeting was held in November at St. Mary's  
Church, with a large attendance, the Celebrant being the Bishop  
who also spoke to us of the action of the Lambeth Conference on  
women's work in the Church. At this meeting it was voted to  
establish a fund to send representatives to our out of town  
branches. This has made it possible for the Recording Secretary  
to visit Lexington and Sedalia and the Vice President to visit  
Marshall where a new Branch of our Woman's Auxiliary has been  
established. The entire Auxiliary is delighted to welcome this  
new Branch.

#### **REPORT OF UNION AUXILIARY BOX FOR 1920.**

The fund for financing the Union Auxiliary Box was raised by giving a benefit picture show at the Warwick Theatre Nov. 4, 1919. The amount realized with donation was \$85.00. With this money the material for children's garments to be sent to the Cathedral Home at Laramie, Wyo., was purchased by a committee of three ladies: Mrs. Ware, Mrs. Crane and Mrs. Casperson and apportioned to different parishes in the Diocese to be made. Those receiving material: Lebanon, Independence, West Plains, Harrisonville, Excelsior Springs, Clinton, Pleasant Hill, Chillicothe, Nevada, Savannah, Warrensburg and St. Andrews of K. C. Very liberal donations were received from Savannah and Cameron also St. Augustine's Mission, who found materials and made 14 garments. It is very much regretted that all of the garments sent out have not been returned so a complete valuation cannot be made at this time. However garments to the valuation of \$256.75 have been sent and safely received, a letter of heartiest appreciation from the Supt. having been received since the arrival of the Box.

#### **REPORT OF EDUCATIONAL SECRETARY.**

The year 1920 has not marked the advance along educational lines that was hoped for. It is hard for one unable to be in close touch with the individual needs of each local Branch, to put through a definite program in all its details, for all alike. We are very likely to forget that the aims of the Auxiliary are: Prayer, Study and Work,—the last being the result of the first two,—and to get ourselves so busy with work and money that prayer and study are neglected.

The Auxiliary has, however, shown so splendid a response to the Box Work and financial appeals, that one can take courage in feeling that this response is possible only because we do pray for and study the needs, to a larger extent than the statistics would indicate.

A questionnaire sent out in May 1920 reveals the following returns:

1. One Normal Class in "Neighbors," led by Mrs. Lowe, attendance, 5.
2. (a) Bible Classes in Lent, led by Bishop Partridge, with a large attendance.  
(b) Numerous Bible classes for women, and men and women.

3. Two Prayer Circles.
4. Three Reading Circles on Church History, during Lent.
5. Fourteen Study Classes on "Neighbors," Prayer, etc.
6. Seven Parishes with Program Meetings, monthly.
7. Six Parishes report educational matter of some kind at the regular meetings.
8. Two Parishes report having a pageant or play.
9. Two hundred new subscribers to Church papers.

Of the results of the Daily Bible Readings sent out, no reports could, of course, be tabulated.

An encouraging feature has been the steadily increasing interest in and sale of, devotional and Church books. About one hundred were sold during the year.

The Educational Exhibit was a feature of the Annual Meeting at St. George's and was particularly fortunate in having a most beautifully illustrated Church Year Calendar loaned by Mrs. Fuller of Trinity Church. During the fall about fifteen hundred pamphlets dealing with the new plans, Church Service League, Prayer leaflets, etc. were sent out and it is hoped, were received, distributed and inwardly digested. Personal letters were written to every outlying Branch and Parish, requesting their co-operation and urging the formation of study classes on the Survey in 1921.

It is a matter of great regret that there can be no report of attendance of even one delegate to any of the splendid Church Summer Conferences. Your Secretary had registered at Racine, but at the last moment was unable to attend. Too great stress cannot be laid on the value of attending these inspiring centers when possible. As Miss Matthews aptly said "They are like being a little while in Heaven."

Realizing that little of the great task has been done, and requesting your especial interest and prayers in behalf of the educational work.

## THE UNITED THANK OFFERING OF 1922.

Resolution Adopted in Detroit, October 20, 1919.

RESOLVED: That the United Thank Offering of 1922 be given to the Board of Missions or any organization which has succeeded, or may hereafter succeed to its functions, for women's work in the mission field, including the training, sending and support of women workers and the care of such workers when sick or disabled—provided that one-tenth of the offering be set aside as a permanent trust fund to be invested and administered by the Board of Missions, or any organization which has succeeded or may hereafter succeed to its functions, the income to be applied to the support of retired United Thank Offering workers,—also provided that the sum of not less than \$10,000 be devoted to the erection, completion or renewal of a building or buildings approved by the Board of Missions on the recommendation of the President of the Board of Missions and the Executive Board of the Woman's Auxiliary.

Also Resolved: That to our united gifts shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves or of their substance to the work of the Master in the mission field.

## THE UNITED THANK OFFERING PRAYER.

O Lord, our Heavenly Father, we pray Thee to send forth more labourers into Thy harvest, and to grant them Thy special grace for every need. Guard and guide the workers in the field, and draw us into closer fellowship with them. Dispose the hearts of all women everywhere to give gladly as Thou hast given to them. Accept from grateful hearts, our United Thank Offering of prayer and gifts and joyful service; and bless it to the coming of Thy Kingdom, through Jesus Christ our Lord. Amen.
