



Fifth Annual Report

In presenting this, the fifth annual report of the Western Massachusetts Branch, the Executive Committee feels that the outlook is encouraging.

Details must of necessity be very similar from year to year, but, looking back five years to the beginning of our Diocesan life, the results appear, upon the whole, very gratifying.

The growth of Diocesan fellowship and sympathy is indicated by the hearty response of parishes and individuals throughout the Diocese, to the call for aid for the church at Easthampton. The earnest efforts of the three vice-presidents and the secretary for Diocesan Missions have been crowned with such success that considerably more than the amount asked has been raised.

Three regular Branch meetings have been held during the year: the fourth annual meeting in St. Peter's Church, Springfield; the autumnal meeting in St. John's Church, North Adams; and the midwinter meeting in St. Matthew's Church, Worcester. The average attendance has been one hundred and fifty-two, an increase of twenty-seven over the previous year.

The speakers at these meetings have been: the Rt. Rev. Alexander Vinton, Bishop of the Diocese; Miss Isabel Emberly of Alaska; the Rev. John D. Gring of Japan; the Rt. Rev. James H. Van Buren, Bishop of Puerto Rico; the Rev. John Meem of Pelotas, Brazil; and Miss Julia Emery, General Secretary of the Auxiliary.

Two Executive Board meetings have been held at the home of the president, besides short sessions held on the day of the regular Branch meetings. One change has occurred in the Executive

Board—Mrs. Hudson, secretary of the Branch since its organization, feeling physically unable to continue longer in the discharge of her duties, was succeeded by Mrs. John Reed of Springfield.

The vice-president for the Worcester District reports a conference of parish officers and juniors, held at All Saints' Church, Worcester, on March 9. About fifty were present in spite of unfavorable weather. Ten parishes have been visited and organization effected in one parish, that of North Brookfield, where before there was only a correspondent.

The vice-president for the Connecticut Valley District reports a pre-Lenten conference held in Grace Church, Chicopee, on February 23, which was well attended. The speakers were, the Rev. Mr. Dakin of Springfield; the Rev. John Porter of Tampa, Fla.; the Rev. Mr. Sniffen, Diocesan Missionary, and Miss Sara Huntington of Connecticut.

The vice-president for the Berkshire District reports few parish visits made, as her efforts have been directed mainly toward raising the fund for the church at Easthampton, with gratifying results.

The first conference of Diocesan officers in the New England Department of the Auxiliary was held in All Saints' Church, Worcester, on April 26. Forty-four Diocesan officers were present, representing all of the New England states. Rev. Dr. Lloyd, General Secretary of the Board of Missions, and Rev. E. P. Smith, Educational Secretary, made brief addresses. Miss Emery, General Secretary of the Auxiliary, conducted a question box, which aroused great interest.

Gifts of money and boxes have been generous. Pledges in the Domestic and Colored Missions departments have been met earlier than ever before.

Twenty-two parishes have contributed to the Foreign pledge.

Twenty-five boxes have been sent for Domestic Missions, thirty-nine for Colored Missions, and eight, including one Berkshire district box, to which six parishes contributed, for Indian Missions. Total, seventy-two; value, \$4,798.52.

Four hundred and ninety-two annual reports, one thousand five hundred and thirty-four leaflets and one hundred and seventeen letters and postals have been sent out.

There are very few parishes and missions which have not contributed in some way to the work of the Woman's Auxiliary; and the Executive Committee wishes to say to the smaller parishes in particular: Do not make the mistake of thinking that because the gift must of necessity be small, it is not worth the giving. Every smallest gift helps the great work, and every parish, no matter how poor, can do something.

Surely, every offering made in the name of the Lord Jesus Christ is "twice blessed. It blesseth him that gives, and him that takes."

The work of the Junior Department this year has been most steadily and faithfully carried on by the parochial branches, although the formation of only one new branch can be reported,—that at St. John's, Williamstown.

Conferences of the Junior parochial officers have been held at the time of the meetings of the Woman's Auxiliary, and plans made for the year.

The Worcester branches had the privilege of hearing Rev. Everett P. Smith, educational secretary, at a meeting held at St. Mark's; it would be a great inspiration to the work if neighborhood meetings could be held in the different districts, with Mr. Smith to address the Juniors.

The pledges have both been paid, and considerable sums sent to other fields; while the "special" set before the Juniors this year—the building of a Junior class room at St. Paul's College, Tokyo—has called forth the generous response of over a hundred dollars.

Trinity Branch of the Junior Auxiliary, Lenox, has by its record earned the banner for the coming year. This honor is well deserved, for the branch, though small, is one of the most faithful in the Diocese.

Fourth Annual Report of the Librarian

Of the forty-six blank forms sent out by the Librarian to the missionary societies which constitute the Western Massachusetts Branch of the Woman's Auxiliary, but twenty-three were returned. Of these twenty-three only fifteen report any missions study done. Those reporting are: St. John's, Athol; Christ Church, Fitchburg; St. James', Greenfield; St. Paul's, Holyoke; St. Mark's, Leominster; St. John's, North Adams; St. John's, Northampton; Christ Church, Springfield; Trinity, Ware; Reconciliation, Webster; St. John's, Williamstown; All Saints', St. John's, St. Mark's, and St. Matthew's, Worcester.

The Librarian would remind the women of the Western Massachusetts Branch that the aims of the Woman's Auxiliary, and, consequently, the duties of its members, are prayer for missions, study of missions, and work and gifts for missions. The second place is given to study. Especially would she remind parochial officers that it is for them to see to it that, in forming plans for the guidance of their societies, provision is made for the fulfilling of this second duty of our auxiliary life.

The Librarian has spoken on the study of missions at a meeting of the missionary society of St. Mark's, Leominster, and has, by letter, given suggestions to several other societies. She arranged a missions study exhibit for the conference of the First Missionary Department, held in All Saints', Worcester, April 26, and also spoke at that conference. She has distributed six hundred sixty-four leaflets.

It is pleasant to note that, in increasing the number of its editors, the Church Missions Publishing Company, one of the recognized auxiliaries to the Board of Missions, has appointed Miss Alice C. Chase of Ware an associate editor.

Preamble

The Church itself is the Missionary Society. Therefore, every baptized woman is a member of the Woman's Auxiliary, and becomes an active member by attendance upon its meetings.

Constitution

of the

Western Massachusetts Branch

of the

Woman's Auxiliary to the Board of Missions

ARTICLE I.

NAME.

The name of this organization shall be the Western Massachusetts Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

OBJECT.

The object of this organization shall be, to unite all church women of the Diocese in work for Domestic and Foreign Missions, to increase missionary activity in the parish auxiliaries, and to encourage the formation of such branches where there are none.

ARTICLE III.

MEMBERS.

All societies of church women in the Diocese, doing work for missions, may be auxiliaries to this Branch; and women co-operating with the Western Massachusetts Branch of the Woman's Auxiliary to the Board of Missions will be considered members of the organization.

ARTICLE IV.

OFFICERS AND THEIR ELECTION.

SECTION 1. The officers of this Branch shall be a President, a Vice-President for each district, a Secretary, a Treasurer, and a Secretary for each of the following divisions of the work respectively: Domestic Missions, Foreign Missions, Indian Missions, Missions to the Colored People, and a Secretary for the Junior Auxiliary.

SEC. 2. These officers shall constitute an Executive Committee, to whom shall be intrusted the general business of the Branch when not in session.

They shall fill all vacancies occurring in the Board between the annual meetings. They shall also choose an Auditor.

SEC. 3. These officers shall be elected by the Branch, by ballot, at the annual meeting. The voting shall be by parishes, each parish and mission being entitled to one vote. All delegates shall be enrolled as such before they are entitled to vote. Women enrolled as members of the Auxiliary, but not delegates, are not entitled to vote.

SEC. 4. There shall be appointed annually, by the Executive Committee, a Nominating Committee of three members: one from each district, who shall nominate at the annual meeting, subject to the approval of the Bishop, one or more candidates for each of the offices named in Article IV, Section 1.

SEC. 5. The Executive Committee shall, with the approval of the Bishop, appoint annually a Librarian, whose duty shall be to keep as complete a file as possible of the Auxiliary and Junior Auxiliary publications, and such other missionary literature as may be available, and to correspond with the parish officers in regard to such literature; and to assist them, when requested, by suggestions for mission study. She shall keep the Vice-Presidents informed of such work in their districts; and present a report of her work at the annual meeting.

ARTICLE V.

DUTIES OF OFFICERS.

SECTION 1. It shall be the duty of the President to call the meetings of the Executive Committee, and of the Branch, and to preside at them.

SEC. 2. It shall be the duty of the Vice-Presidents in order of seniority of appointment to call meetings and preside in the absence of the President. It shall be the duty of each Vice-President to endeavor to increase in her own district a missionary spirit, by rousing the societies to greater interest in the three aims of the Auxiliary, viz., daily prayer for missions, systematic giving for missions, and the study of missions. She shall receive from each parish reports of new work undertaken, and an annual report, which she shall forward to the Secretary. The Vice-Presidents are authorized to hold meetings at such times and places as they please in their own districts.

SEC. 3. It shall be the duty of the Secretary to give notice of meetings and to keep a record of such meetings and to conduct the correspondence of the Branch, and to prepare an annual report for circulation in the Diocese.

SEC. 4. It shall be the duty of the Treasurer to take charge of all money sent her for the purposes of the Branch; to disburse the same, as directed by those sending it or by the Executive Committee. She shall present a report at the annual meeting of all money which has passed through her hands.

SEC. 5. It shall be the duty of the Secretary in charge of each department of missionary work, and also the Secretary of the Junior Auxiliary, to conduct all correspondence relating to that work with the parish auxiliaries, General Secretary, Secretary of the Diocesan Branch and Vice-Presidents, and to present a report of such work at the annual meeting. They shall forward to the General Treasurer all money deposited with them for missionary objects and receive a voucher for the same.

SEC. 6. It shall be the duty of the Auditor to examine all accounts of the Treasurer and to present a voucher for the same.

ARTICLE VI.

This constitution may be amended by a two-thirds vote at a regular meeting of the Branch, provided due notice of such amendment be sent to each parish and mission two weeks before the date of such meeting.

By-Laws

1. The Diocese shall be divided into three districts: the Worcester District, comprising Worcester County; the Connecticut Valley, including Hampden, Hampshire, and Franklin Counties; and Berkshire, comprising Berkshire County.
2. This Branch shall hold three regular meetings yearly, in October, January, and May, the latter to be the Annual Meeting, and to be held in the central district of the Diocese.
3. Special meetings may be called by a two-thirds vote of the Executive Board.
4. Meetings of the Executive Board shall be at the call of the President, or, in her absence, at that of the senior Vice-President, and shall be not less than two annually.
5. An offertory shall be taken at every meeting of the Branch, and each parish may also make an annual voluntary contribution to the running expenses.
6. These By-Laws may be amended by a two-thirds vote at any regular meeting of the Branch.

Definitions

The following definitions will be found helpful:—

General Missions are those Missions of the Church for which the General Board of Missions is responsible.

Domestic Missions are such Missions, supported by the General Board, as are situated within the jurisdiction of the Government of the United States.

Foreign Missions are such Missions, supported by the General Board, as are beyond the jurisdiction of the Government of the United States.

Diocesan Missions are Missions within the Diocese which receive support from the Diocesan Board of Missions, outside the limits of one's own Parish or Mission.

The United Offering is the Thank offering presented at every Triennial service of the Woman's Auxiliary.
