

## Historic Altar now in Church of the Holy Communion, Buffalo, N. Y.



The Church of the Holy Communion, Buffalo, N. Y., was filled to capacity on the afternoon of Whitsunday, June 4, 1933, when the women of the Diocese presented their United Thank Offering. An interesting feature of this very inspiring service was the unveiling and dedication of a beautiful bronze tablet, erected and presented by the Woman's Auxiliary of the Diocese.

The table commemorates the fact that the historic Altar and the Communion Rail, now in this Church, are a gift of the Church of the Holy Communion, New York City, where at this selfsame Altar, the first U. T. O. was made, October 3, 1889.

The Altar and Communion Rail were presented by the Church of the Holy Communion, New York City, to the Church of the Holy Communion, Buffalo, because of the close friendship existing between Dr. Henry Mottet, third rector of the former, and Dr. Charles H. Smith, founder and first rector of the latter.

The Altar is probably the oldest Altar in use in the Church in the United States today, and is approximately 100 years old.

The inscription on the tablet is as follows:

ON THIS ALTAR IN THE CHURCH OF THE HOLY COMMUNION, NEW YORK CITY WAS PRESENTED THE FIRST UNITED THANK OFFERING OF THE WOMEN OF THE CHURCH, OCTOBER 3, 1889. THE WOMEN PRESENTING IT RECEIVED HOLY COMMUNION KNEELING AT THIS RAIL.

THIS TABLET GIVEN AT THE PRESENTATION SERVICE WHITSUNDAY, JUNE 3, 1933 BY THE WOMAN'S AUXILIARY, DIOCESE OF WESTERN NEW YORK.

## Minutes of the Annual Meeting and Officers Reports for 1933

The Woman's Auxiliary to the National Council, Diocese of Western New York, held their annual meeting at the Church of the Transfiguration, Buffalo, January 16, 1934.

The meeting opened with a celebration of the Holy Communion at 10 A. M. Bishop Davis was the celebrant, assisted by Rev. John Sagar, Rev. Edgar L. Tiffany and Rev. Charles D. Broughton. Bishop Davis made a short address in which, among other things, he said that he was depending very much upon the women of the Church to help to deepen the spiritual life of the home and hoped for the same sympathetic help he had always received from them. The Bishop also paid a very beautiful tribute to the late Dr. Charles R. Allison, Dean of the Lake Shore District, saying Dr. Allison was one of the outstanding rural workers of the Church.

Following the service, the business meeting was called to order by the President, Mrs. Dyett. Bishop Davis was asked to come in and the President requested the women to rise and thereby pledge him their support.

Mrs. Frank Weaver, retiring Devotional Chairman, led the opening prayers.

Mrs. Ida Fox, President of Transfiguration Branch, gave a short address of welcome.

A motion to approve the minutes of the 1933 annual meeting as printed in the year book was seconded and carried.

The Chairman of the Committee on Constitution and By-Laws, Mrs. Julius Potter, presented a constitution which she moved be substituted for the one in use. Seconded. The chair asked if there were any Amendments, hearing none, the question was put and the motion carried by a unanimous vote.

The Treasurer read her report, also the report of the Auditor. A motion to accept the report of the Auditor was seconded and carried.

Reports were heard from all other officers and heads of departments and are printed elsewhere in the year book.

A motion to send a message of greeting and hope for a speedy recovery to Mrs. Hippler, Educational Chairman, who has been very ill, was seconded and carried.

We had as guests, Miss Helen Lade, who is home from Tokio, Japan, on furlough and Miss Letitia Viele who is at present in charge of rural work in the Warsaw district.

Rev. Edgar L. Tiffany led the noonday prayers.

The President read her annual message which is also printed in the year book.

Announcement was made of the Triennial Convention of the Church to be held this coming fall in Atlantic City. Being so near, it is hoped that a large delegation will go from our Diocese.

Motion to adjourn for lunch was seconded and carried.

During the luncheon period conferences for all officers and Secretaries were held in various parts of the building.

At 2 o'clock the meeting was again called to order by the President. Mrs. Allan L. Burton led the opening prayers.

During the afternoon, three very interesting addresses were given. The first speaker was Rev. Harold C. Kelleron, Deacon in charge of the work at Youngstown, N. Y. He gave a most interesting account of the rural work in that community.

Mrs. Henry Hill Pierce of New York brought a message from the National Executive Board of which she is a member, particularly stressing the importance of the United Thank Offering, and urging a thoughtful, loving and spiritual participation in it.

The third and last speaker was Rev. John Magee of Nankin, China, who went out there as a Missionary 22 years ago. He told in a very interesting way what the introduction of modern methods of Education and modern medical science had done for China.

Hymn 92 was sung while the offering was taken which amounted to \$102.07.

The report of the registration committee showed a registration of 462. There were 46 Buffalo Parishes represented and 25 outside of Buffalo. There was one visitor from Japan and one from New York.

The Chairman of the Nominating Committee, Mrs. Nixon, gave the following report of the election: 1st Vice President, Mrs. John K. Walker of St. Paul's, Buffalo; 3rd Vice President, Mrs. Charles M. Wilson of the Church of the Good Shepherd, Buffalo; 4th Vice President, Mrs. Everett W. Jameson of Trinity Church, Buffalo; Recording Secretary, Mrs. Charles G. Berry, Kenmore. These officers were declared elected by the chair. The terms of all other officers have not yet expired.

The President announced the appointment of Mrs. Charles D. Broughton as 5th Vice President to fill the vacancy caused by the resignation of Mrs. Allison, and also that hereafter the 3rd Vice President would be in charge of Advanced Work.

Mrs. Broughton, Devotional Chairman, announced that The World Day of Prayer would be observed here in Trinity Church on February 16th.

The appointment of the following Standing Committees was announced by the President: Nominating Committee, Mrs. Charles G. Berry, Kenmore, Mrs. Karl N. Searles, Buffalo. Constitution Committee, Mrs. Julius Potter and Mrs. F. A. Zebold both of Buffalo. Three additional members for the Nominating Committee were nominated and elected from the floor. They were Mrs. Albert E. Clark, Buffalo, Dr. Frances Boynton and Mrs. Frank A. Weaver of Lockport.

The report of the Resolutions Committee was read by Mrs. Henry S. Madden, who moved its adoption. Motion seconded and carried. A copy of which is herewith appended.

Closing prayers were led by Rev. H. C. Kelleron.

Motion to adjourn was seconded and carried.

There followed immediately in the Parish House an informal reception for the presiding Bishop, Rt. Rev. James De Wolf Perry and Bishop and Mrs. Davis. This was a most delightful part of the annual meeting, not only giving the women of the Church a chance to meet and greet the guest of honor, Bishop Perry, and our own beloved Bishop and Mrs. Davis but also providing an opportunity for the women to meet each other.

In the evening a service was held in St. Paul's Cathedral which was attended by about 800 men and women to welcome to our Diocese the Presiding Bishop of the Church, Rt. Rev. James DeWolf Perry. This is the first time that a presiding Bishop has ever visited this Diocese in his official capacity and let it be noted in passing that the Woman's Auxiliary invited him.

Bishop Perry has lately made a pilgrimage of the Mission fields in the Orient and took as his topic, impressions gained while there. He opened by paying a tribute to Bishop Brent who with wonderful vision and faith pioneered as a Missionary in the Philippines. His life and work will be an incentive to all Missionaries throughout the ages.

Speaking of China and Japan he said both countries look to America with longing for our continued leadership. We must not fail them now.

This evening service brought to a close the 53rd Annual Meeting, which had been most inspiring.

## PRESIDENT'S ADDRESS

January 16, 1934

Dear Friends of the Auxiliary:

I wonder if you look forward to these gatherings with as much feeling as I do. There is always such a thrill when so many of us meet together and also a great sense of strength and comfort in our Corporate Communion.

For some of us the year has brought joy, for others difficulties and sorrow. To those our thoughts go out in loving sympathy. Our loss in the death of Dean Allison cannot be measured. His was a ministry of utter unselfish devotion and will never be forgotten.

The Bishop has established a fund to be known as the Allison Memorial Fund to be used for rural work in the Diocese. The offering at our service tonight will go to this fund.

The reports show a fine "carrying on" and I congratulate the branch officers that pledges, supply work and all the rest have suffered so little during this hard year. It shows real sacrifice and thoughtful planning.

I want you to know about a group now three years old called the Junior Girls' Mission Club of Grace Church with the hope that other such groups will be formed. A marvelous training for future Auxiliary members. There are 35 girls from 8 to 13. They have their own officers and make their own plans with only a little help from Mrs. Hoffman, who organized the club. They conduct their own meetings, have speakers and send boxes to Missionaries. On the table at every meeting is the blue box of the United Thank Offering. They can give many of us pointers on a well rounded program. As the twig is bent the tree will grow.

We had two diocesan events in 1933 that made it different from other years. The first was the Pot Pourri we gave for the Church Mission of Help, \$612 was the amount sent to their Treasurer. Over 1000 people turned out and I think it did us all good to laugh together. Some of the musical talent exhibited by our clergy will go down in history.

The second event was the tour of the Reservation. This was the most astonishing gathering. We had thought a hundred might turn up but never dreamed of auto load after auto load until there were over seven hundred men, women and children. We met Dr. Harvey and he spoke to us of the work. We saw the beautiful vestments made by the Indians for Dr. Harvey in token of their affection. It was a great success and I am sure gave evidence to the people of the Reservation that we are interested.

In February we had an unusually well attended supper meeting for Evening Branches. Mrs. E. P. Miller, one of our Western New York Missionaries home on furlough was the speaker. She brought many lovely examples of hand craft and gave a vivid picture of her Chinese work. These meetings are now an established part of our program.

I wish to thank all the Diocesan officers for their loyal service. We have had almost perfect attendance at executive meetings. To the retiring officers we bid good bye with regret. We never want to give them up, but we do realize that responsibilities should be shared, that the contribution of many different ones stimulates the growth and strength of our organization and I do feel that a retired Diocesan officer is just the best Branch member ever. I particularly must speak of Mrs. Frank Weaver, better known to us as Miss Loraine Loosen, who for six years was our most efficient Treasurer after which she became 1st Vice President and Devotional Chairman and was so inspiring in her talks and helpful with suggestions.

One thing that pleases me very much is the fine cooperation of the various Church organizations in our Diocese. The Church Mission of Help has a baby to be cared for. The case is reported to the Child Welfare Committee of the Church Home. Funds are needed. An Auxiliary member of the Committee is sure her group will give fifty dollars and it is done. The Fellowship assisted the Church Mission of Help with their Christmas Party and ushered when the Auxiliary gave Potpourri. The Girls' Friendly do their box work for Missions through the Auxiliary.

The Church Periodical Chairman is a guest member of our Executive Board and we assist her in many ways.

We are including in our Year Book reports of the Church Mission of Help, Church Periodical Club and Girls' Friendly Societies.

The Social Service work is being developed. One Parish has opened a shop in the Parish House where members can sell things, and they also have an employment bureau. I hope you will all give thought and support to the Child Labor Laws and other laws that are bringing a new hope into the lives of those who toil.

We must also feel a very great responsibility for Peace, for Temperance and for all the agencies to relieve suffering and care of children and the aged. Being Christians we have a leadership we cannot evade.

We are living in a time of great chance in all lines of thought and endeavor. The attitude we Christian women take toward the new order is important. We must welcome and be ready for the new ideas and new interpretations but we must keep our steadfast faith in Christ Jesus who stands sure in the midst of confusion. What our religion means in our lives is shown by what we are willing to dare for Christ. Will we dare only what seems expedient or will we dare unpopularity, poverty, danger, suffering, sarcasm, scorn. Will we dare all and go forward joyously, heart afame, in cheerful service wherever the Master's call may lead, whether it be to humble acts among the most forlorn, or to difficult tasks of leadership. One and all are made radiantly beautiful if they are done for Christ Jesus.

"Go ye". The magic of His power is in those two small words. As we go forth for Him on many errands we feel confident that His love will guide us, His strength sustain us, His wisdom give us understanding. Let us be truly His and may God bless you and keep you throughout the coming year.

#### REPORT OF SOCIAL SERVICE IN THE DIOCESE FOR 1933

I think "Social Service" has a deeper meaning for all of us the past three years. Services, that were more or less routine jobs, dealt out to us by some one in authority have become real personal privileges for each and every one of us.

From 57 reports received and checked we find that 37 Branches have social service chairmen, 19 have done social service work in the community, 34 in their own parishes, 29 cooperating with social service agencies and 6 with other churches.

Families have been cared for with food, clothing, medical help and flowers. And please don't forget that flowers are sometimes as important as a warm coat, and also that the value of personal contacts may be way beyond our knowledge.

St. Peter's at Westfield reported free luncheons served to undernourished children.

The usual Thanksgiving and Christmas baskets were very generally distributed, either by the Branches themselves, or in cooperation with social agencies.

Money, clothing and Christmas gifts were supplied and Church Vestments and Altar Hangings sent to the Indian Mission.

Layettes were made and care given to the unmarried mother and her babe.

The services we can render these hectic days are legion and I'm sure every Parish can find some service adaptable to their organization.

Fifteen reports came through blank. Please report your work, however small.

Once more I ask that your Branch appoint a chairman. In case of an emergency call, it simplifies matters very much in making the contact with your Branch.

During the last year a call came to clothe a retired clergyman. Five or six Branches did the job.

Dr. Allison asked for clothing for nine boys, all of whom were promptly and completely cared for, either by groups or individuals.

I wish to express my appreciation of your help and support and I trust you will stand by for the coming year, as its needs will be many.

Owing to the prolonged illness of the Educational Secretary we were unable to name the usual Intensive Day in October. However, we hope to meet in small groups soon to carry on the study of our topic for the coming year, Christ in the Modern World.

#### SUGGESTIONS FOR SUPPLY SECRETARIES

When supply work is received in the Fall, Branches will please appraise, and if for any reason your Branch is not able to fill the allotment, please notify Diocesan Supply Secretary before January 1st.

Branches receiving Personal Family boxes for Missionaries, or \$5.00 Christmas gift letters for Missionaries will please notify Diocesan Supply Secretary of their acceptance as soon as possible in the Fall, and will report the sending of these not later than December 15th.

Branches sending Personal Family boxes should communicate with the family to whom the box will be sent, giving them the date of shipment, and telling whether sent by parcel post or freight or express.

Branches working for Institutions, Missions and Hospitals will send boxes directly to the Mission for which they are working, enclosing a self-addressed return post card, in order that they may be notified of its safe arrival.

Branches are privileged to use the Standard of Values sheet, which may be obtained from the Diocesan Supply Secretary, in order to estimate the cost of making garments, which may be added to the cost of material, thus obtaining the full value.

There is no valuation on second-hand articles of clothing.

When allotment is finished please list all articles on the blue sheet and the pink sheet and the white sheet. Compute all values, including postage, on the blue sheet and the pink sheet, sending the blue sheet to the Diocesan Supply Secretary as soon as possible, and keeping the pink sheet carefully on file to be used later in making out Supply report to Diocesan President in December. The white sheet is sent with articles in box, with no values attached.

All work for the year should be finished and sent, and blue sheets returned to Diocesan Supply Secretary by May 1st at the latest.

Under no consideration should work be carried over until the next Fall.

#### REPORT ON CONTACT WITH OUR WESTERN NEW YORK MISSIONARIES

October 1933 marked the close of the first three year cycle of our plan for contact with our Western New York missionaries, and according to that plan we have now given a different missionary to each group of branches. Some groups have really come to know their own missionary better, others seem not to have realized that they had one. Some msisionaries have not seemed to care much, but where both the missionary and the group have appreciated the mutual friendliness, a real interest in the worker and her (or his) work has resulted.

During the three years we have had home on furlough, Deaconess Bedell, Deaconess Shaw, and Mrs. E. P. Miller, Jr., and by arranging meetings for them, many groups have had the opportunity of hearing of their work, and by prayer and gifts of sharing in it.

We are glad to report that Miss Alice Larery is almost well again, but is still at home; while Deaconess Bedell is now serving among the Seminoles of Florida, with headquarters at Everglades. Captain Franklyn Board is now studying for the ministry at the University of the South, Sewanee, Tenn., and the Rev. Timothy E. Woodward, a former member of Grace Church, Lockport, has joined the staff of All Saints Mission, Bontoc, P. I., where Deaconess Shaw is finding the auto we sent her a real life saver, it being the only one in town.

Miss Christine Nuno of St. Luke's International Medical Center, Tokyo, paid us a very fleeting visit on her way back to Japan from the International Red Cross Convention in Paris, where she was sent by the Japanese Government to take the place of one of their delegates who could not be present. Miss Helen Lade, the Executive Secretary of St. Luke's is home on her first real furlough since going out to Japan, and we trust she will go back rested, refreshed, and glad she is a member of the Western New York Family.

Miss Laetitia Viele of St. Paul's, Buffalo, has been appointed by Bishop Davis as Director of Religious Education at Warsaw; and Mrs. Marguerite Priddis having graduated last June from the Simmons School of Social Work in Boston, is now the Director of Goodhue House, New Brighton, Staten Island, a shelter for adolescent girls during a time of study of them and their problems, this being an experimental project of the New York Children's Aid Society in cooperation with the New York School of Social Work. We welcome Miss Viele, Mrs. Priddis and Mr. Woodward to our group of Western New York missionaries and rejoice that there are so many Western New Yorkers (see list) at work for the Master in such varied fields, and that in very truth they and we are serving together.

Mrs. E. P. Miller, of Wu Chang, who is returning to China in August, will spend the last two weeks of April in our Diocese. We will thus have an opportunity to meet her and deepen the friendly contacts made on previous visits. Please let me know as soon as possible the date you wish, so that we may arrange her engagements with as little duplication of travel as possible. The more we hear of distant peoples from those who live among them, the more we speed the day of world friendship and peace.

Our 45 branches show a gain in number of 24 since the division of the diocese, and of 6 since our report of the previous year.

Each of these branches shows activity in at least one line. A city branch which is unable to obtain even one mailing contributor reports nearly 600 papers and magazines distributed, mostly by the rector, in our city hospitals.

Institutions in the diocese aided include almost every hospital and institution in the cities and many in towns and villages.

During the year we have welcomed two opportunities to cooperate directly with the Diocesan Auxiliary. More than 200 magazines, mostly in yearly files, were delivered to the Episcopal Church House at Chautauqua for the use of guests during the two months that the house is open. The need was shown by the remark, "Well they certainly are welcome. Last year we could hardly get hold of a newspaper until it was worn out."

And we have arranged for regular mailings of fourteen monthly publications to Dr. Harvey of the Indian Reservation.

## REPORT OF THE UNITED THANK OFFERING

The work done by the parish United Thank Offering Custodians during the past two years has been no easy task. May I say a word of thanks and praise for these loyal and faithful women who have been my co-workers? To them, alone, belongs all of the credit for the splendid amount of the 1933 Offering, for it certainly took much patience and loving devotion to gather it in.

The Annual Diocesan Presentation Service was held at the Church of the Holy Communion, Buffalo, N. Y., on United Thank Offering Sunday, June 4, 1933, at 4 P. M. The Rev. Elmore M. McKee, rector of Trinity Church, Buffalo, N. Y., was the preacher.

Seventy-three different groups of women shared in the 1933 Offering, which amounted to \$2642.55. Every Buffalo parish is represented and all but two of the parishes represented in 1932 are again on the 1933 roll. These are two small parishes in communities very hard hit by existing economic conditions. Eighteen branches show an increase over their 1932 offering, and there were eight branches that gave for the first time. This all shows an increase in the number of givers --- our real objective.

We had one individual gift, and by that is meant a gift sent directly to the Diocesan Custodian as a special Thank Offering. This gift, a truly beautiful one, has been given every year for many years. The giver writes a check on Christmas Eve, and it is her Thank Offering for the gift of Our Blessed Lord---on His Birthday! I wish there might be more of these special gifts.

We are fast approaching the time for the Triennial Presentation which will take place Thursday, October 11, 1934, at Atlantic City, N. J. At this service all of the United Thank Offerings, from every diocese and missionary district of our Church around the world, will be poured out upon the Great Golden Almsbasin.

We must put on full steam ahead during the few remaining months of this Triennium. May I urge you to increase your devotion to your Little Blue Box, both by your prayers and by your gifts. Keep it daily before you, in your prayers for your Diocesan Custodian, your parish Custodian and all parish custodians. If we unite our efforts and our prayers we shall have a glorious offering to present next October.

Recruiting for the Mission Field is now a part of the duties of the United Thank Offering Custodian. Let us pray for the gift of a life for service for the Master. Who knows, perhaps Western New York may have this greatest of all gifts to put on the Great Golden Almsbasin along with our gifts of money and our prayers.

#### REPORT OF THE GIRLS' FRIENDLY SOCIETY

For those who have worked in the Girls Friendly Society in the past and are carrying on its activities today, the letters G. F. S. stand as symbols for problems solved and joys and sorrows shared, along with achievement in many fields.

Our motto, 'Bear Ye One Another's Burdens' strikes the key note of our corporate life together, for the value of our work lies in the group friendship and the joy derived from that contact in our work for one another and for our Church. The Society was founded on a great principle of character and its purpose is that its members accept these principles as their personal standard of Christian Womanhood. The work originally started by older women for girls has now broadened into work *with* girls, for individual and personal relationship and for mutual help, sympathy and prayer.

Our program is one of Religion, Education and recreation.

For 1933 our Mission Object was the raising of our contribution to the \$2000, pledged by the National Society for the House of The Merciful Saviour at Wu Chang, China, which sum was oversubscribed \$179.

Our assignments for our Lenten sewing come through the Woman's Auxiliary.

We are happy to note some growth in membership at our last census when the personnel of our Diocesan Organization numbered 382.

Our Holiday House on Conesus Lake, owned jointly with the G. F. S. of the Diocese of Rochester, had a very successful season in July and August, 232 girls from the two dioceses spending their vacations there in its lovely surroundings. Daily prayers were said there in the Atwater Memorial Chapel, where our visiting clergy conducted vesper service every Sunday.

We sent three delegates to the Triennial Conference of the National Council held in New York City last June, at which time Miss Brent was made National President and Mrs. Roosevelt Honorary President.

The outstanding event of our G. F. S. year is the annual Candle-light Service and Tea, held at the Diocesan House, on the Sunday nearest to All Saints Day, the Bishop conducting the service, which is in memory of Bishop Brent. This year Miss Brent was present and gave us an inspiring address.

At our annual conference last May the G. F. S. was most happy to welcome as their guests, members of the Women's Auxiliary at a talk given by Mother Ursula Mary of the House of the Merciful Saviour, in Wn Chang, China. An informal reception and tea followed.

The G. F. S. acknowledges with much appreciation the invitation of the Woman's Auxiliary to contribute this report to their Year Book for 1933.

#### A STATEMENT OF THE WORK OF THE CHURCH MISSION OF HELP FOR YEAR 1933

The event of 1933 that will undoubtedly be the most far reaching in its effects on the work of the Church Mission of Help was the study by Miss Vinnie Borton, Assistant Executive Secretary of the National Church Mission of Help, of the work of the organization in the Diocese of Western New York. She found the case work with individual girls between the ages of 16 and 25 to be of high quality and commented that our professional standing among the social agencies of Buffalo was attested to by the placing with us of a student for training from the Curriculum of Social Work of the University of Buffalo.

The recommendations for reorganization which she made are rapidly being put into effect. A Board of Directors of 18 members with direct responsibility for the work has been appointed by the Department of Social Service with Bishop

Davis as President; Miss Helen Olmstead, 1st Vice President; Mrs. Laurence Gardner, 2nd Vice President; Miss Esther Smith, Secretary; Mr. Noel Symons, Treasurer; Dean Hale, Chaplain; and Mrs. James Dyett, Chairman of Committee on Interpretation.

With the leadership of Miss Esther Smith, an increased membership is to be sought since the work is dependent on volunteer subscription except for a Diocesan grant of \$3500 from the Department of Social Service of which C. M. of H. is a part.

During 1933, 272 young people---girls, children, and young men---were rendered assistance varying in form according to their individual needs.

That our annual Christmas party is now an "institution" is illustrated by the remark of a former C. M. H. girl, now a settled young woman, who said, "I hope I can come every year as long as I live."

The Auxiliary group, the Church Mission of Help Council (formerly the Council of Church Women) and the Child Welfare Committee of the Church Charity Foundation have rendered valuable service with whole hearted enthusiasm.


Our budget is inadequate to the needs of the girls but our spirit of hopefulness that the days of "going on" are here and that the next year will see our opportunities for usefulness much increased, is great.

Because we believe firmly that there is a power "not ourselves", the power of the Holy Spirit, available for the rescue and redemption of our race, we strive to make that power a reality to those whom we are trying to help. We are sure that the Church has a contribution to make that is needed, and equally sure that the church worker needs to be adequately trained to use intelligently all the resources within reach.

It is the plan of CMH to bring to bear upon the problems of young people not only the methods of social work and of medical, psychological and psychiatric research; but also, the formation of the Christian ideal of living, the fellowship of the Church, the counsel and guidance of experienced clergy, and the help of the sacraments."

The office is at 237 North Street, and there is a staff of three, Mrs. Wilma Vanderwall, Executive Secretary; Miss Selene Gifford, Assistant Secretary; Miss Ruth Ford, Office Secretary.

# CONSTITUTION

## ARTICLE I — NAME

The name of this association shall be The Western New York Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the United States of America.

## ARTICLE II — OBJECT

The object of this Auxiliary shall be to help in carrying forward the program of the National Council of the Church along the lines of Missions, Religious Education, Christian Social Service, and Church Extension in home, parish, community, diocese, nation, and world.

## ARTICLE III — MEMBERSHIP

Sec. 1. Any group of women in this diocese willing to further the work of the Auxiliary as defined in Article II may become a branch of this Auxiliary.

Sec. 2. Each branch shall make a voluntary contribution, commensurate with its ability, to the pledges of this Auxiliary, Administration Fund and such other objects as may be recommended by the Executive Board.

Sec. 3. Any woman in this diocese willing to co-operate in the work of a branch may become a member.

## ARTICLE IV — OFFICERS AND THEIR ELECTION

Sec. 1. The officers of this Auxiliary shall be a President, five Vice-Presidents, a Recording Secretary, a Corresponding Secretary, a Treasurer, a United Thank Offering Custodian, an Educational Secretary, and a Supply Secretary. When advisable there may be one representative from each Deanery, to be appointed by the Executive Board.

Sec. 2. These officers shall be elected for a term of three years and shall be eligible for election to the same office for not more than two consecutive terms.

Sec. 3. There shall be a nominating committee of five members, two appointed by the Chair and three elected from the floor at the annual meeting.

Sec. 4. The officers shall be divided into three groups, as follows:

Group I. To be elected the year preceding Triennial--President, Corresponding Secretary, Educational Secretary, Fifth Vice-President.

Group II. To be elected the year of Triennial--Recording Secretary, First, Third and Fourth Vice-Presidents.

Group III. To be elected the year following Triennial--Treasurer, Supply Secretary, Second Vice-President, United Thank Offering Custodian.

Sec. 5. The election of officers shall be by ballot, a majority vote constituting an election.

Sec. 6. Any vacancies occurring during the term shall be filled by the Executive Board.

#### ARTICLE V—ORGANIZATION

Sec. 1. The Executive Board shall be composed of Diocesan Officers, Deanery representatives and Chairmen of any committees the Executive Board may appoint.

Sec. 2. There shall be the following standing committees:  
Nominating (see Art. IV, Sec. 3)  
Constitution and By-Laws

#### ARTICLE VI—MEETINGS

Sec. 1. The Annual Meeting shall be held in January of each year, unless otherwise deemed expedient by the Executive Board.

Sec. 2. Special meetings may be called by the Executive Board.

#### ARTICLE VII—AMENDMENTS

This Constitution may be amended at any annual meeting of this Auxiliary by a two-thirds vote of the branches present, provided the proposed amendment has been submitted in writing to the Executive Board, the Committee on Constitution and By-Laws, and every Branch in the diocese.

## BY-LAWS

#### ARTICLE I—DUTIES OF OFFICERS

Sec. 1. It shall be the duty of the President to preside at all meetings, and to perform all other duties appertaining to the office, as defined in Article II of the Constitution.

Sec. 2. In the absence of the President, the Vice-Presidents in the order of their rank shall perform all the duties of that office.

Sec. 3. The special duties of the Vice-Presidents shall be determined by the Executive Board.

Sec. 4. It shall be the duty of the Recording Secretary to keep a correct record of the proceedings of all meetings of the Diocesan Branch and of the Executive Board, and to prepare and edit the Year Book.

Sec. 5. It shall be the duty of the Corresponding Secretary to carry on all correspondence assigned by the Executive Board and annual meeting, to issue notices of all meetings, to read all letters and have custody of same; to send out the Year Book; to keep a correct list of all Diocesan officers and Branch officers; to notify the proper authorities of all newly elected officers and delegates, and of those who have passed away during the year; to submit a written report at the annual meeting.

Sec. 6. It shall be the duty of the Treasurer to receive all moneys, with the exception of the United Thank Offering, Advance Work, and Supply Fund, and deposit the same in the name of the Auxiliary in such bank or banks as the Executive Board approves; to dispense all money as directed by the Diocesan Branch; to keep an accurate account of all receipts and disbursements, and to render an audited report at the annual meeting.

Sec. 7. It shall be the duty of the United Thank Offering Custodian to increase and deepen the interest in this offering of life and money; to receive all moneys and deposit same in bank or banks approved by the Executive Board, to render an annual report of all money and an audited report each Triennial. To take the Offering to the Triennial, and should this be impossible, the Executive Board shall designate the person to do so.

Sec. 8. It shall be the duty of the Educational Secretary to stimulate the educational work in every possible way, and co-operate with the National Educational Committee of the Auxiliary and the Diocesan Department of Education in so doing.

Sec. 9. It shall be the duty of the Supply Secretary to have charge of receiving the allotments from the National Auxiliary Supply Secretary and re-allotting of the same, and to co-operate with Diocesan agencies needing assistance; to receive supply money and to deposit same in bank or banks approved by the Executive Board; to render an annual report of all supplies and an audited report of all moneys.

Sec. 10. It shall be the duty of the Deanery representatives to assist the Executive Board in whatever way it may deem advisable.

## ARTICLE II—DUTIES OF EXECUTIVE BOARD

It shall be the duty of the Executive Board to choose the policy and prepare plans for the year; to pass upon the budget; to appoint committees; deanery representatives; delegates to the Triennial and Synod; to fill vacancies.

## ARTICLE III—DUTIES OF COMMITTEES

Sec. 1. It shall be the duty of the Nominating Committee to prepare a ticket to be voted upon at the annual meeting.

Sec. 2. It shall be the duty of the Committee of Constitution and By-Laws to receive any proposed changes in the Constitution and By-Laws; to submit same to the Executive Board and present them to the annual meeting.

## ARTICLE IV

The fiscal year of the Auxiliary shall be from January 1 to December 31.

## ARTICLE V — MEETINGS OF BOARD

Sec. 1. The Executive Board shall meet at the call of the President, at least four times a year.

Sec. 2. Special meetings may be called at the discretion of the President or by her upon the request of three members.

## ARTICLE VI — REPRESENTATION AT MEETINGS

Sec. 1. Branches shall not be limited as to delegates to the annual meeting, but only one vote shall be cast from each Branch when balloting for officers. Each Branch shall appoint its own representative for this balloting.

Sec. 2. Delegates to the Triennial and Synod shall be appointed by the Executive Board.

## ARTICLE VII — QUORUM

Sec. 1. One-third of the Branches of the Auxiliary shall constitute a quorum at the annual meeting.

Sec. 2. Seven members shall constitute a quorum of the Executive Board.

## ARTICLE VIII — PARLIAMENTARY RULES

Robert's Rules of Order, Revised, shall be authority in all questions of Parliamentary Law not covered by the Constitution and By-Laws.

## ARTICLE IX — AMENDMENTS

These By-Laws may be amended at any annual meeting of this Auxiliary by a two-thirds vote of the Branches present, provided the proposed amendment has been submitted in writing to the Executive Board, the Committee on Constitution and By-Laws, and every Branch in the diocese.
