That the 80th General Convention of The Episcopal Church amend Article X of the Constitution of the Episcopal Church as follows

# **Explanation**

As recorded under the Acts of Convention 1973-2018 in the Archives of The Episcopal Church, legislative action taken at the 79th General Convention concurred with Resolution 2018-A063. This resolution provides a second reading of the unaltered text.

*Resolved*, That the 79th General Convention of The Episcopal Church amend Canon II.3.6 as follows:

#### Sec. 6

THE ARCHIVES of the Episcopal Church

(a) Whenever the General Convention, pursuant to Article X(b) of the Constitution, shall authorize for trial use a proposed revision of the Book of Common Prayer, or of a portion or portions thereof, the enabling Resolution shall specify the period of such trial use, the precise text thereof, and any special terms or conditions under which such trial use shall be carried out *including translation*.

(b) It shall be the duty of the Custodian of the Standard Book of Common Prayer:

(1) To arrange for the publication of such proposed revision;

(2) To protect, by copyright, the authorized text of such revision, on behalf of the General Convention; which copyright shall be relinquished when such proposed revision or revisions shall have been adopted by the General Convention as an alteration of, or addition to, the Book of Common Prayer;

(3) To certify that printed copies of such revision or revisions have been duly authorized by the General Convention, and that the printed text conforms to that approved by the General Convention.

(c) During the said period of trial use and under the modifying conditions specified, only the material so authorized, and in the exact form in which it has been so authorized, shall be available as an alternative for the said Book of Common Prayer or the said portion or portions thereof; *provided, however*, that it shall be competent for the Presiding Bishop and the President of the House of Deputies, jointly, on recommendation by a resolution duly adopted at a meeting of the Standing Commission on Liturgy and Music communicated to the said presiding officers in writing, to authorize variations and adjustments to, or substitutions for, or alterations in, any portion of the texts under trial, which seem desirable as a result of such trial use, and which do not change the substance of a rite.

(d) In the event of the authorization of such variations, adjustments, substitutions, or alternatives, as aforesaid, it shall be the duty of the Custodian of the Standard Book of Common Prayer to notify the Ecclesiastical Authority of every Diocese, and the Convocation of the <u>AmericanEpiscopal</u> Churches in

Europe, of such action, and to give notice thereof through the media of public information.

*Resolved*, That the Standing Liturgical Commission be directed to prepare a plan for liturgical revision and enrichment of the common worship of this Church to be presented to the 73rd General Convention; and be it further

*Resolved*, That this plan include forms of worship reflective of our multicultural, multiethnic, multilingual and multigenerational Church while providing rites and structures that ensure the unity of Common Prayer; and be it further

*Resolved*, That any new or revised rites when authorized be available for distribution in a variety of forms, including multimedia and electronic options; and be it further

*Resolved*, That the Standing Liturgical Commission be directed to prepare for publication and use alternative liturgical materials to be presented to the 74th General Convention; and be it further

*Resolved*, That the Standing Liturgical Commission present the necessary budget request for this process of liturgical revision and enrichment to the 73rd General Convention.

Final Text:

*Resolved*, That this 70th General Convention direct the Standing Liturgical Commission to continue to study, develop and evaluate supplemental inclusive language texts as previously directed by the 68th and 69th General Conventions, in consultation with the Theology Committee of the House of Bishops, among other consultants, and in consultation with the bishops, clergy and laity of this Church through a process which solicits their reactions and suggestion to report back to the 71st General Convention; and be it further

*Resolved*, That for the sake of perfecting such draft texts as the Standing Liturgical Commission shall develop, using this consultative process, this Convention authorize Supplemental Liturgical Materials for use during the next triennium omitting Sections 4 and 34: such use shall always be under the direction of the diocesan bishop or ecclesiastical authority. Paragraph 34 to be referred back to the Standing Liturgical Commission in consultation with the House of Bishops Committee on Theology for evaluation, study and refinement, but not for use at this time; and be it further

*Resolved*, That the second paragraph of Article X of the Constitution be amended by adding the following sub-paragraph (c):

(c) Provide for limited use for other forms of worship on an experimental basis for such periods of time and upon such terms and conditions as the General Convention may provide.

And that this amendment be sent to the Secretary of the Convention of every Diocese and be made known to the Diocesan Convention at its next meeting.
