That the 80th General Convention urge dioceses of The Episcopal Church across the United States to advocate for safe gun legislation with their state governments; and be it further

Resolved, that the Episcopal Church's Office of Government Relations support domestic dioceses in state-level advocacy against gun violence and other forms of community violence; and be it further

*Resolved*, to assist the Office of Government Relations in this state-level advocacy against violence, the Joint Standing Commission on Program, Budget, and Finance consider a budget allocation of \$160,000 for the implementation of this resolution.

## **Explanation**

Recent gun violence in Buffalo, Uvalde, and Tulsa have underscored the need for safe gun legislation to prevent gun violence. Deep political divisions in the U.S. Congress, however, have made it difficult to pass meaningful gun violence-prevention legislation at the federal level. In the absence of coherent federal policy, state lawmakers can pass laws that can prevent gun violence.

Episcopalians in dioceses across the church, led by Bishops United Against Gun Violence, are eager to advocate with their state legislatures and governors for legislation that can help stop the epidemic of gun violence, but currently, the Episcopal Church's Office of Government Relations (OGR) does not have the capacity to provide support to state-level advocacy efforts. This resolution provides two years of funding for OGR to support state-level gun violence and community violence prevention advocates. The work can be accomplished without increasing the permanent DFMS staff and will be evaluated in advance of the 2024 General Convention.



**Resolution Number:** 2015-C005

**Title:** Implement Laws to Decrease Gun Violence

**Legislative Action Taken:** Concurred as Amended

**Final Text:** 

Resolved, That the 78th General Convention on the 50th anniversary of the murder of seminarian Jonathan Daniels, urge all legislators at federal, state and local levels to help decrease gun violence by implementing laws that;

- 1. Require permits to carry concealed weapons and criminal background checks for every gun purchase, including those made at gun shows; and
- 2. Except for the use of military and law enforcement agencies, ban the sale, transfer, importation and manufacture of military-style assault weapons and high-capacity magazines; and
- 3. Ban the importation and manufacture of Full-Auto Conversion kits that convert guns into automatic weapons; and
- 4. Tighten laws against gun trafficking, and increase penalties for those who engage in "straw purchases" of firearms for ineligible persons; and
- 5. Prohibit persons from purchasing guns without evidence of gun safety training; and
- 6. Recognize the impact of existing inheritance laws on the transfer of gun ownership; and
- 7. Promote funding for research into the prevention and causes of gun violence.

Title: Express Concern About Availability of Handguns and Assault

Legislative Action Taken: Concurred as Amended

**Final Text:** 

Resolved, That the 73rd General Convention express deep concern about the repeated use of easily available hand guns and assault weapons by and against children and call upon Episcopalians to seek ways to develop community strategies and create sanctuaries for our children, so that all may come to identify and value themselves and others as the precious children of God that they are, and that they may come to know peace in their lives and to create peace for future generations.
