## <Proposed amended resolution text showing exact changes being made:>

4. When a Diocese desires the ordination of a Bishop Coadjutor, the Standing Committee shall forward to the Presiding Bishop, in addition to the evidence and testimonials required by Canon III.10 III.11.3.a, a certificate of the Presiding Officer and Secretary of the Convention that every requirement of this Section has been complied with.

## **Explanation**

Canon III.11.9.a governs the procedure for a Diocese to elect a Bishop Coadjutor. When a Diocese elects a Bishop Diocesan, Canon III.11.3.a specifies the documents (evidence of prior ordinations, medical and psychological certificates, and the testimonials regarding the election signed by the members of the electing diocesan convention) that the Standing Committee is required to transmit to the Presiding Bishop in order to begin the consent process.

Canon III.10 deals with the Reception of Clergy from other Churches and has nothing to do with Episcopal Church elections of Bishops. The reference to III.10 is a typographical error, probably caused by canonical renumbering, that needs to be corrected.
