Resolution Text

Resolved, the House of _____ concurring,

That The Episcopal Church (TEC) support the Provincial part of The Episcopal Church structure by:

- participating in the networking and, when appropriate, the ministries of the Provinces
- ensuring each Province has the resources it needs to fulfill its commitment and responsibility to The Episcopal Church
- consulting with the Provinces for their support and participation in identifying qualified persons to serve TEC on various Interim Bodies; and be it further

Resolved, That Provincial ministry of TEC be partially funded through the establishment of a budget line for Provinces I - VIII in TEC budget; and be it further

Resolved, That the Provincial Representatives to Executive Council and the Provincial Leadership Conference together determine how this funding is to be distributed throughout Provinces I - VIII each year. Each Province will include its accounting for any funding received in the annual Provincial report to Executive Council; and be it further

Resolved, That The General Convention request a budget allocation of \$80,000 per budget year for the implementation of this resolution.

Explanation

Province IX currently receives funding from TEC; therefore, Province IX is not included in this request.

Provinces are part of The Episcopal Church structure; and this relationship has the potential to strengthen other relationships of TEC (church wide programs and ministries) with the Dioceses. The Province is committed to strengthening the connections between the Dioceses within the Province as well as with the wider Episcopal Church. The responsibility for the functioning of the Province is shared between the Dioceses in the Province and the wider Episcopal Church. Part of the responsibility involves the financial support that helps to enable the ministry of the Province.

in order for the system to work the best it can, each part must be cared for. This resolution offers one concrete way of supporting the Provincial part of the system called The Episcopal Church.



Resolution Number: Title: Legislative Action Taken: Text of Resolution: 2022-C059 On the Topic of Support for Provincial Ministry Rejected

Resolved, the House of Deputies concurring,

That The Episcopal Church strengthen the connection and collaboration between The Episcopal Church and its Provinces and Dioceses by enhancing the mission, ministry, and networking of the Provinces, facilitating the partnership between The Episcopal Church and the Provinces, and supporting the Provinces in fulfilling canonical responsibilities; and be it further *Resolved*, That this Provincial ministry be partially funded through the establishment of a budget line item for Provinces I – VIII, said allocation to be \$10,000 per Province per fiscal year and to be accounted for in the annual Provincial report submitted to Executive Council; and be it further *Resolved*, That the General Convention urges the Joint Standing Committee on Program, Budget and Finance to allocate \$160,000 for fiscal years 2023 and 2024 for the implementation of this resolution.

Resolved, That the 73rd General Convention reaffirm the current system of organizing the dioceses of our church into geographical provinces for more effective mission and ministry, in recognition of the momentum, positive experiences, and energy within the provinces during this triennium; and be it further

Resolved, That the provinces utilize and broaden existing networks and resources to strengthen and expand their capacity to facilitate, coordinate, and support their mission and ministry initiatives; and be it further

Resolved, That provinces continue to fulfill their canonical responsibilities and those that **may be assigned to them by General Convention or Executive Council;** and be it further

Resolved, That provinces demonstrate accountability by reporting regularly to dioceses, **Provinces**, and **Executive Council**; and be it further

Resolved, That the Standing Commission on the Structure of the Church be directed to work with the Executive Council and the provincial leadership to study and make recommendations to the 74th General Convention in the following areas:

- The role and responsibilities of provinces regarding the sharing of national and regional program resources;
- The future of Province IX, working with the Standing Commission on World Mission and the individual dioceses.
