The question recurring on the proposed substitute as amended, it was adopted.

The Bishop of Albany moved that Section 7 of Article II. of the present Canon 52 be put in place of Section 3 of Article II. as just adopted.

The Bishop of Indianapolis moved that Canon 52, as amended, be laid on the table; which was not adopted.

The question recurring on the motion of the Bishop of Albany, it was not adopted.

The question recurring on the proposed Canon 52, as amended, the Bishop of Indianapolis moved to add to Article VIII. the following as Section 3: "This Canon shall take effect immediately"; which was adopted.

The question being on the adoption of the whole of the proposed Canon 52, as amended, it was adopted.

The Bishop of Massachusetts, from the Joint Commission on the Relations of Capital and Labor, presented the Report of the Commission, with the following resolutions [see Appendix XI.] :

Resolved, the House of Deputies concurring, That the Joint Commission on the Relations of Capital and Labor be discharged.

Resolved, the House of Deputies concurring, That a Joint Commission on Social Service be appointed, consisting of five Bishops, five Presbyters, and five Laymen. It shall be the duty of this Commission to study and report upon social and industrial conditions; to co-ordinate the activities of the various organizations existing in the Church in the interests of social service; to co-operate with similar bodies in other communions; to encourage sympathetic relations between capital and labor; and to deal according to their discretion with these and kindred matters.—

Which, on motion, were adopted; and the Chairman appointed as members of such Joint Commission on the part of this House, the Bishop of Massachusetts, the Bishop of Chicago, the Bishop of East Carolina, the Bishop of Utah, and the Bishop of Michigan.

Resolved, the House of Bishops concurring, That Canon 53, § II., be amended by striking out after the words "permanently disabled," the words "or having reached the age of sixty-four years," in the sixth line of clause [i.] of said Section, and by the addition of a new clause thereto, to be numbered [iii.], and to read as follows:

[iii.] The Trustees shall distribute, without discrimination, except as specified herein, the entire net income received from the new Automatic Fund collected by the Joint Pension Fund Commission appointed by the Convention of 1907, among all clergymen sixty-four or more years of age in a ratio proportioned to the number of years they have served in the Ministry of this Church; *Provided*, that no one who shall remain in active service and in receipt of salary shall be entitled to receive under the provisions of this Canon more than is enough with such salary to make his income equal to one thousand dollars per annum; and *provided further*, That the Trustees shall ascertain in each case whether any such clergyman of this Church reaching the age of sixty-four years is eligible to receive any pension from a provision or fund established in the Diocese with which he is canonically connected, in which case the Trustees shall have discretion as to whether any or how large a proportion of the income of this fund shall be awarded to him.
