

Dear Colleagues,

Thank you for agreeing to serve as your diocese's contact person with the Standing Commission on Liturgy and Music, for our work in response to 2012 General Convention Resolution A049, "Authorize Liturgical Resources for Blessing Same-Gender Relationships." The SCLM subcommittee met this week, so I can now give you a general outline of our plans.

First, I want you to know that I received your names in response to an email to diocesan bishops. That same email asked whether the resource has been authorized for use in the diocese and for letters or other documents (or links) the bishop may have issued regarding the resources. The Archives of the Episcopal Church has been cataloging those responses for the commission, and today a website with those responses went live: <a href="http://www.episcopalarchives.org/SCLM/2012-A049/">http://www.episcopalarchives.org/SCLM/2012-A049/</a>. Your names and positions, but not your contact information, are on the spreadsheet listing responses to my inquiry.

I have asked the General Convention Office to create an "Extranet" site with all of your names, along with the SCLM subcommittee members working on these resources. For those of you not familiar with the Extranet, it is a password-protected forum administered by the General Convention Office to facilitate communication, including messages and files. You'll receive information directly from the General Convention Office about accessing the Extranet site for the group.

The commission is working on a survey to gather feedback about use of the resources. We plan to release that survey on September 1, giving people 10 months from the Advent 1 2012 official "launch" of the resource to get some experience of the resource. Responses to the survey will help the subcommittee determine what aspects of the resource need revision prior to the 2015 General Convention.
